**DESCRIPTION**

FIG. 1 is a front left perspective view of the coffee brewer showing the new design;

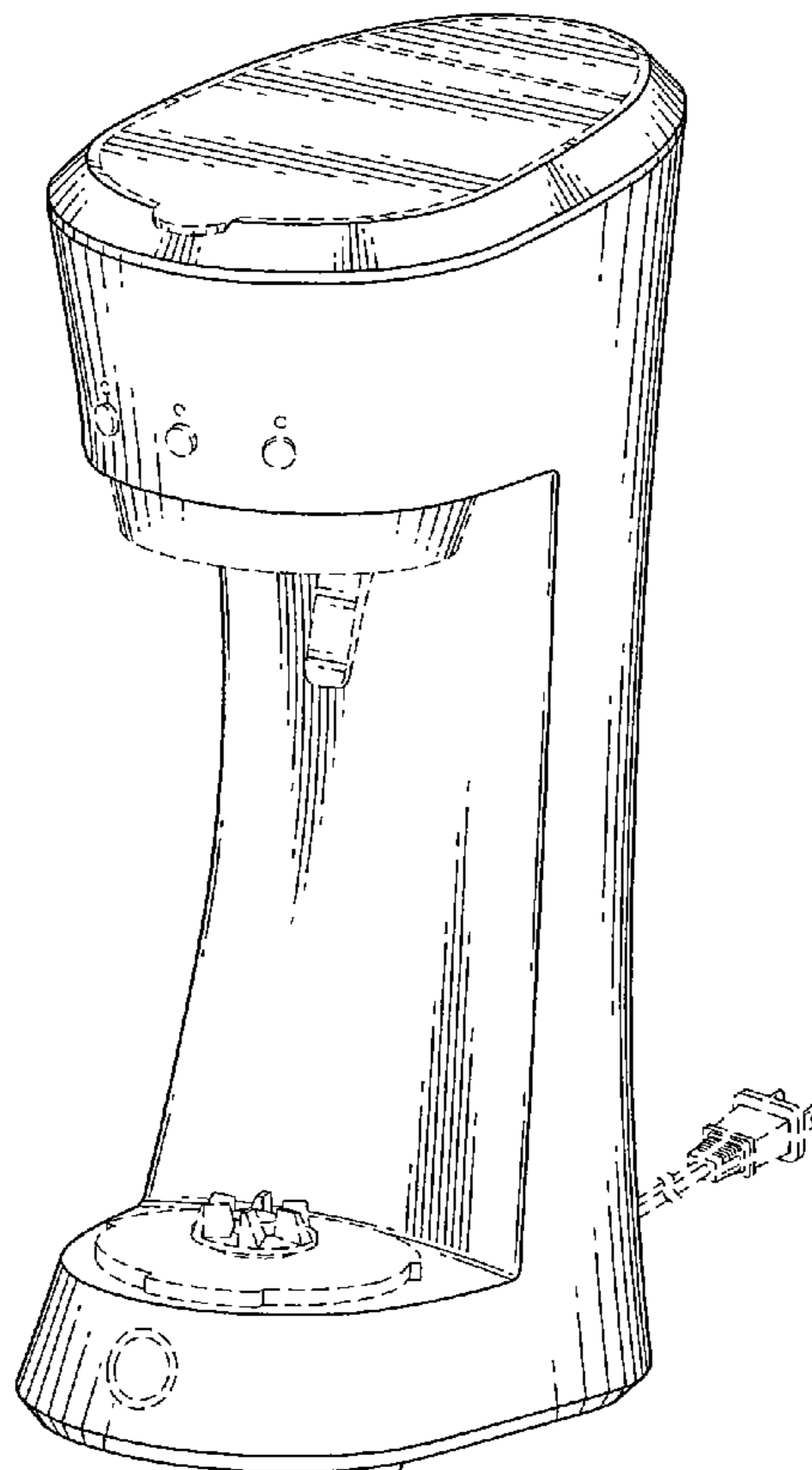

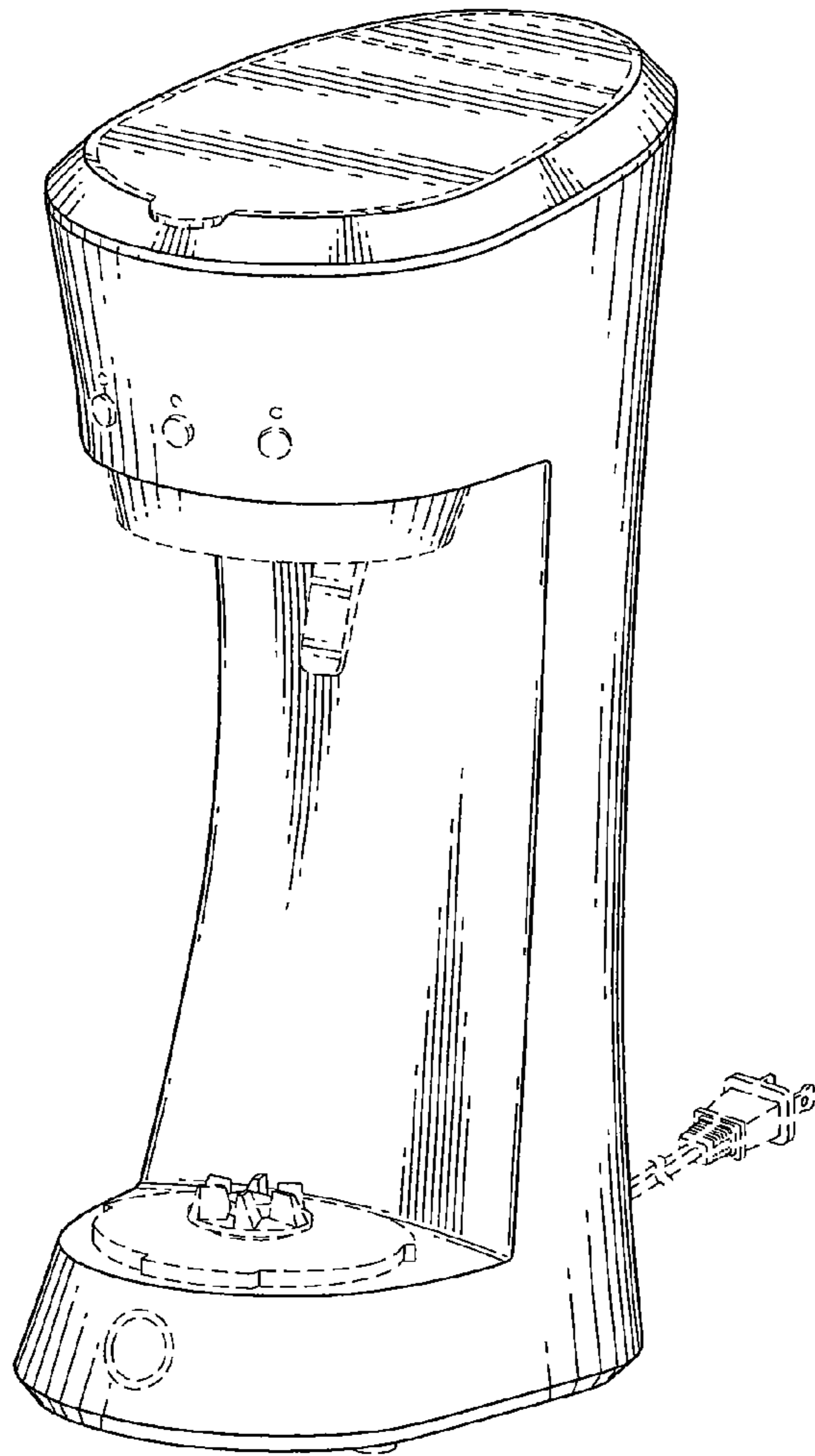

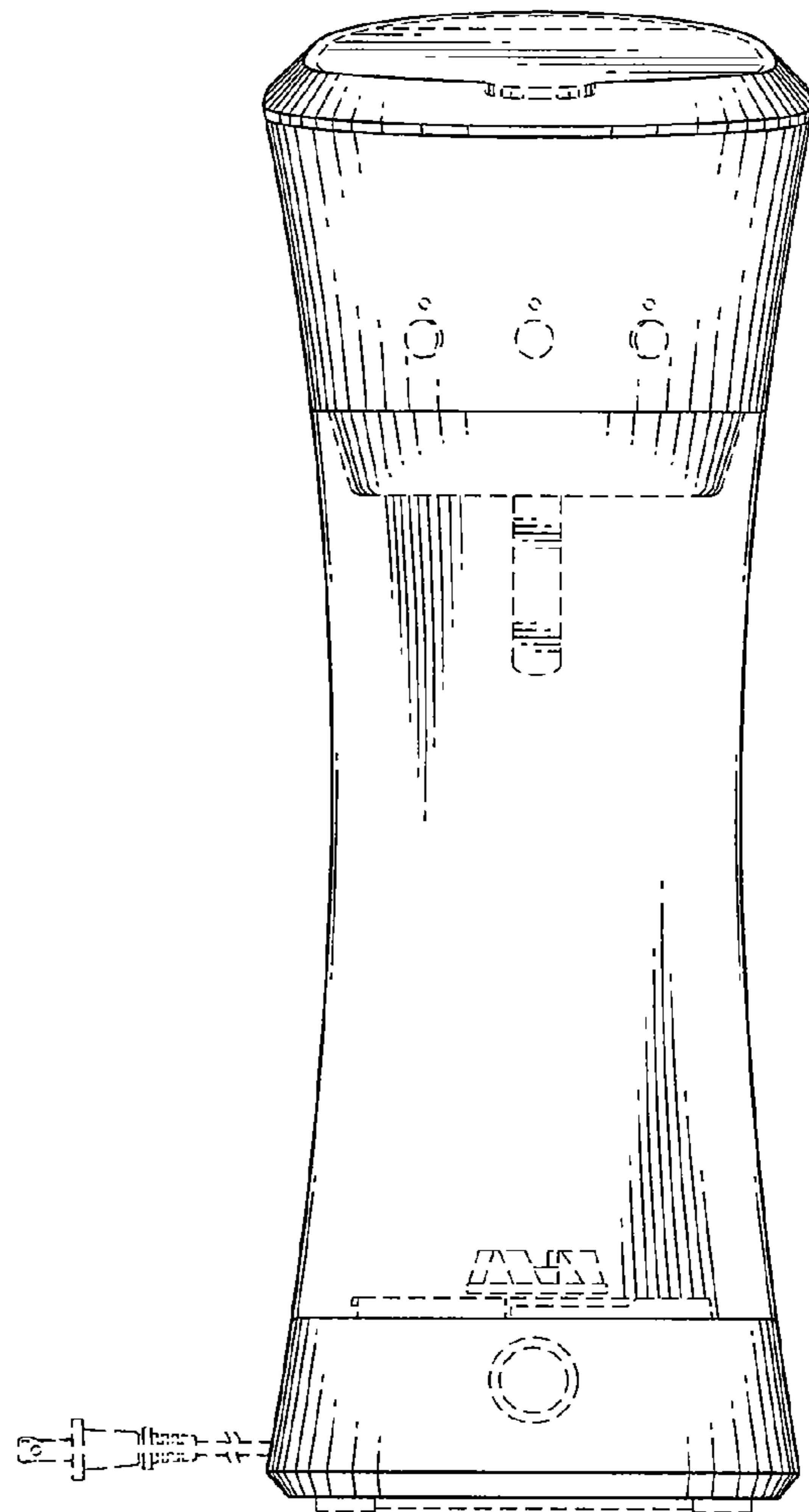

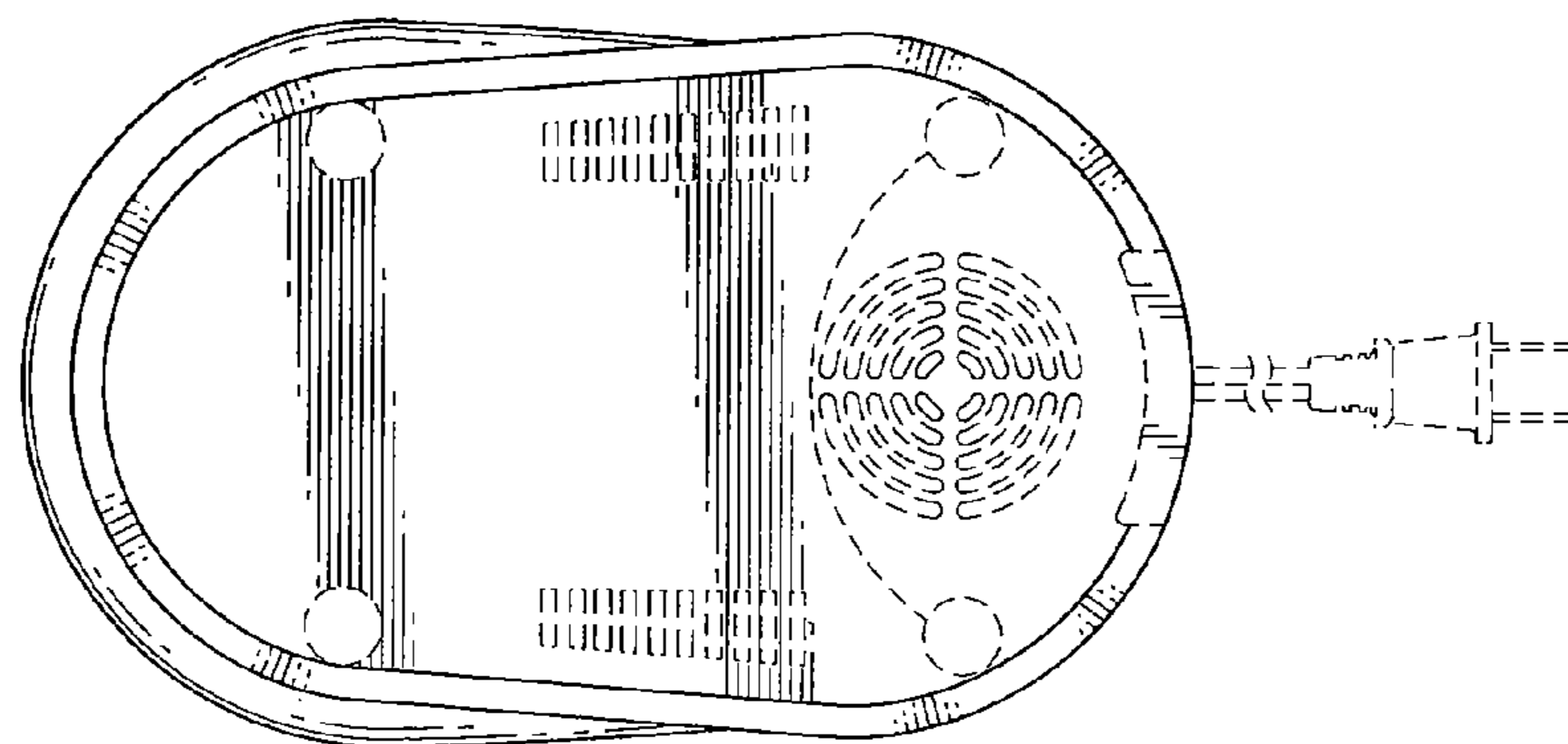

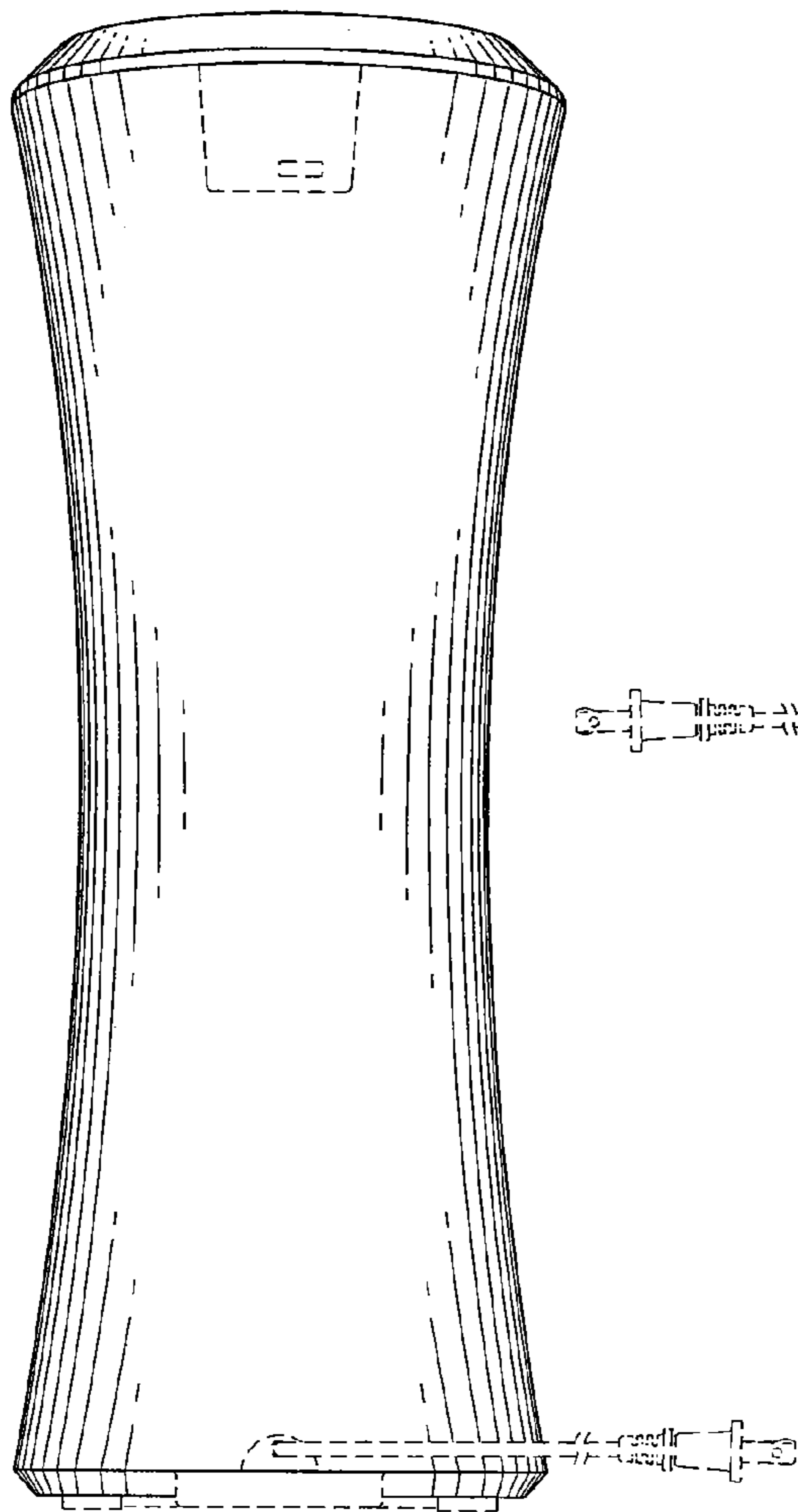

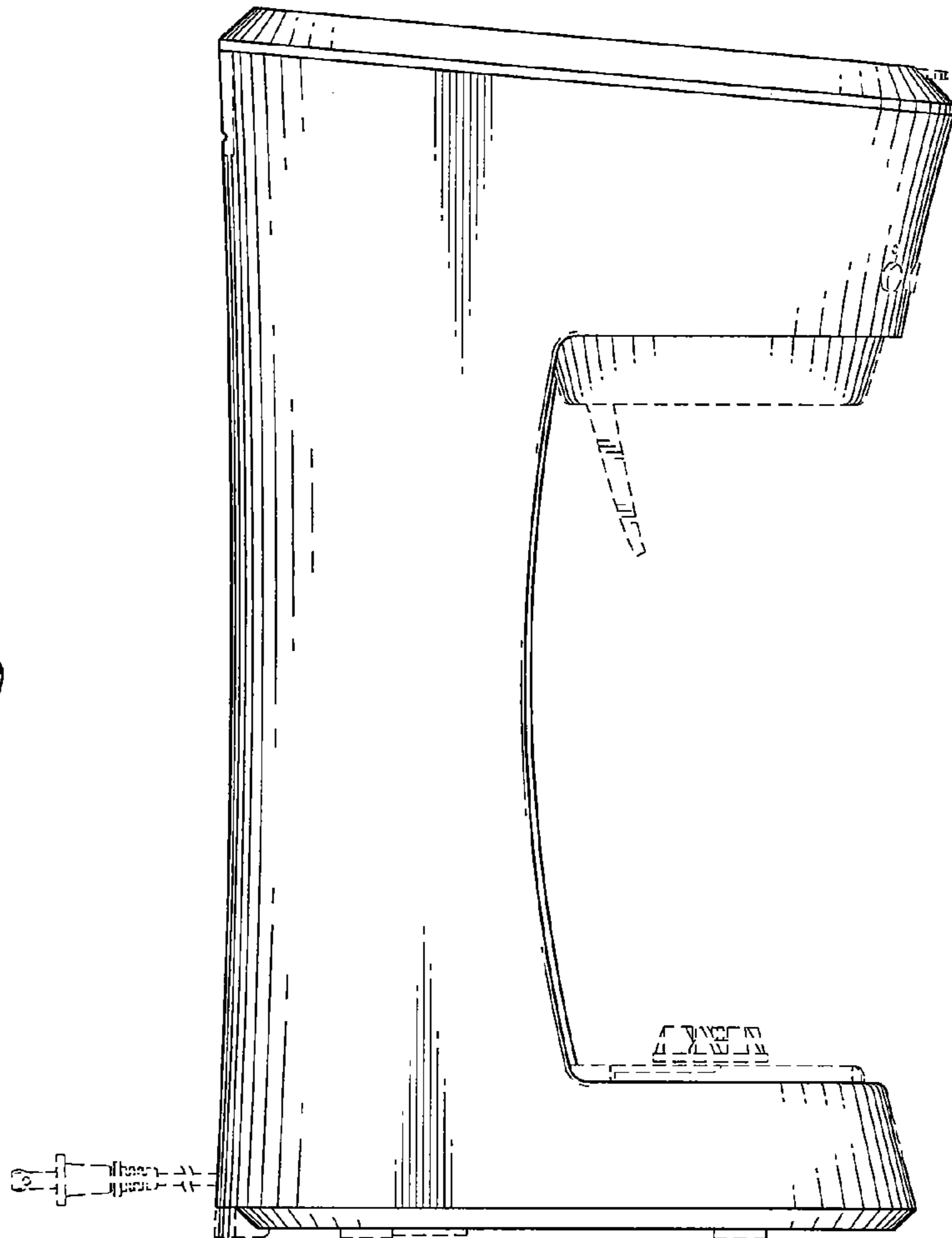

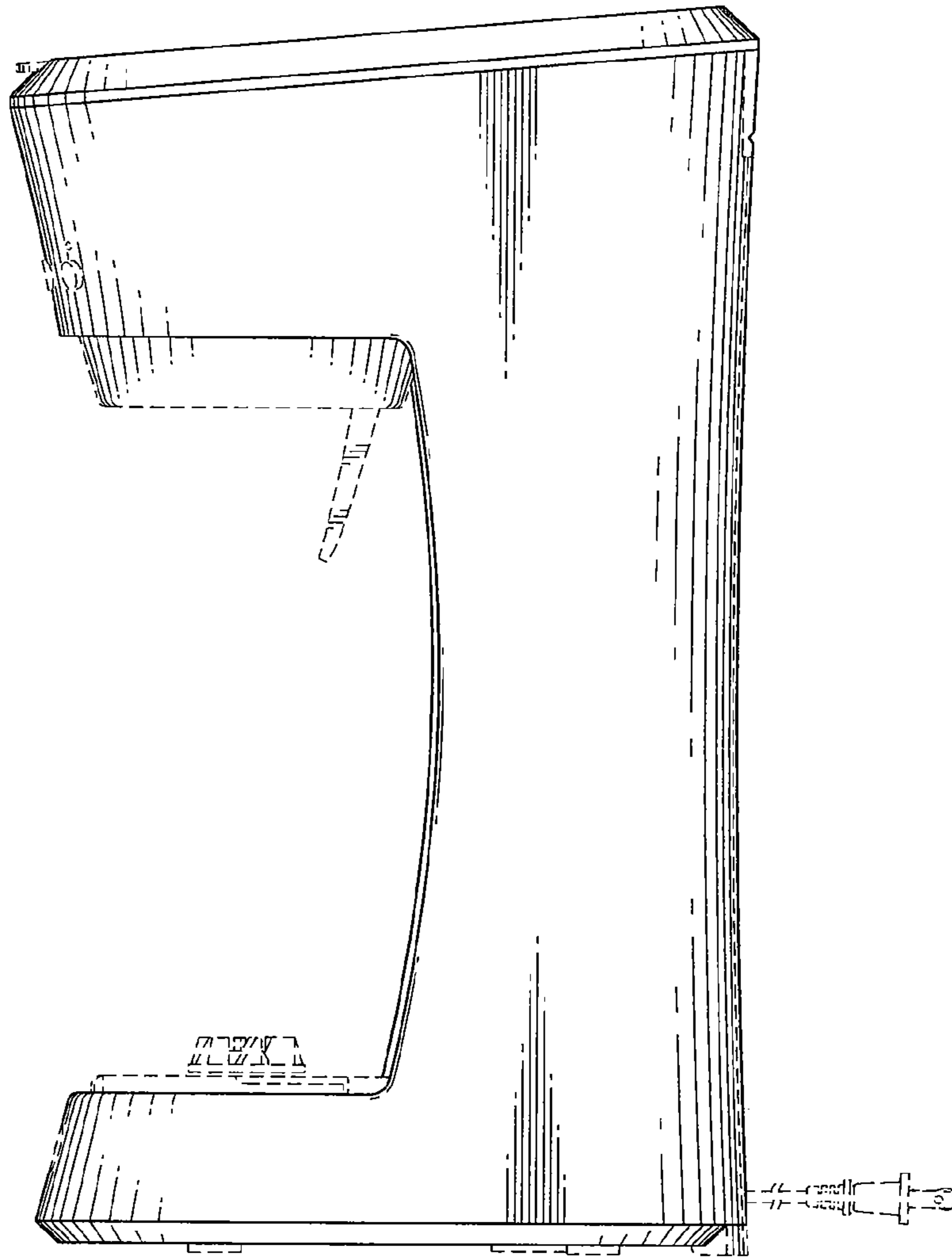
