(57) **CLAIM**

The ornamental design for a knife, as shown and described.

**DESCRIPTION**

The claimed knife is used as a back-up survival tool by members of the military, law enforcement and emergency rescue organizations, or employed for general use in activities such as camping, hiking, hunting and fishing.

FIG. 1 is a front view of a knife, showing our new design;

FIG. 2 is another front view of thereof;

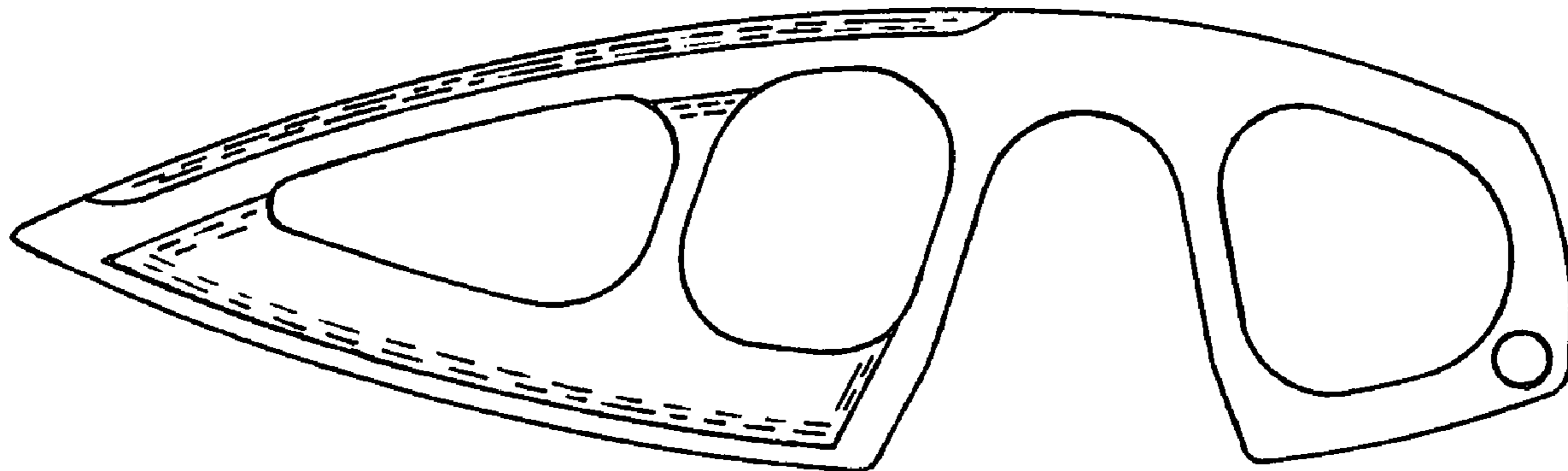
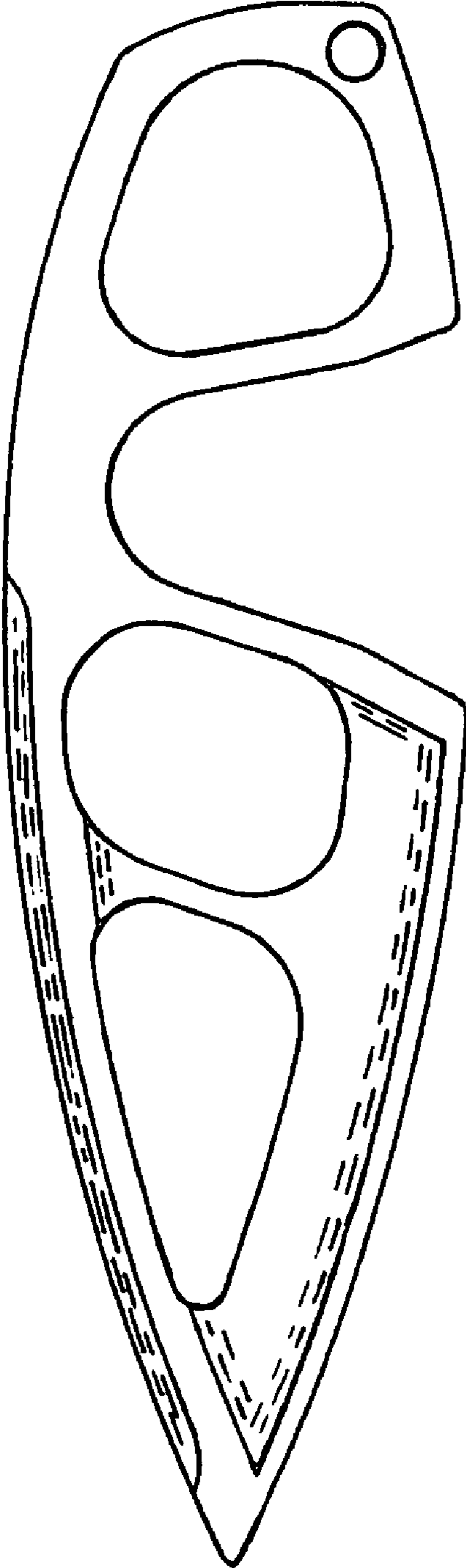

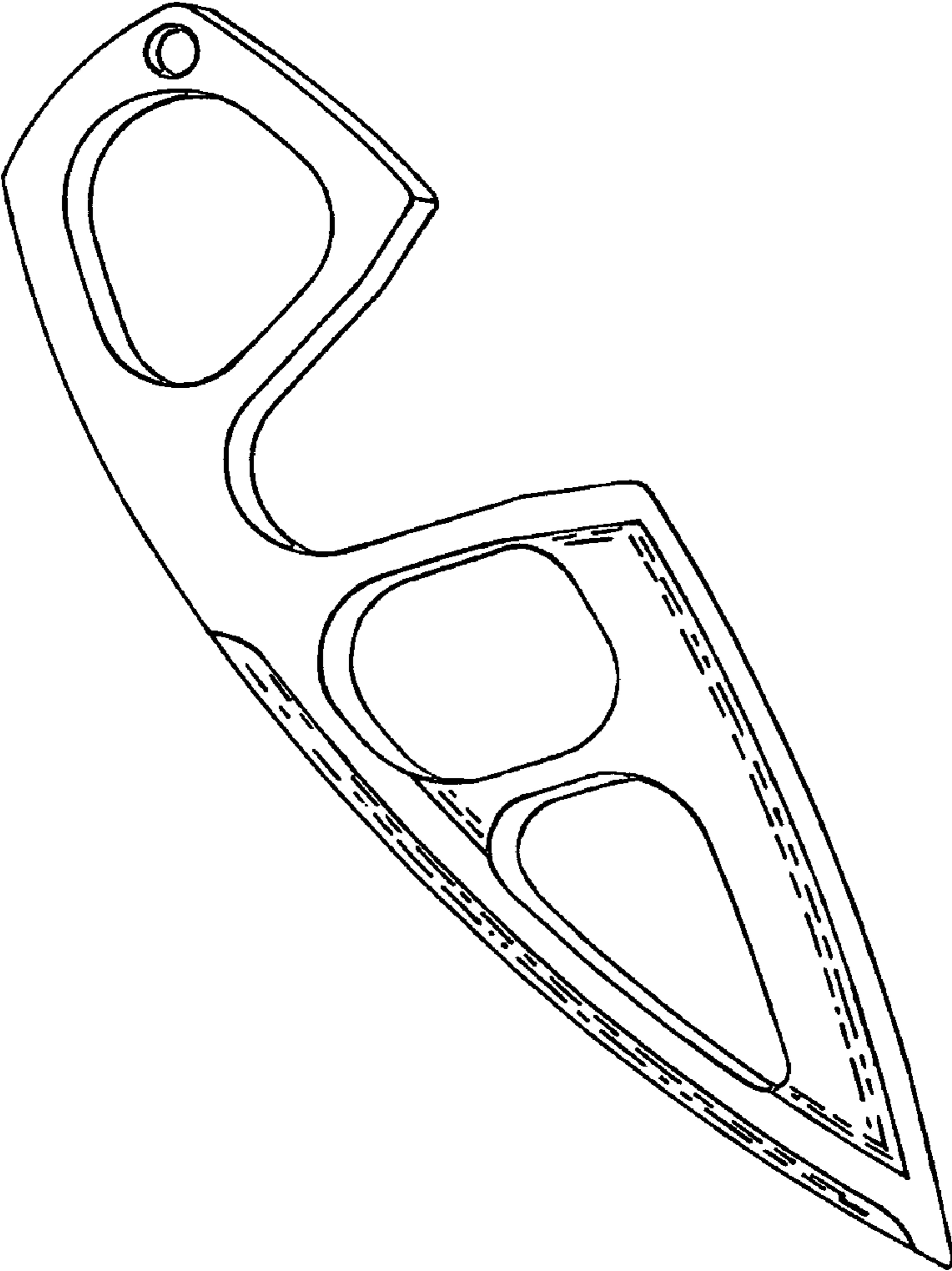

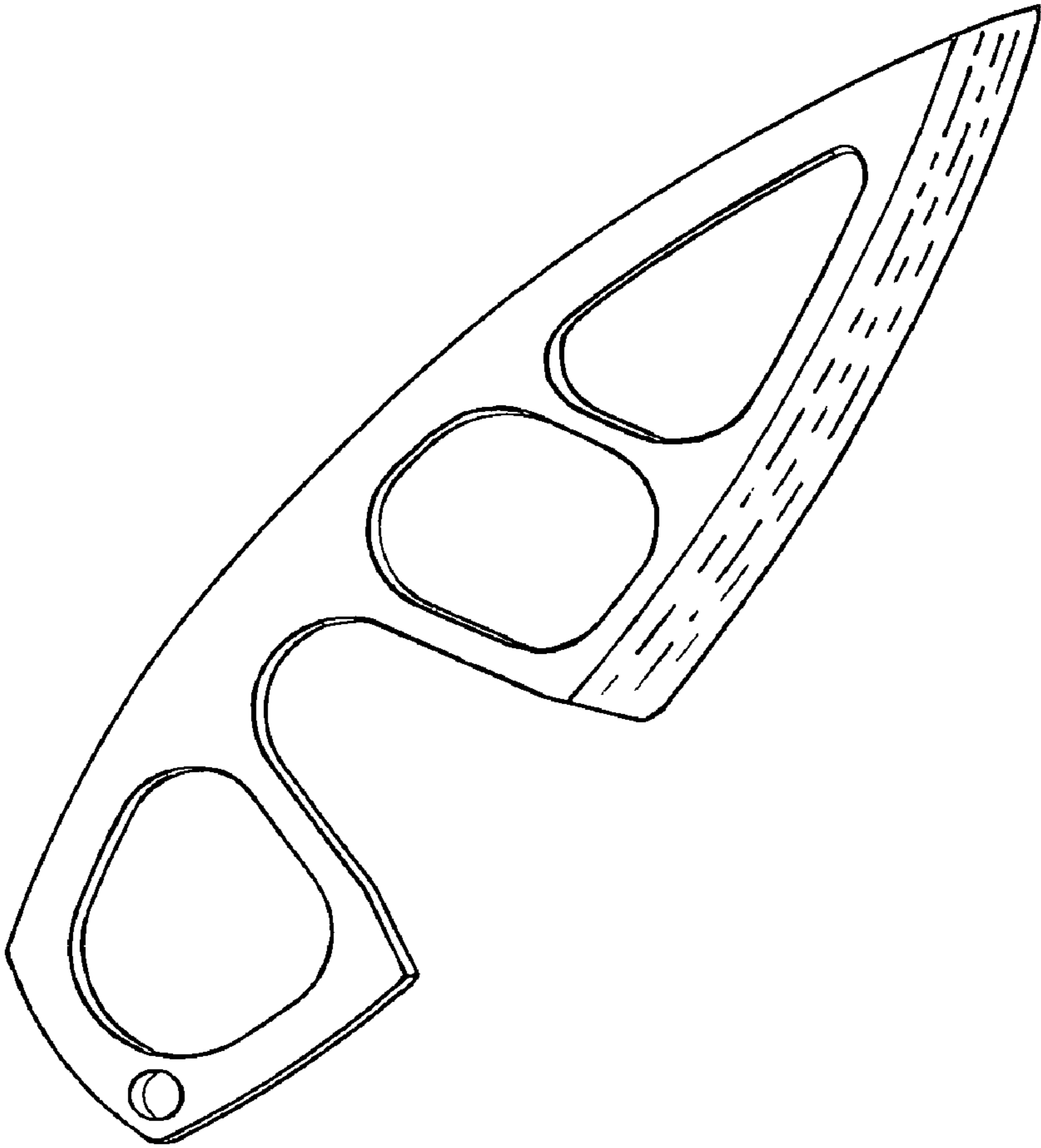

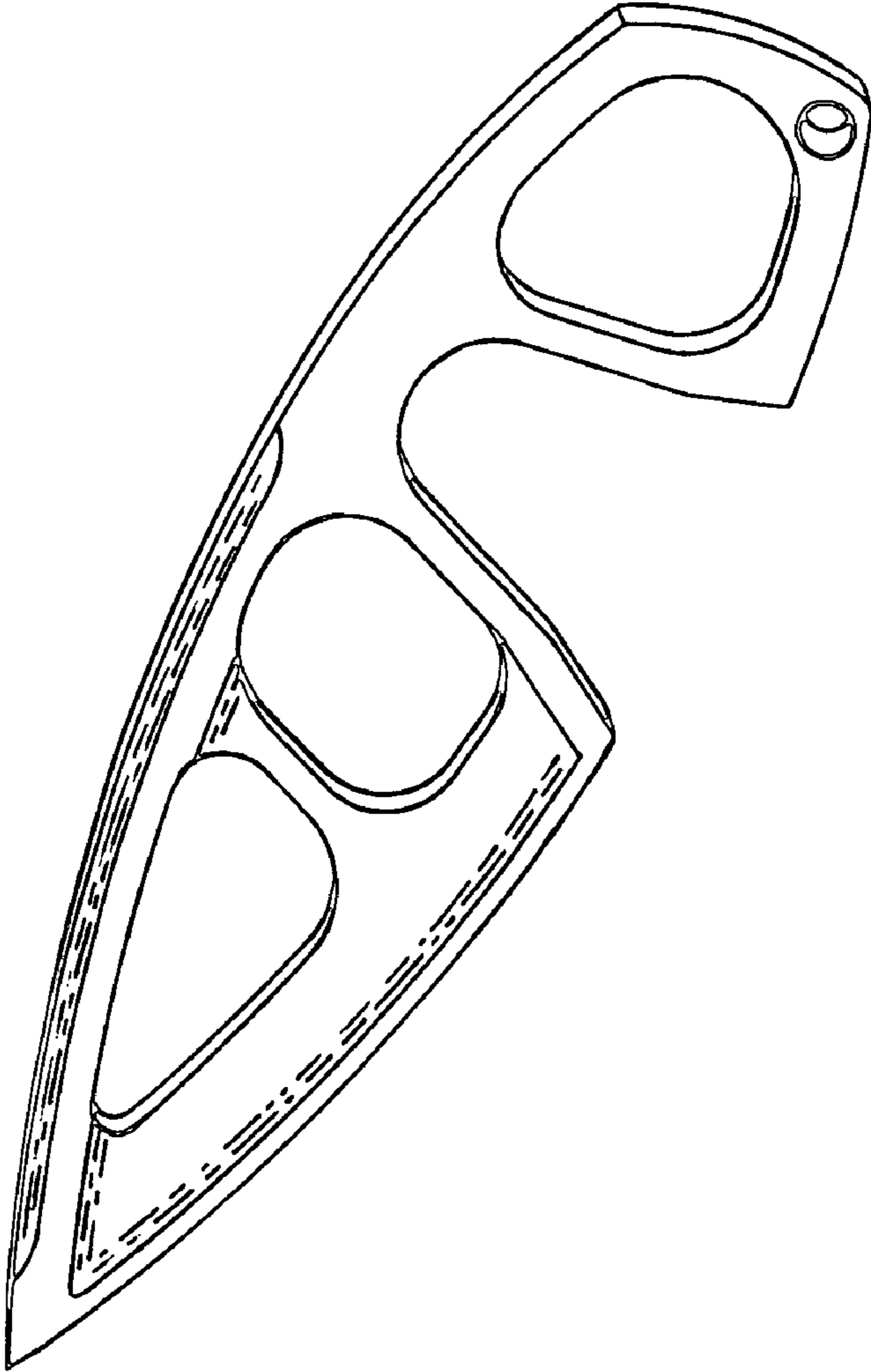
