FIG. 5 is a perspective view of a third embodiment thereof;

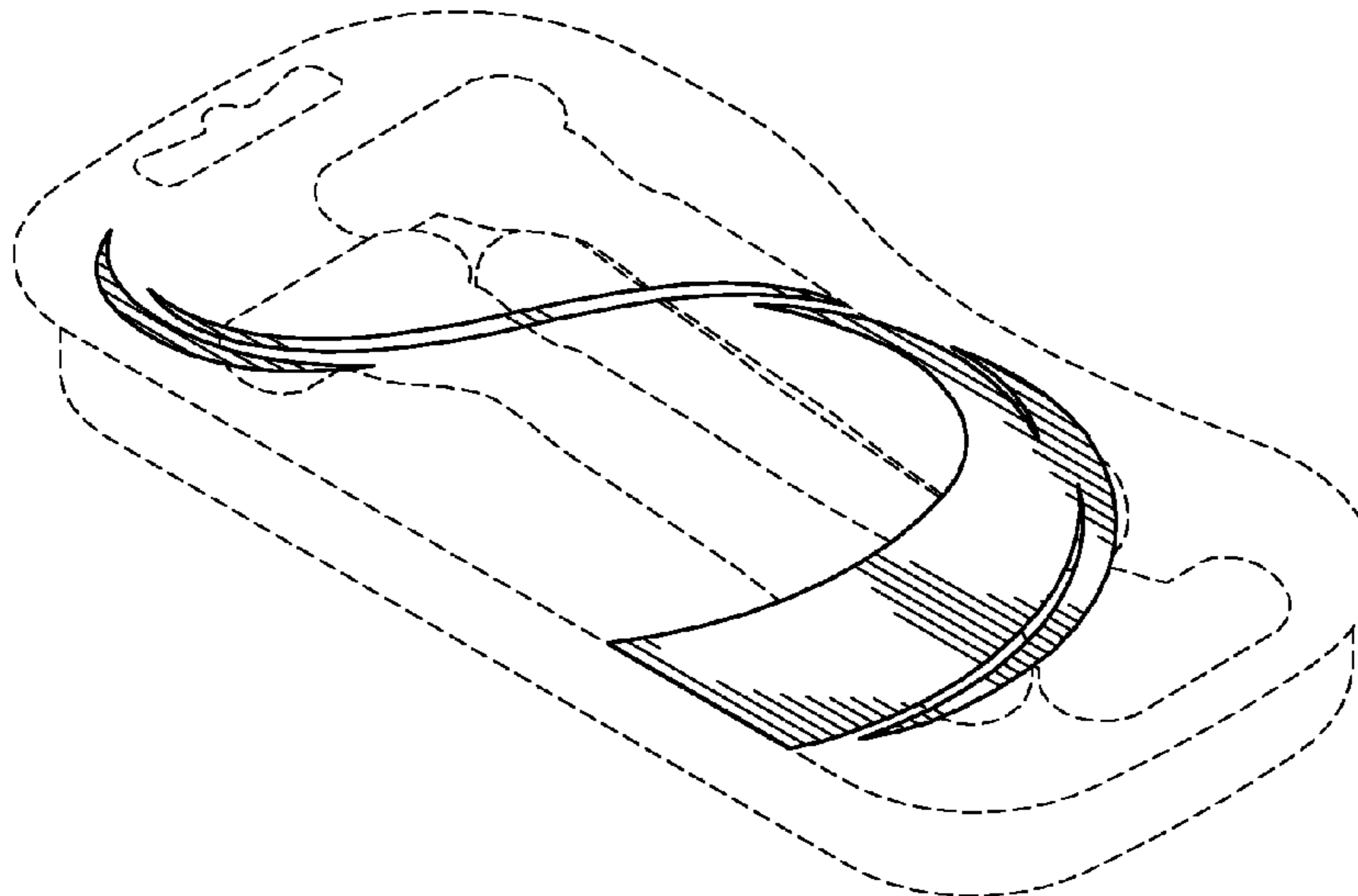
FIG. 6 is a top plan view thereof;

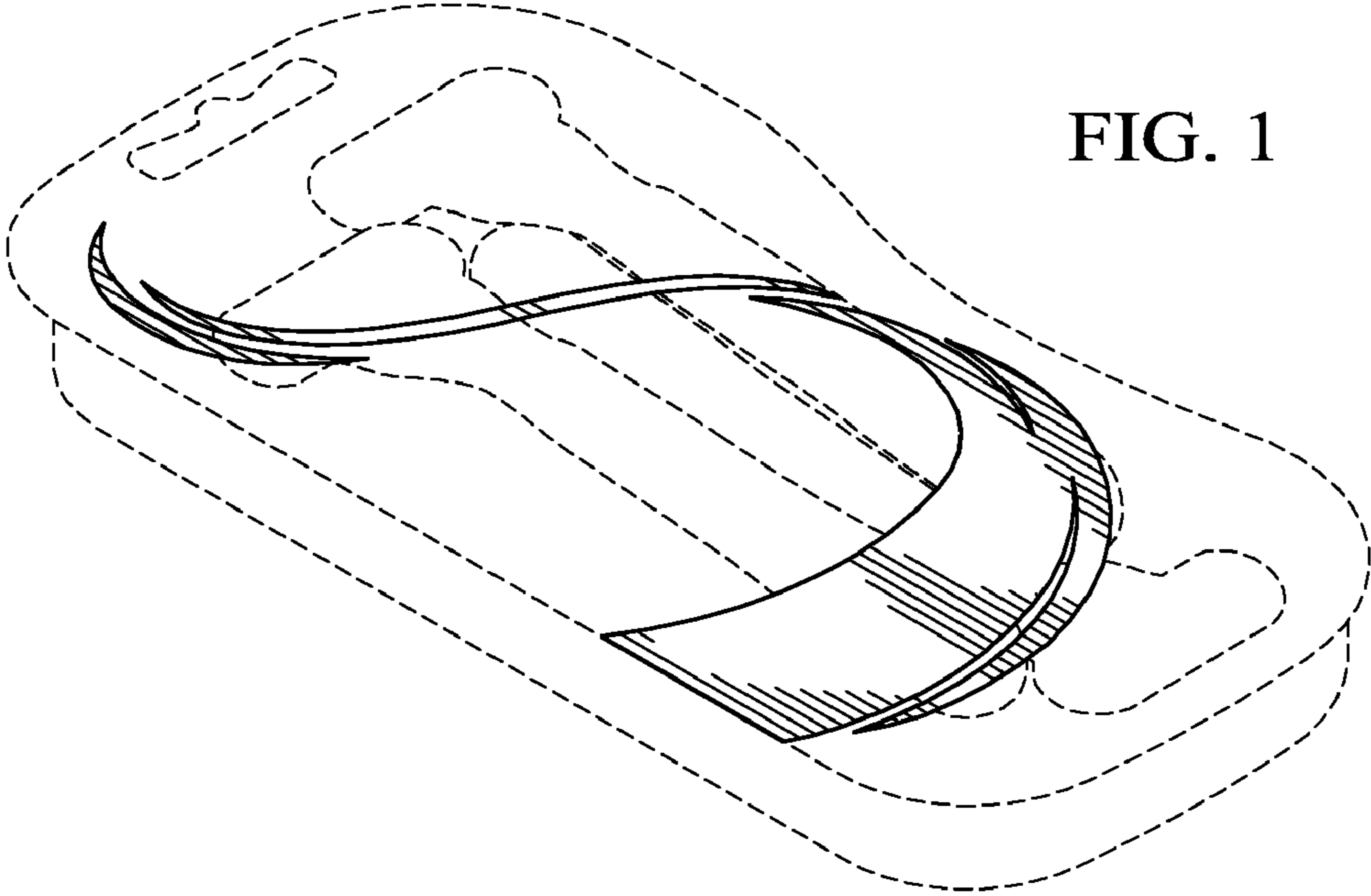

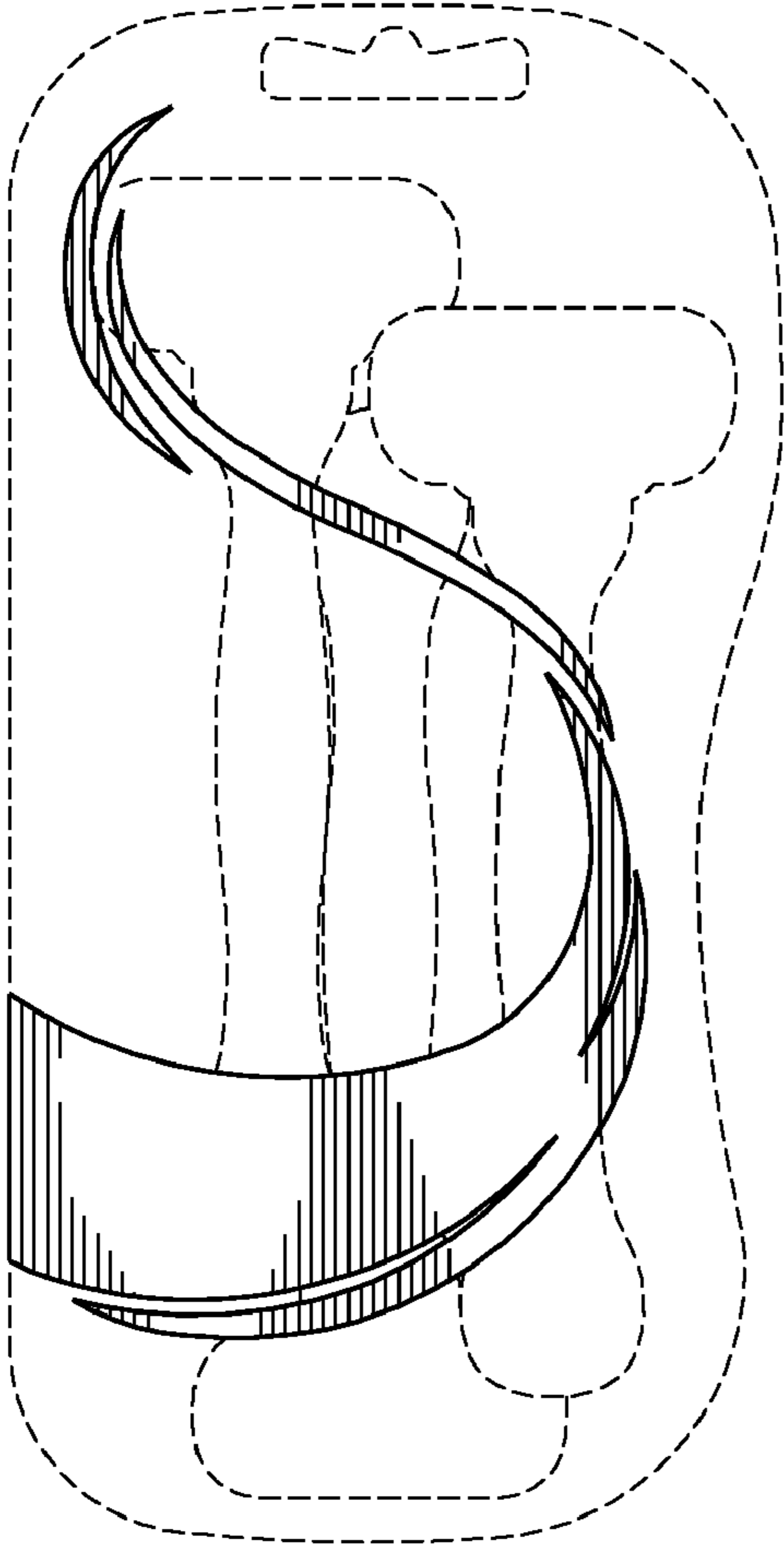

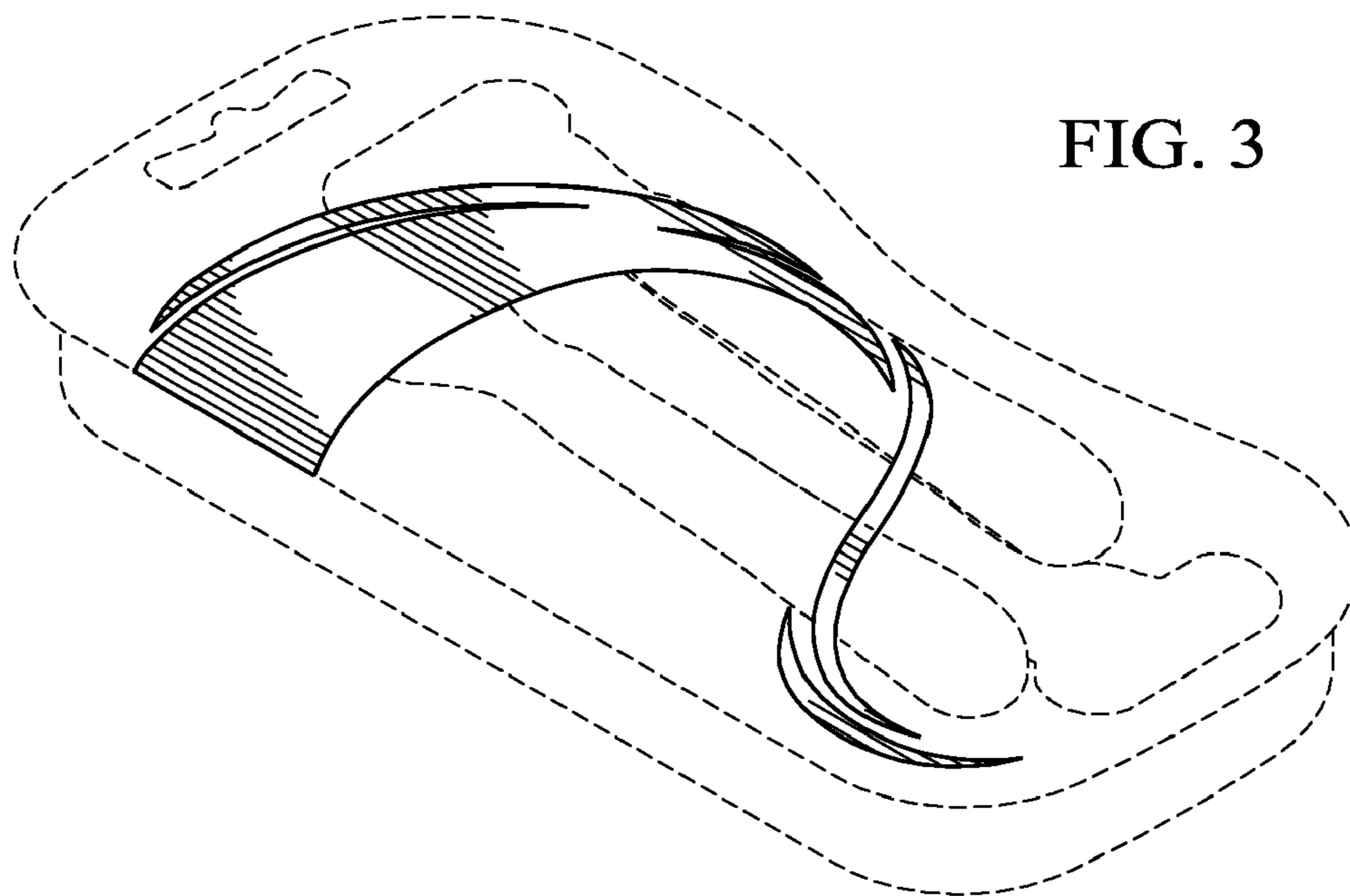

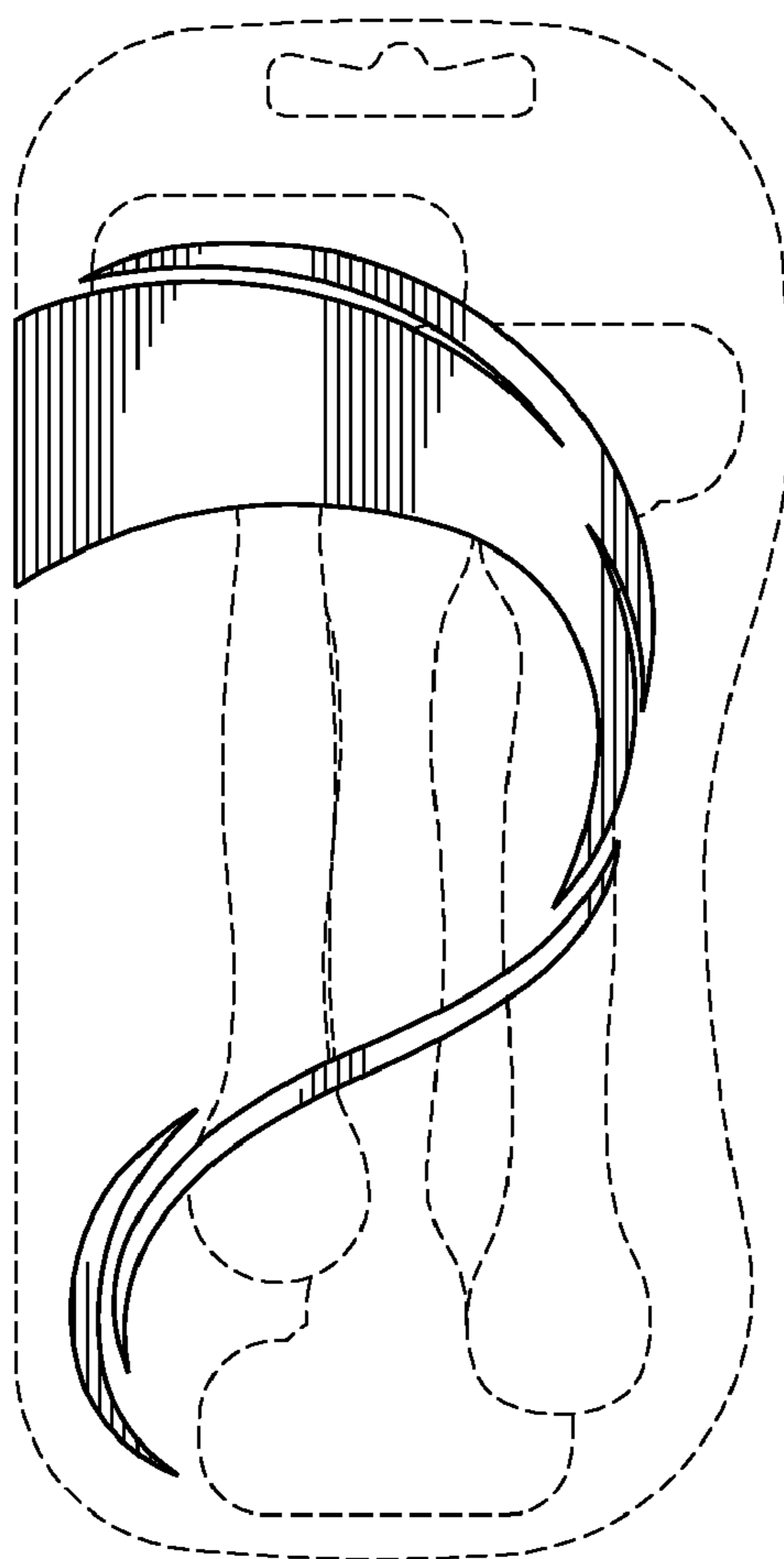

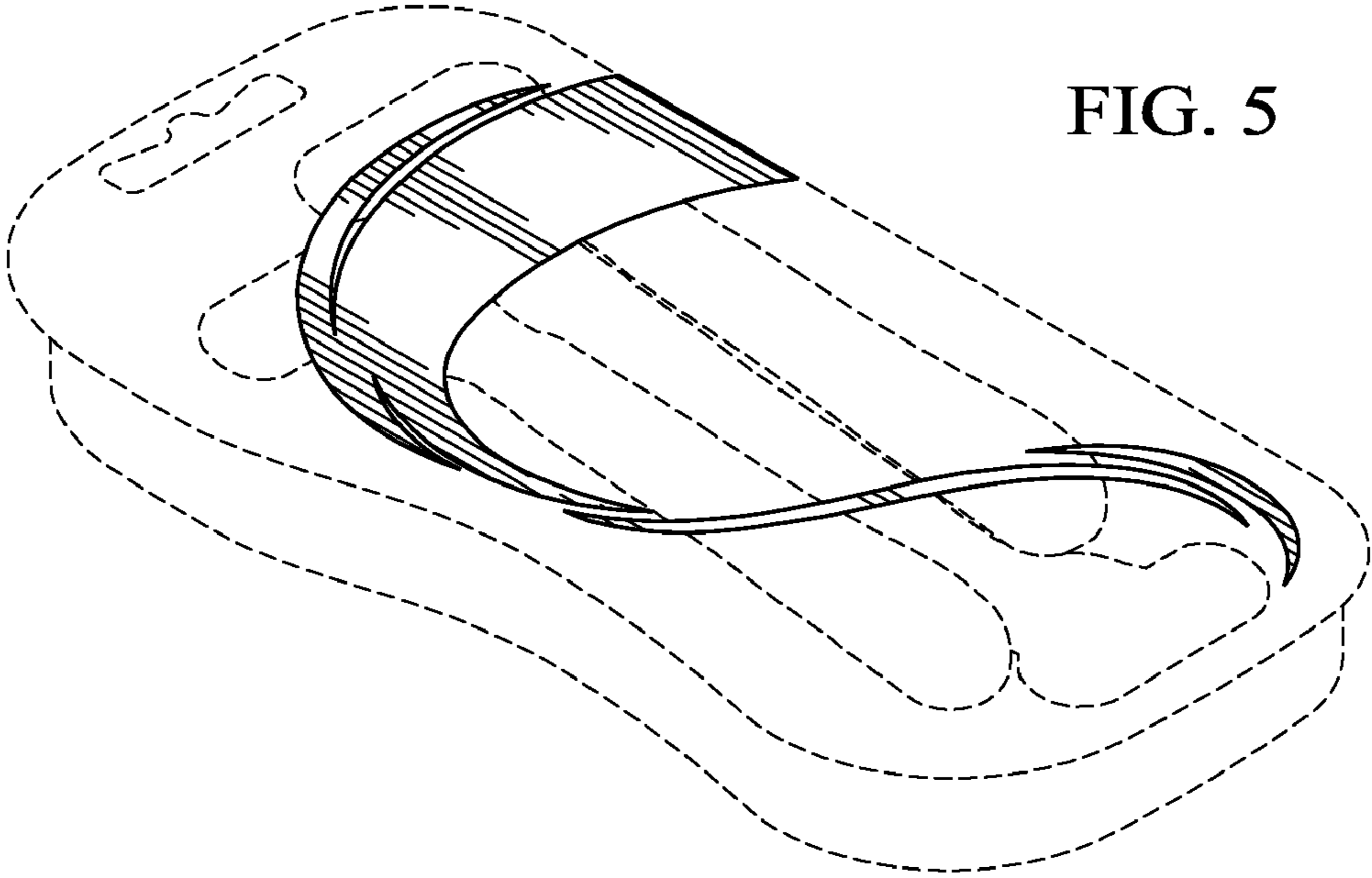

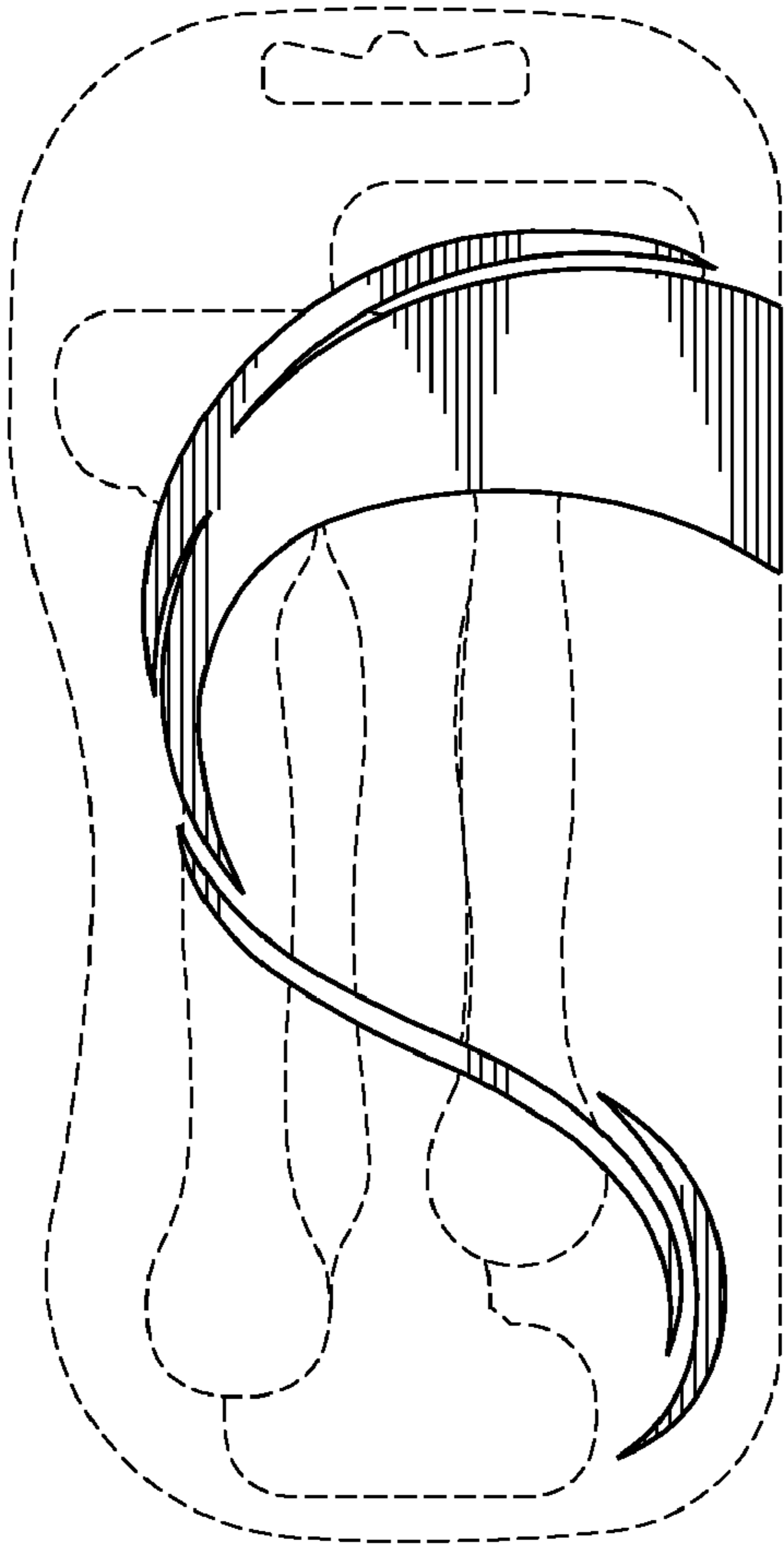

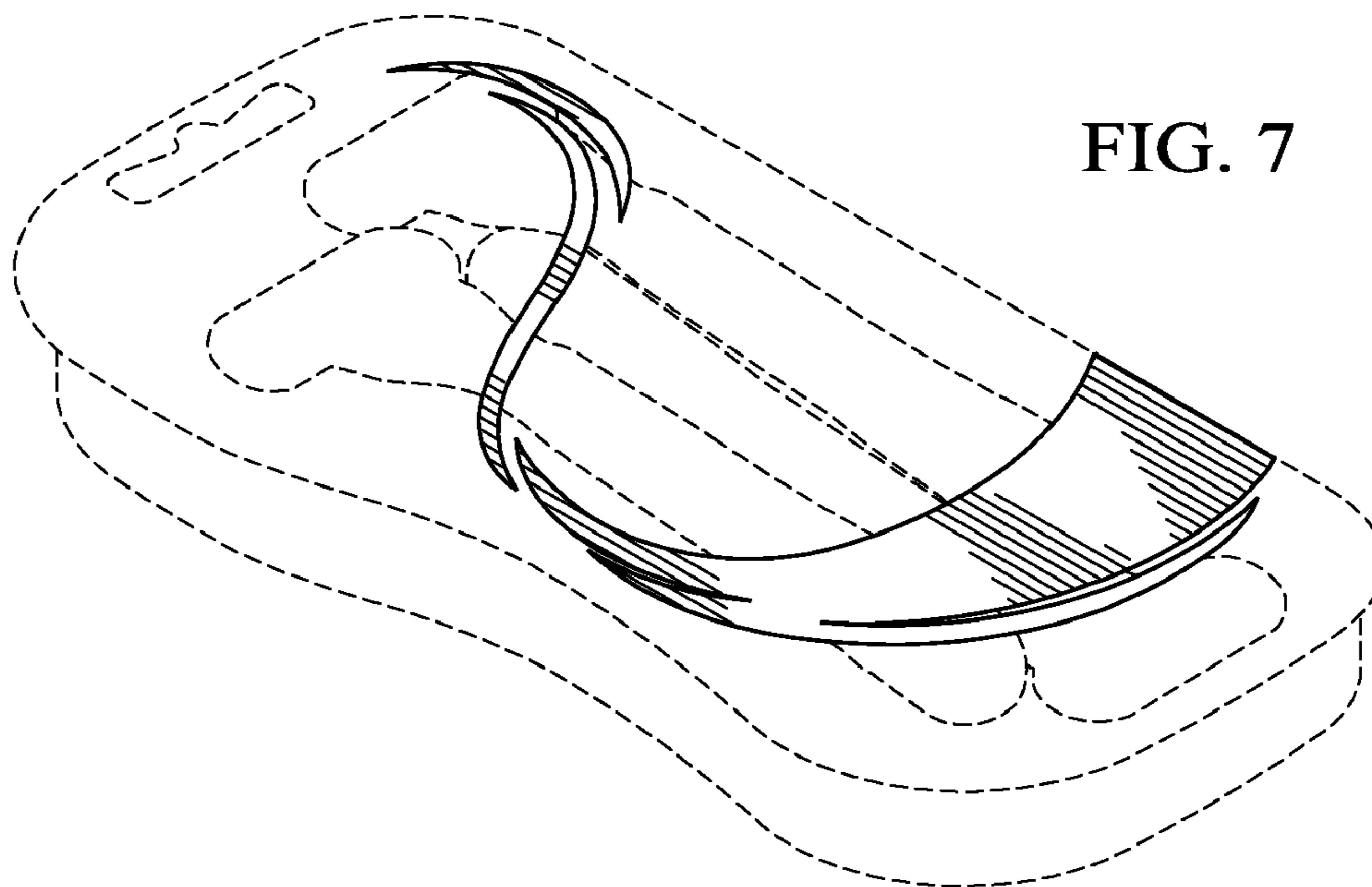

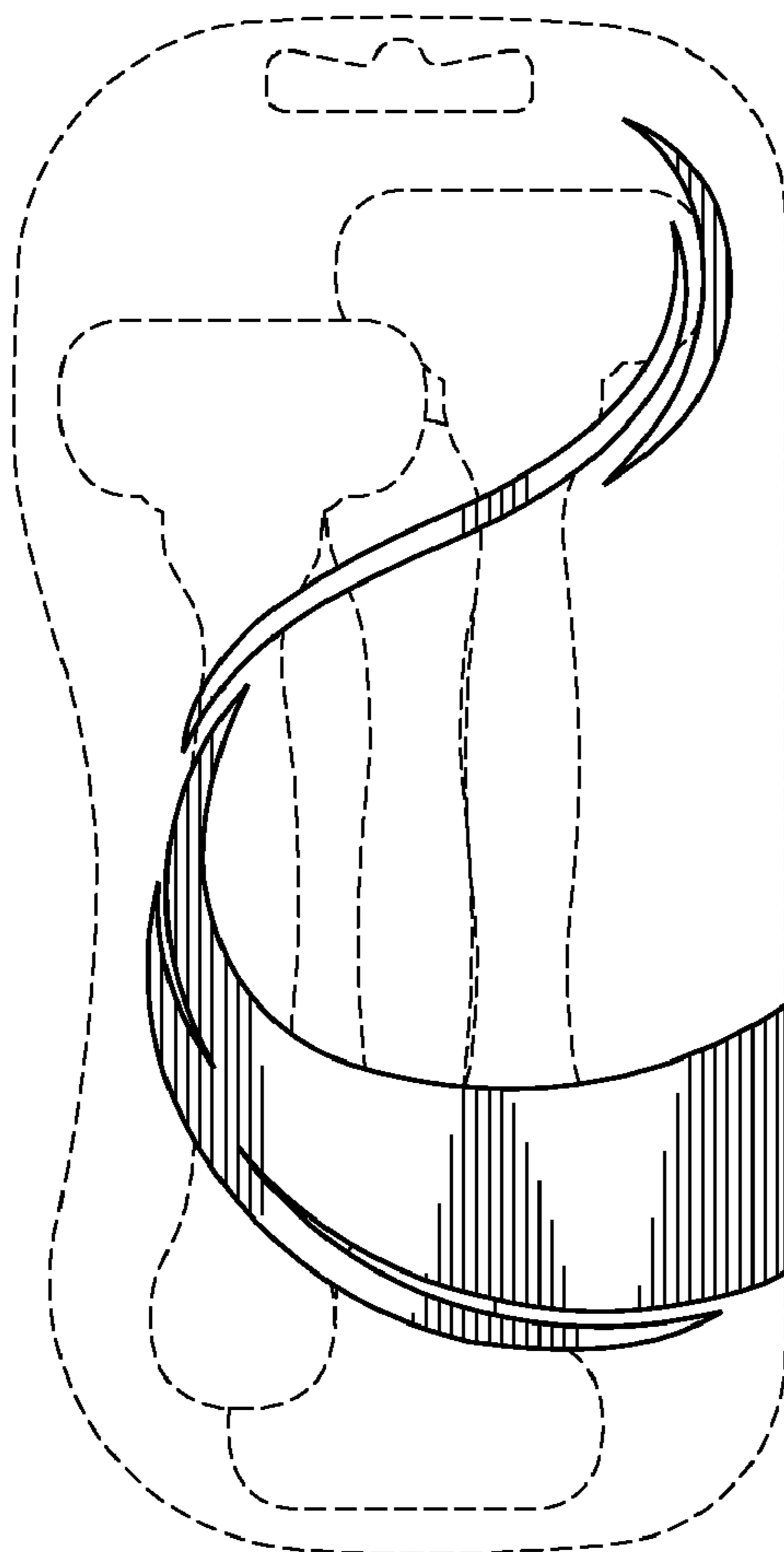
