**DESCRIPTION**

FIG. 1 is a perspective view of the pump actuator of our design.

FIG. 2 is a front elevation view thereof.

FIG. 3 is a rear elevation view thereof.

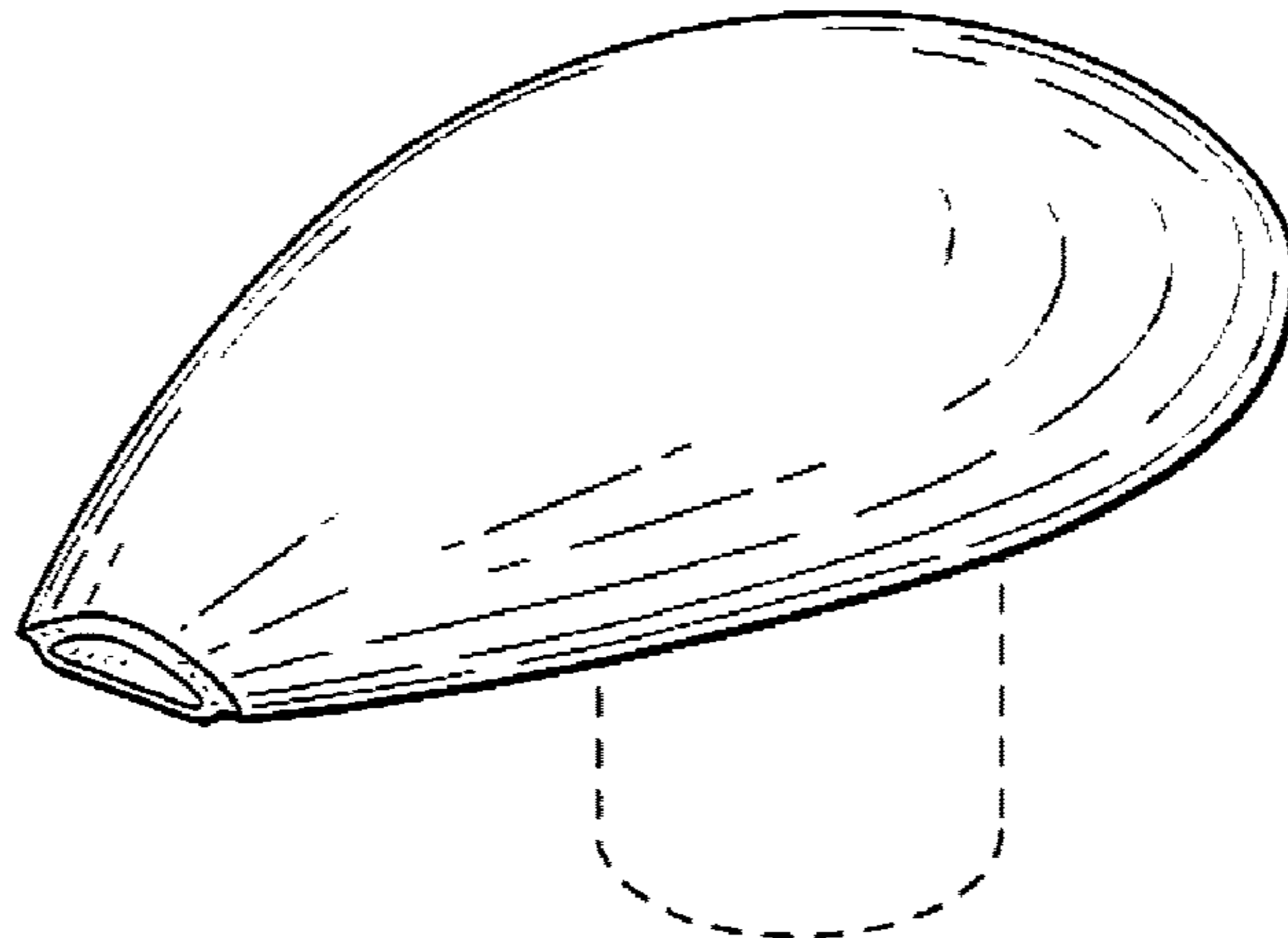
FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image thereof.

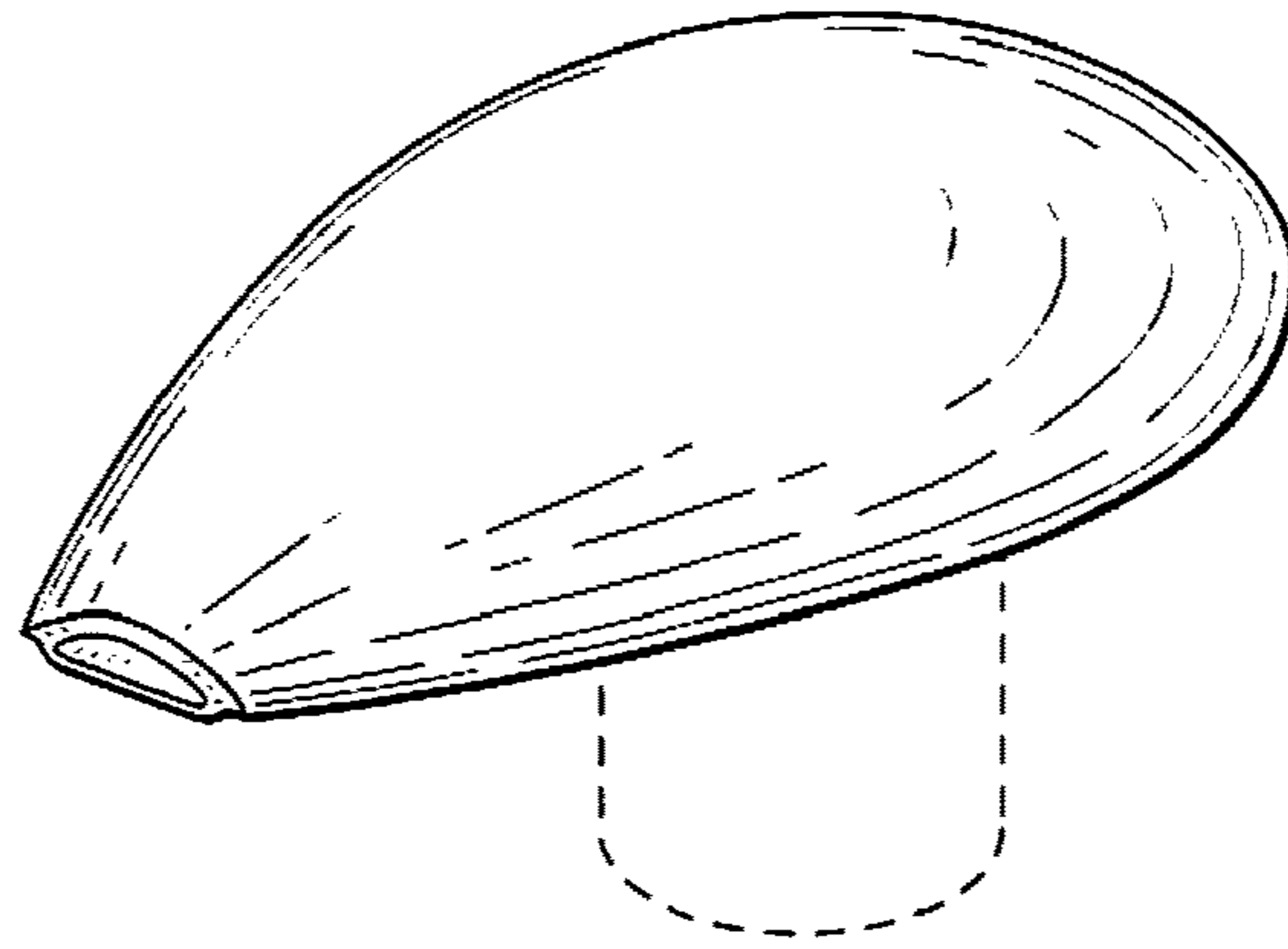

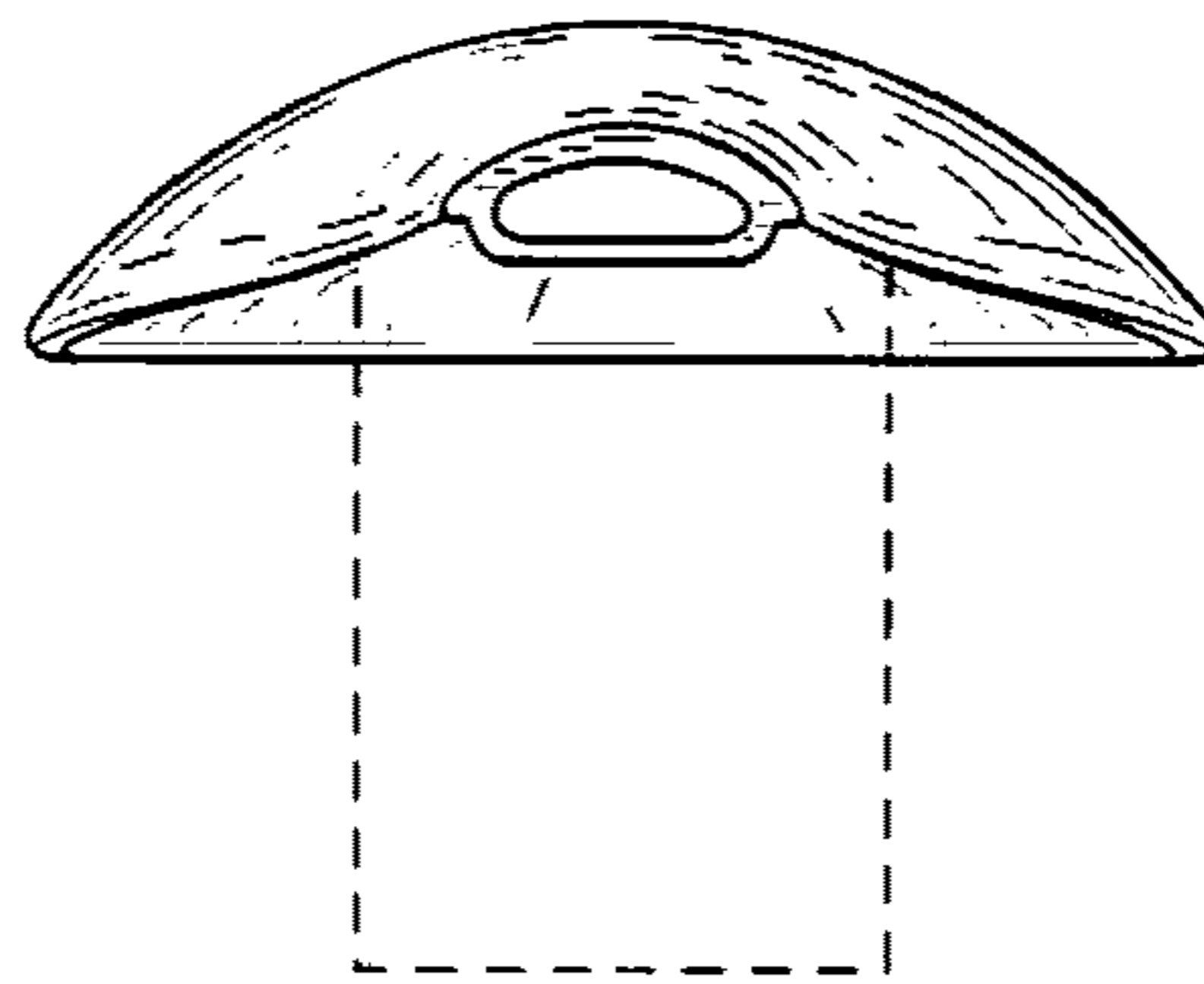

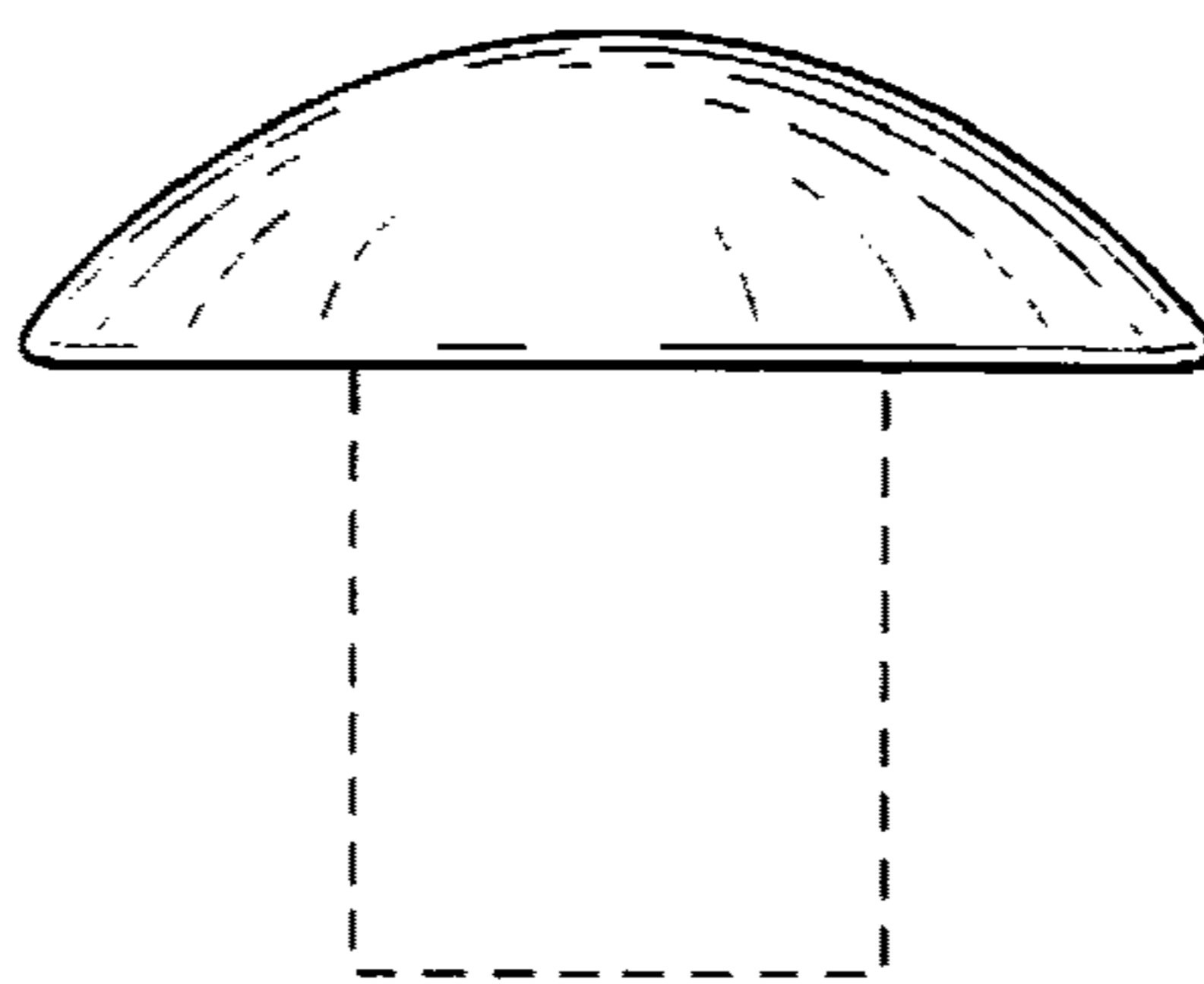

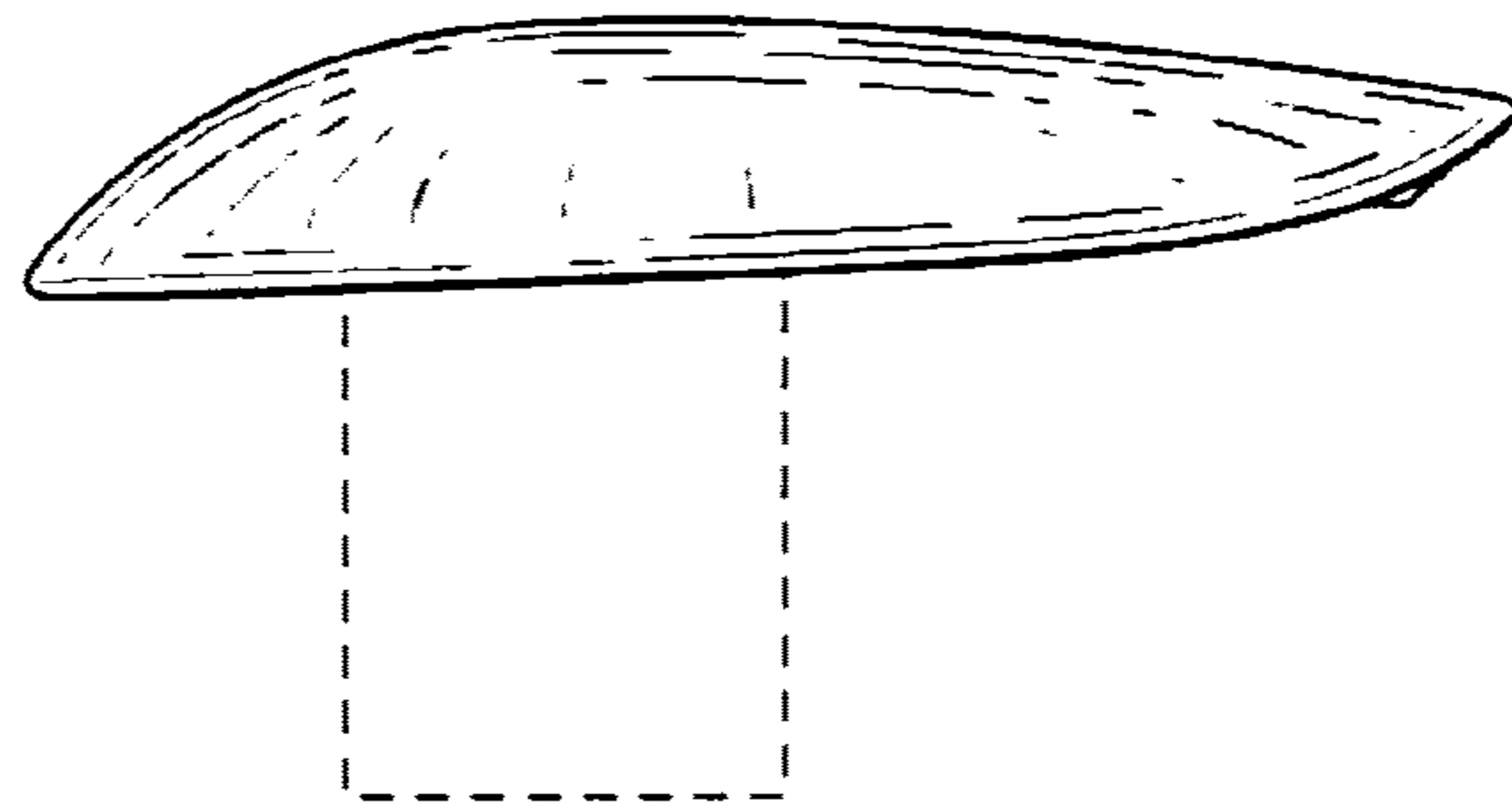

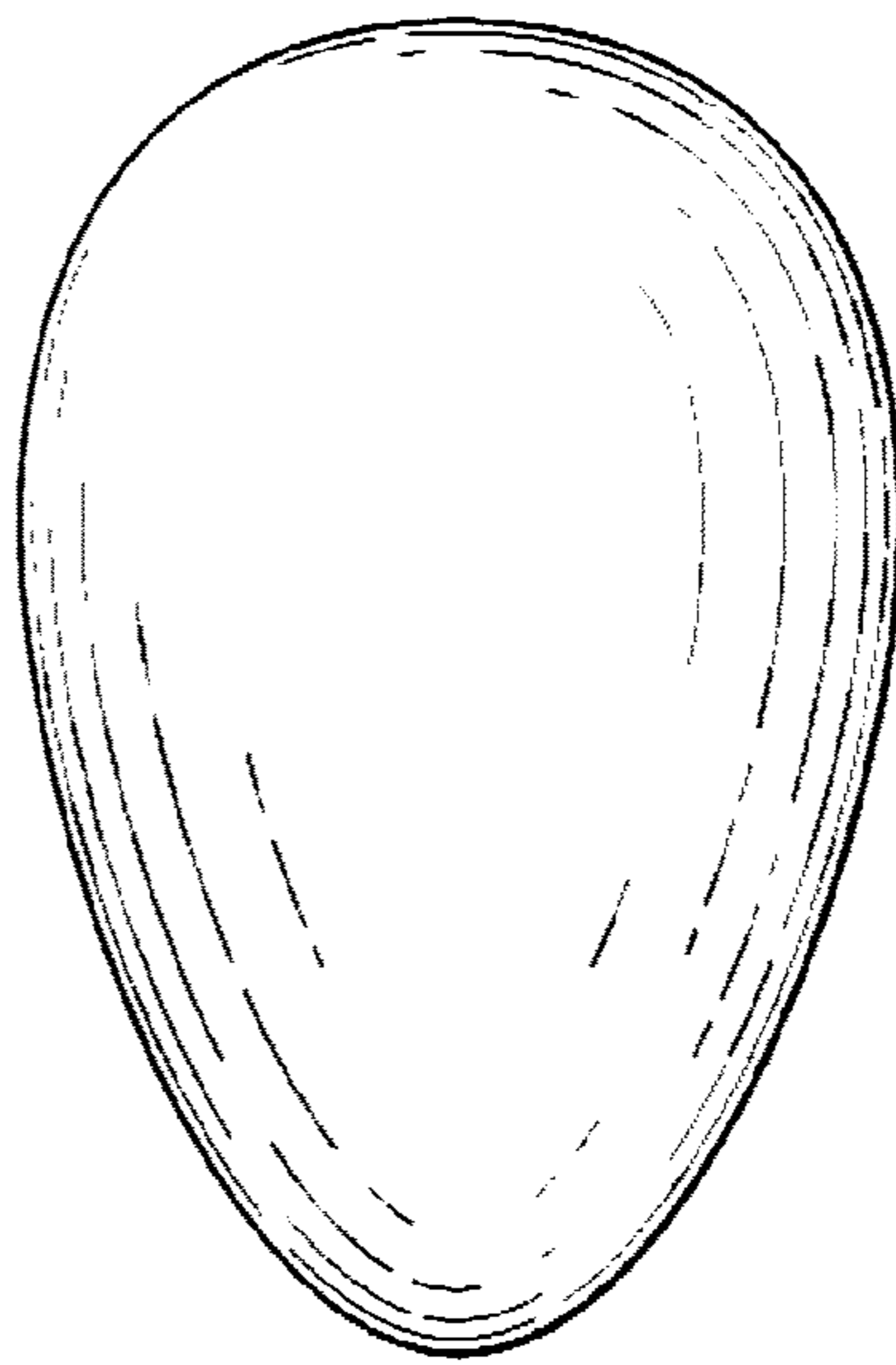

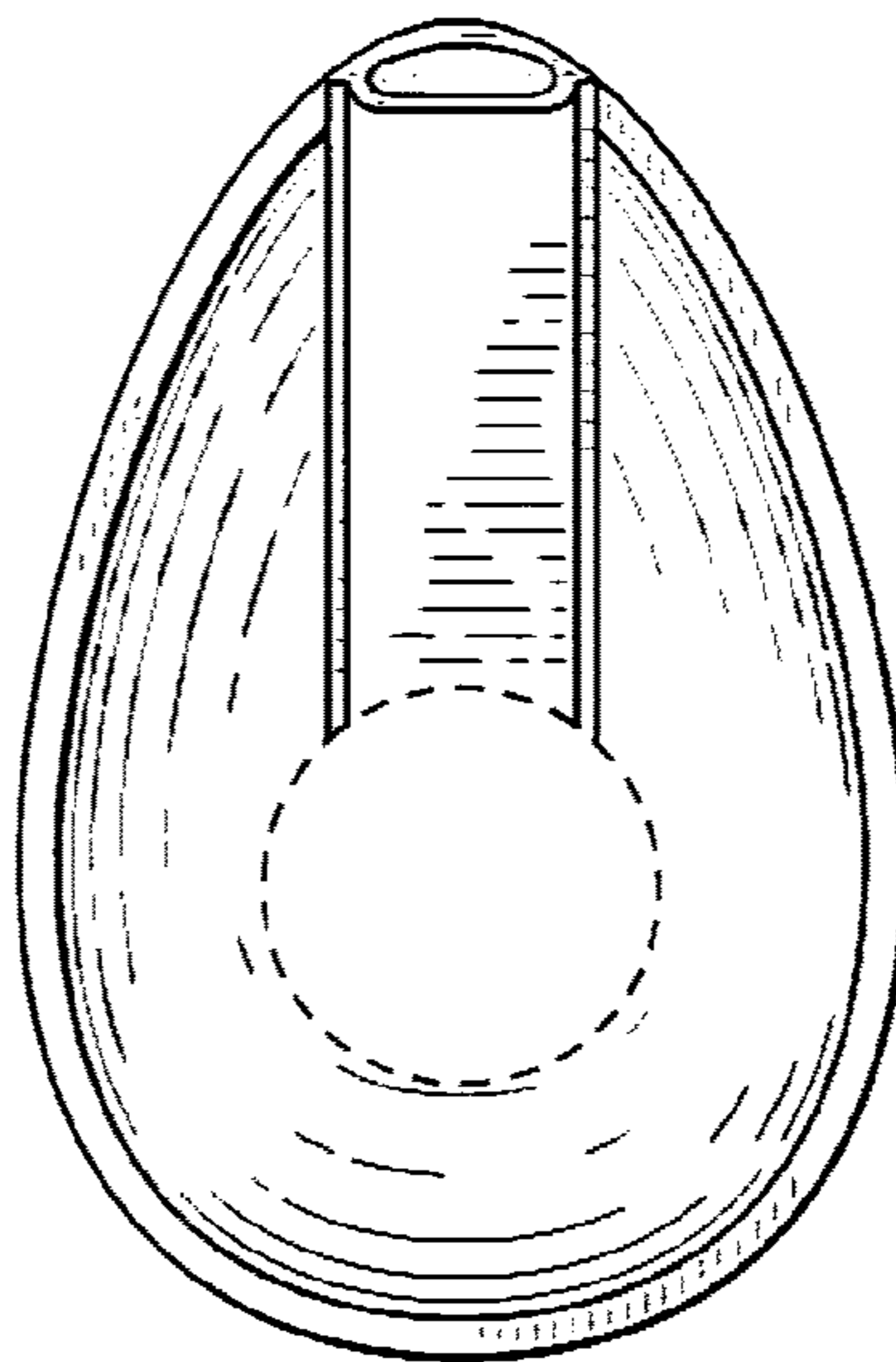
