DESCRIPTION

FIG. 1 is a top view of the carbon monoxide smoke alarm according to the present invention.

FIG. 4 is a front view of the carbon monoxide smoke alarm of FIG. 1.

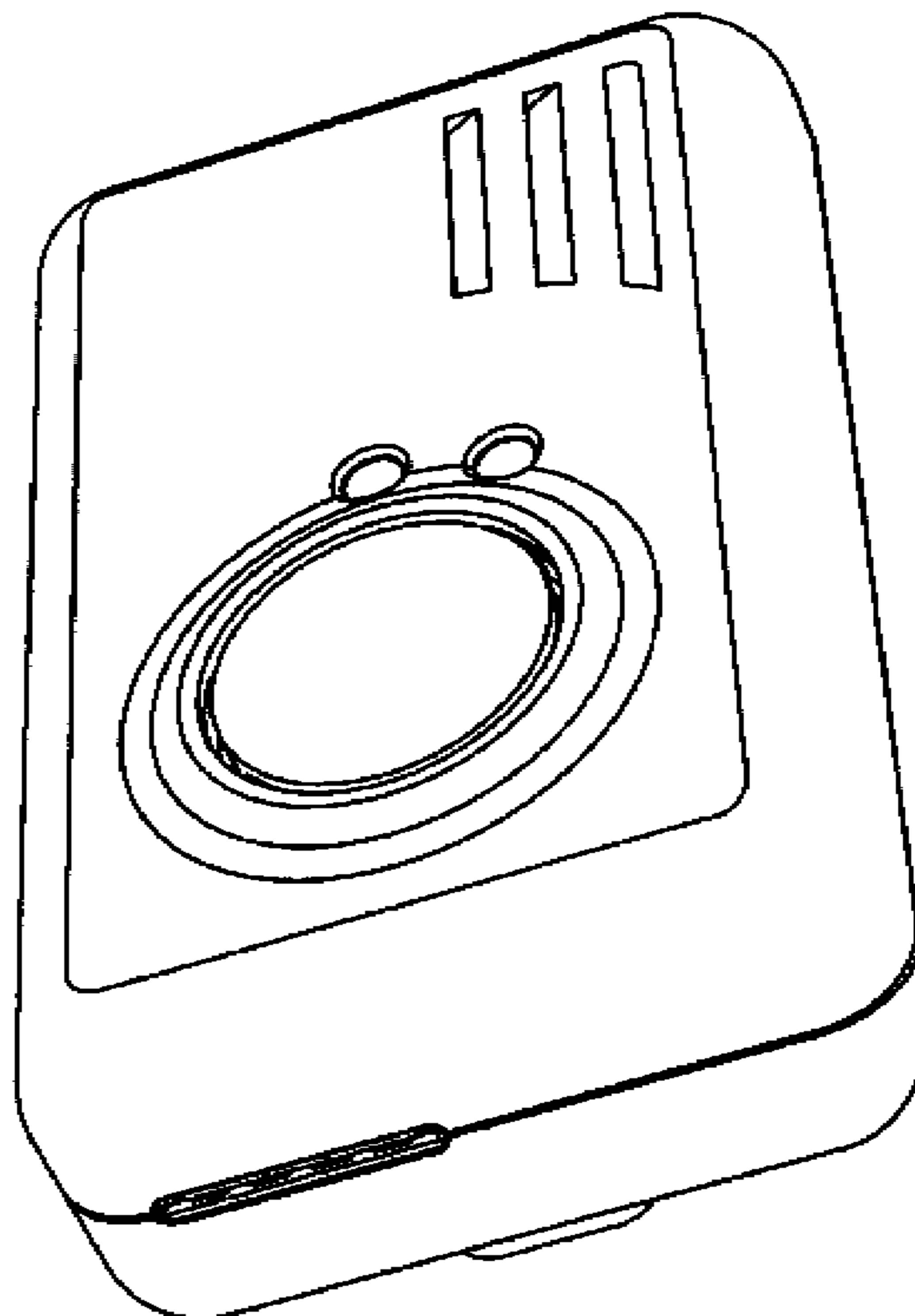
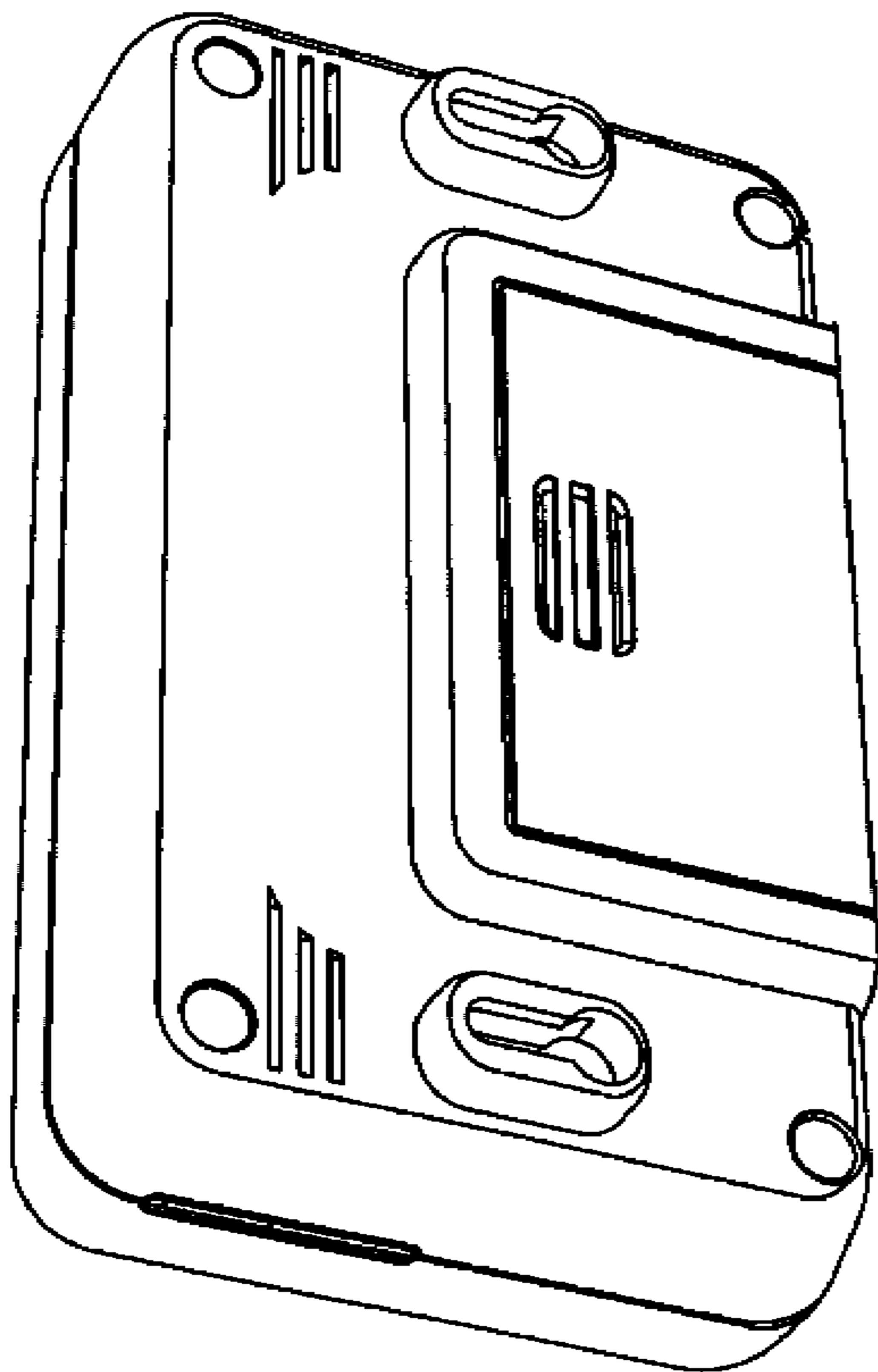
FIG. 5 is a perspective front view of the carbon monoxide smoke alarm of FIG. 1.

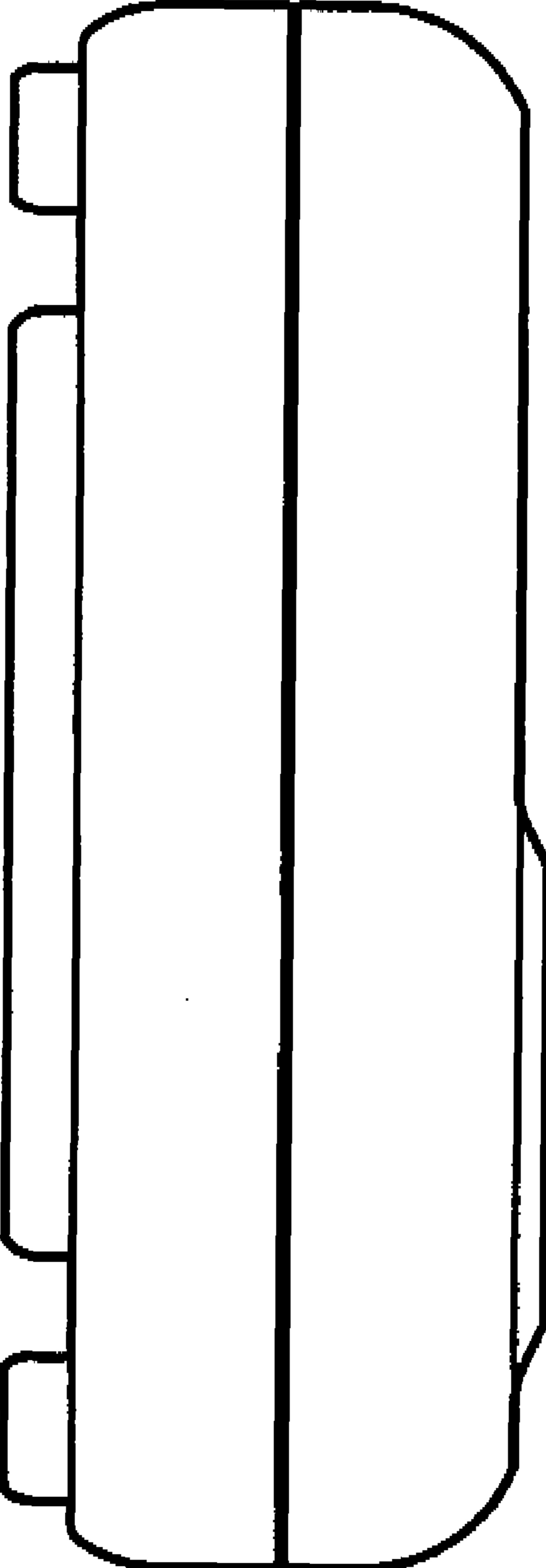

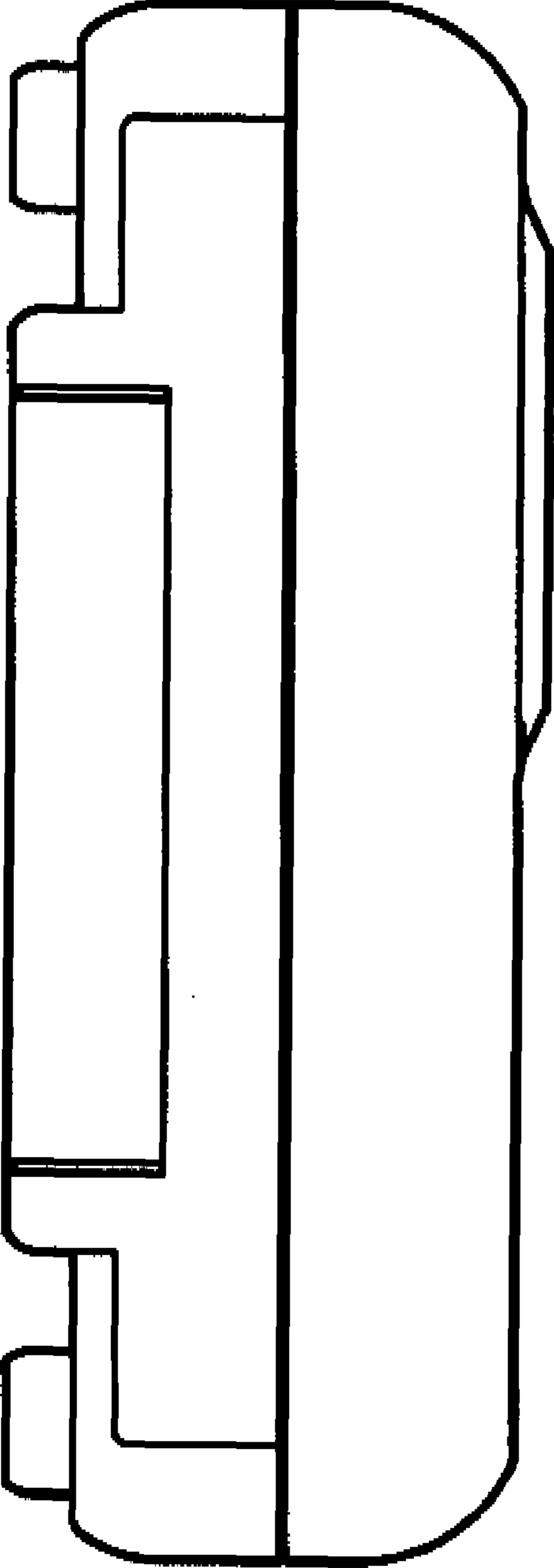

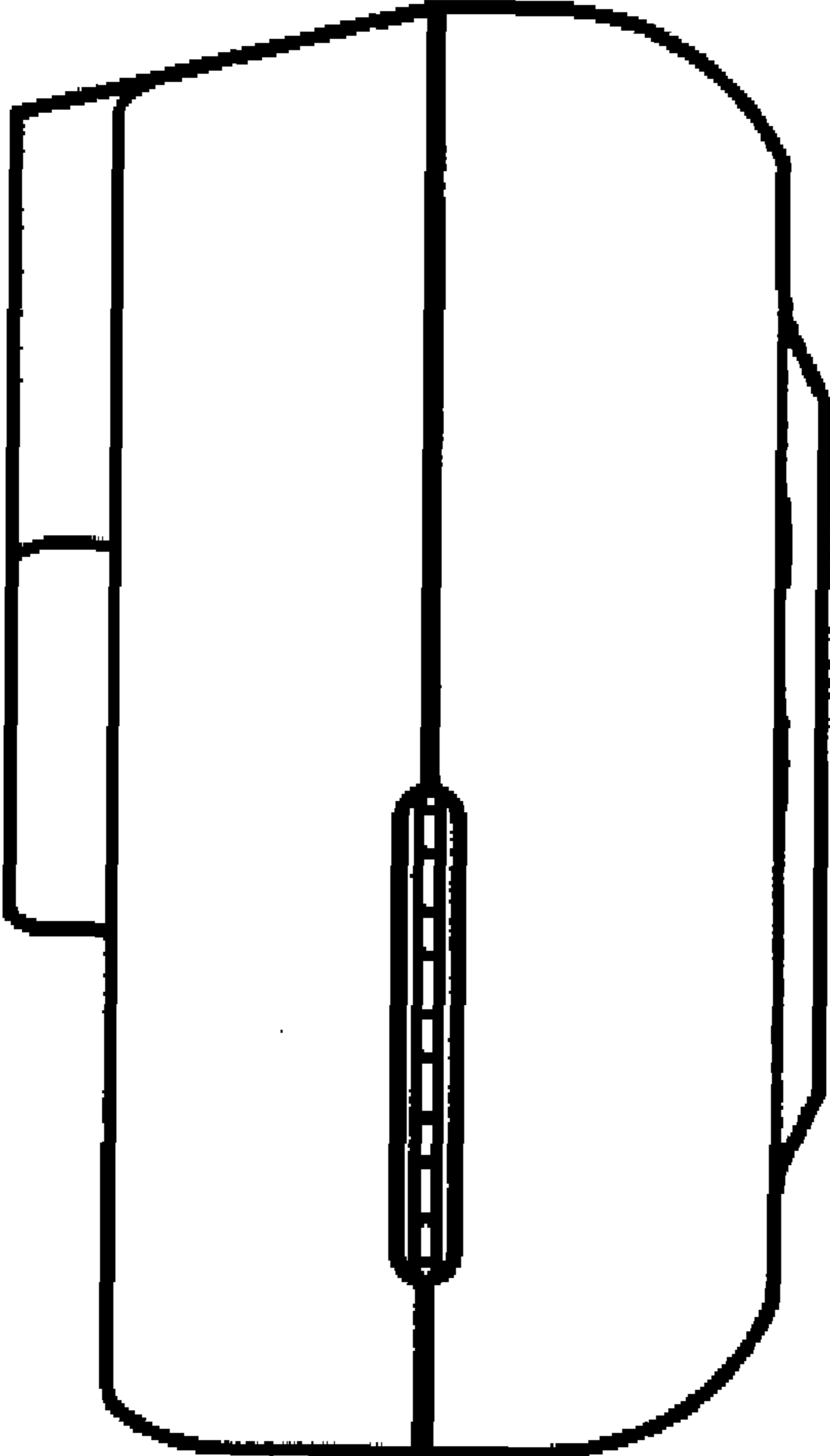

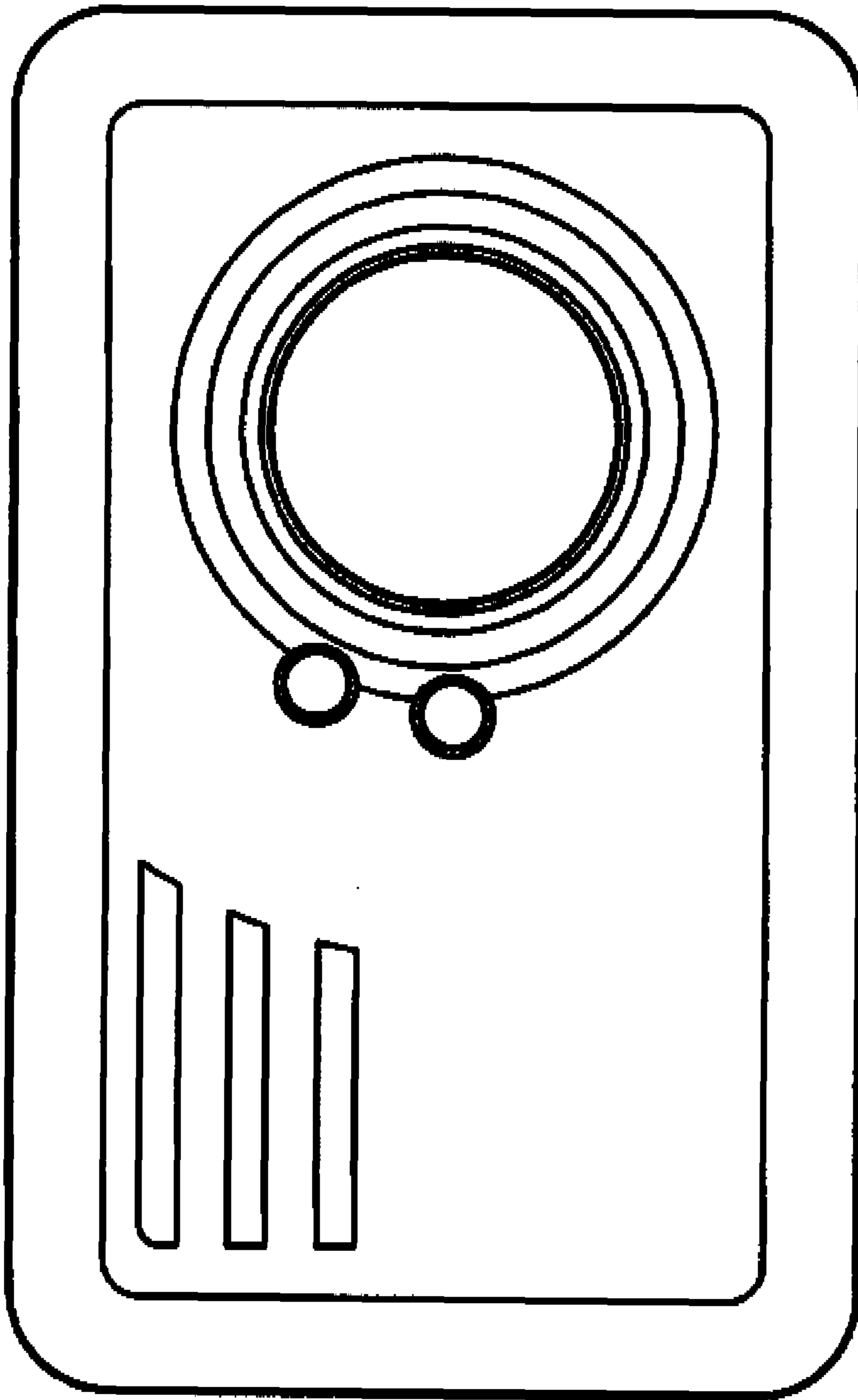

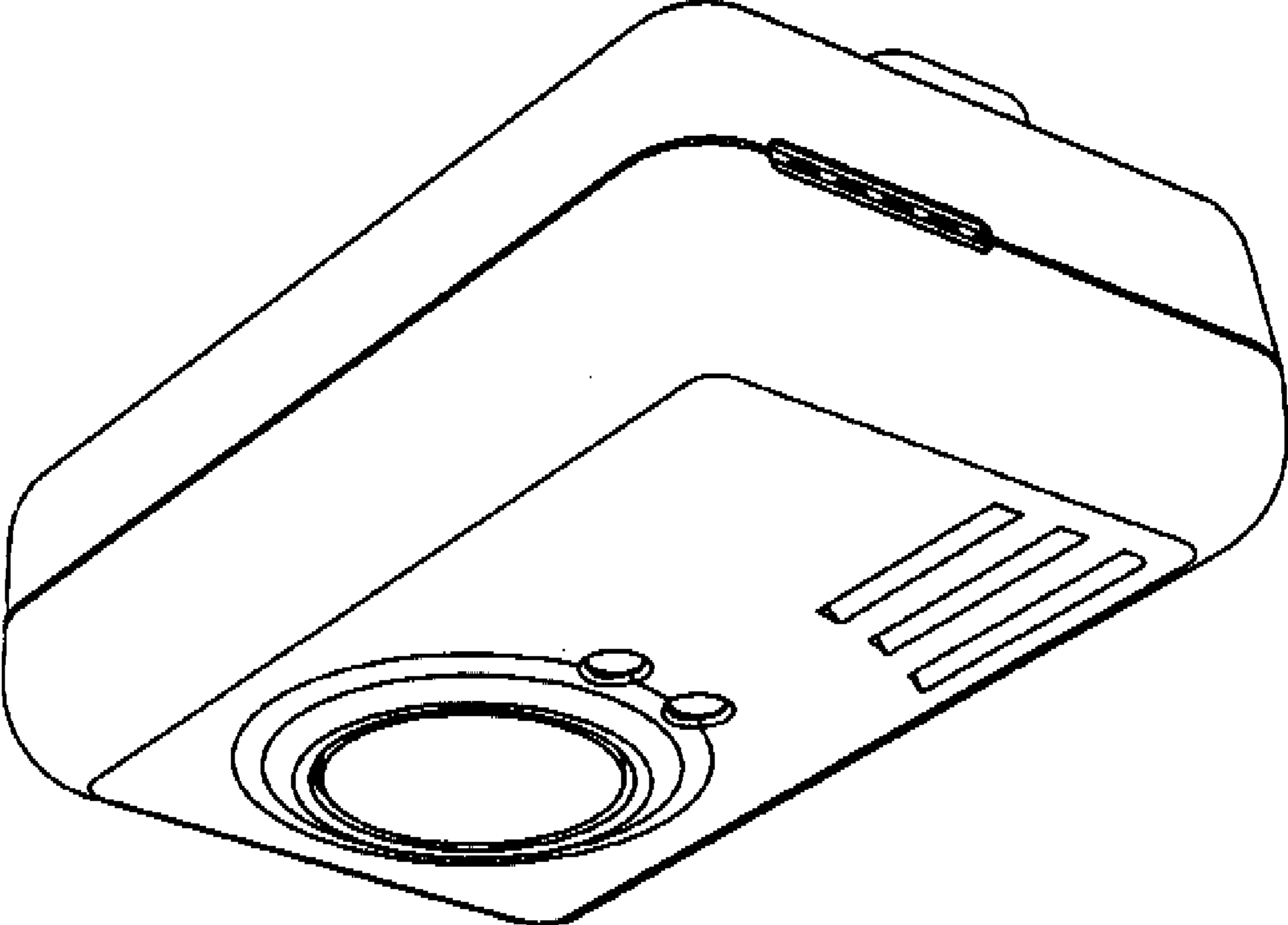

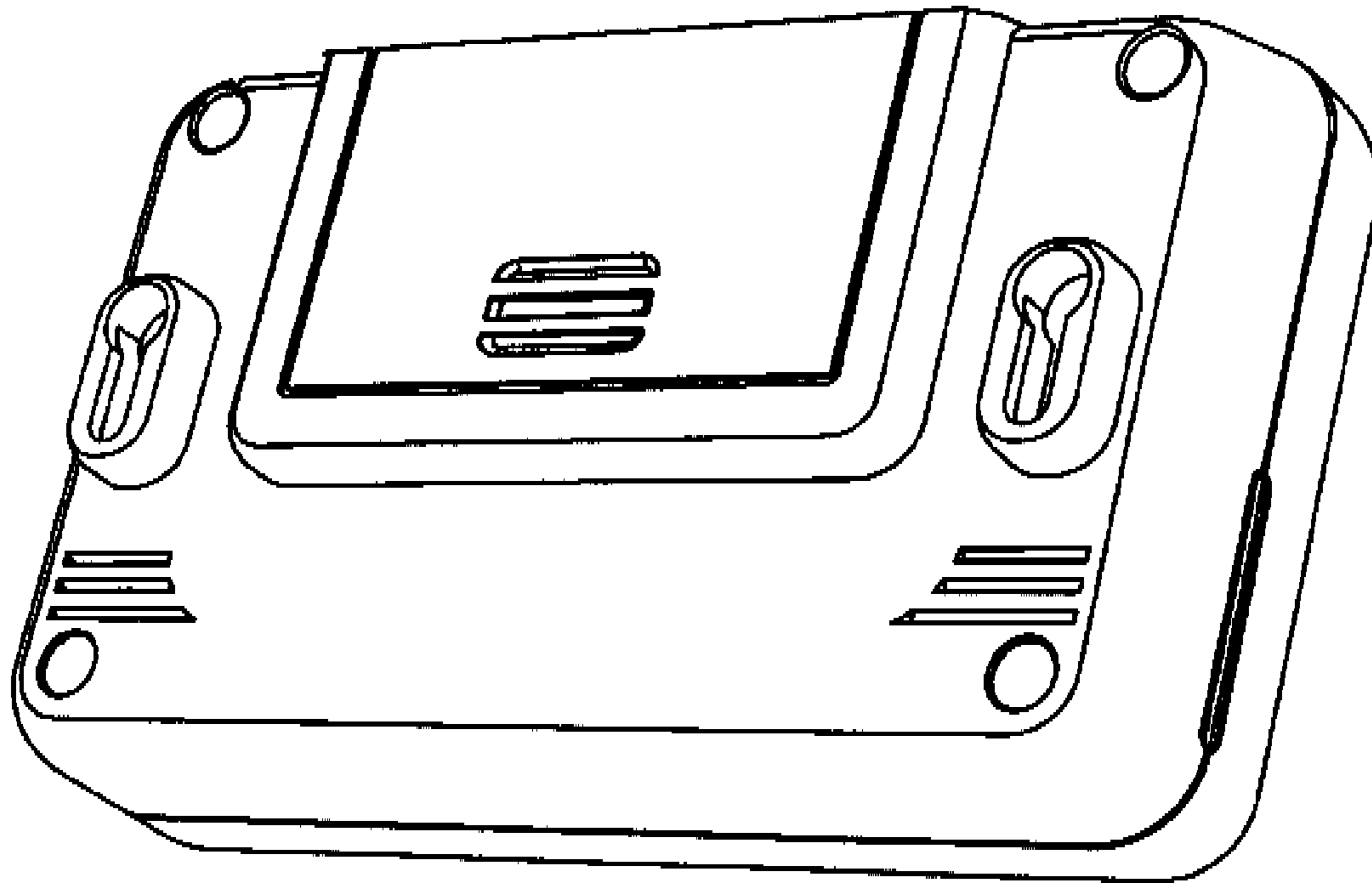

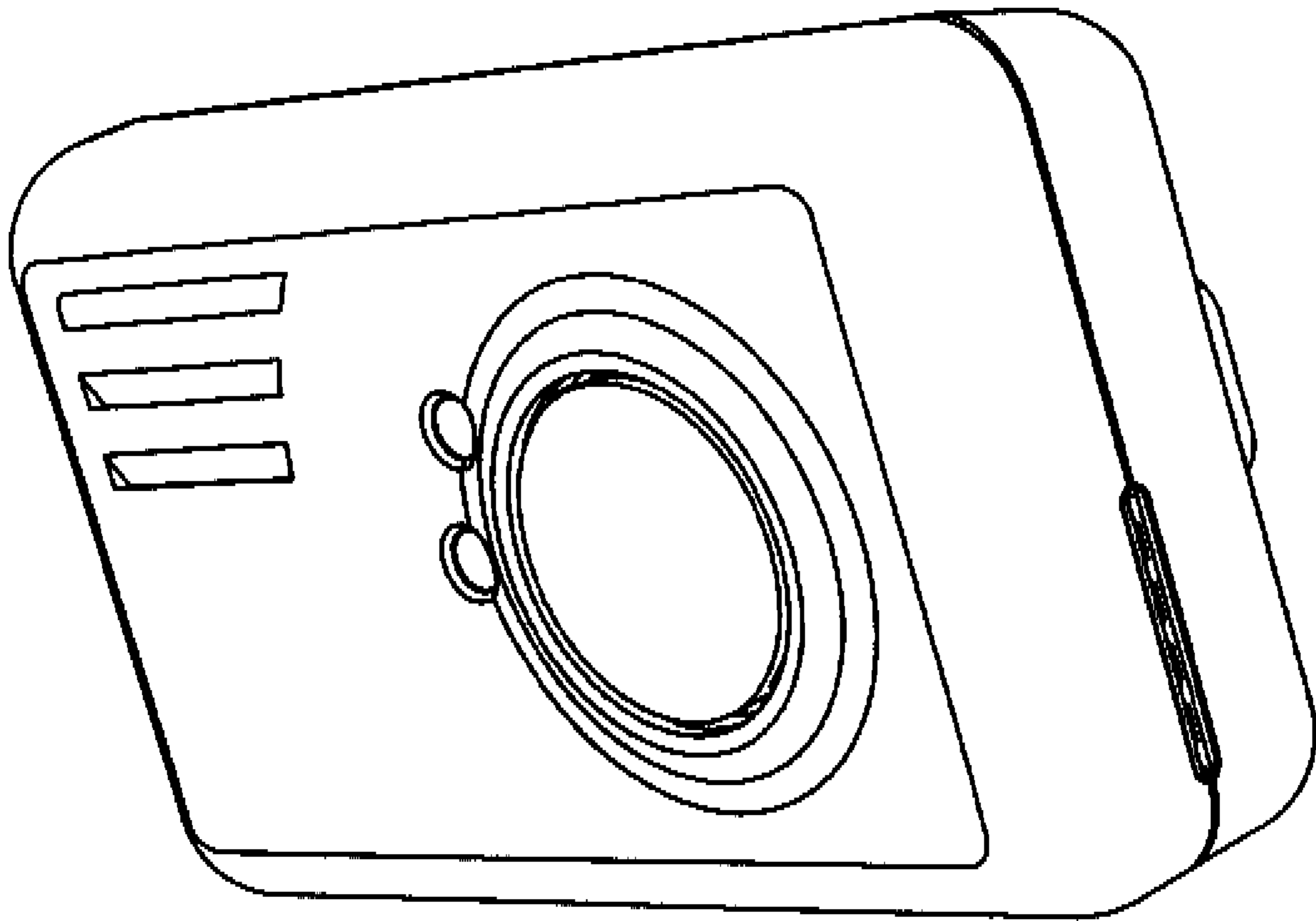

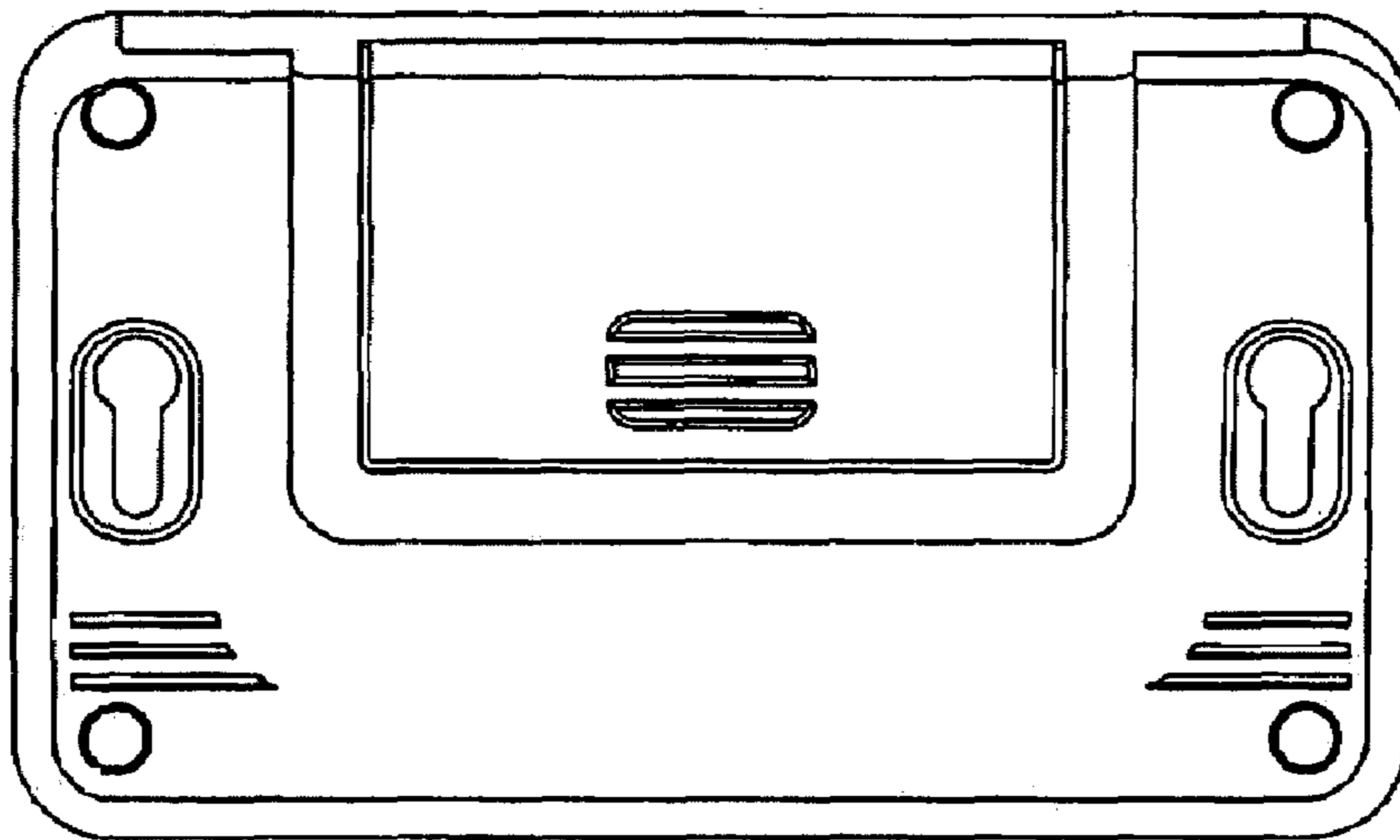
