DESCRIPTION

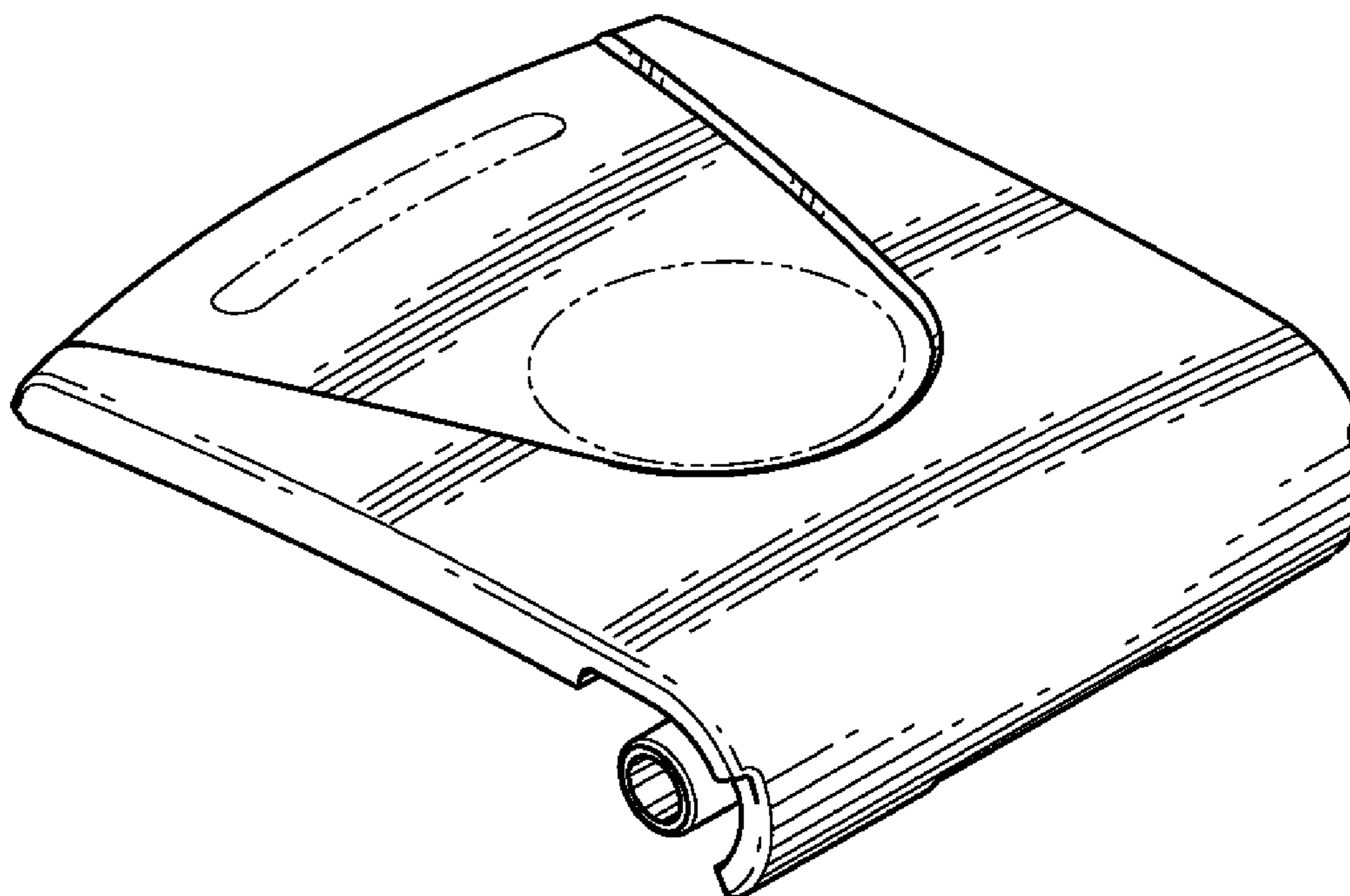

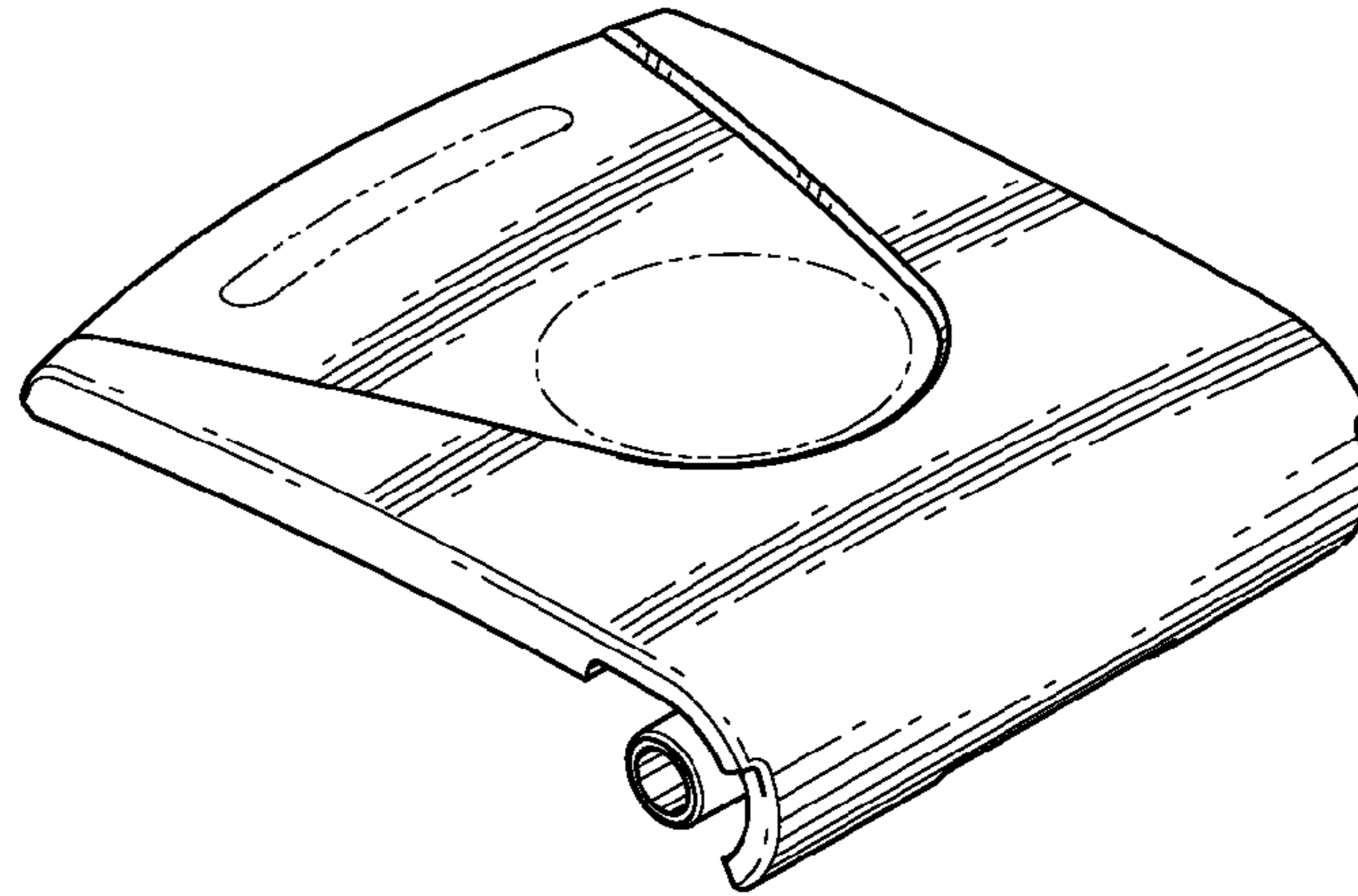

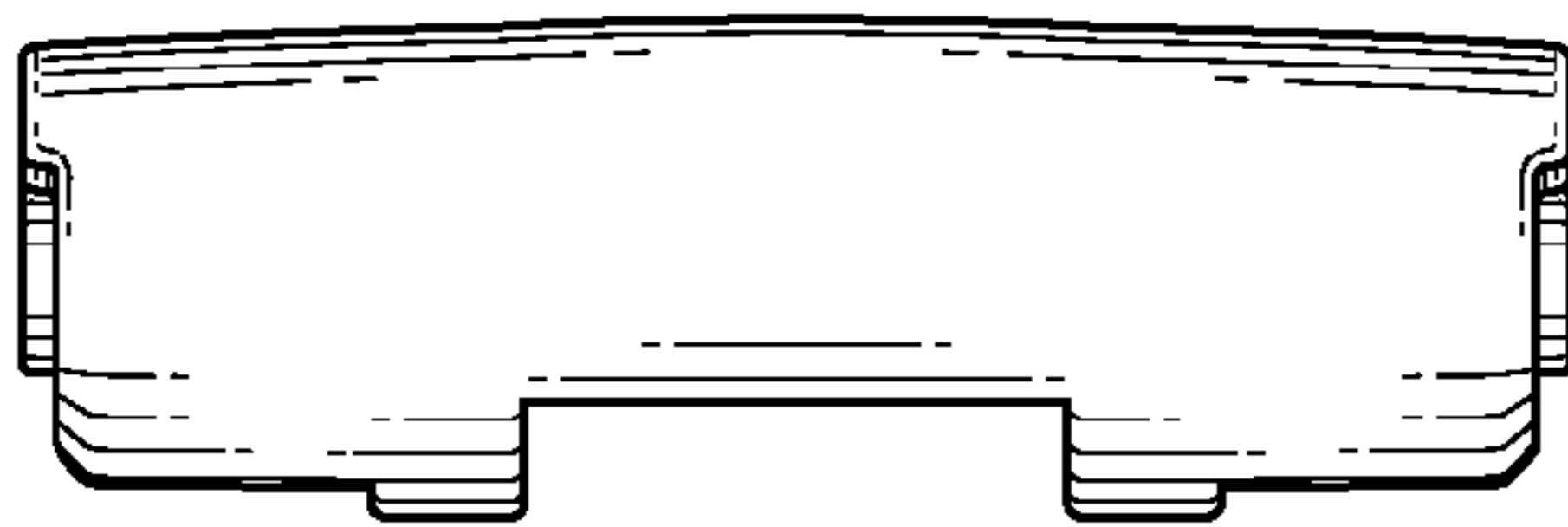

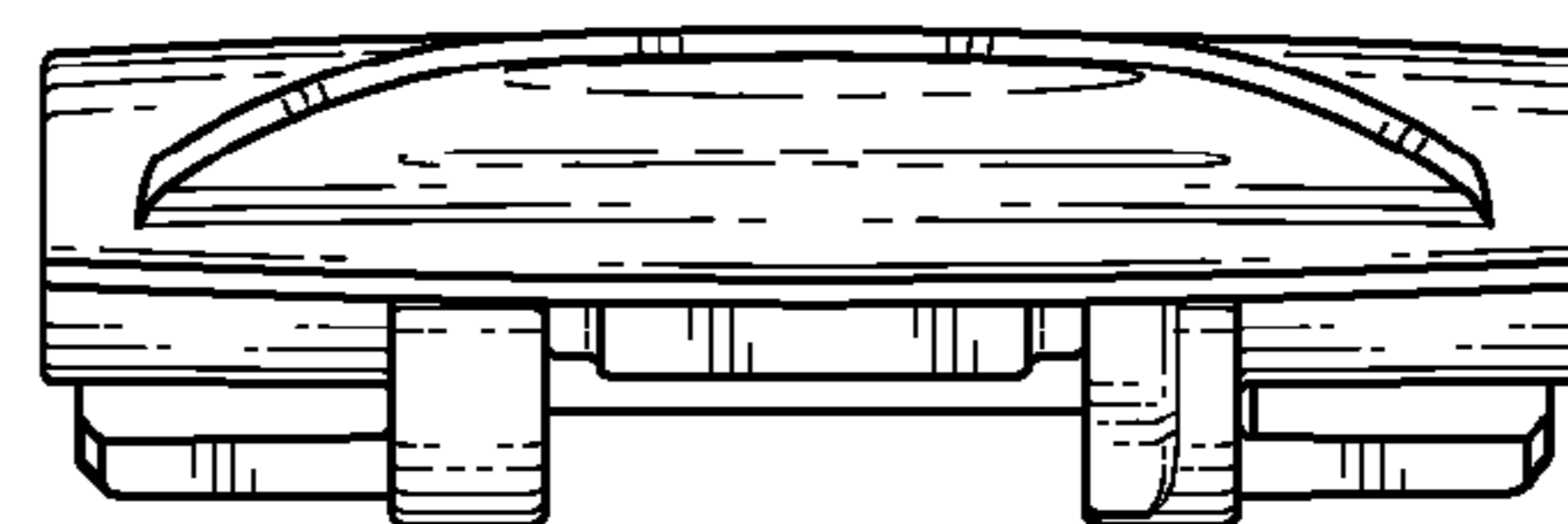

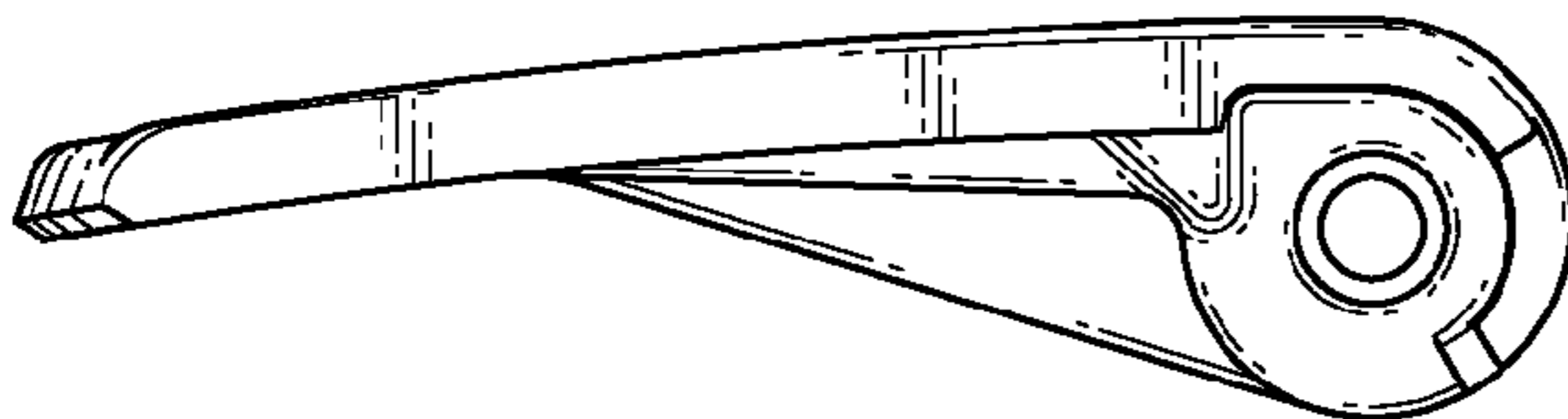

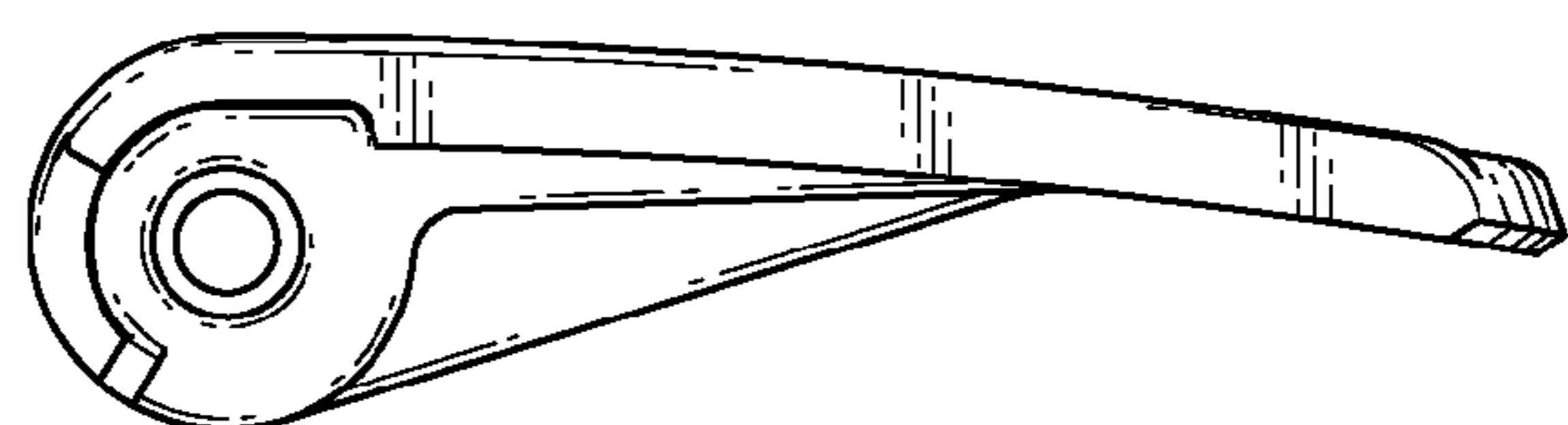

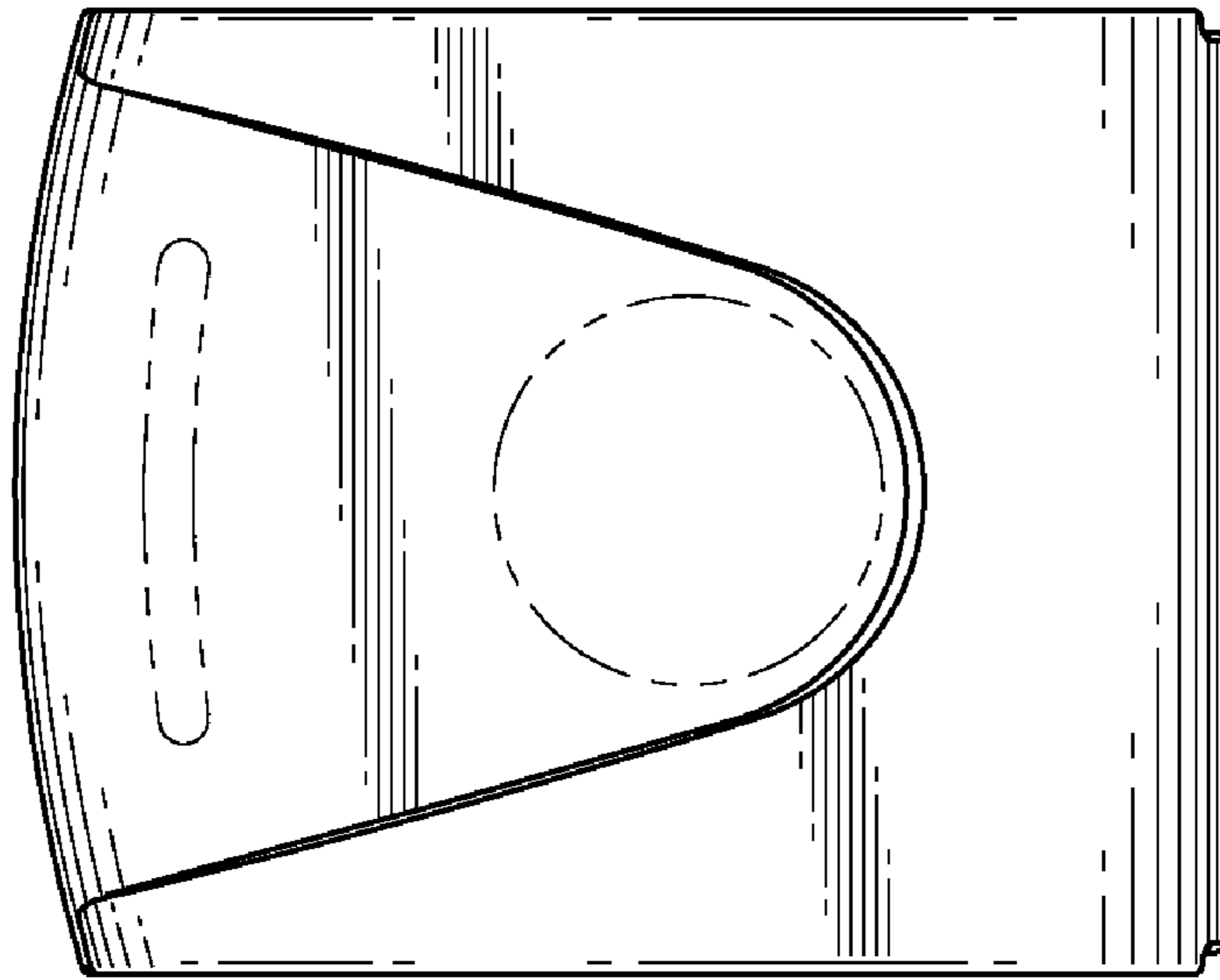

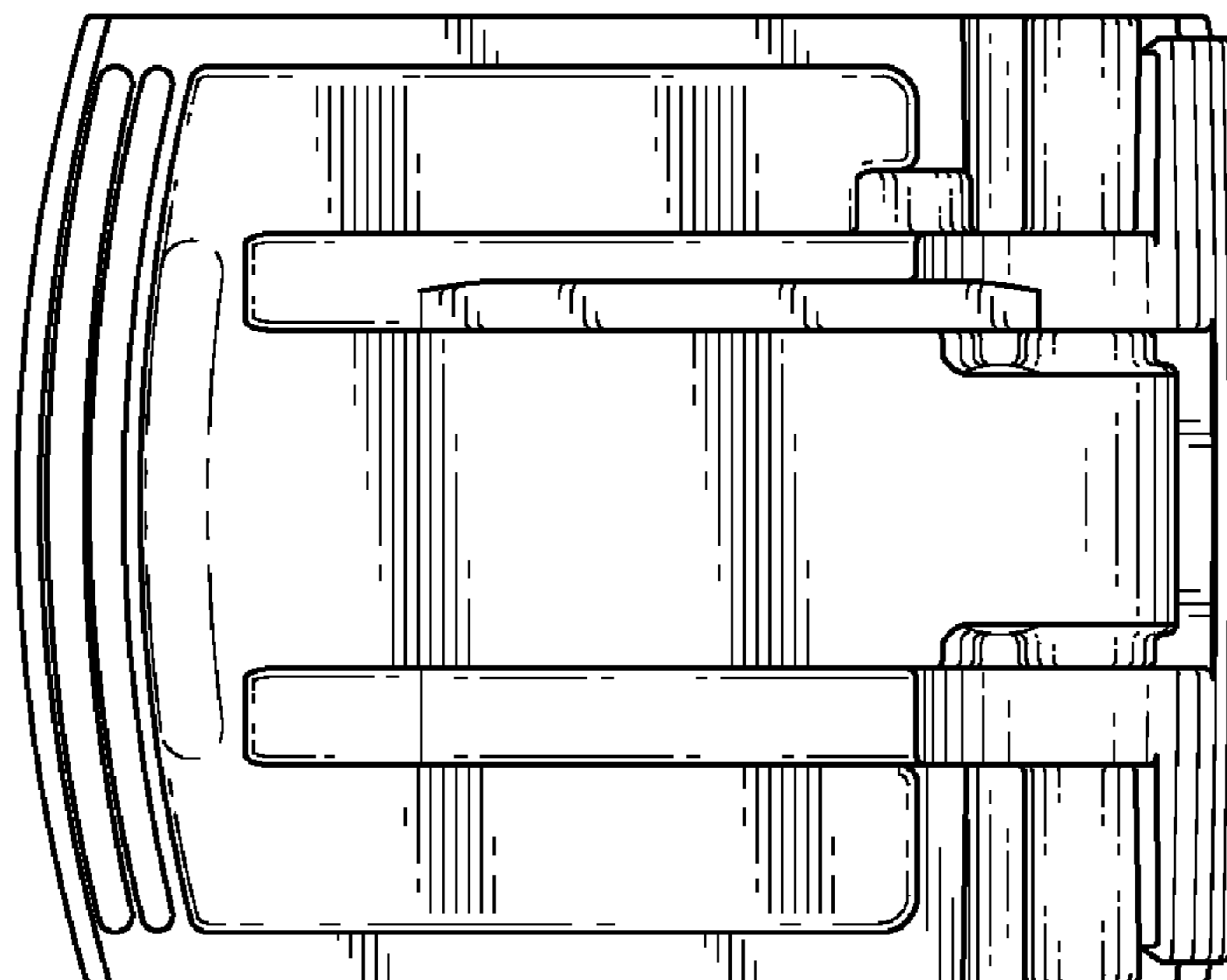

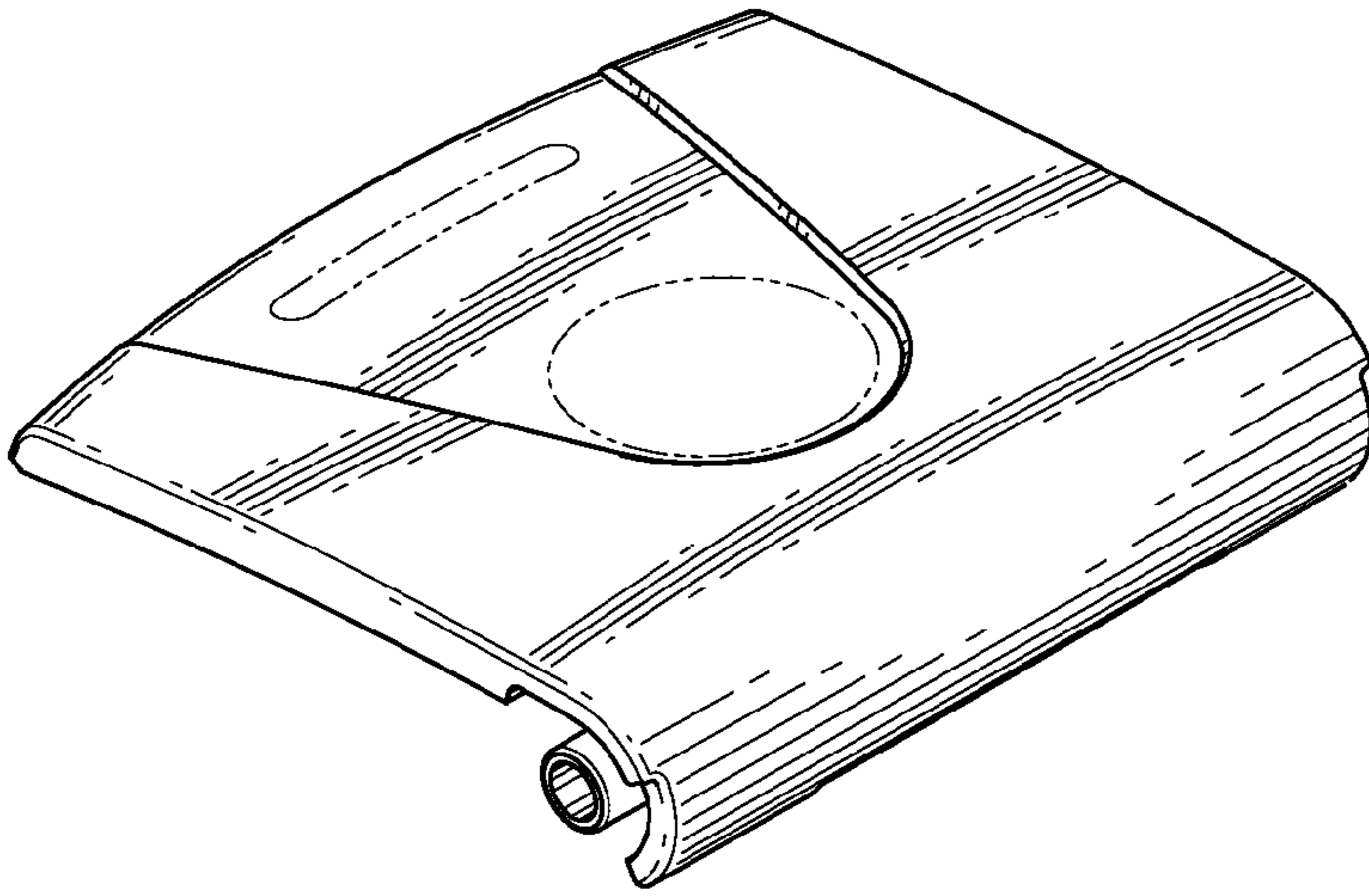

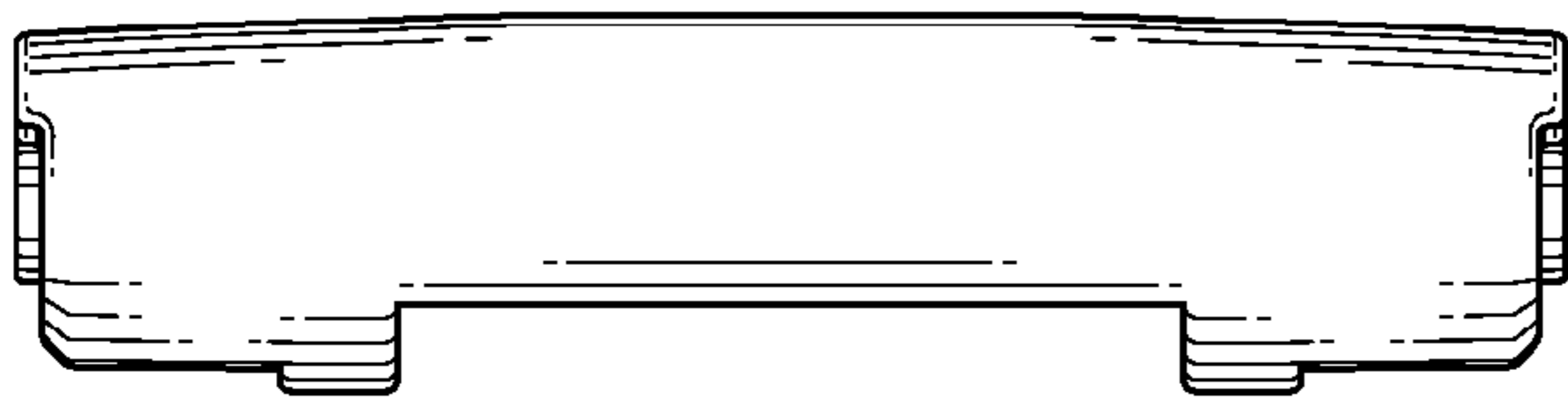

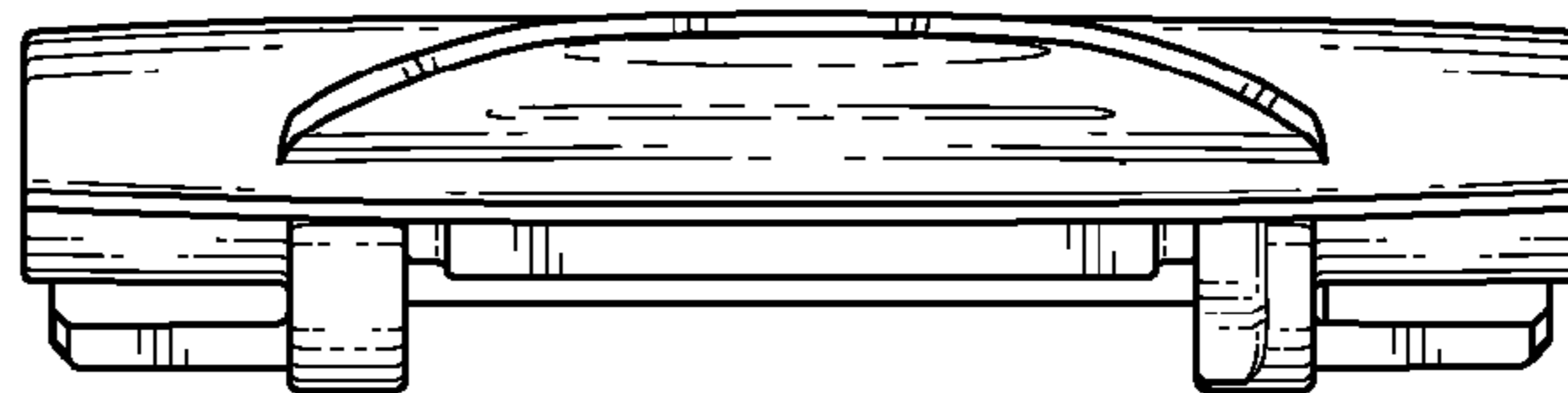

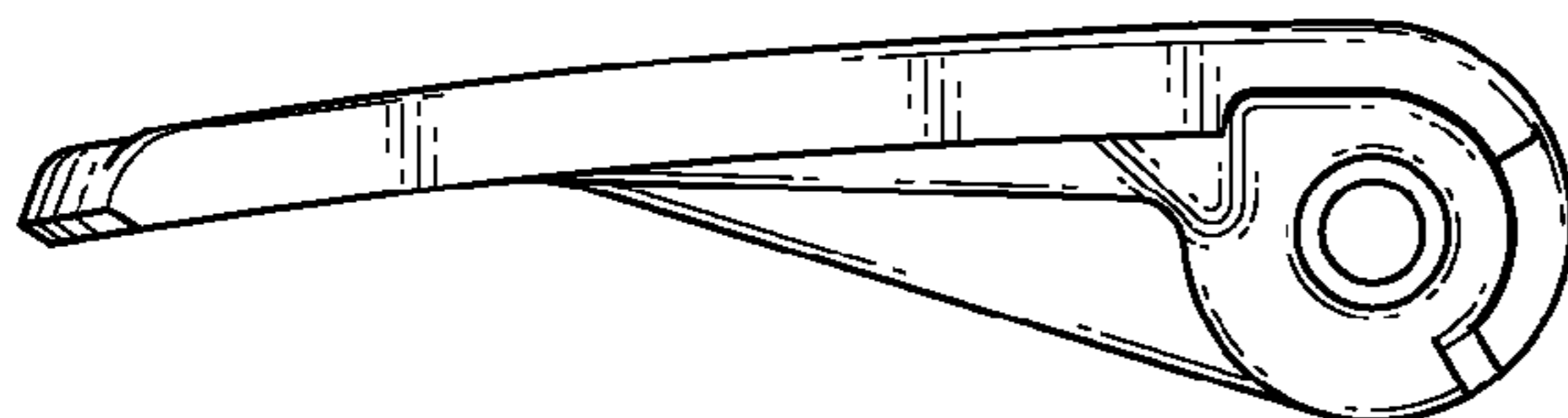

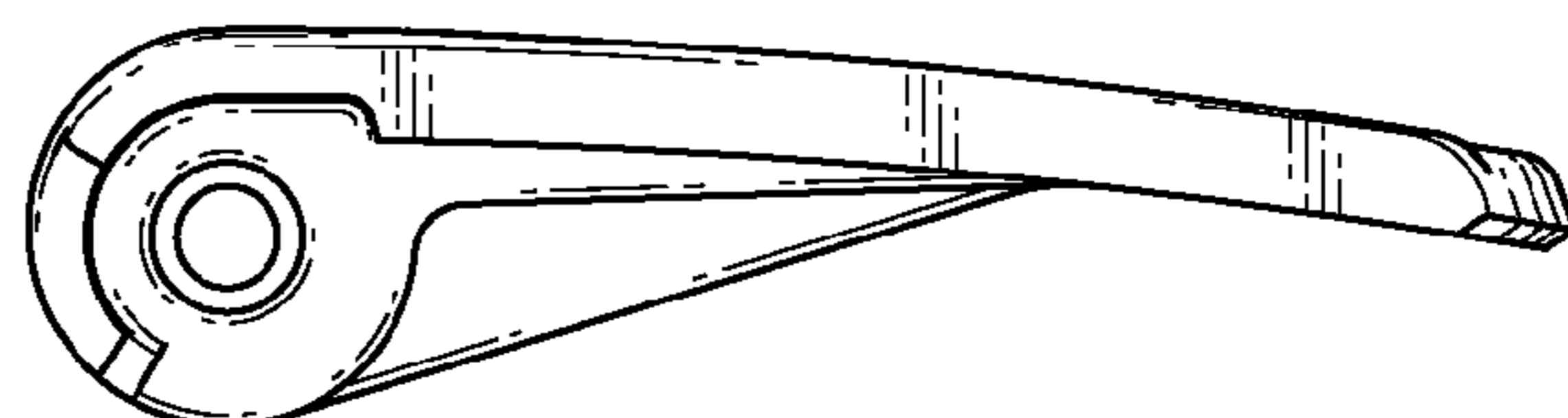

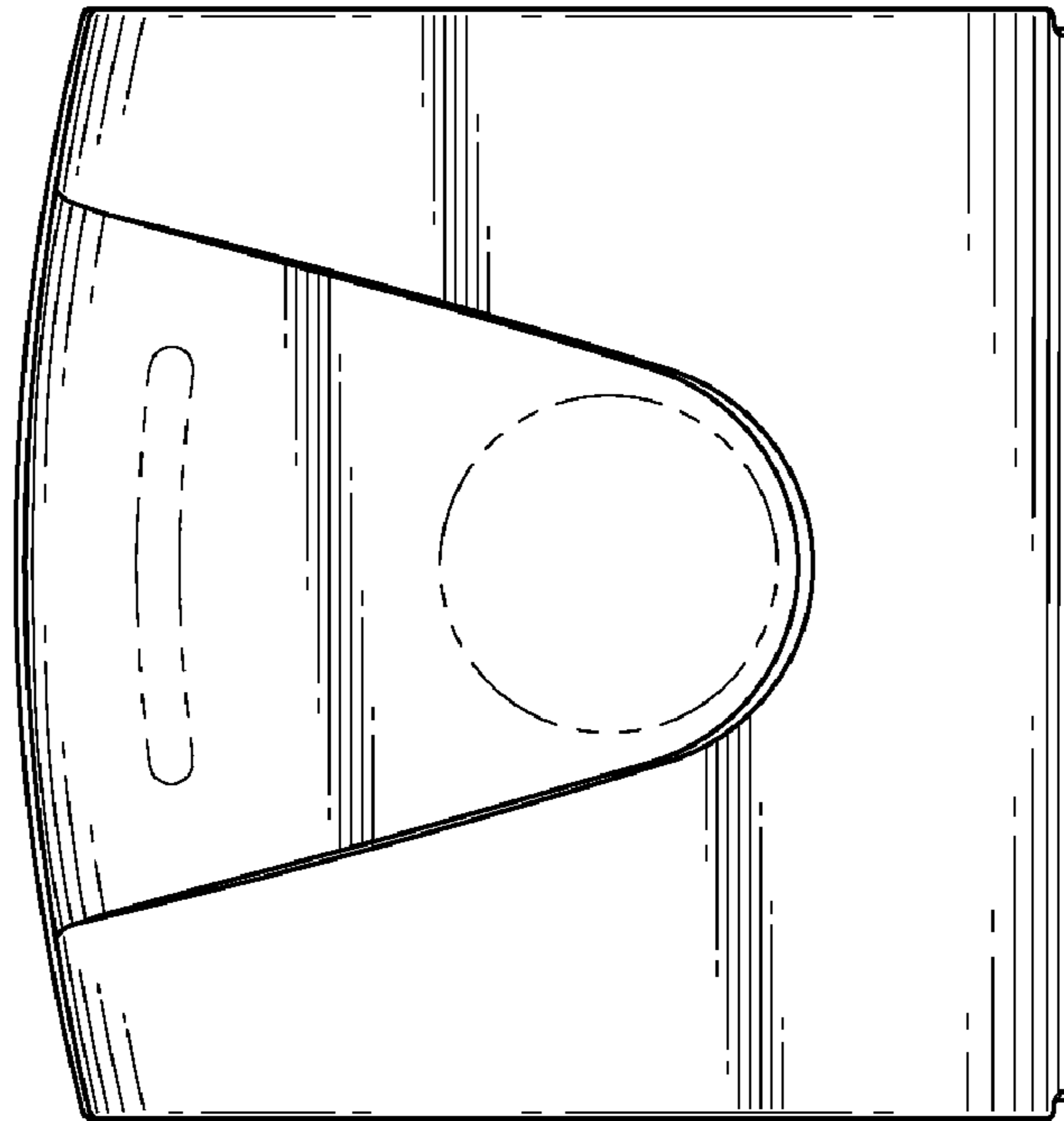
