The ornamental design for a side and door lining panel for an aircraft cabin, as shown and described.

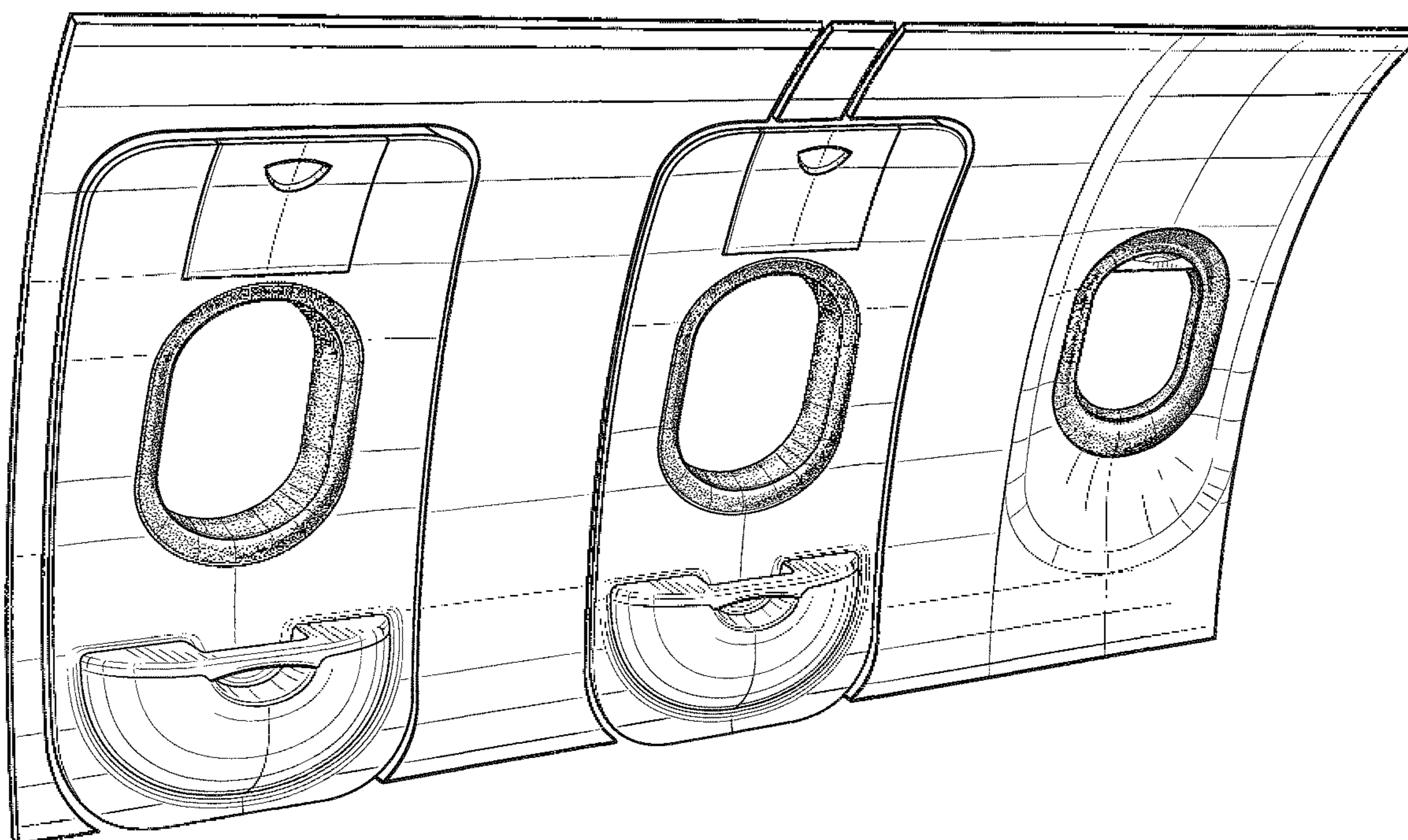
DESCRIPTION

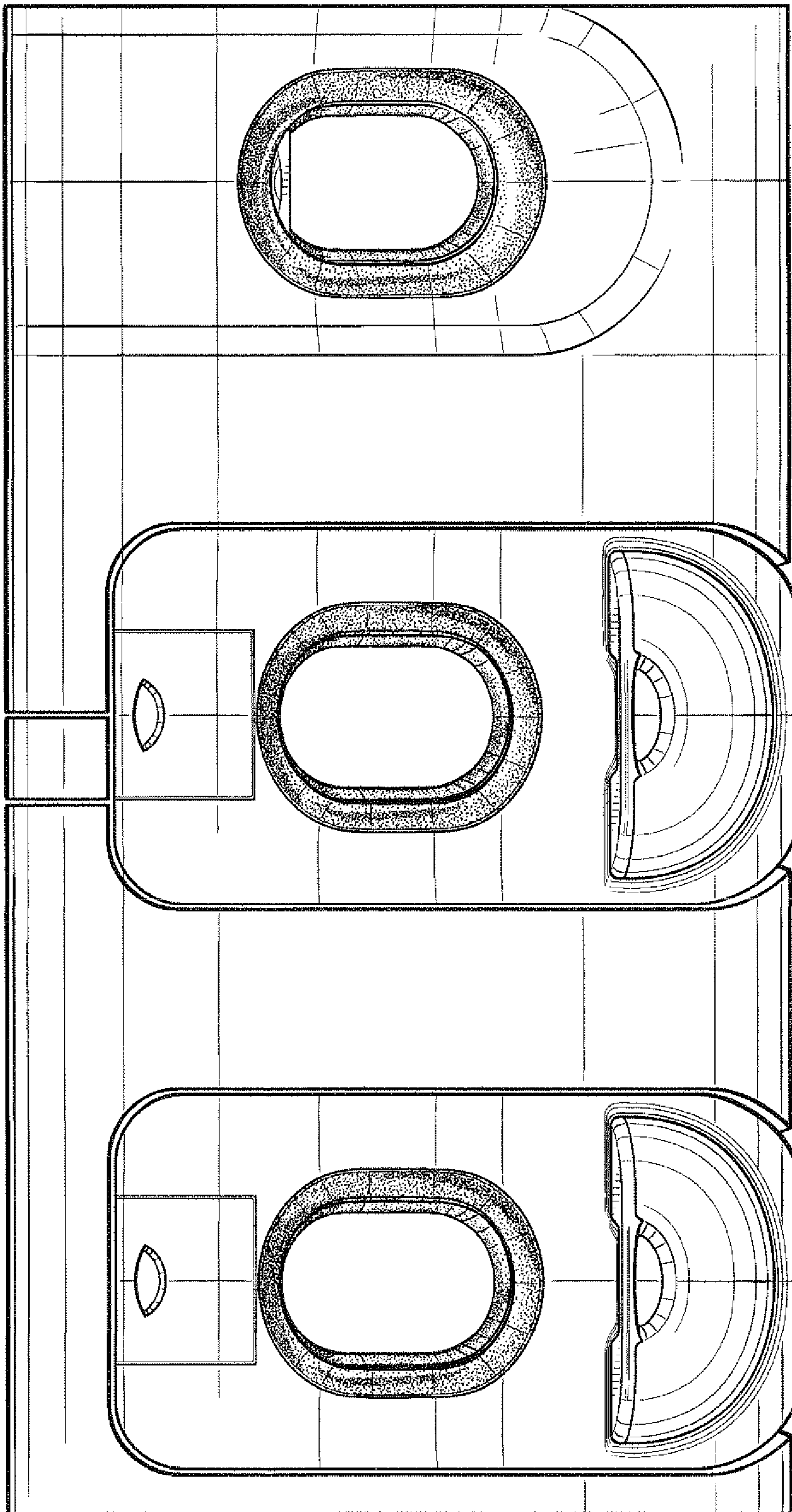

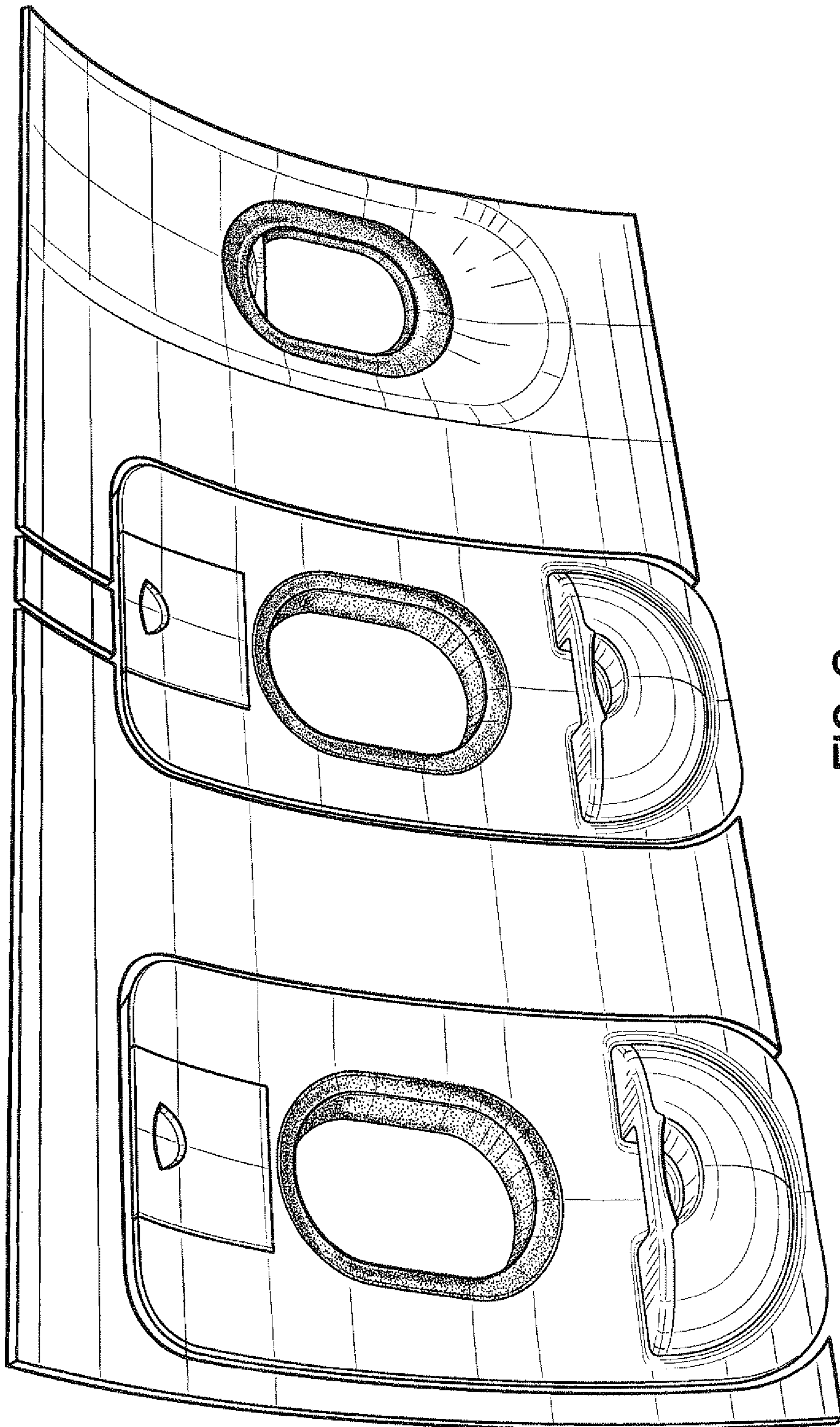
