DESCRIPTION

FIG. 1 is an enlarged top plan view of a rotor for wind turbines
showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a bottom and side perspective thereof;

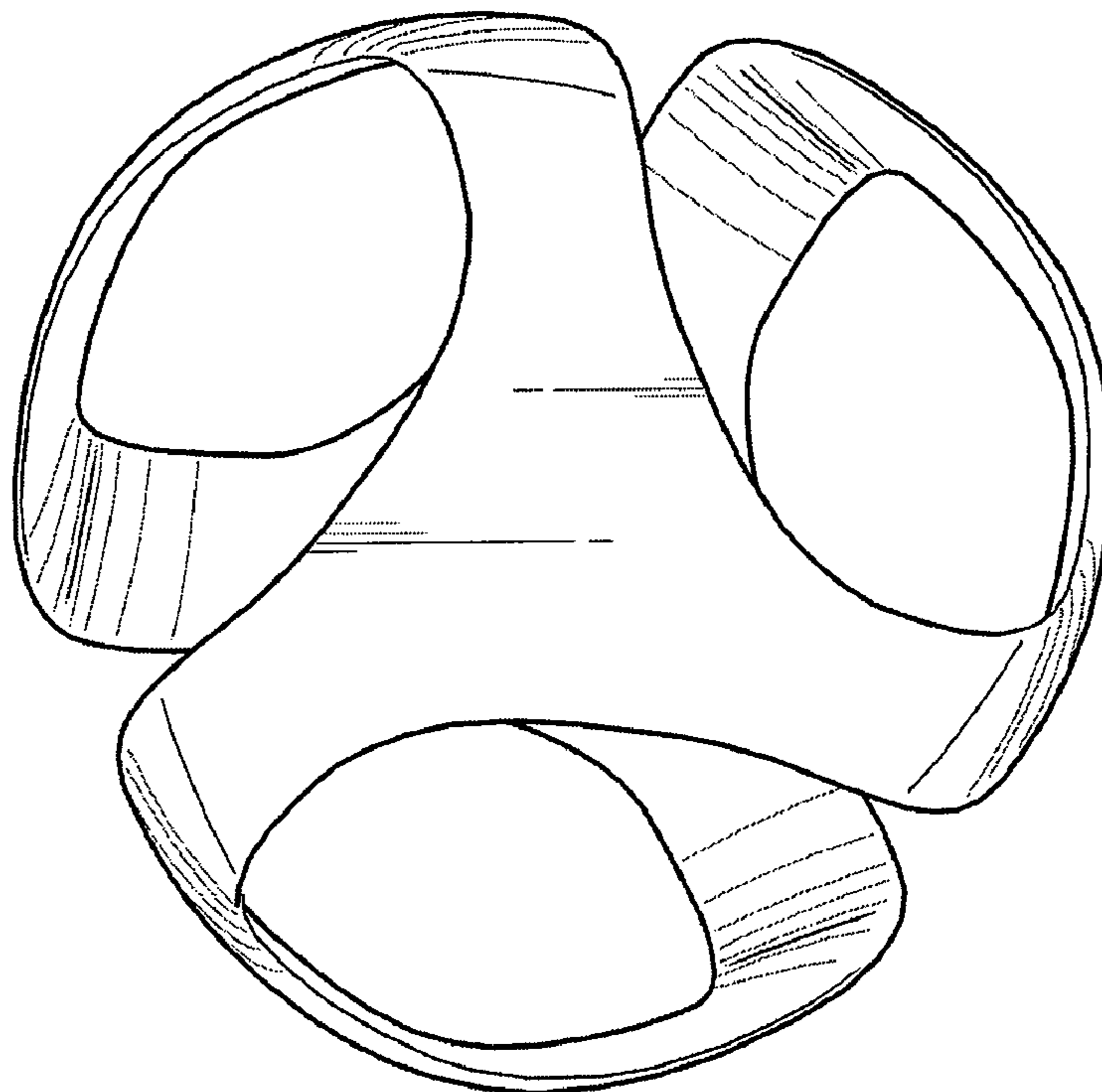
FIG. 4 is second bottom and side perspective view thereof,

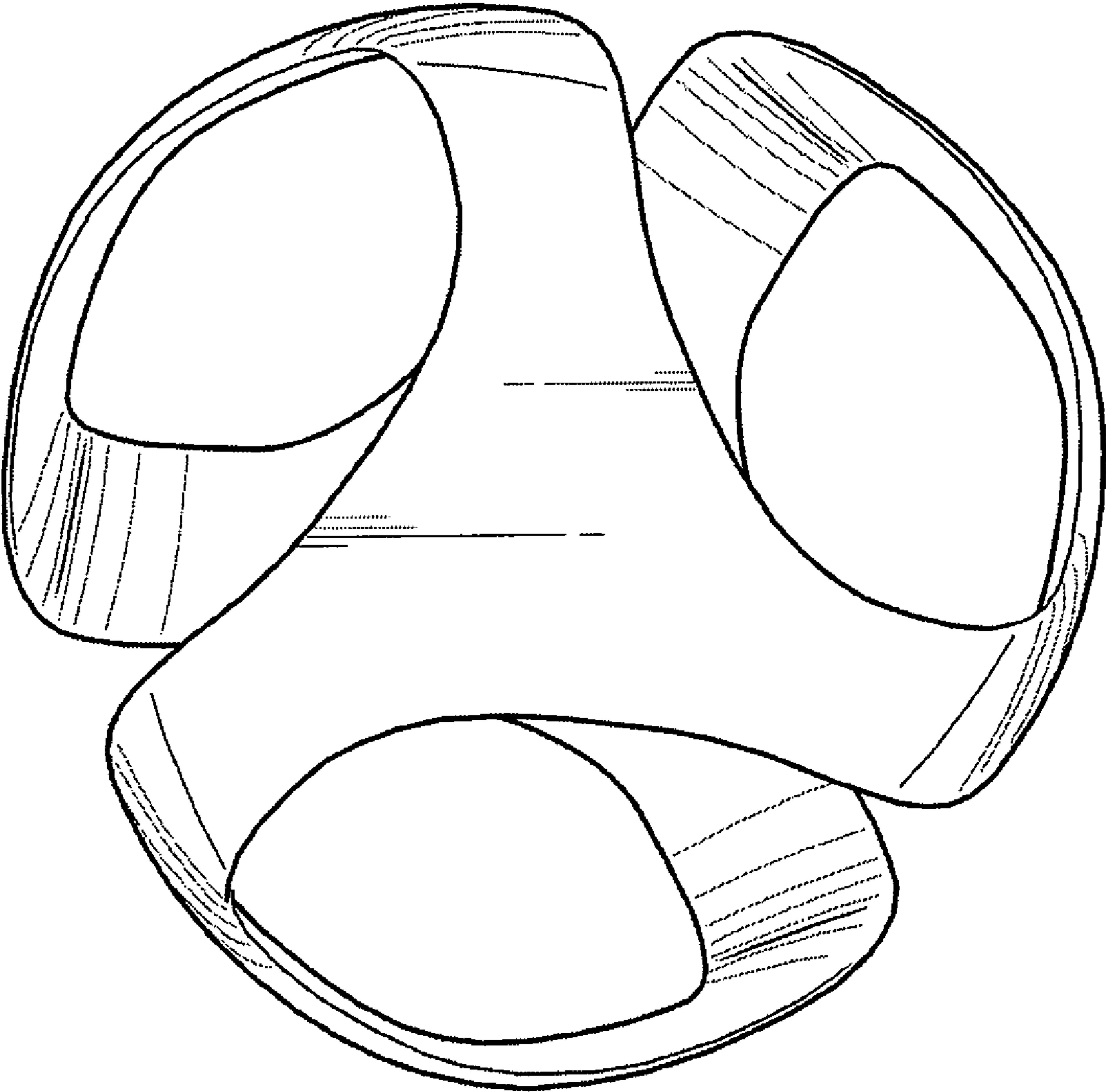

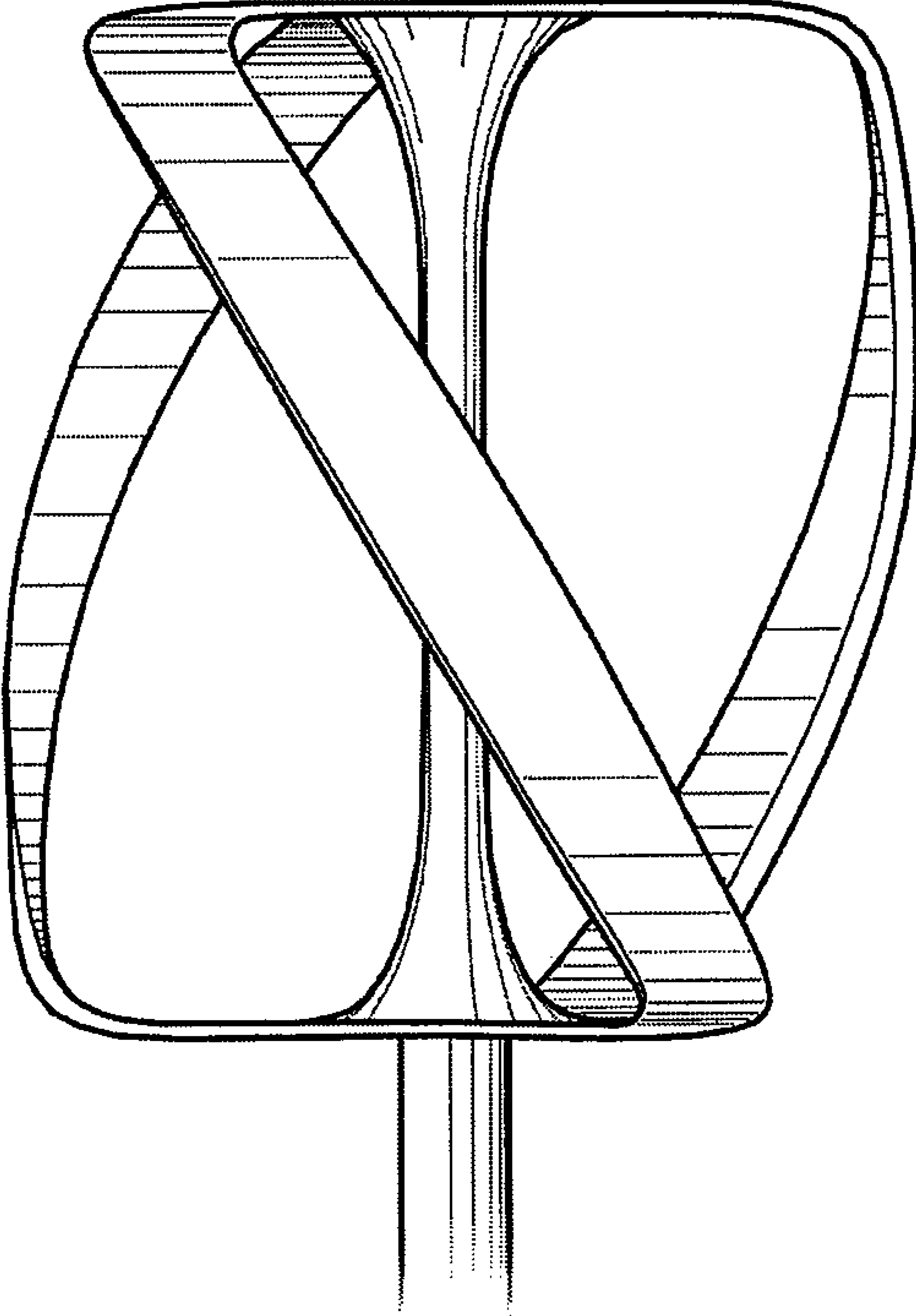

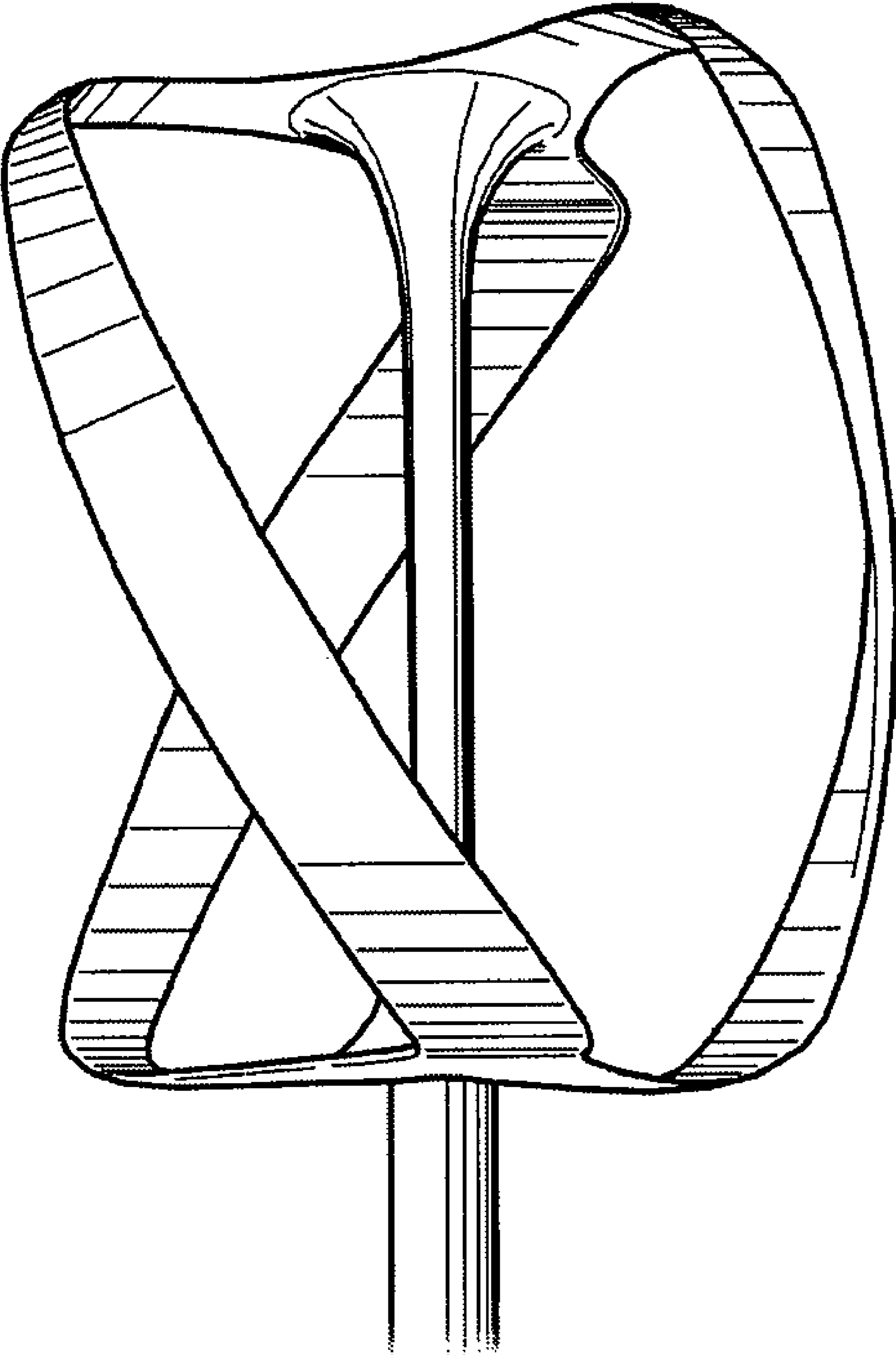

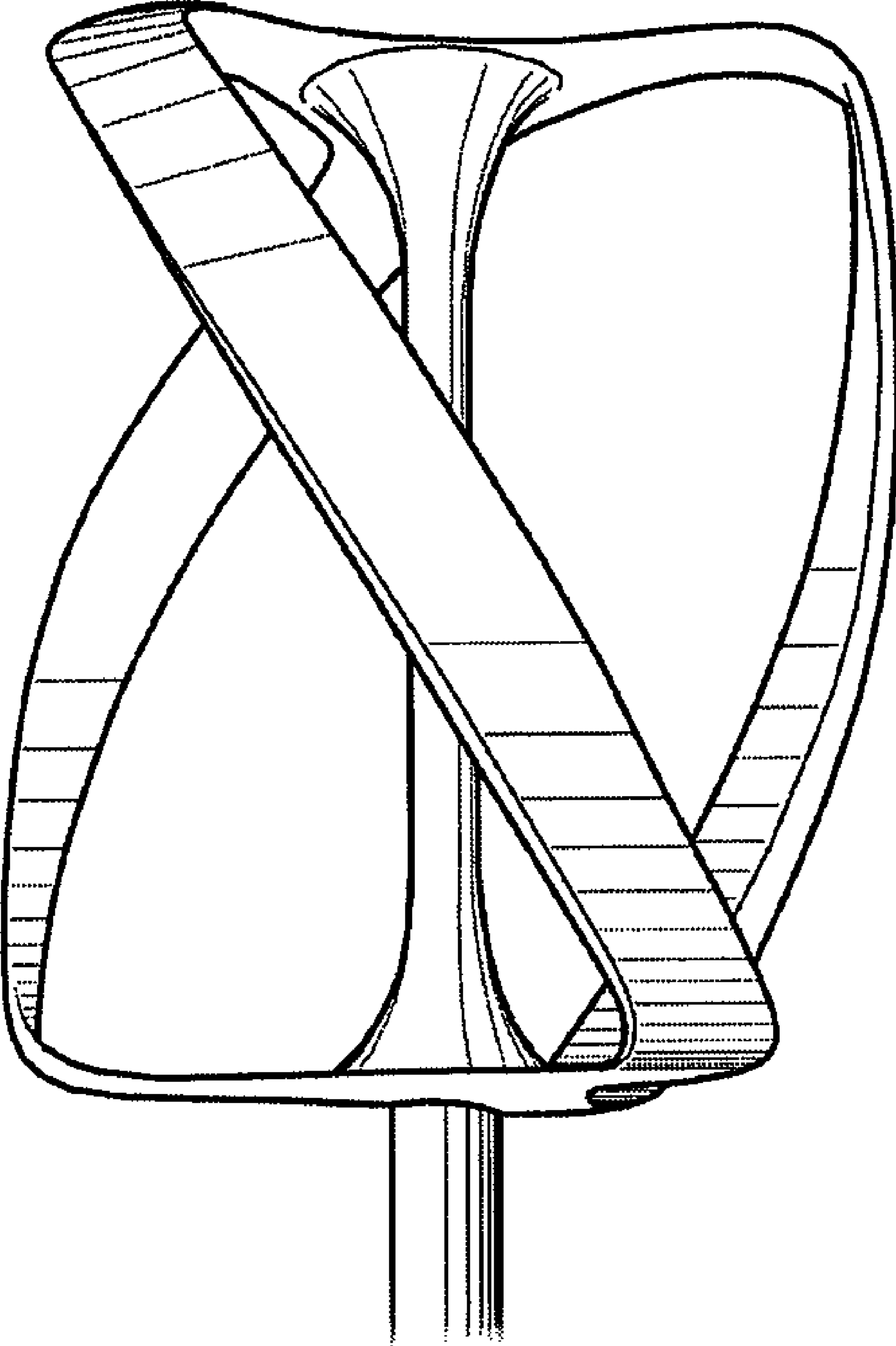

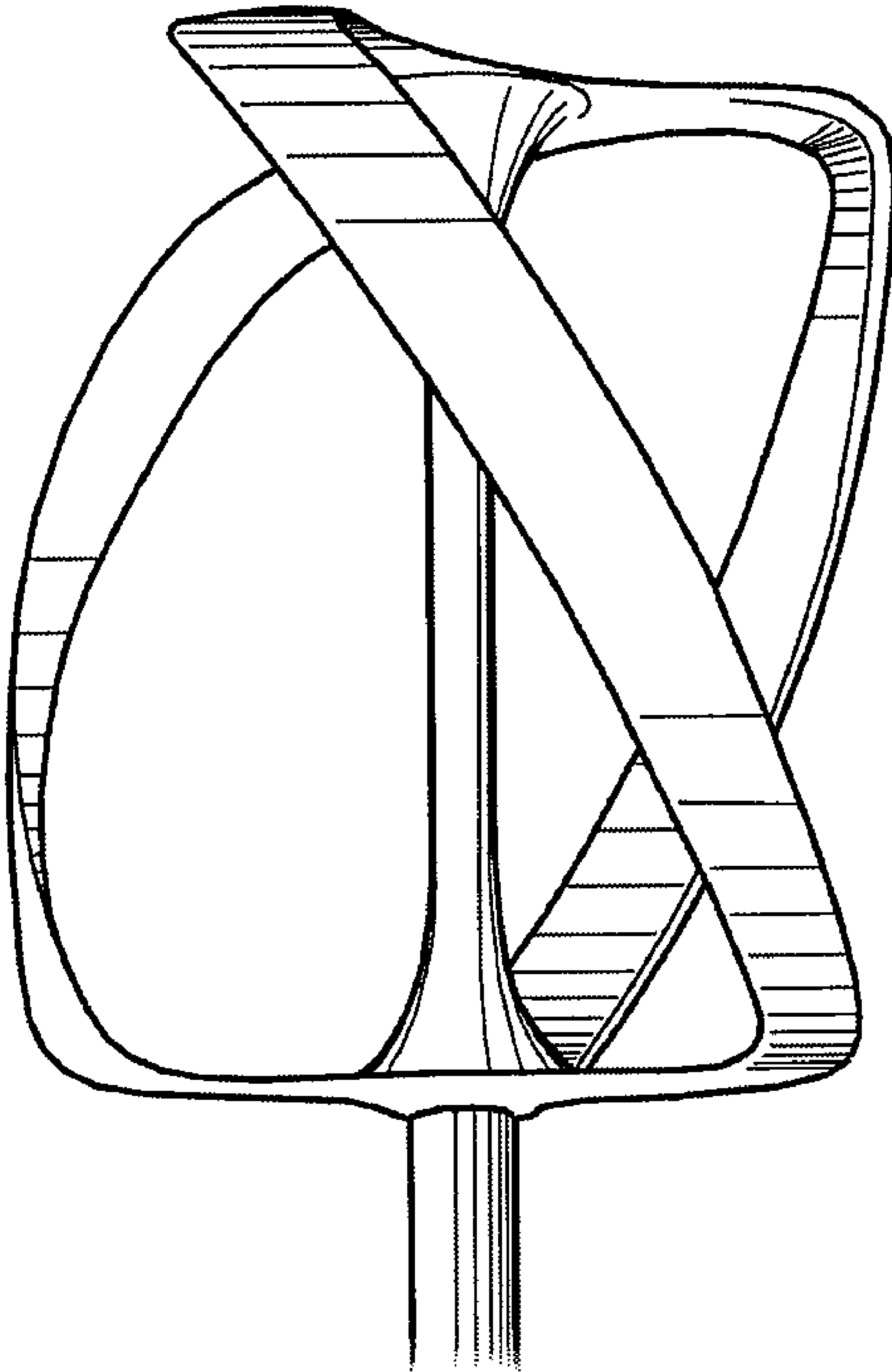

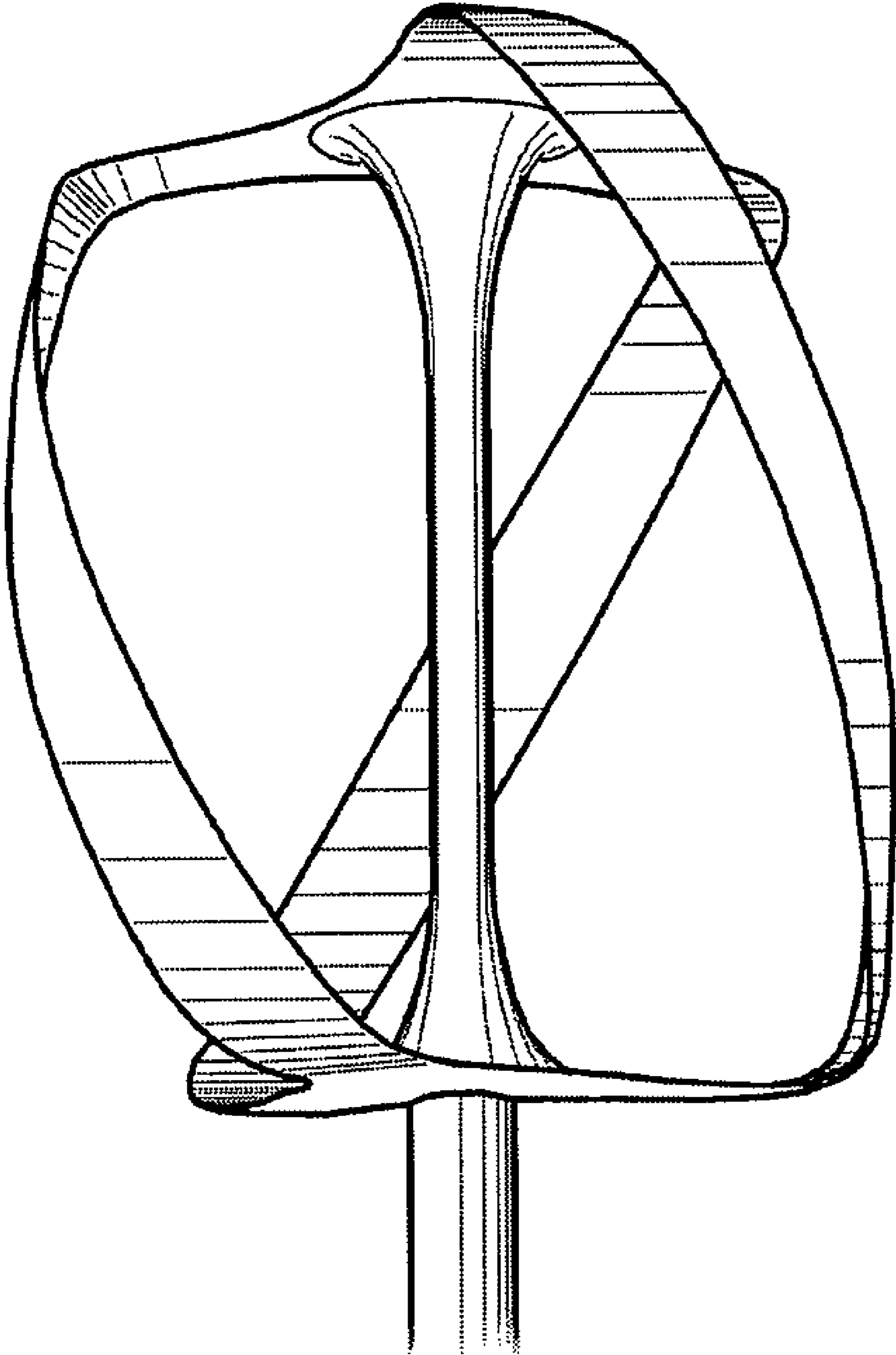

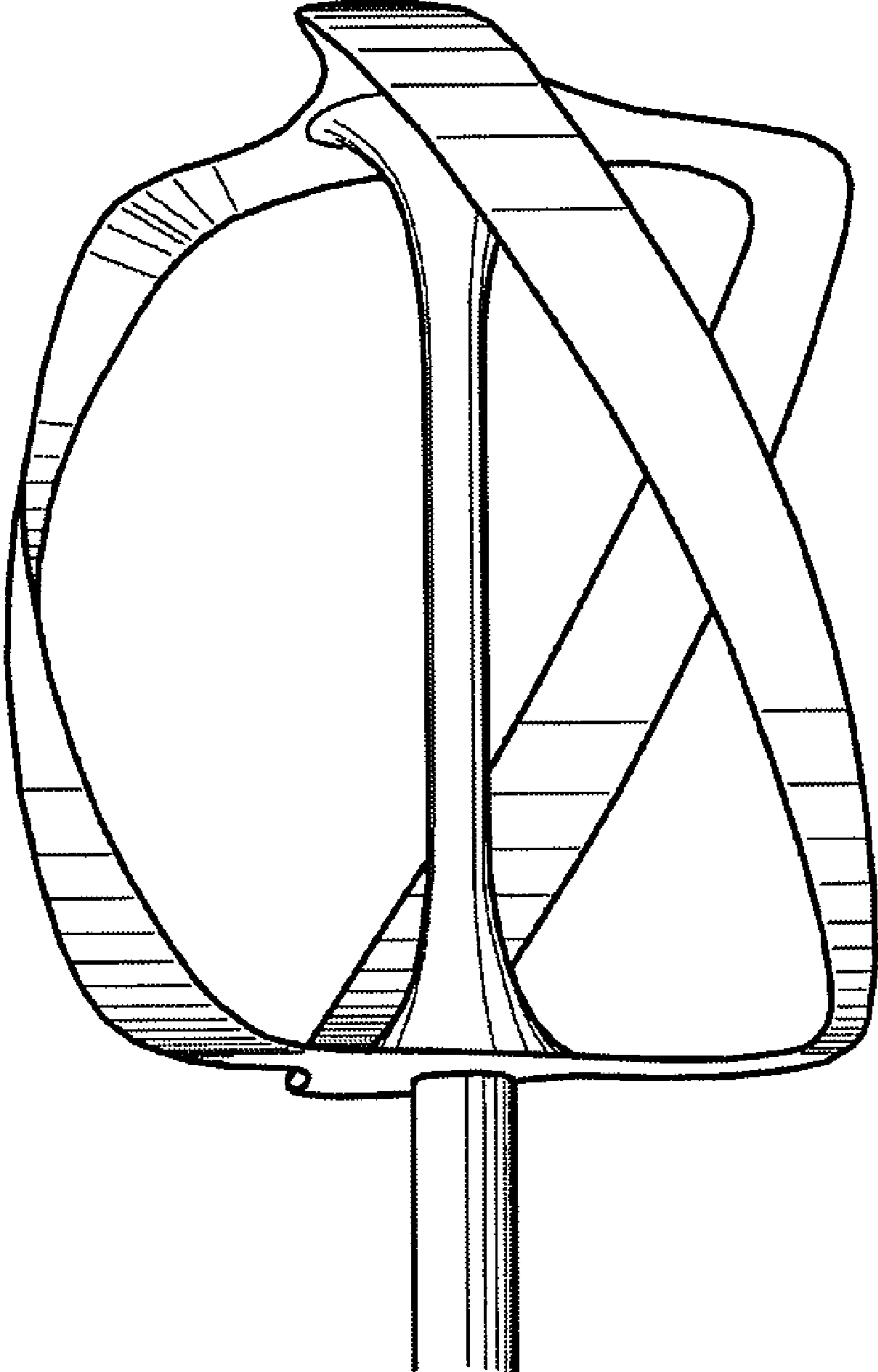
