FIG. 8 is a bottom plan view thereof.

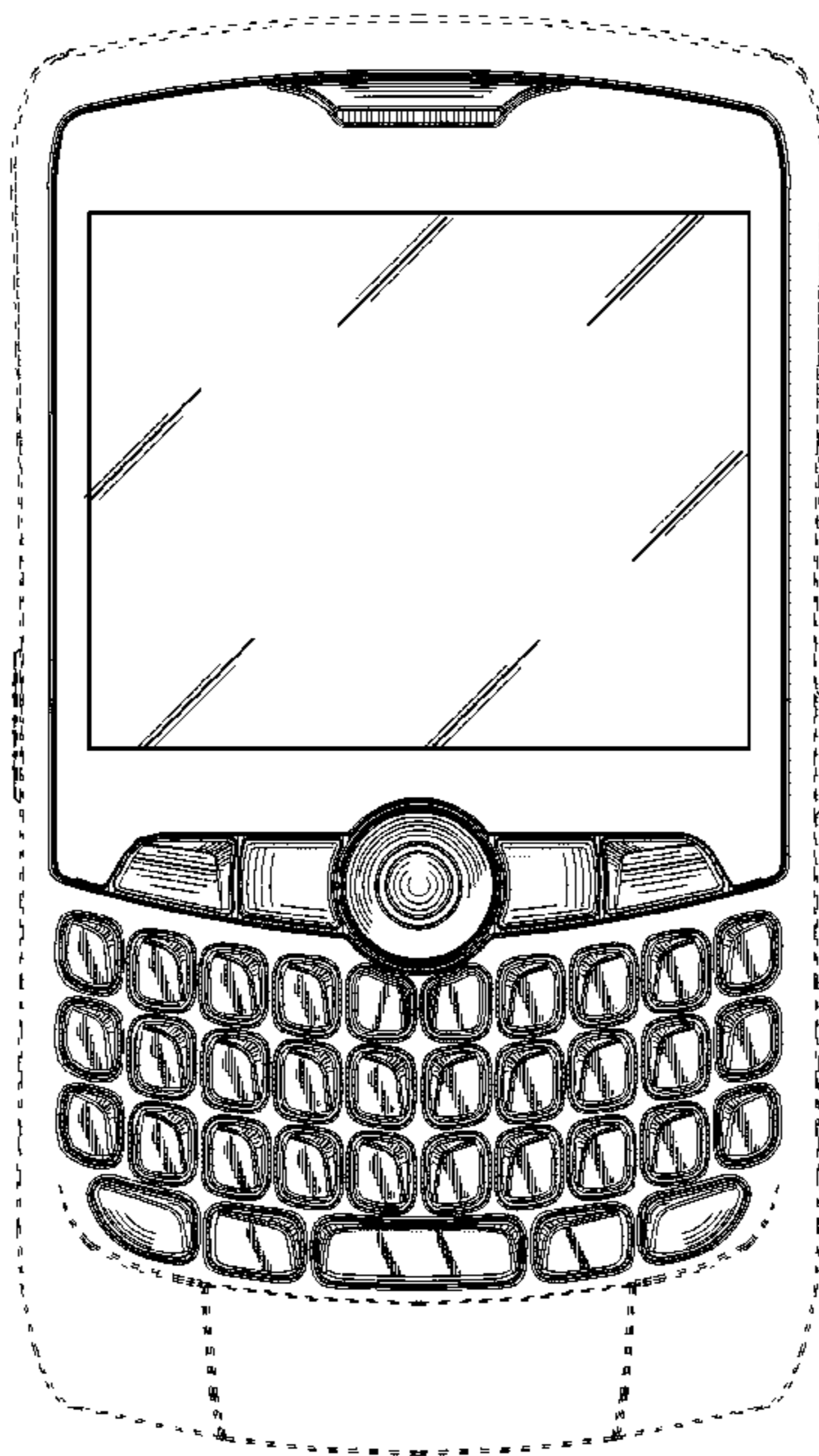
The broken lines in the drawings illustrate unclaimed portions of the hand-held electronic device and form no part of the claimed design.

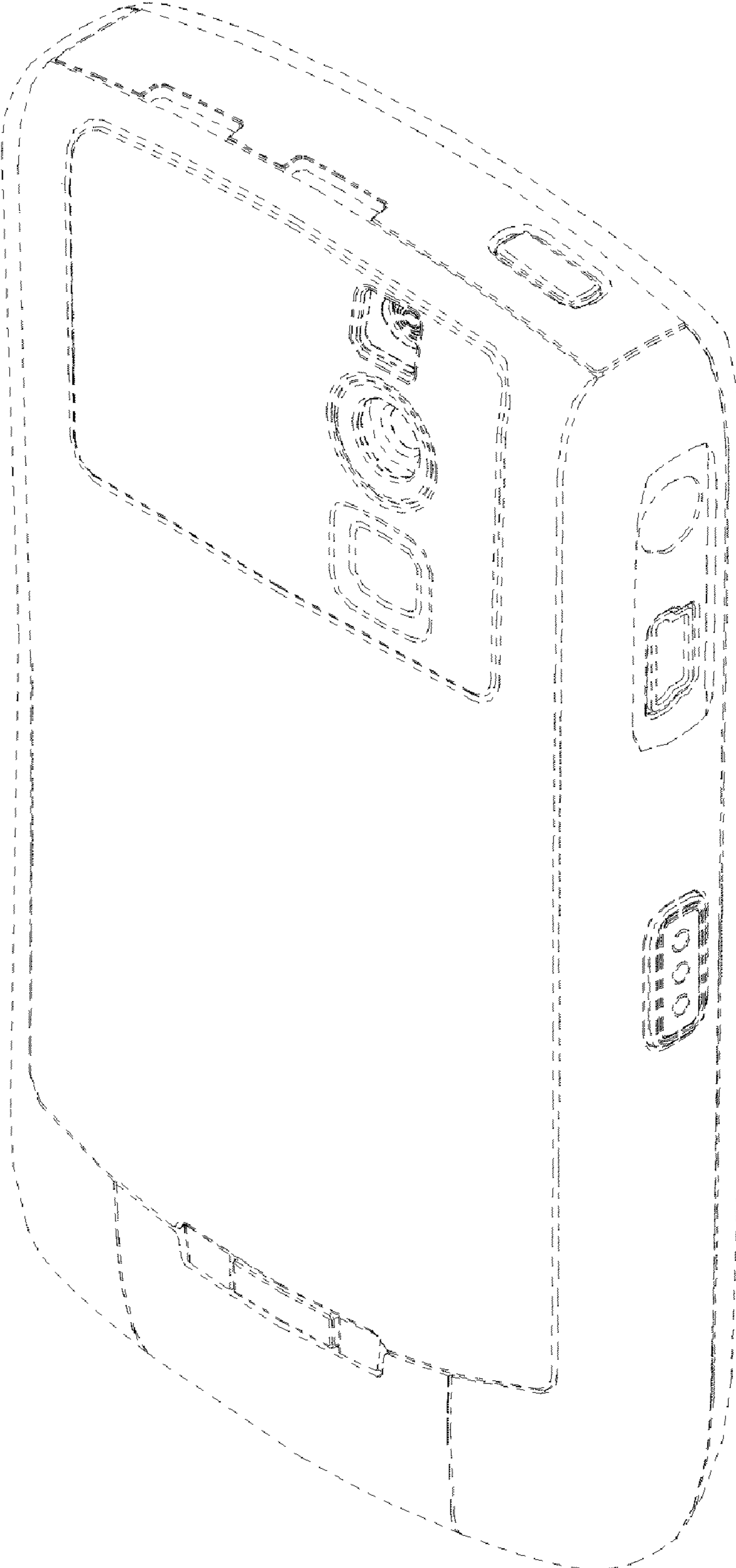

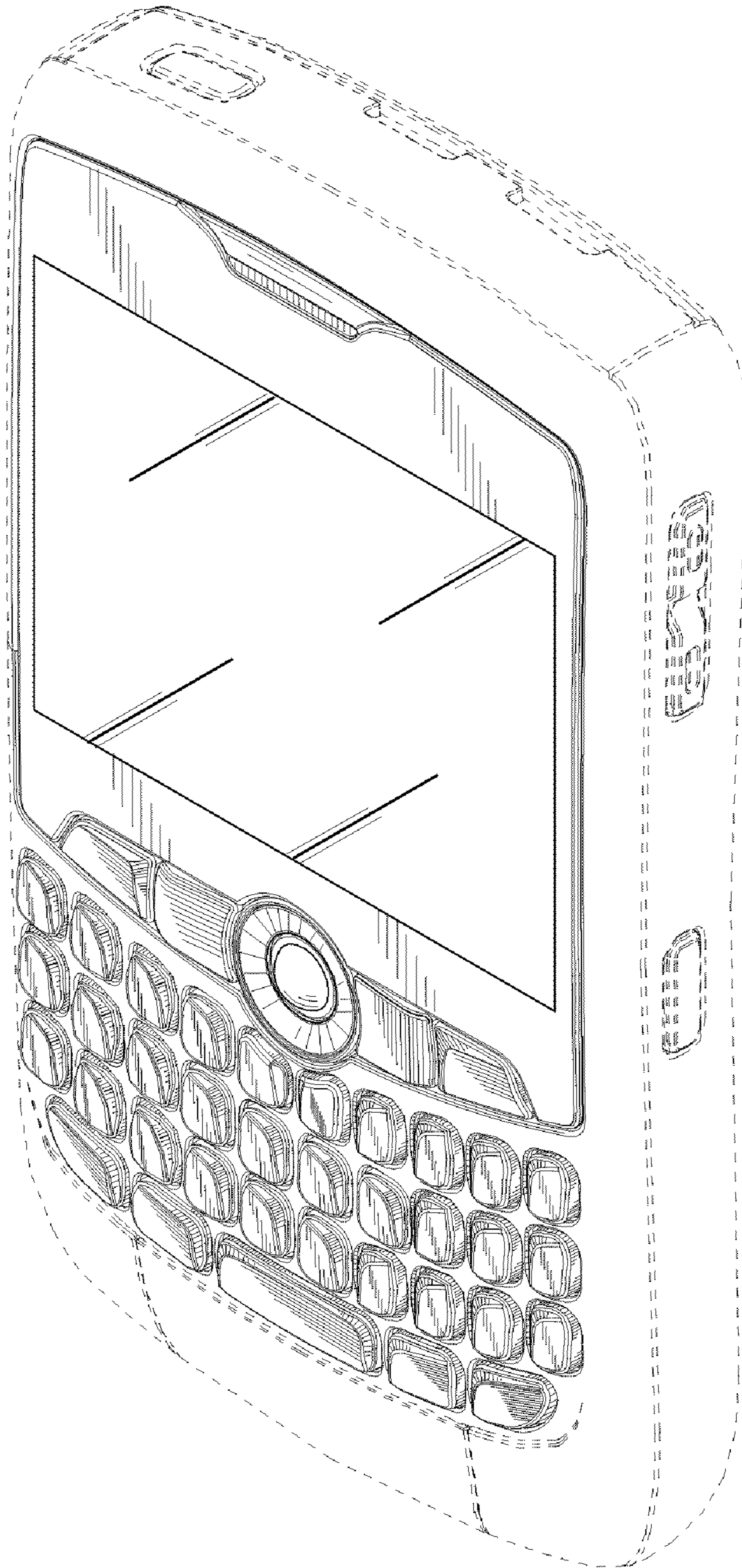

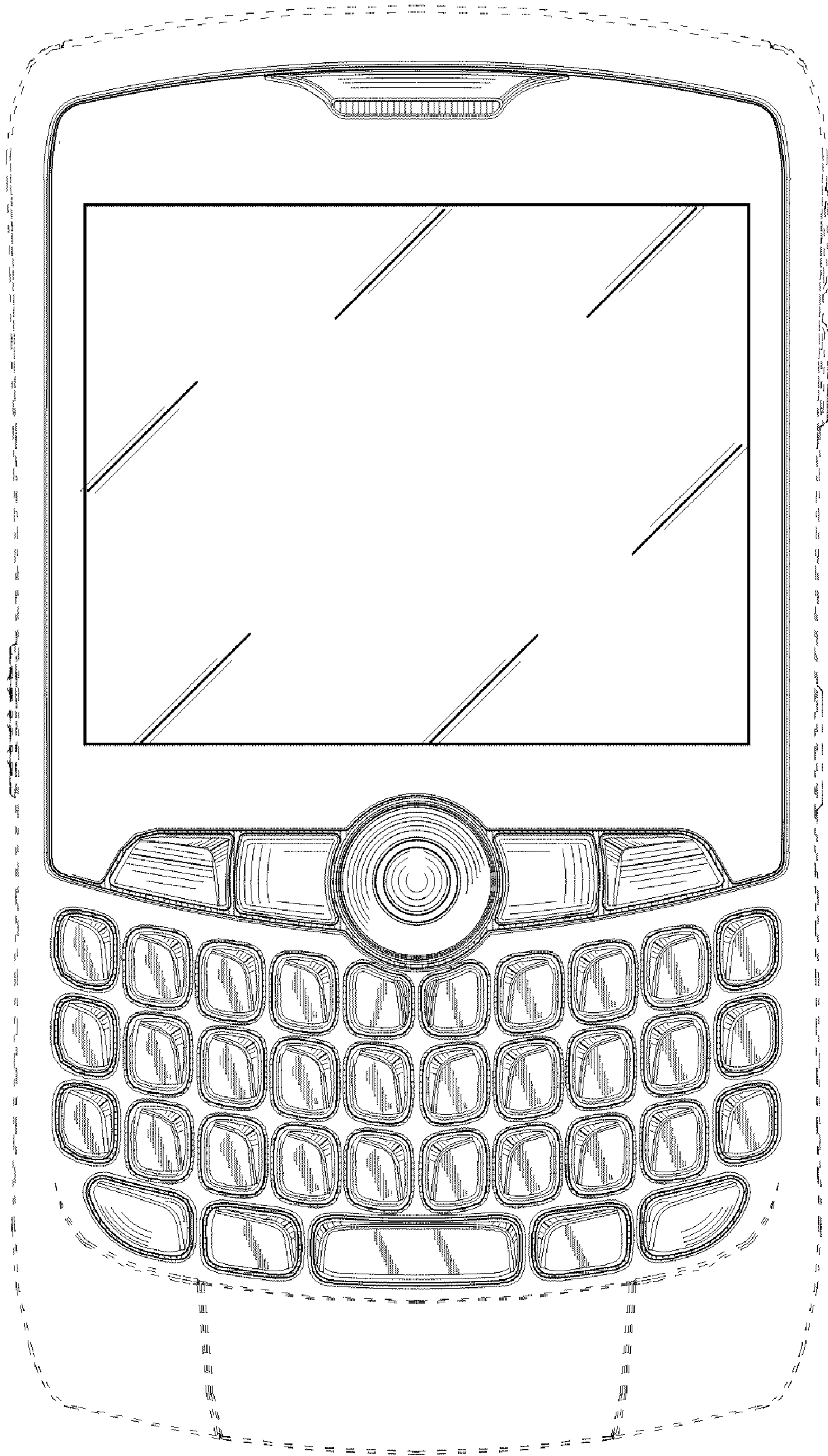

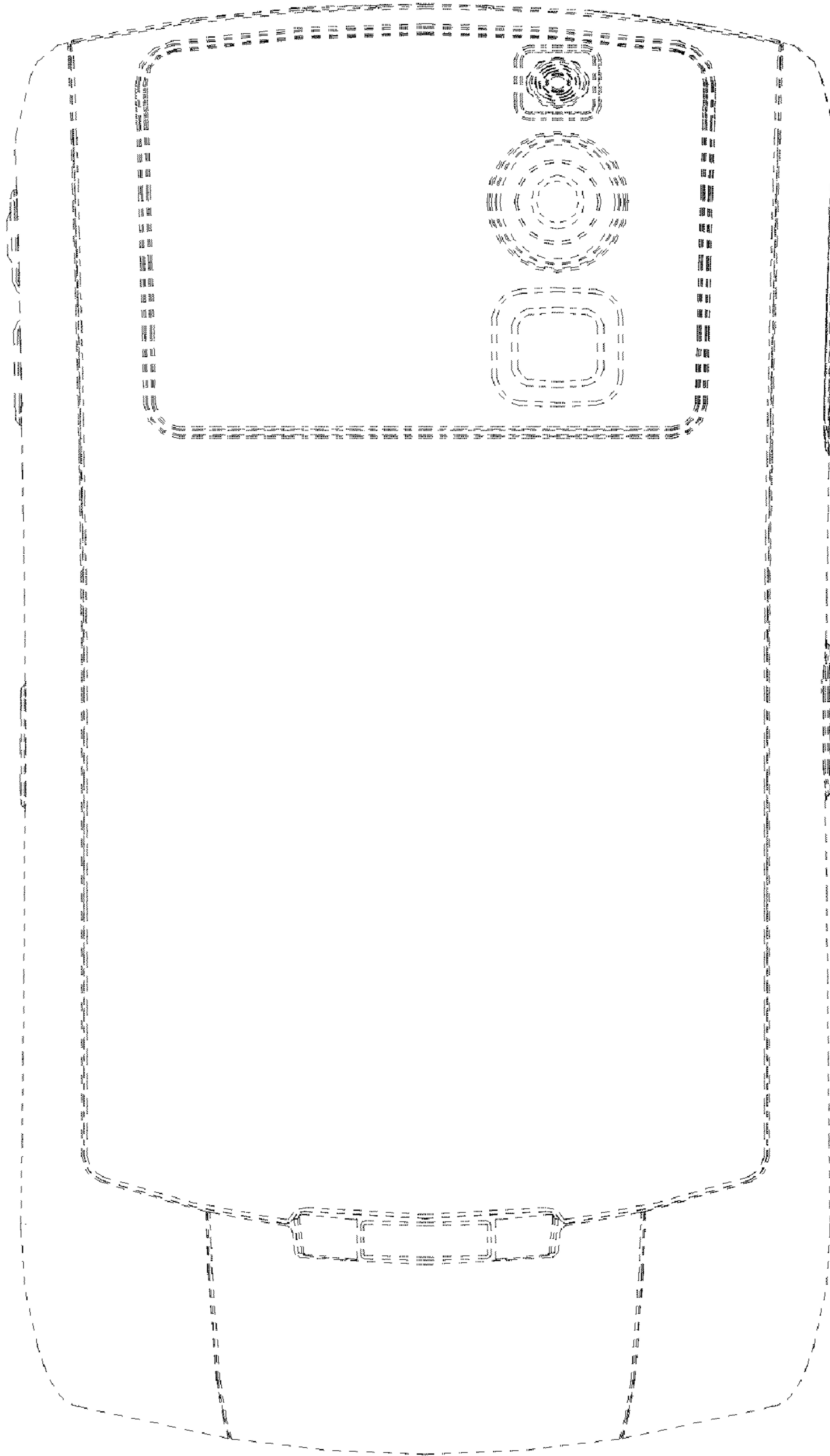

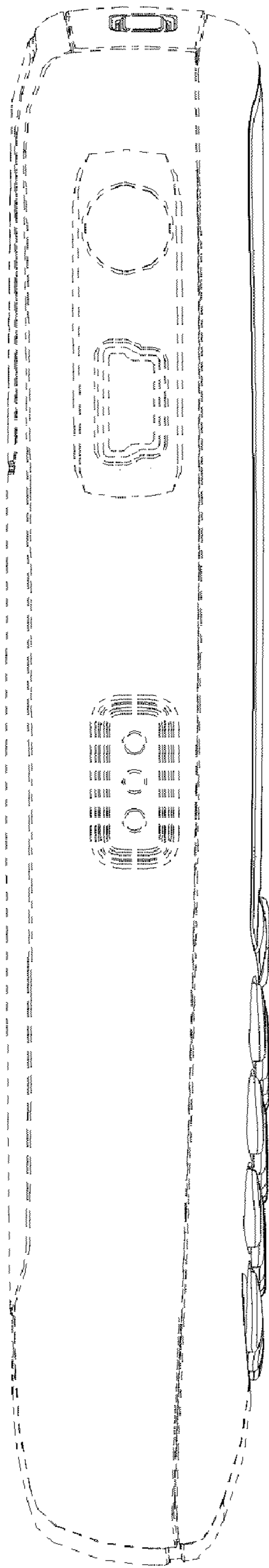

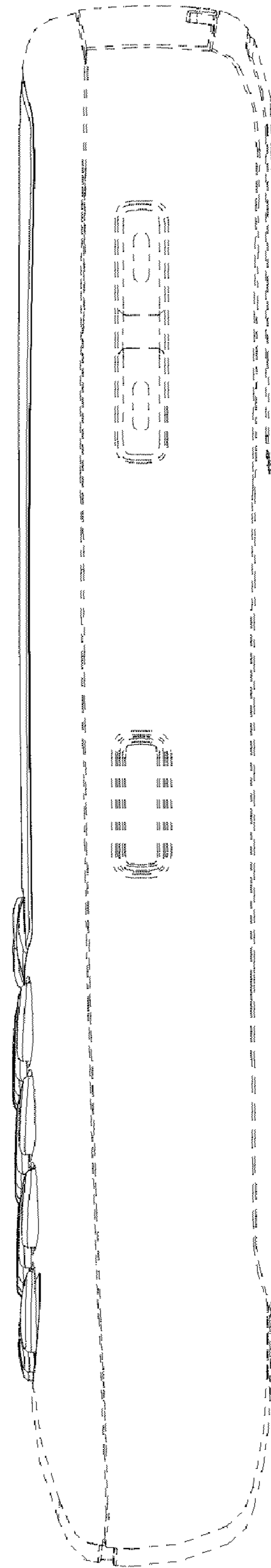

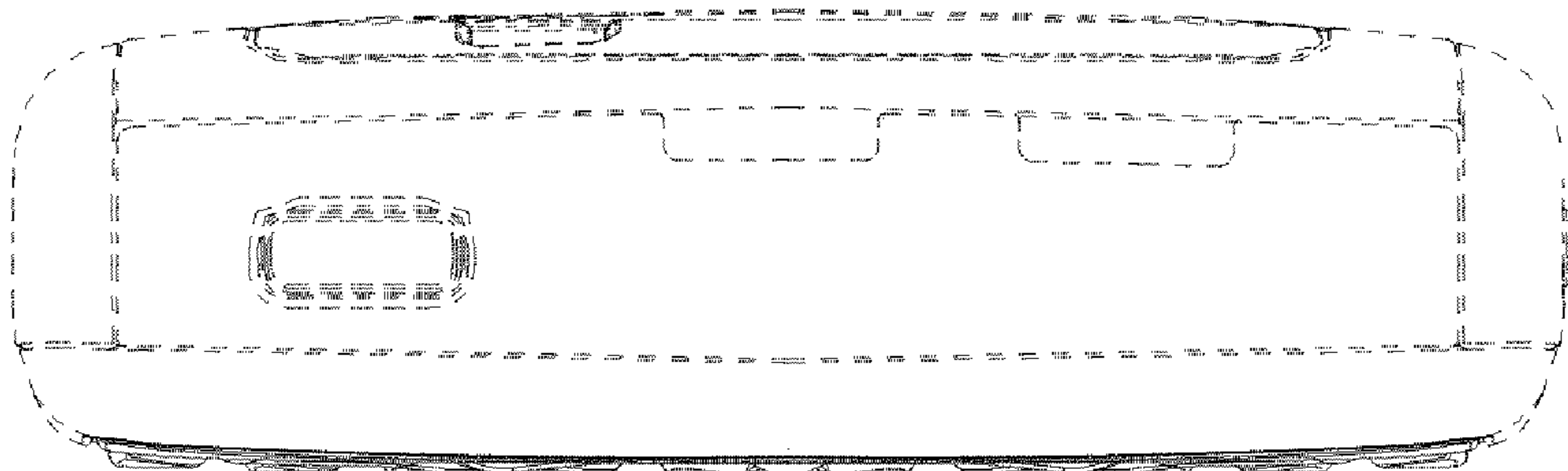

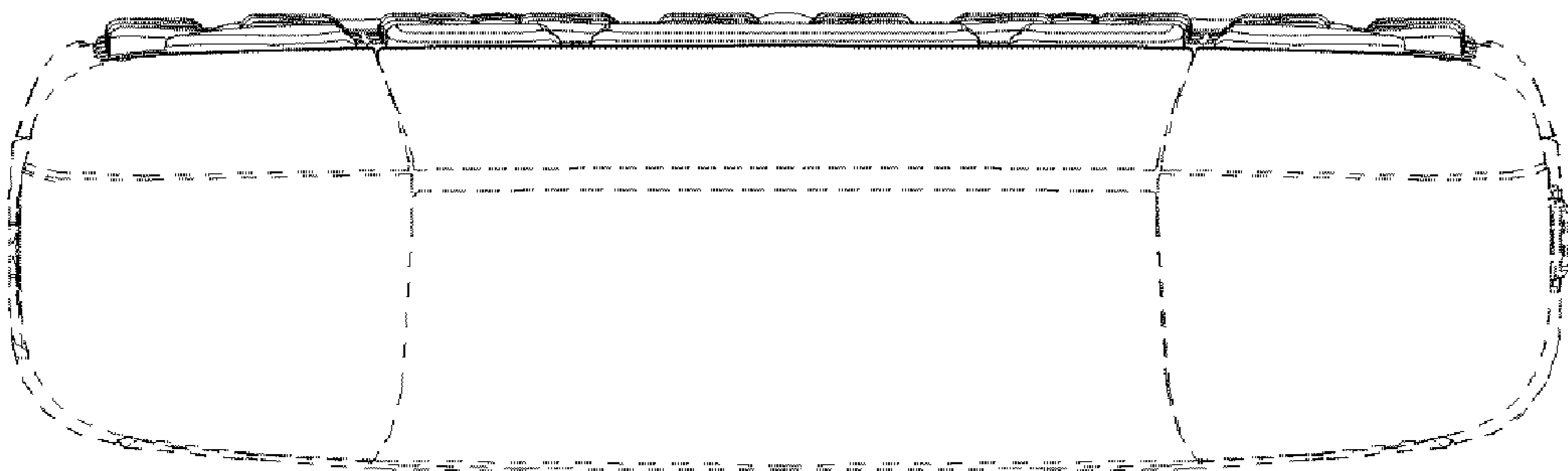
