(57) **CLAIM**

The ornamental design for a slip cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a slip cover according to one implementation, in a folded condition;

FIG. 2 is a top plan view of the slip cover of FIG. 1;

FIG. 3 is a front elevation view of the slip cover of FIG. 1;

FIG. 4 is a back elevation view of the slip cover of FIG. 1;

FIG. 5 is a bottom plan view of the slip cover of FIG. 1;

FIG. 6 is a left side elevation view of the slip cover of FIG. 1;

FIG. 7 is a right side elevation view of the slip cover of FIG. 1;

FIG. 8 is a perspective view of a slip cover according to another implementation, in a folded condition;

FIG. 9 is a top plan view of the slip cover of FIG. 8;

FIG. 10 is a front elevation view of the slip cover of FIG. 8;

FIG. 11 is a back elevation view of the slip cover of FIG. 8;

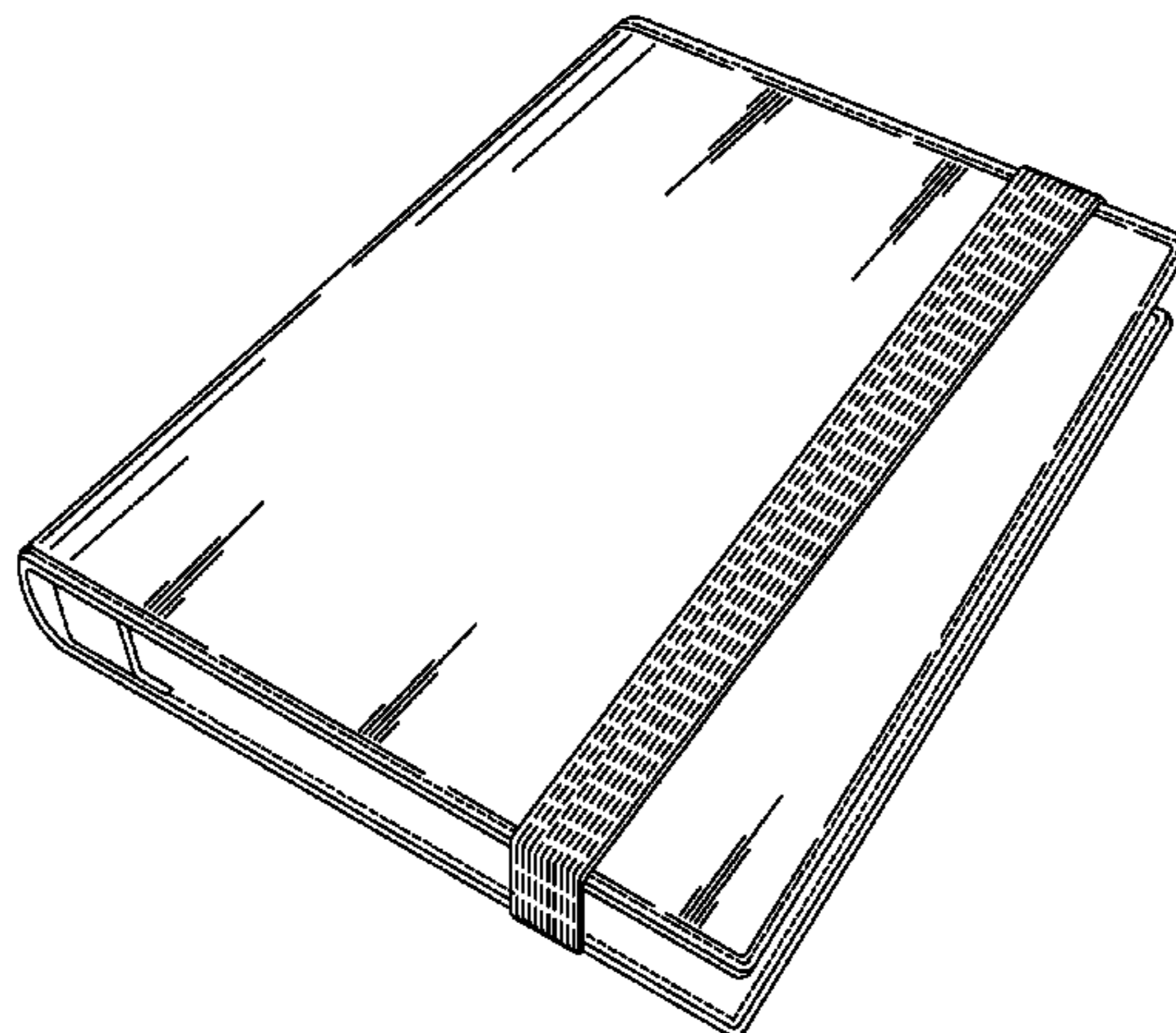
FIG. 12 is a bottom plan view of the slip cover of FIG. 8;

FIG. 13 is a left side elevation view of the slip cover of FIG. 8; and,

FIG. 14 is a right side elevation view of the slip cover of FIG. 8.

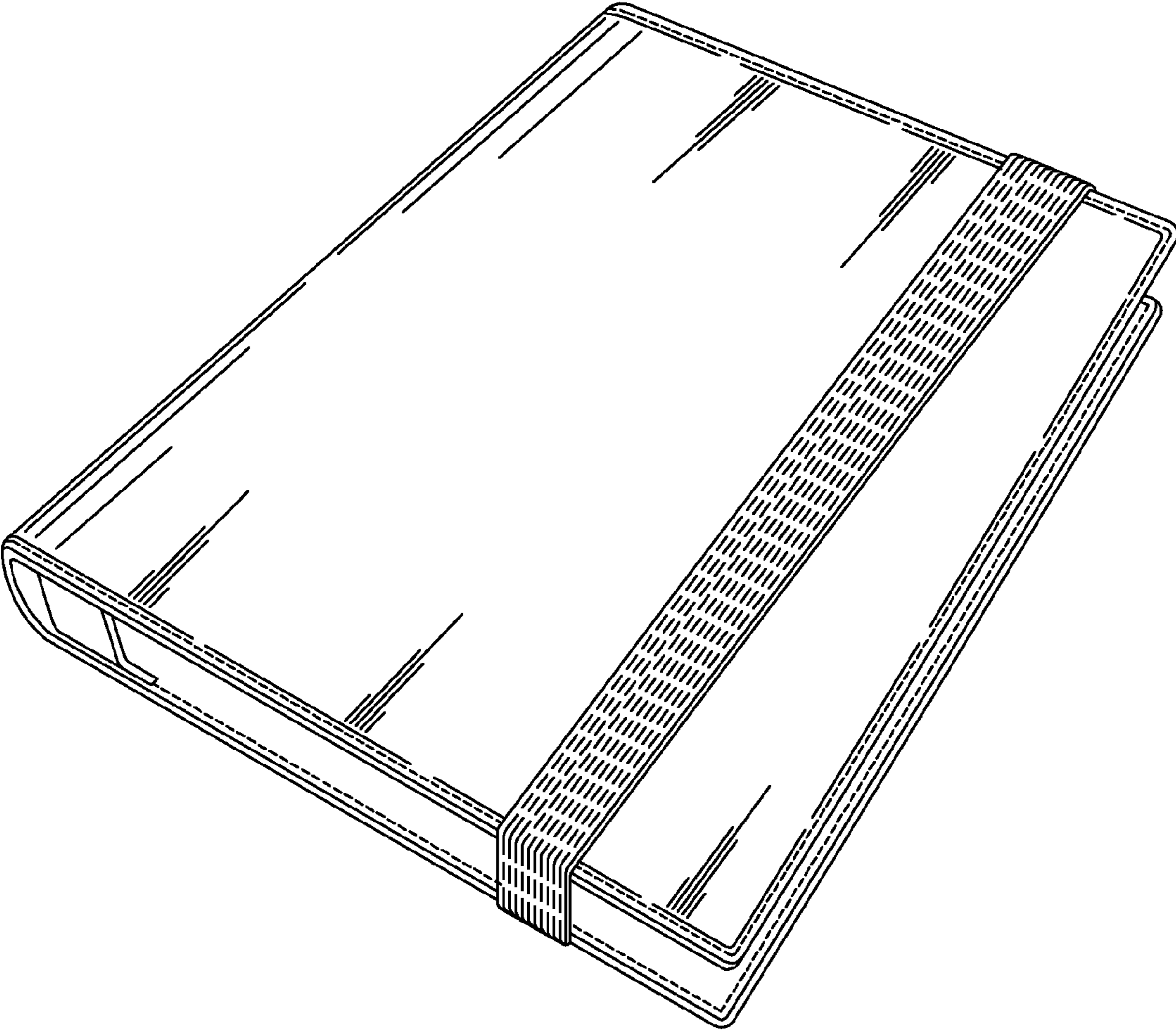

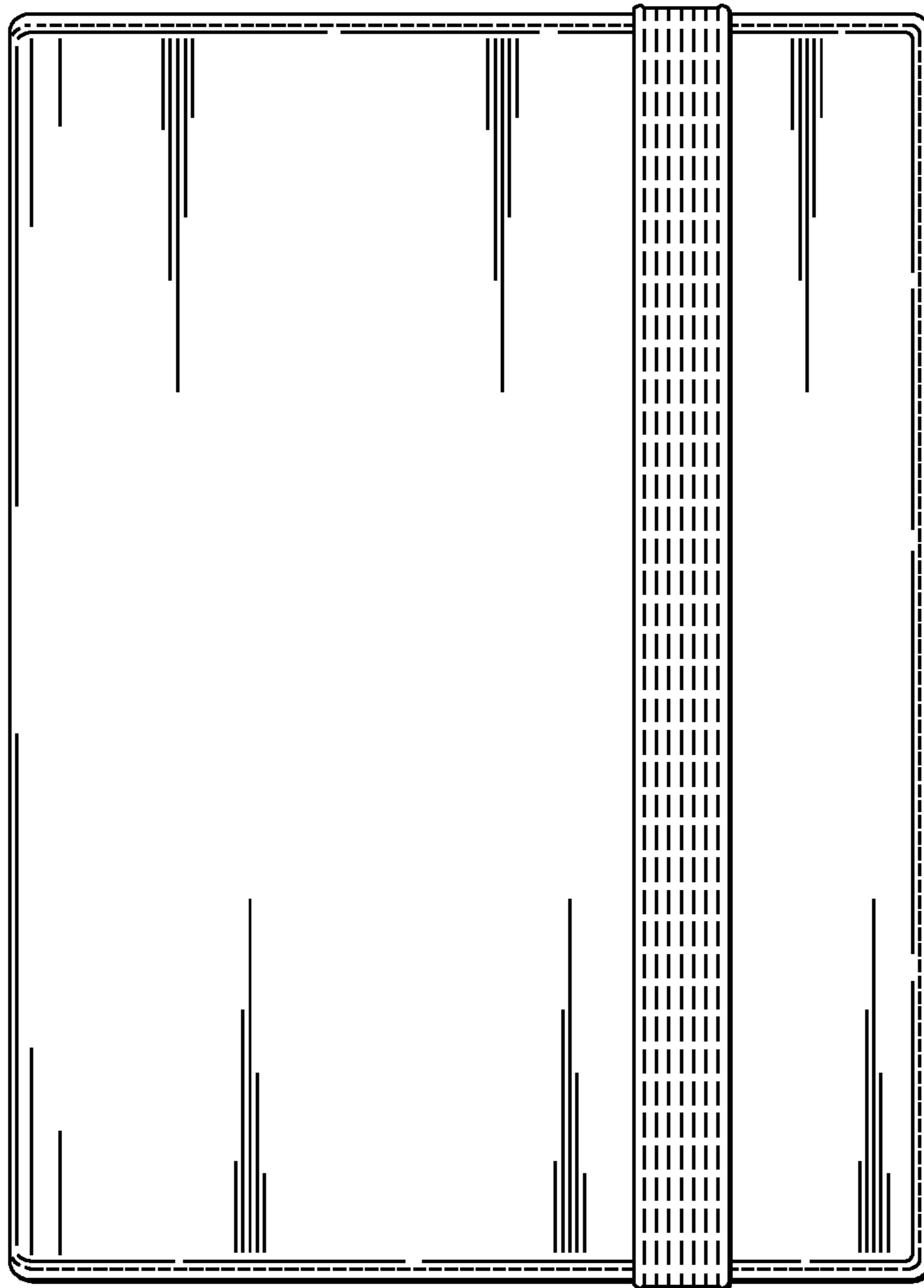

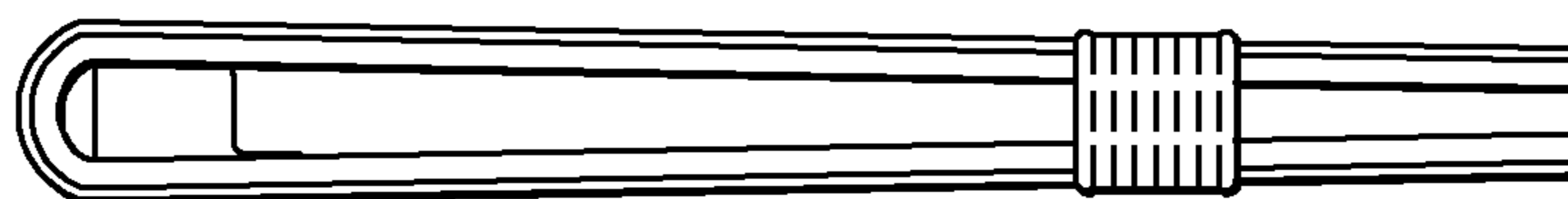

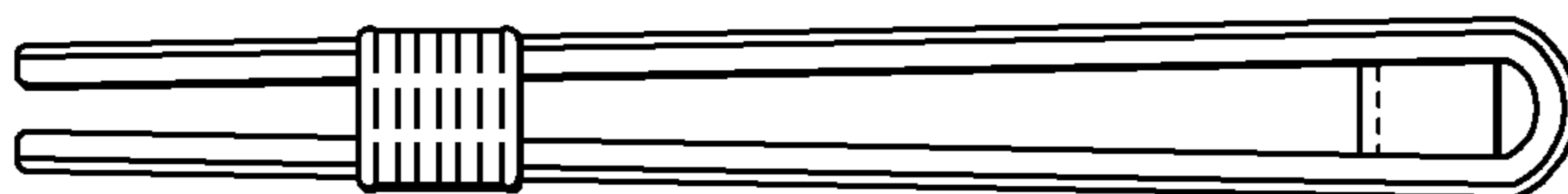

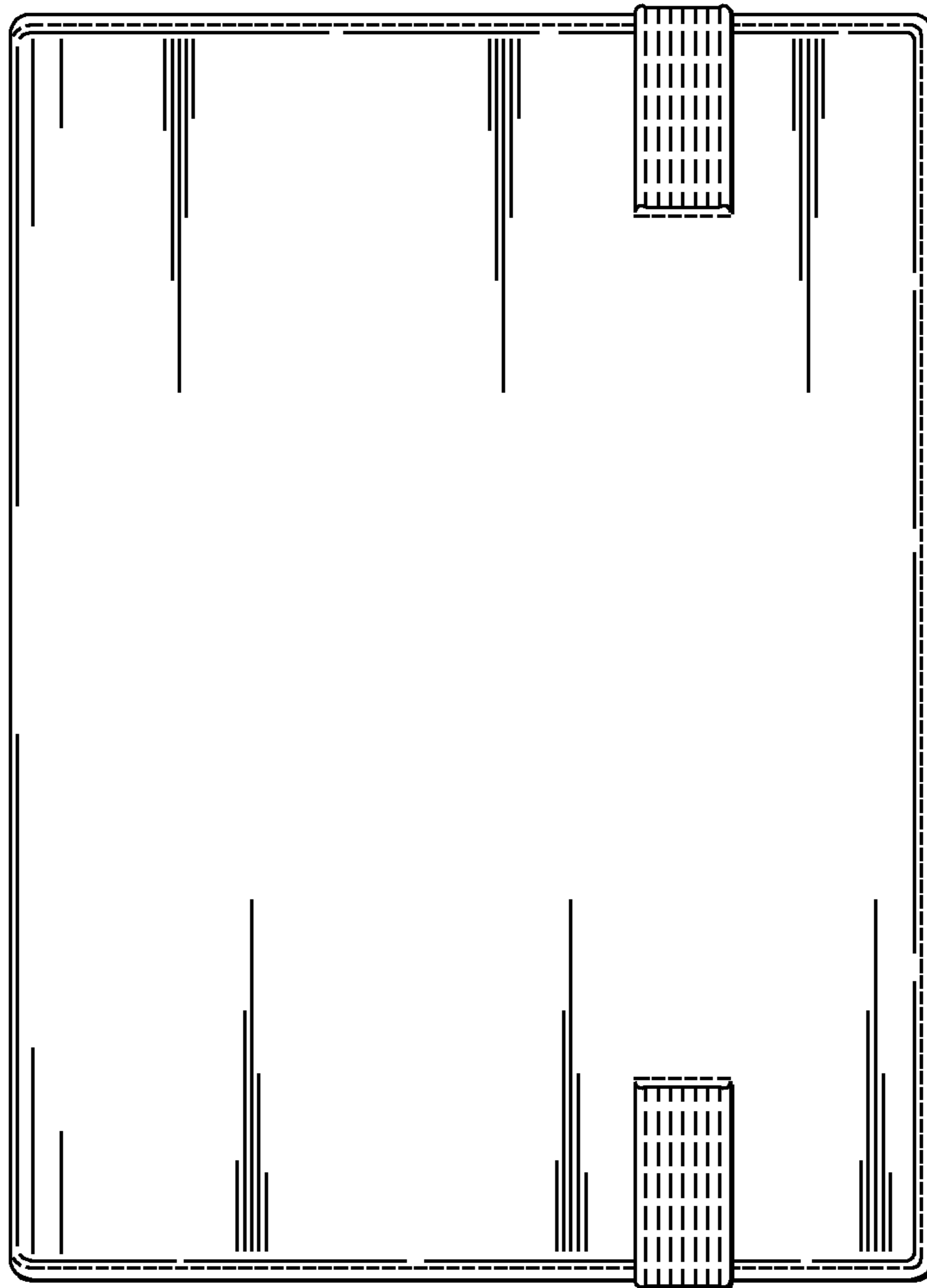

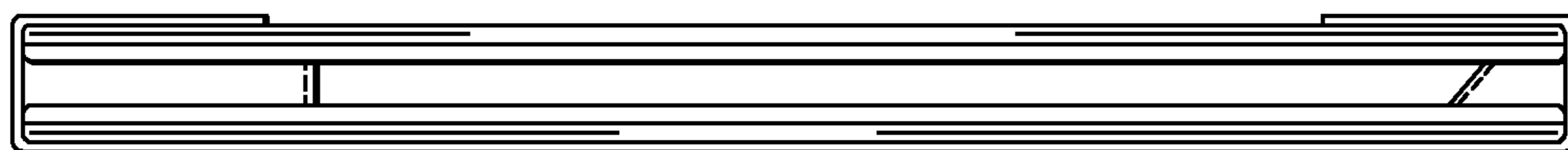

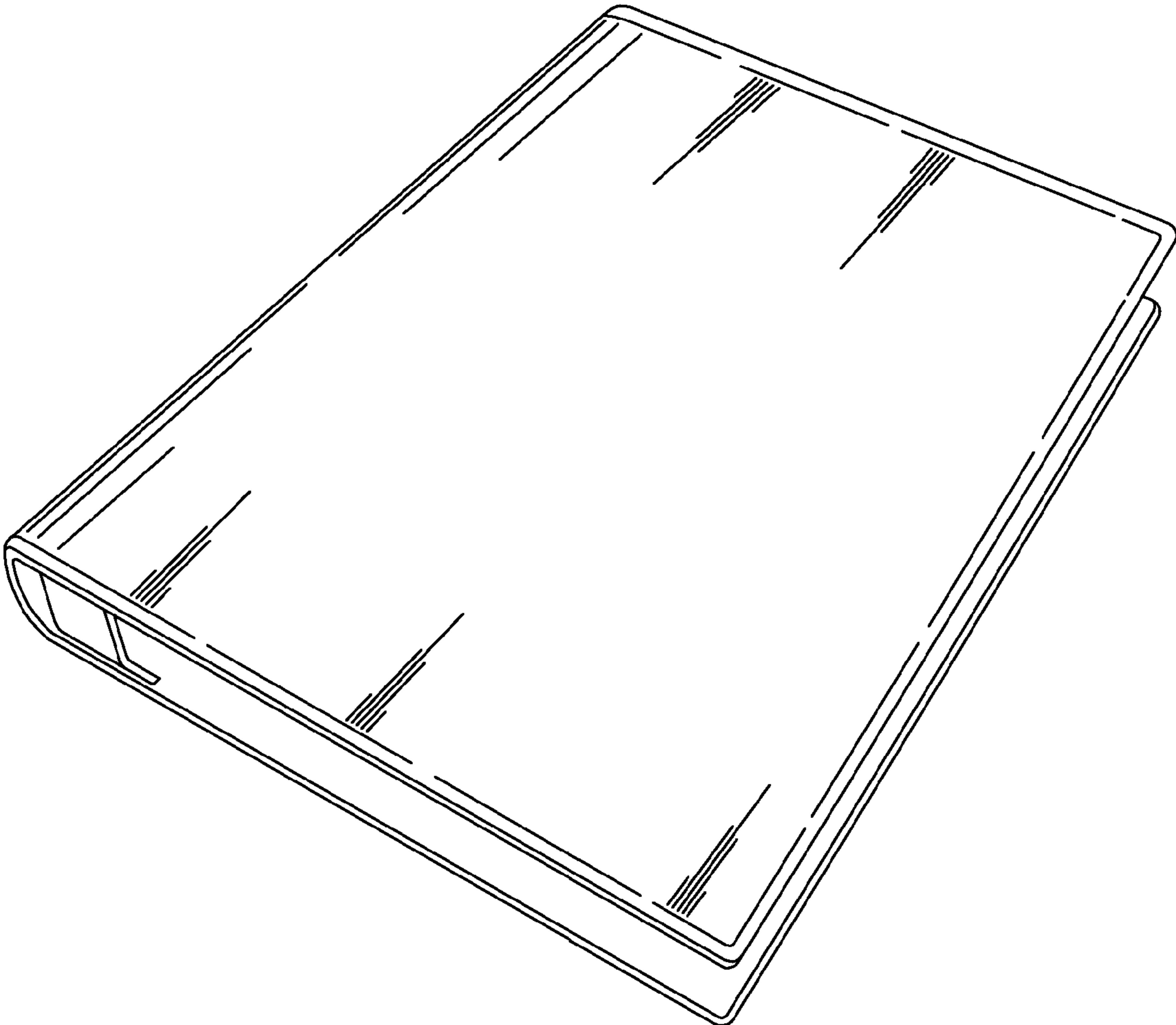

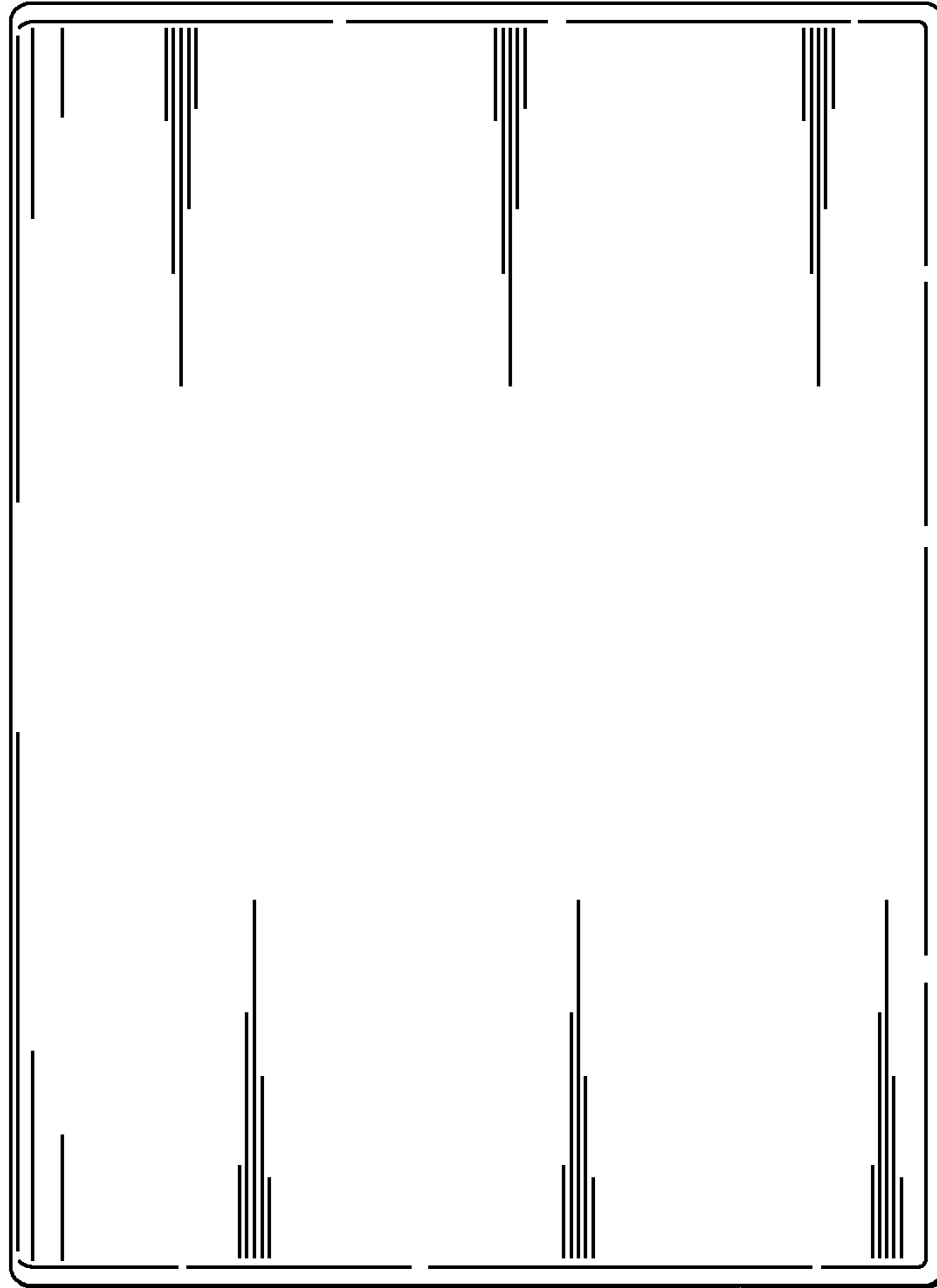

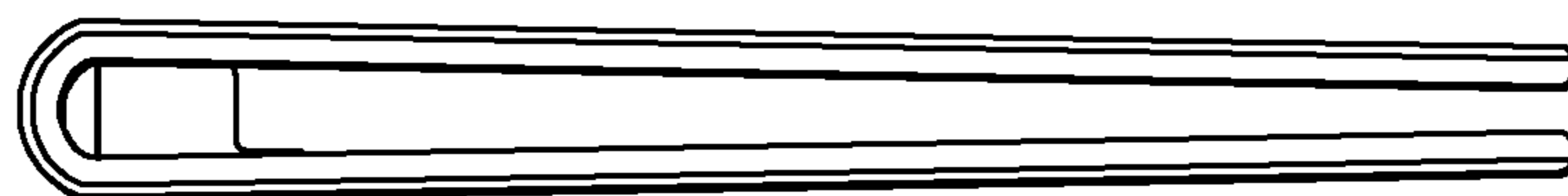

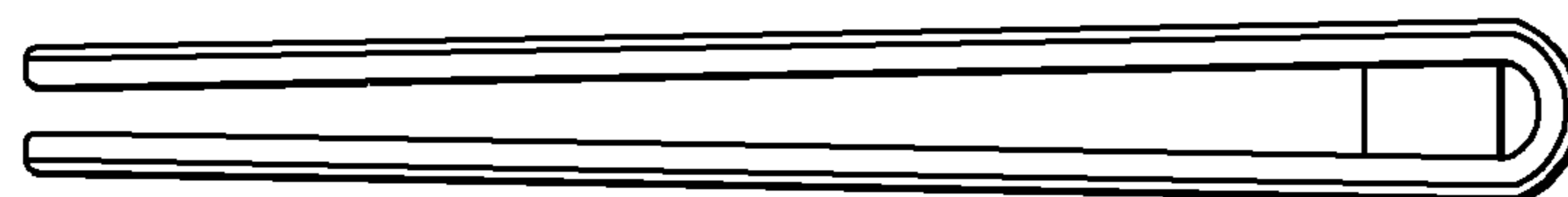

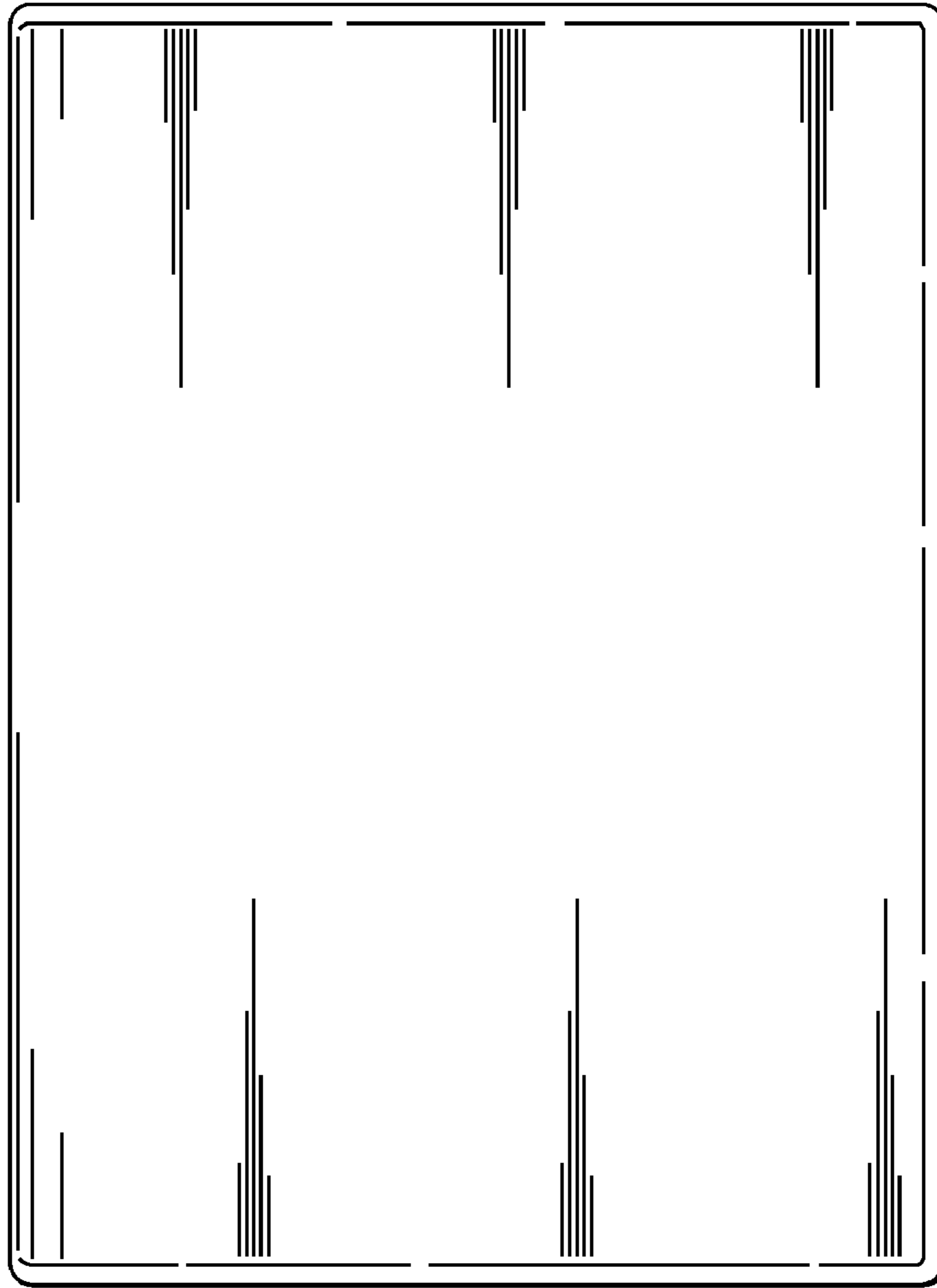

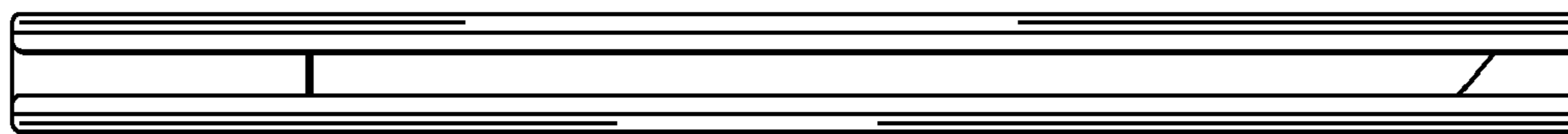
