FIG. 3 is a rear view of the machine of FIG. 1.

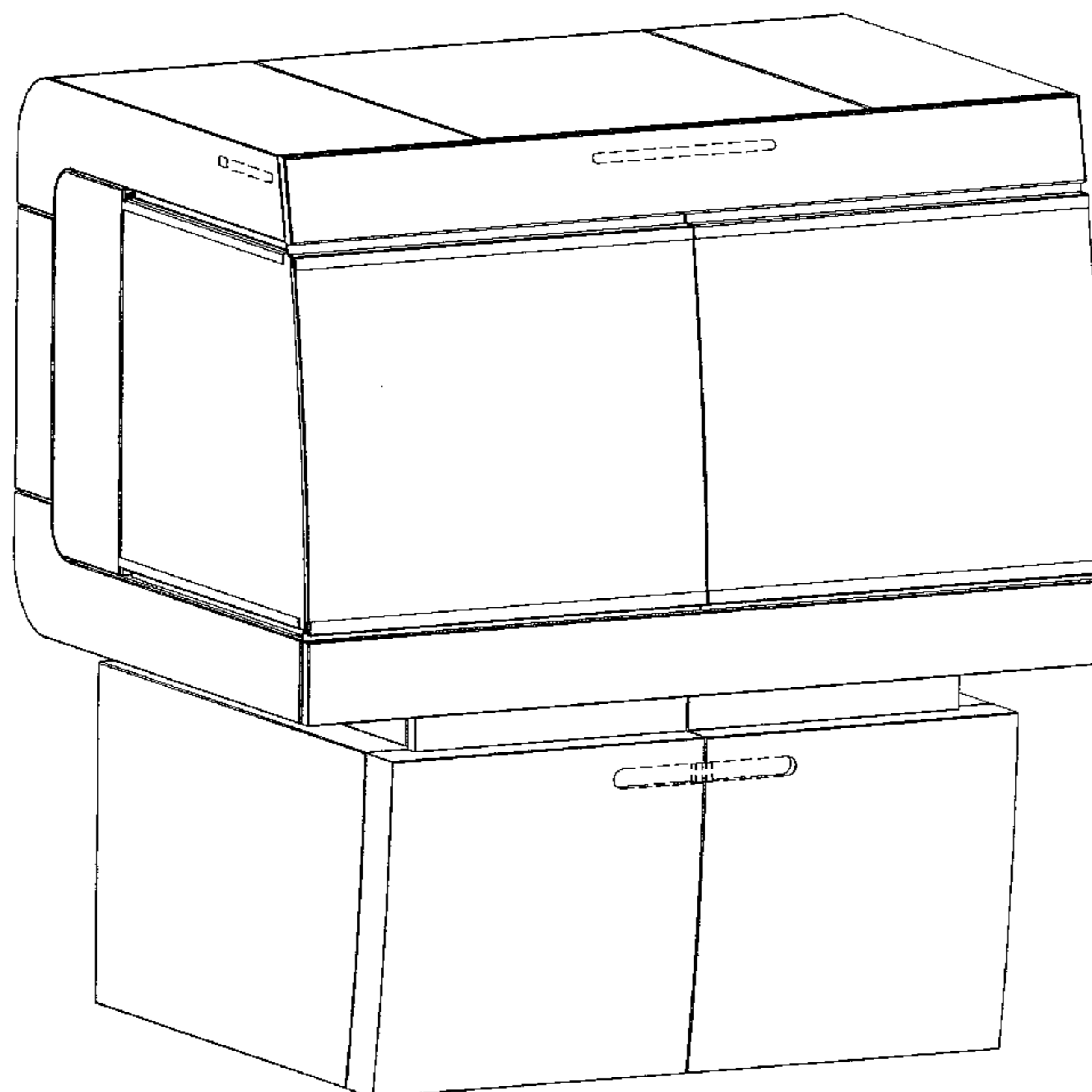
FIG. 4 is a left view of the machine of FIG. 1.

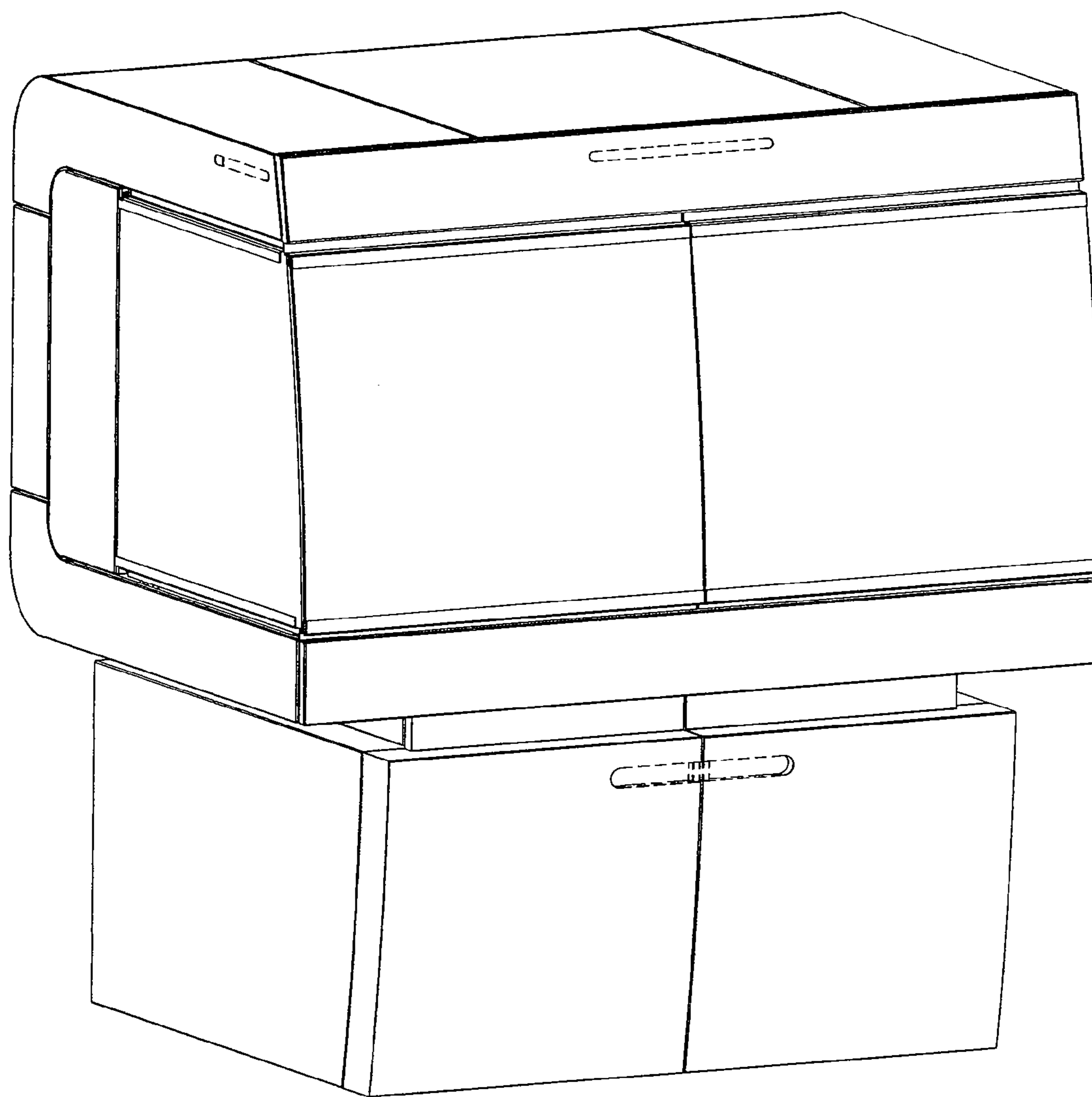

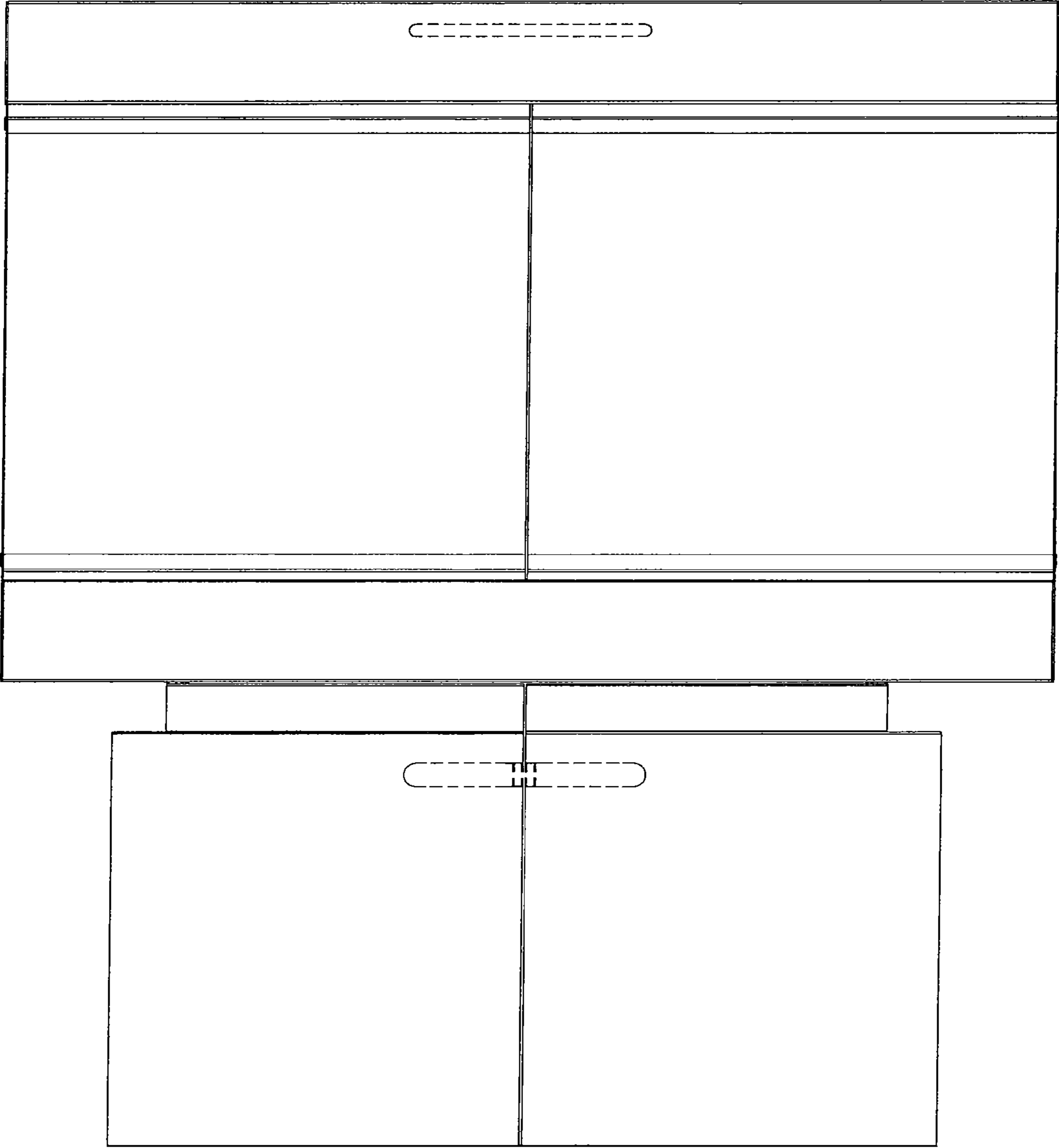

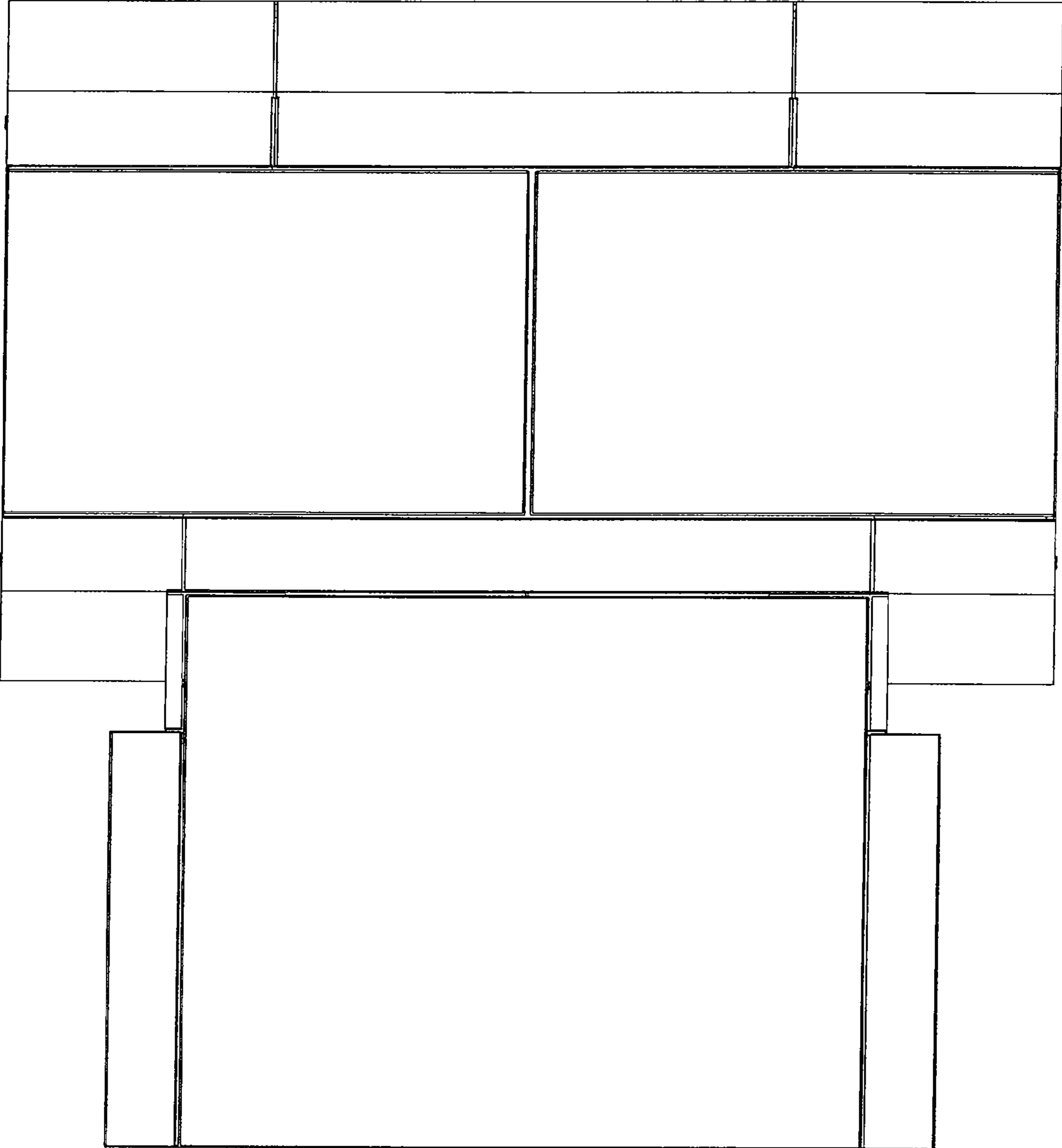

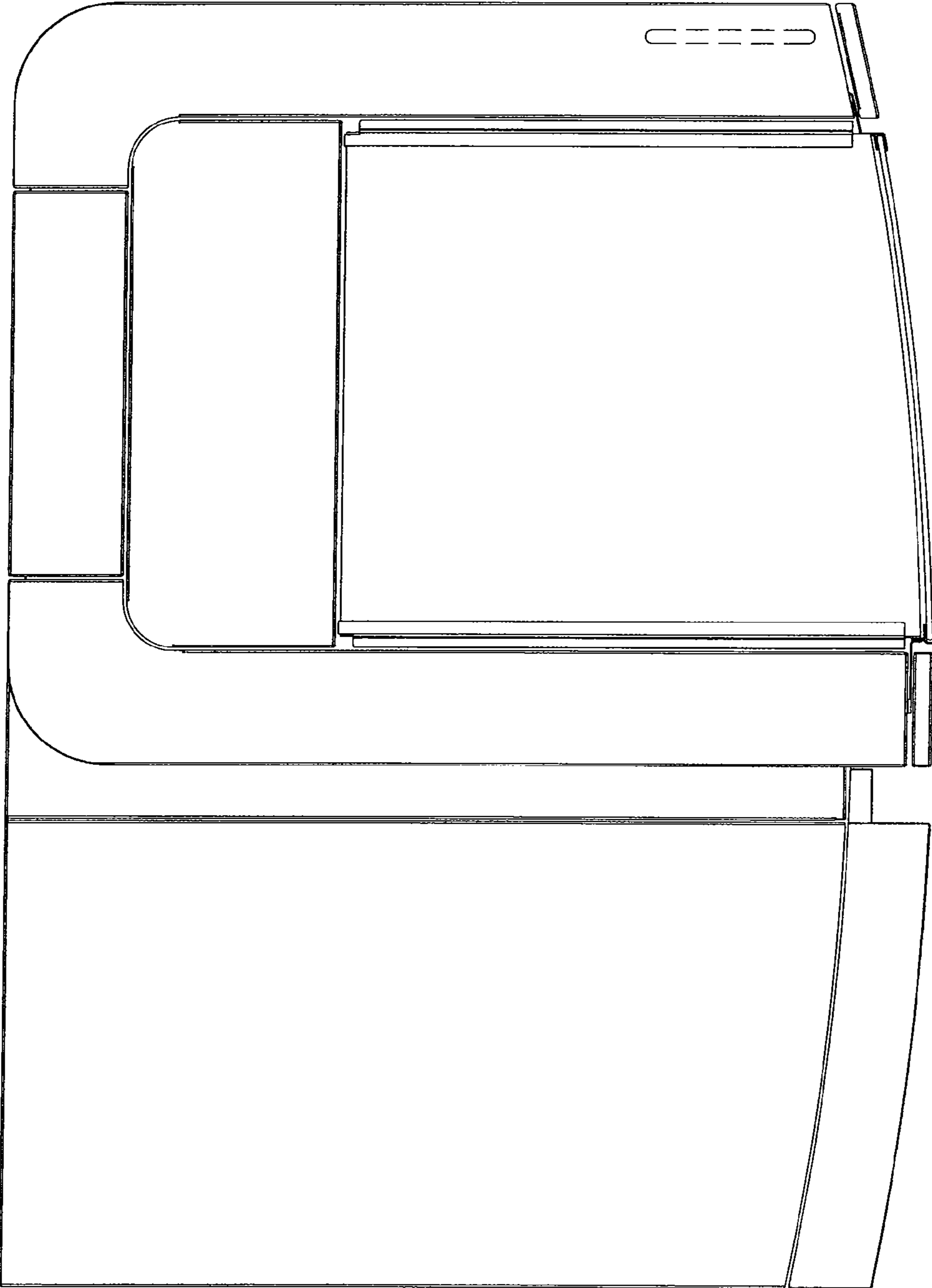

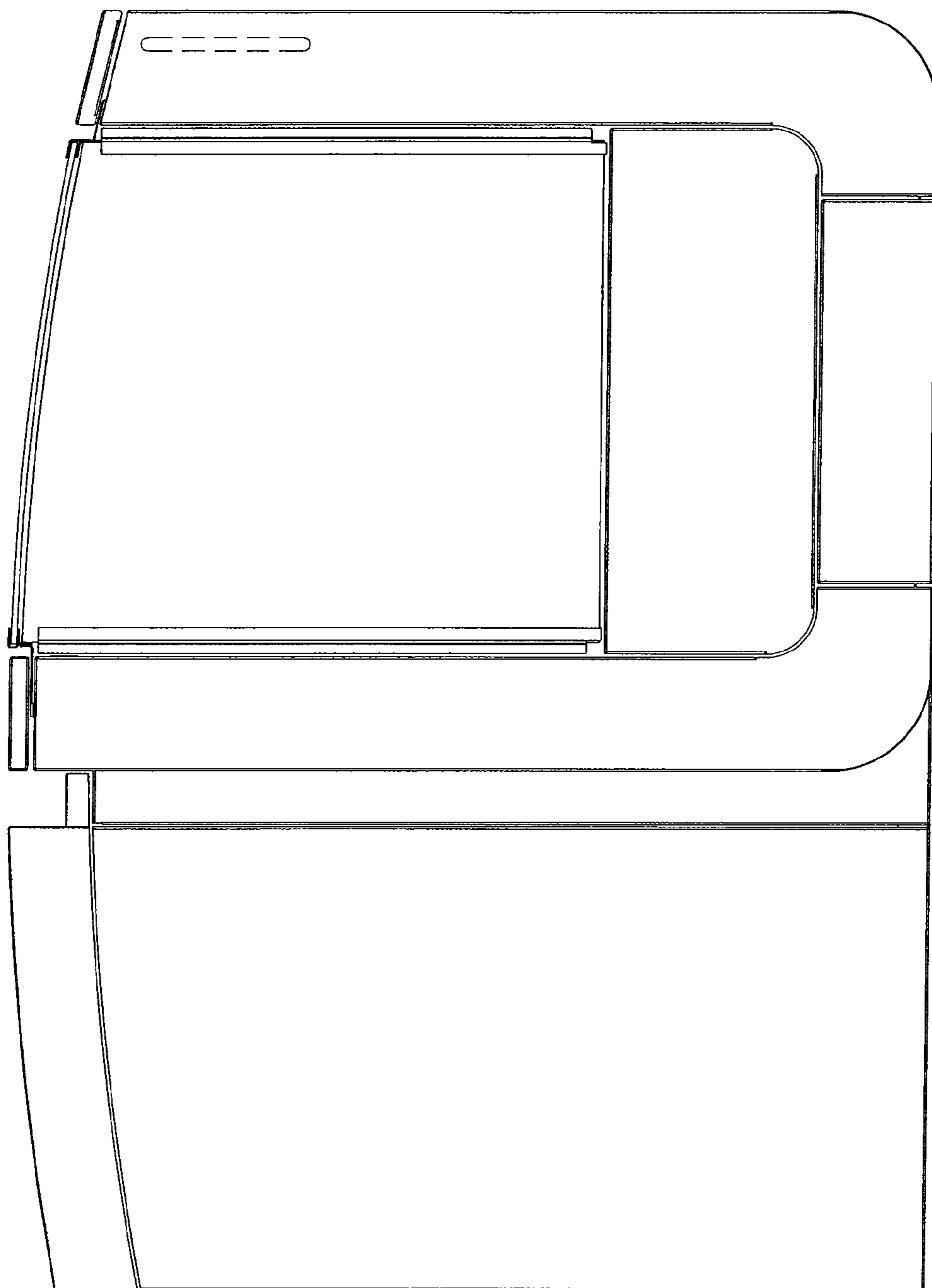

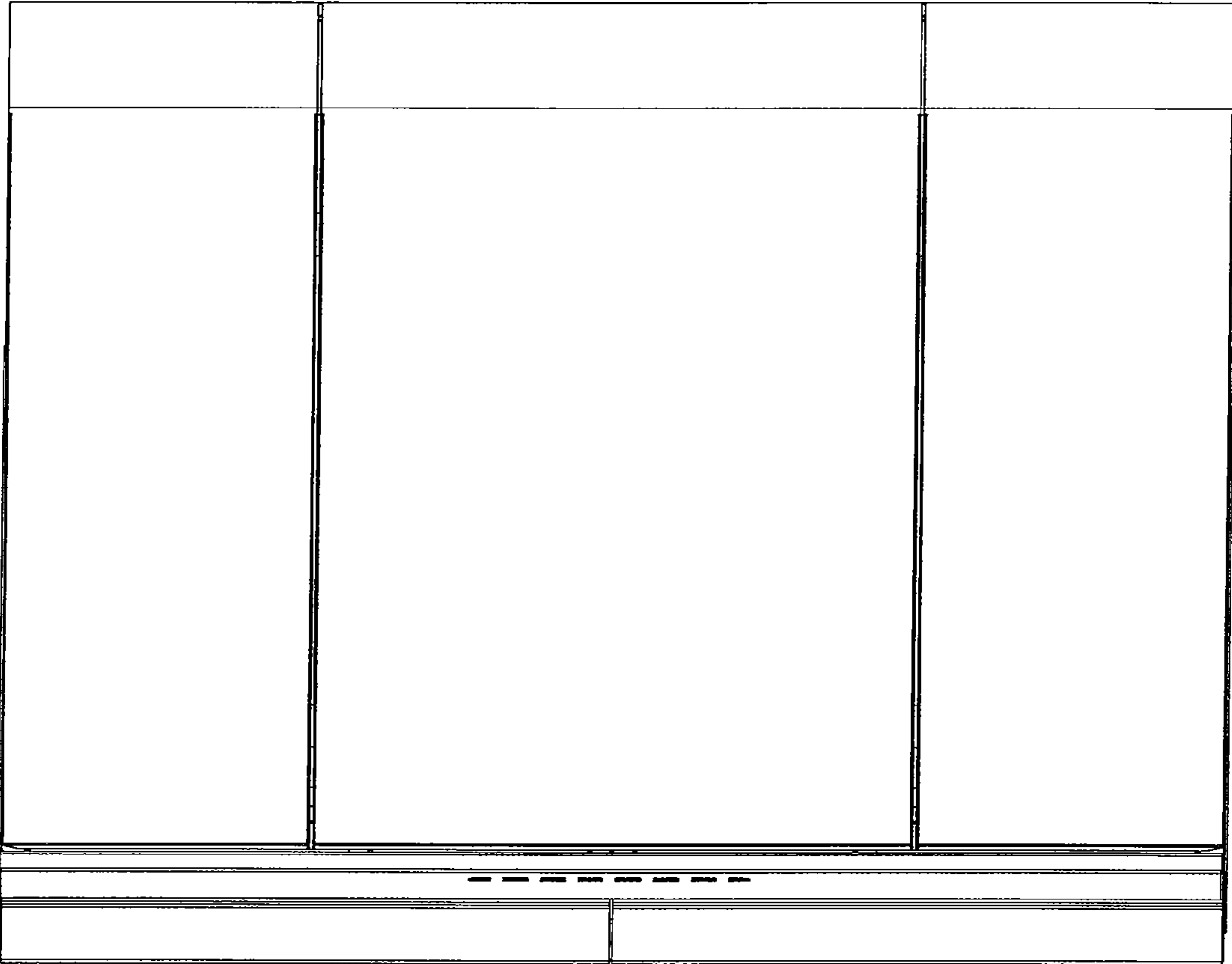
