FIG. 4 is a rear view of the cleaning cart shown in FIG. 1;

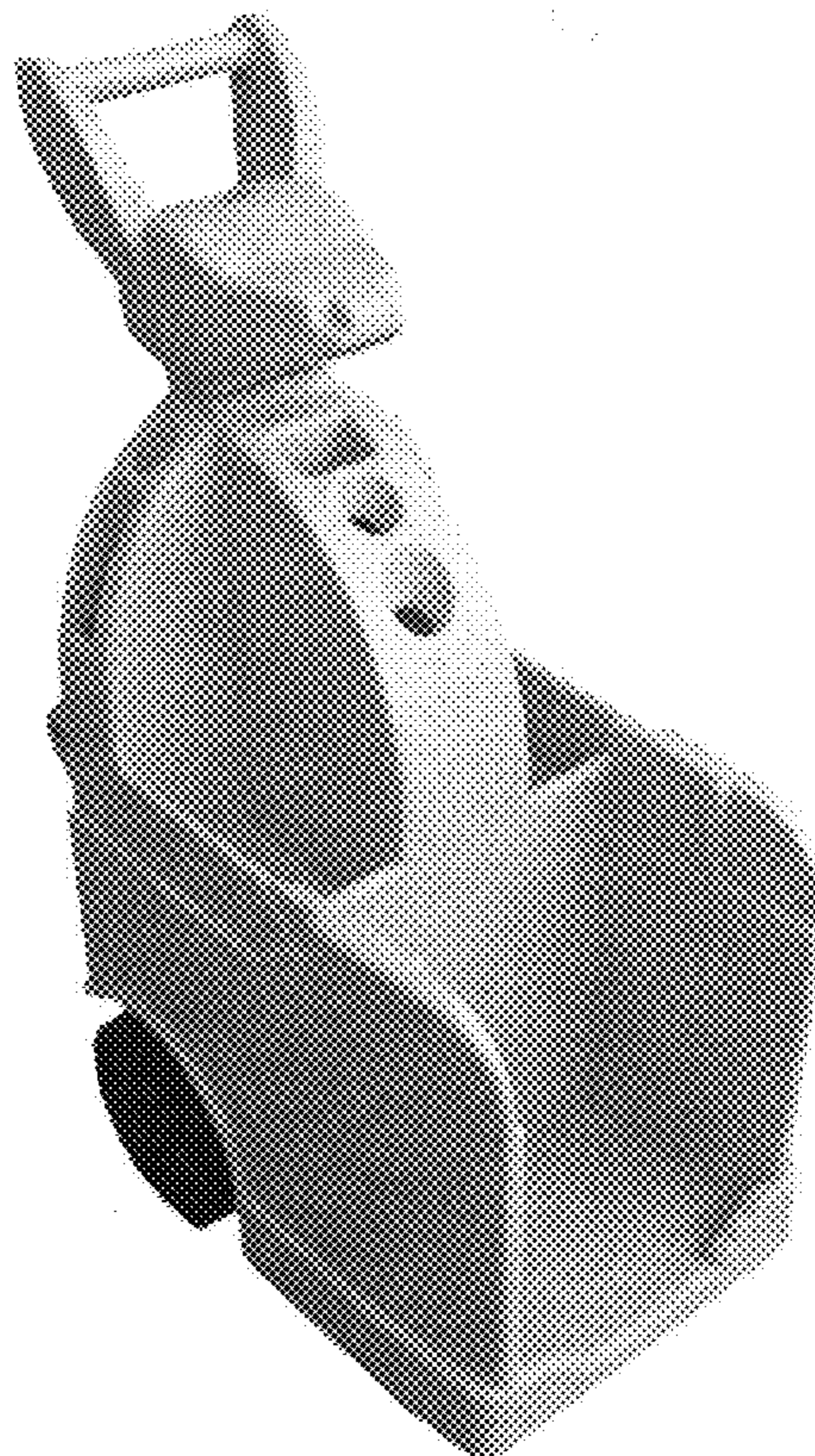
FIG. 5 is a first side view of the cleaning cart shown in FIG. 1;

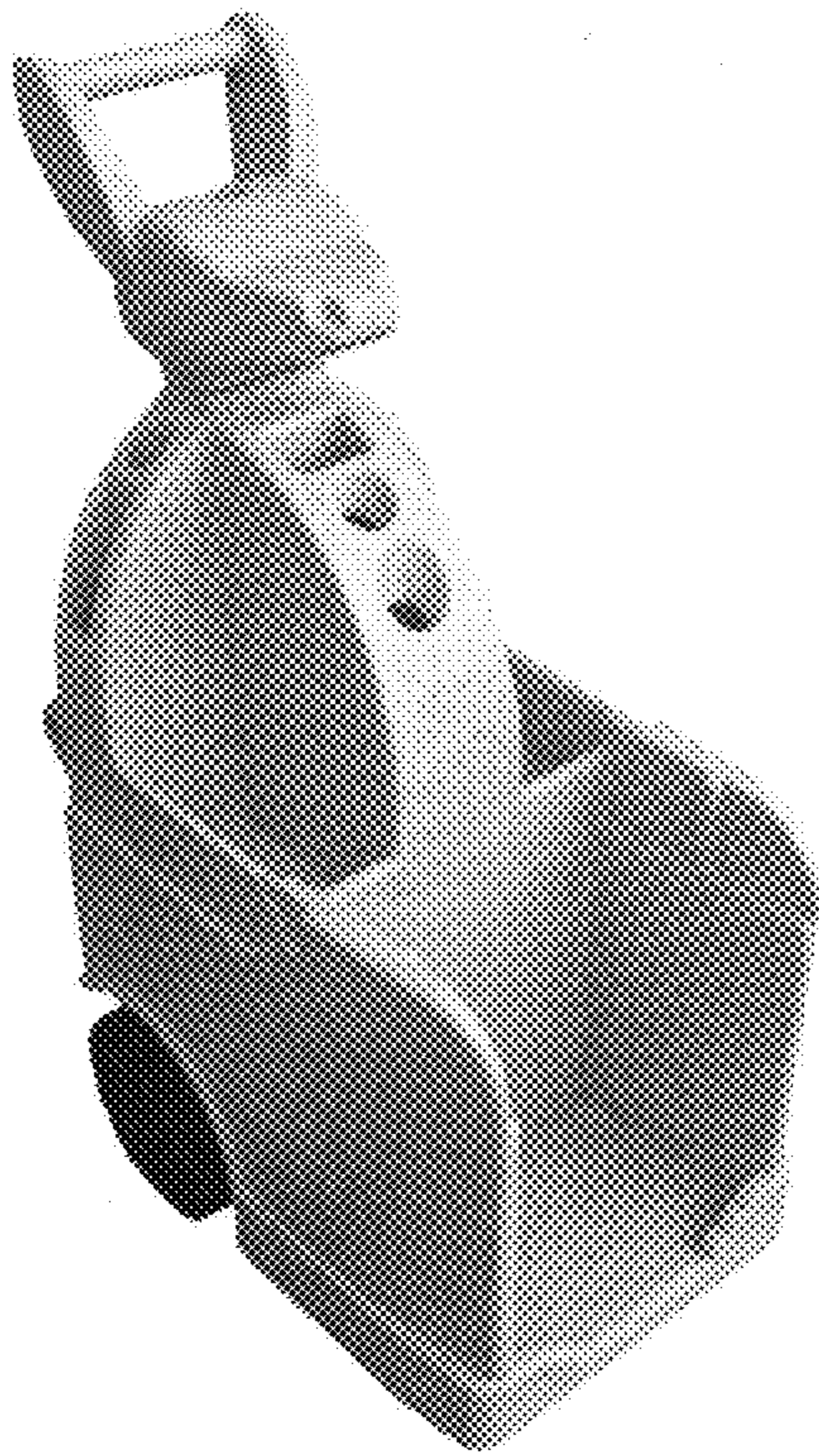

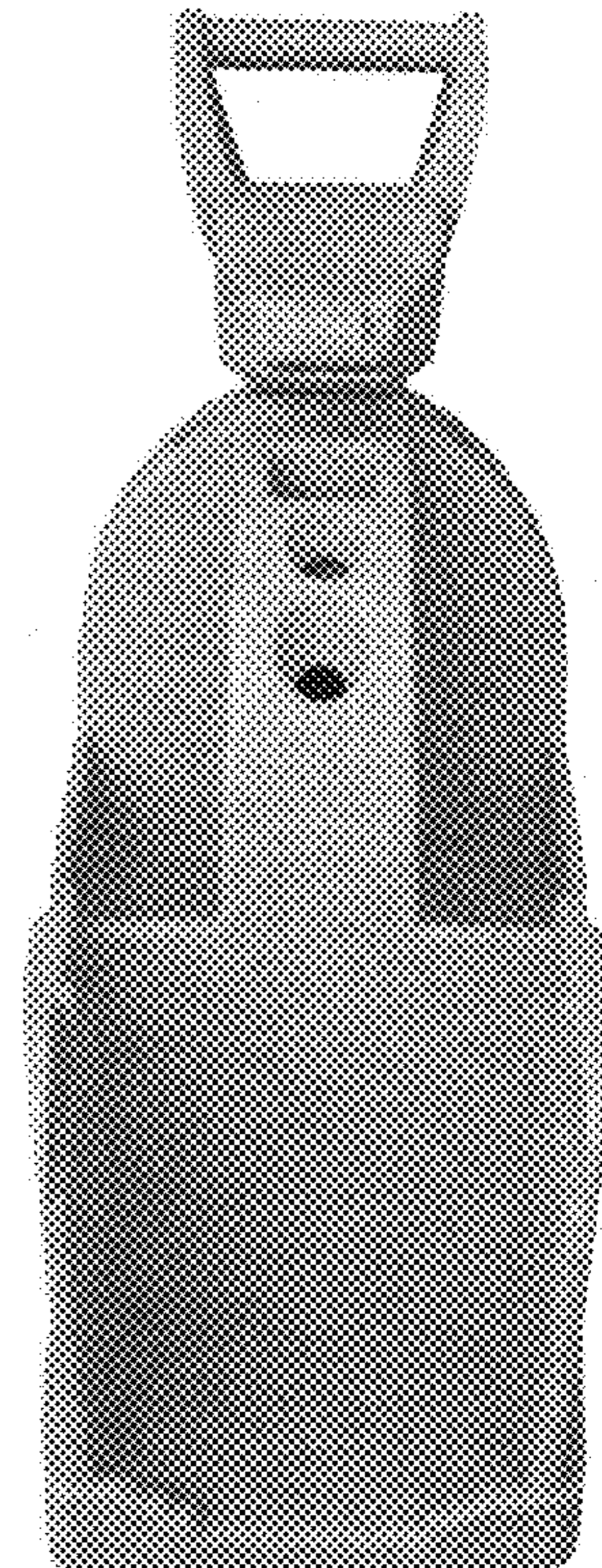

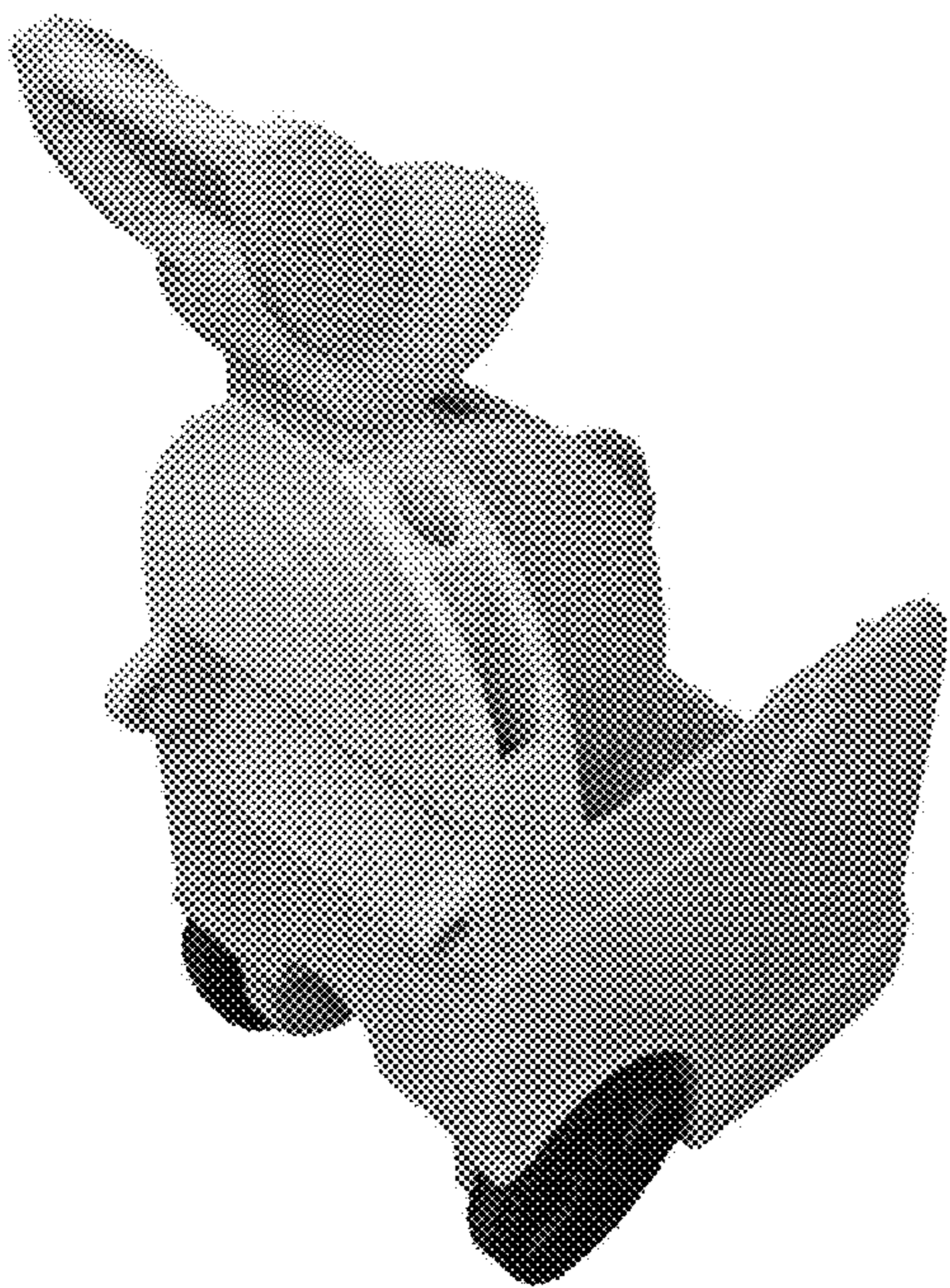

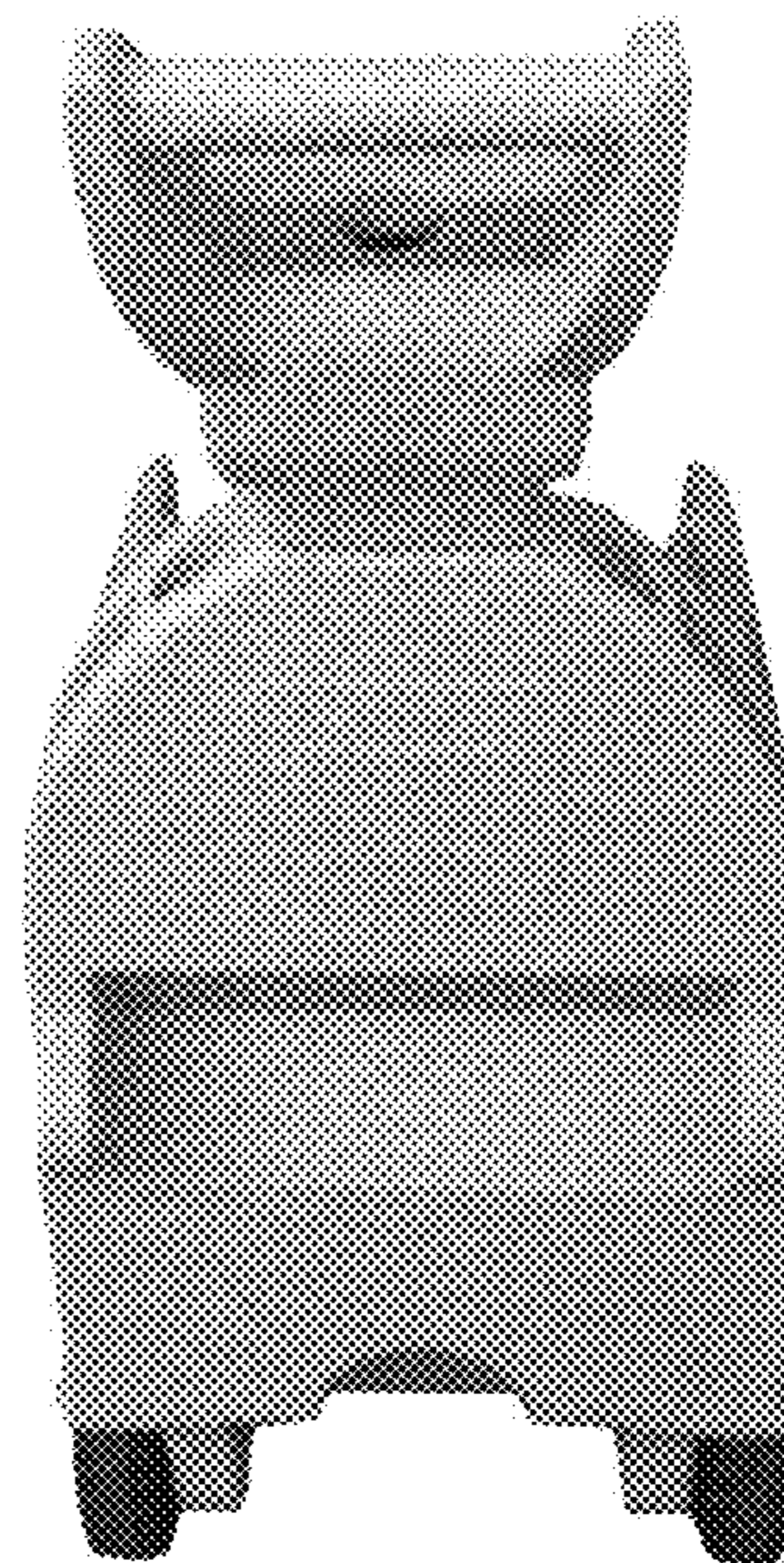

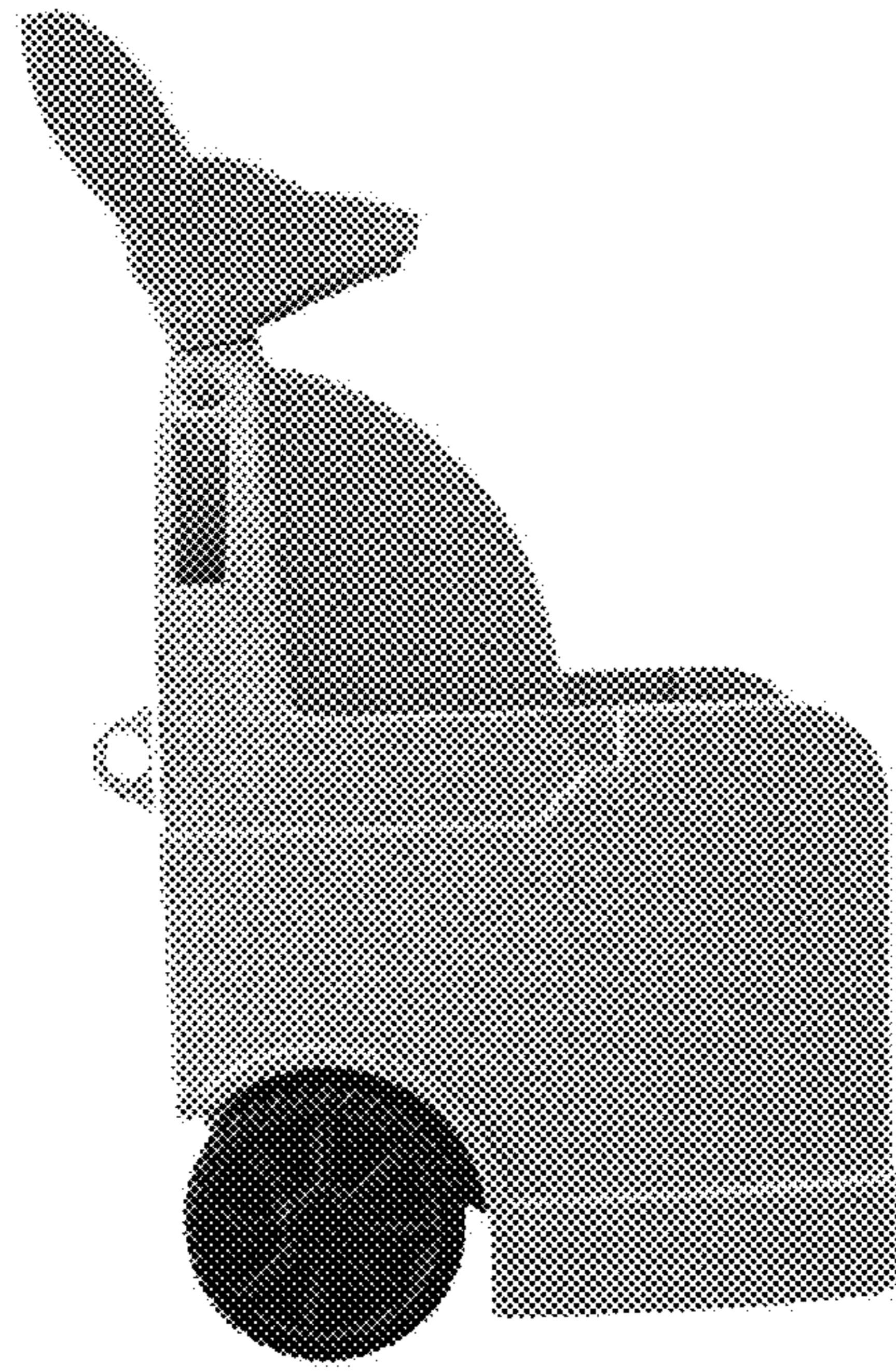

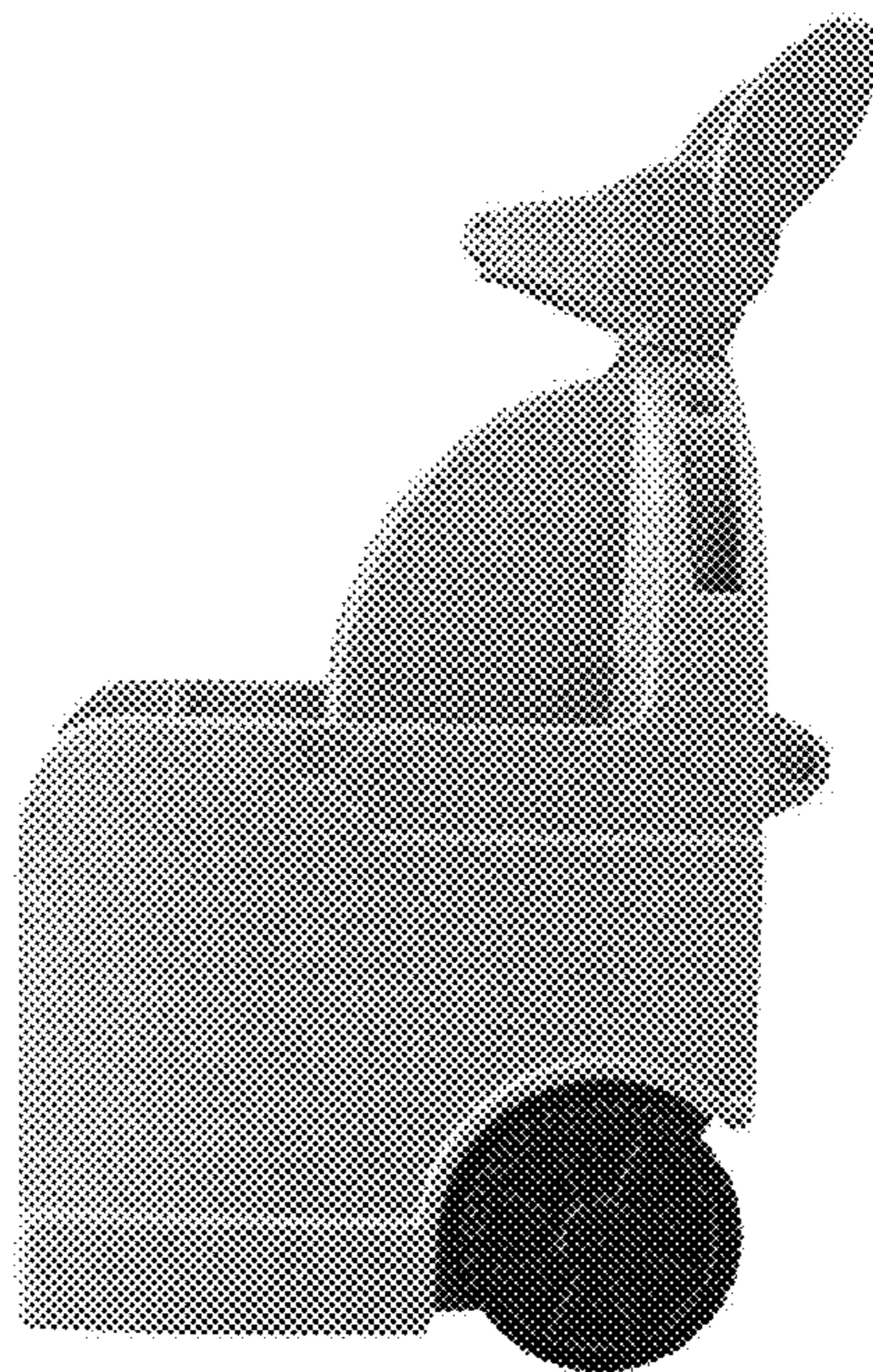

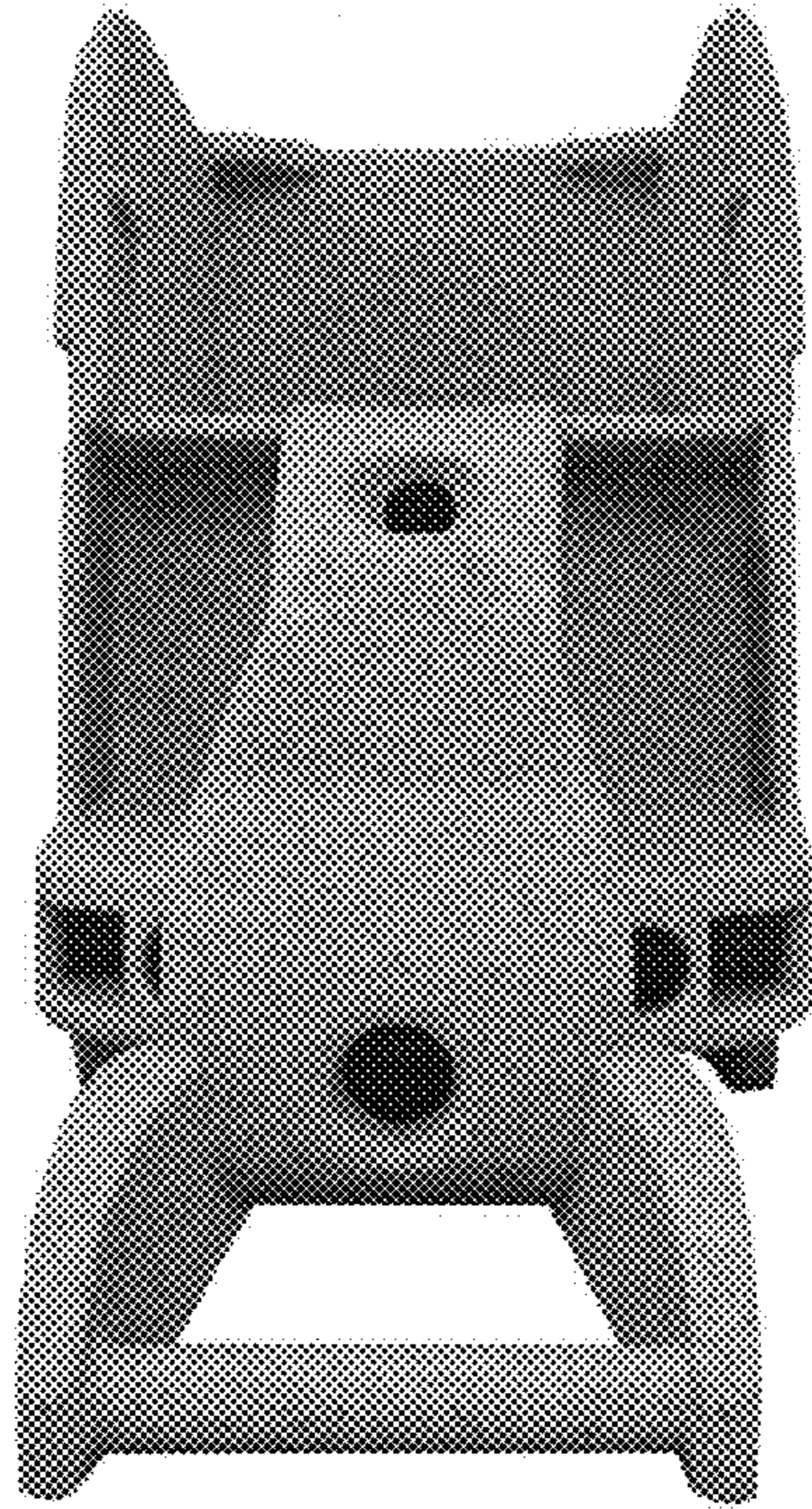

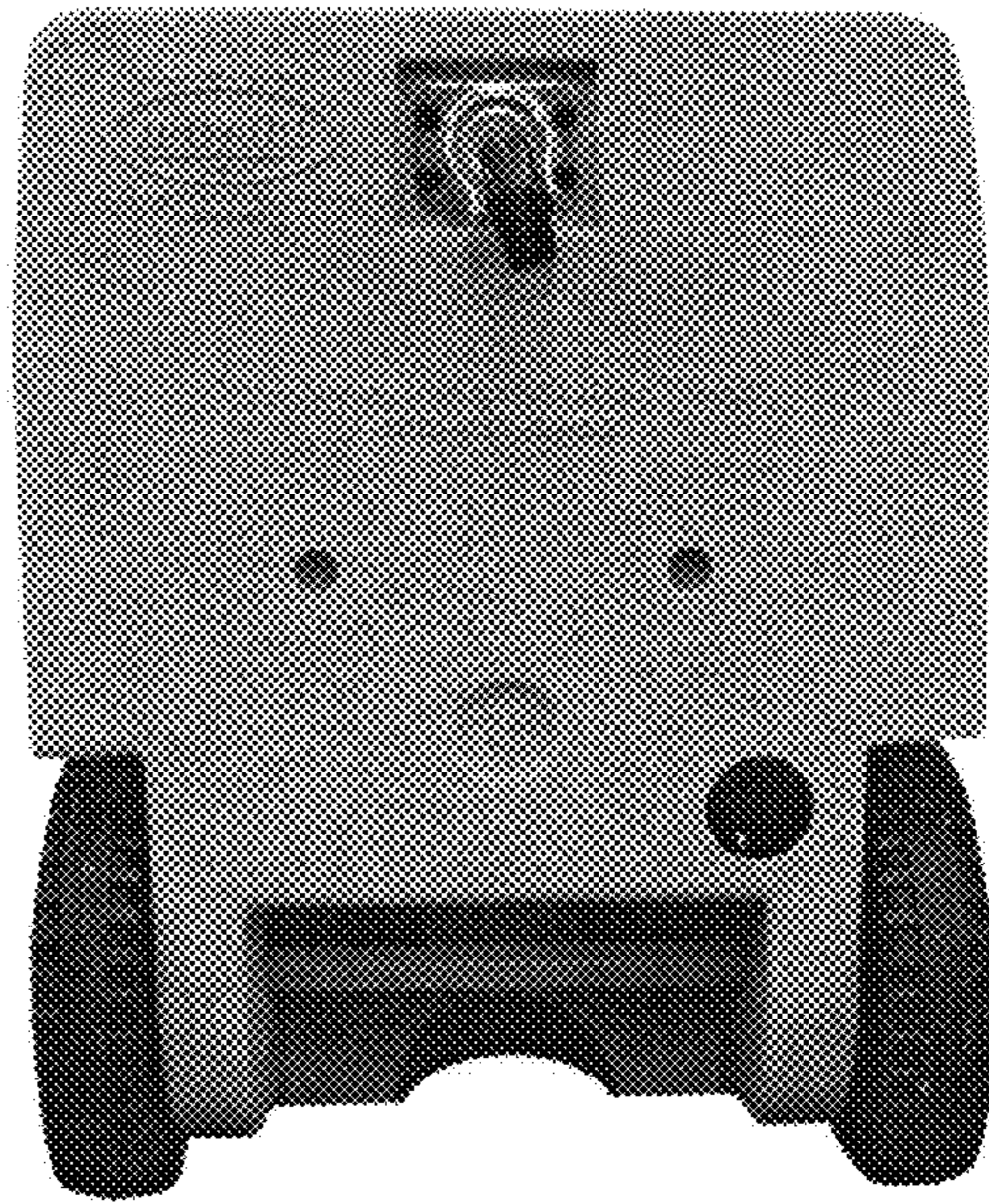
