DESCRIPTION

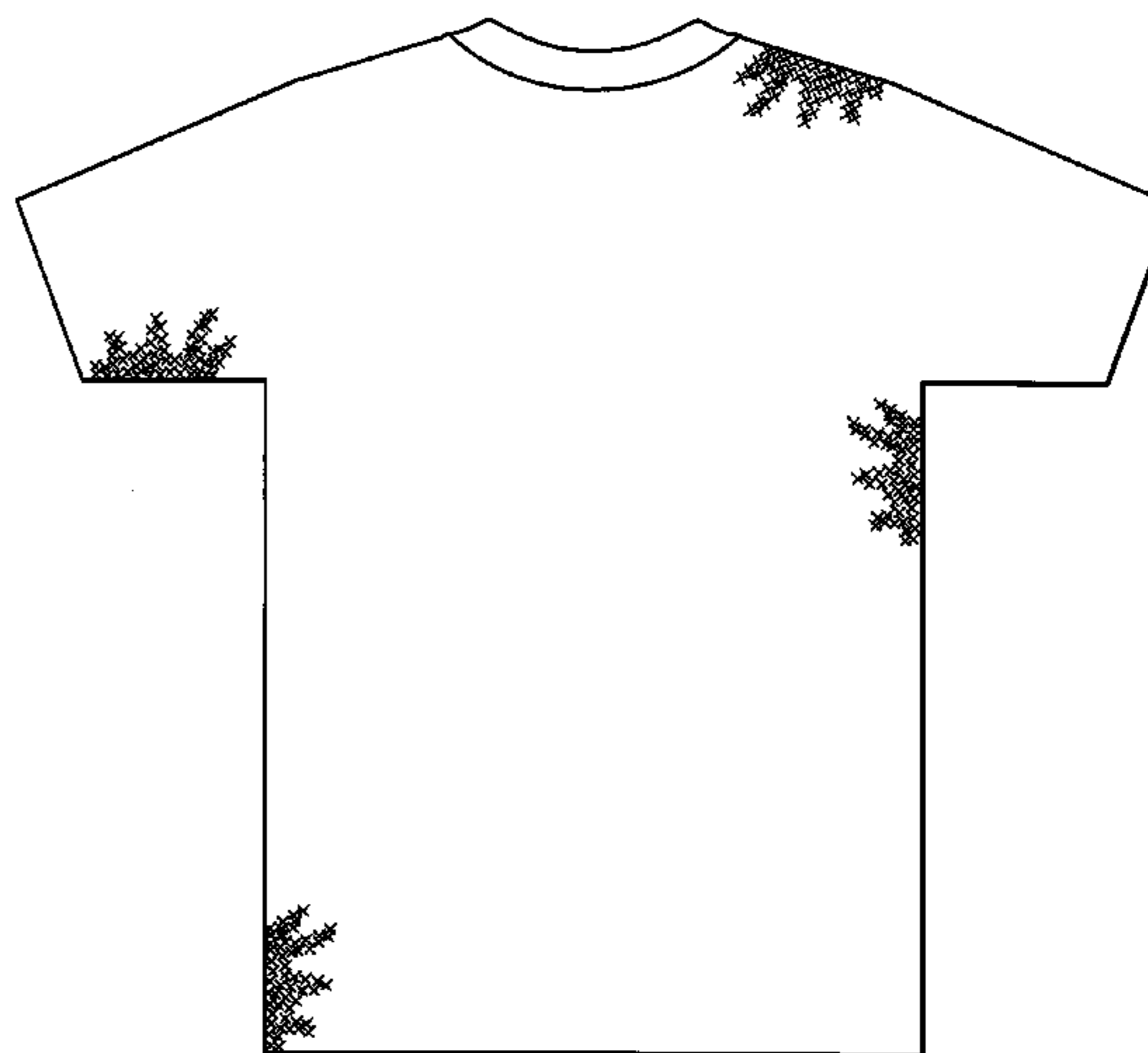
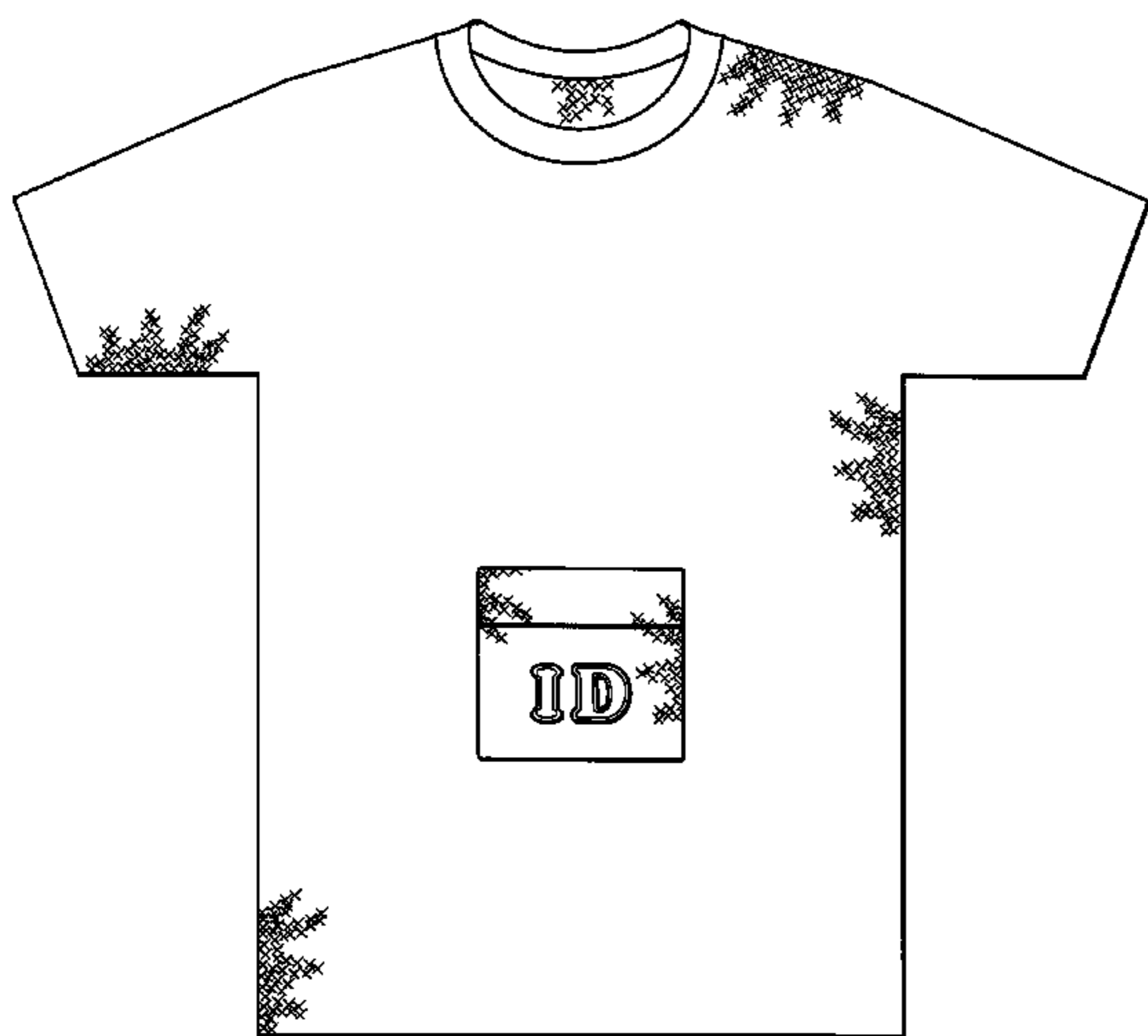

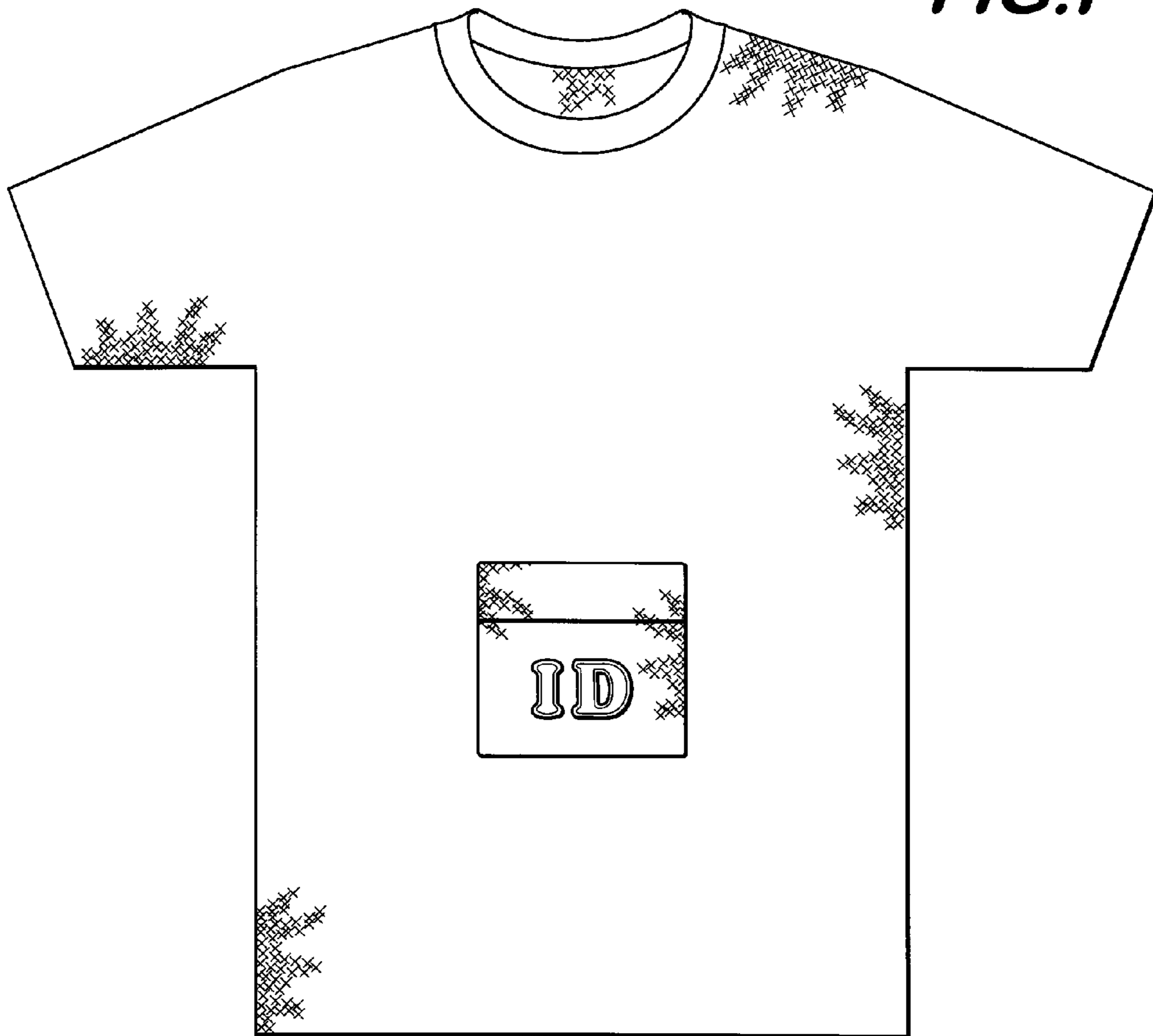

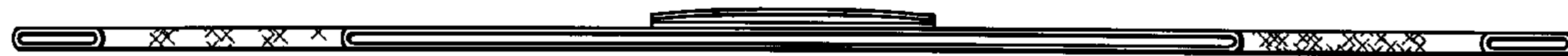

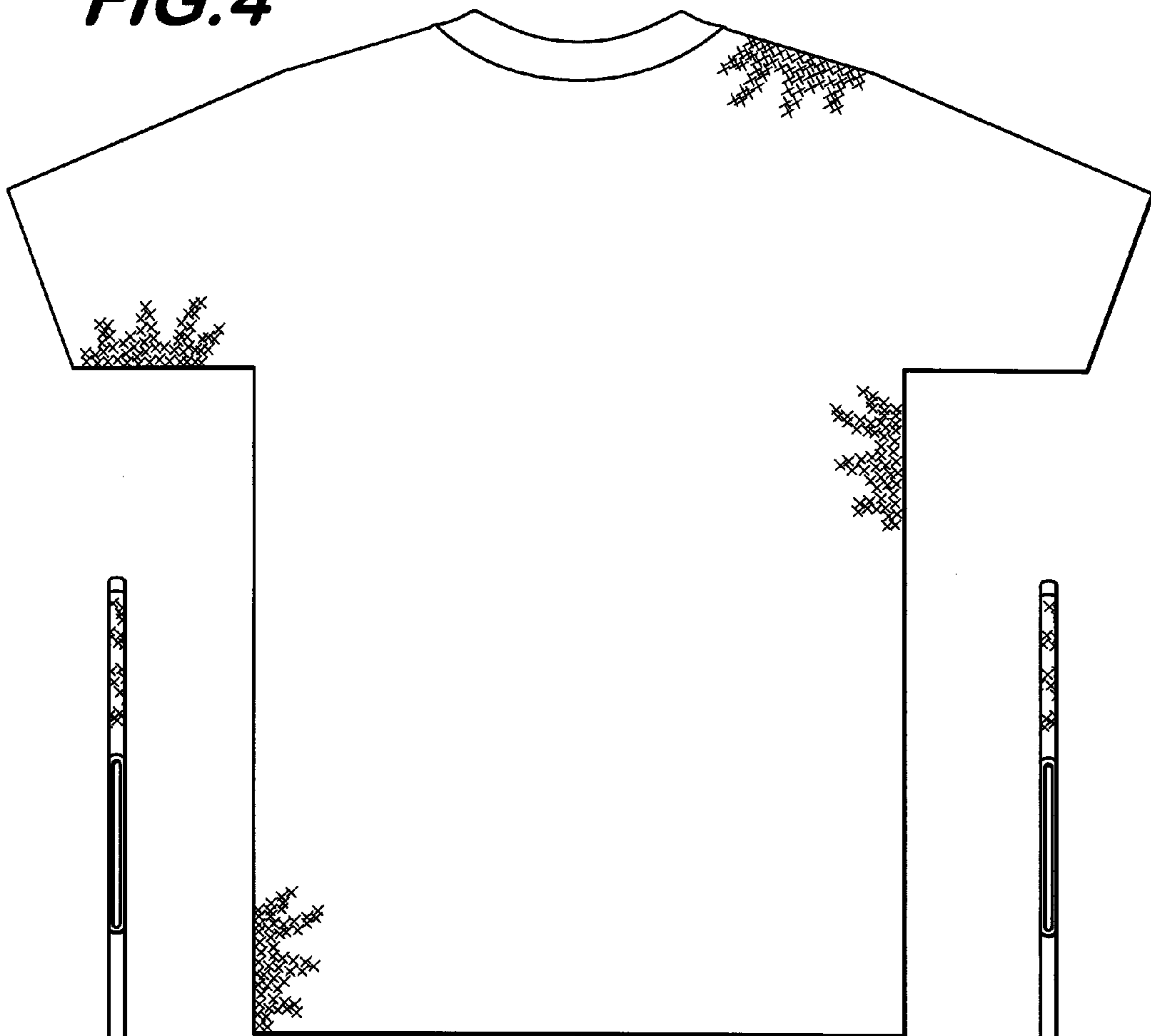
