(57) **CLAIM**

The ornamental design of a maternity garment, as shown and described.

DESCRIPTION

The article is a maternity garment with ruching on the belly of the garment to allow for stretching. The maternity garment has a flap in the groin area that may be open, to allow for dressing, or closed and secured by snaps, to keep the maternity garment neatly tucked.

FIG. 1 is a perspective view of the maternity garment showing the flap in the closed position.

FIG. 2 is a front view of the maternity garment showing the flap in the closed position.

FIG. 3 is a rear view of the maternity garment showing the flap in the closed position.

FIG. 4 is a side view of the right side of the maternity garment showing the flap in the closed position.

FIG. 5 is a bottom view of the maternity garment showing the flap in the closed position.

FIG. 6 is a top view of the maternity garment showing the flap in the closed position.

FIG. 7 is a perspective view of the maternity garment showing the flap in the closed position.

FIG. 8 is a front view of the maternity garment showing the flap in the closed position.

FIG. 9 is a rear view of the maternity garment showing the flap in the closed position.

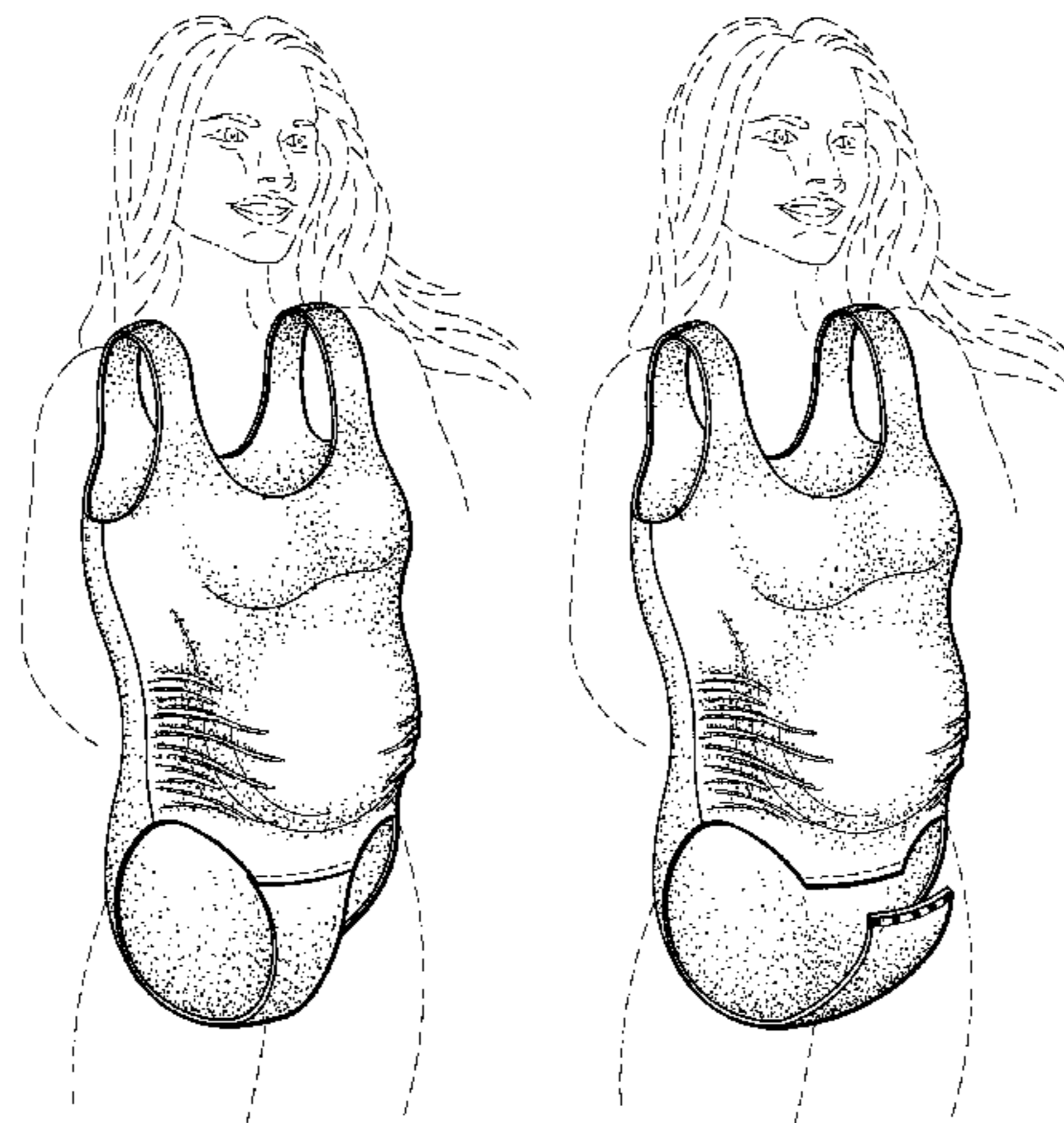
FIG. 10 is a side view of the right side of the maternity garment showing the flap in the closed position.

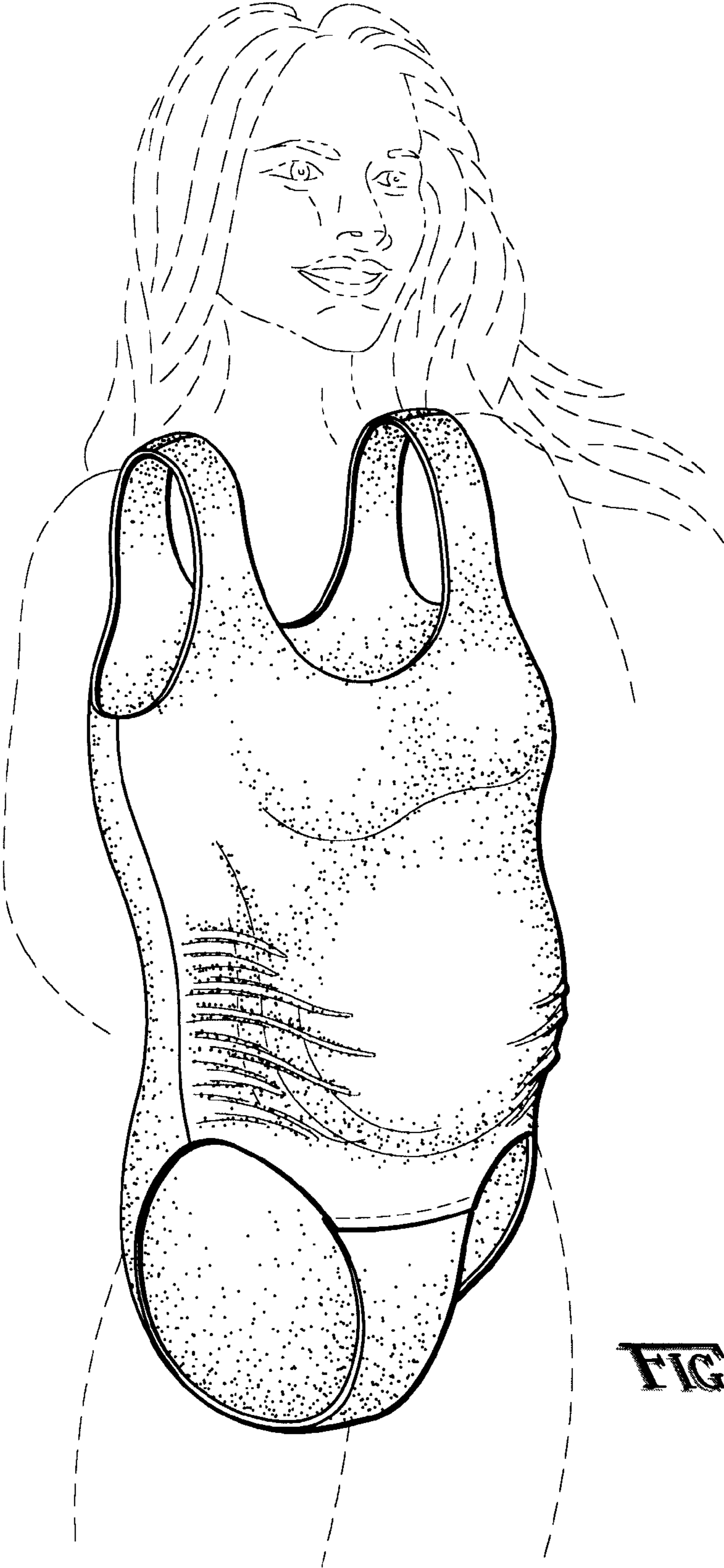

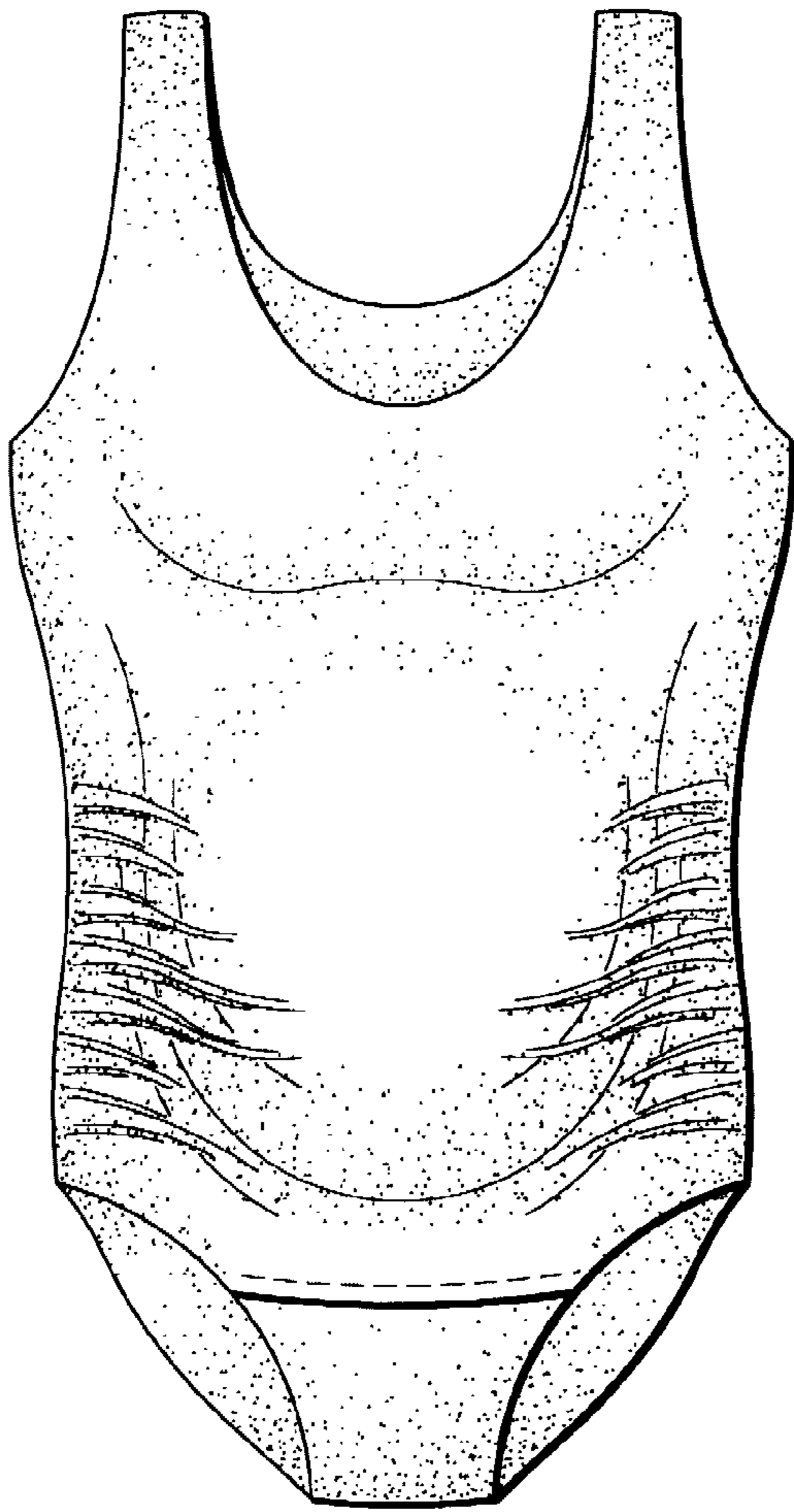

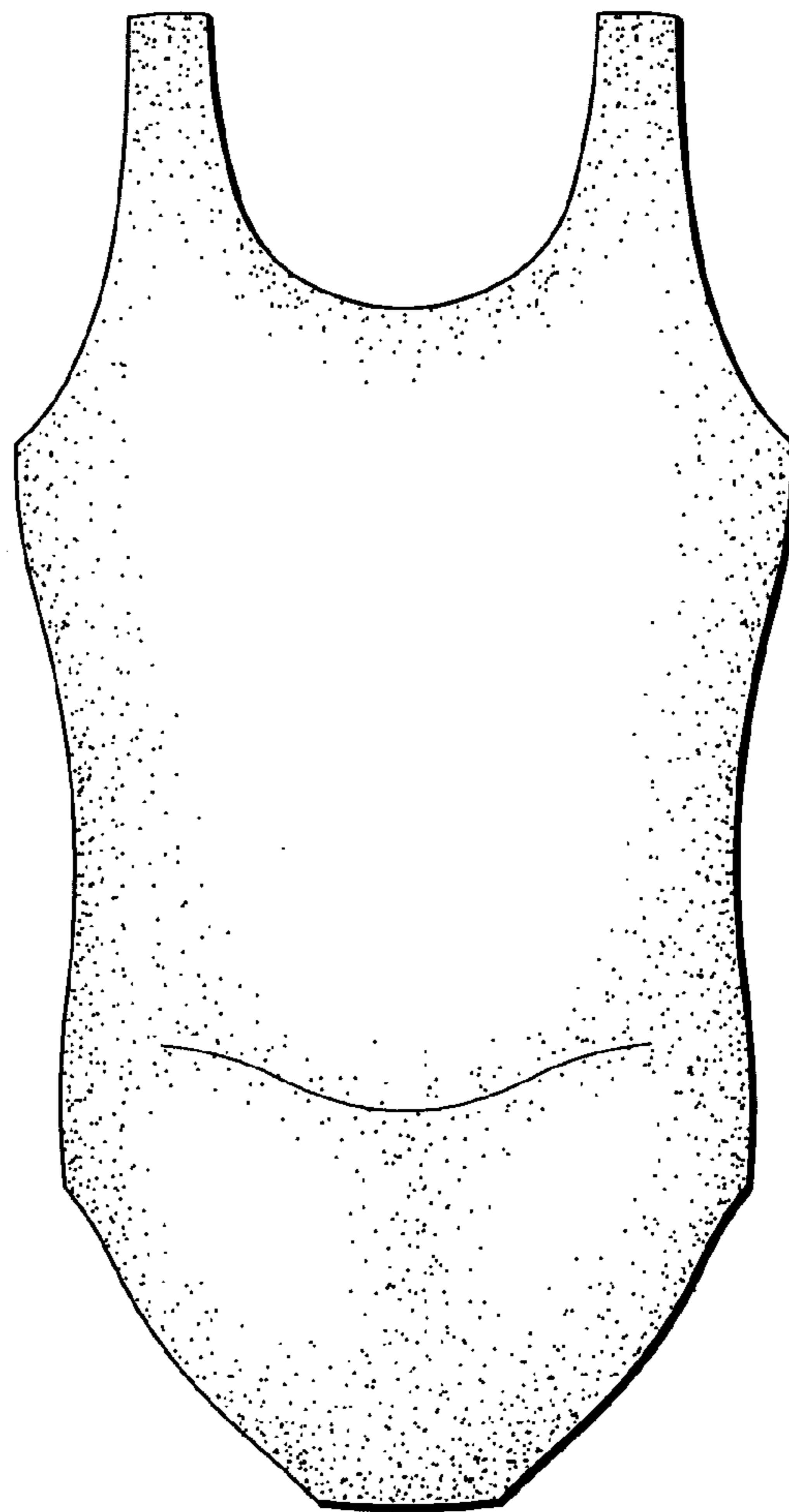

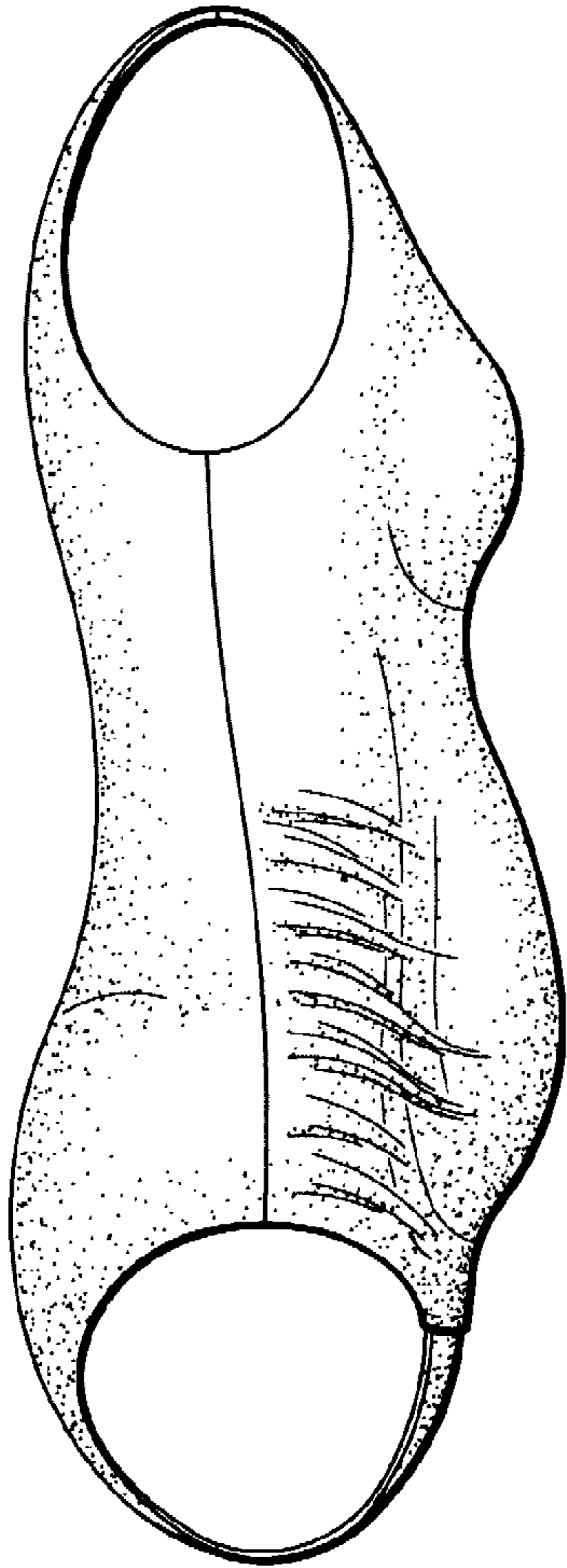

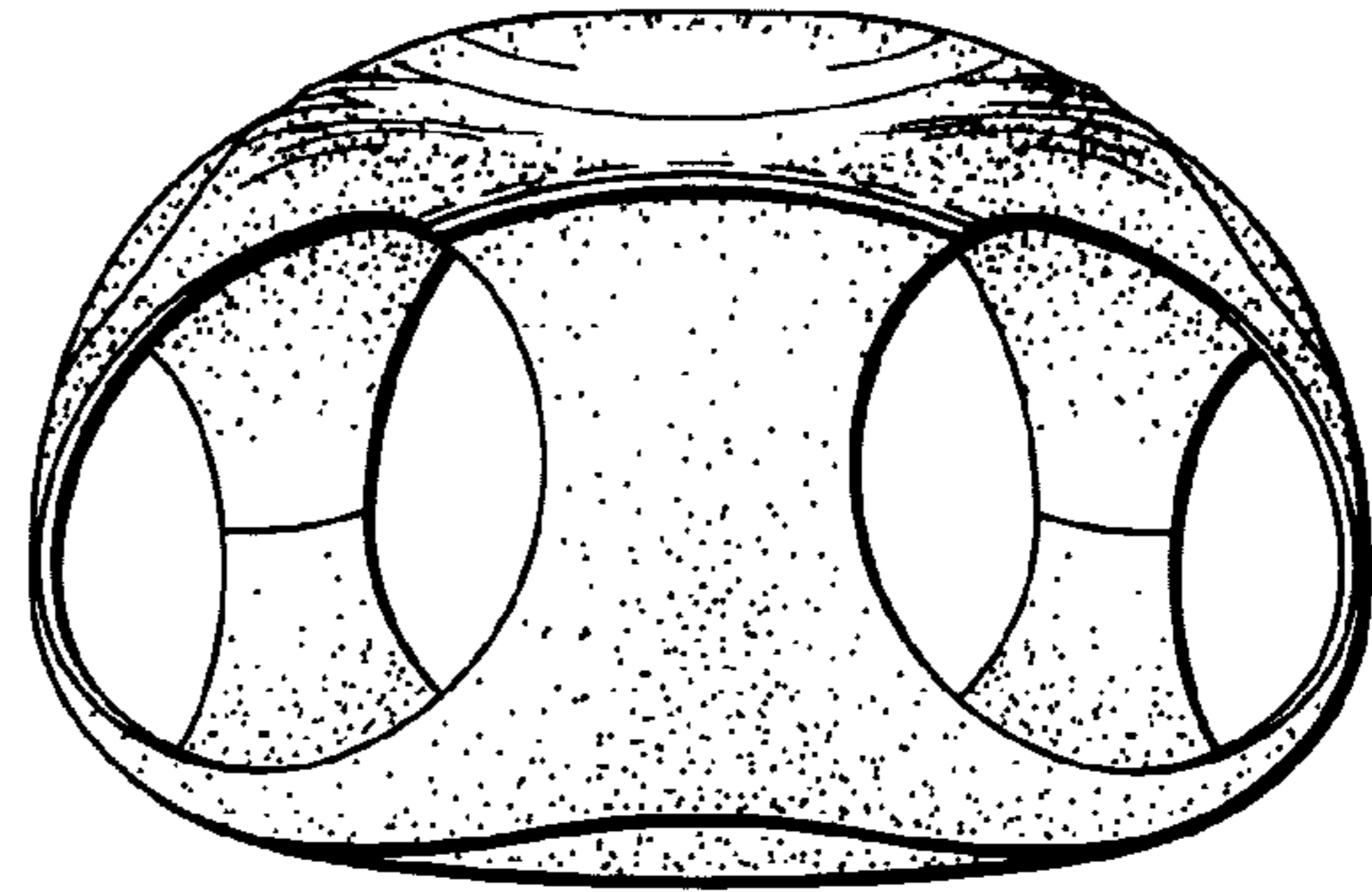

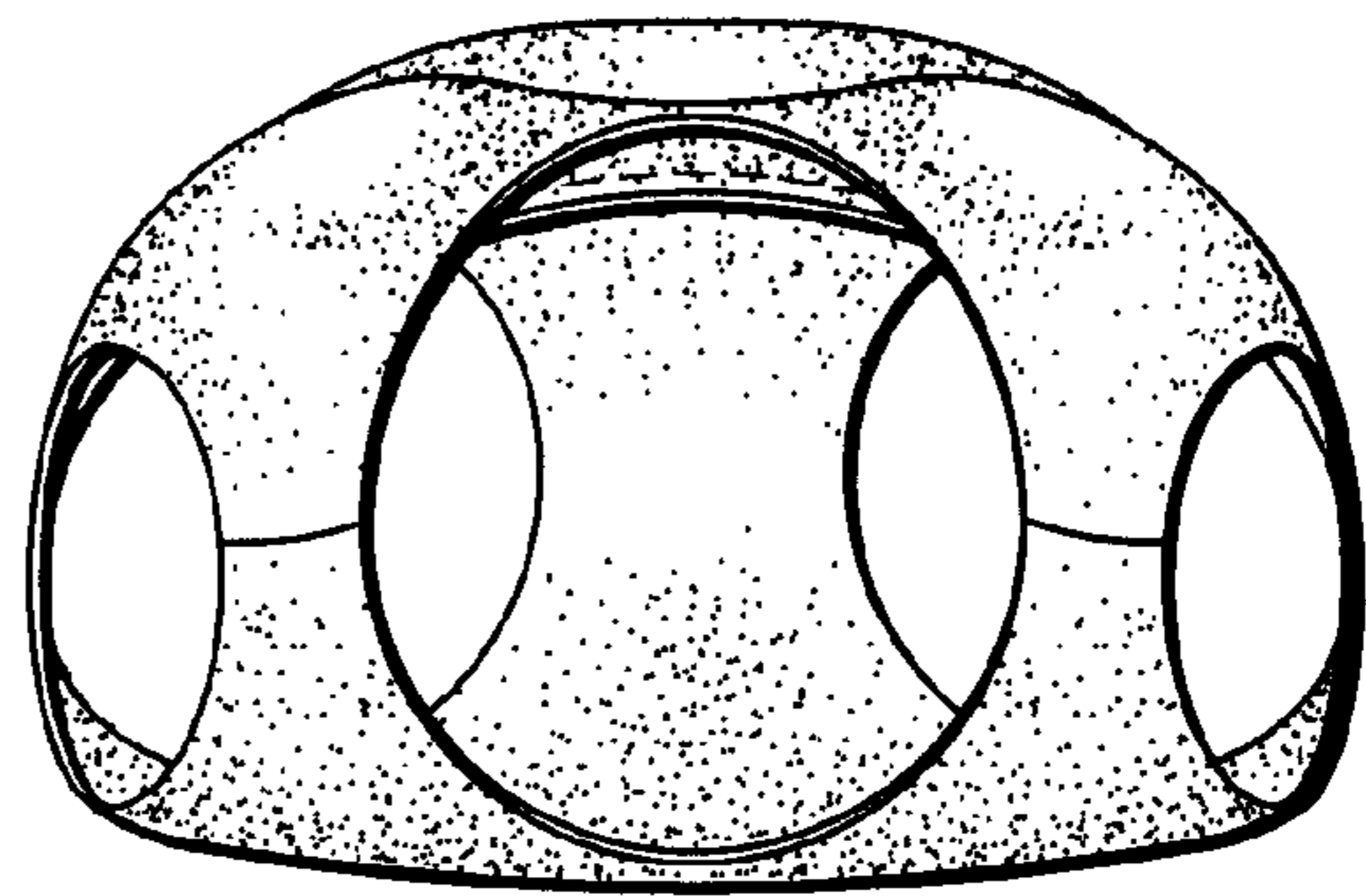

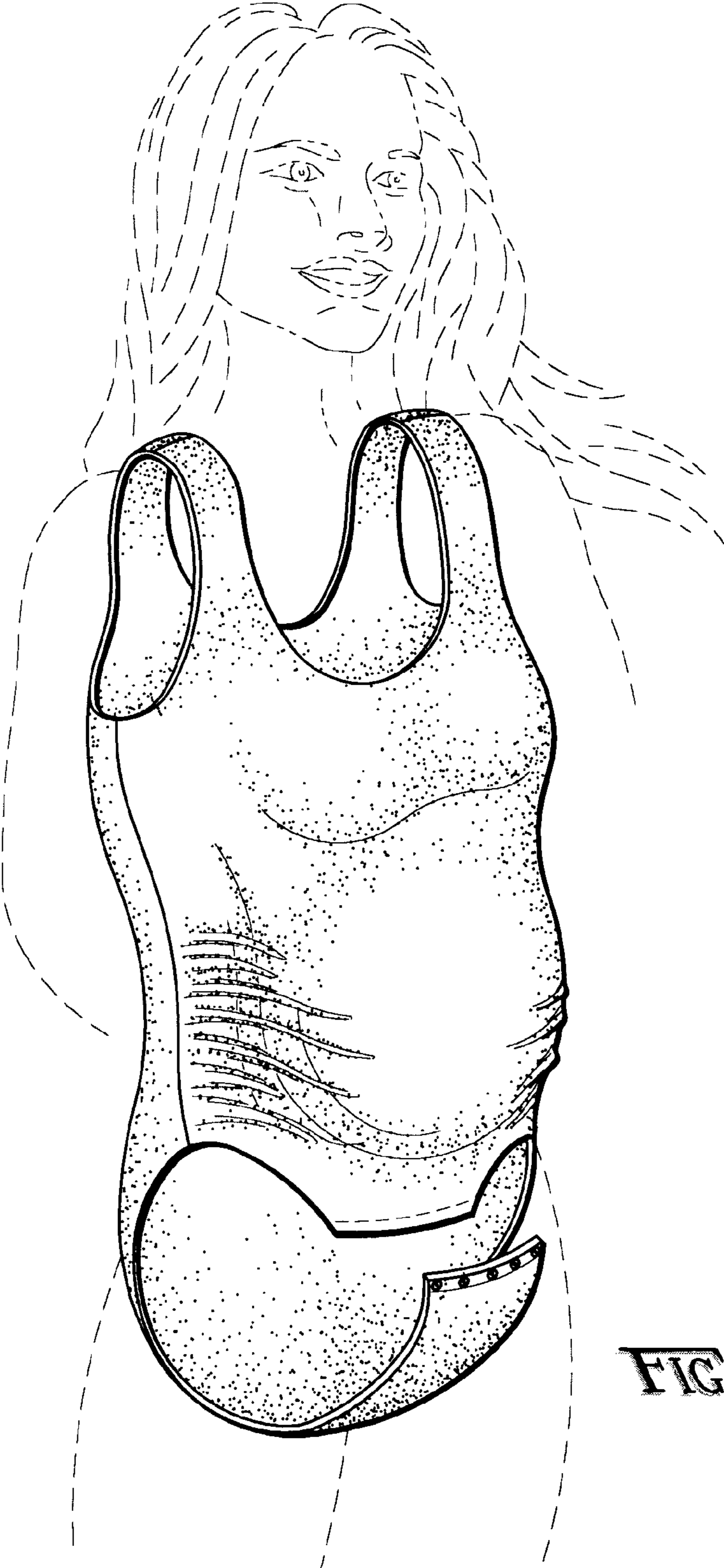

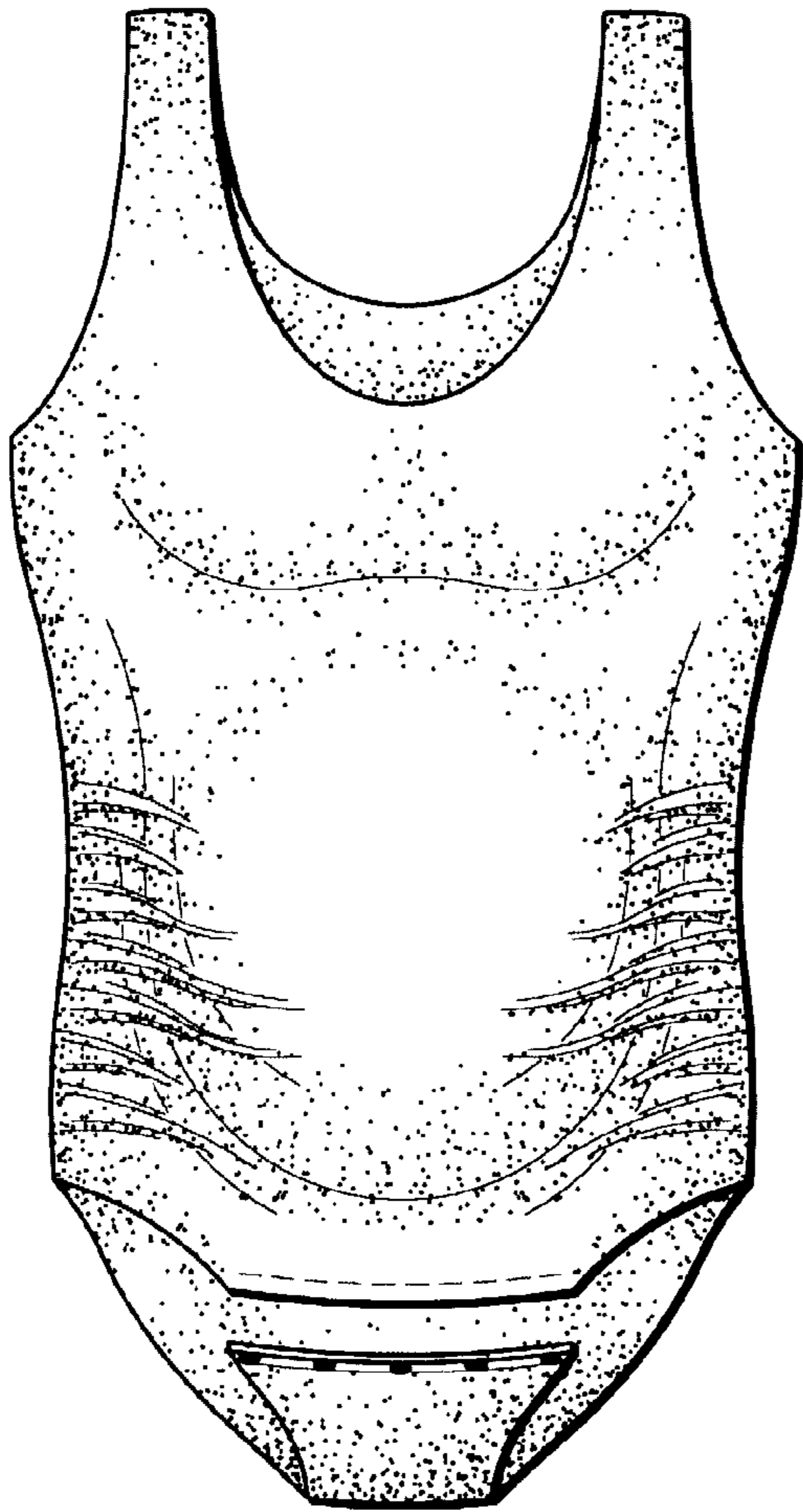

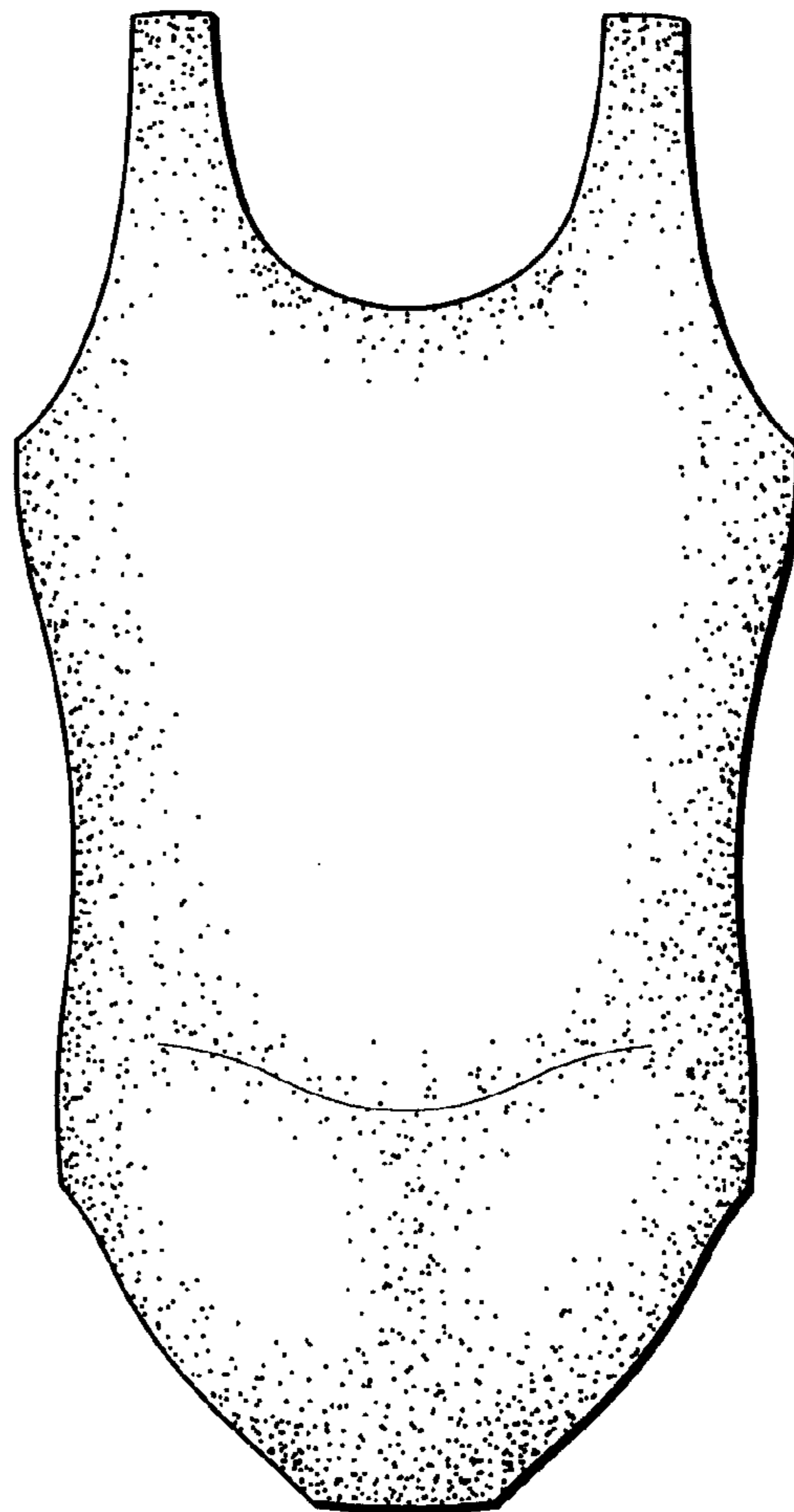

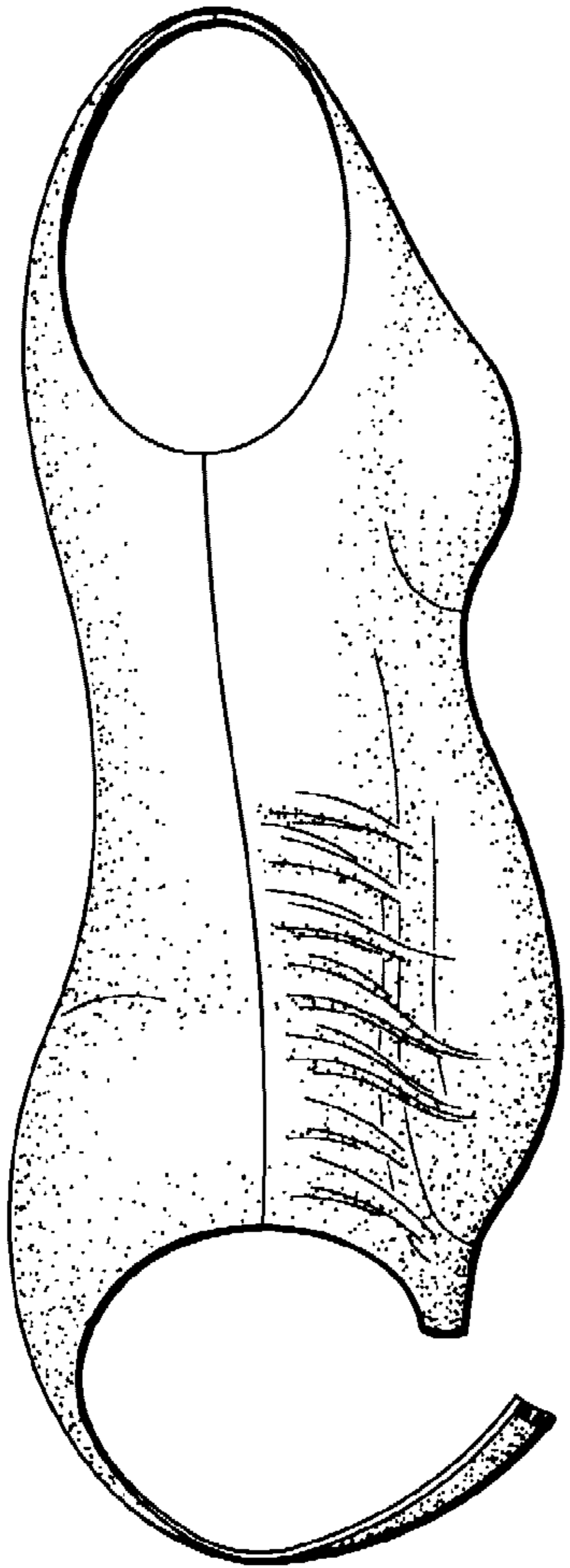

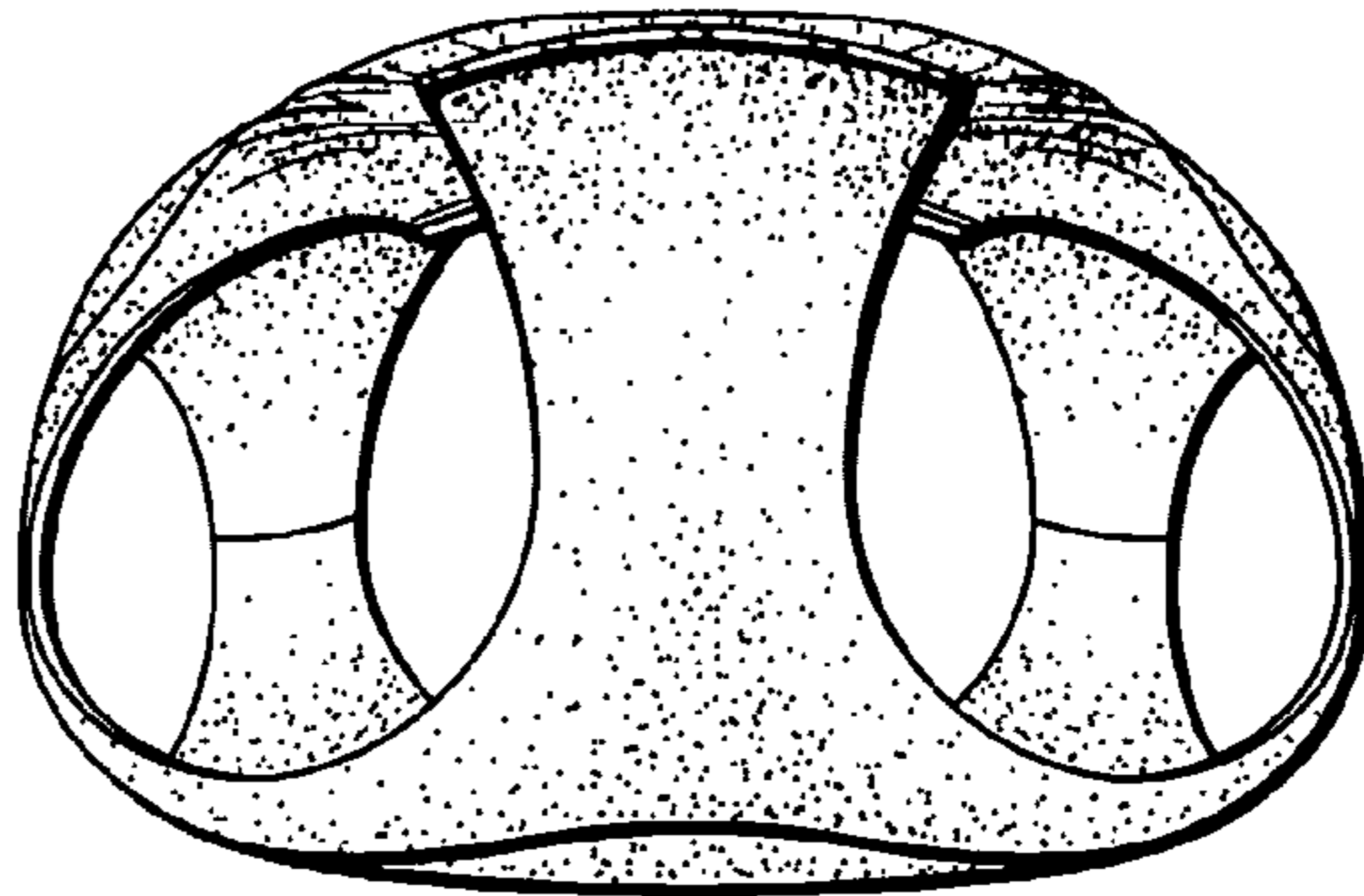

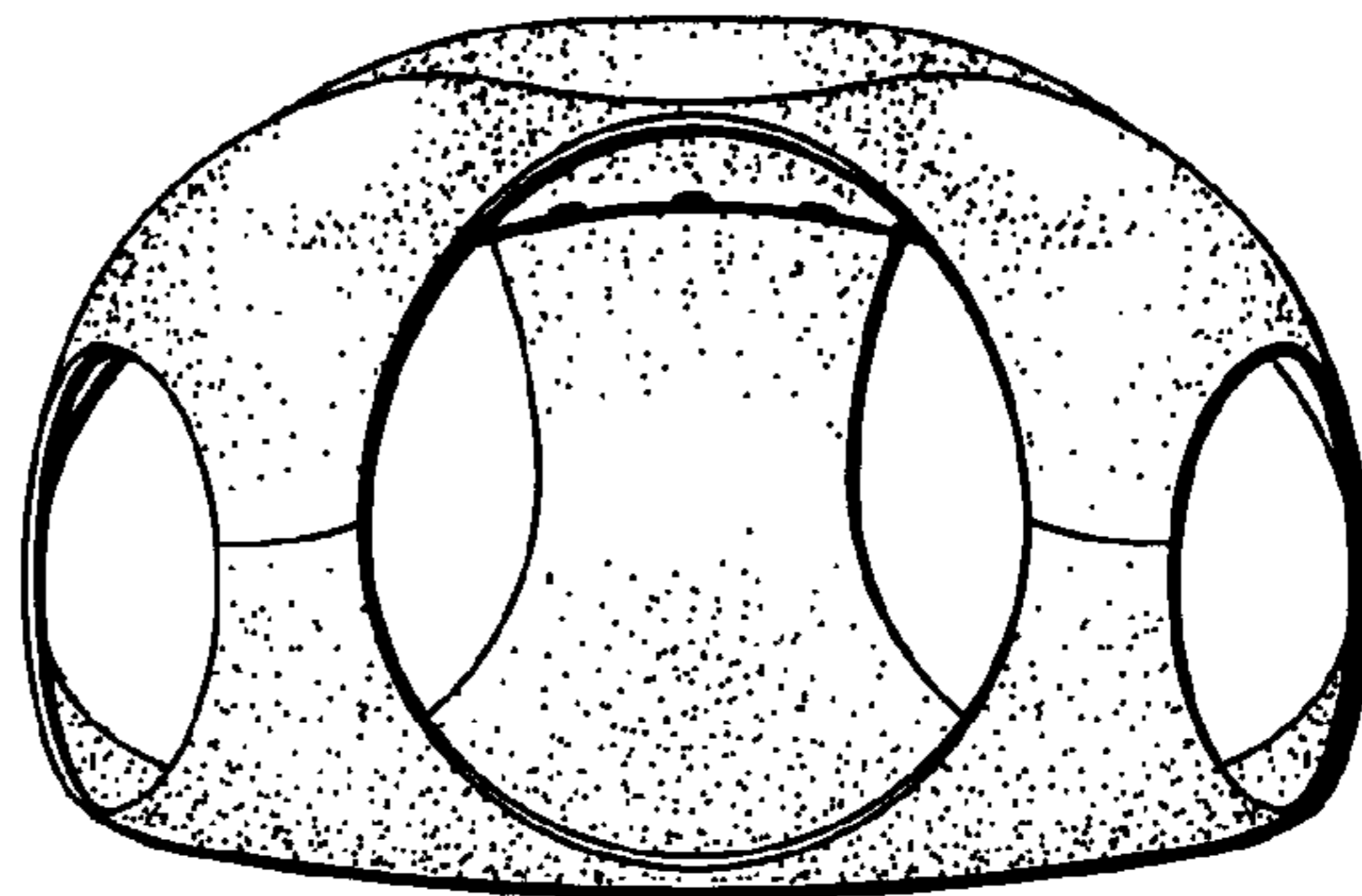
