(57) **CLAIM**

The ornamental design for a pocket square holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the pocket square holder showing my new design, a handkerchief being supported thereon and shown in phantom for illustrative purposes only and forming no part of the claim design;

FIG. 2 is a rear view thereof;

FIG. 3 is an elevational view of a one-side thereof;

FIG. 4 is an elevational view of a side thereof opposite the side shown in FIG. 3;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front view of another embodiment of the pocket square holder showing my new design;

FIG. 8 is a rear view thereof;

FIG. 9 is an elevational view of one side thereof;

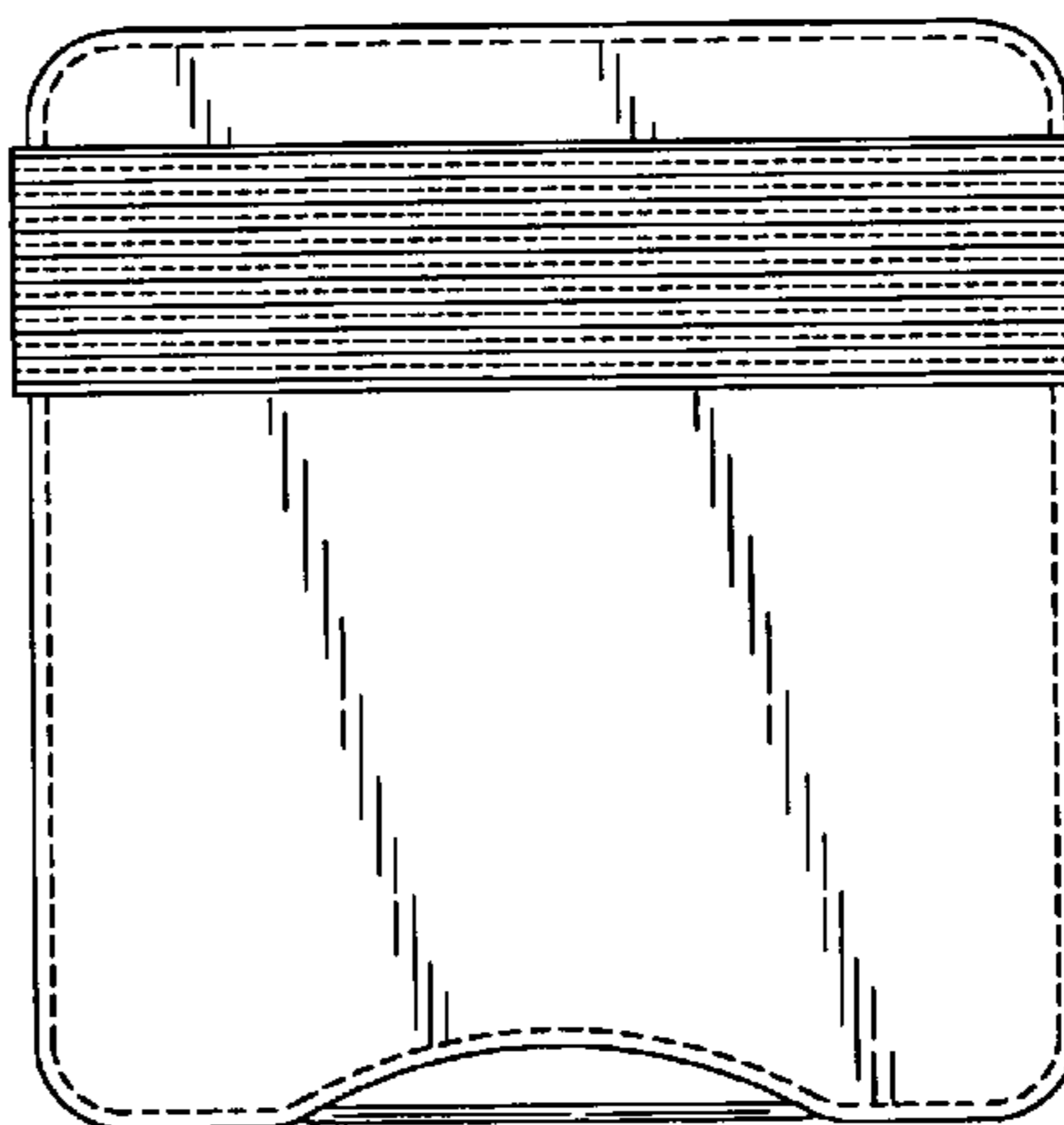
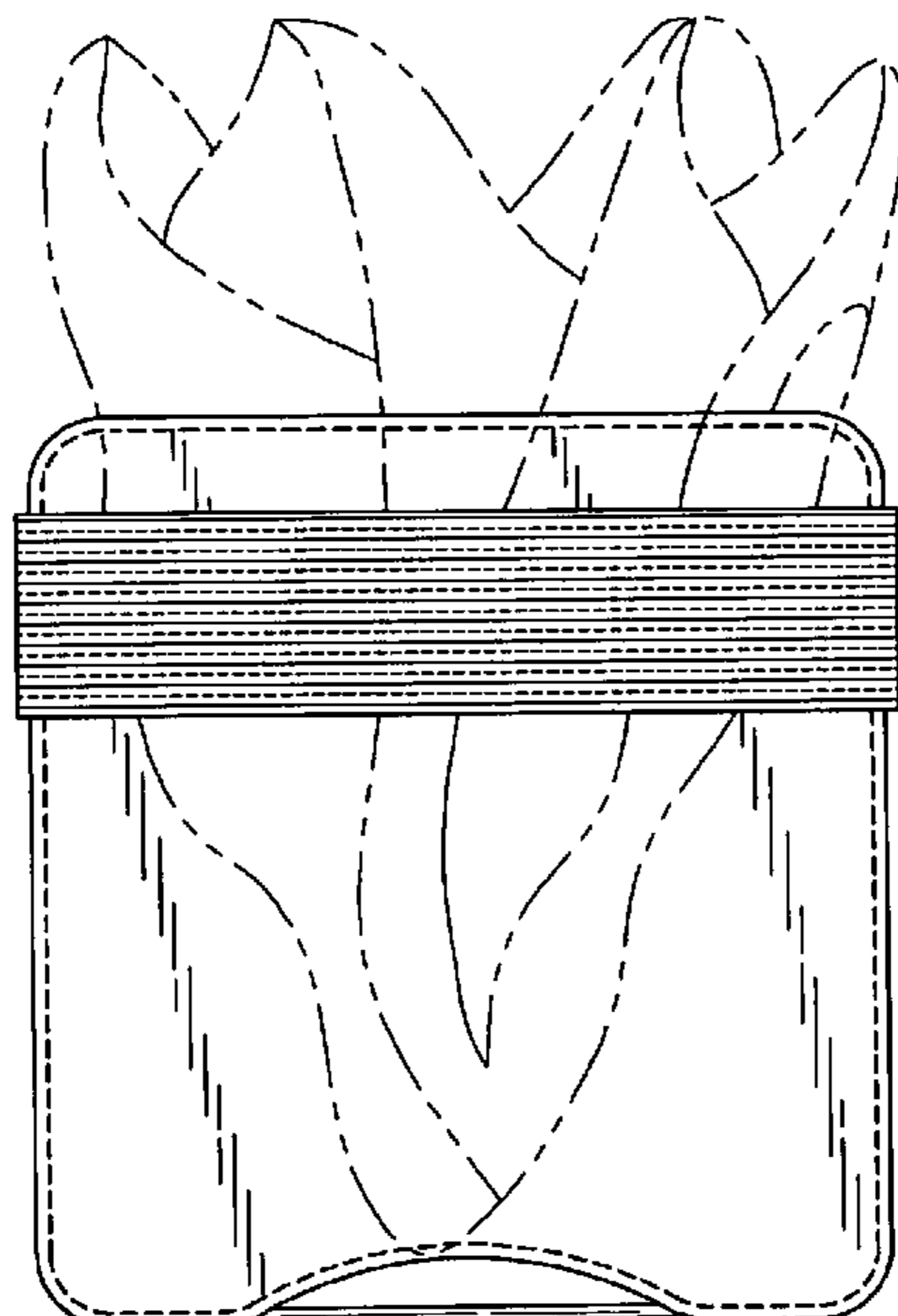
FIG. 10 is an elevational view of the side opposite the side shown in FIG. 9;

FIG. 11 is a bottom plan view thereof; and,

FIG. 12 is a top plan view thereof.

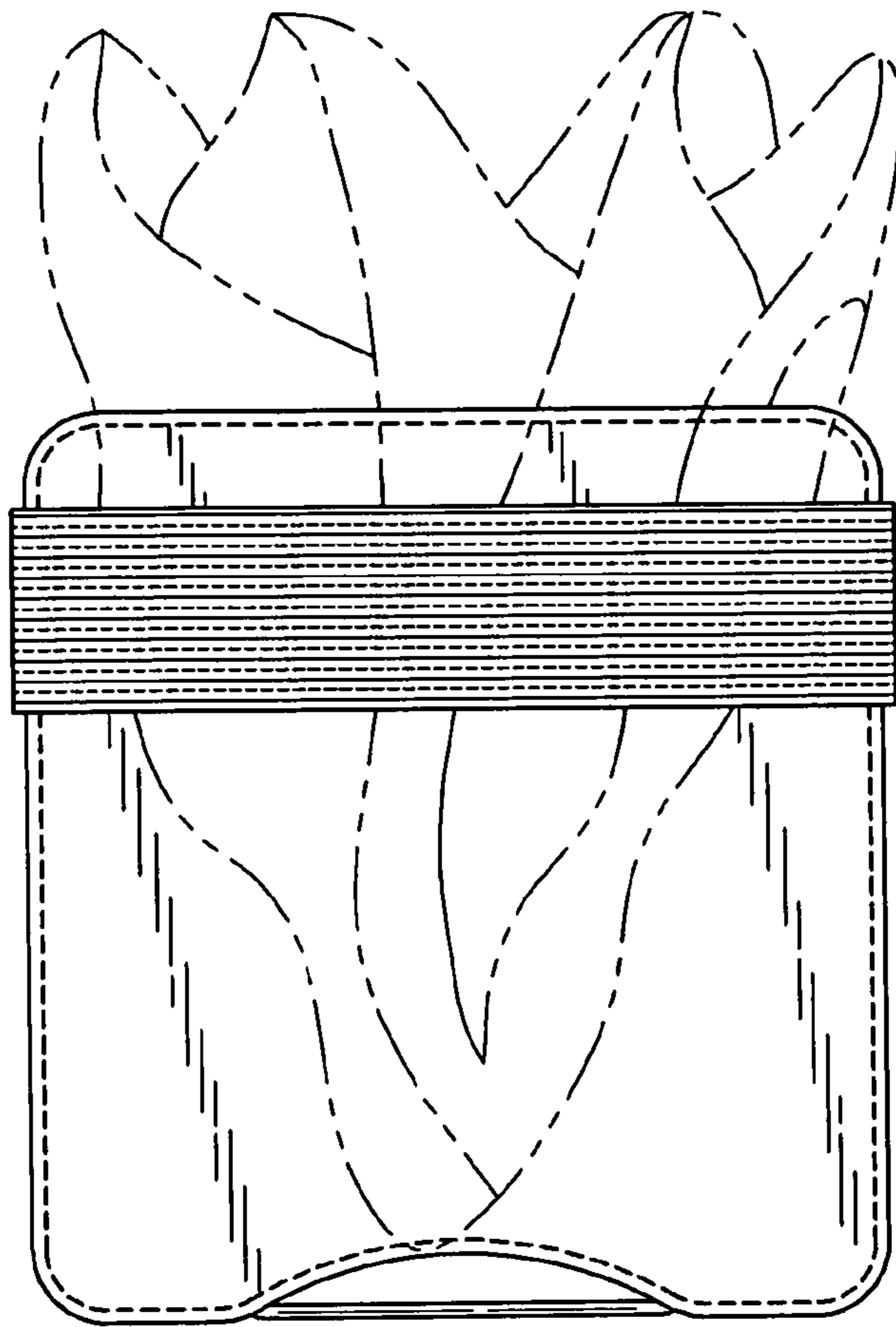

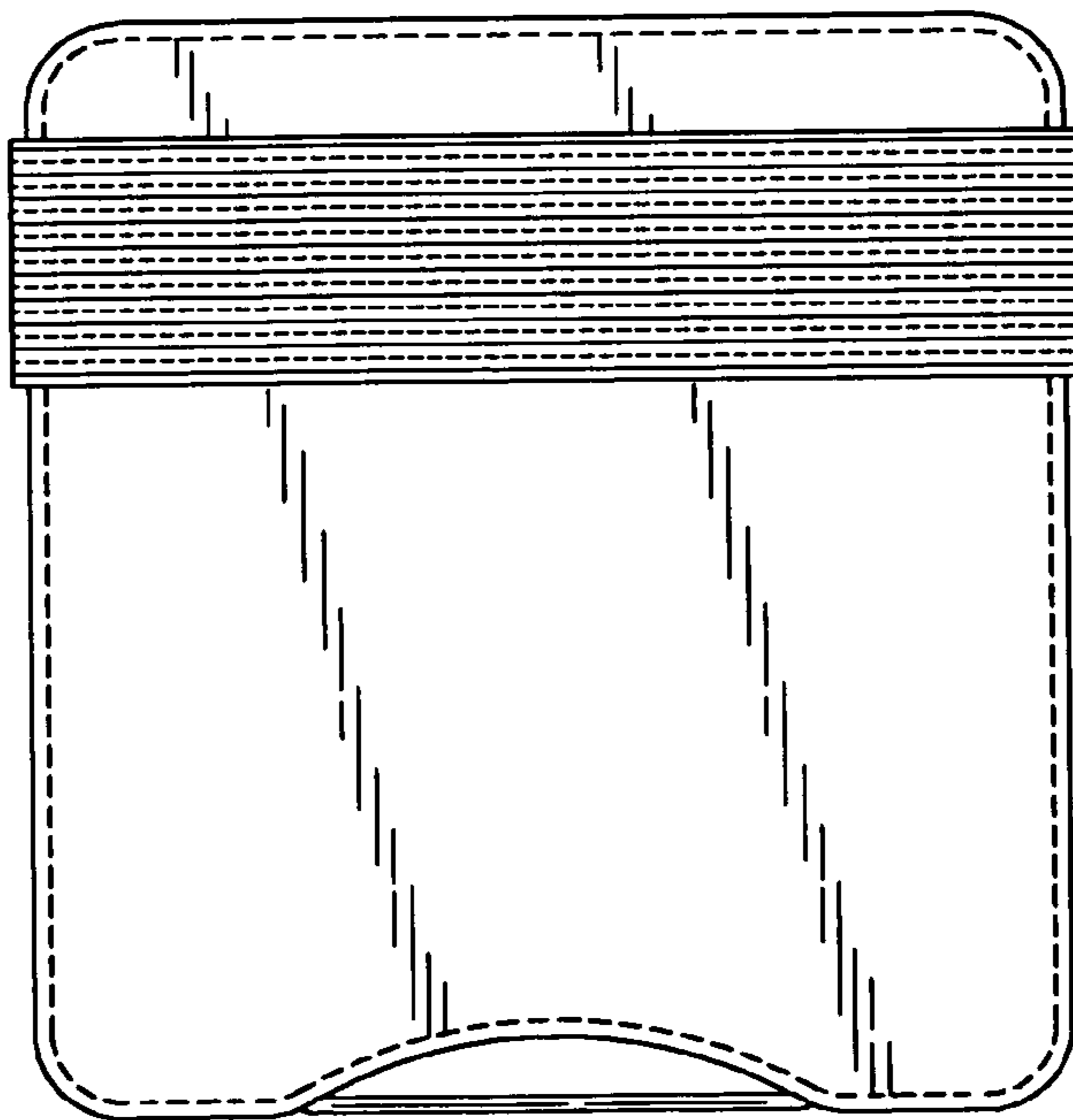
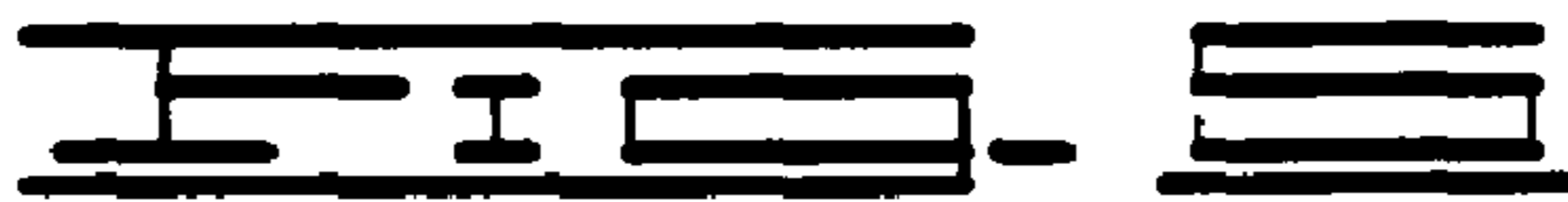
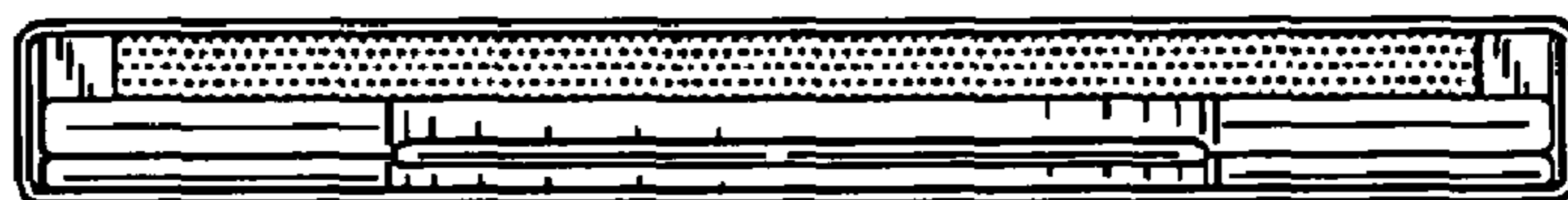
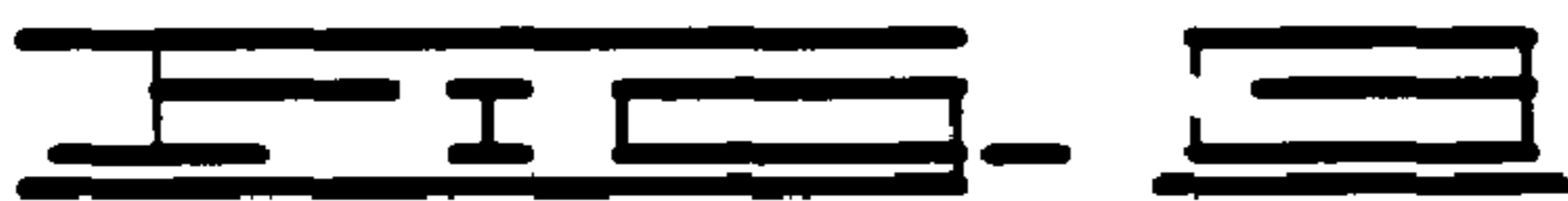
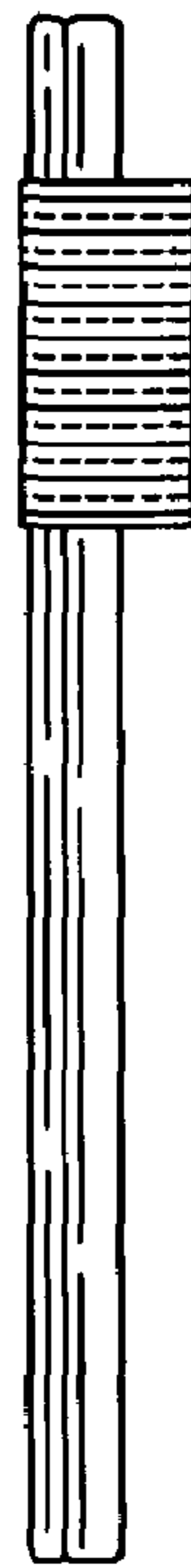

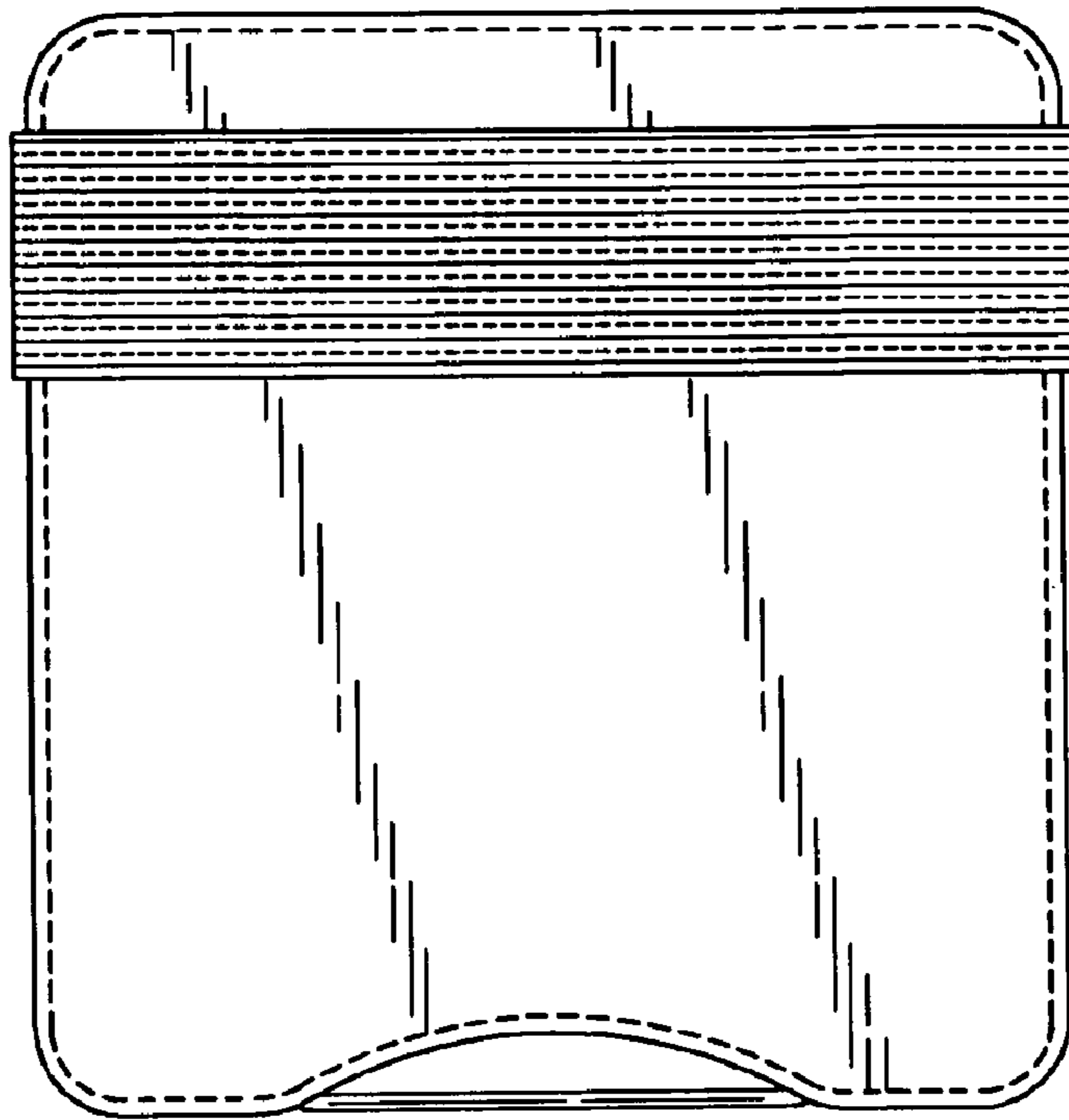

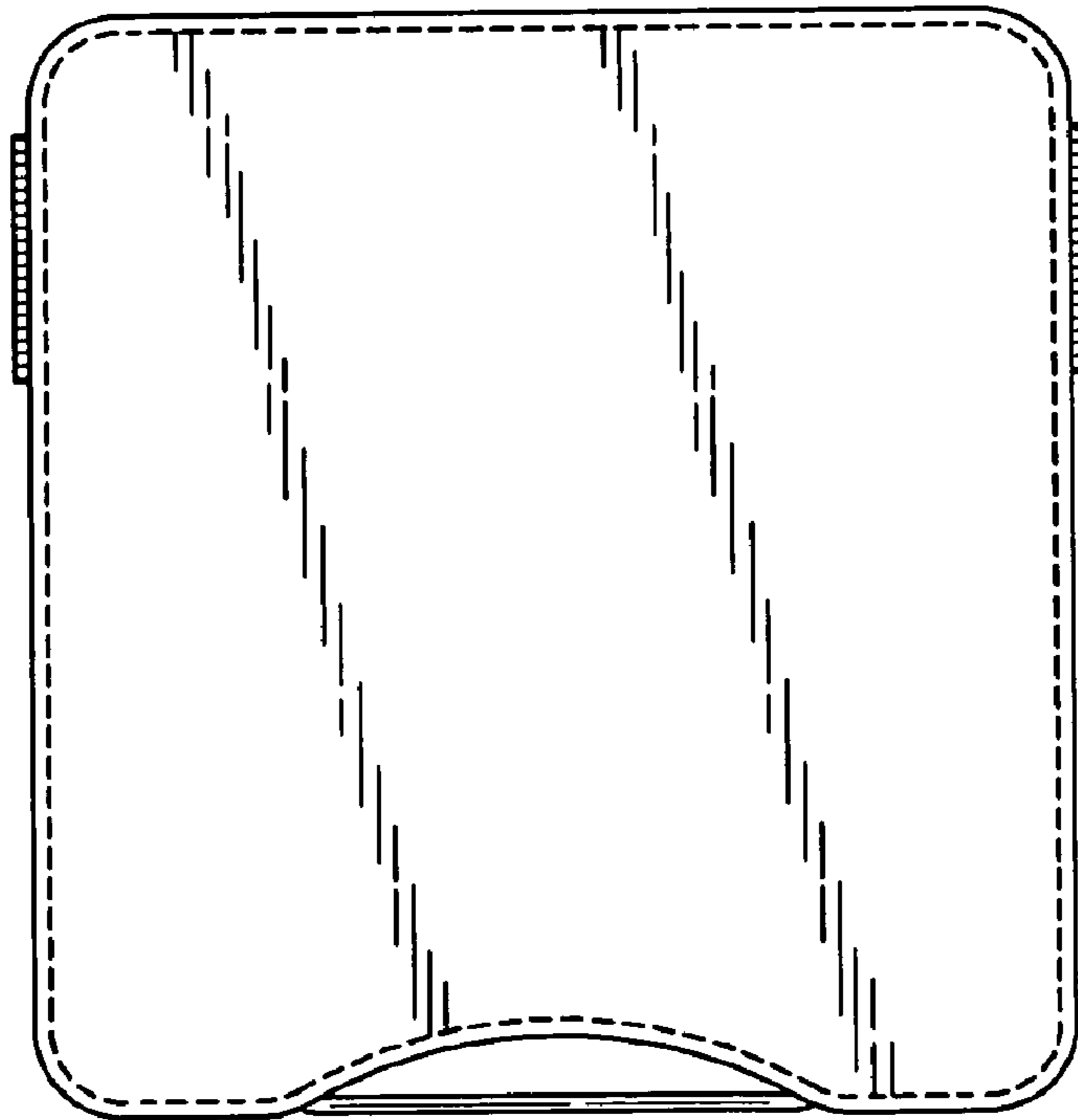
