The ornamental design for a golf bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a golf bag showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a top view thereof; and,

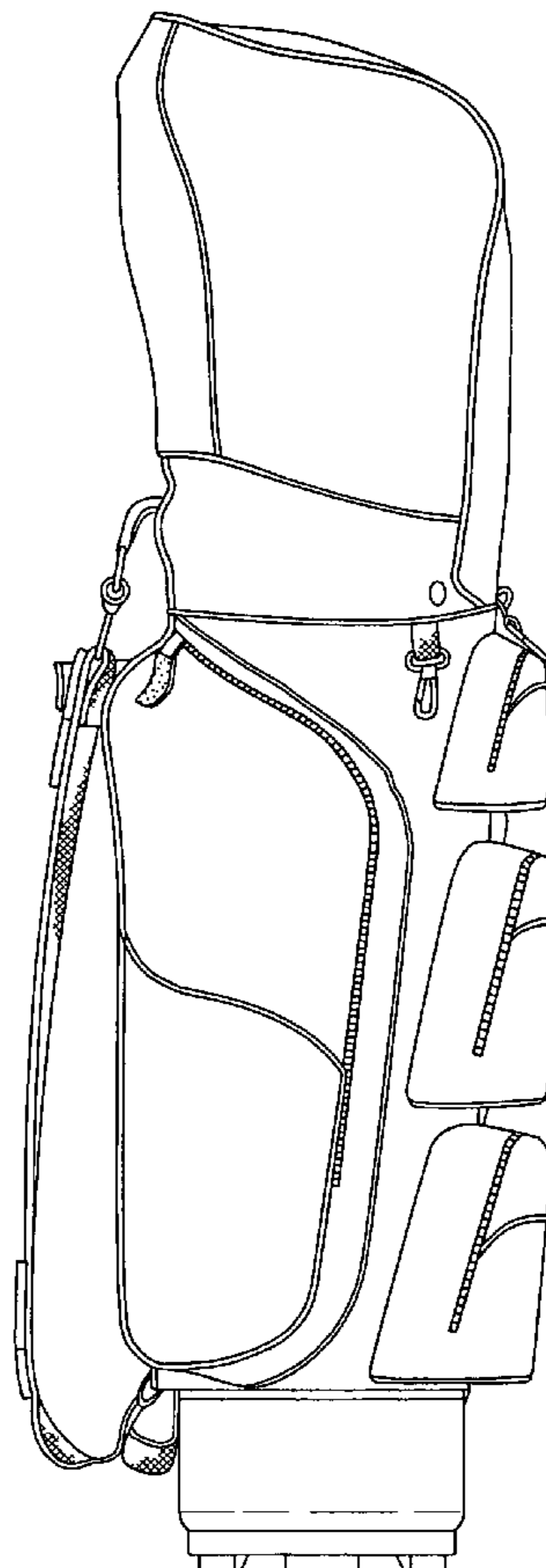

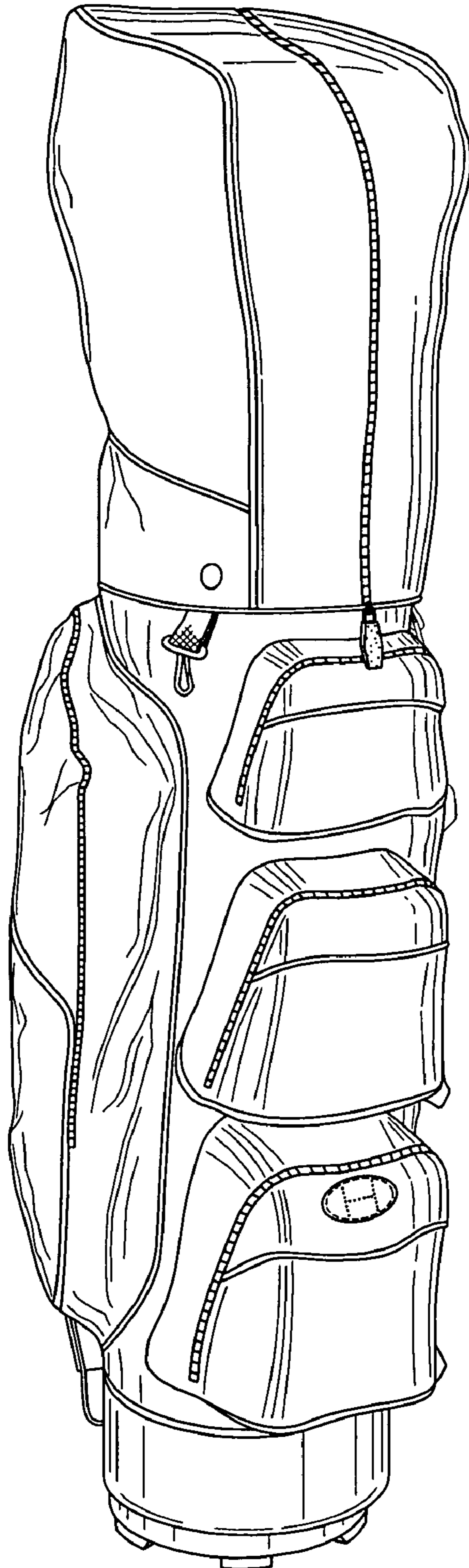

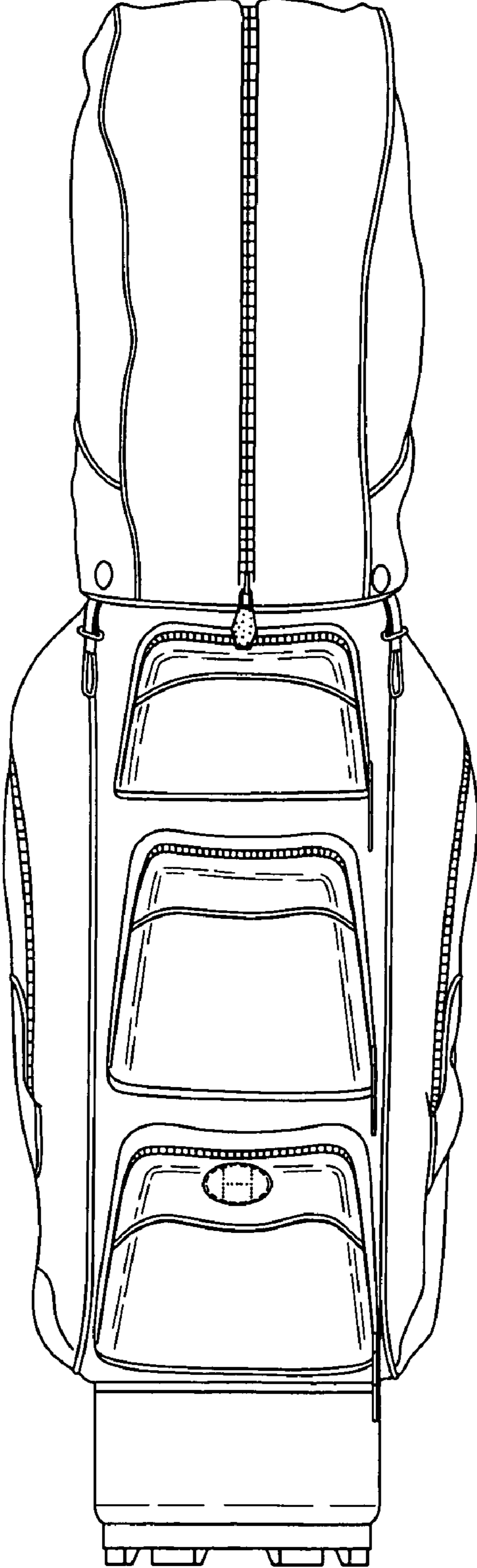

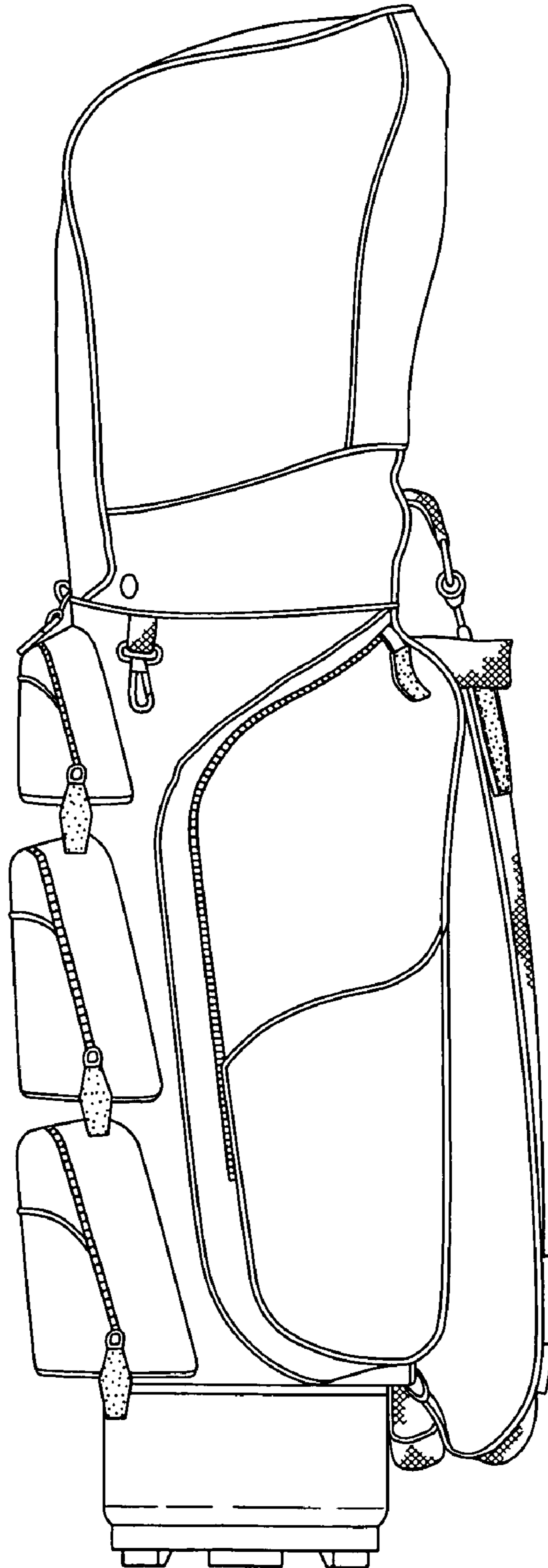

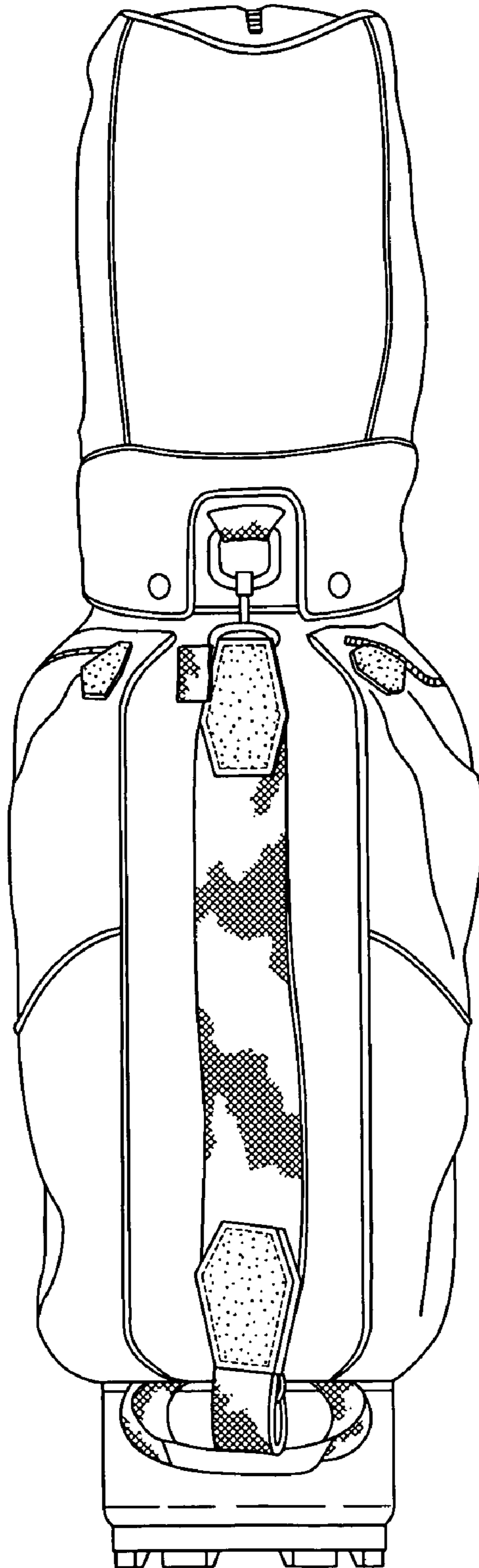

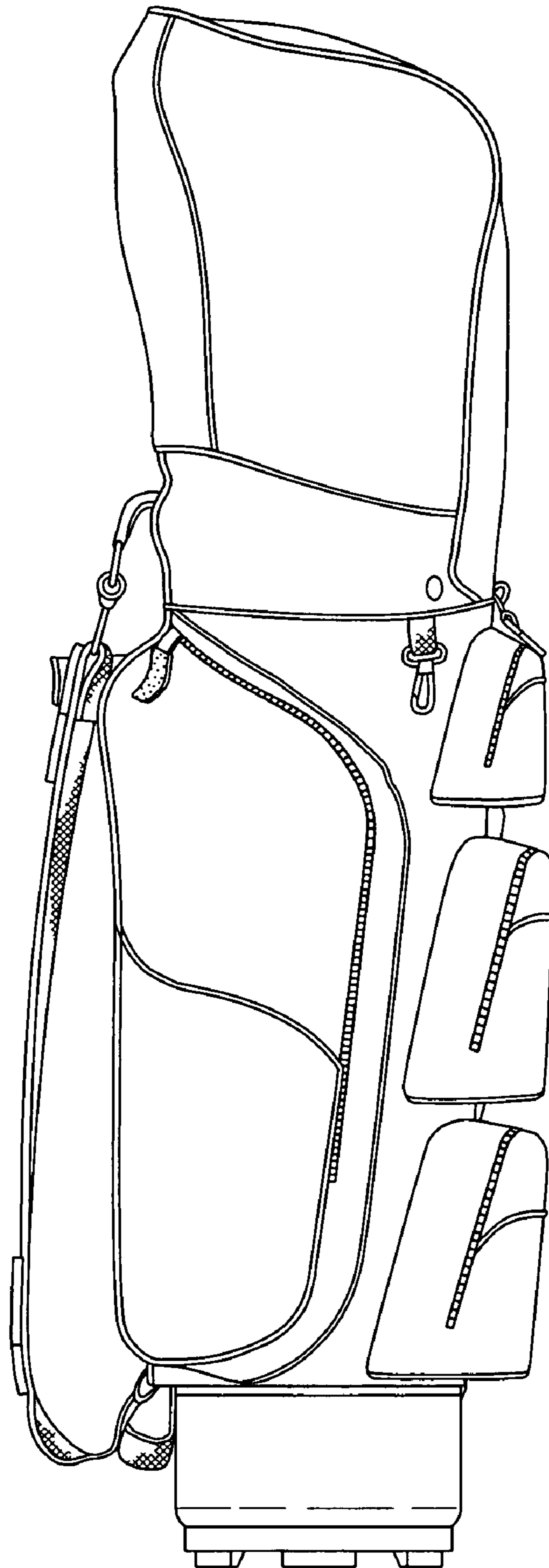

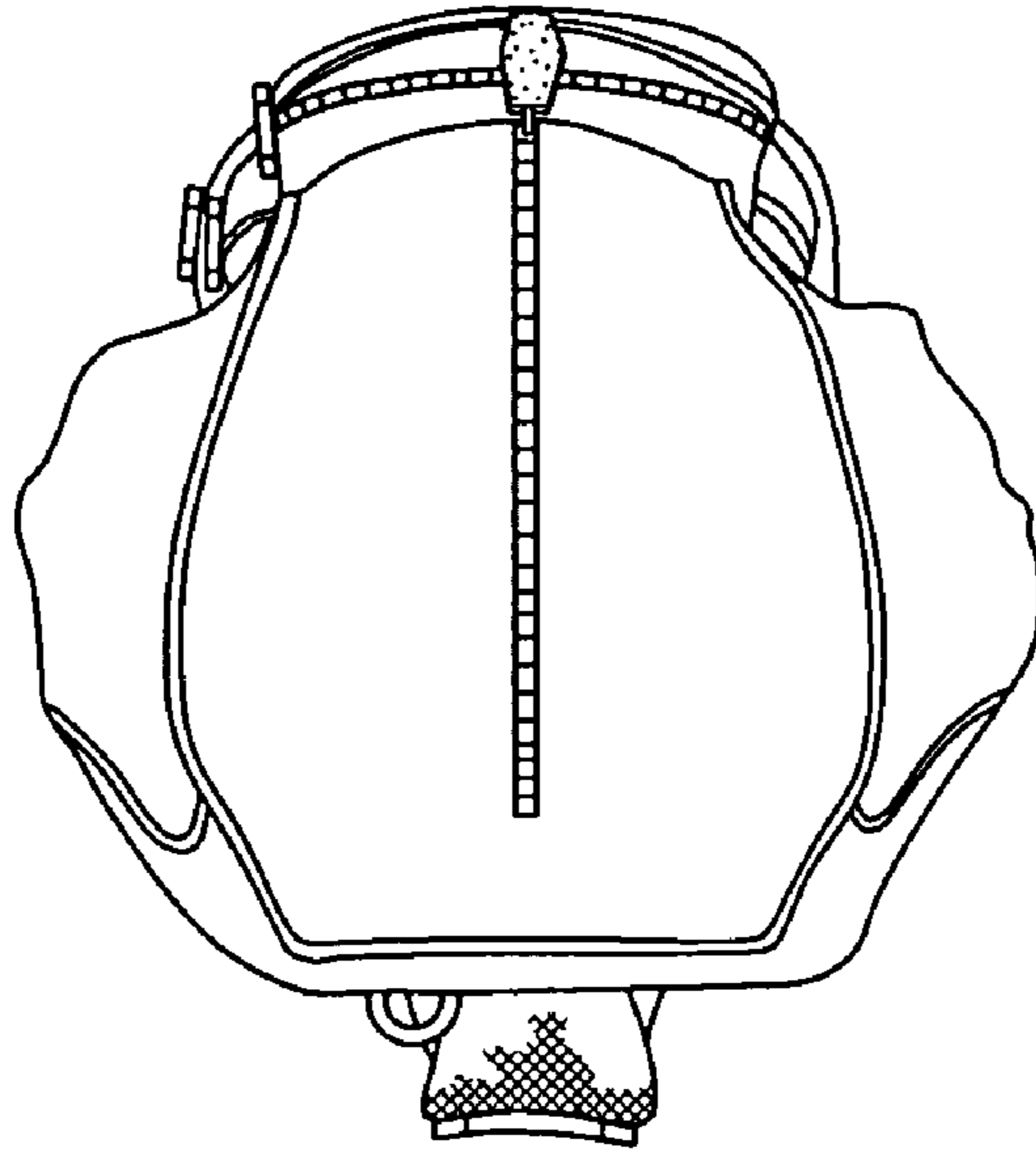
