The ornamental design for a transferable purse liner with selective size adjustment capability, as shown and described.


DESCRIPTION

FIG. 1 shows perspective view of a transferable purse liner with selective size adjustment capability, the broken lines shown on the body, around the top, and on the inside pockets of the purse liner are stitching shown for environmental purposes and does not form any part of the claimed invention.

FIG. 2 shows perspective view of a transferable purse liner with selective size adjustment capability, the broken lines shown around the top and on the inside pockets of the purse liner are stitching shown for environmental purposes and does not form any part of the claimed invention; and,

FIG. 3 shows perspective top view of a transferable purse liner with selective size adjustment capability, the broken lines shown on the body, around the top, and on the inside pockets of the purse liner are stitching shown for environmental purposes and does not form any part of the claimed invention, and the various items shown in broken lines inside the purse liner are shown for environmental purposes and does not form any part of the claimed invention.






