(57) **CLAIM**

We claim the ornamental design for a seating unit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a seating unit according to the new design;

FIG. 2 is a rear perspective view of a seating unit shown in FIG. 1;

FIG. 3 is a front view of the seating unit shown in FIG. 1;

FIG. 4 is a right side view of the seating unit shown in FIG. 1, the opposed left side view being a mirror image thereof

FIG. 5 is a rear view of the seating unit shown in FIG. 1;

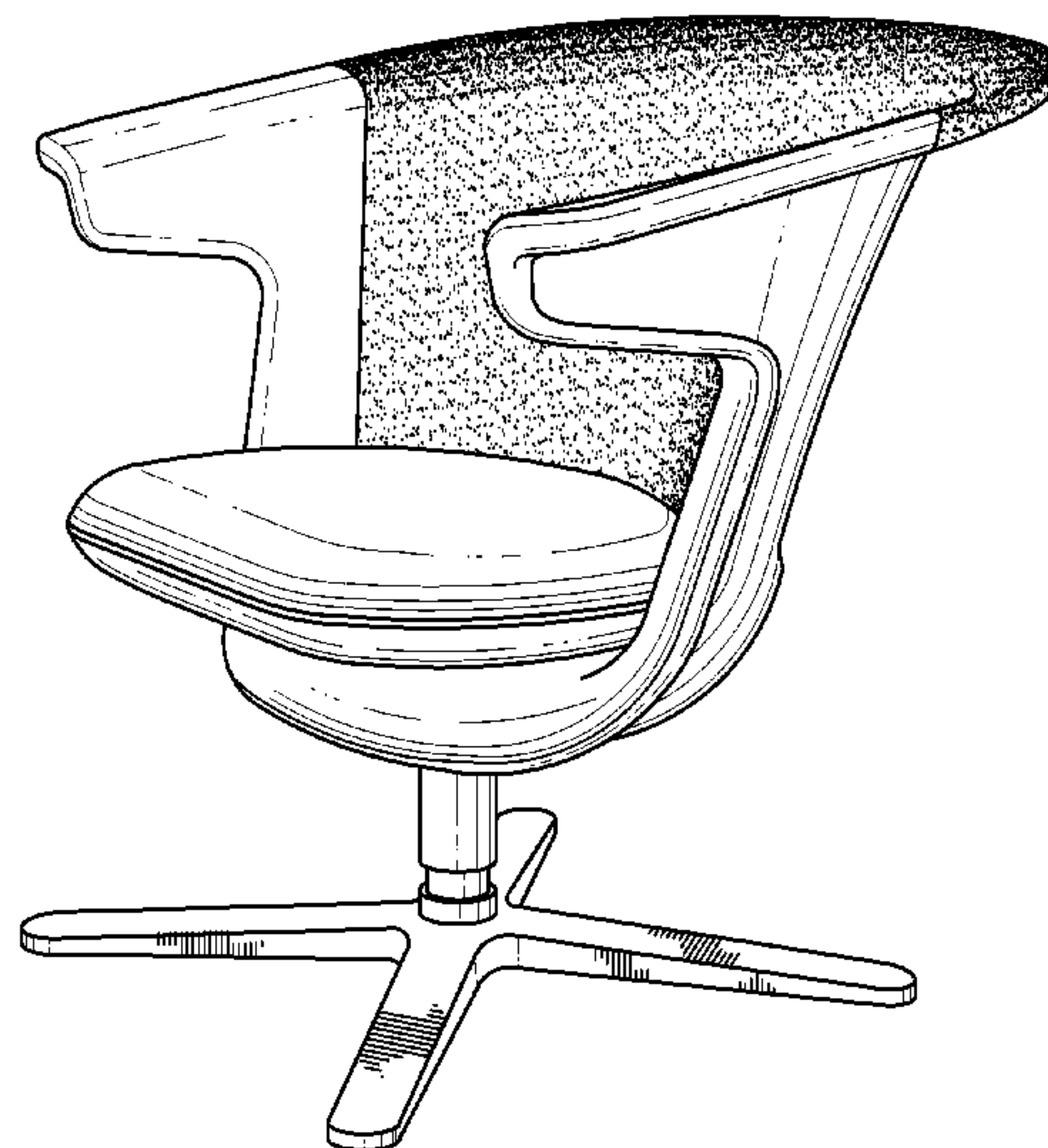
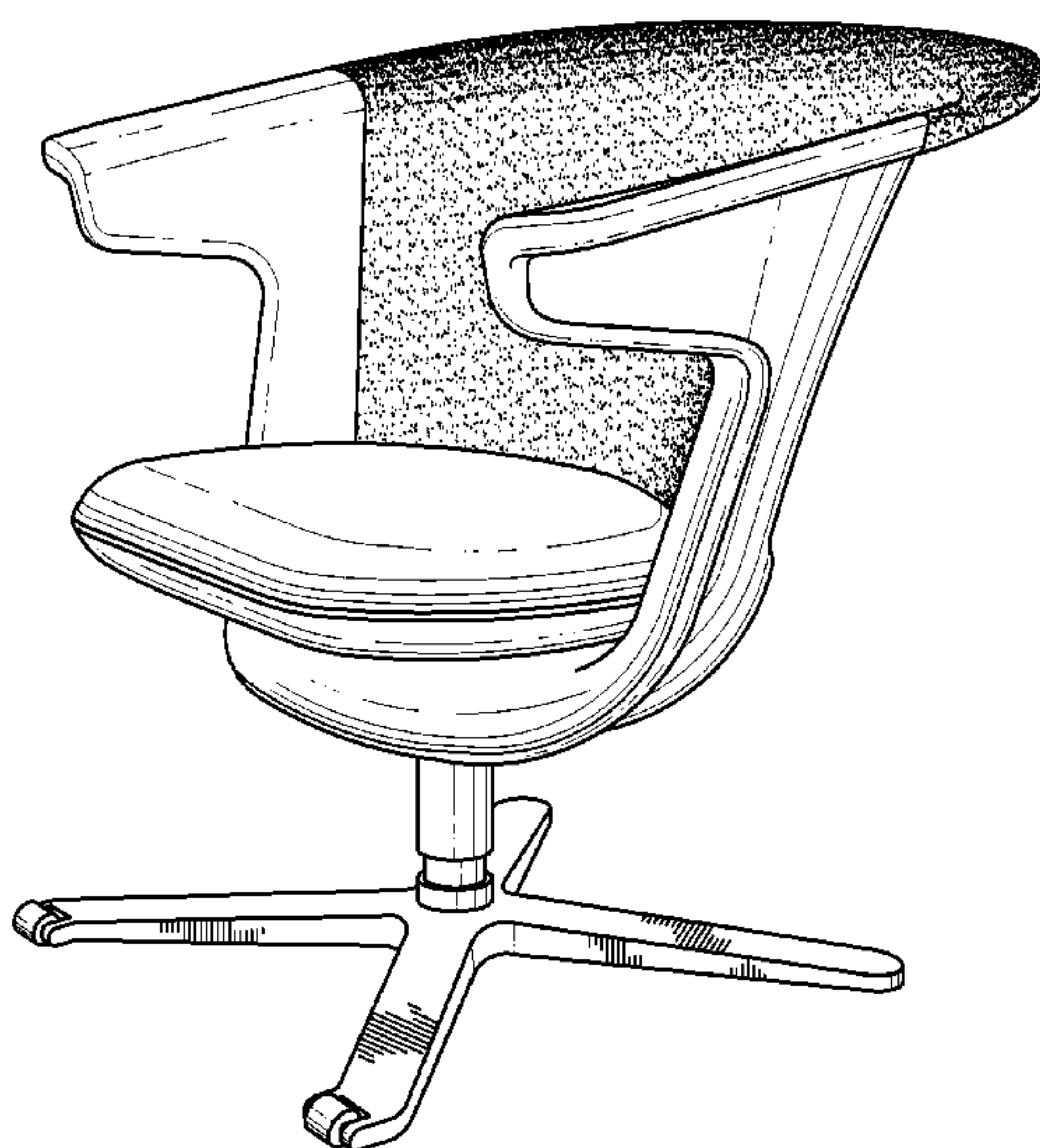
FIG. 6 is a top view of the seating unit shown in FIG. 1;

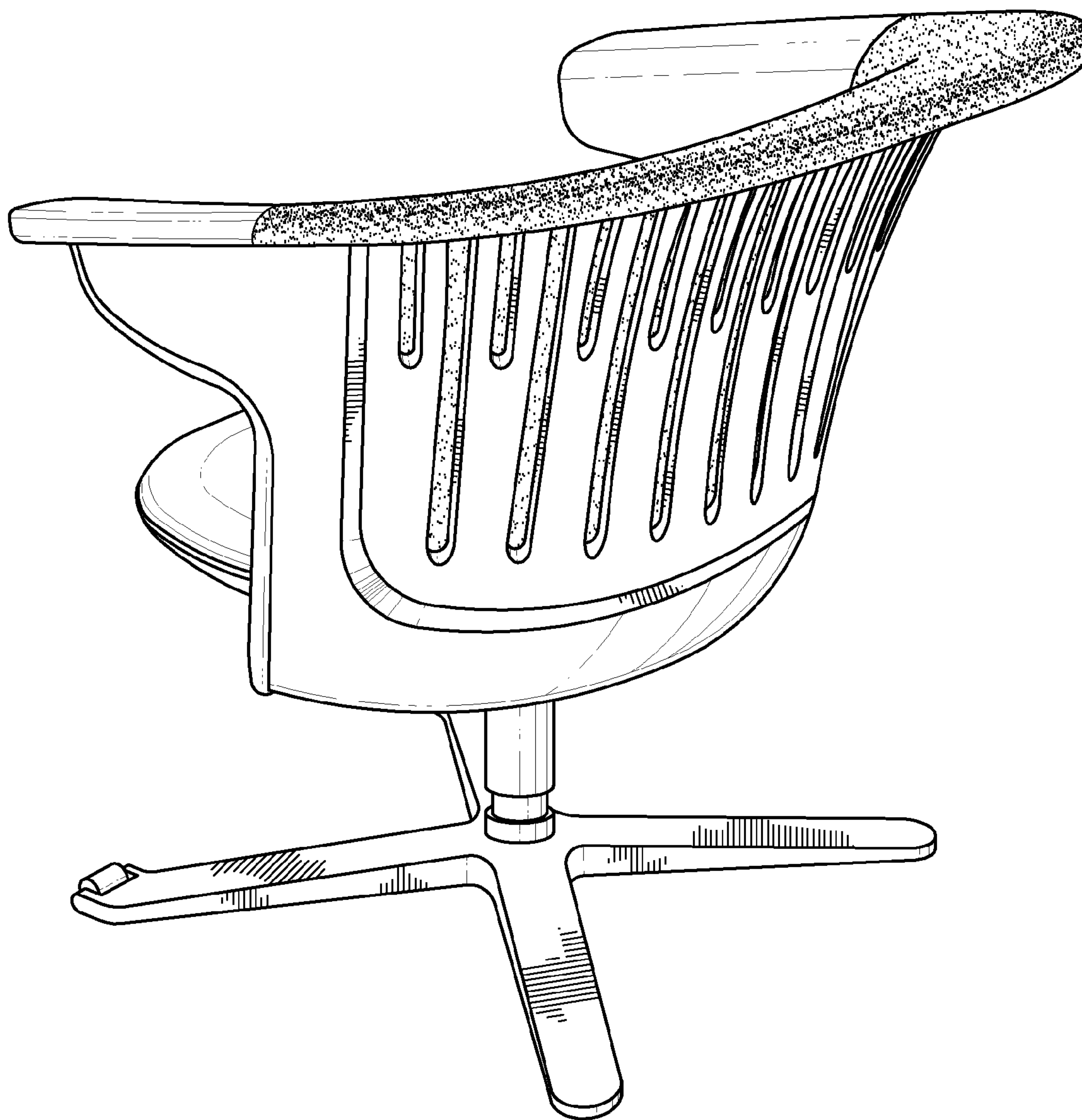

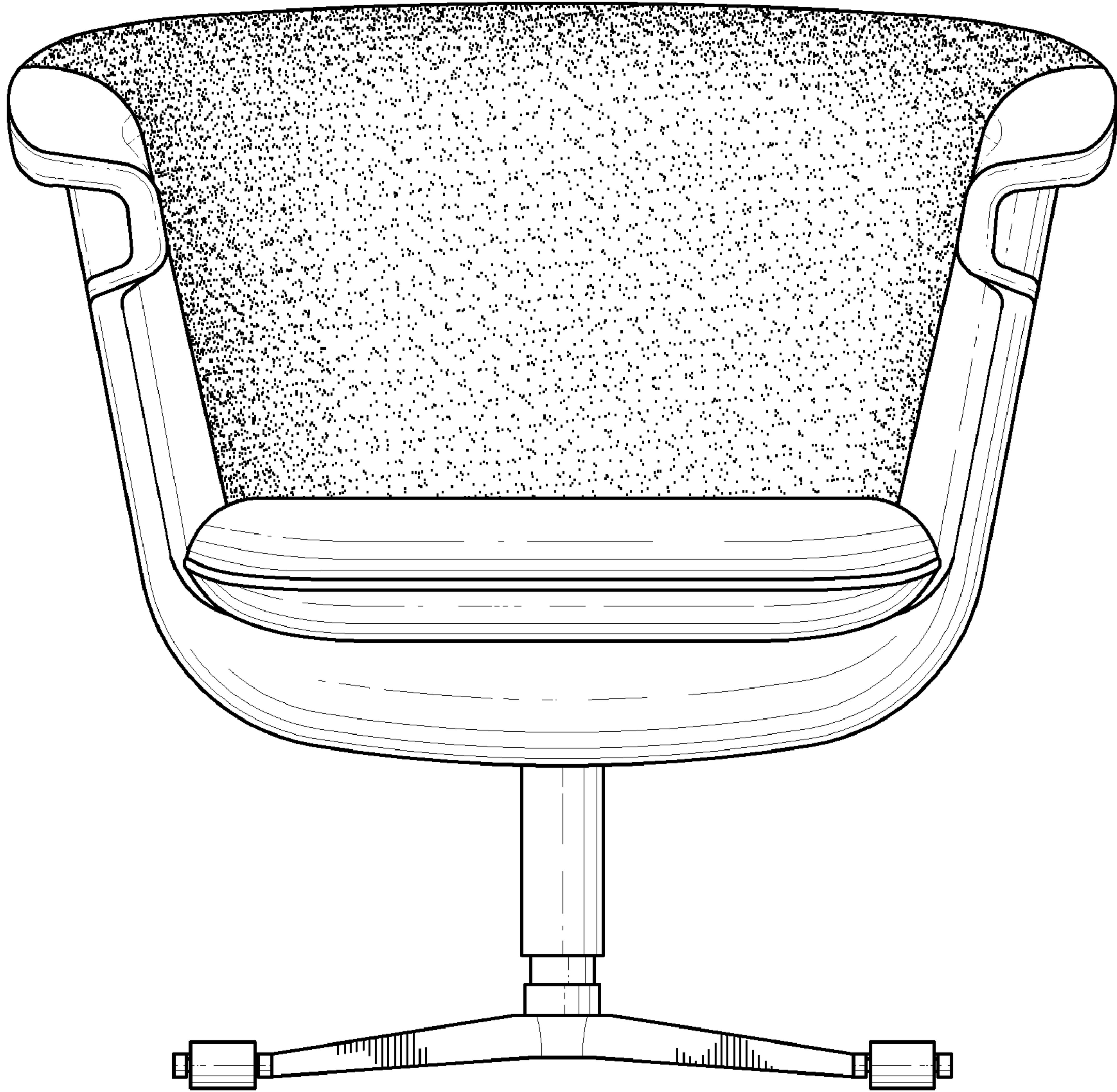

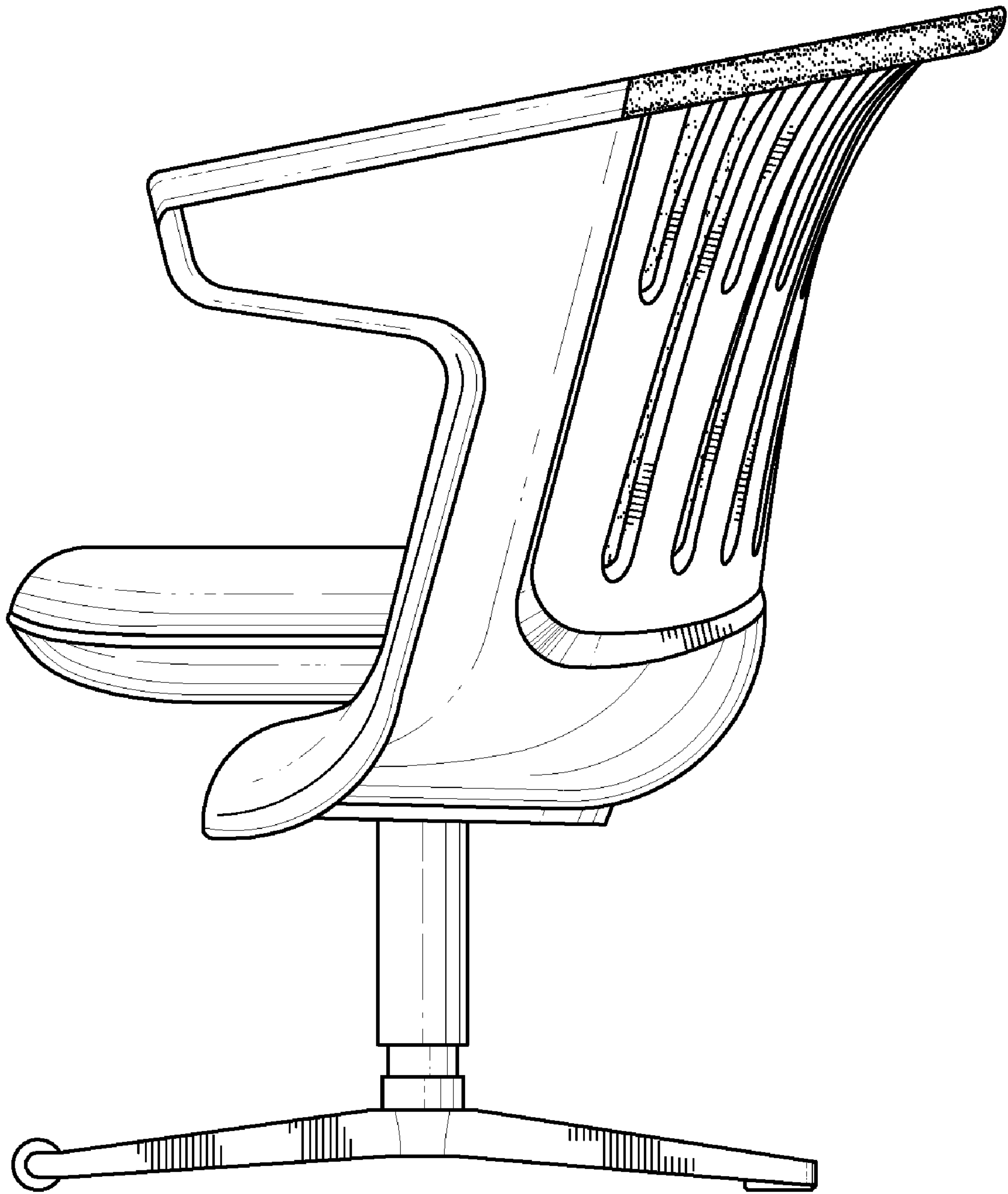

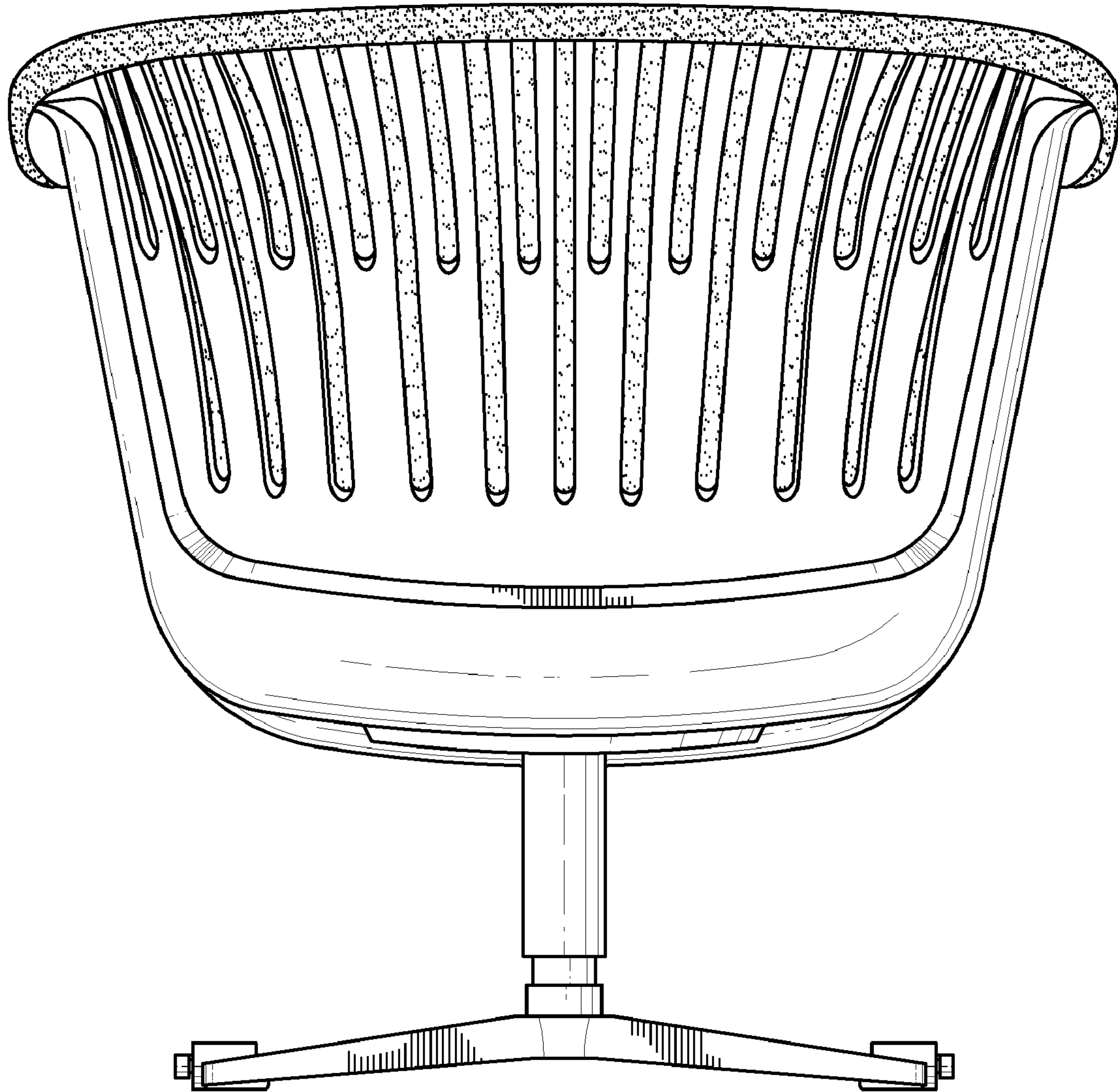

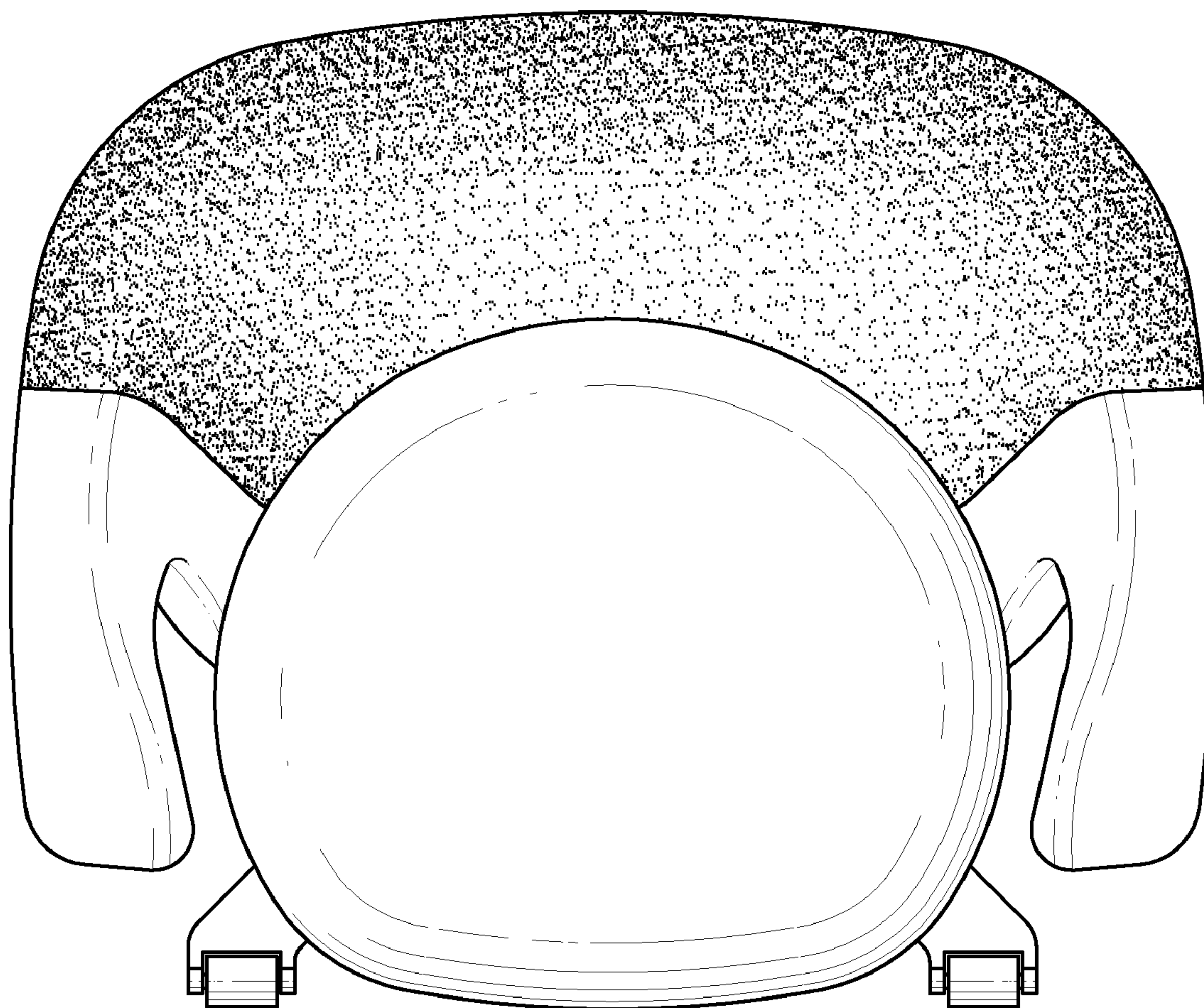

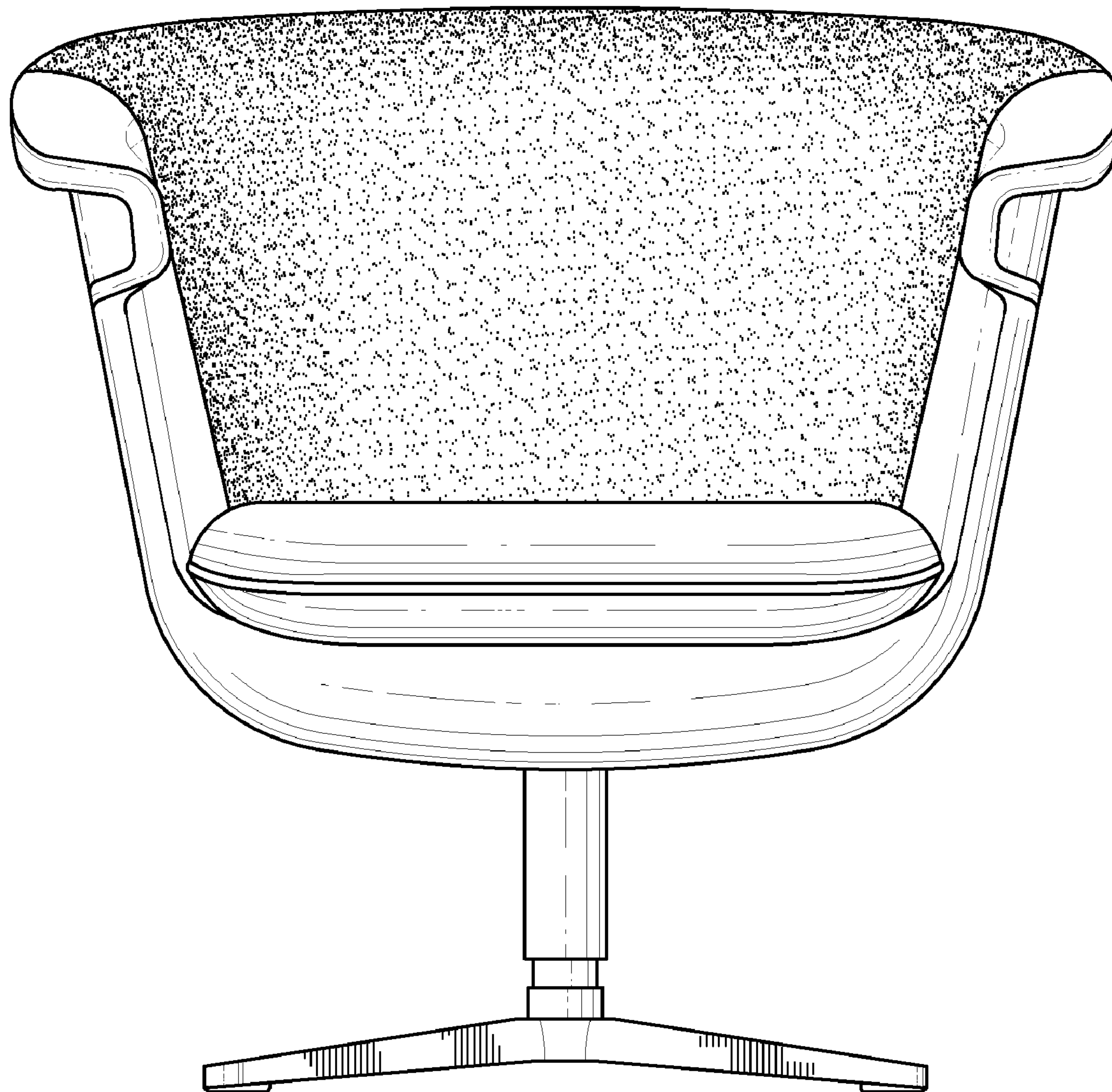
