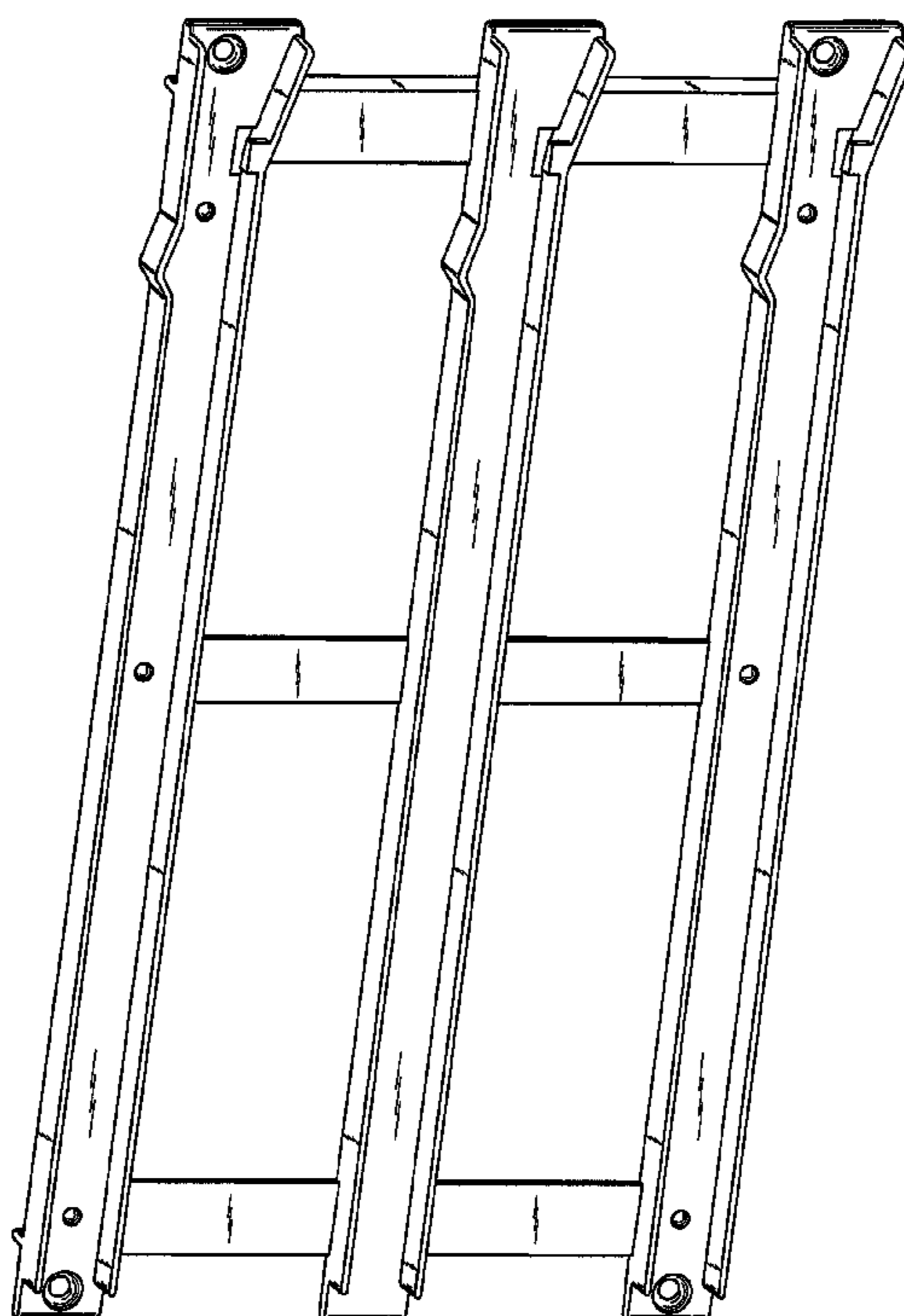

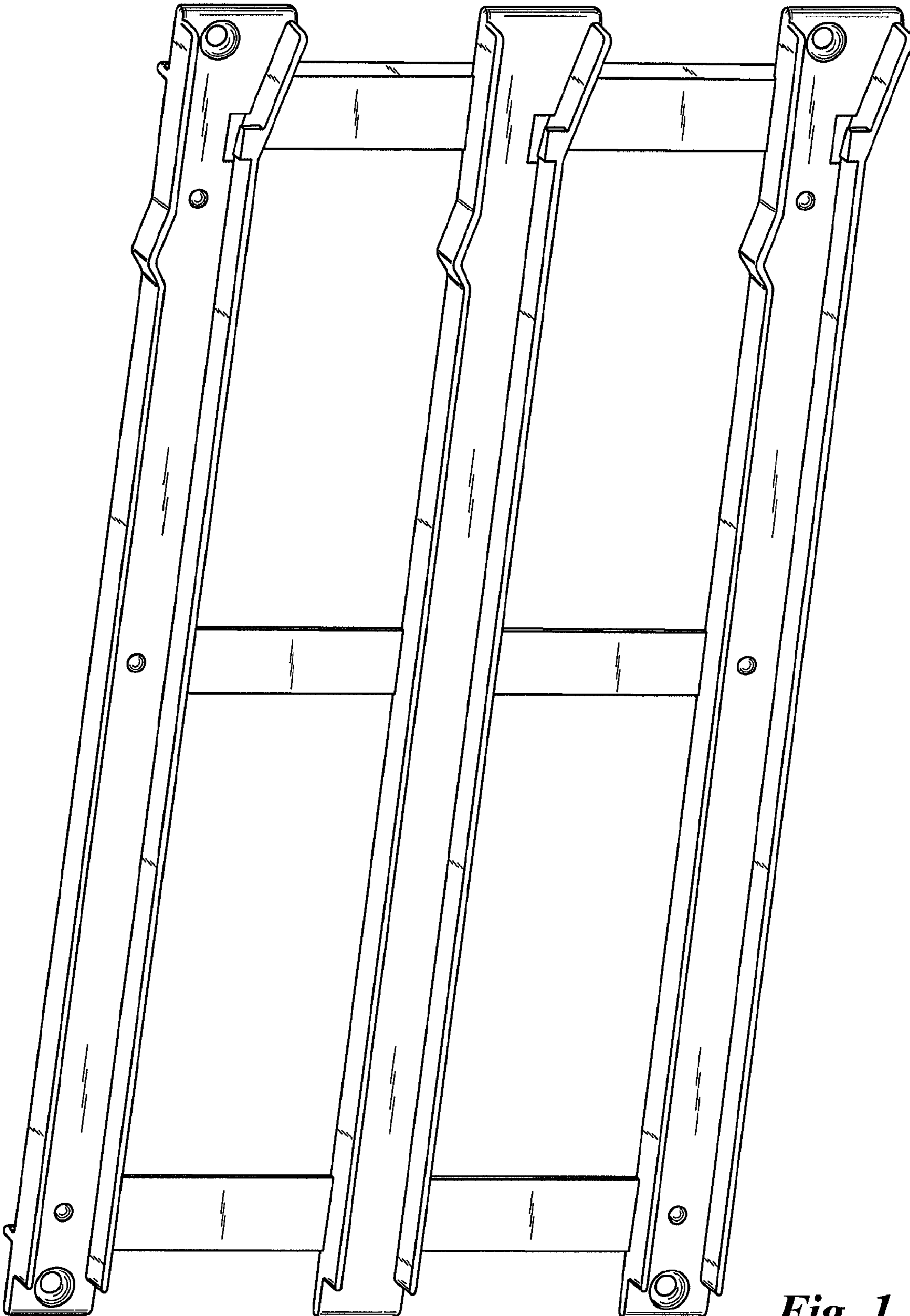
The ornamental design for a tray runner, as shown and described.

**DESCRIPTION**

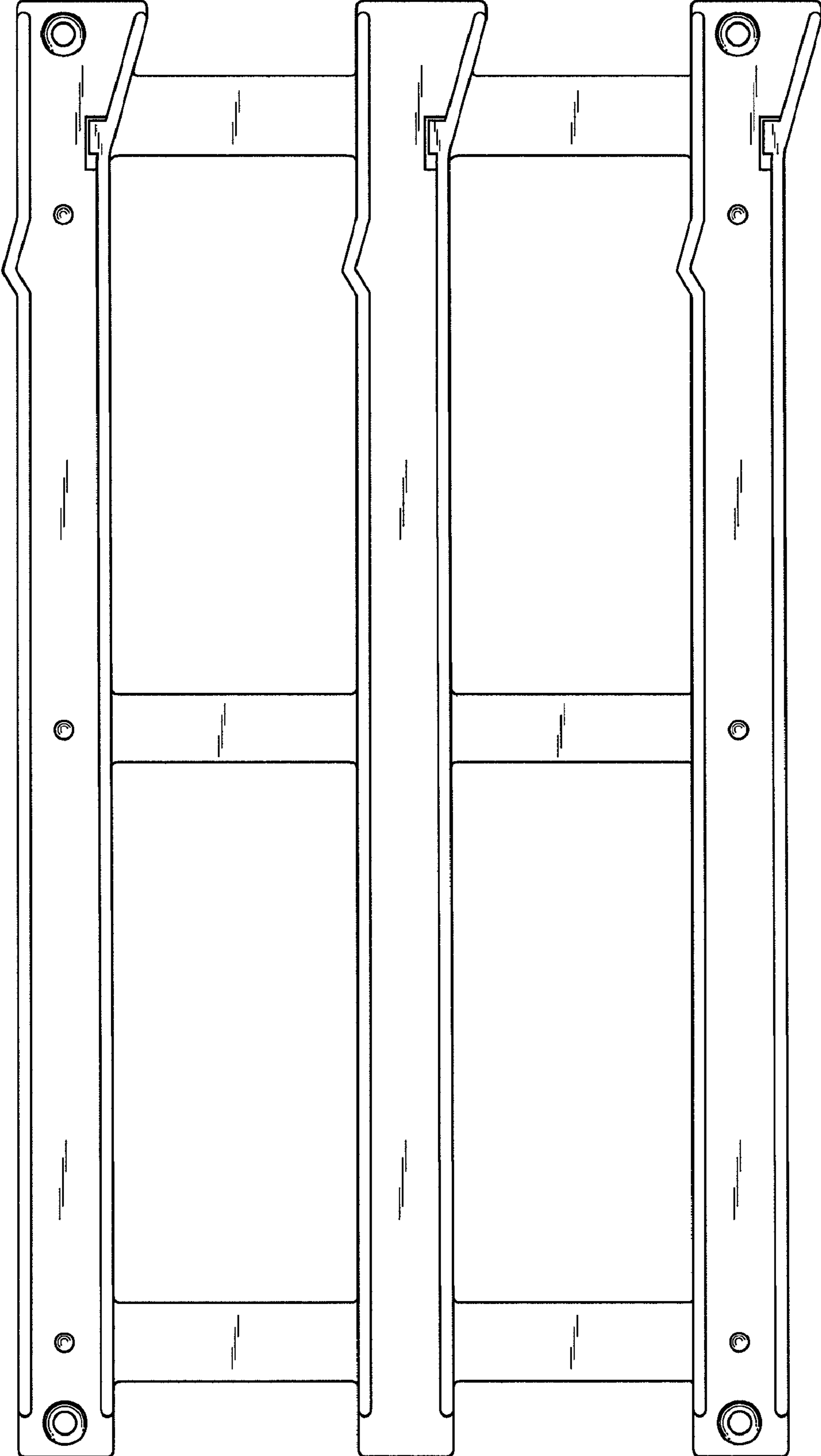
FIG. 1 is a perspective view of a tray runner;

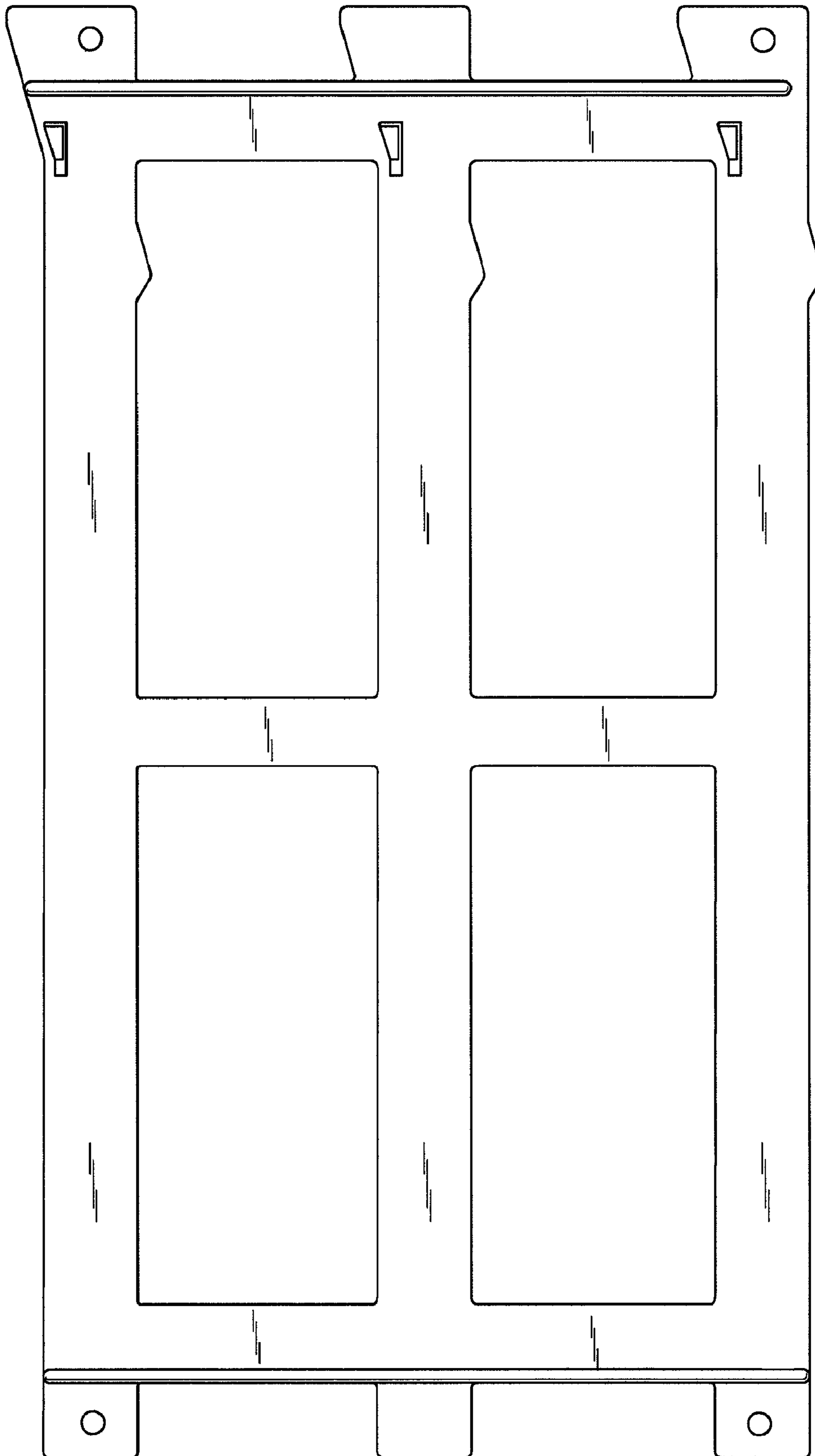




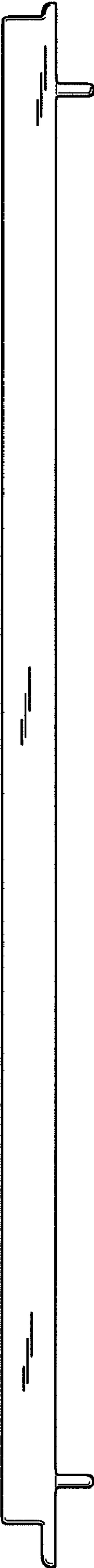

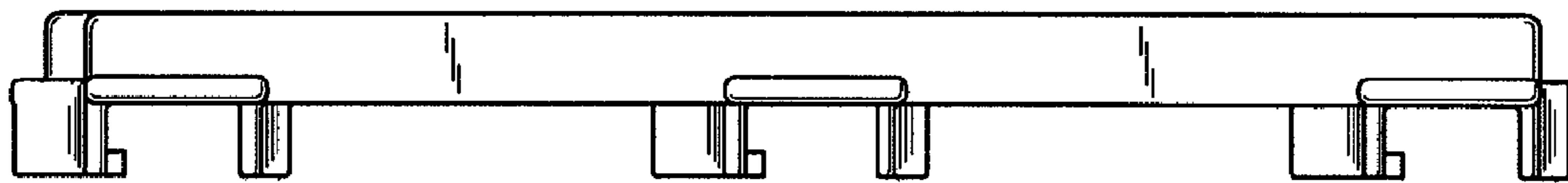

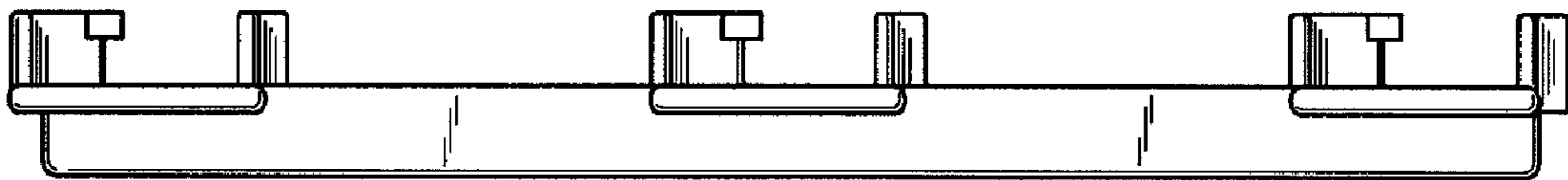
