(57) **CLAIM**

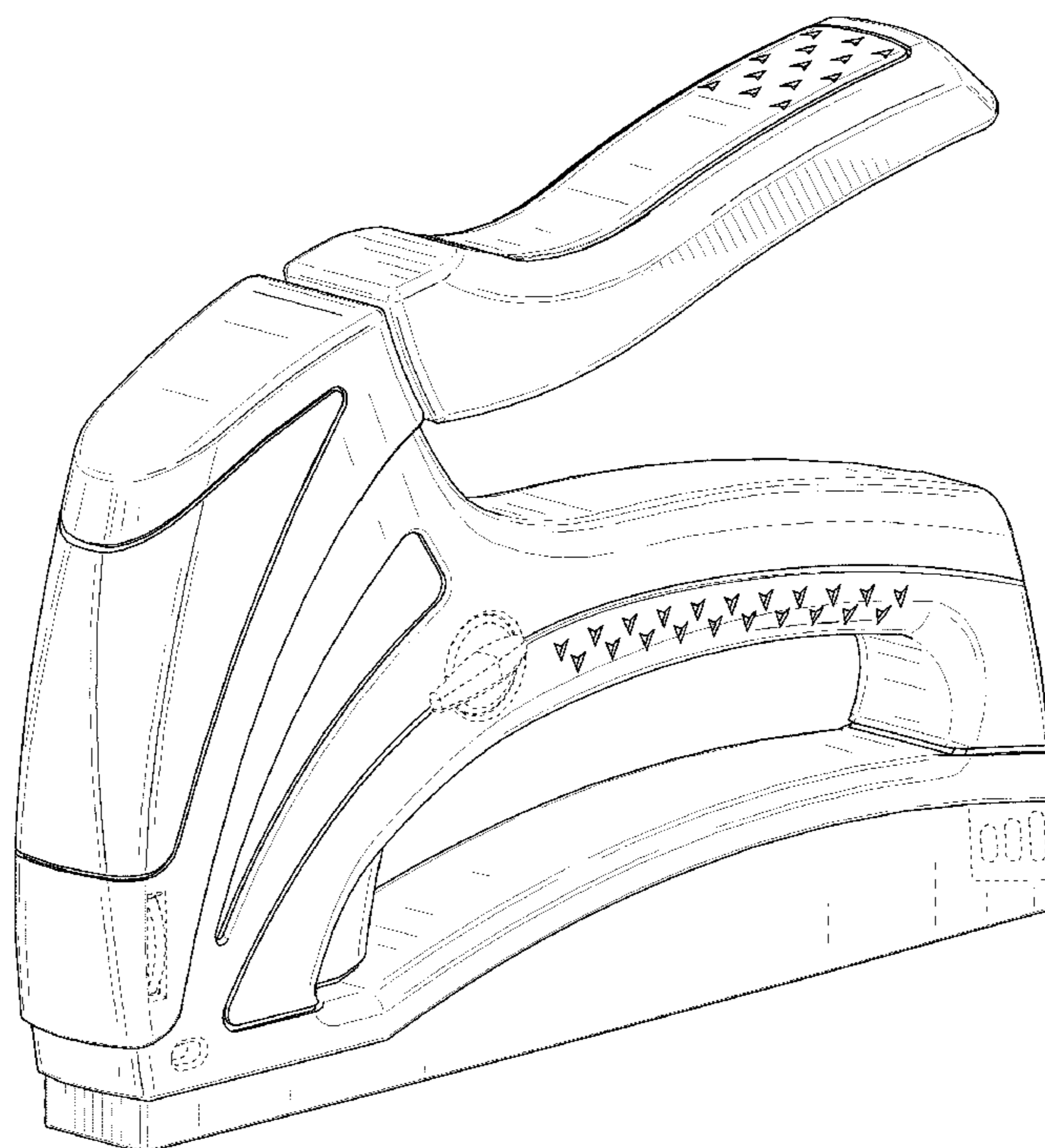
The ornamental design for a stapler, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a stapler showing our design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view thereof;

FIG. 5 is a bottom plan view thereof;
FIG. 6 is a front elevational view thereof; and,

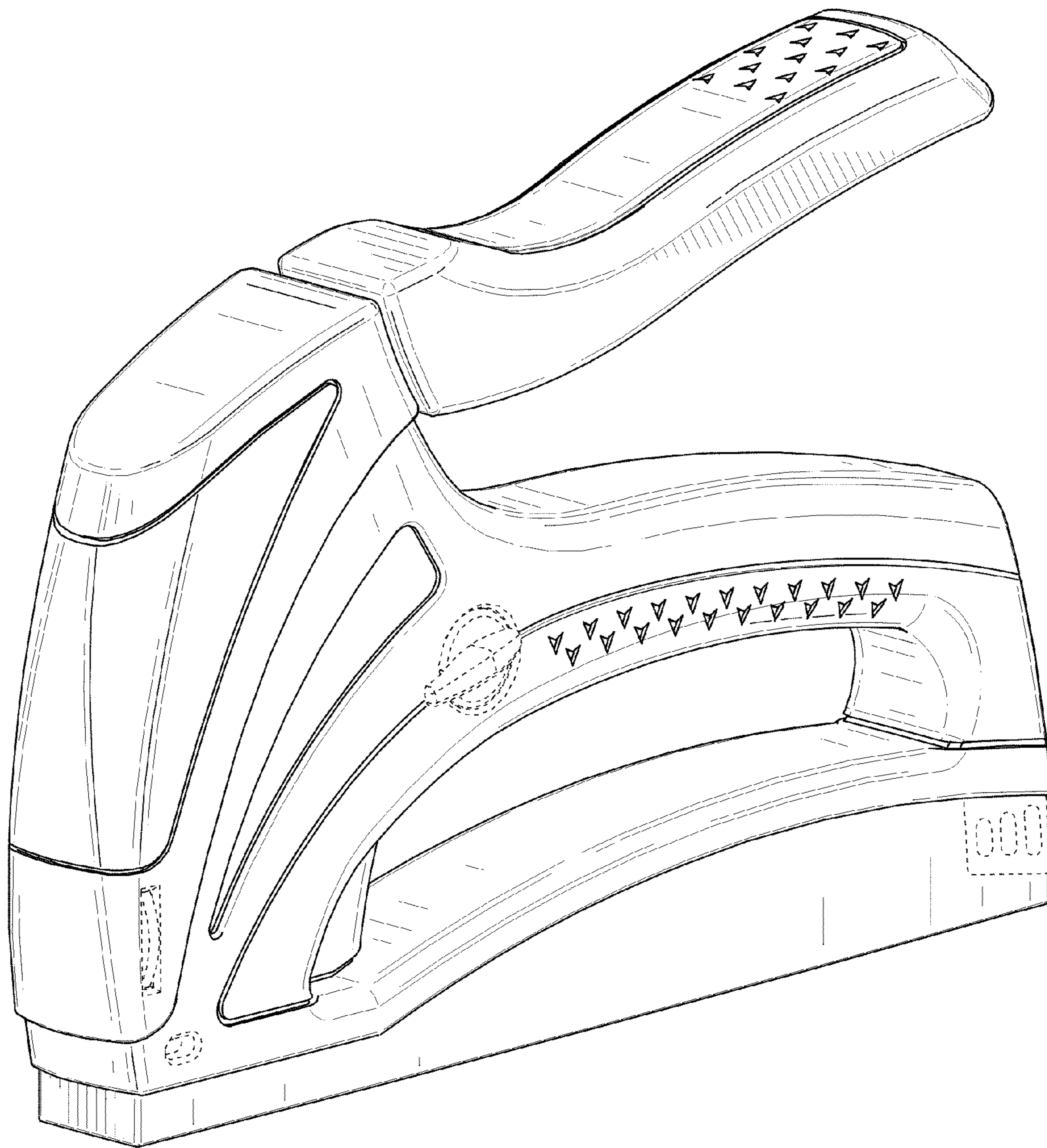

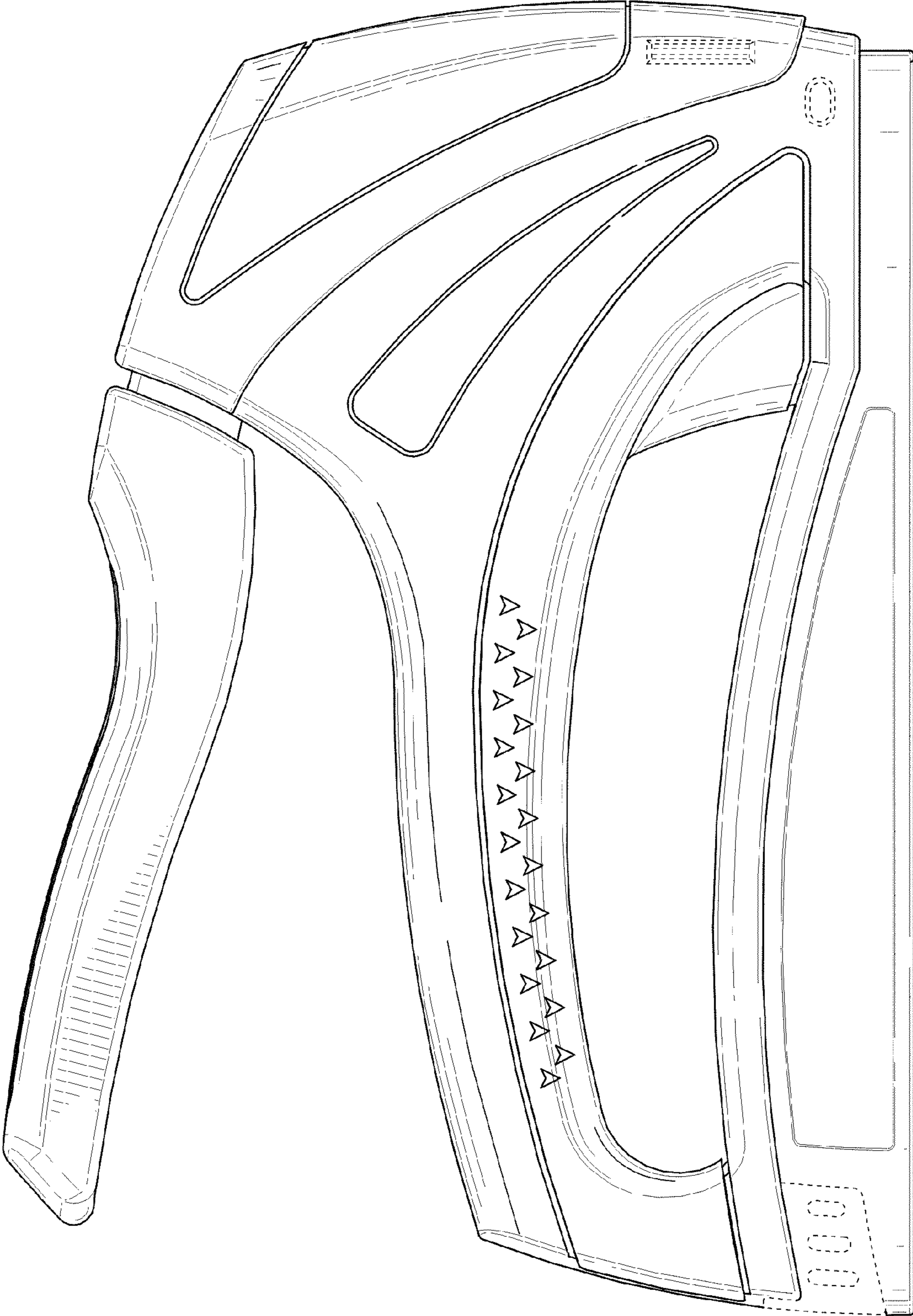

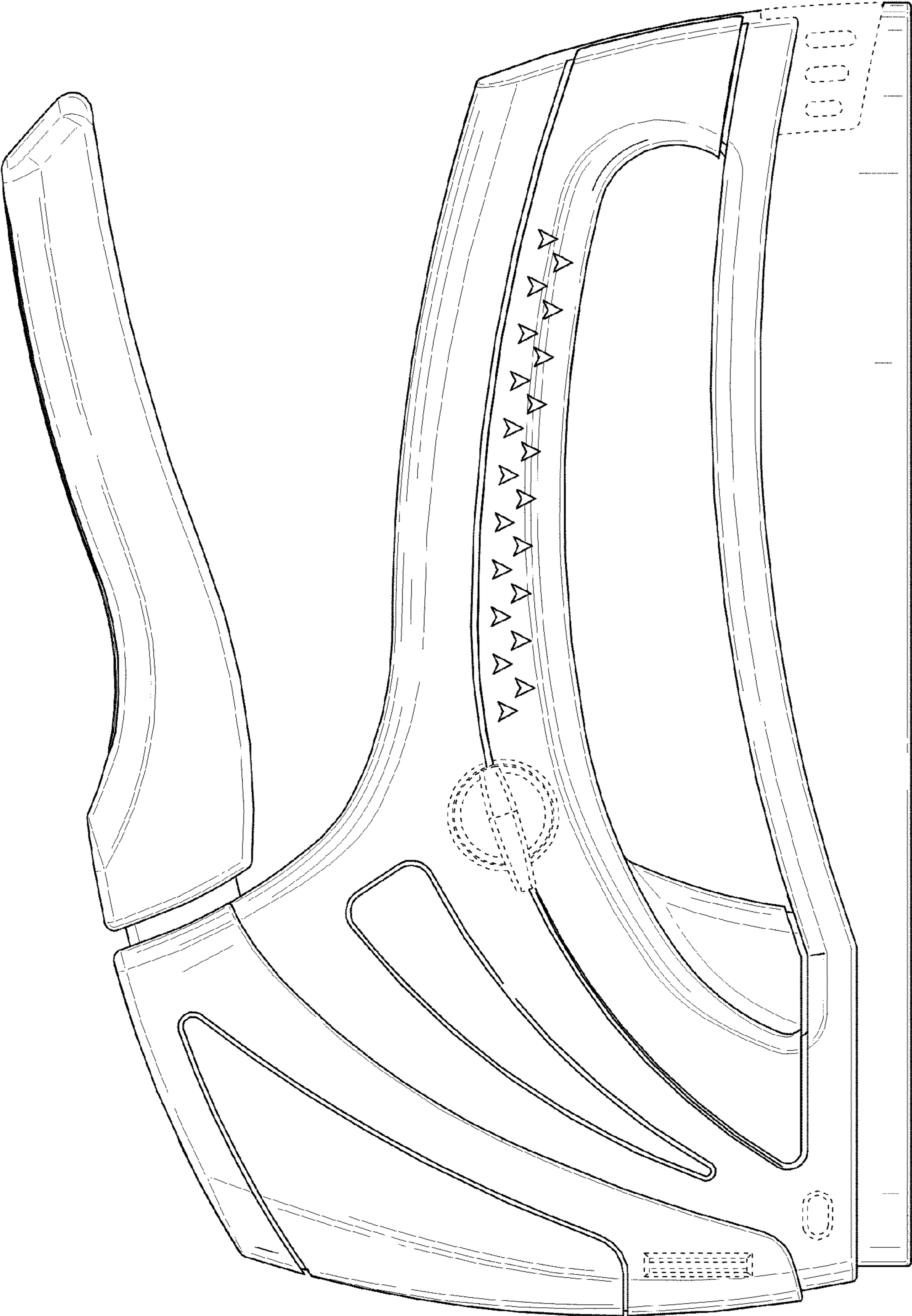

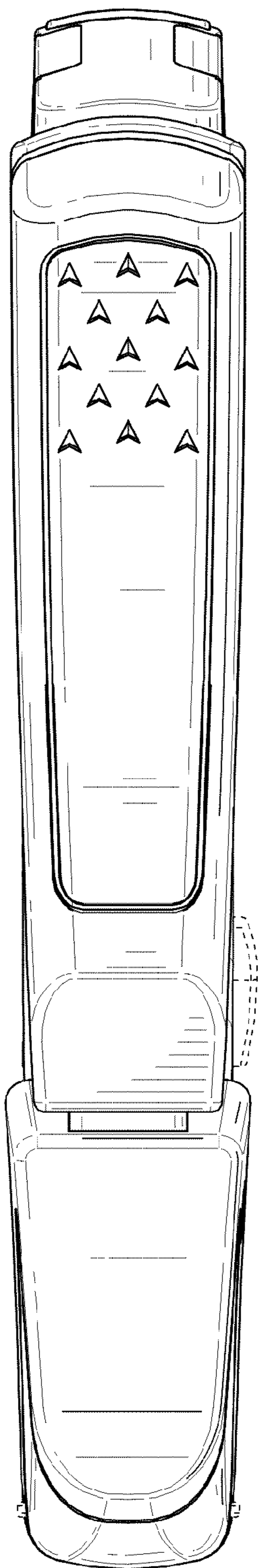

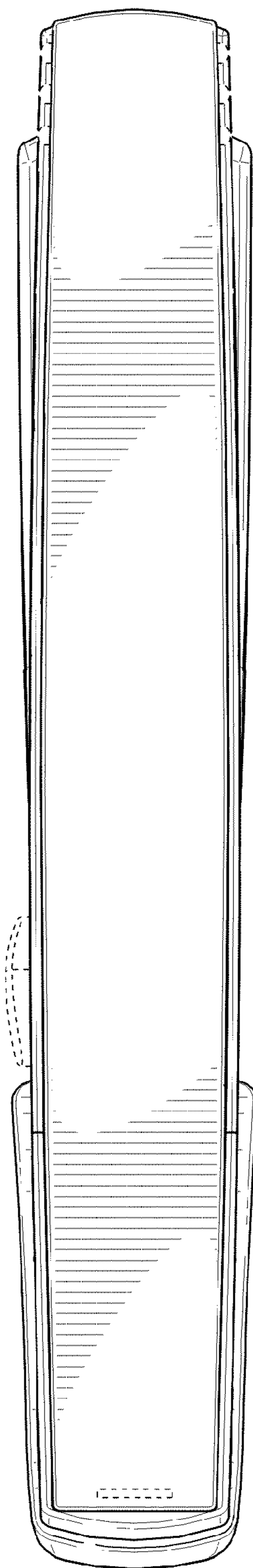

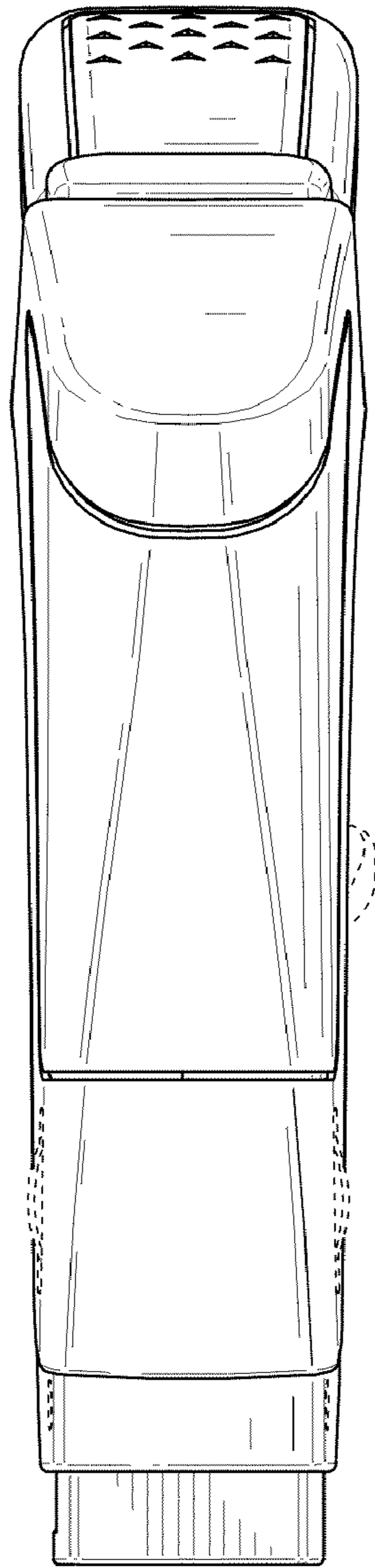

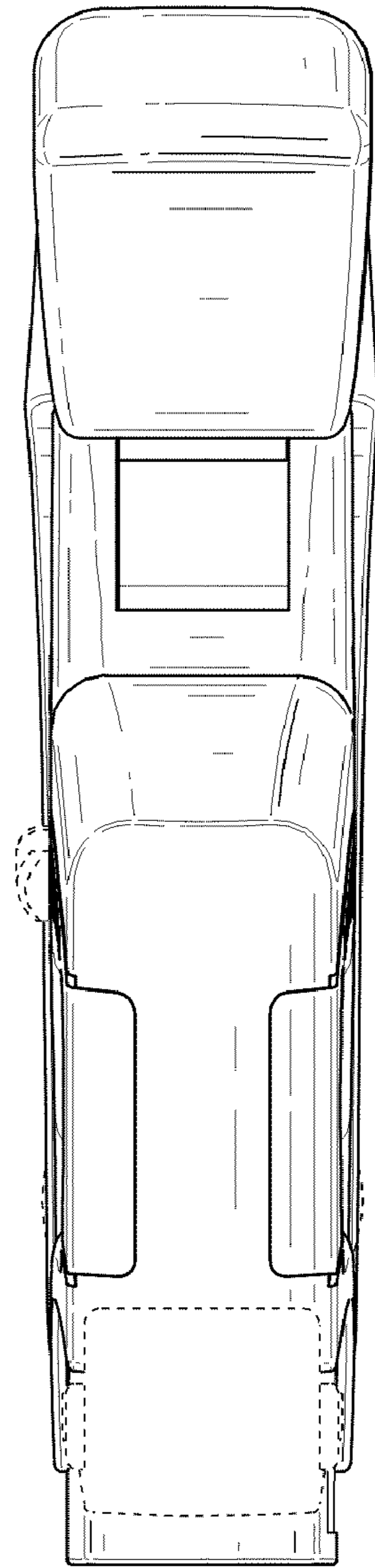
