The ornamental design for a knob, as shown and described.

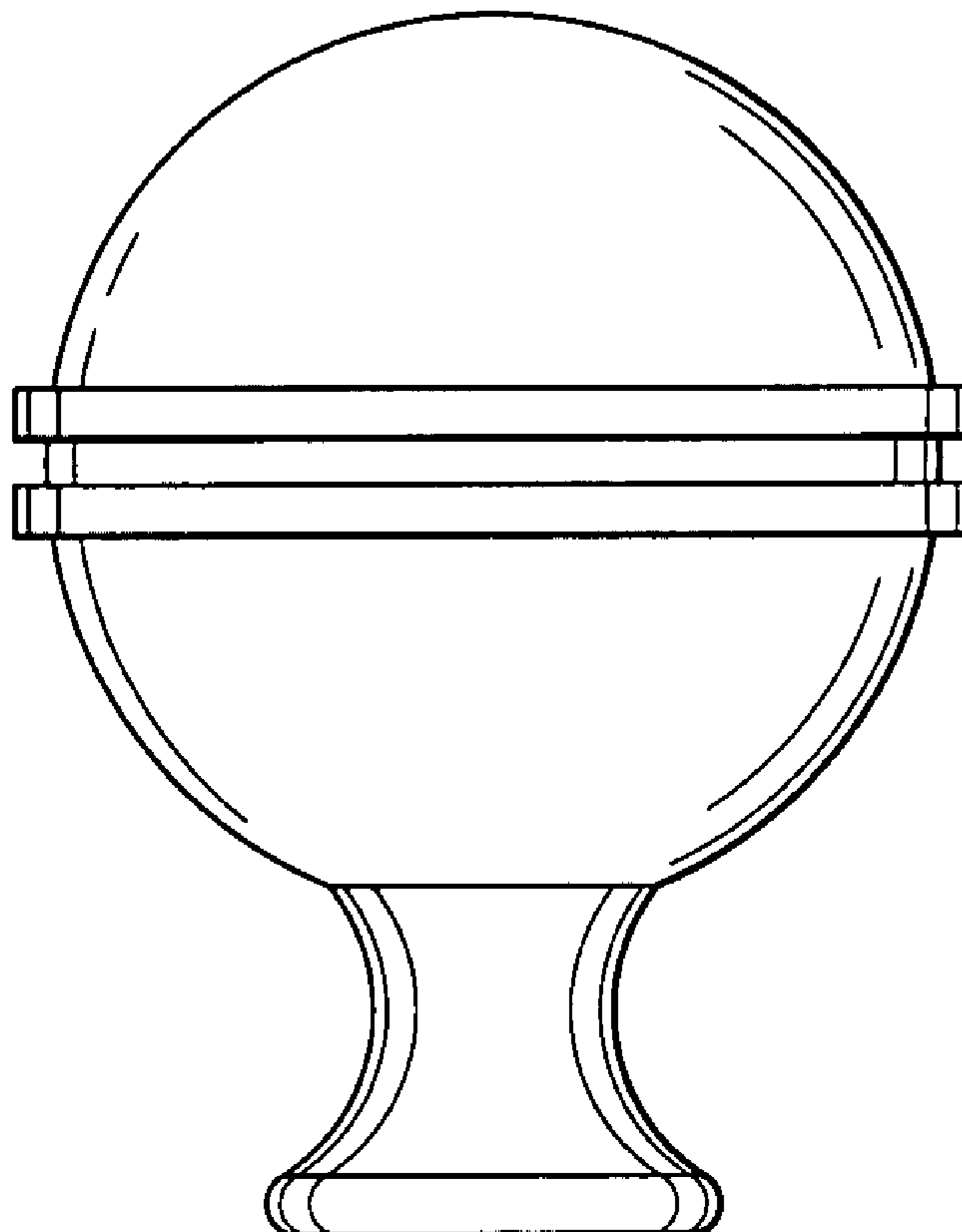
DESCRIPTION

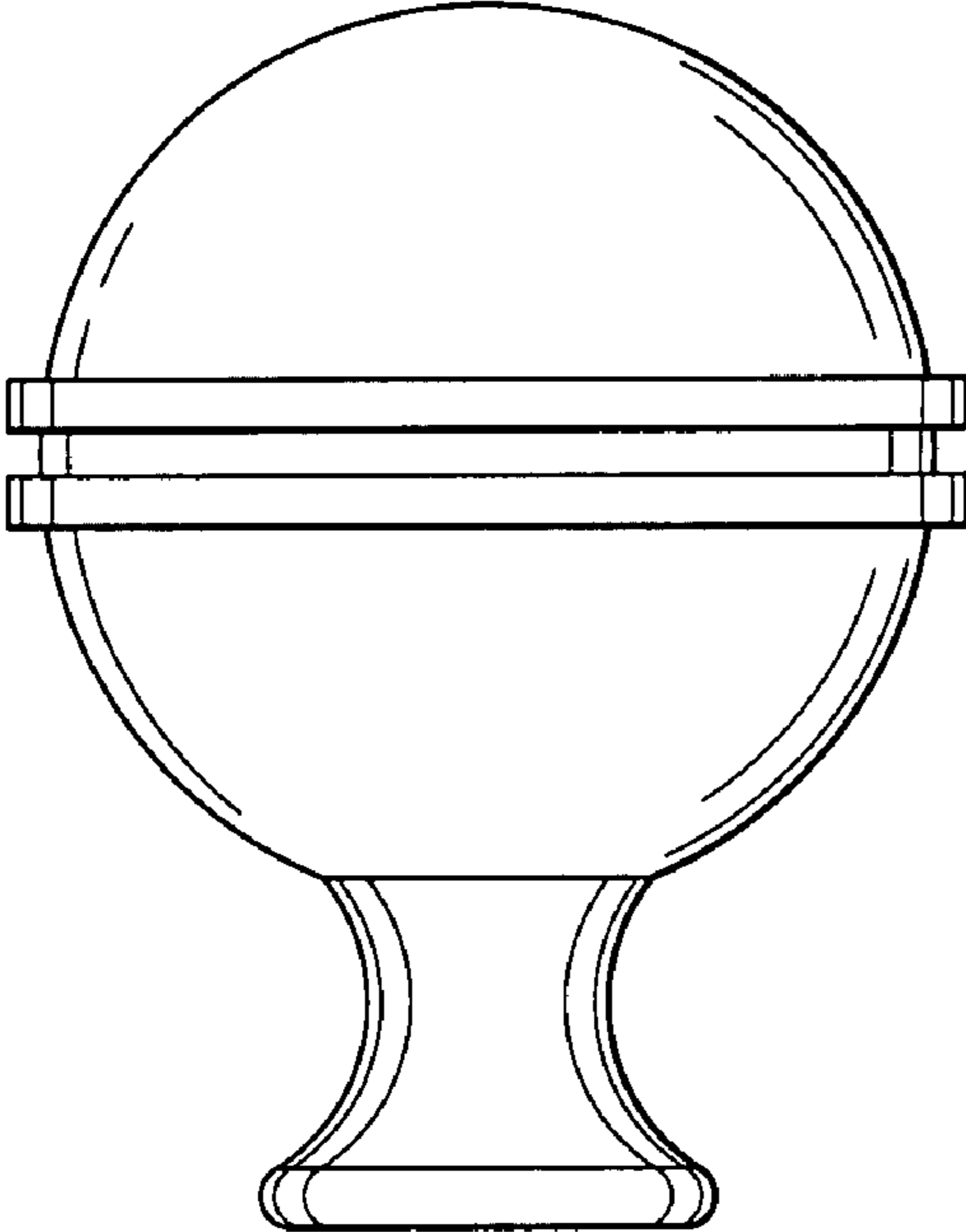

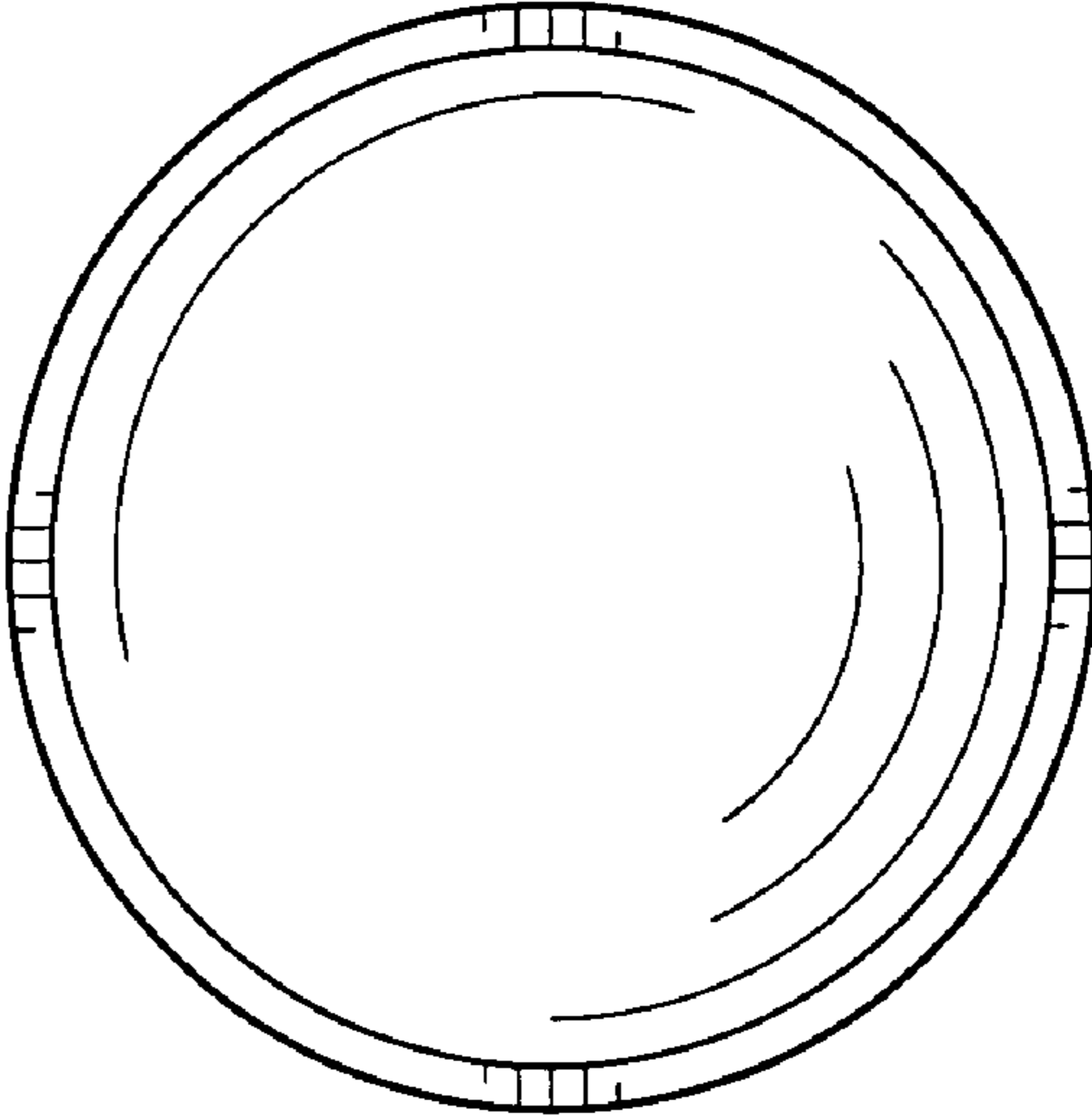
