(57) **CLAIM**

I claim the ornamental design for the lifting handle, as shown and described.

**DESCRIPTION**

FIG. 5 is a left-side elevational view thereof;

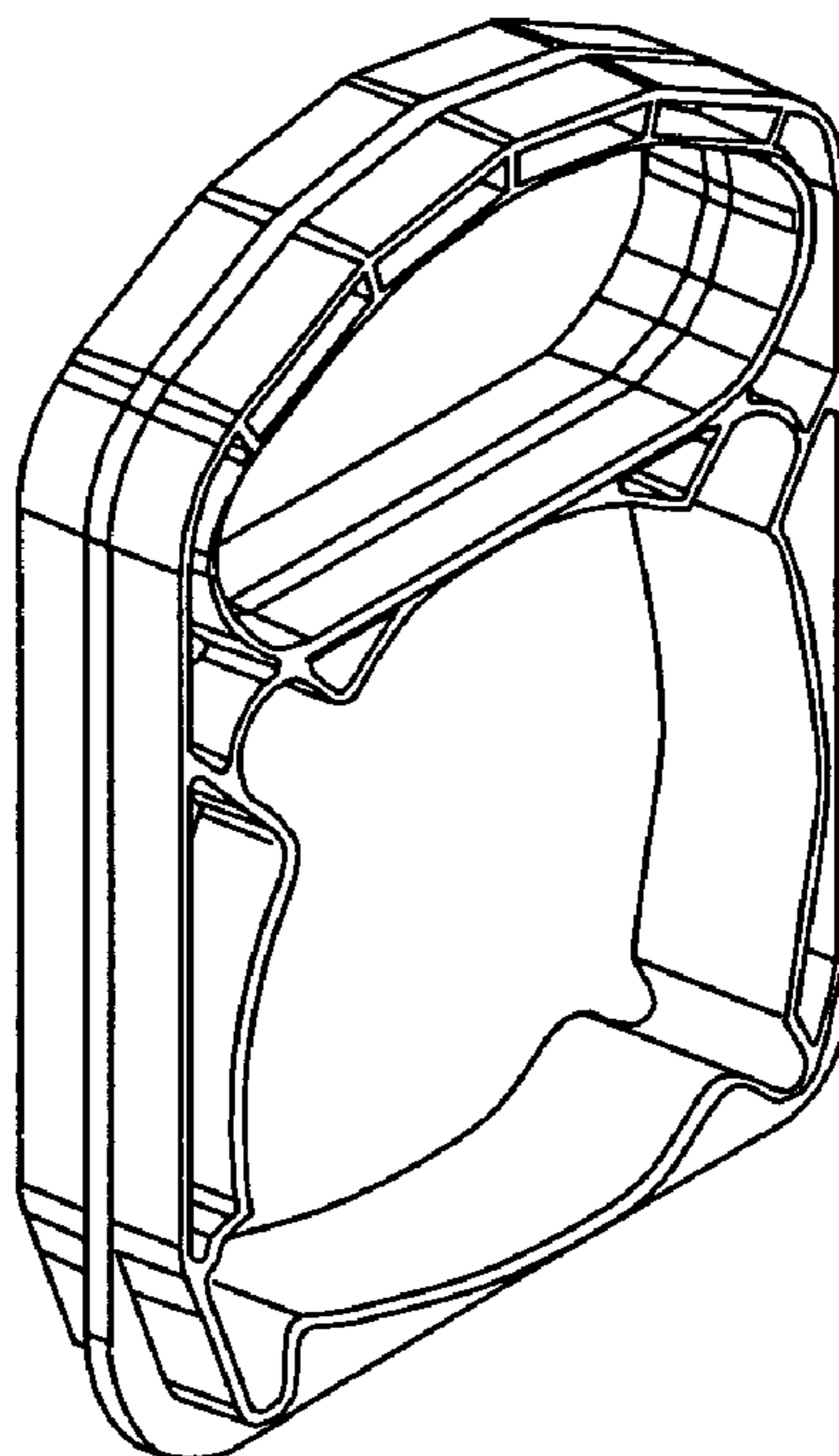
FIG. 6 is a top plan view thereof;

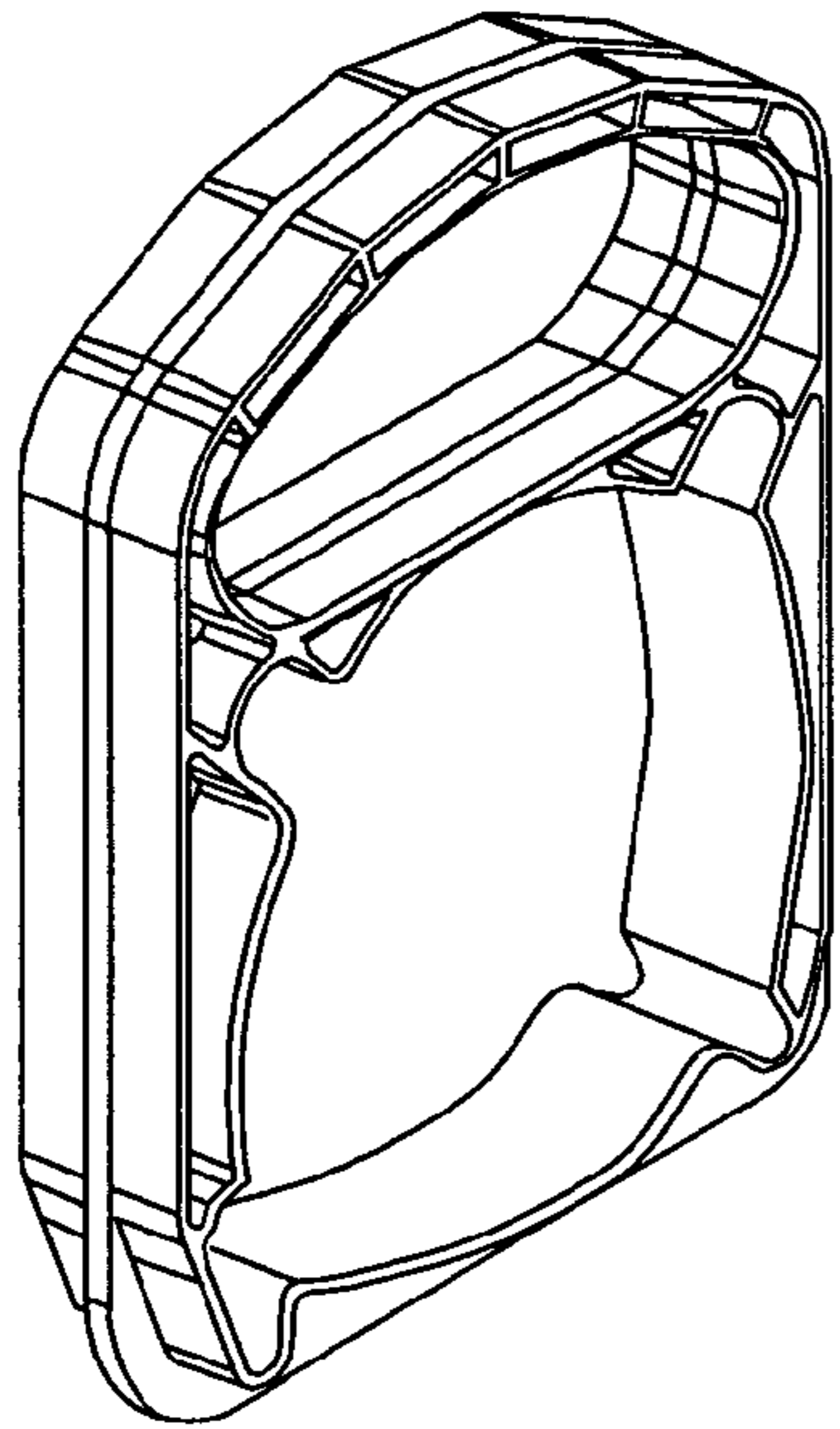
FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a perspective view thereof, with the lifting handle shown in its environmental use.

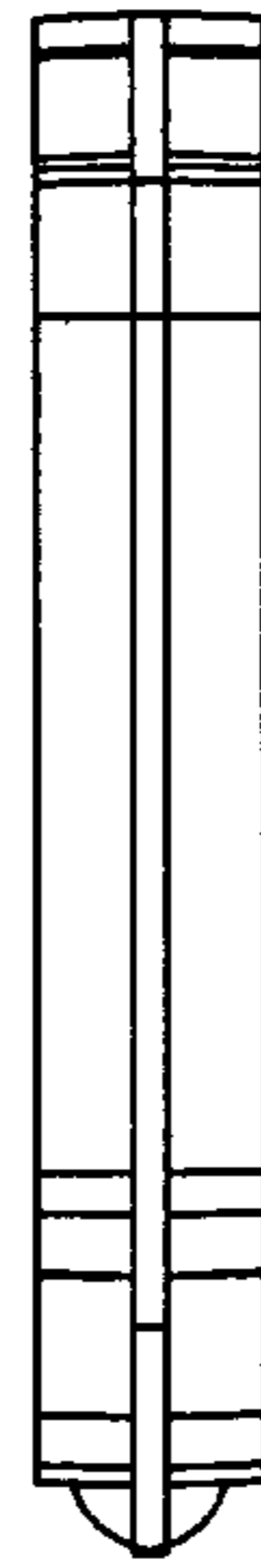
The broken lines environment, showing the lifting handle for actuators for gates and doors, are for illustrative purpose only, and form no part of the claimed design.

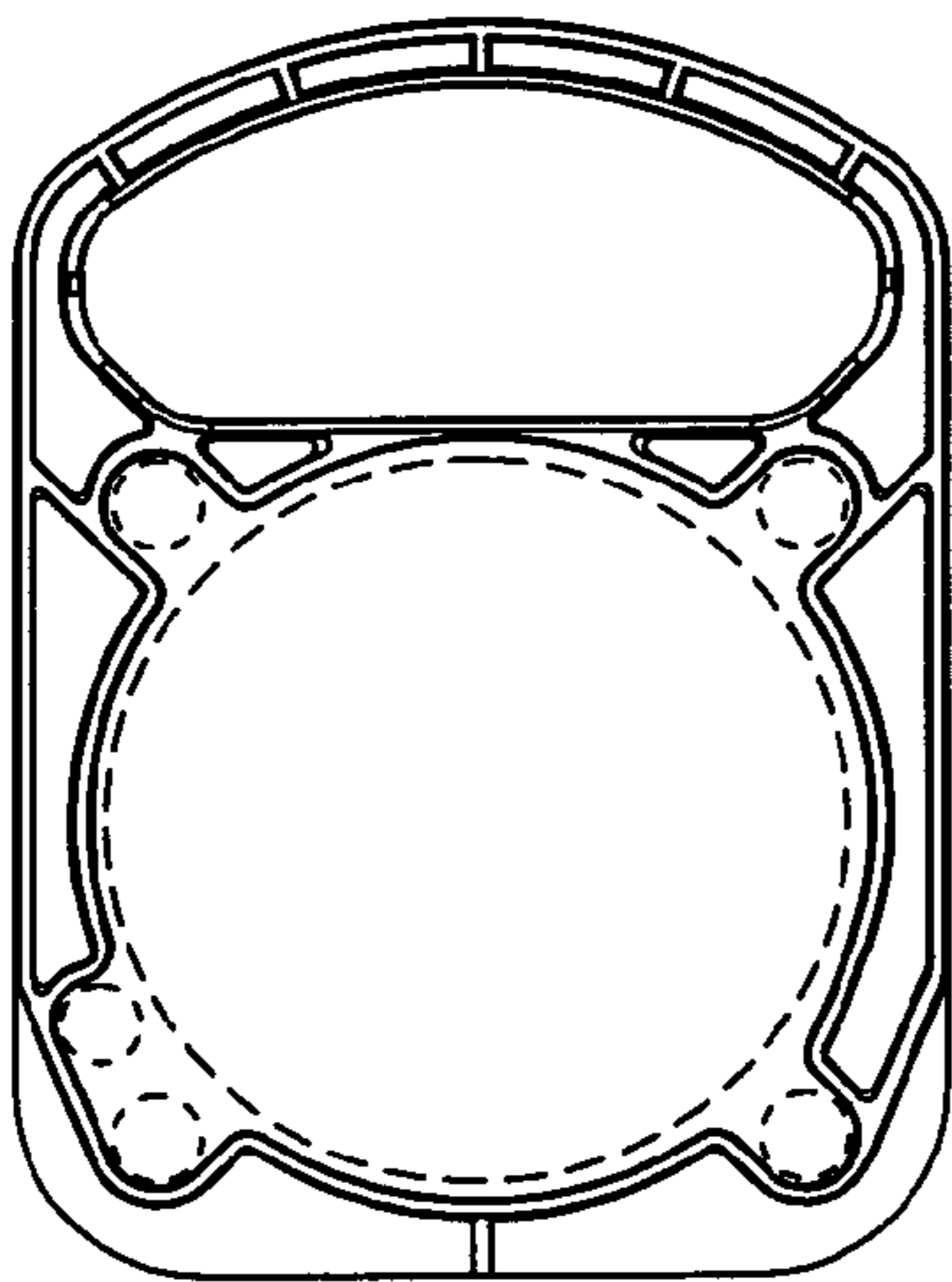

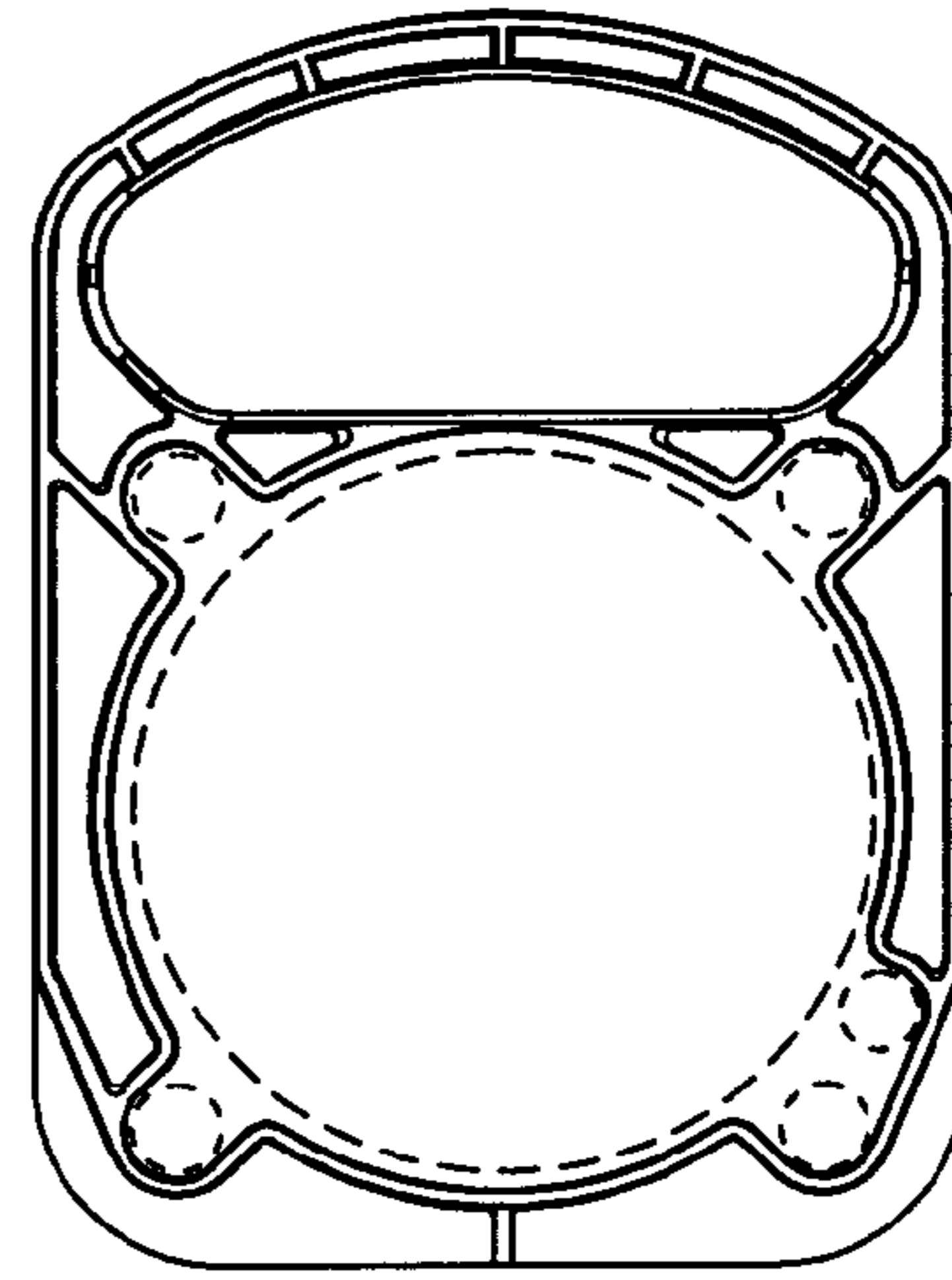

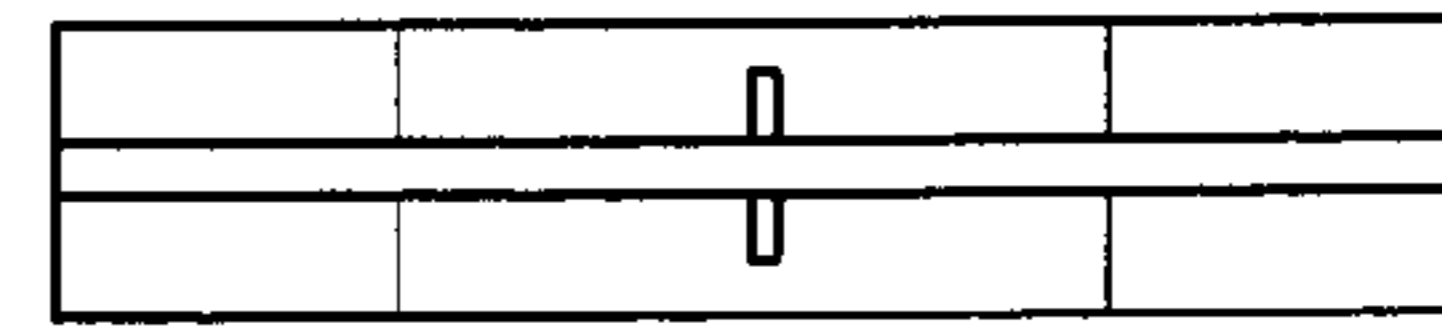

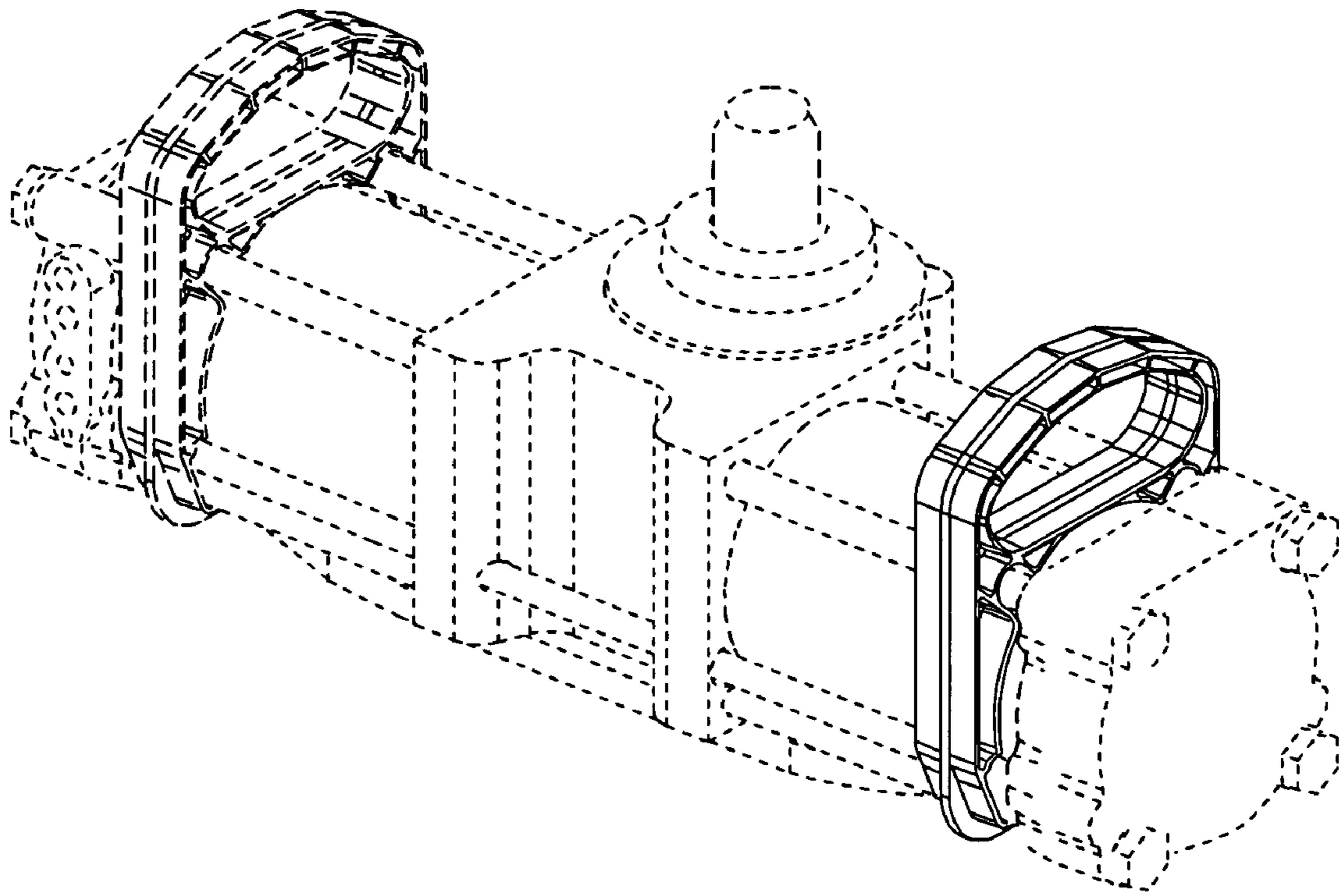
