(57) **CLAIM**

The ornamental design for a bottle hanging clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottle hanging clip coupled to a beverage bottle, with the beverage bottle shown in phantom lines;

FIG. 2 is a perspective view thereof;

FIG. 3 is a top plan view thereof, which is identical to the bottom plan view;

FIG. 4 is a front elevational view of the open end of the FIG. 2 clip;

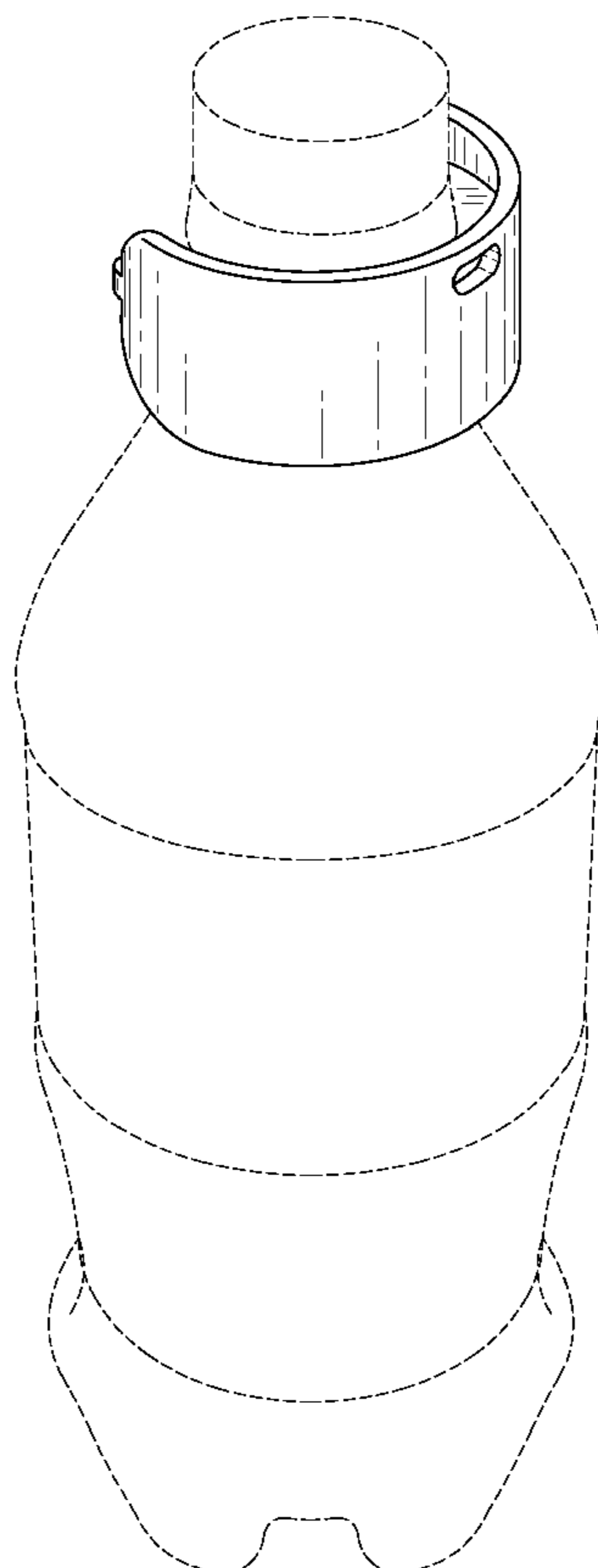
FIG. 5 is a rear elevational view of the FIG. 2 clip;

FIG. 6 is a right side elevational view the FIG. 2 clip; and,

FIG. 7 is a left side elevational view of the FIG. 2 clip.

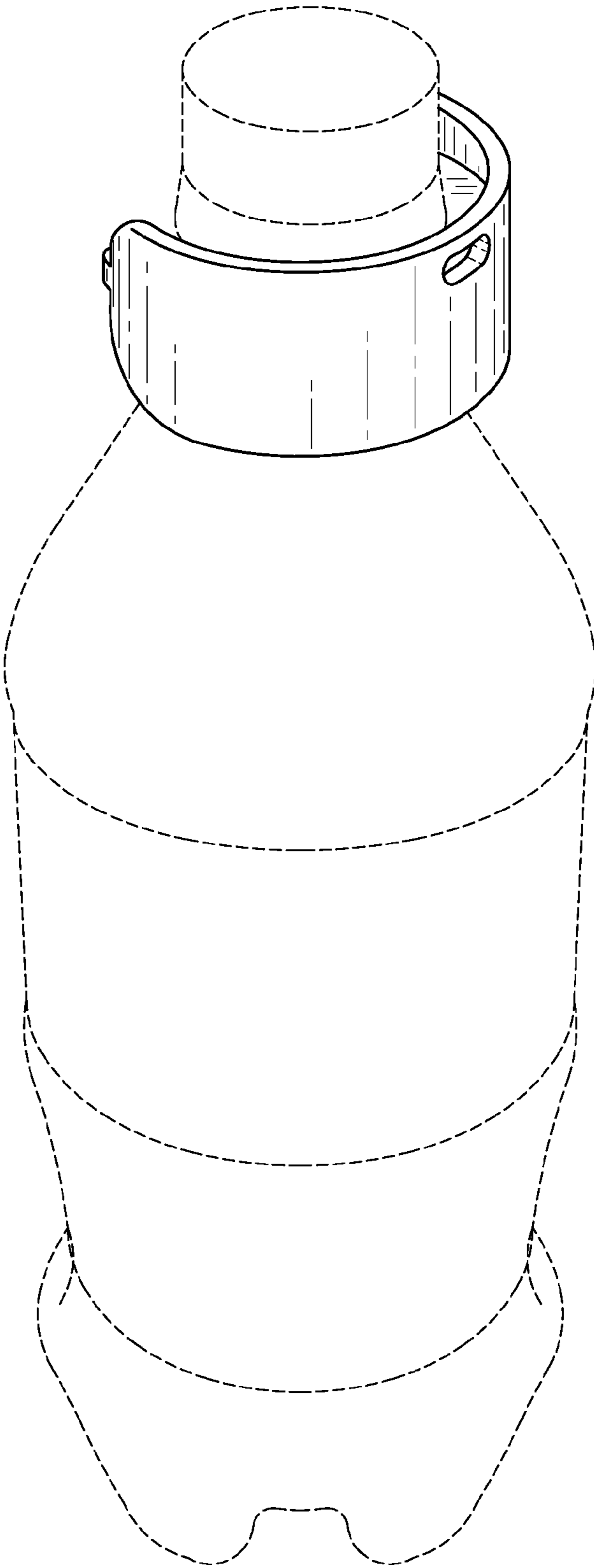

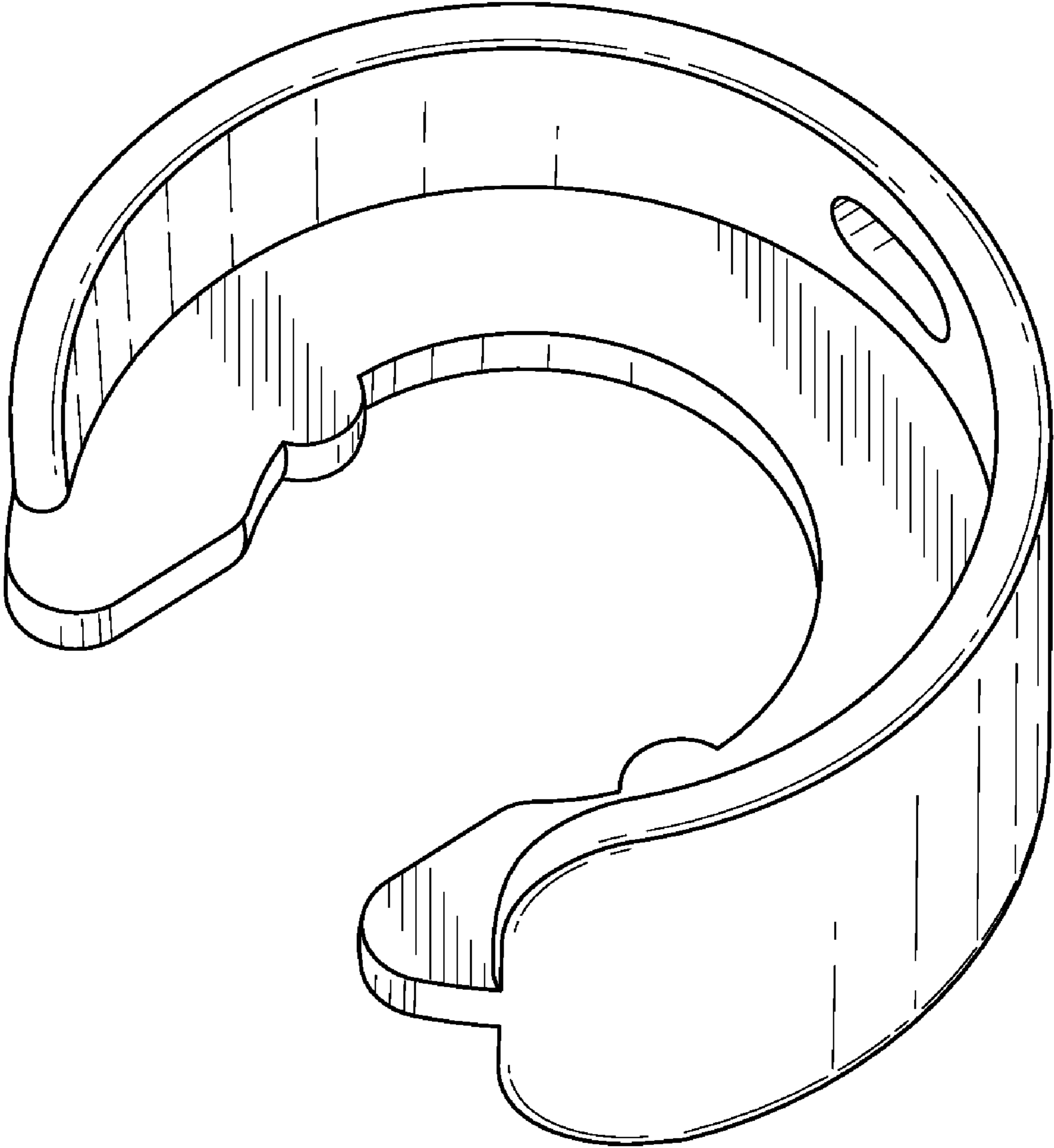

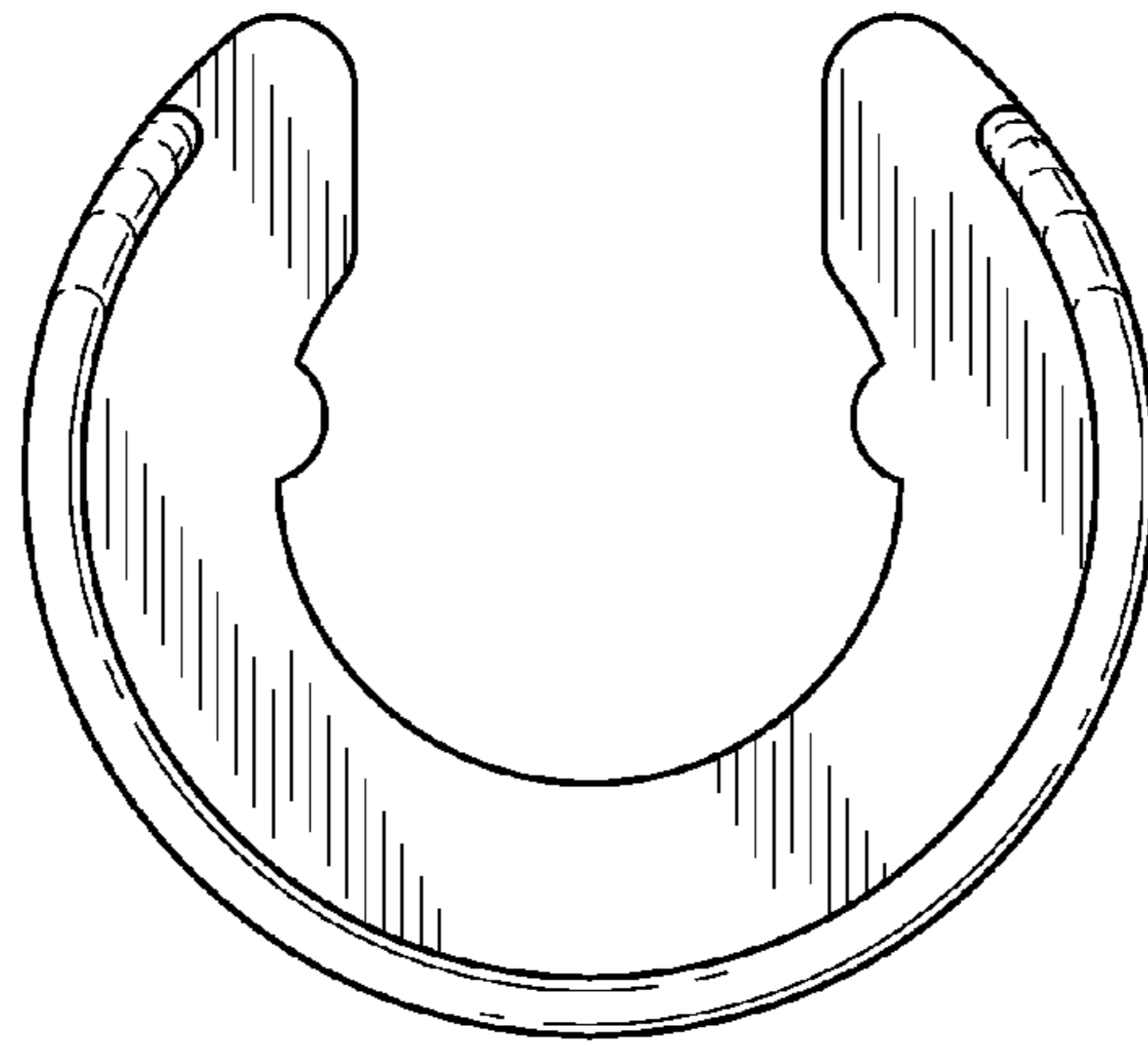

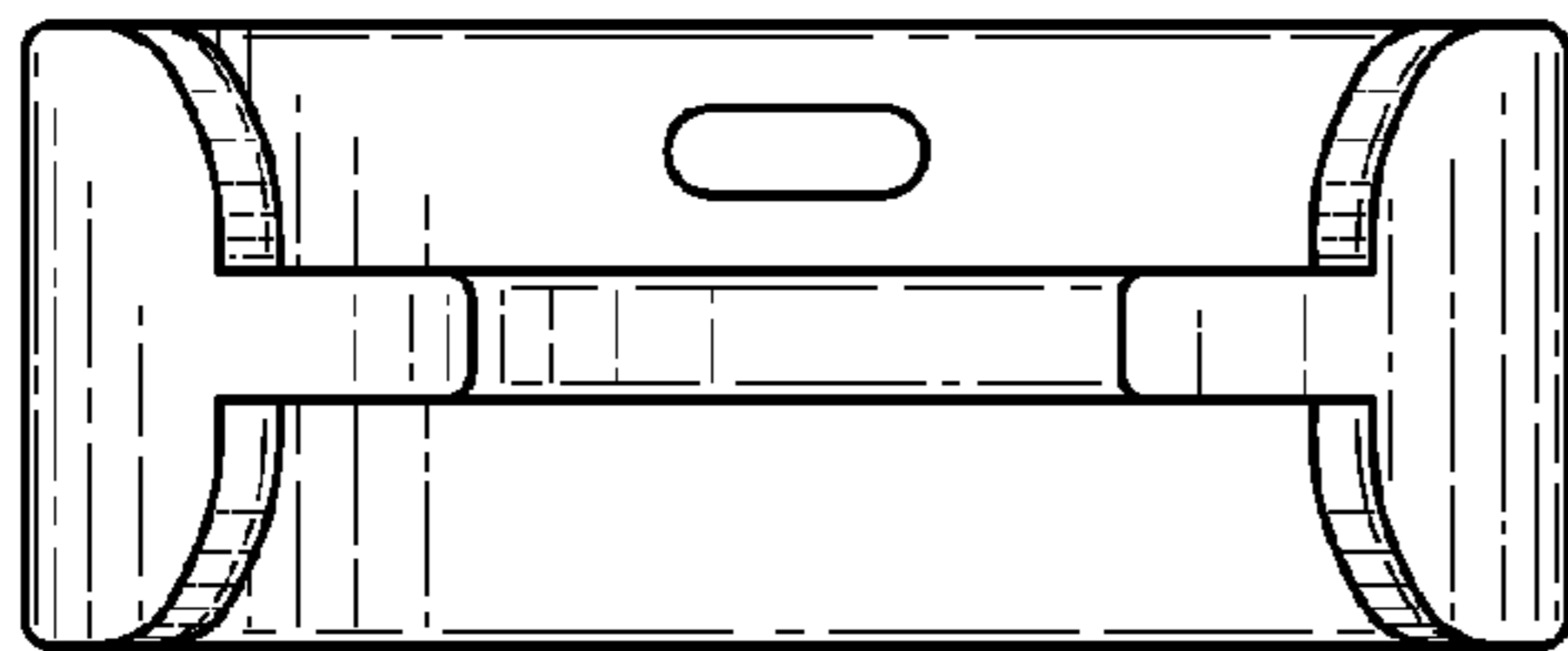

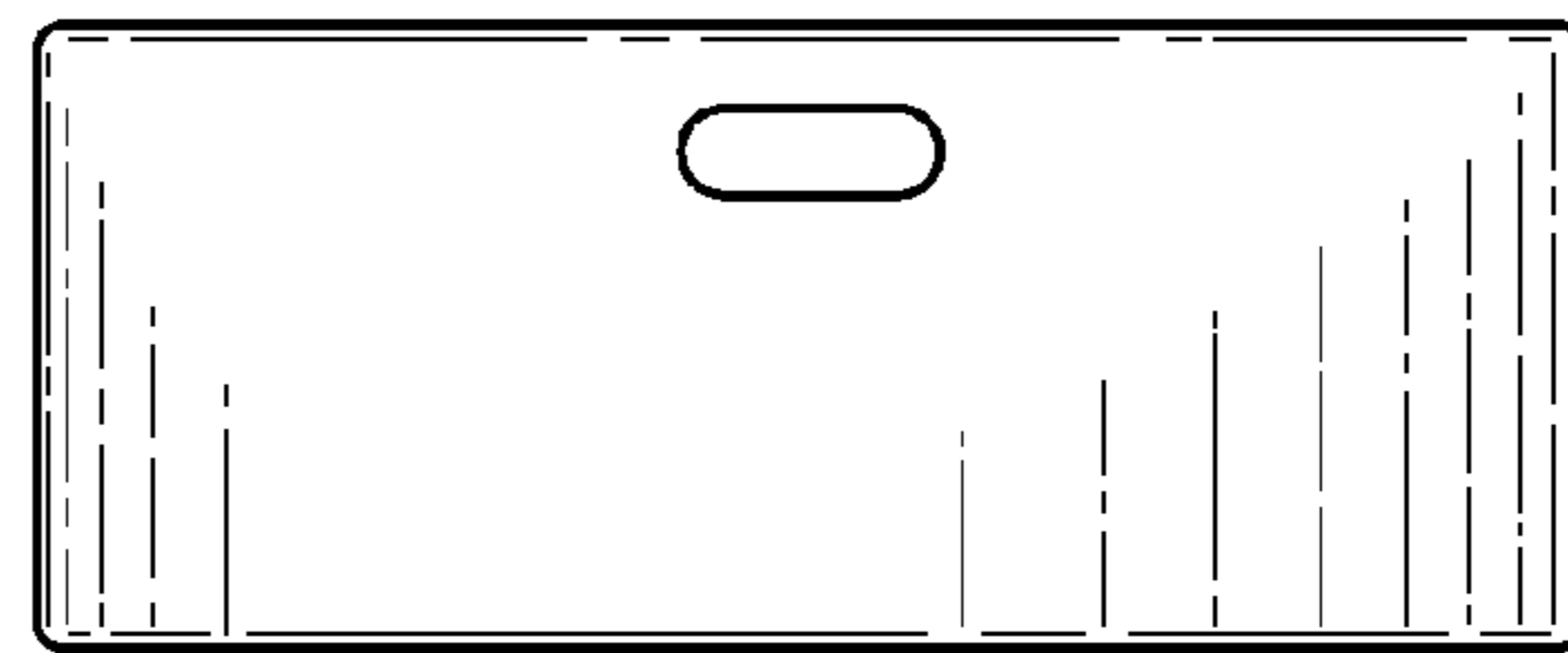

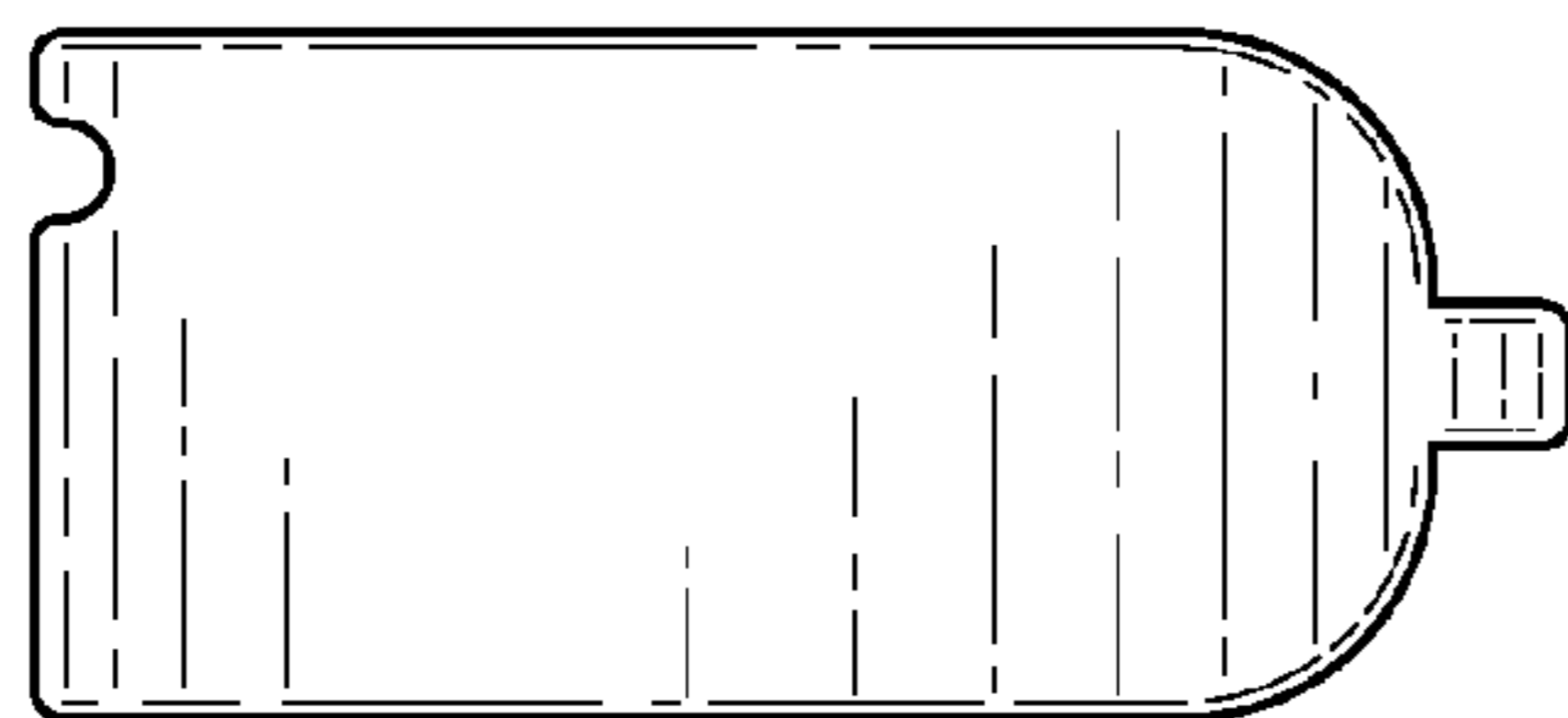

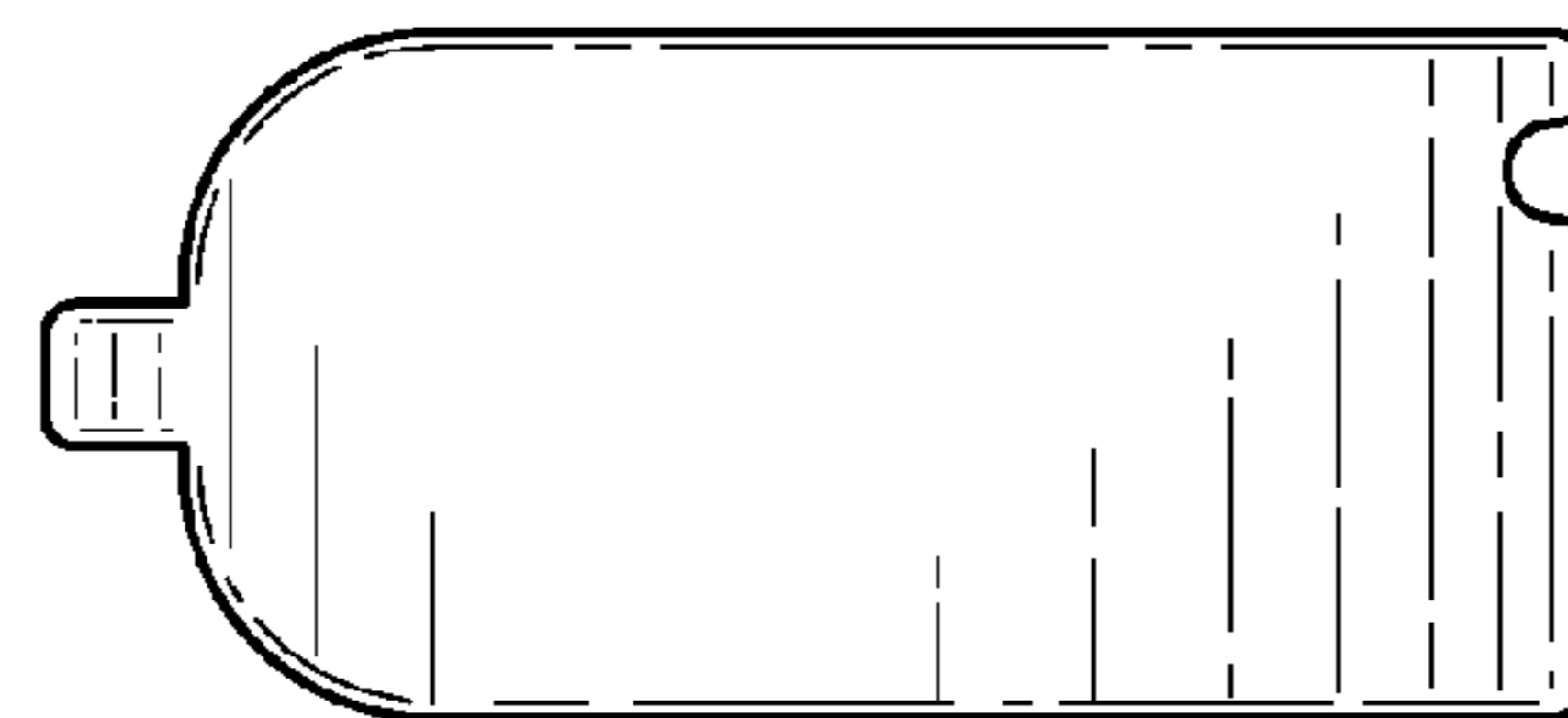
