FIG. 1 is a front/right side perspective view of a vehicle instrument panel showing our new design;

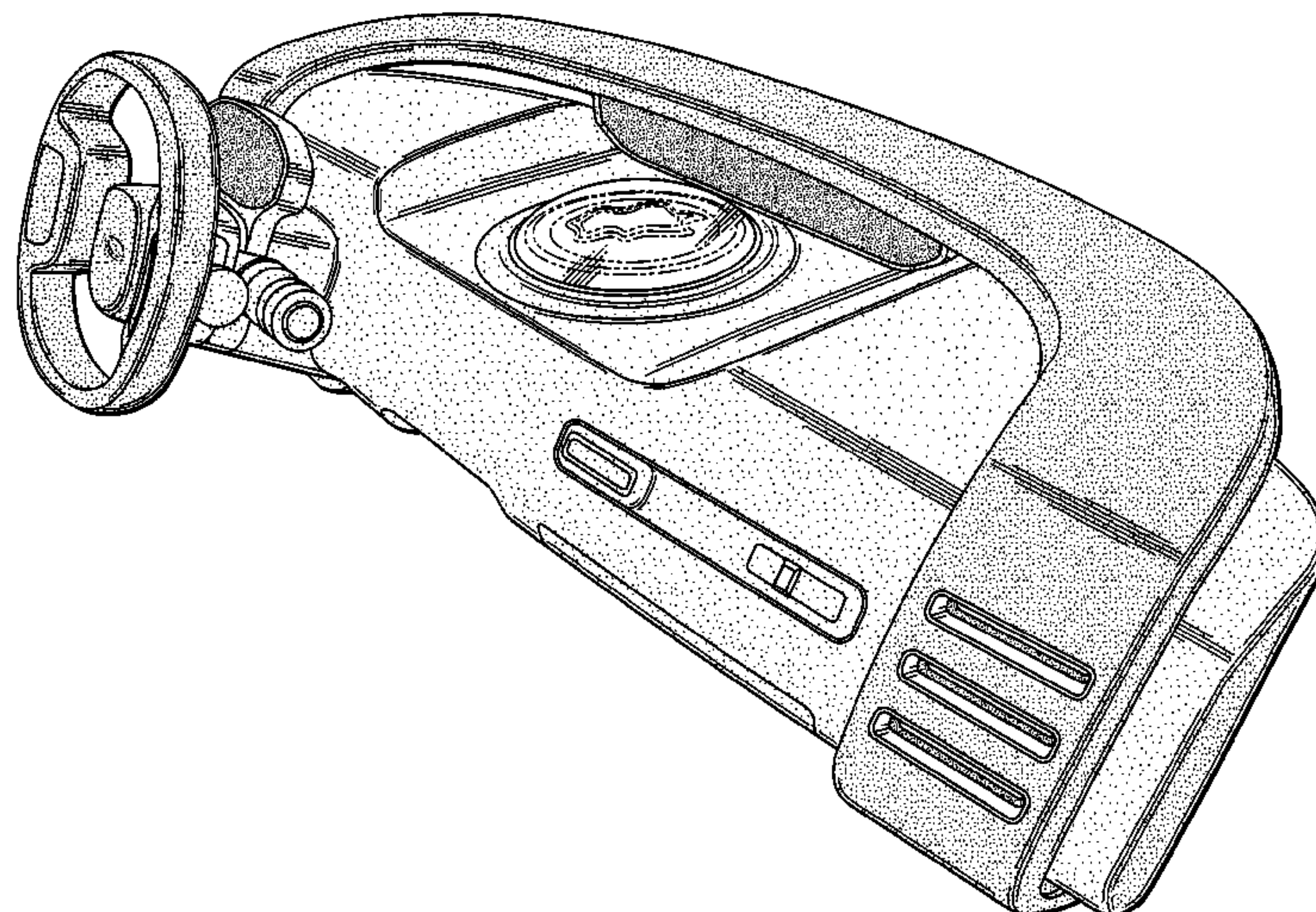
FIG. 2 is a front/left side perspective view thereof;

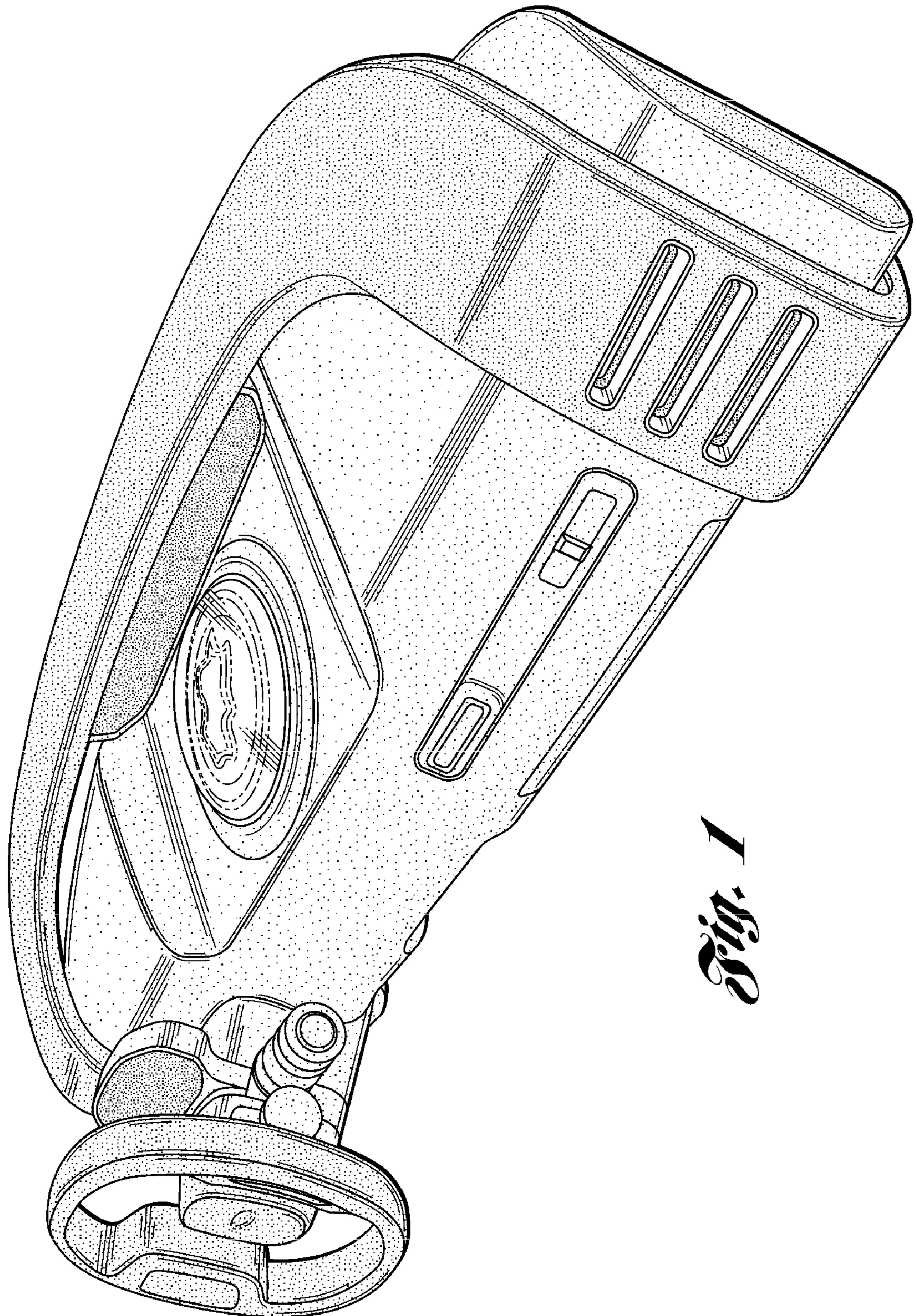

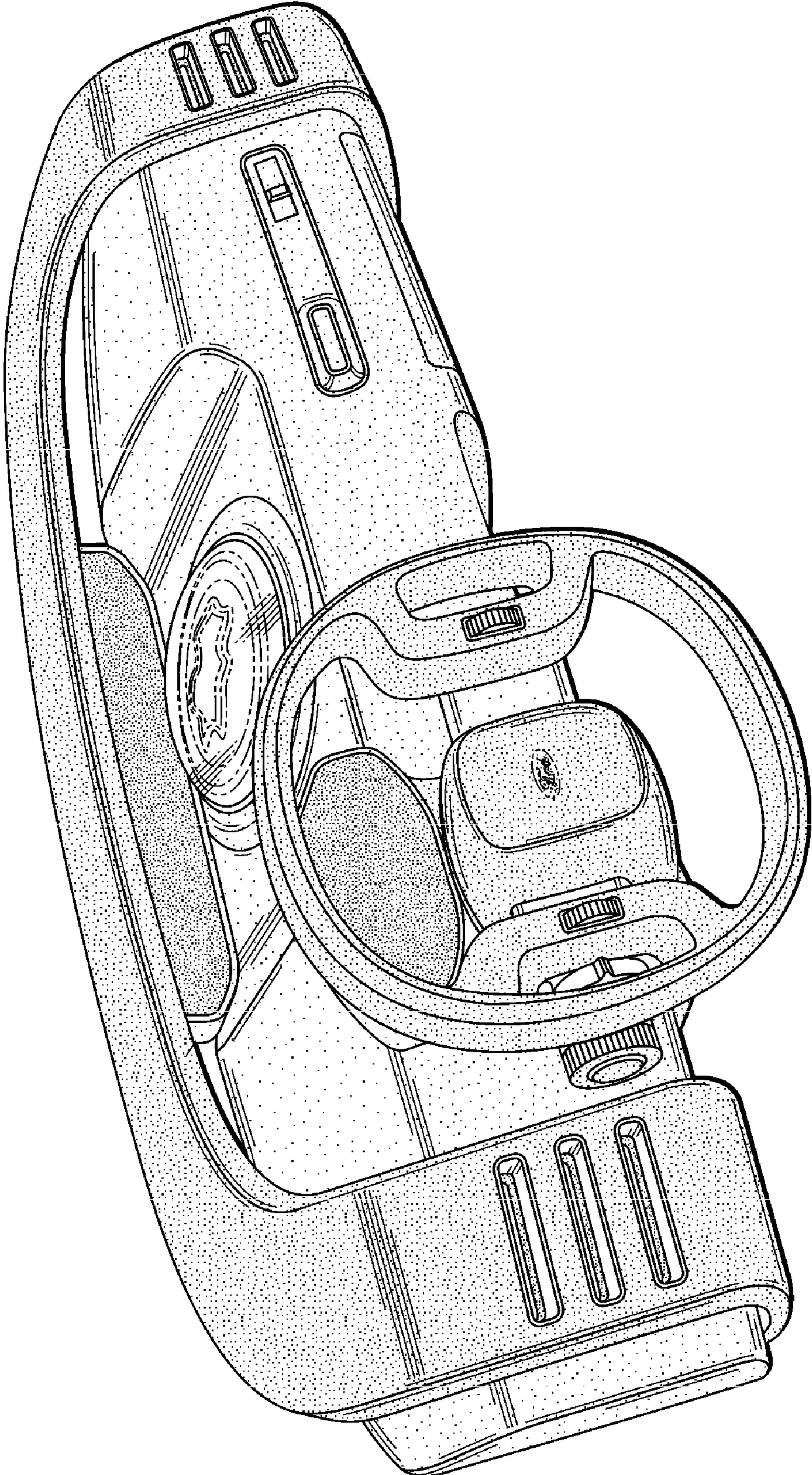

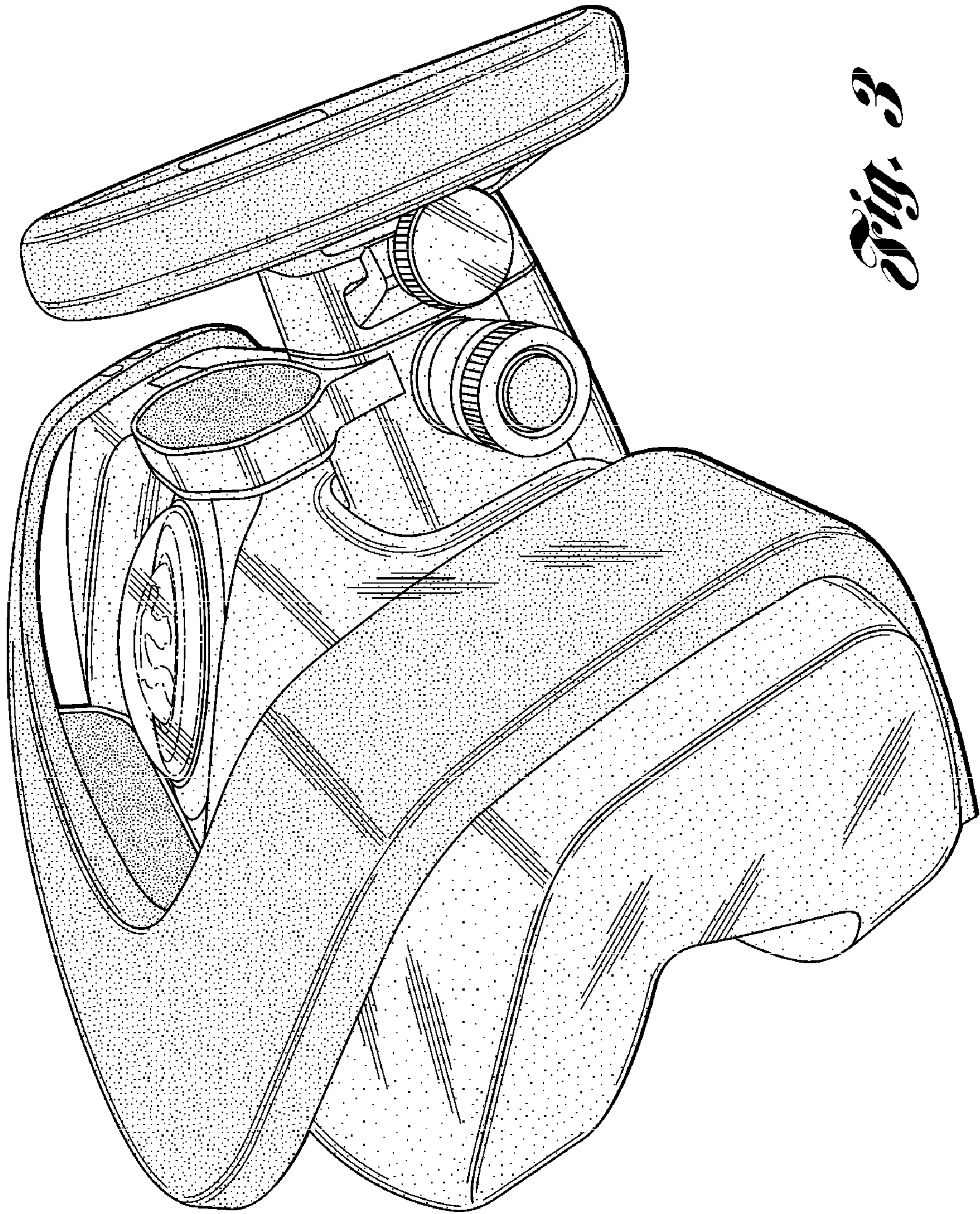

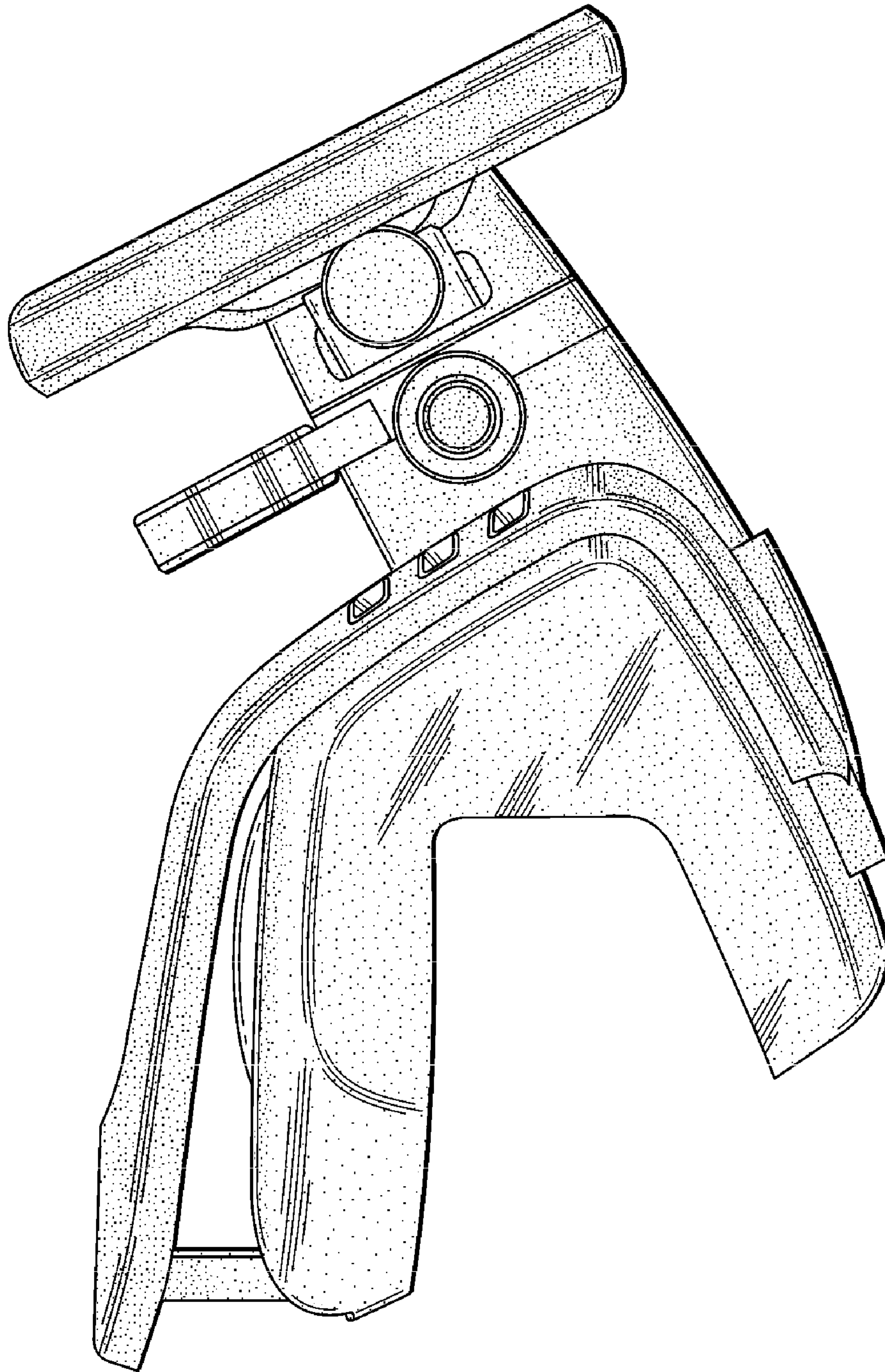
