**DESCRIPTION**

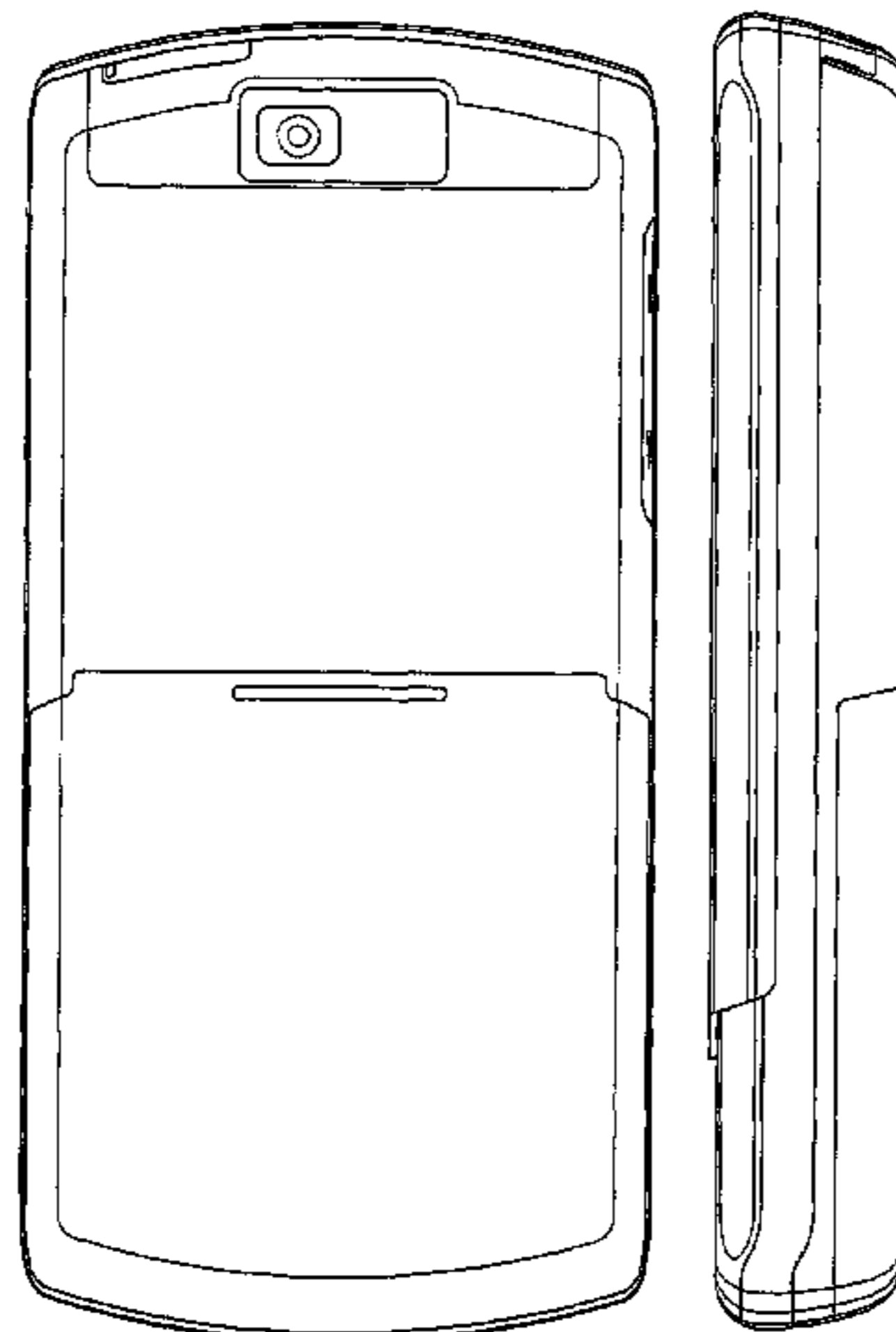

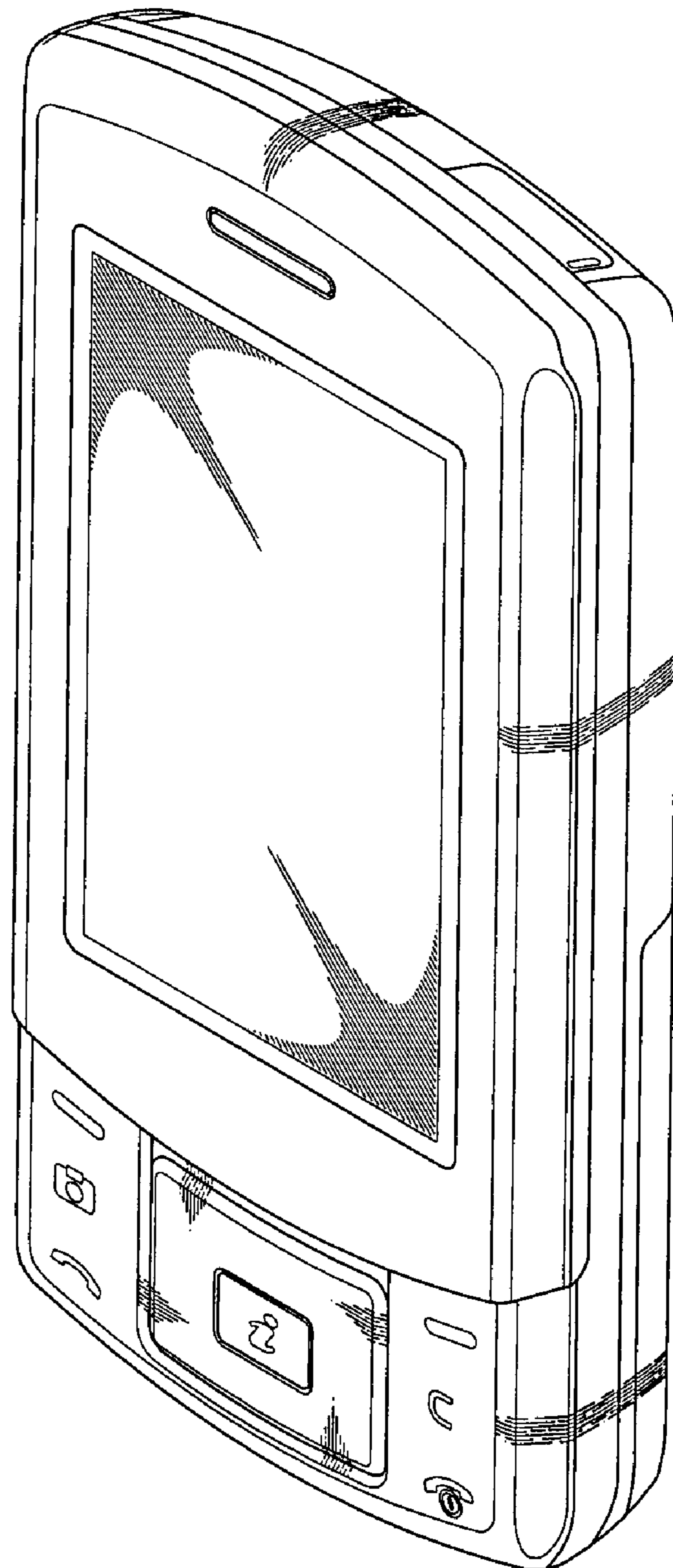

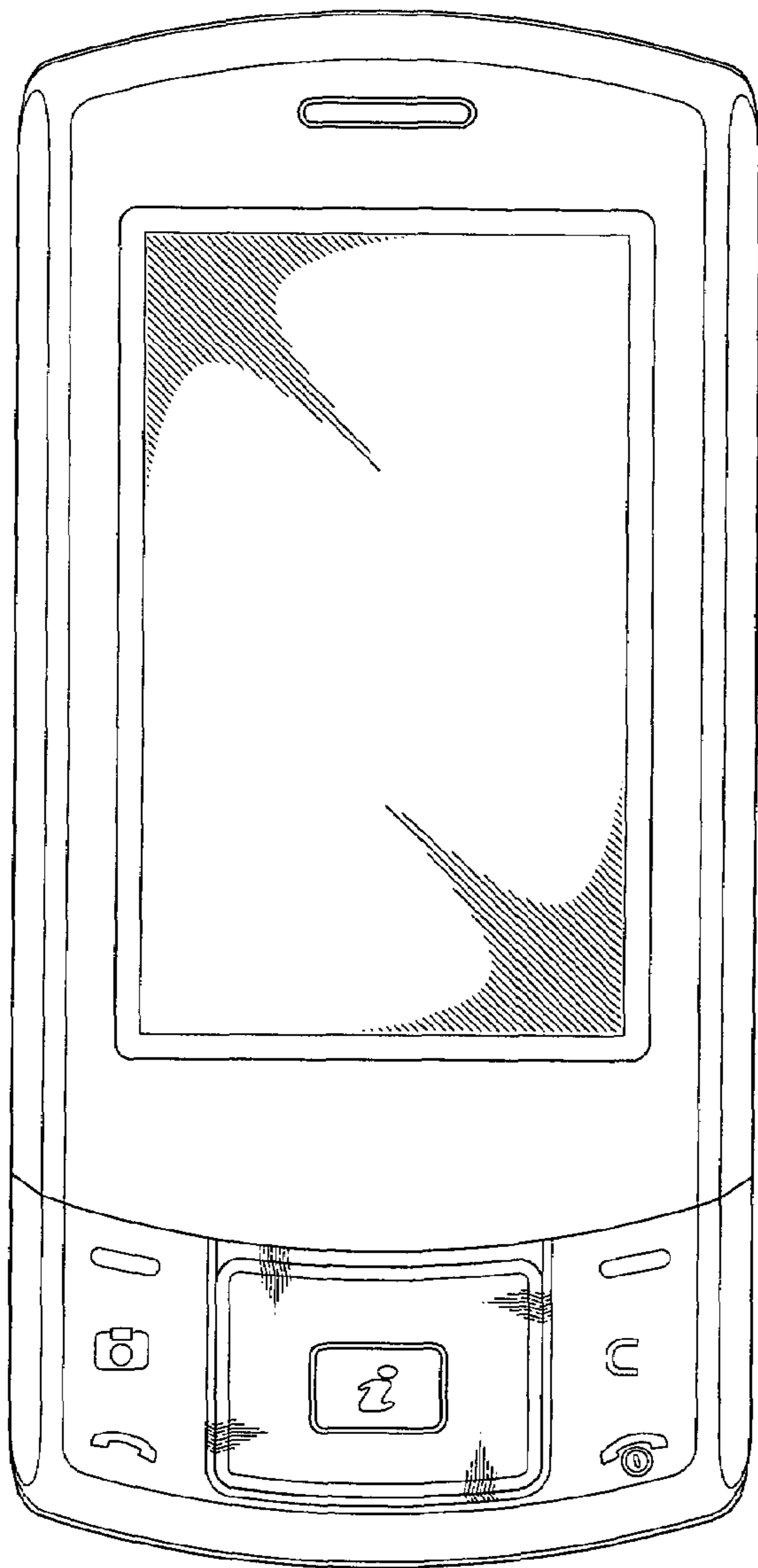

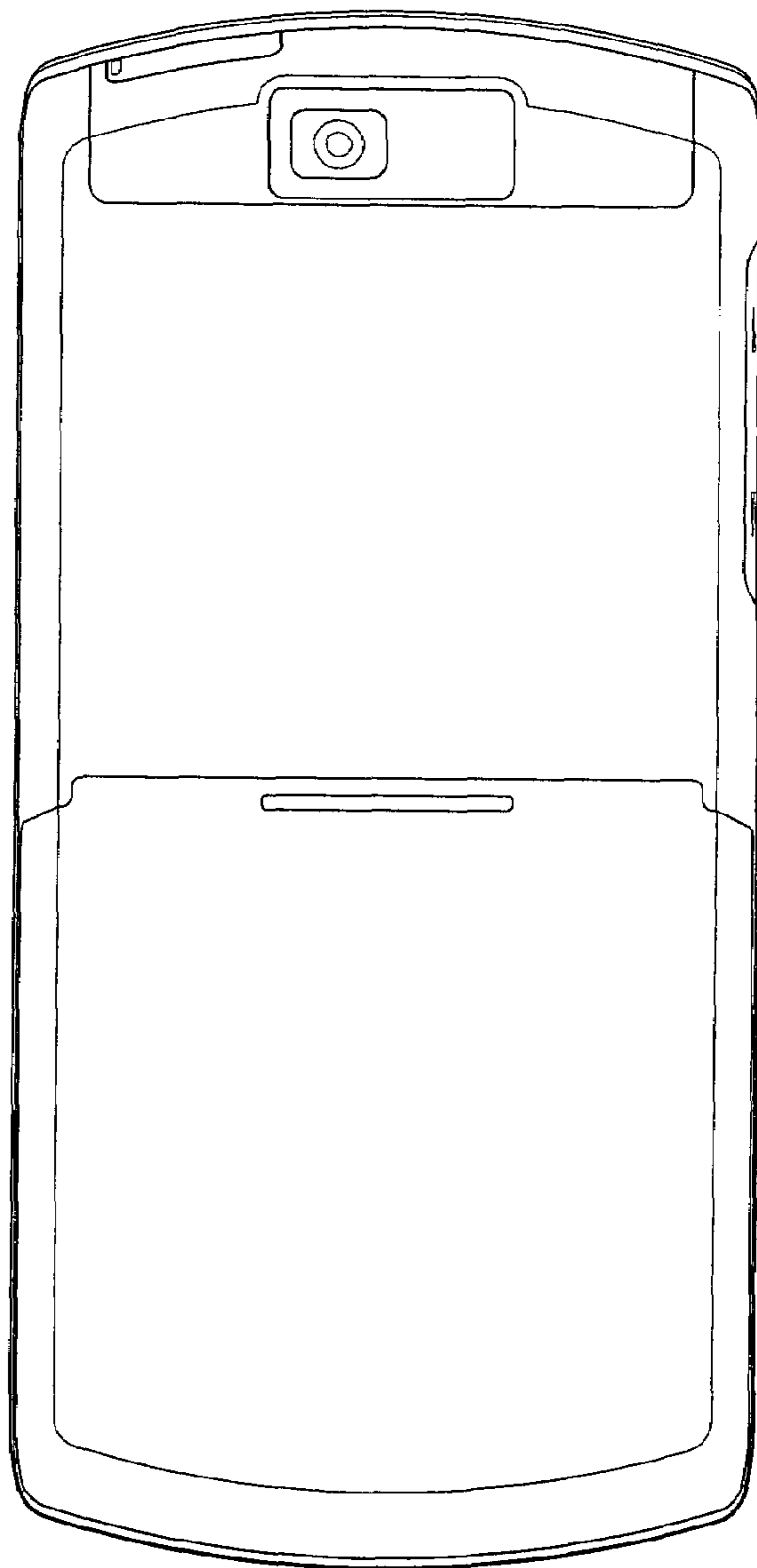

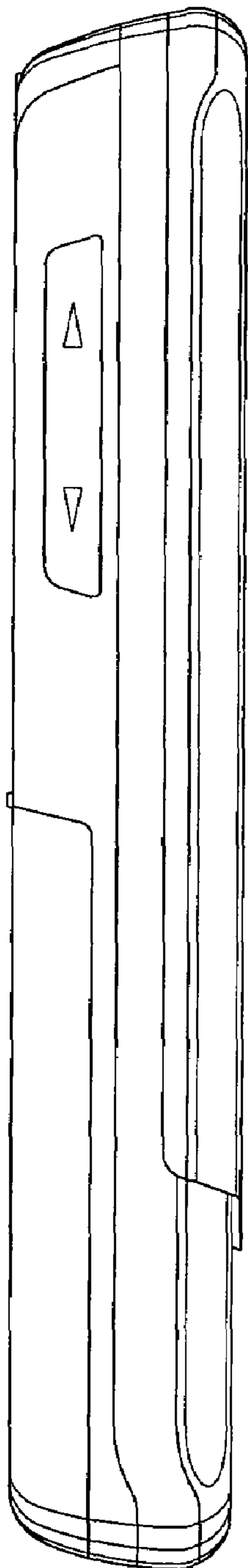

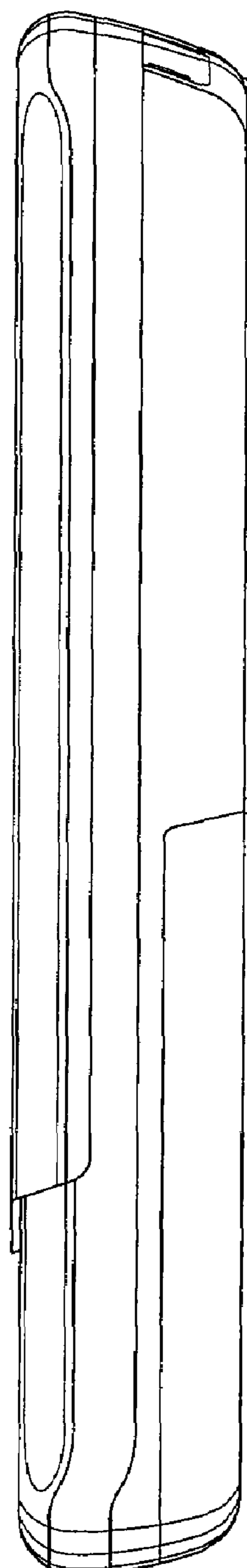

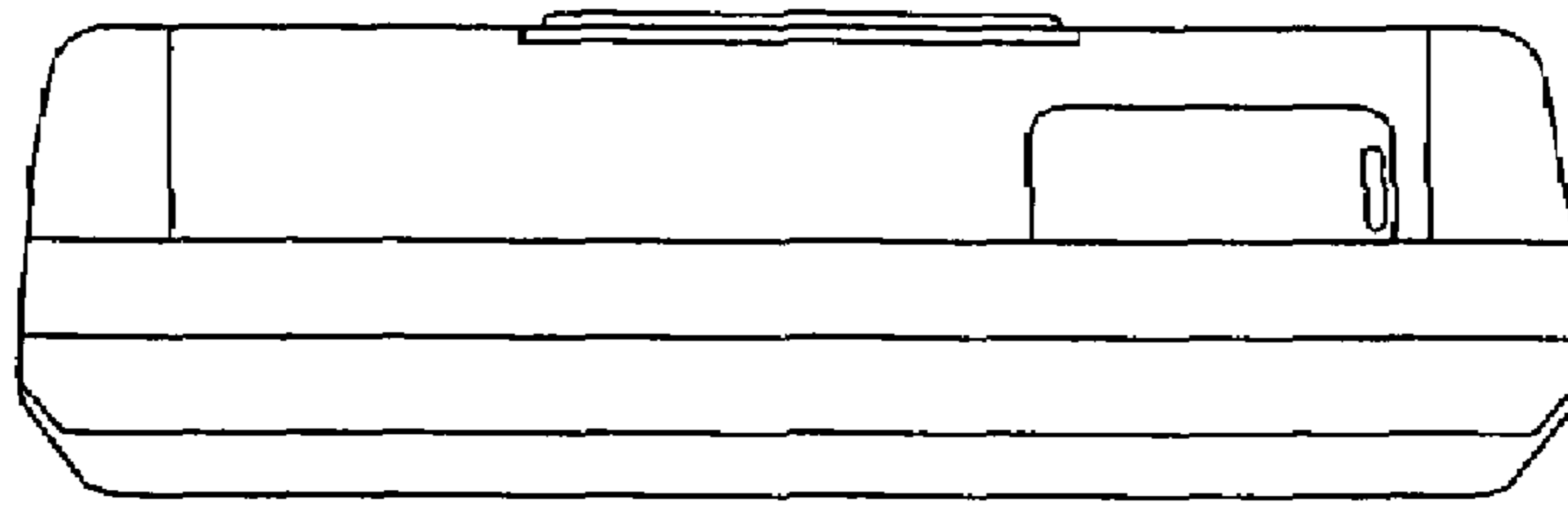

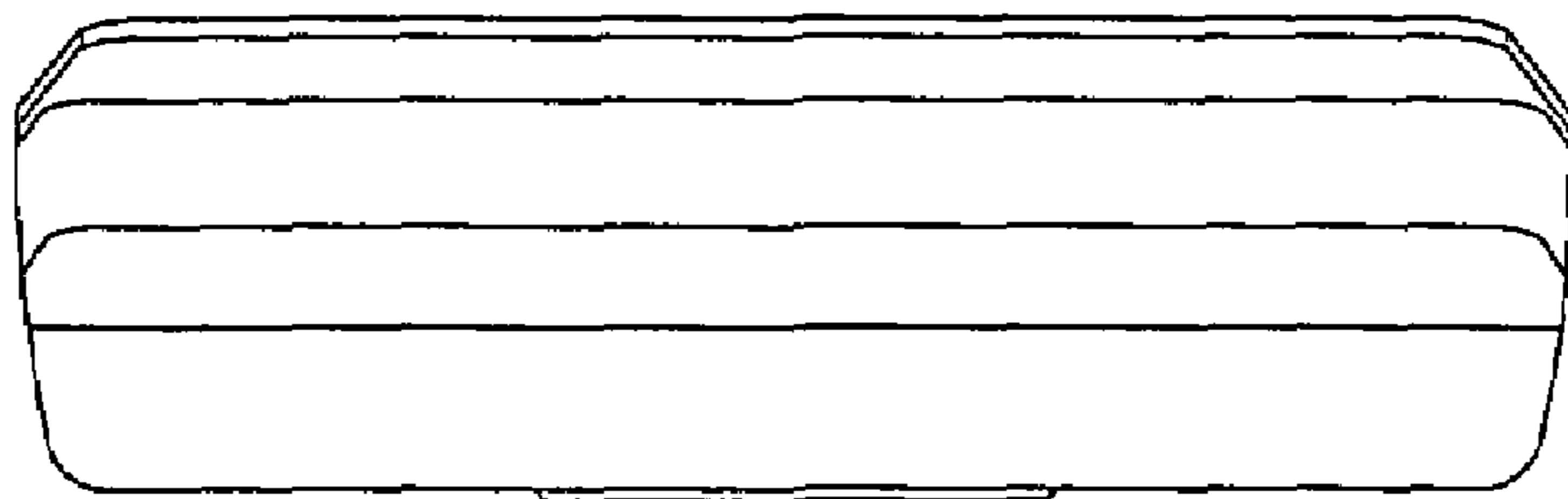

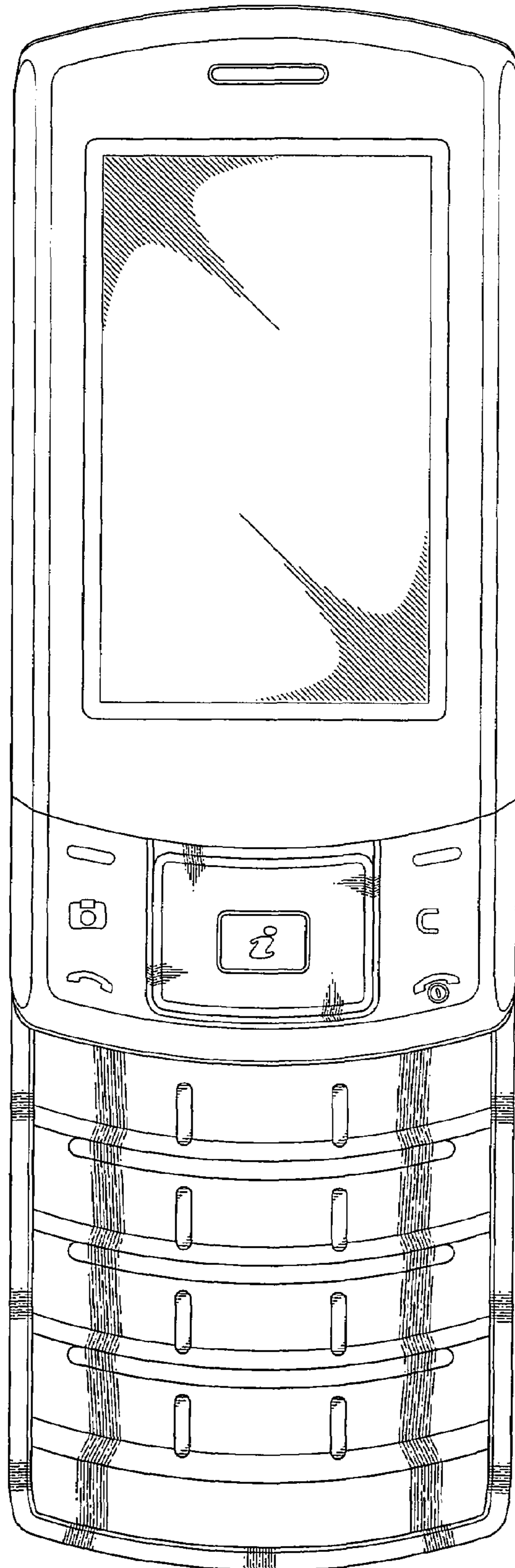
