FIG. 4 is a Left Side view thereof; and

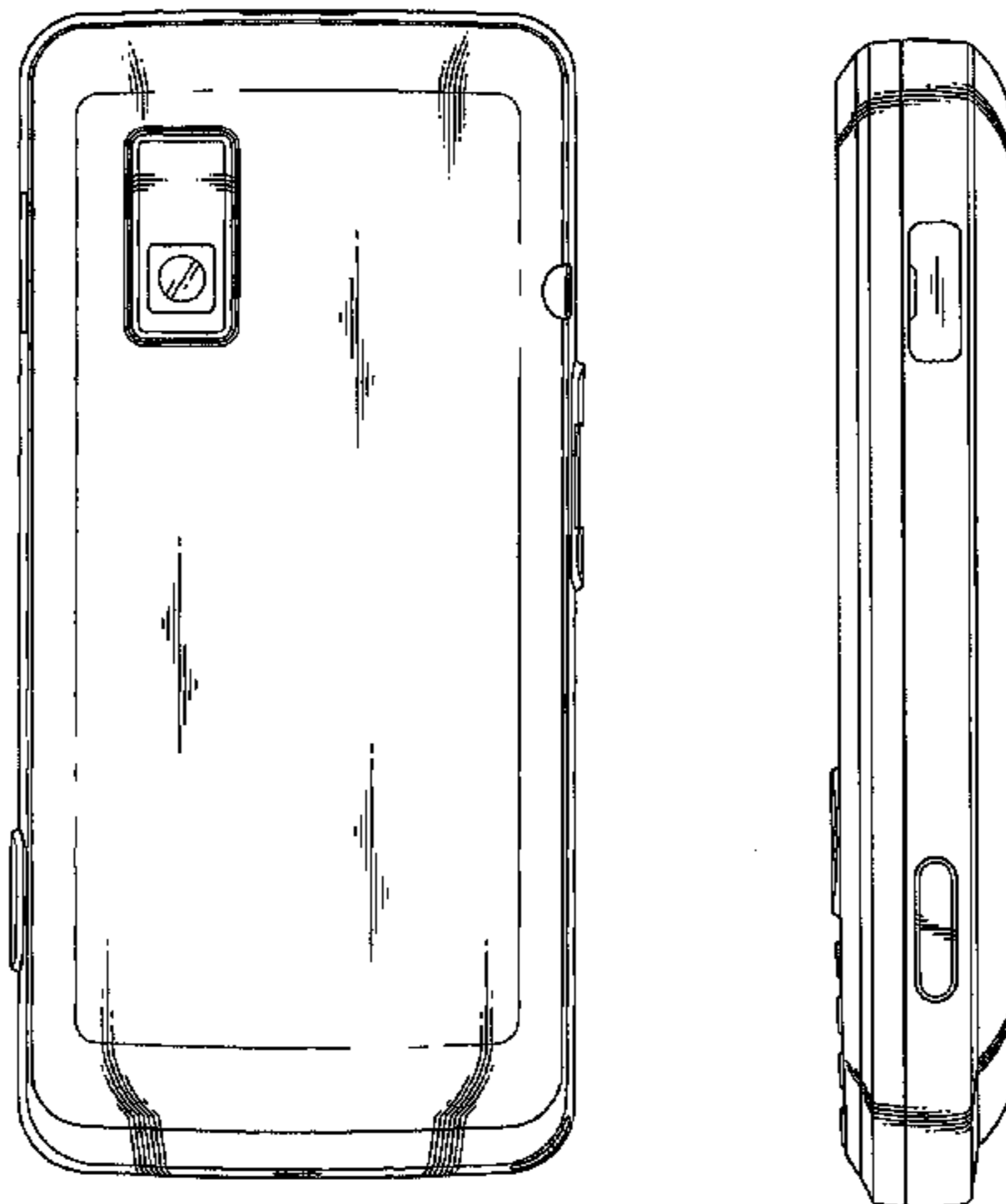
FIG. 5 is a Right Side view thereof.

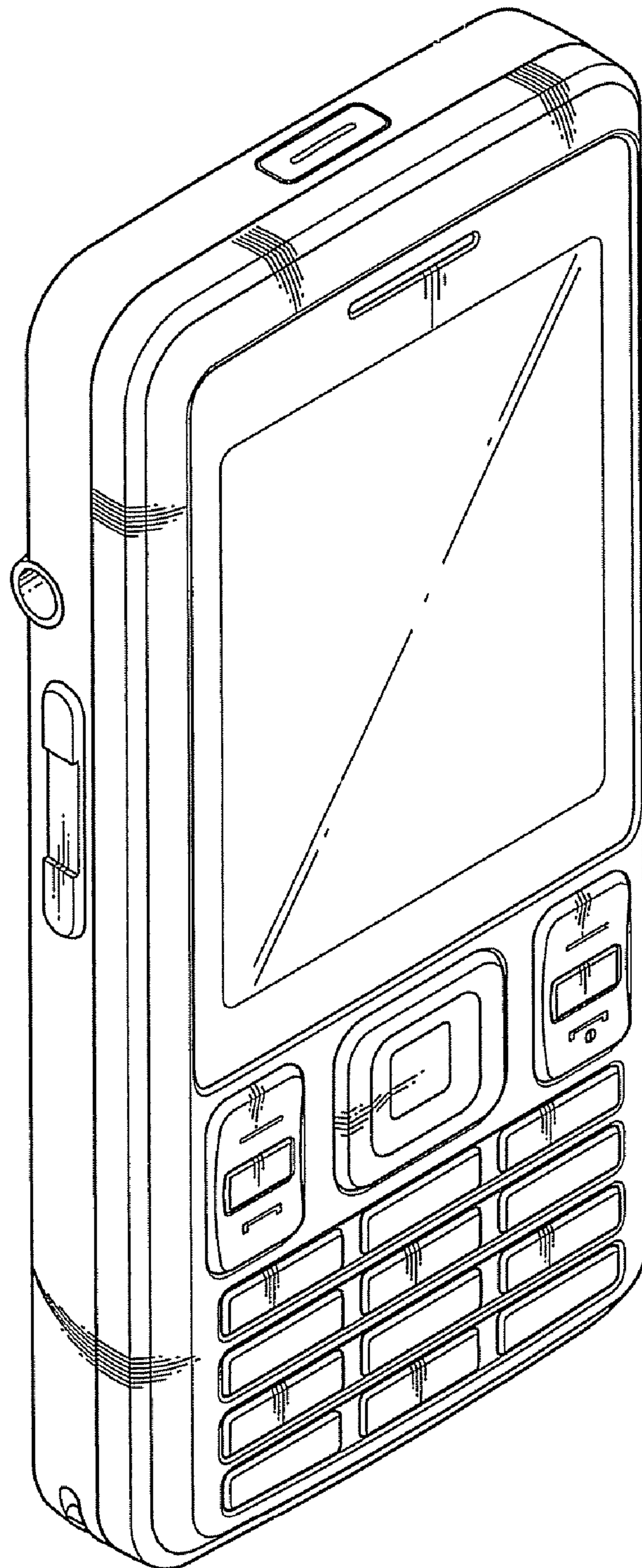

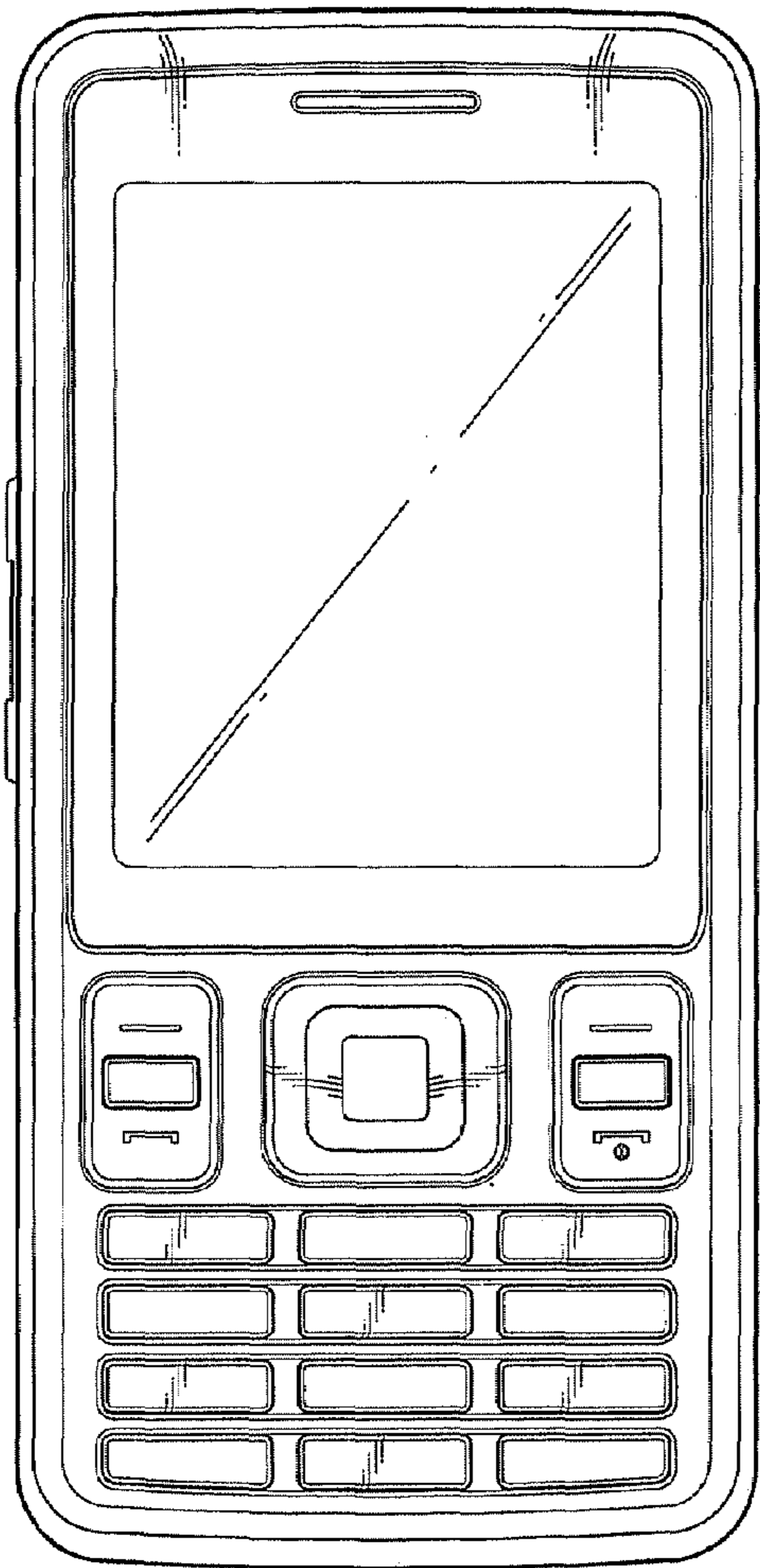

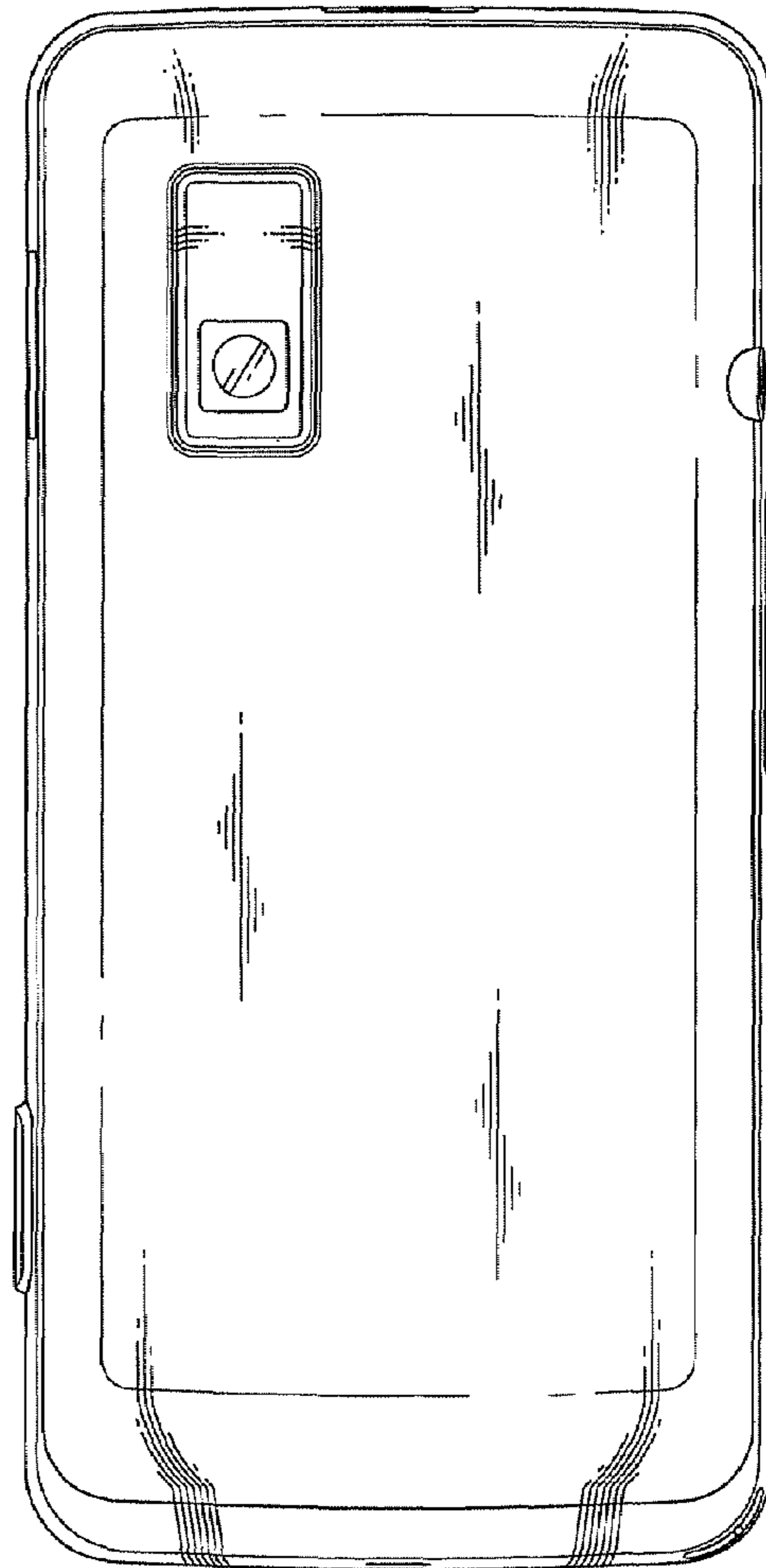

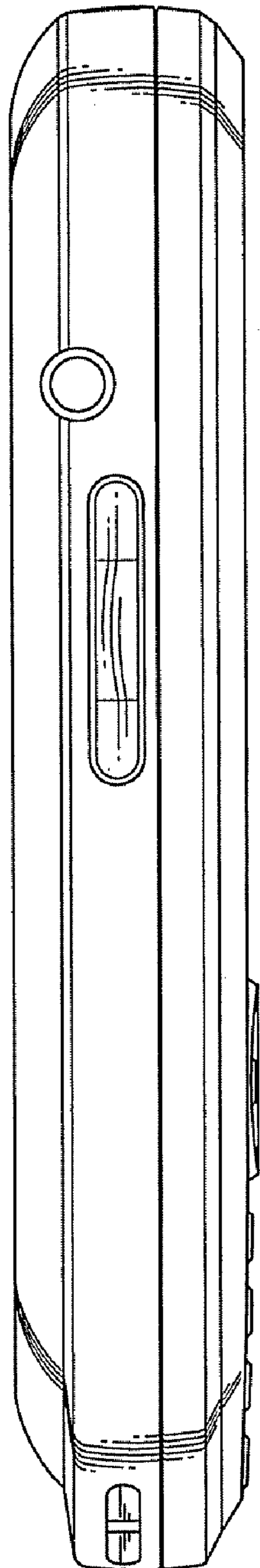

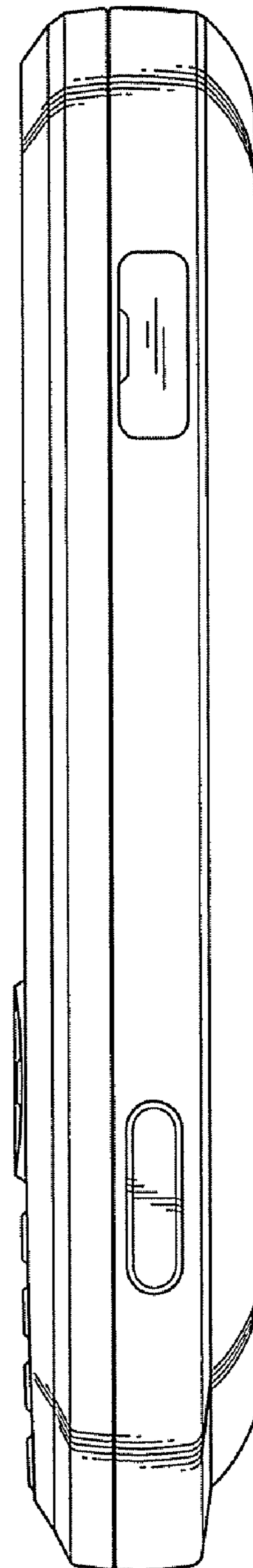

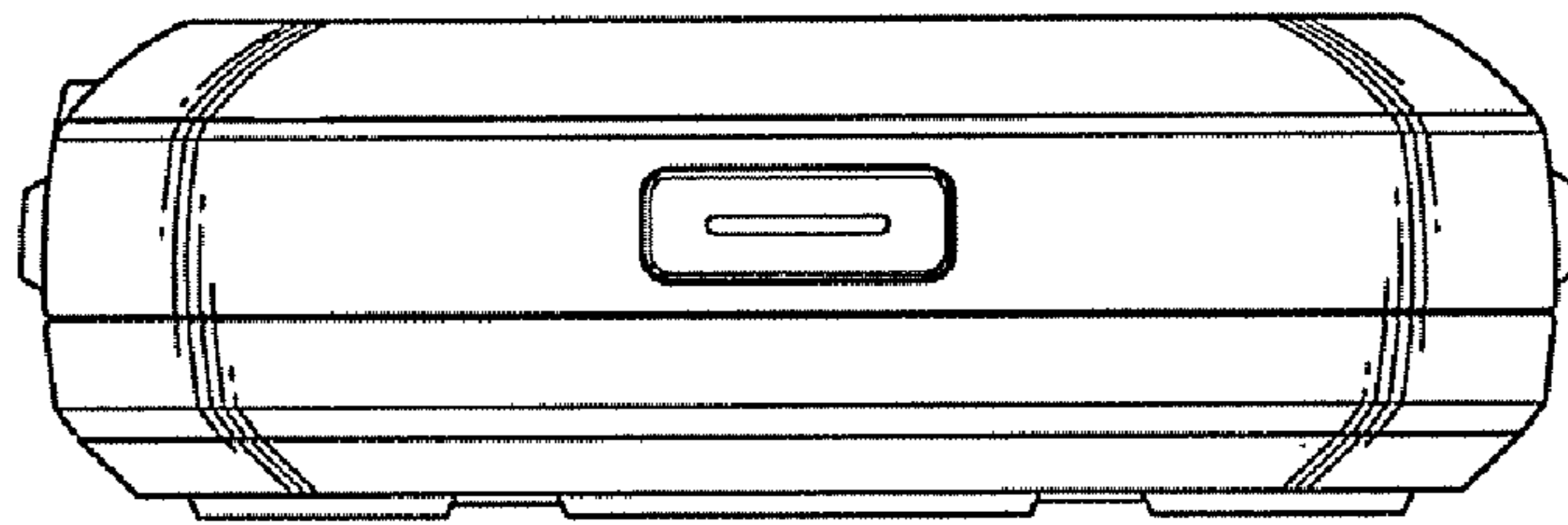

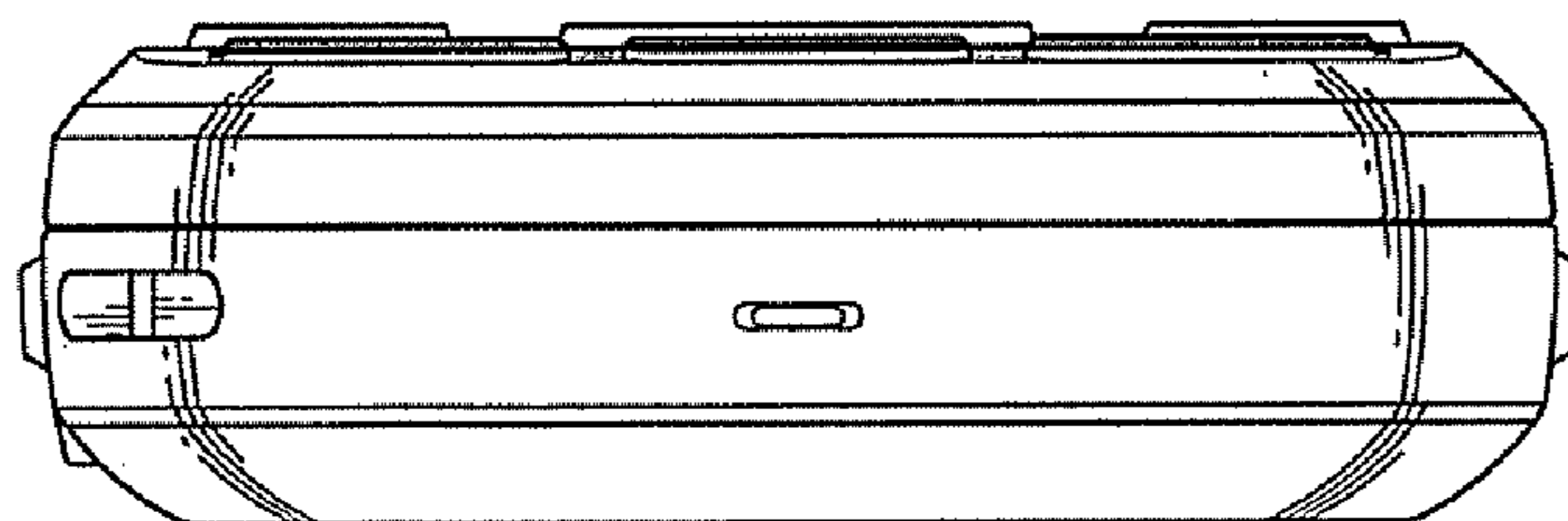
