The broken lines showing the keyboard are for the purpose of illustrating the article and form no part of the claimed design.

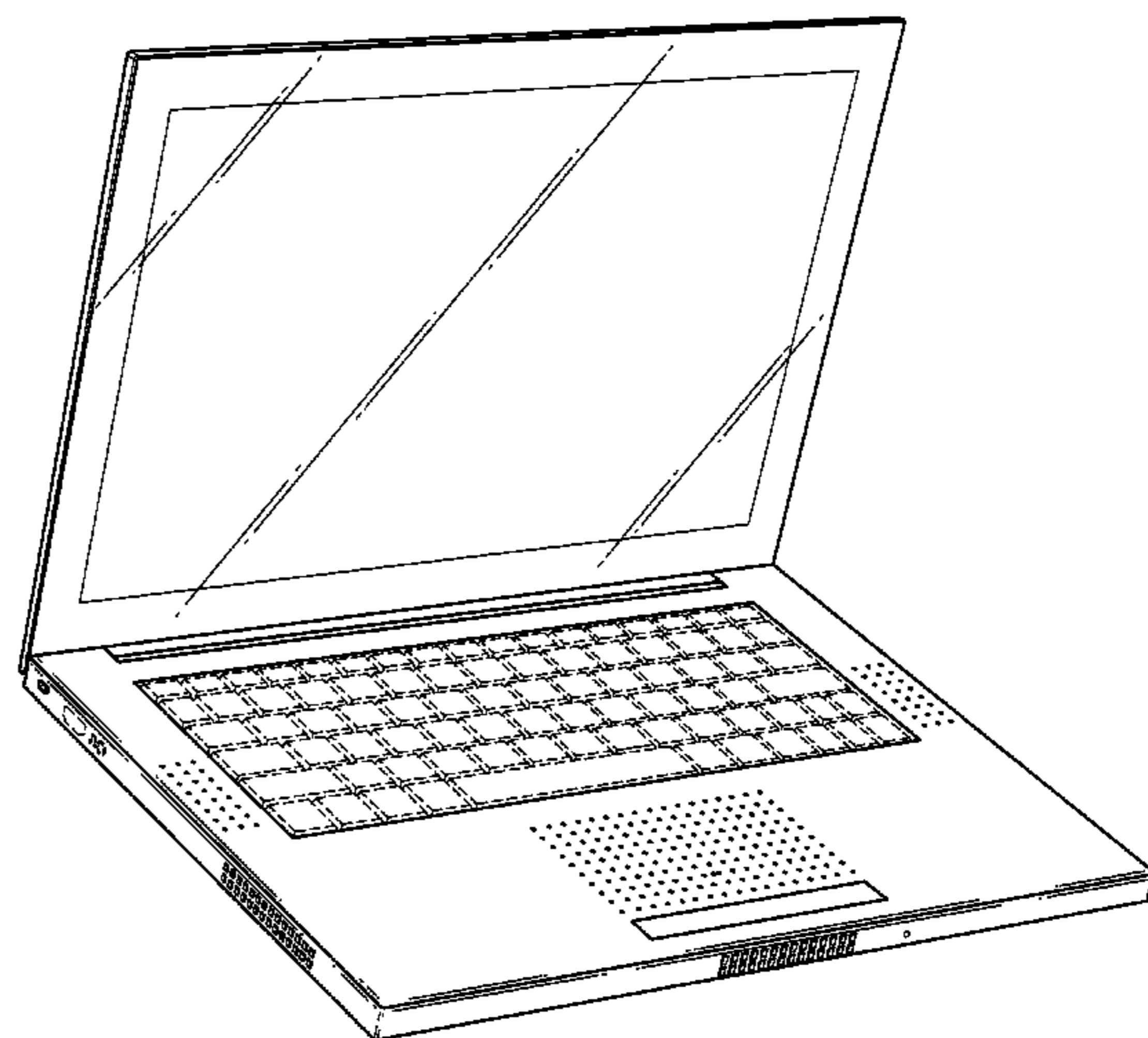
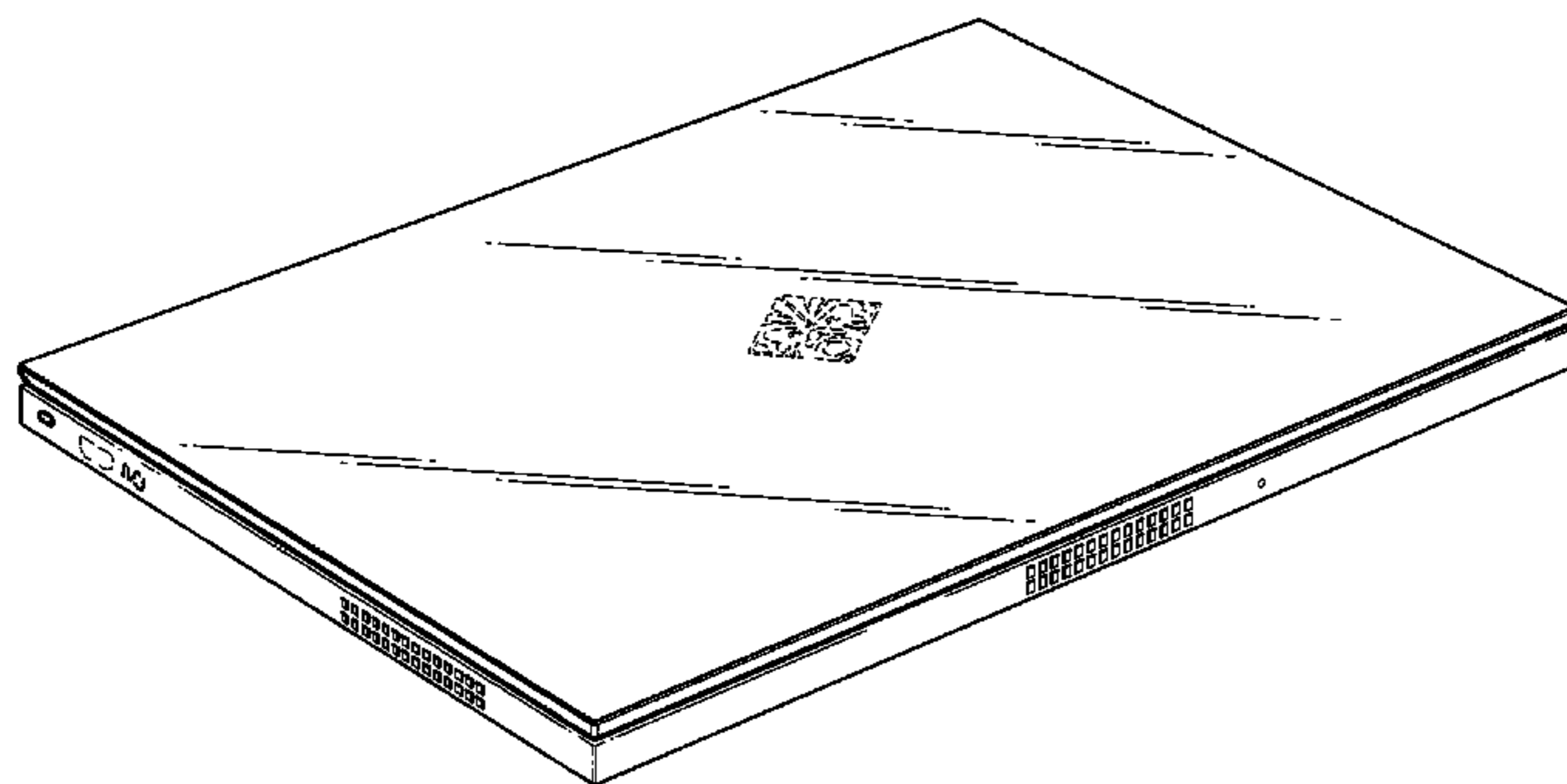

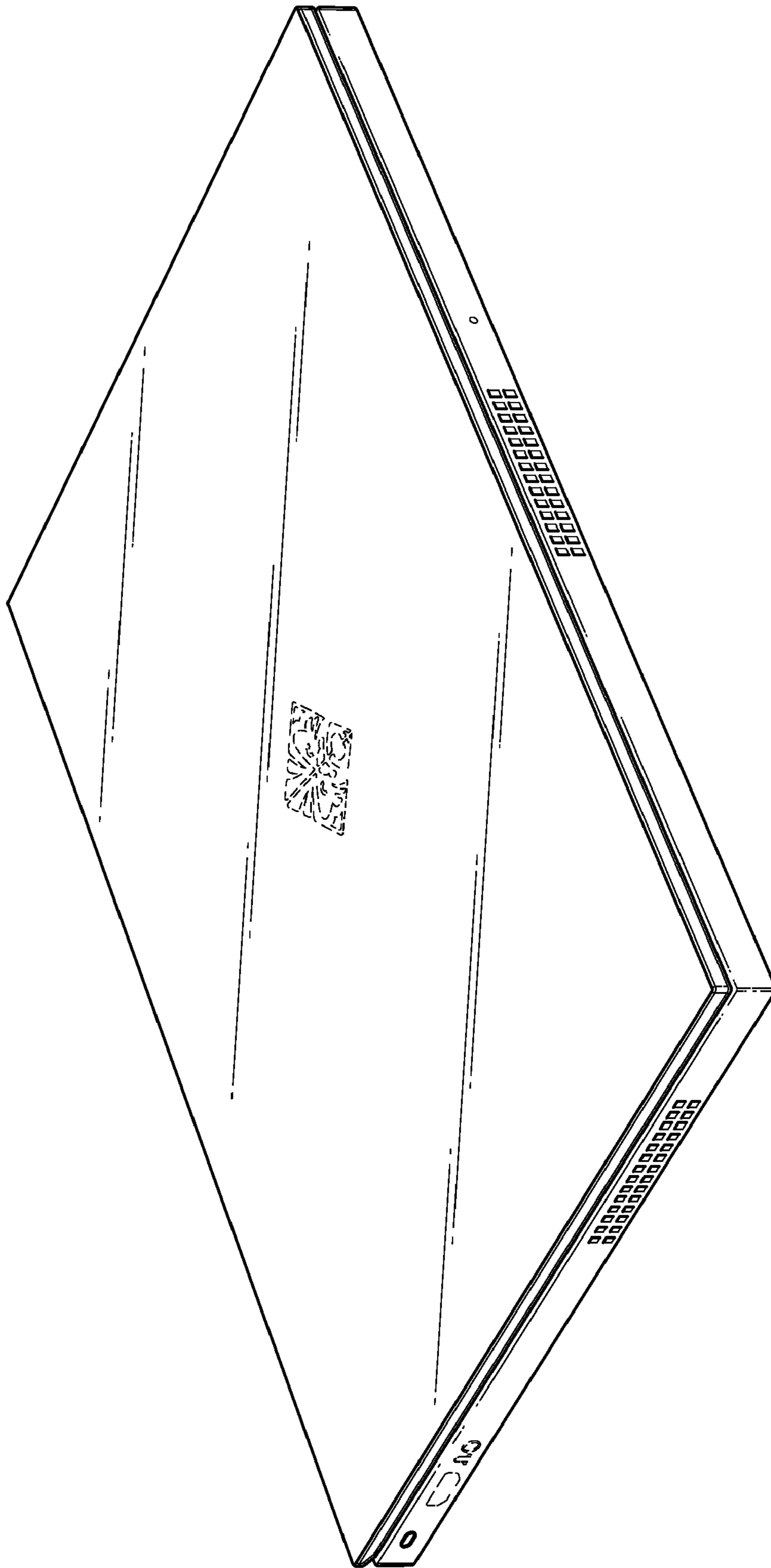

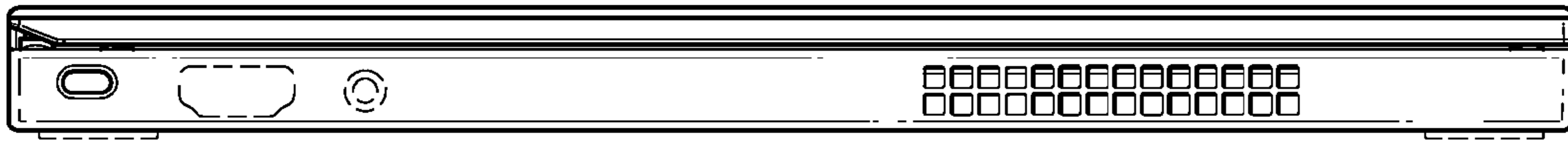

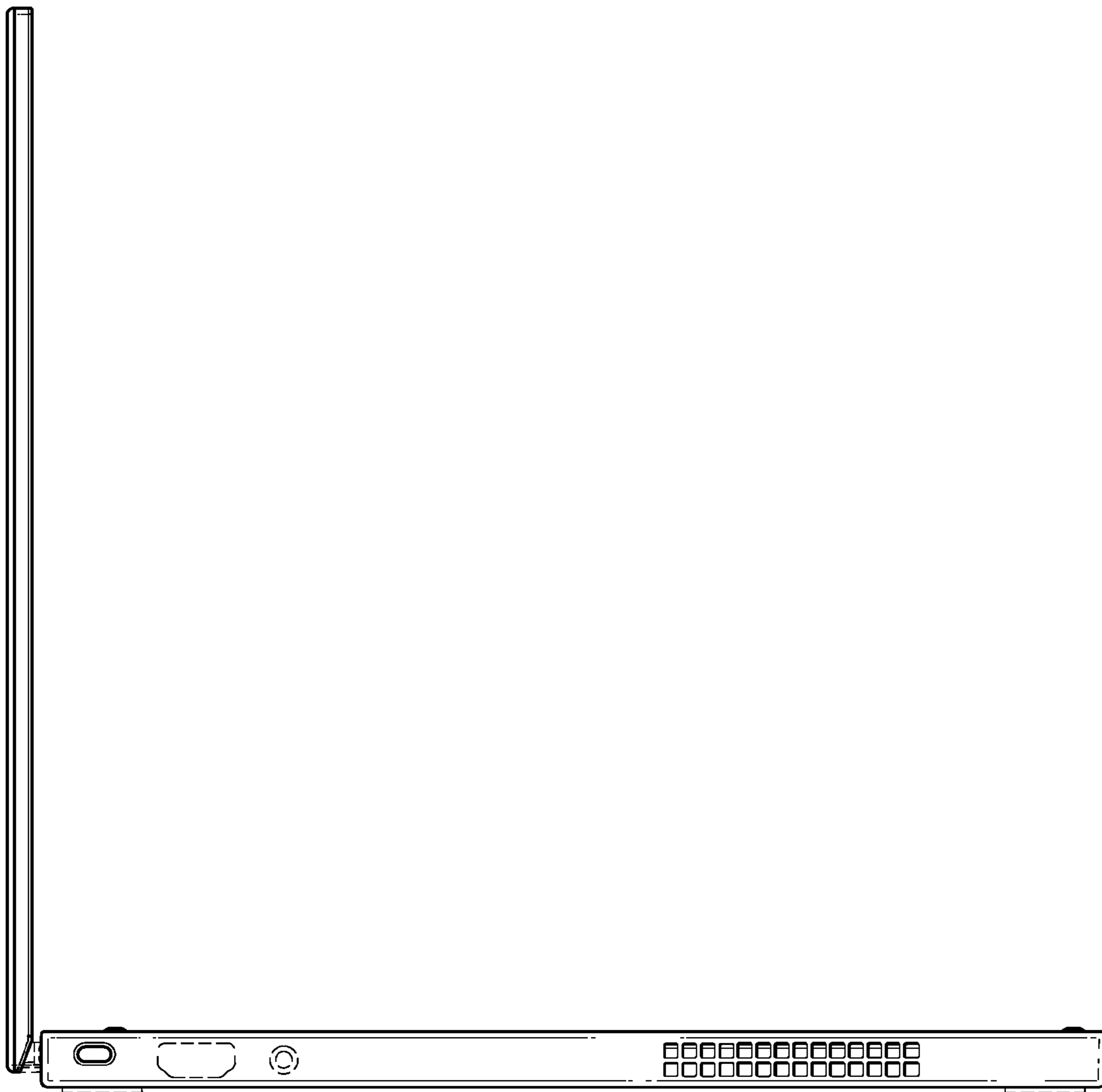

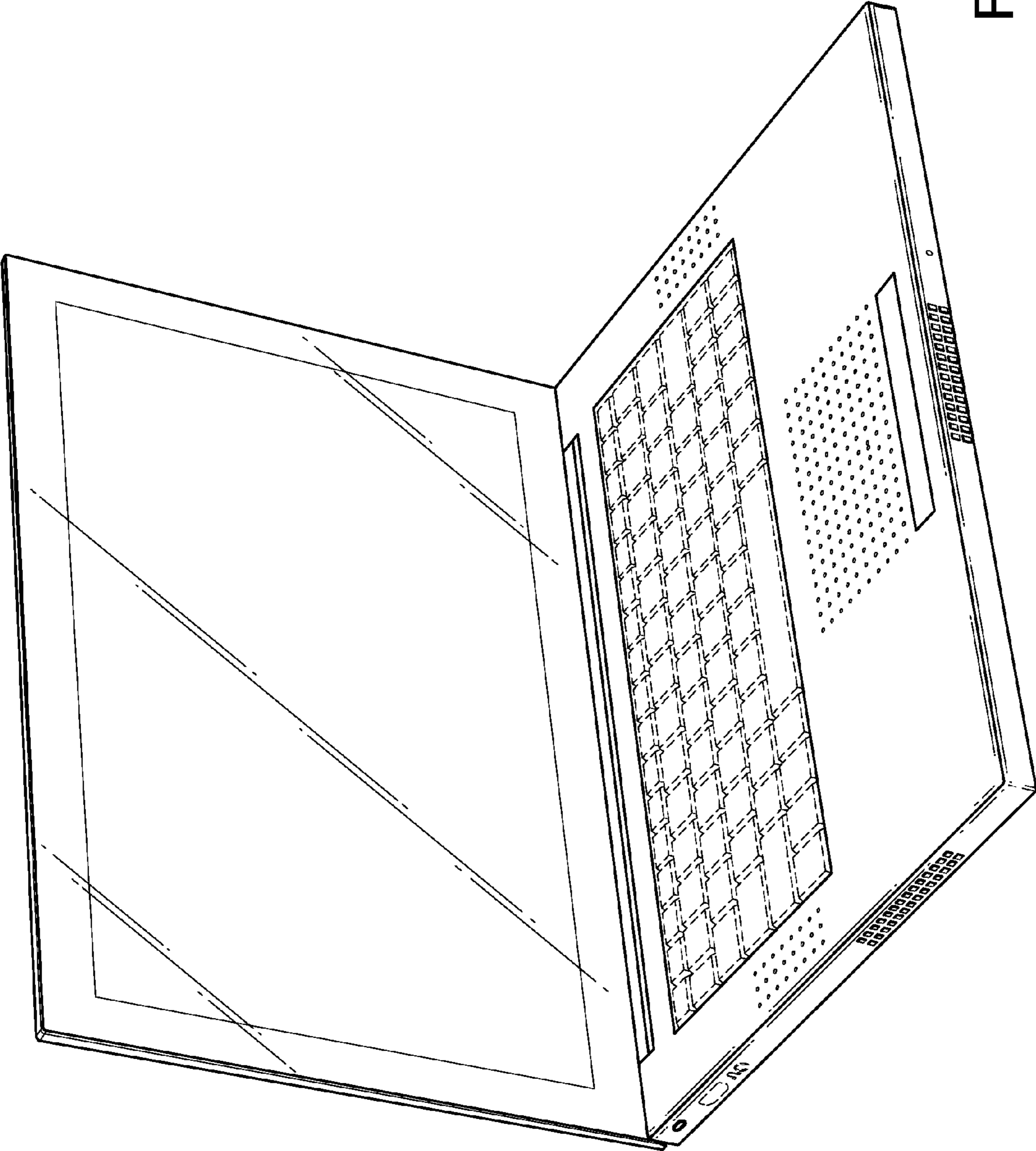

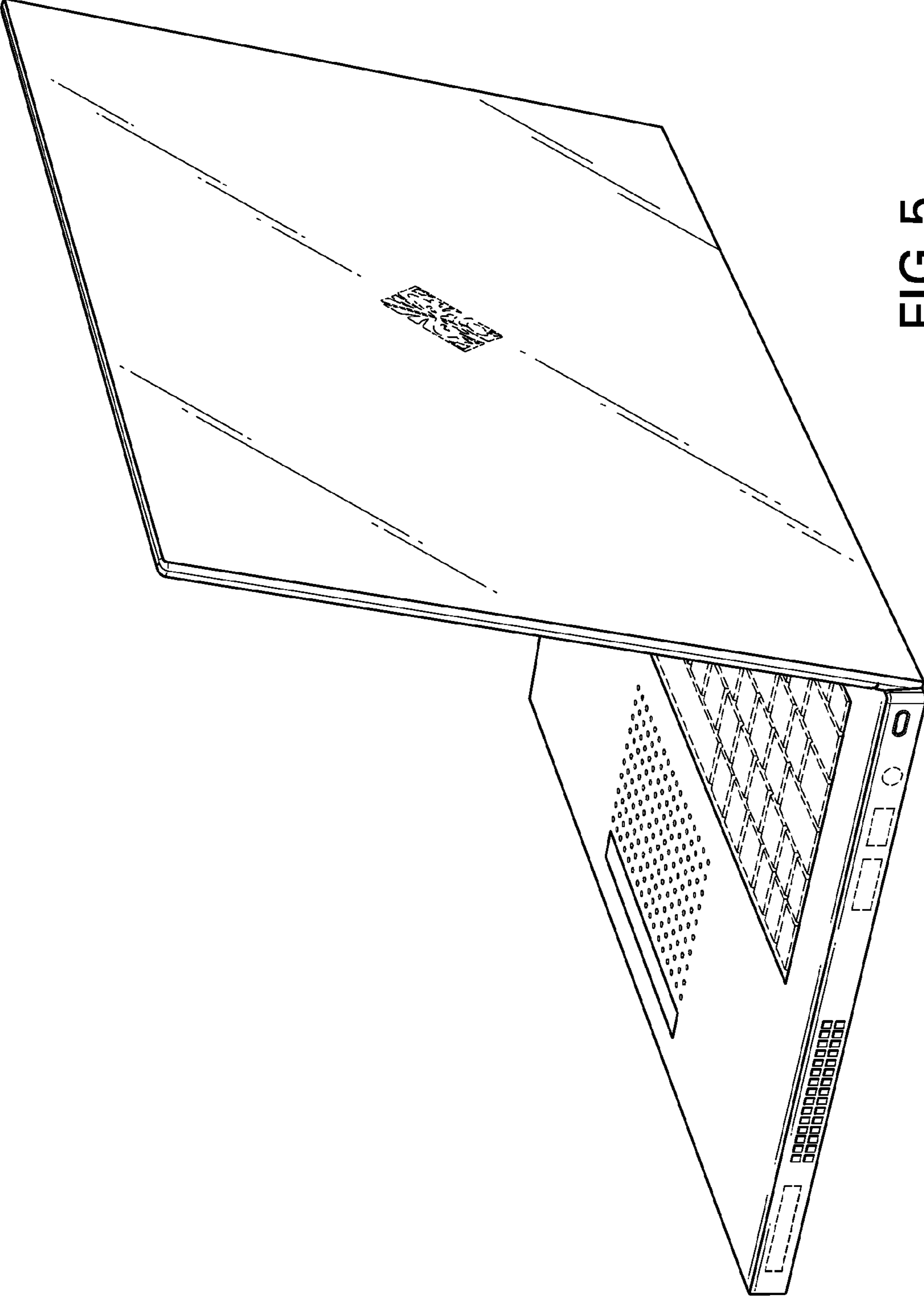

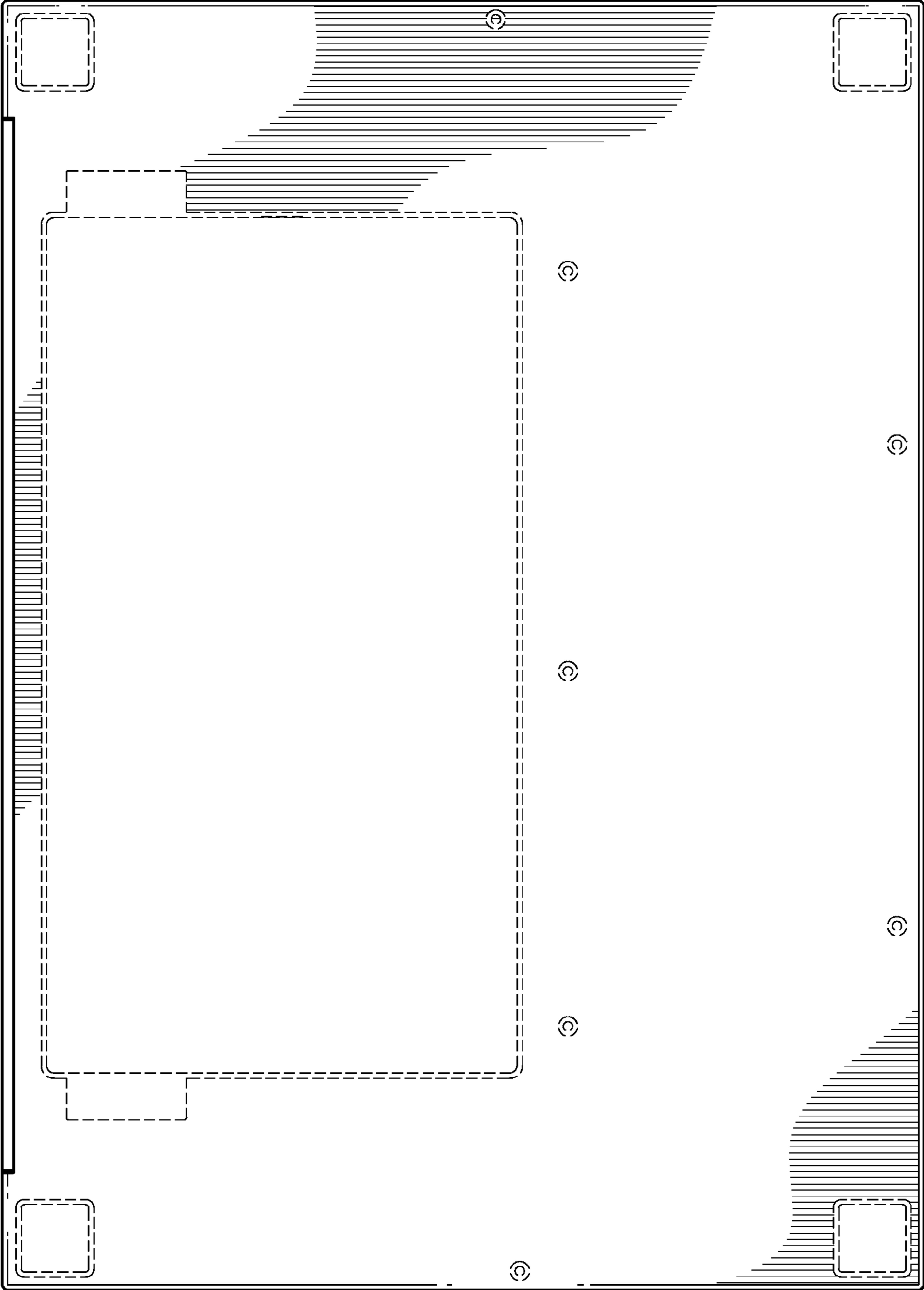
