(57) **CLAIM**

The ornamental design for a hang tag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hang tag showing my new design;

FIG. 2 is a front view of the hang tag shown in FIG. 1;

FIG. 3 is a rear view of the hang tag shown in FIG. 1;

FIG. 4 is a right side view of the hang tag shown in FIG. 1;

FIG. 5 is a left side view of the hang tag shown in FIG. 1;

FIG. 6 is a top view of the hang tag shown in FIG. 1;

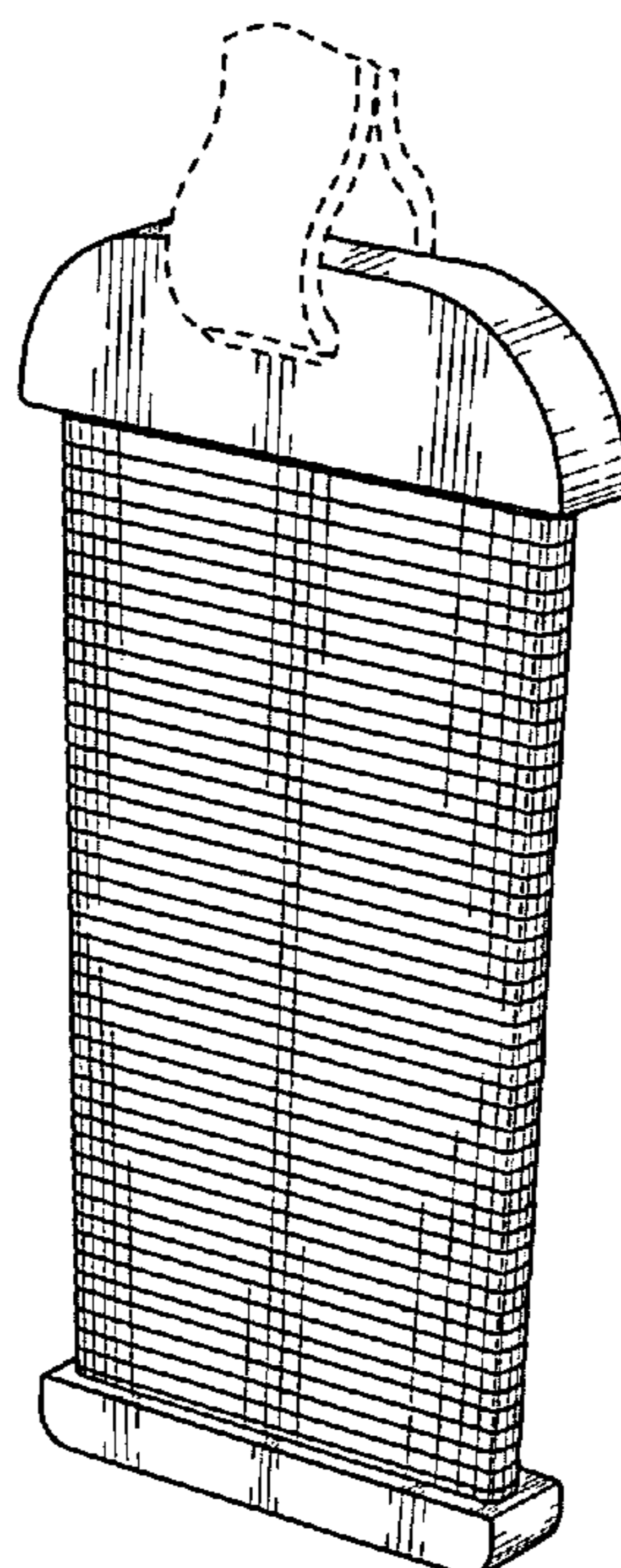
FIG. 7 is a bottom view of the hang tag shown in FIG. 1;

FIG. 8 is perspective view of the hang tag shown in FIG. 1, in a flexed position; and,

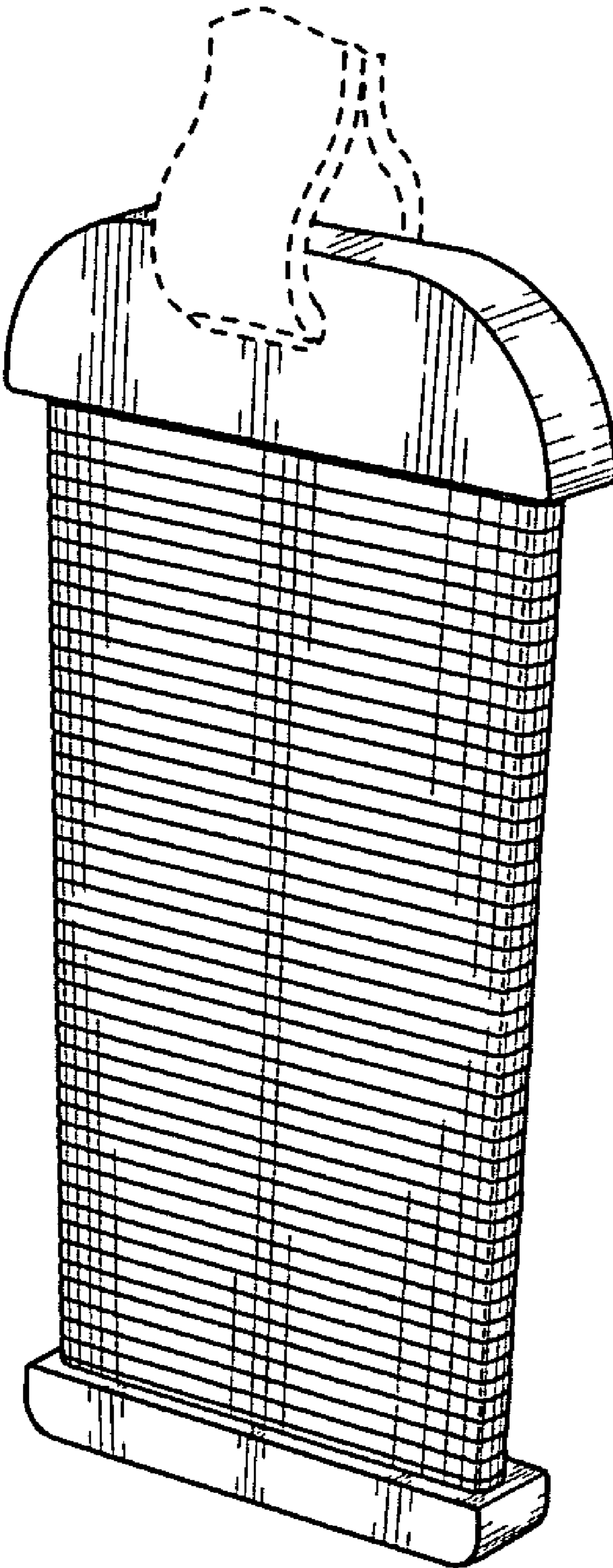

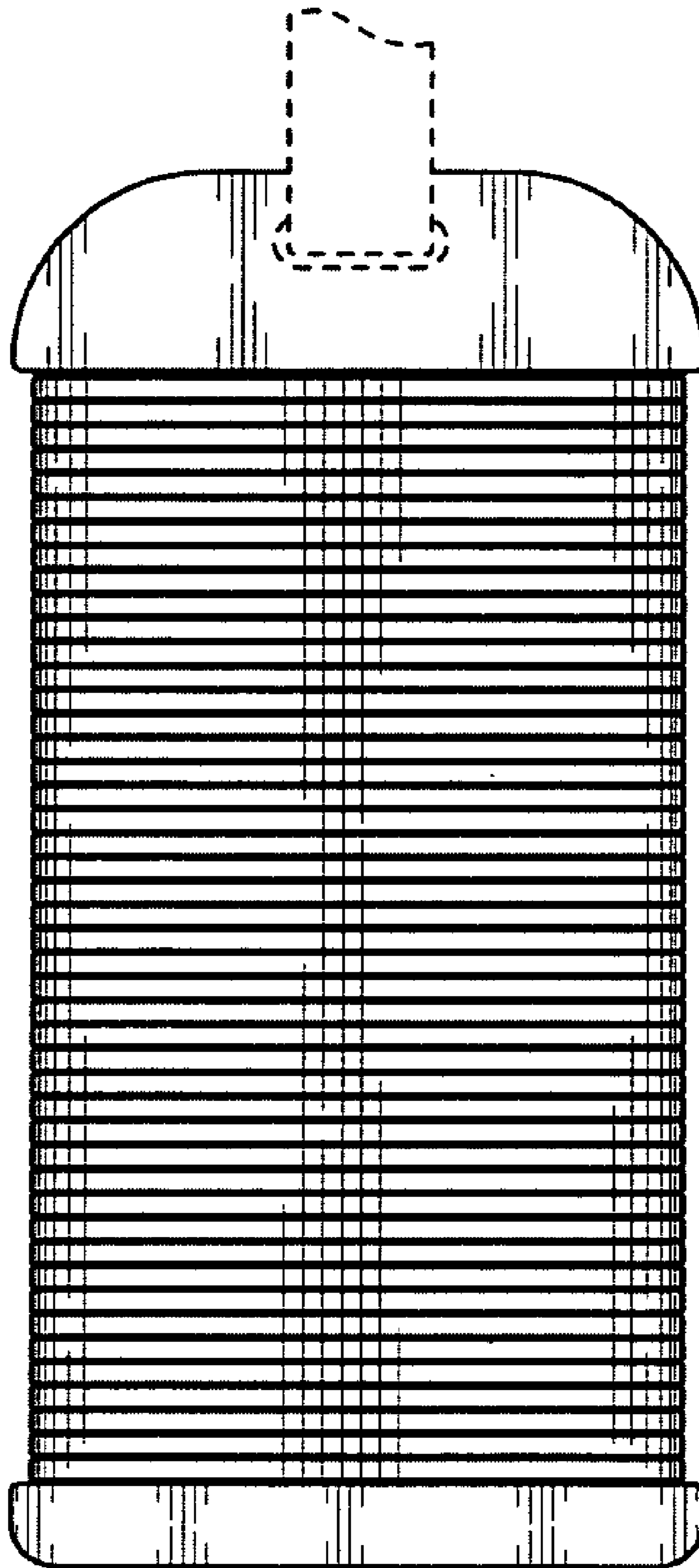

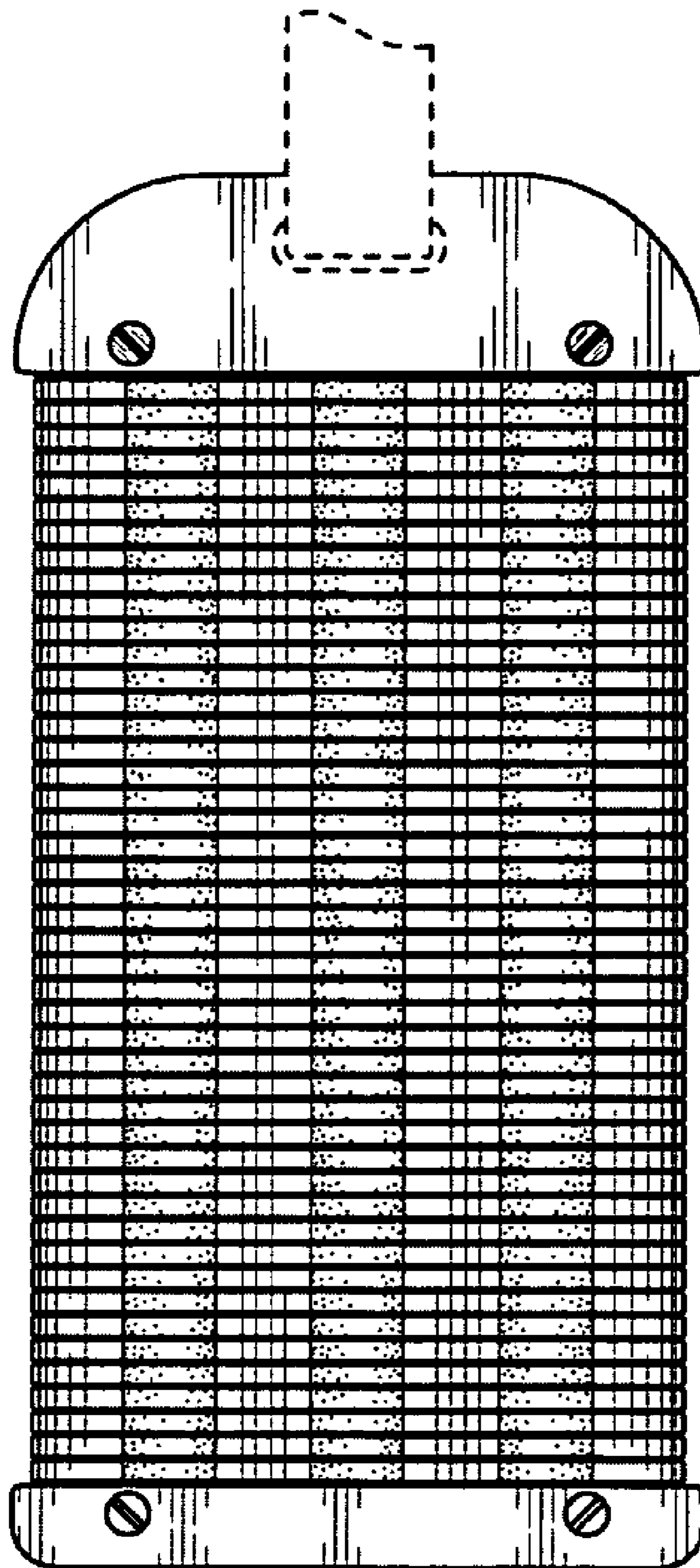

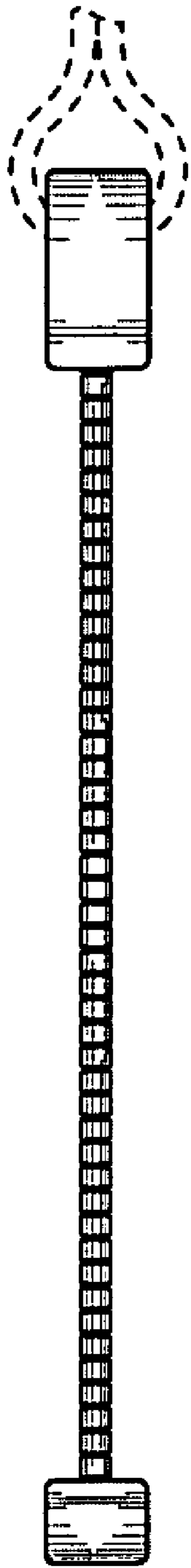

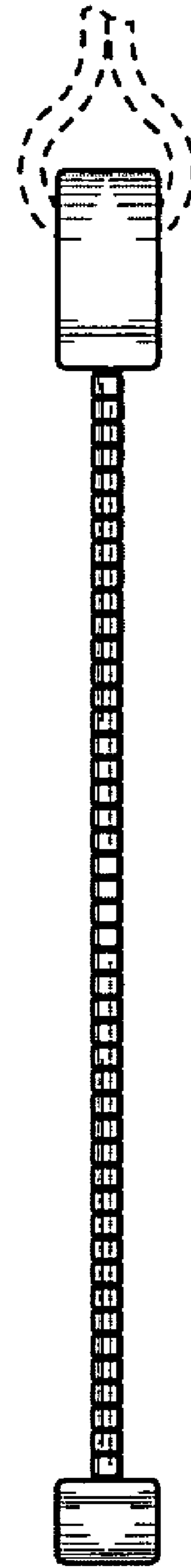

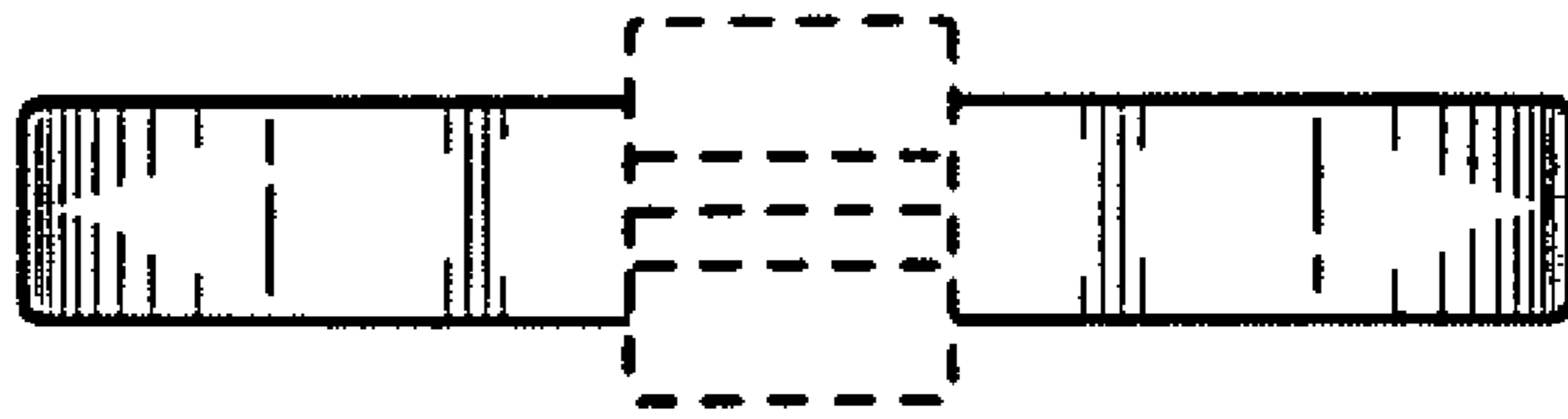

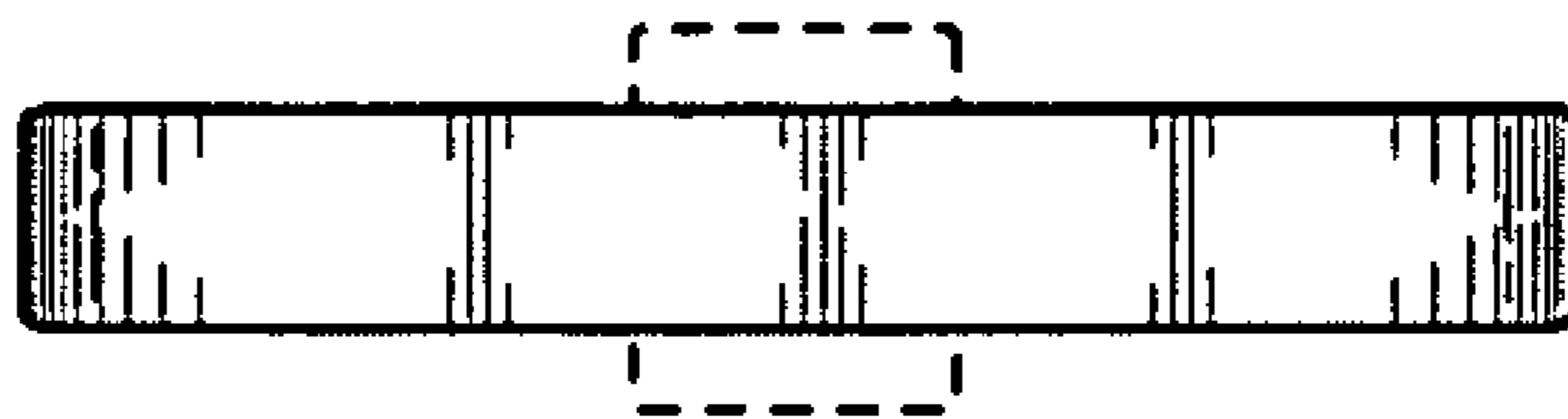

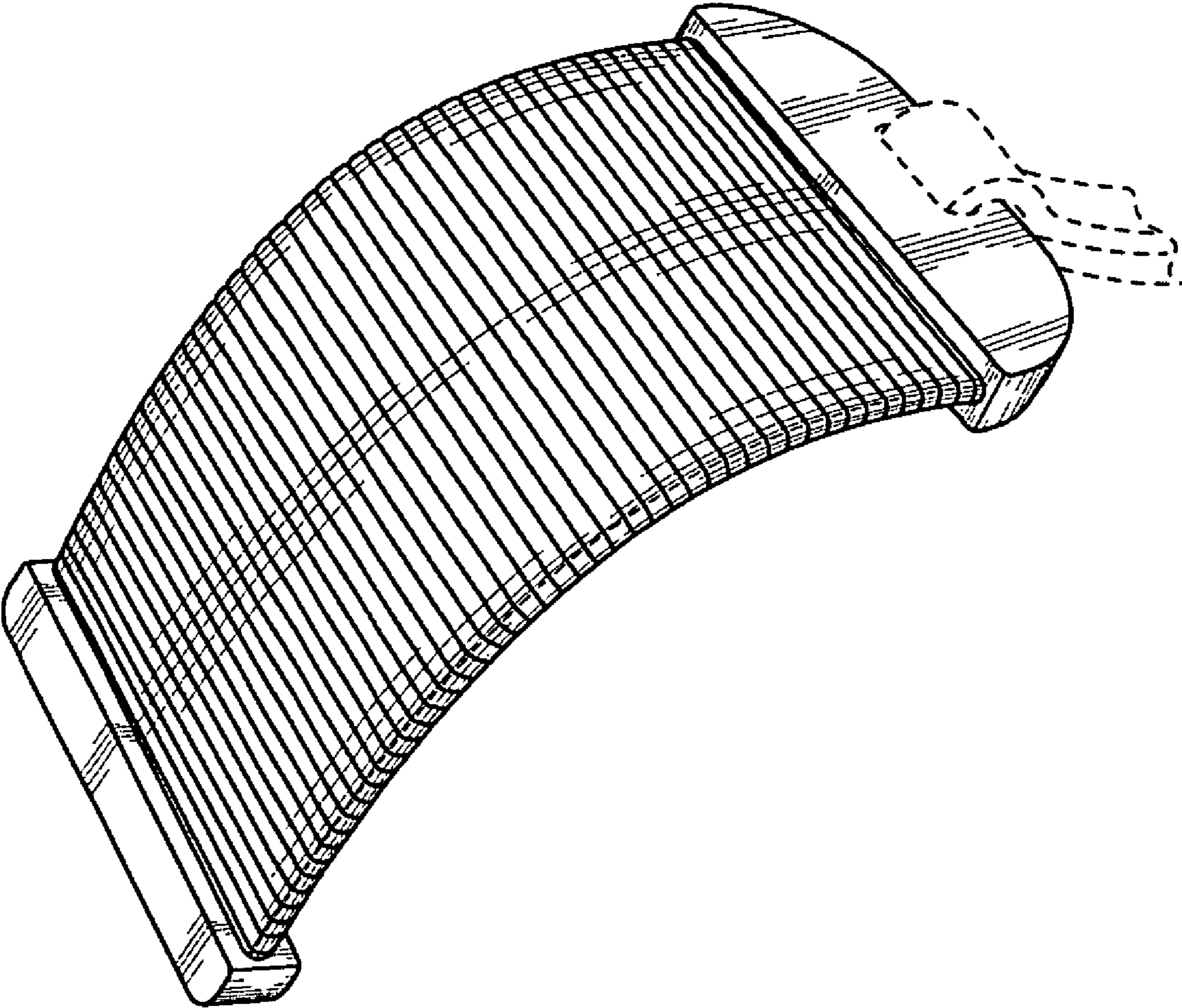

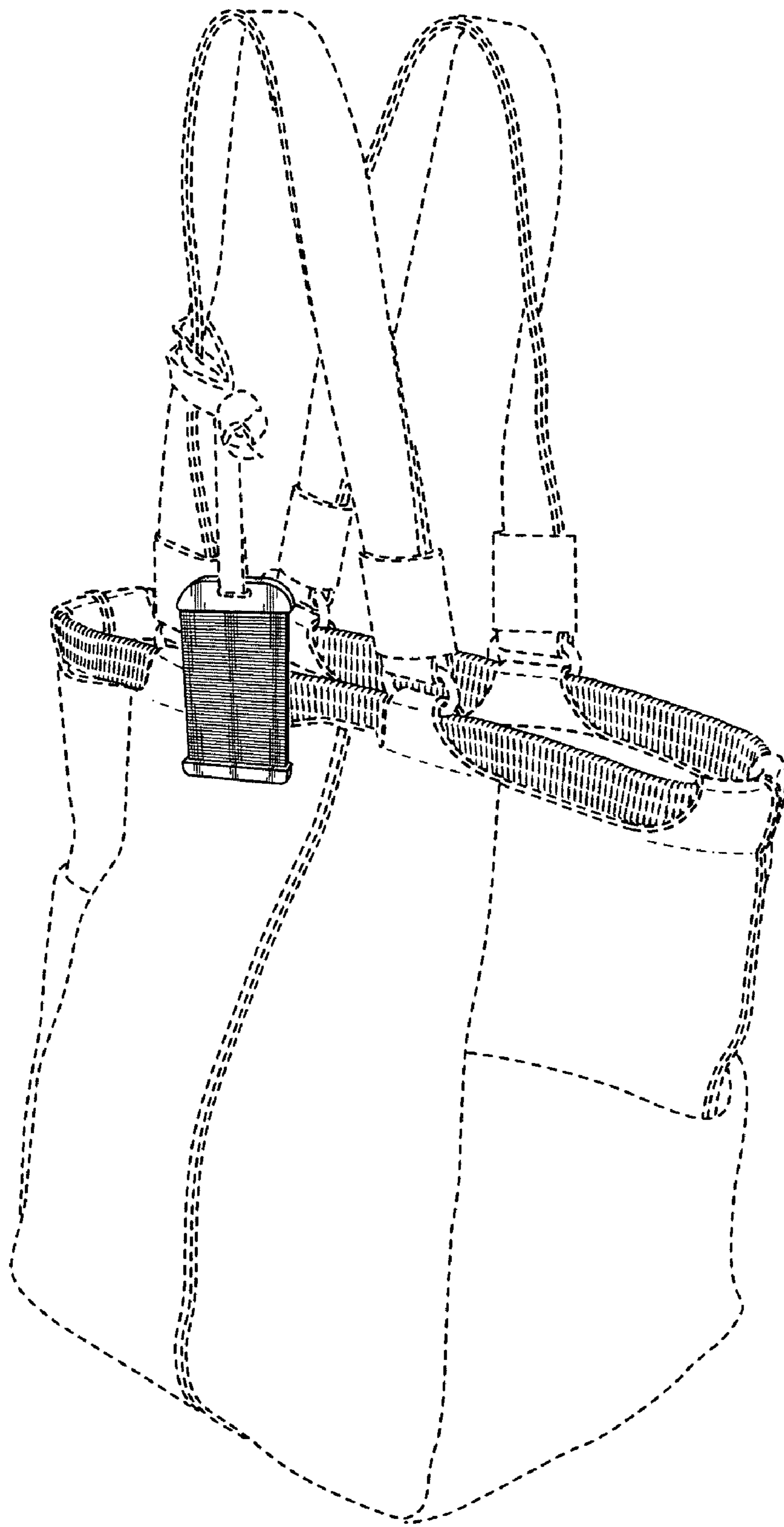
