(57) **CLAIM**

I claim the ornamental design for a combination water hammer arrestor and drain trap primer, as shown and described.

DESCRIPTION

FIG. 1 shows a back elevational view of combination water hammer arrestor and drain trap primer showing my new design.

FIG. 2 shows a left-side elevational view of combination water hammer arrestor and drain trap primer showing my new design.

FIG. 3 shows a front elevational view of combination water hammer arrestor and drain trap primer showing my new design.

FIG. 4 shows a right elevational view of combination water hammer arrestor and drain trap primer showing my new design.

FIG. 5 shows a top plan view of combination water hammer arrestor and drain trap primer showing my new design.

FIG. 6 shows a bottom plan view of combination water hammer arrestor and drain trap primer showing my new design.

FIG. 7 shows a back elevational view of a first alternative embodiment to that shown in FIGS. 1-6.

FIG. 8 shows a left-side elevational view of this alternative embodiment.

FIG. 9 shows a front elevational view of this alternative embodiment.

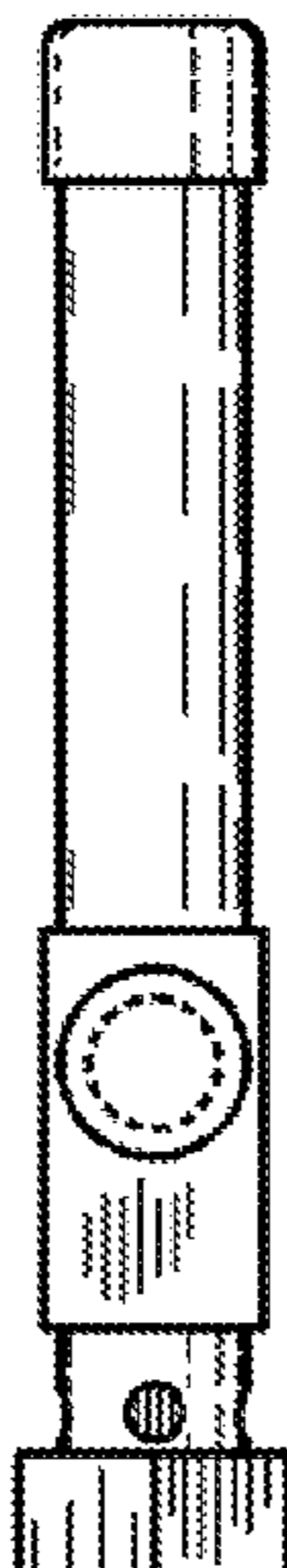
FIG. 10 shows a right elevational view of this alternative embodiment.

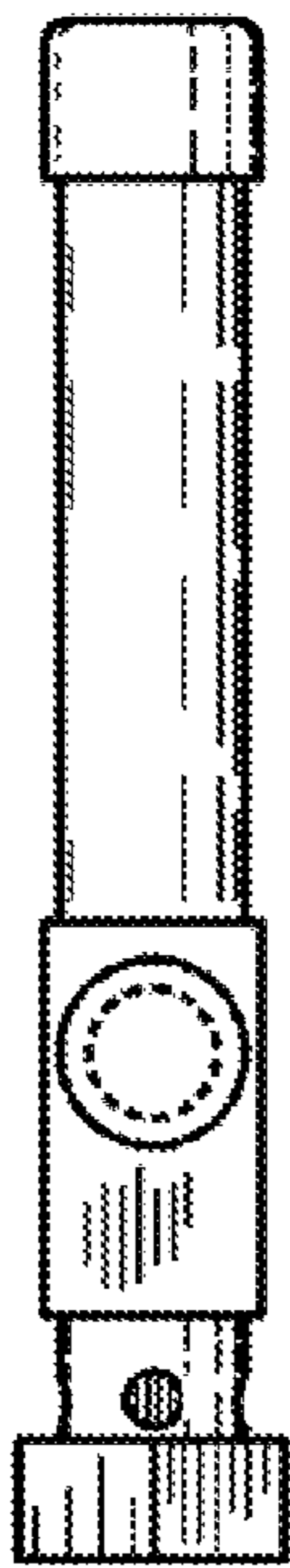

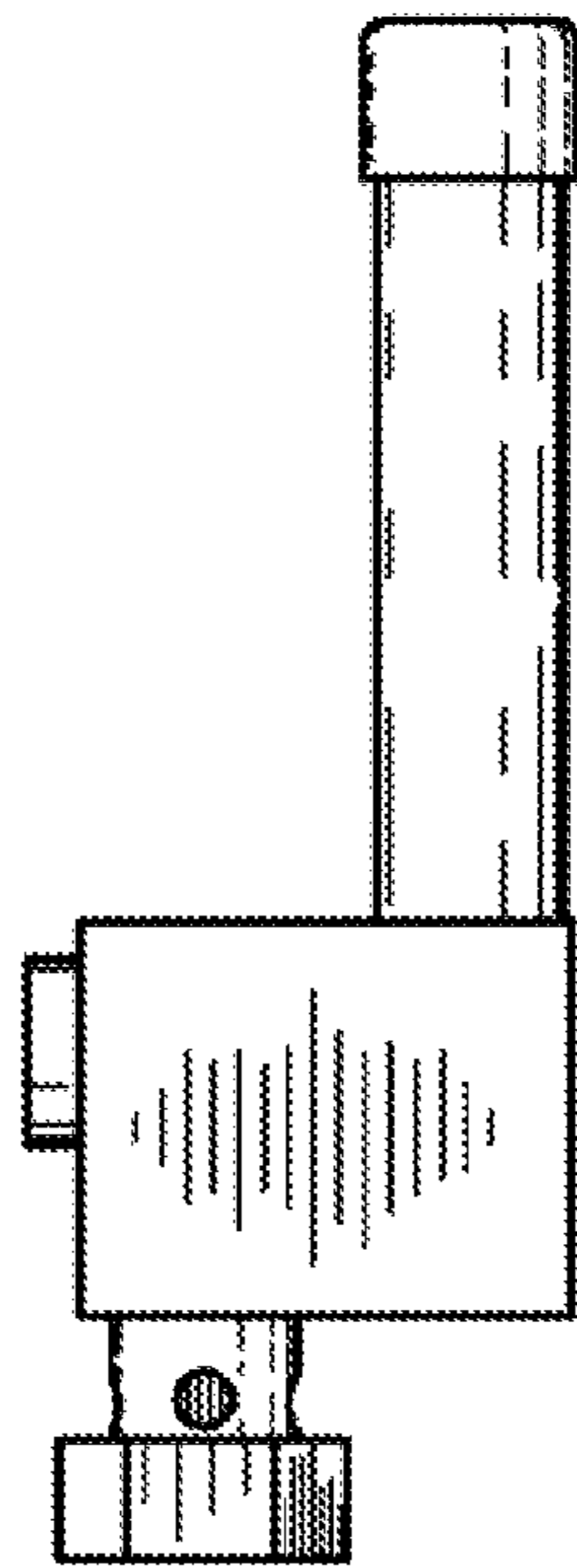

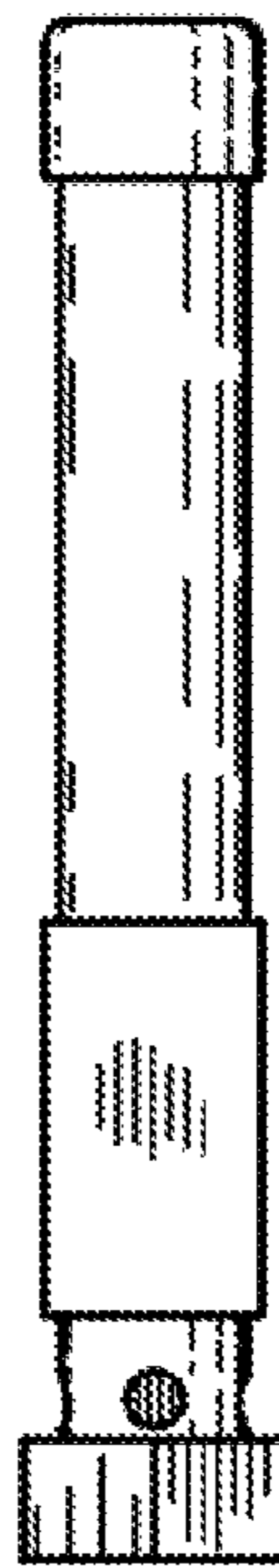

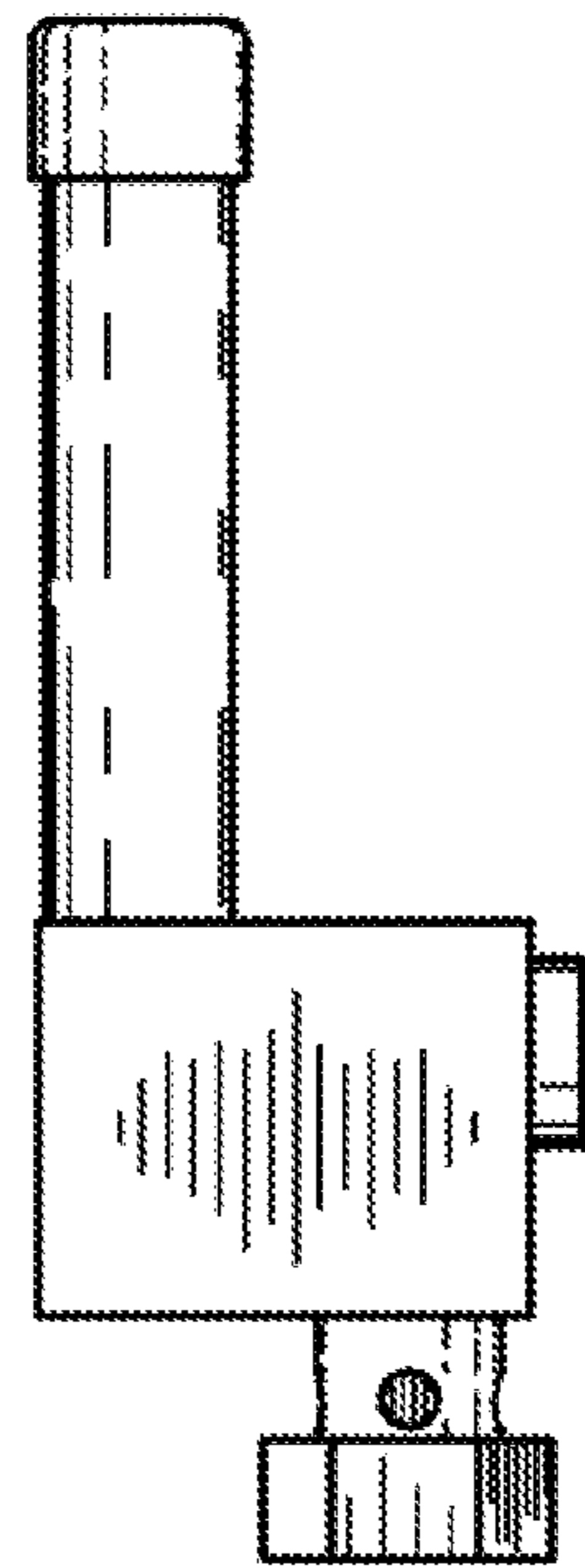

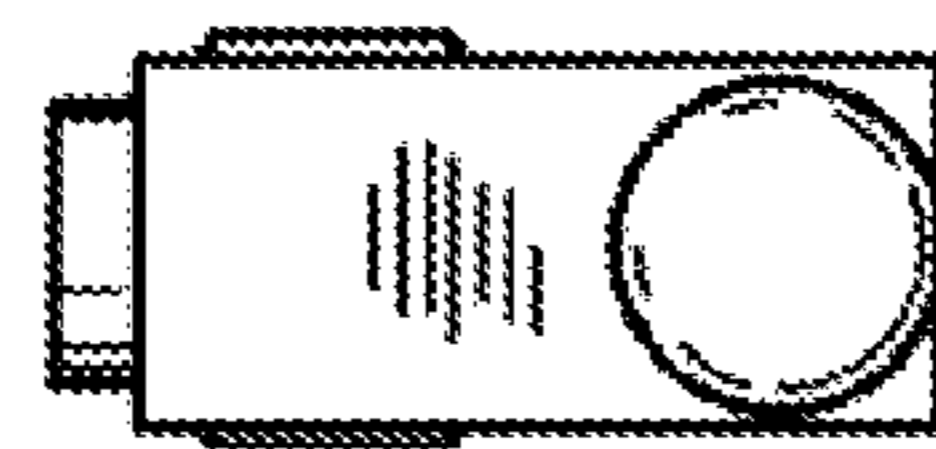

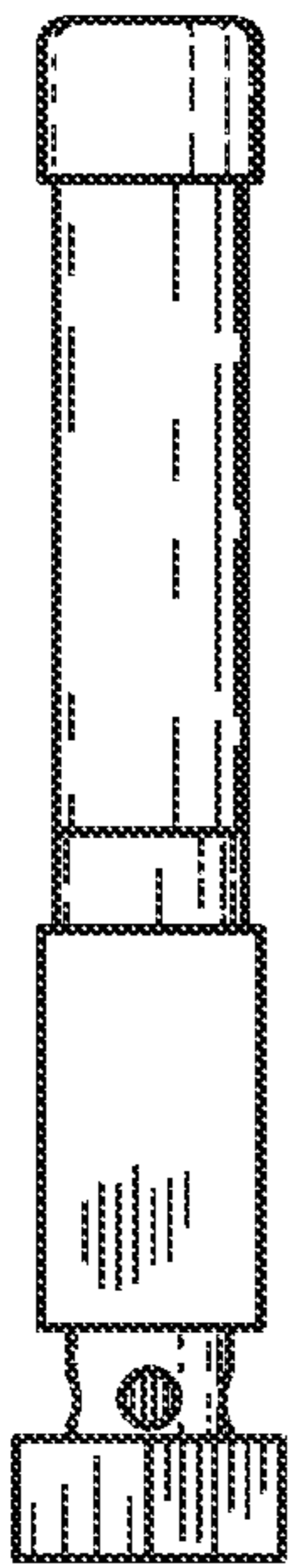

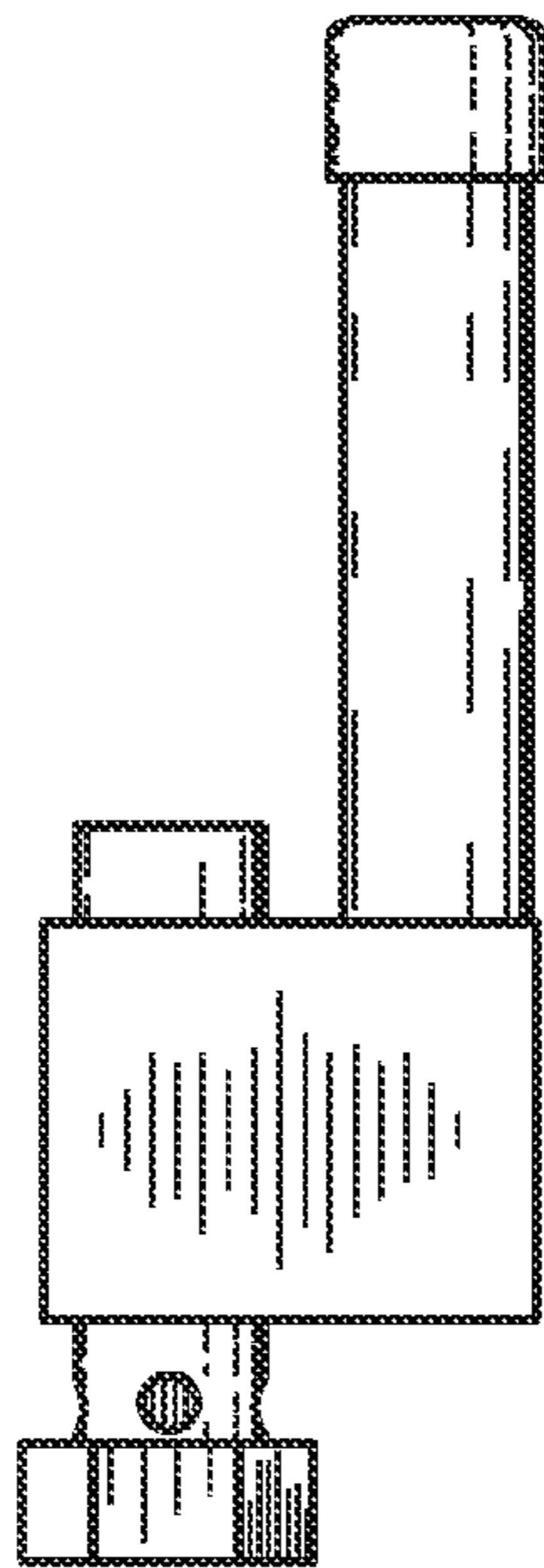

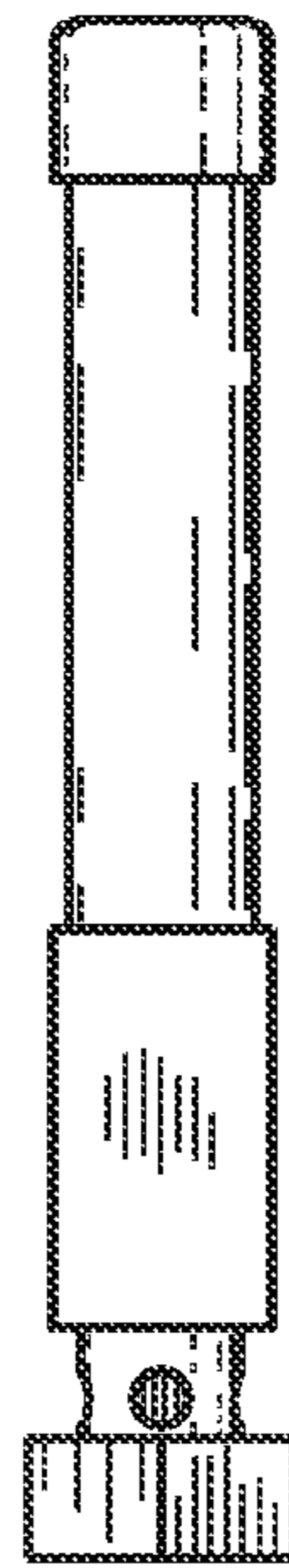

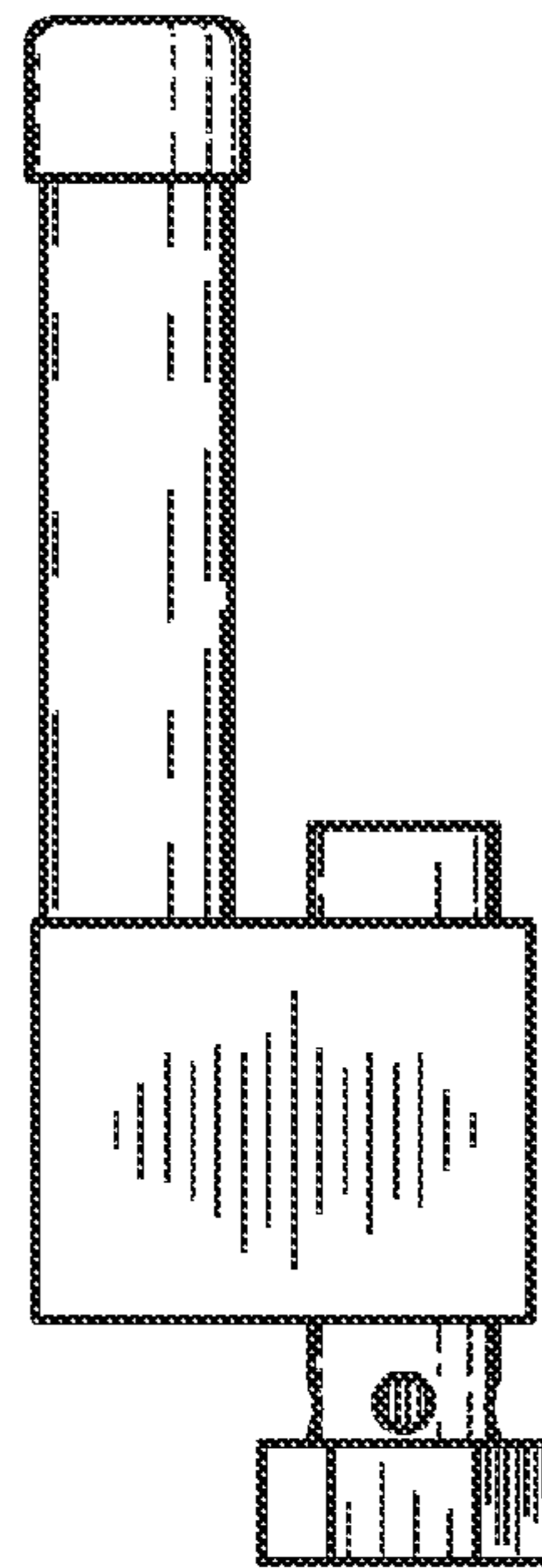
