FIG. 1;

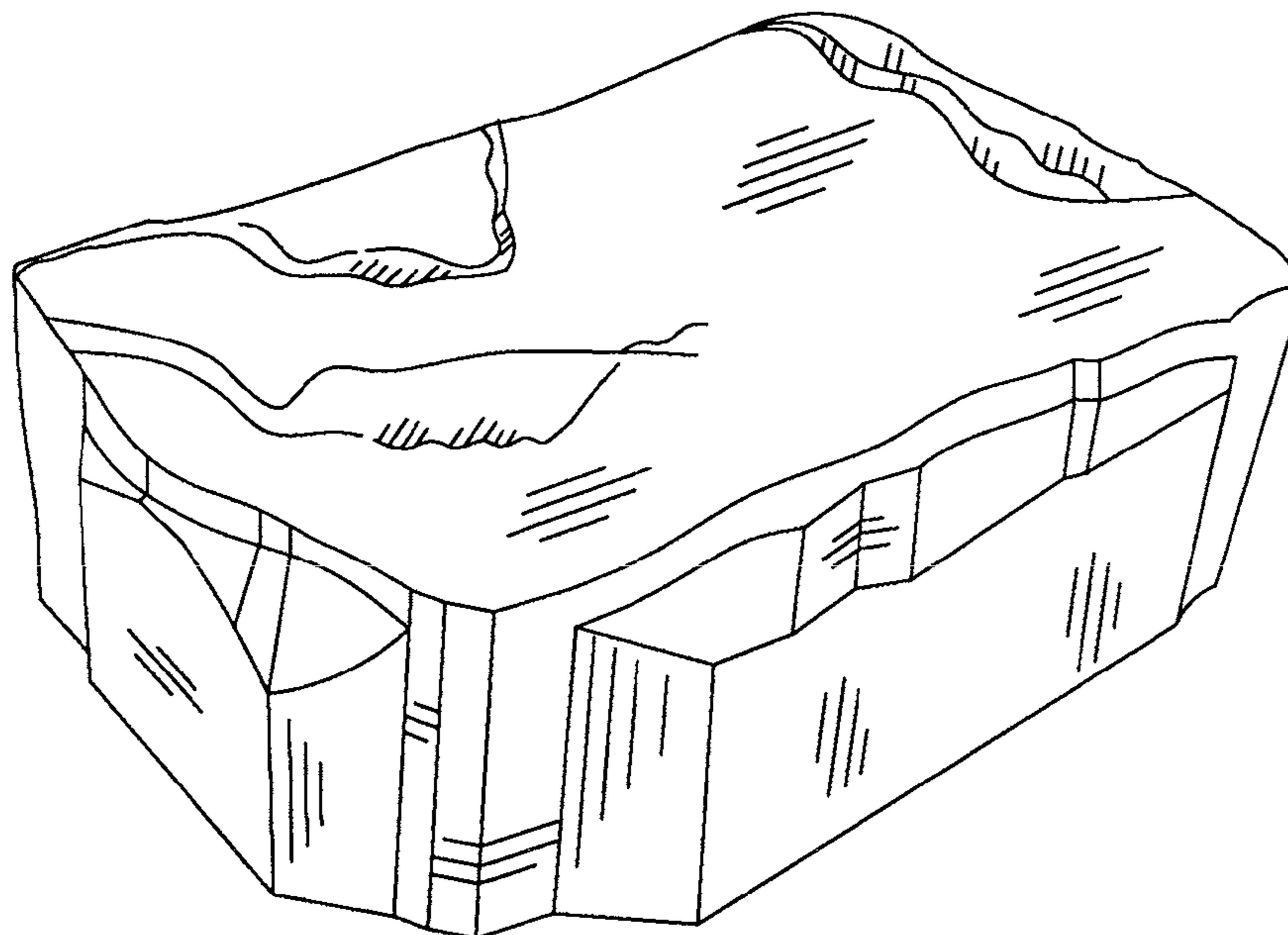
FIG. 3 is a right side elevational view of the design shown in  
FIG. 1;

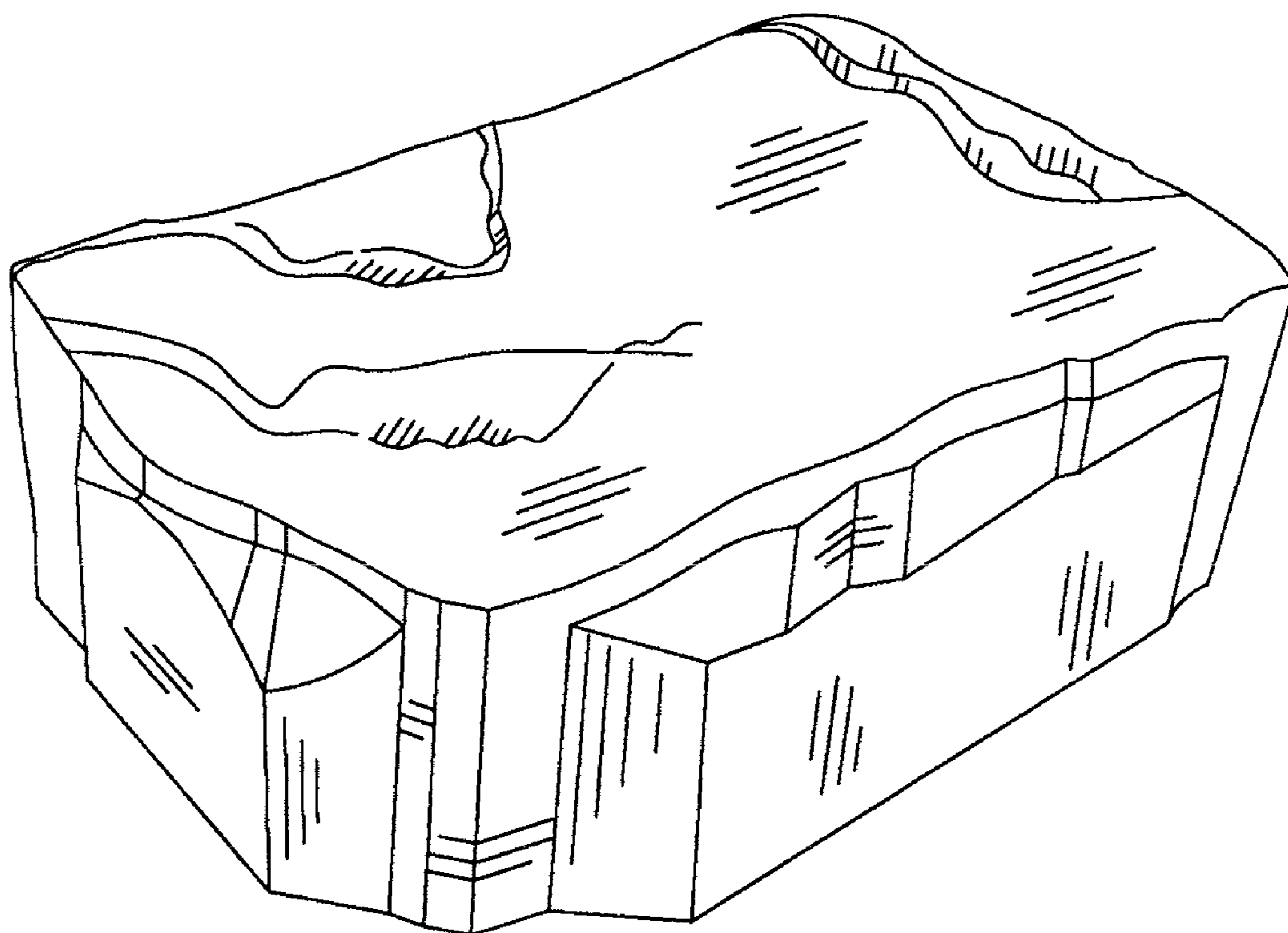
FIG. 4 is a top plan view of the design shown in FIG. 1;

1; and,

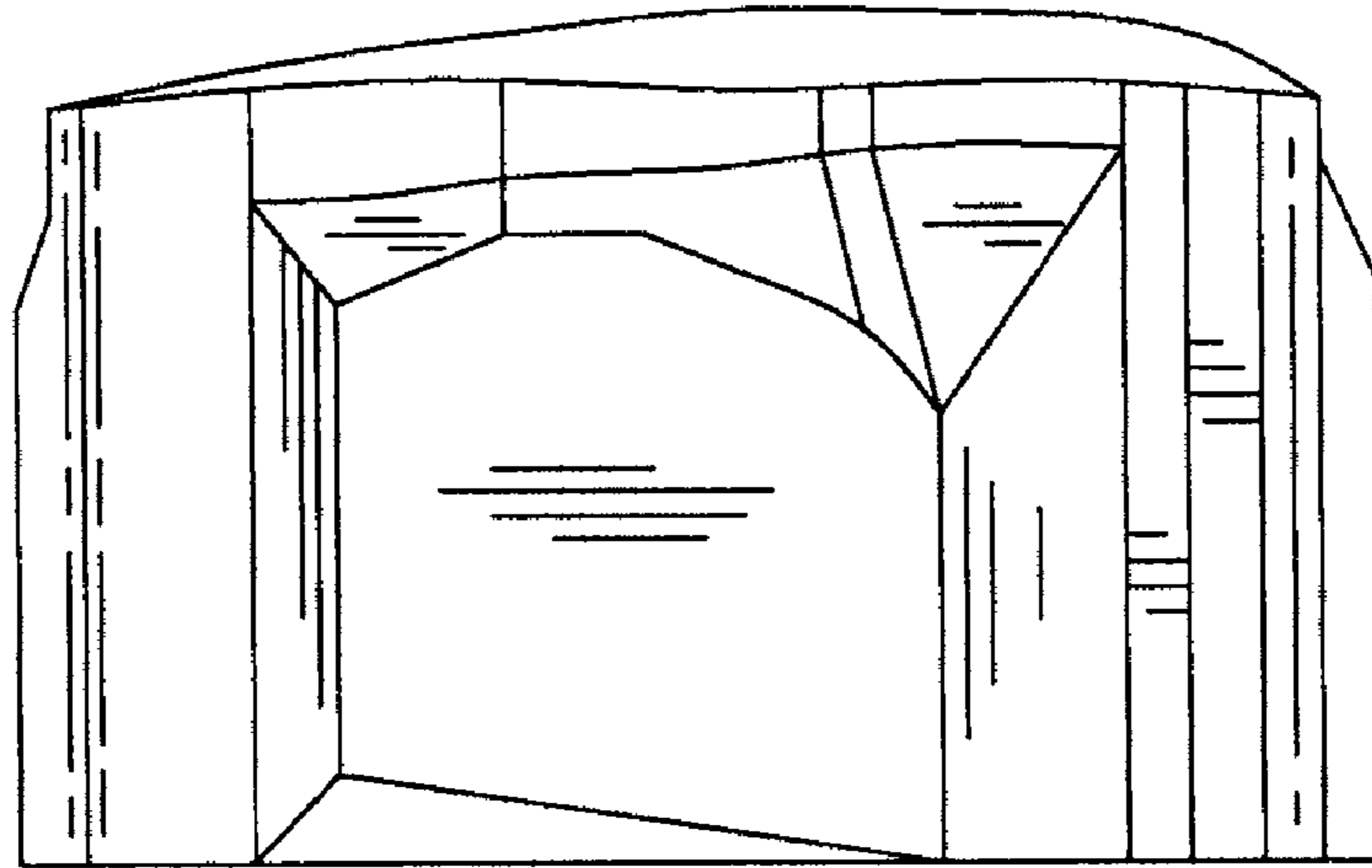
FIG. 6 is a bottom plan view of the design shown in FIG. 1.

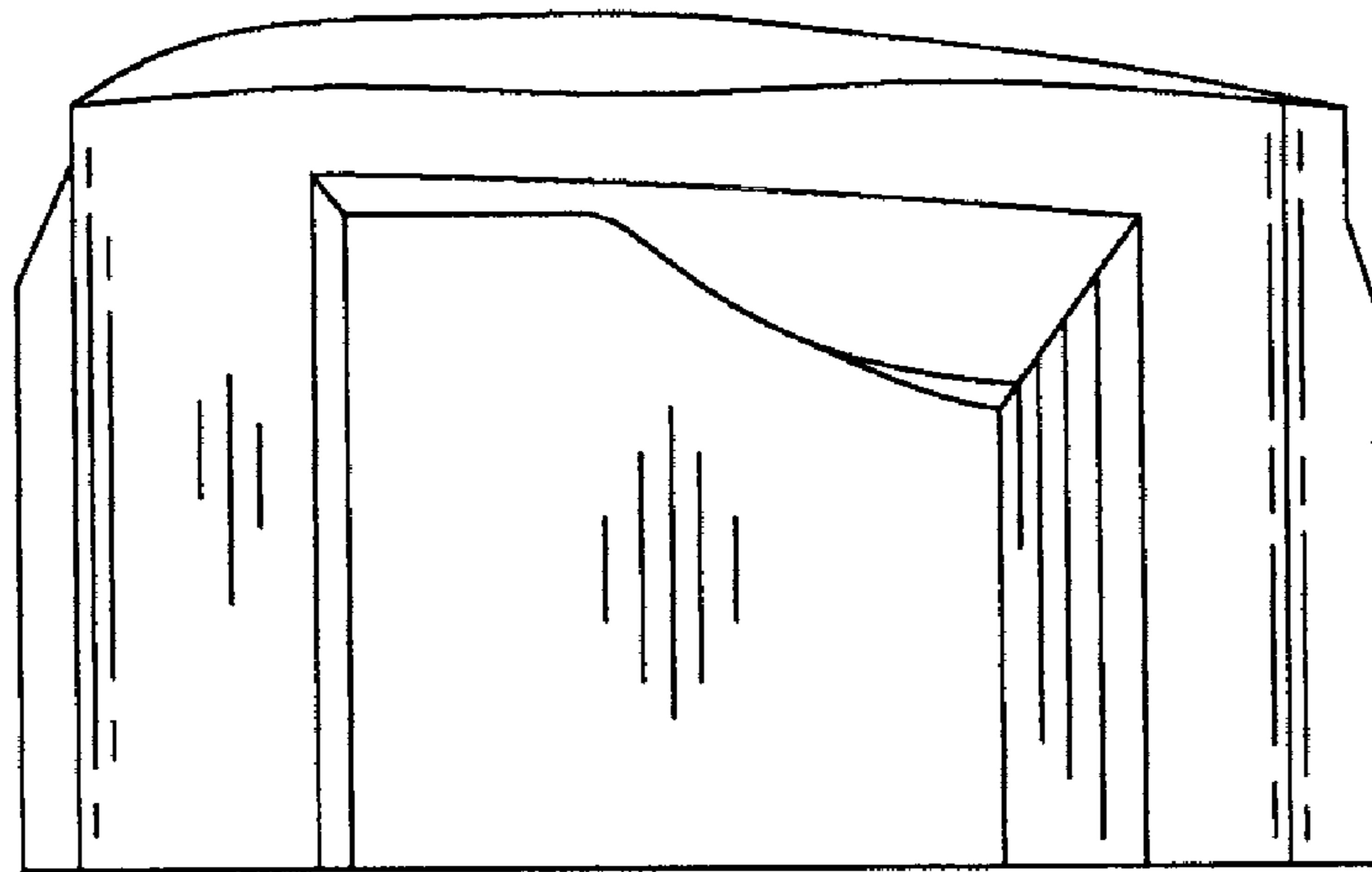




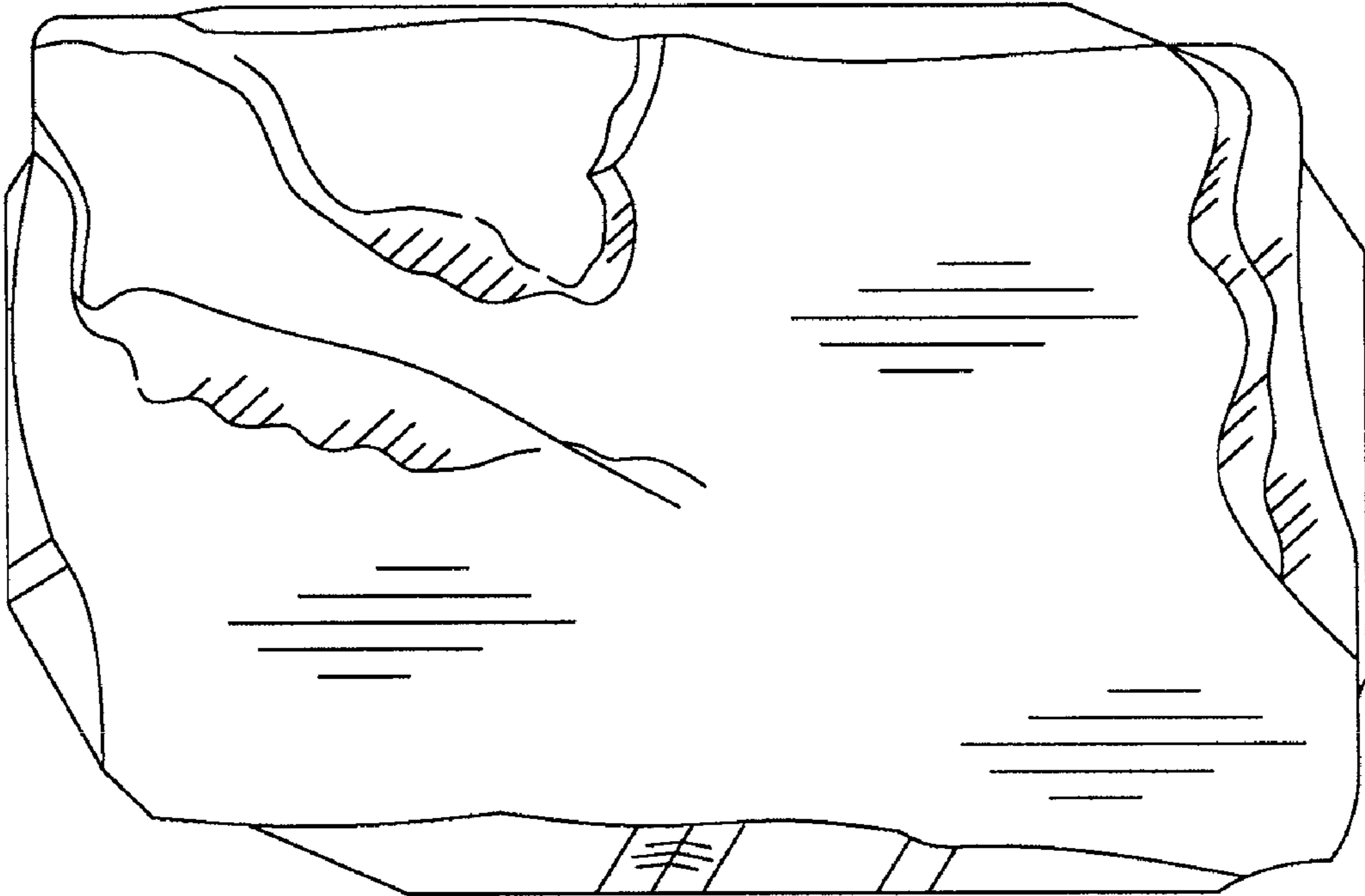

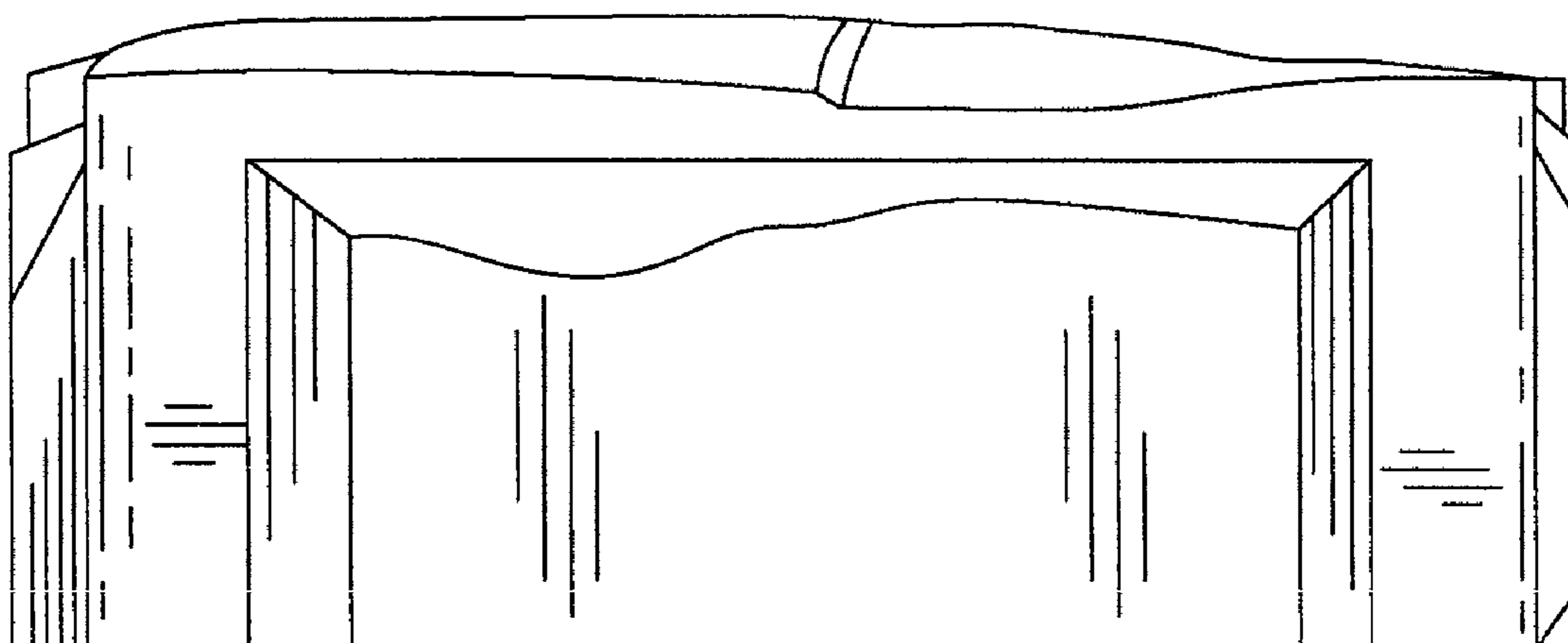

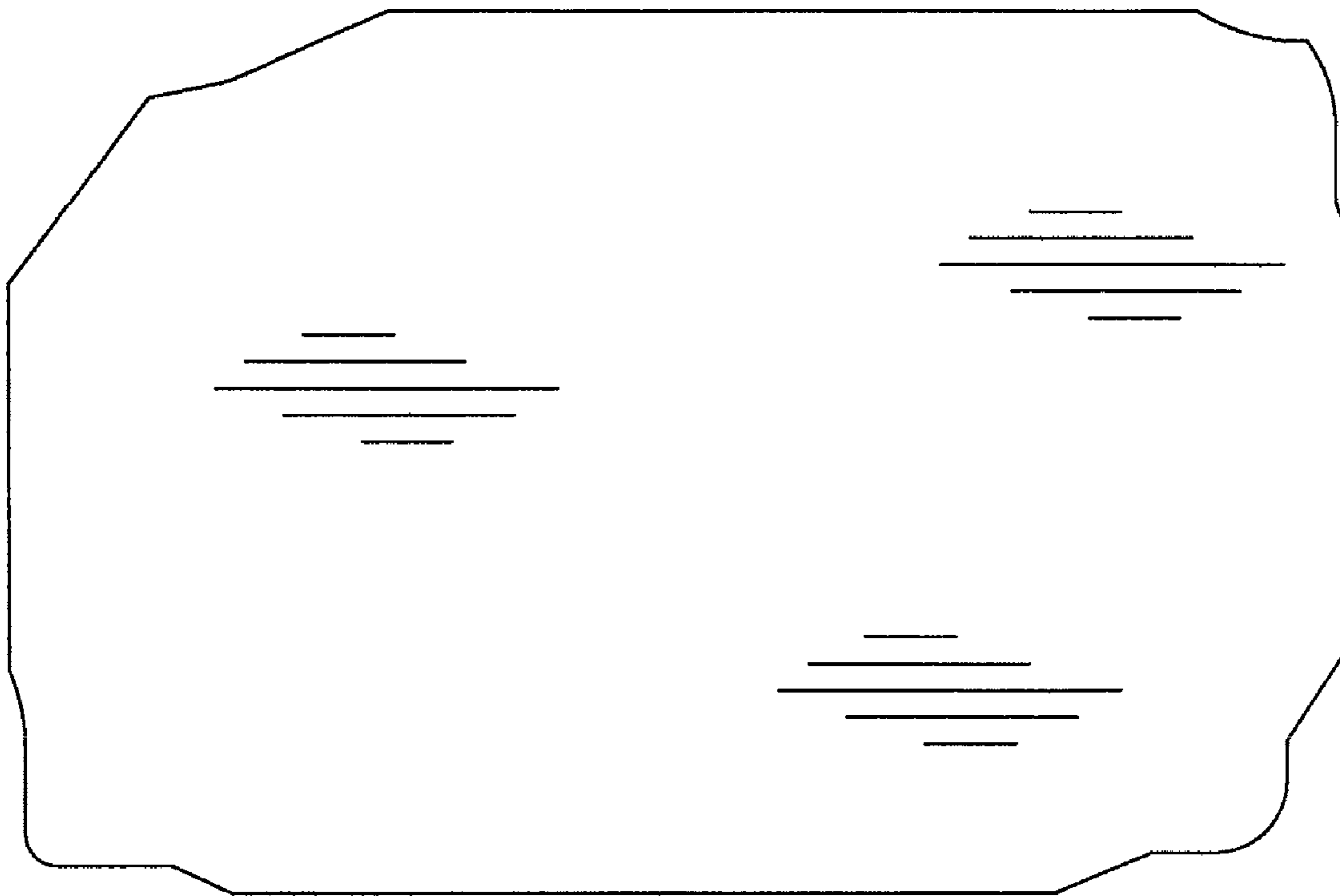
