FIG. 8 is a bottom plan view of the toy of FIG. 2.

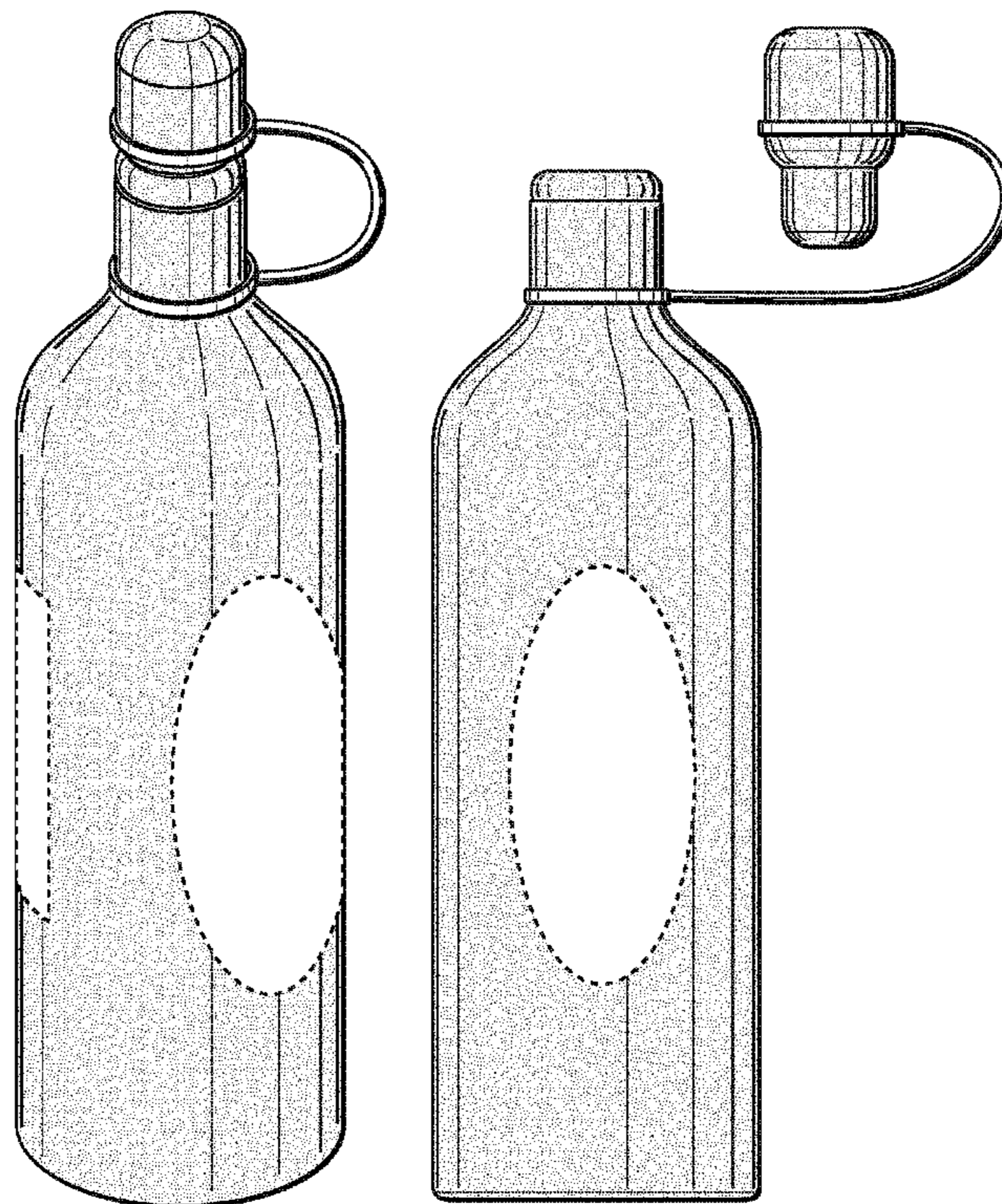
The dashed lines and areas within their boundaries form no part of the claimed design and define surfaces where the design may include indicia that also form no part of the claimed design.

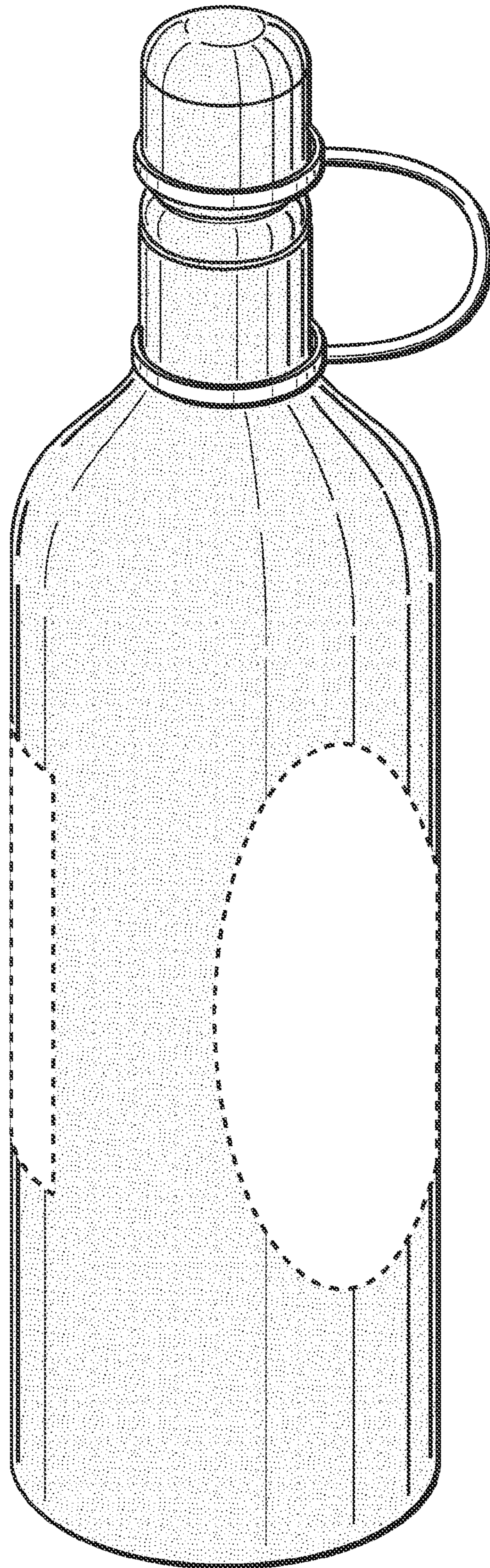

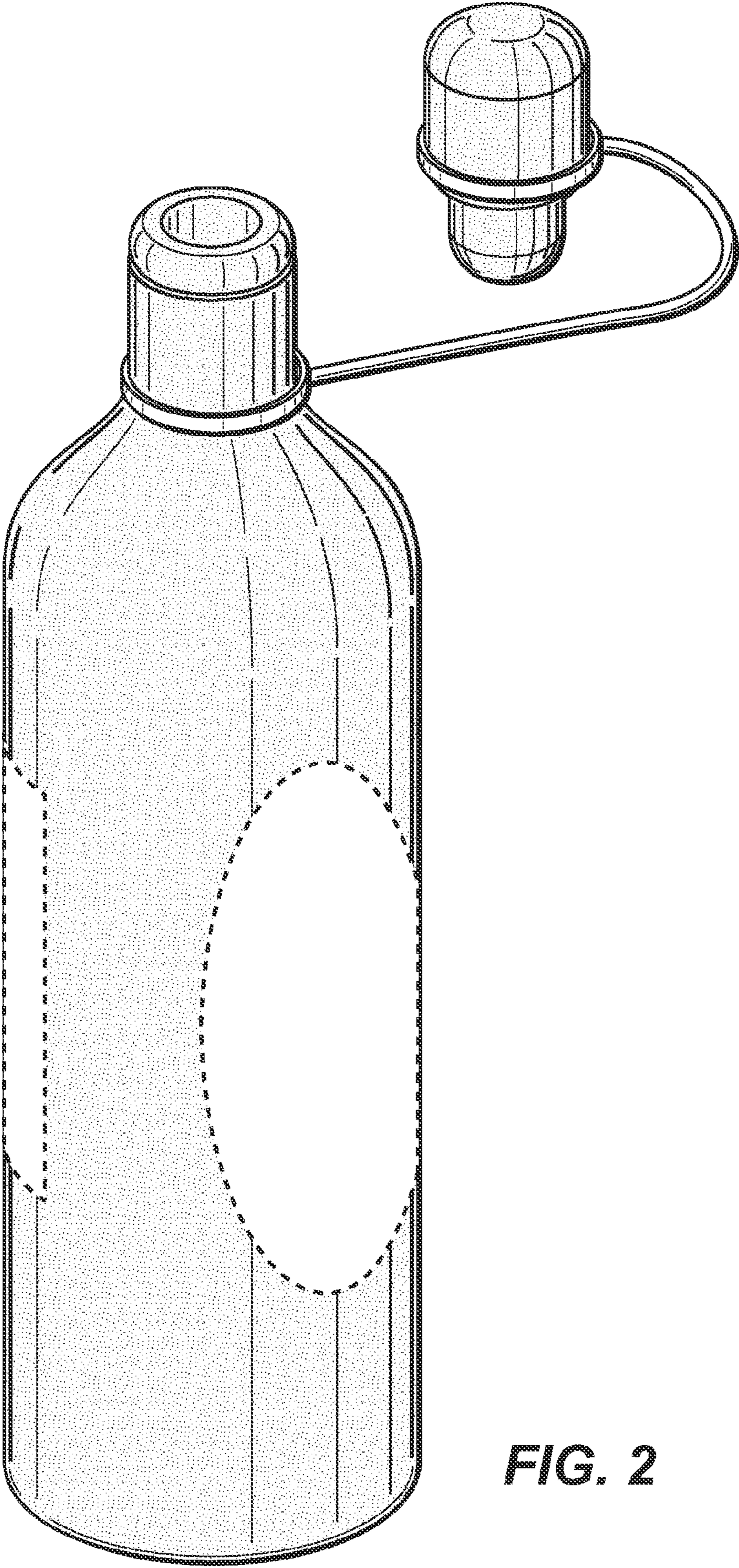

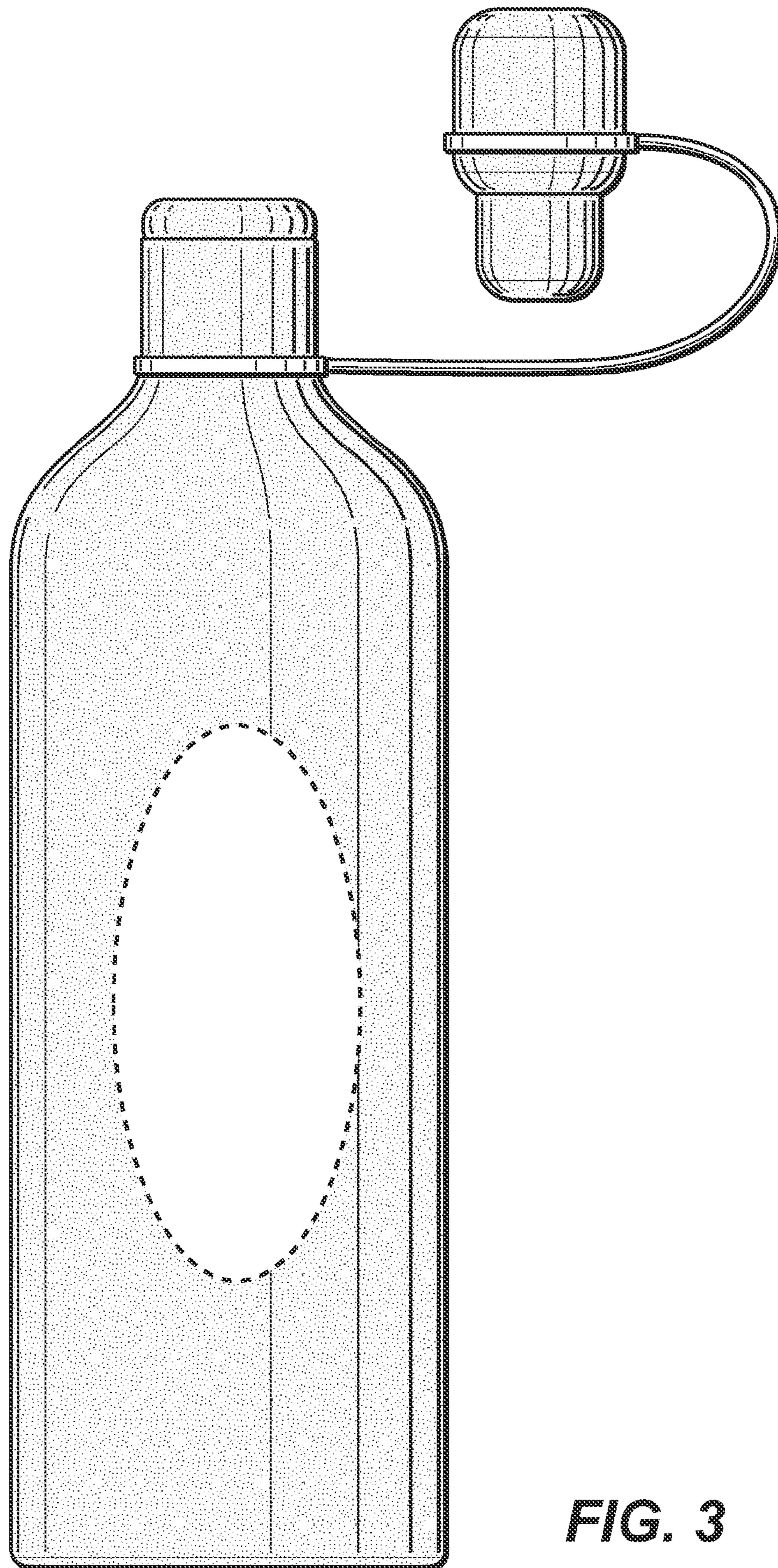

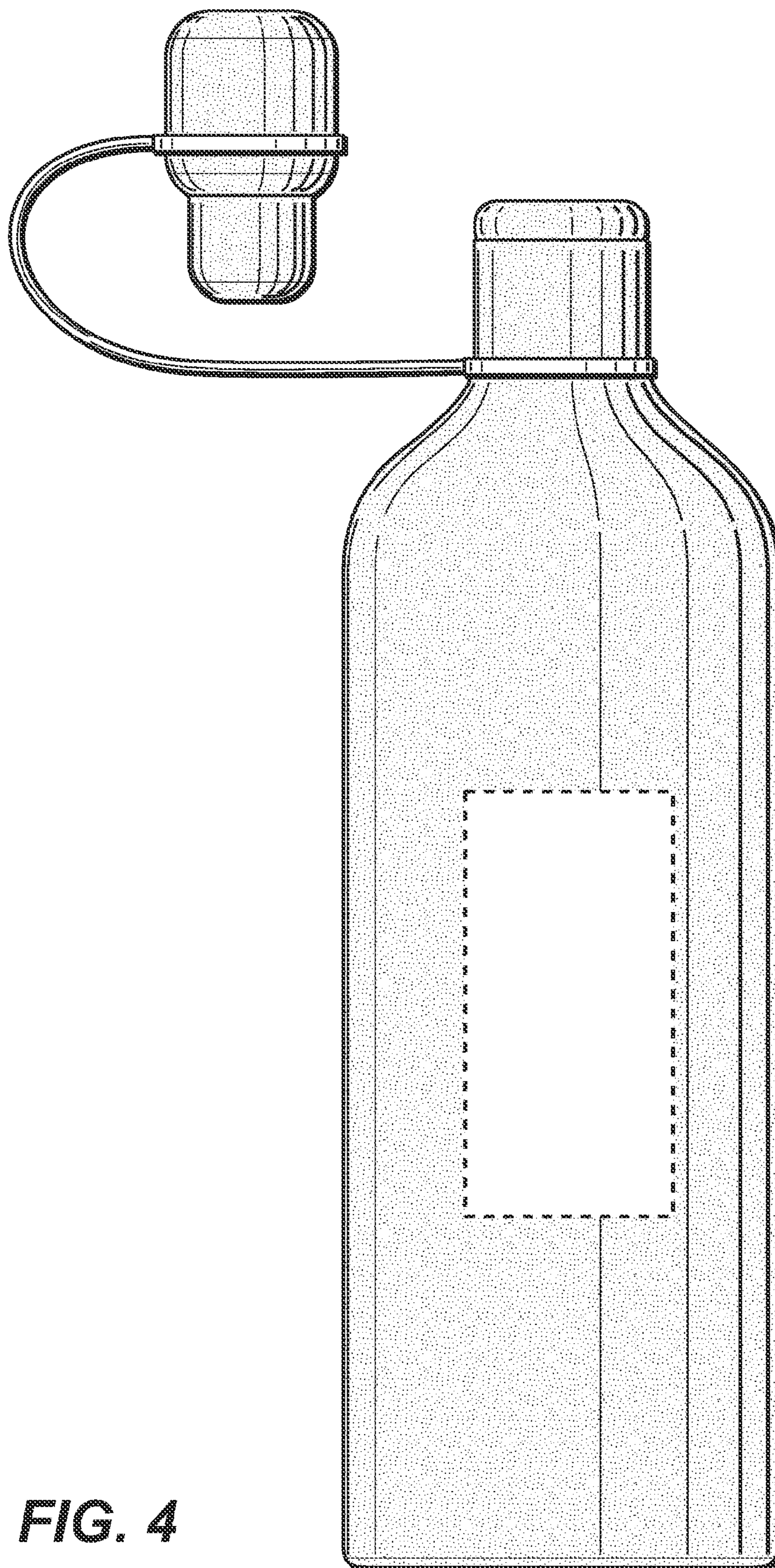

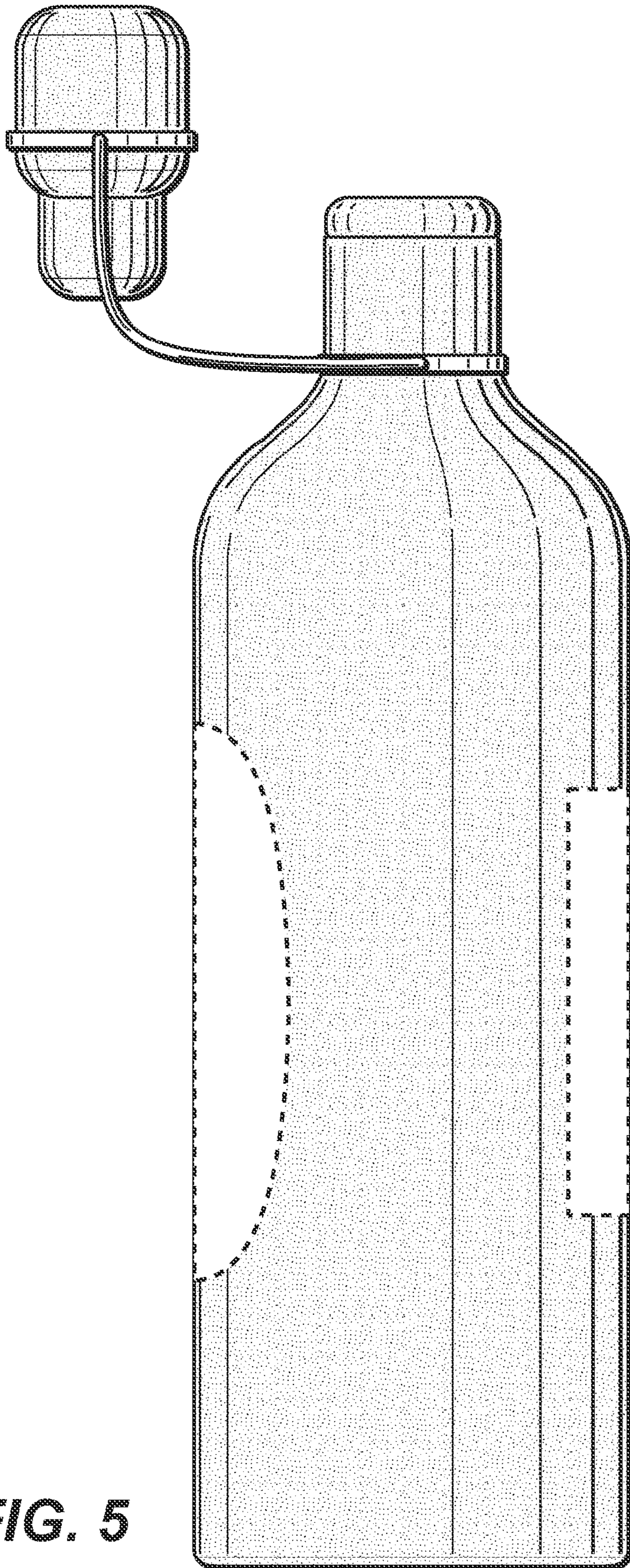

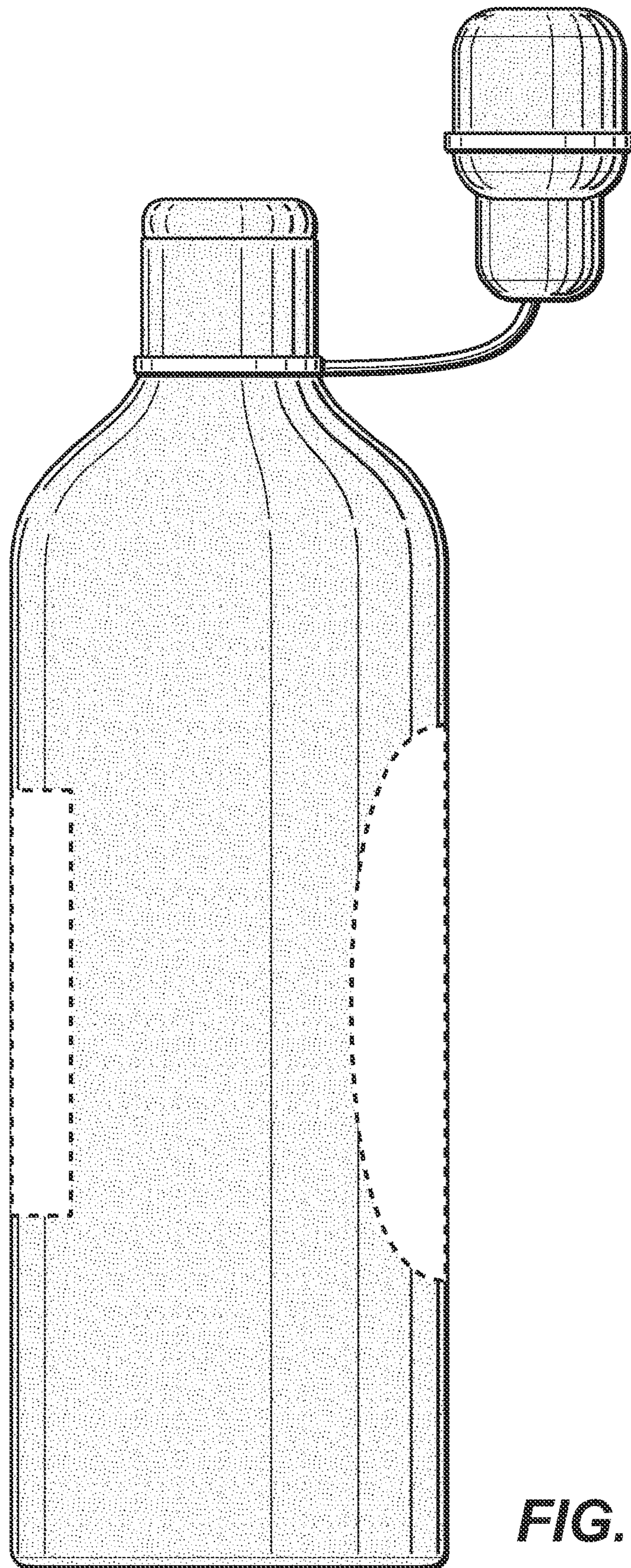

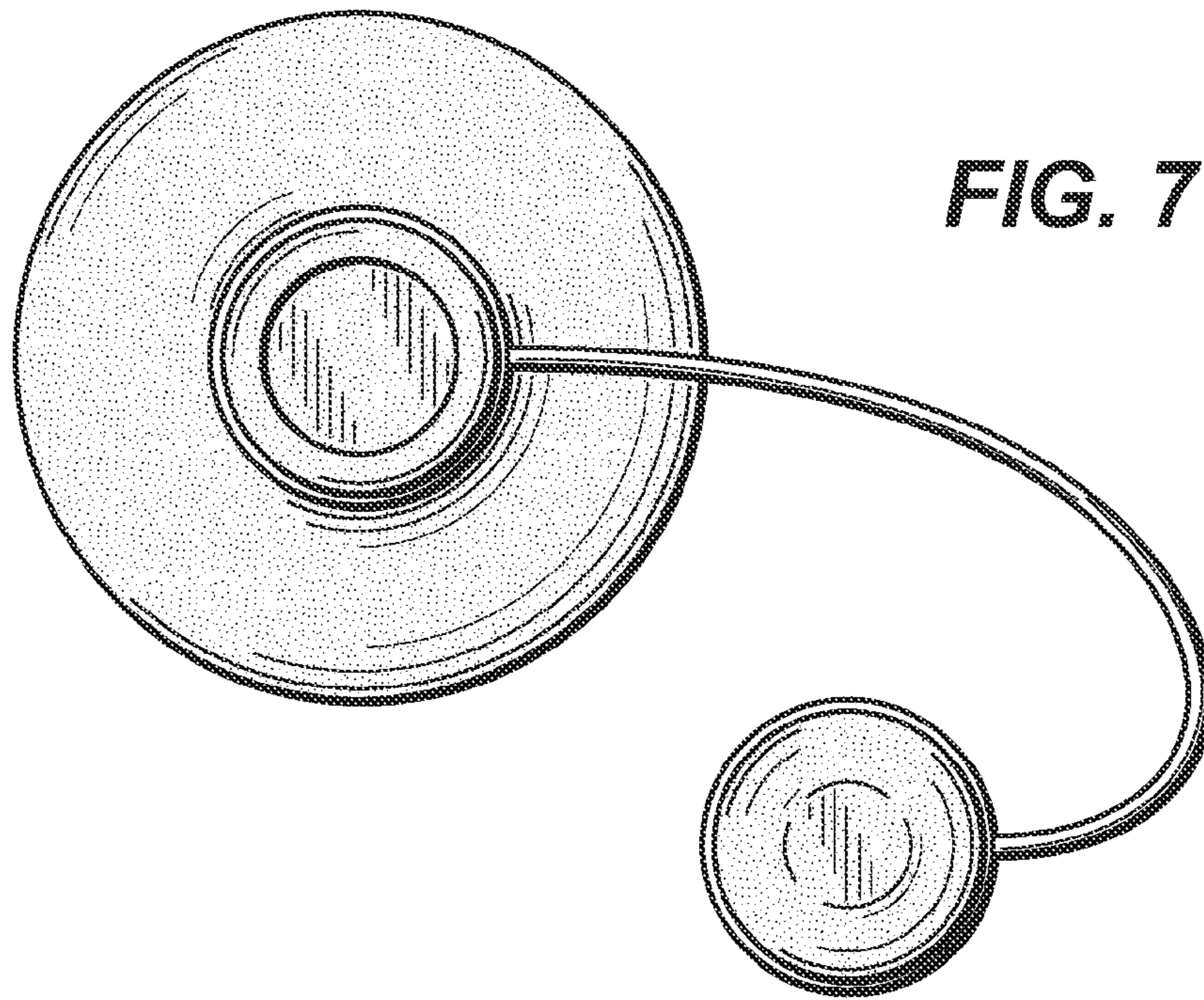

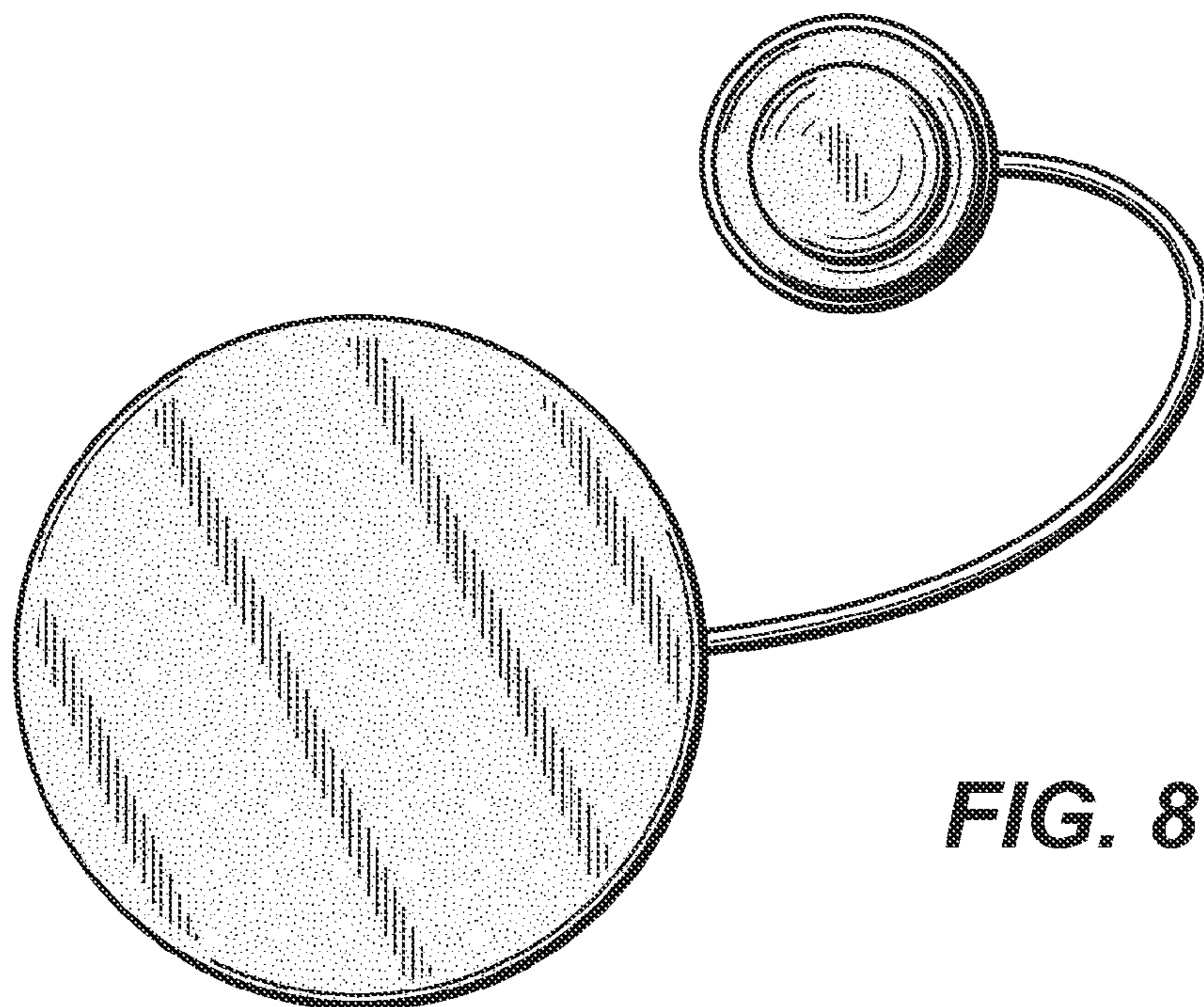
