DESCRIPTION

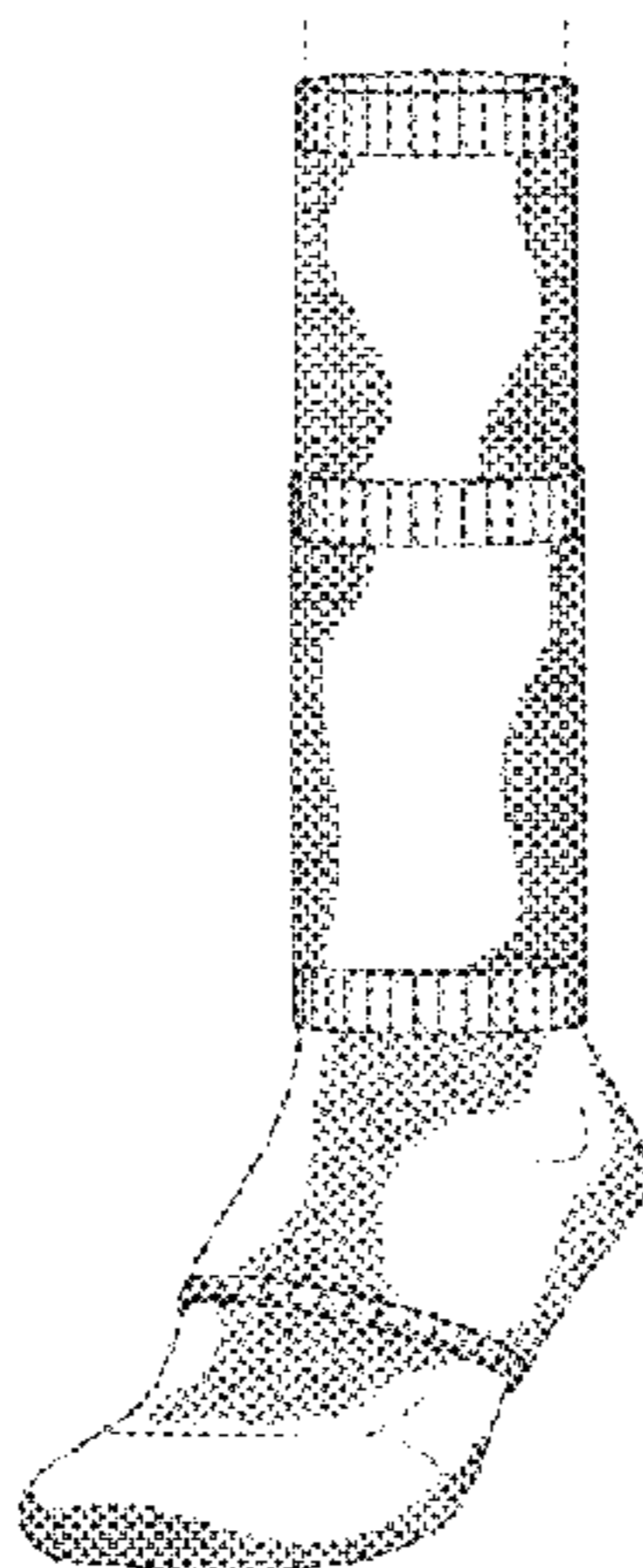
FIG. 1 is a front, top and left side perspective view of the

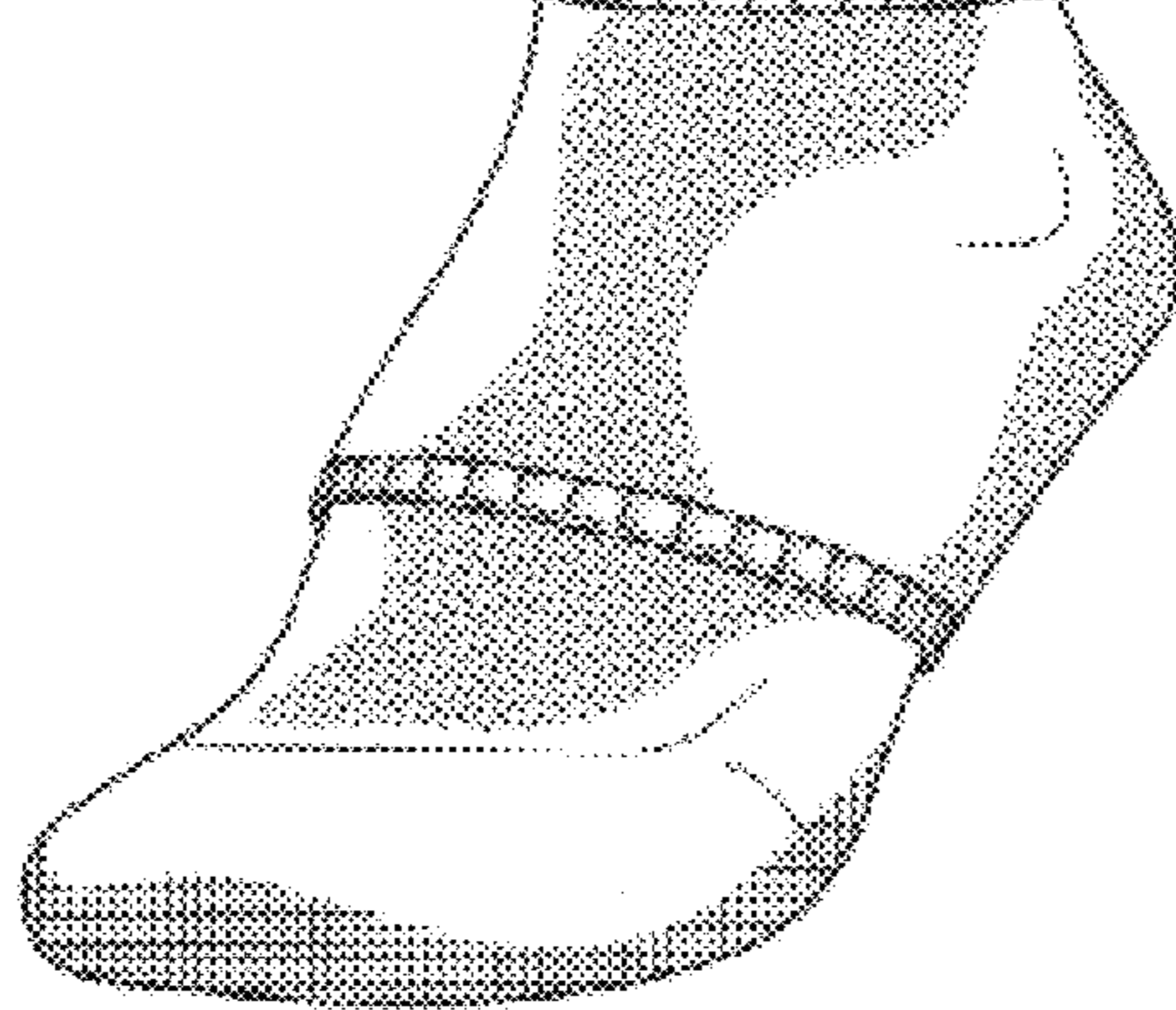
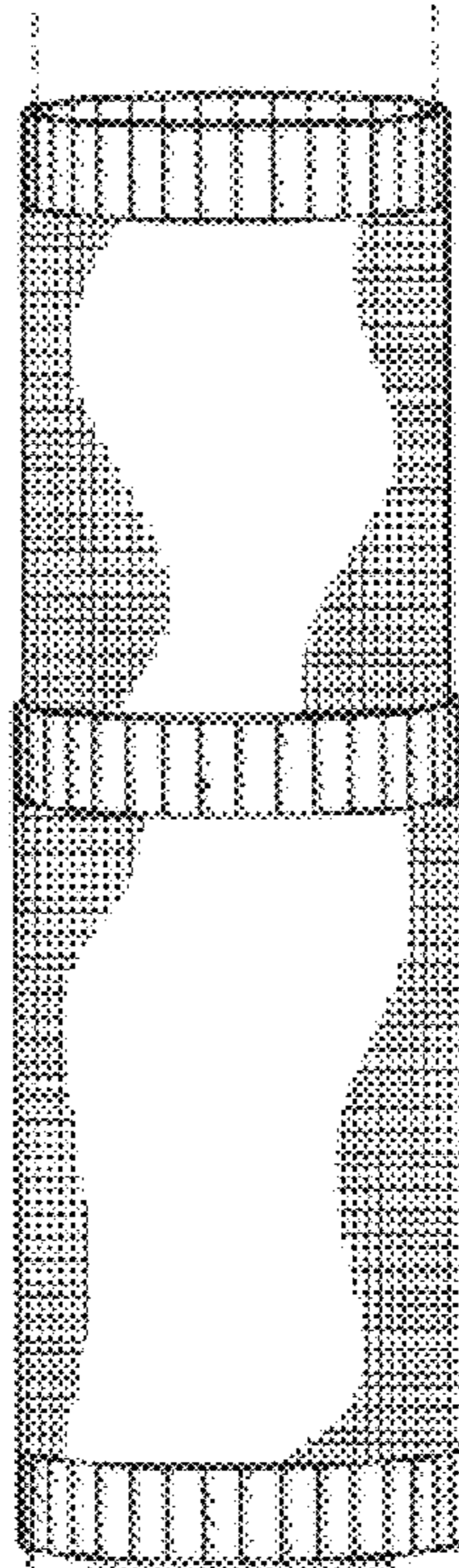

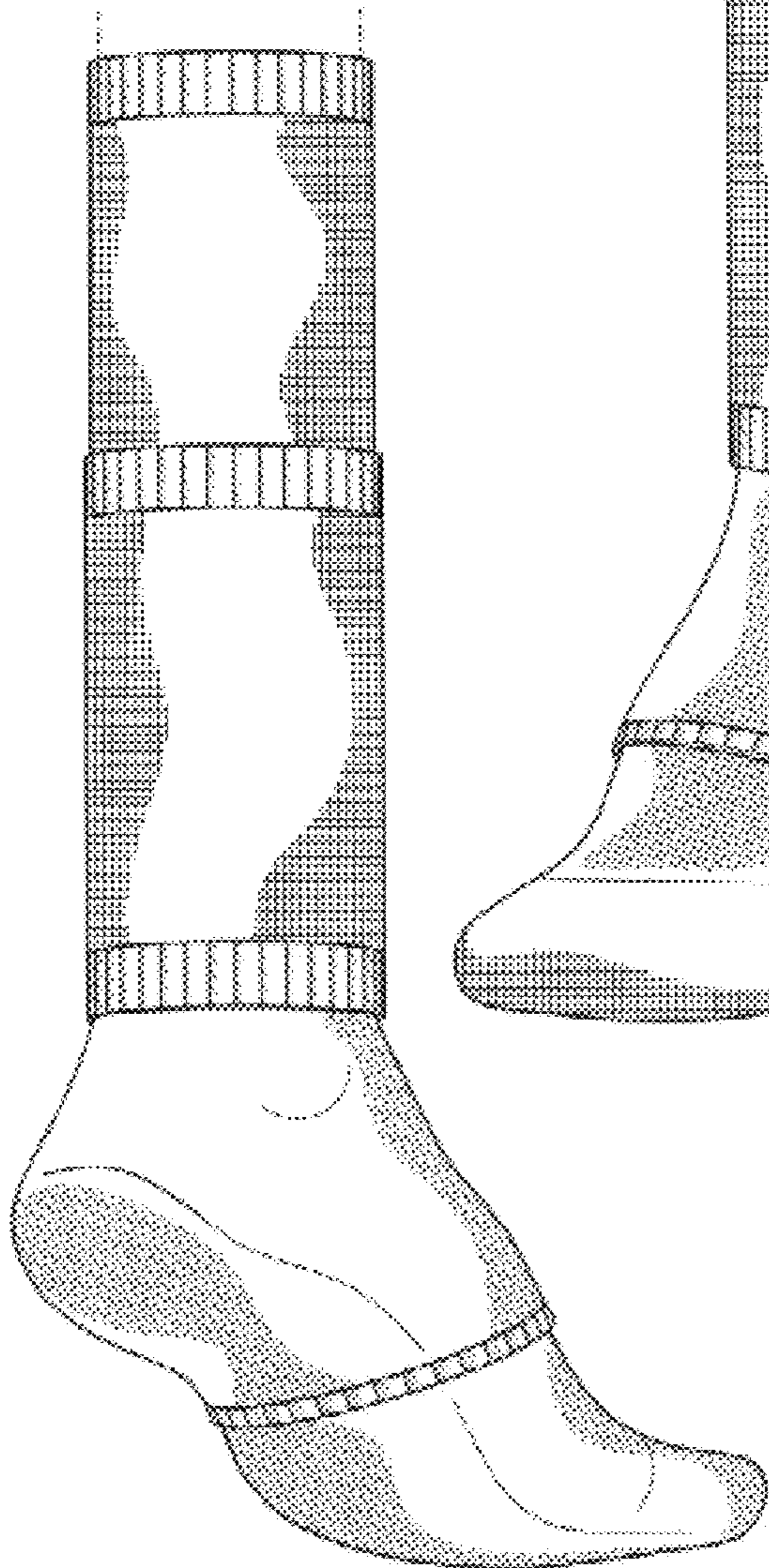
