(57) **CLAIM**

The ornamental design for a grill brush attachment having spiral bristles and auxiliary scraper, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear isometric view of a grill brush attachment having spiral bristles and auxiliary scraper in accordance with the new design;

FIG. 2 is a rear view thereof;

FIG. 3 is a top view thereof;

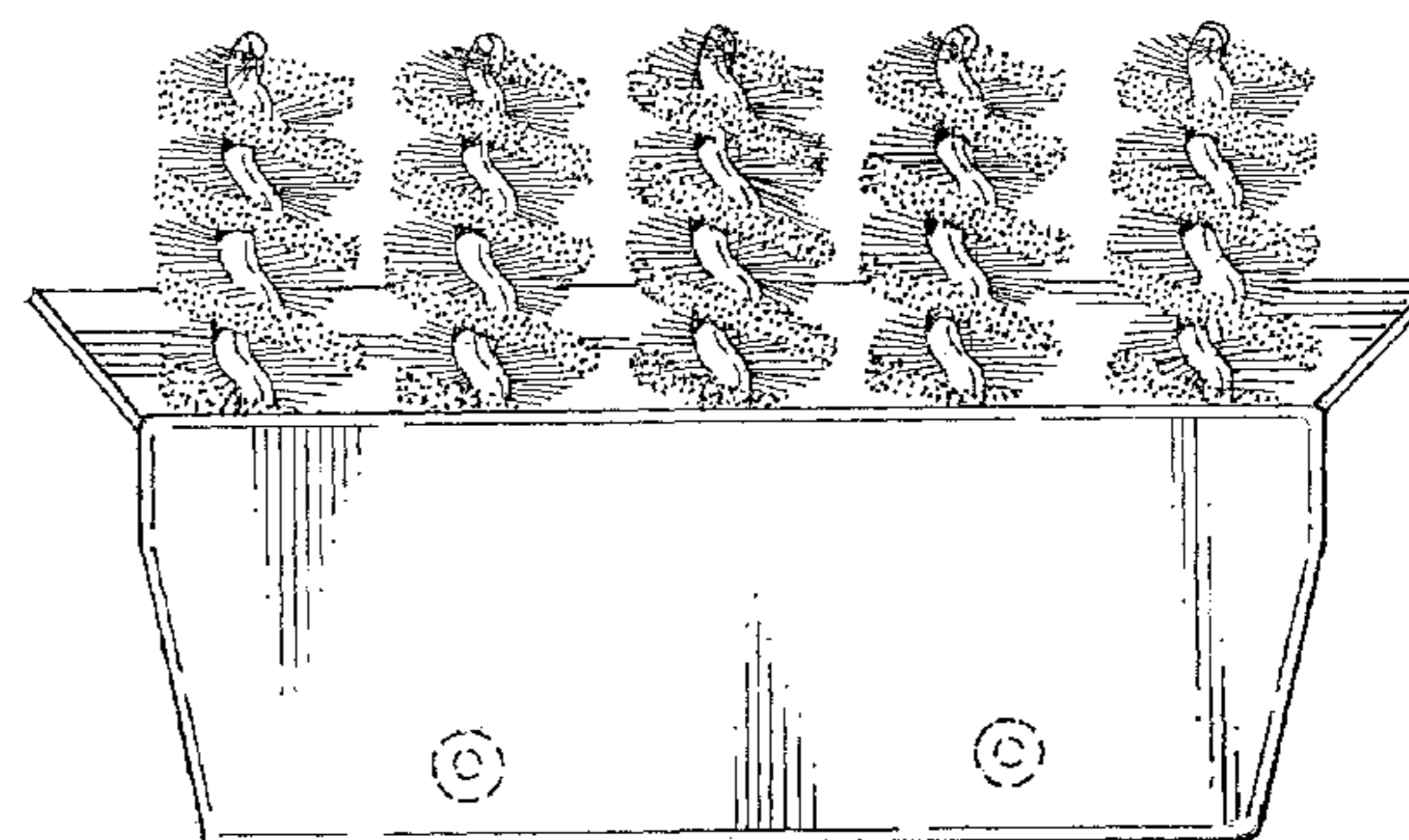
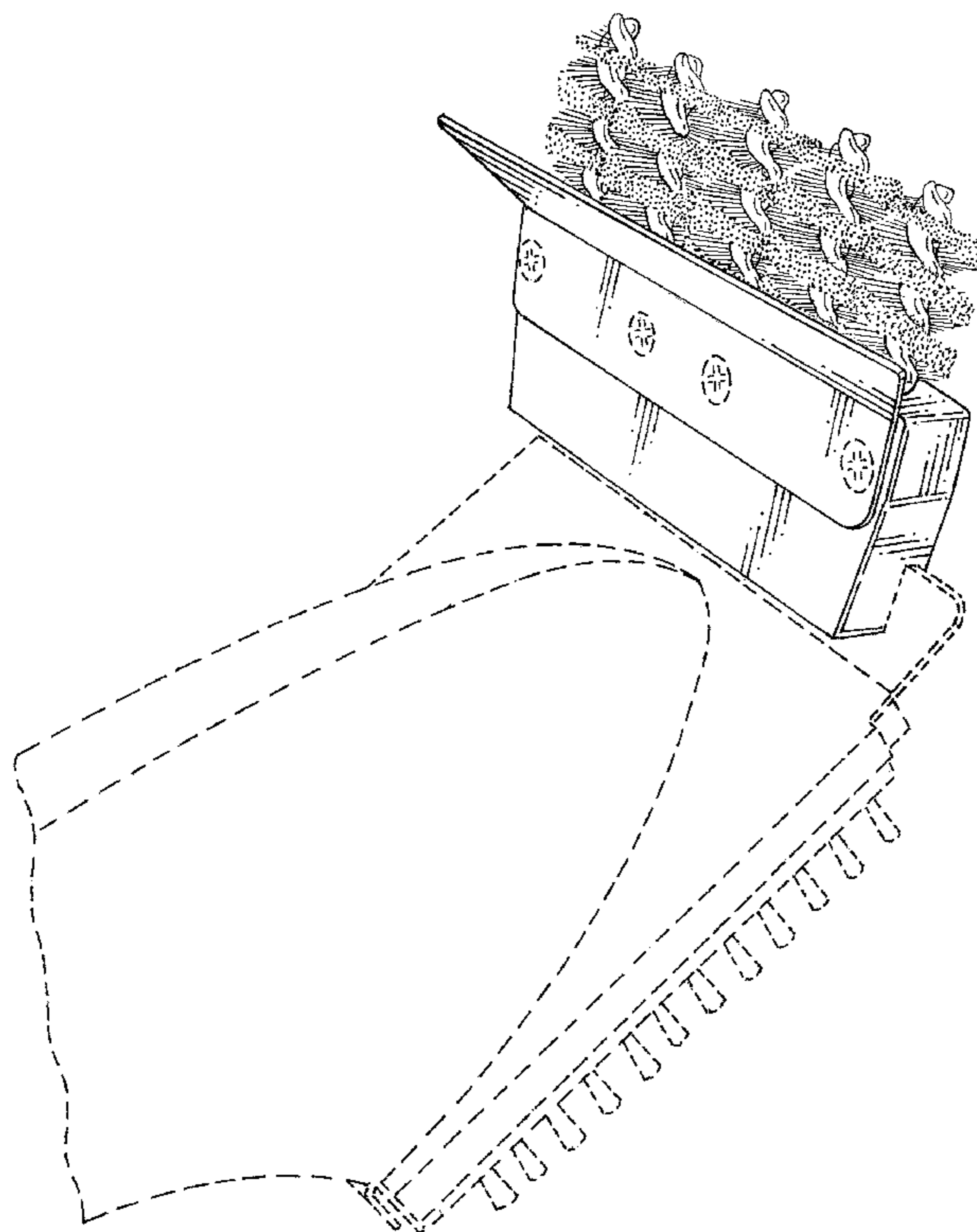
FIG. 4 is a front view thereof;

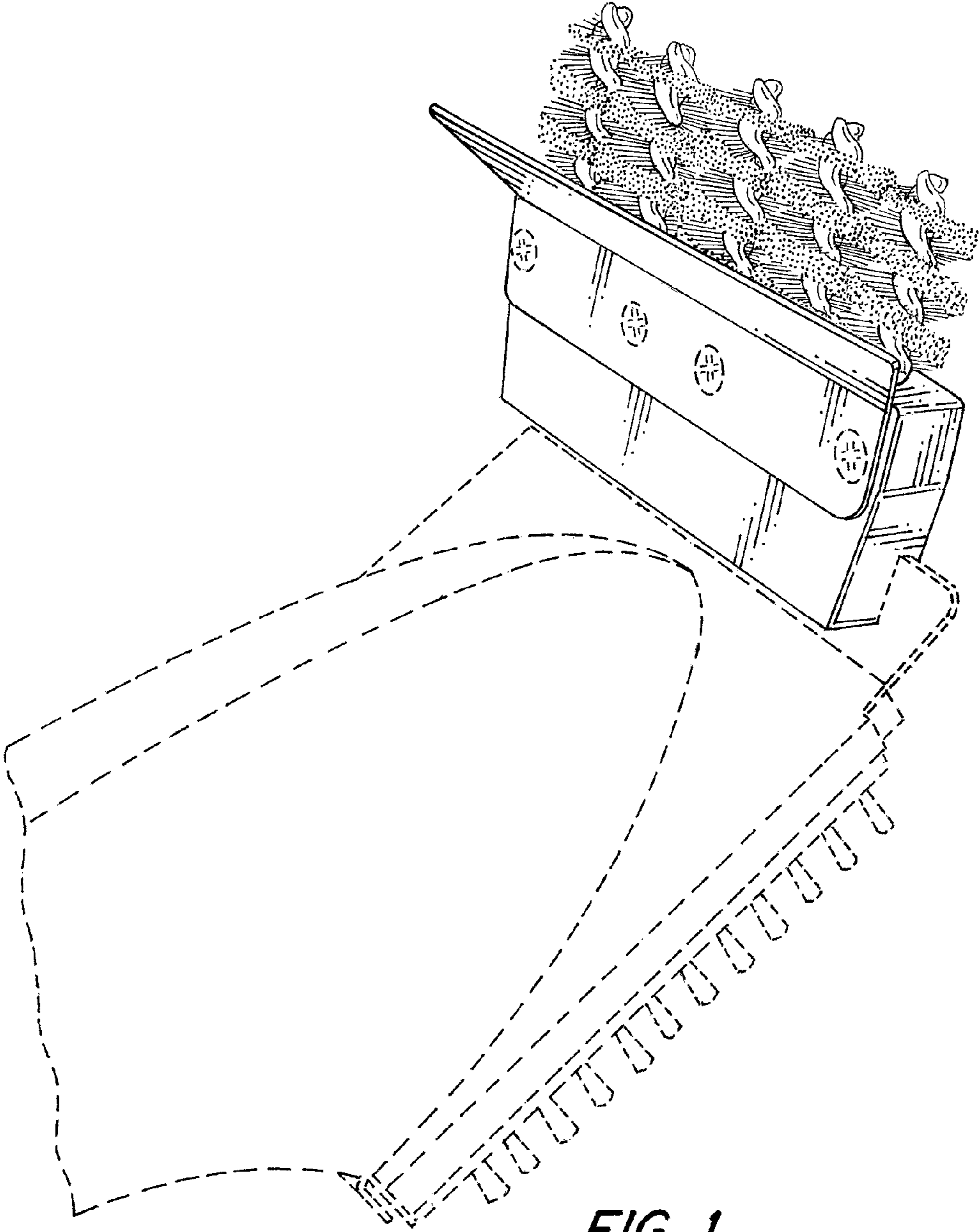
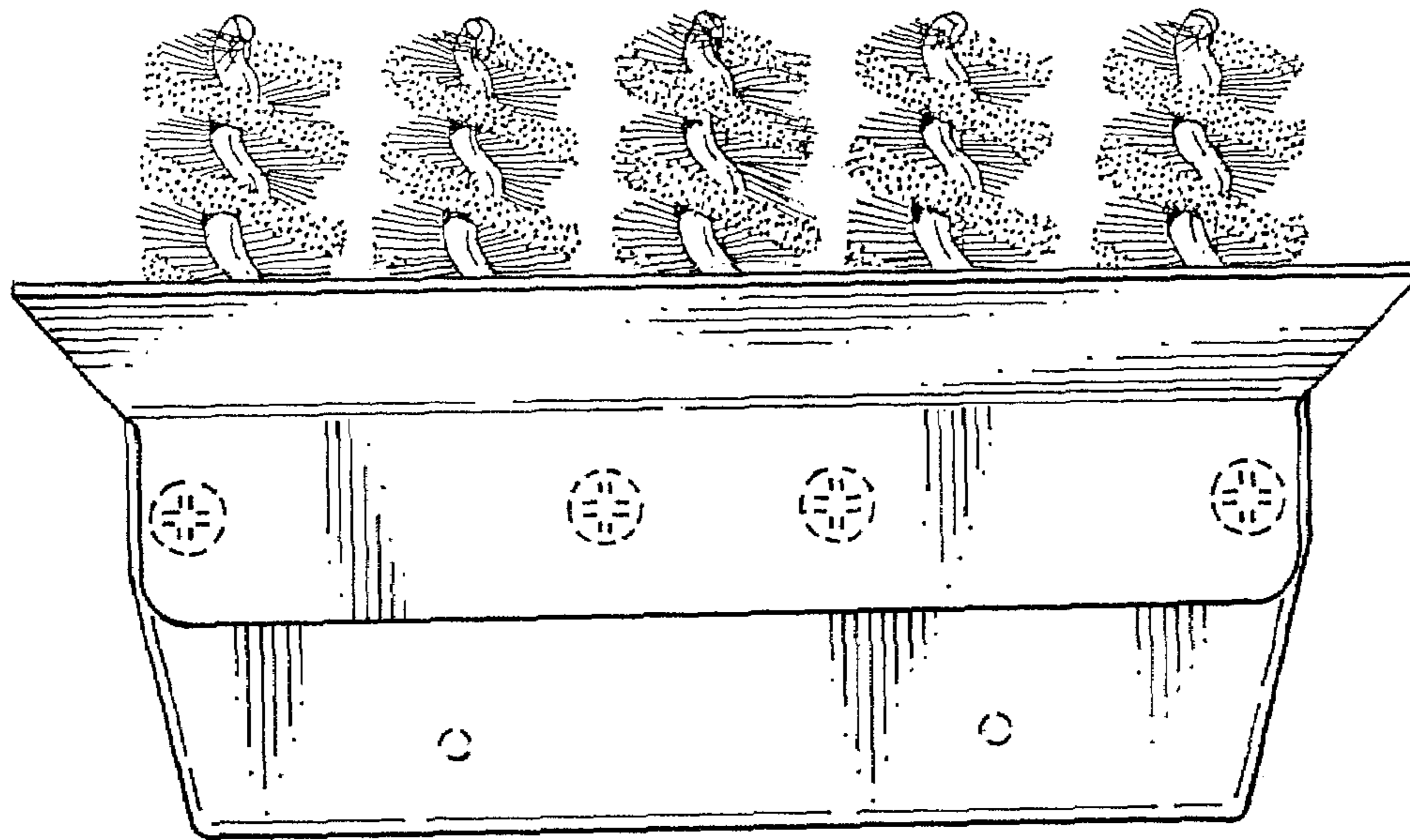
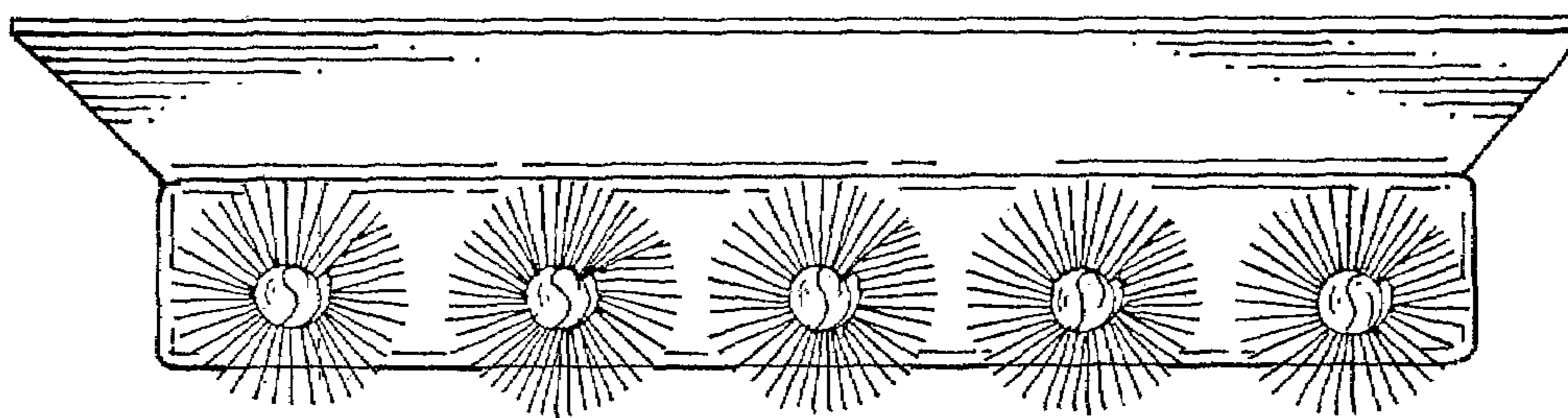

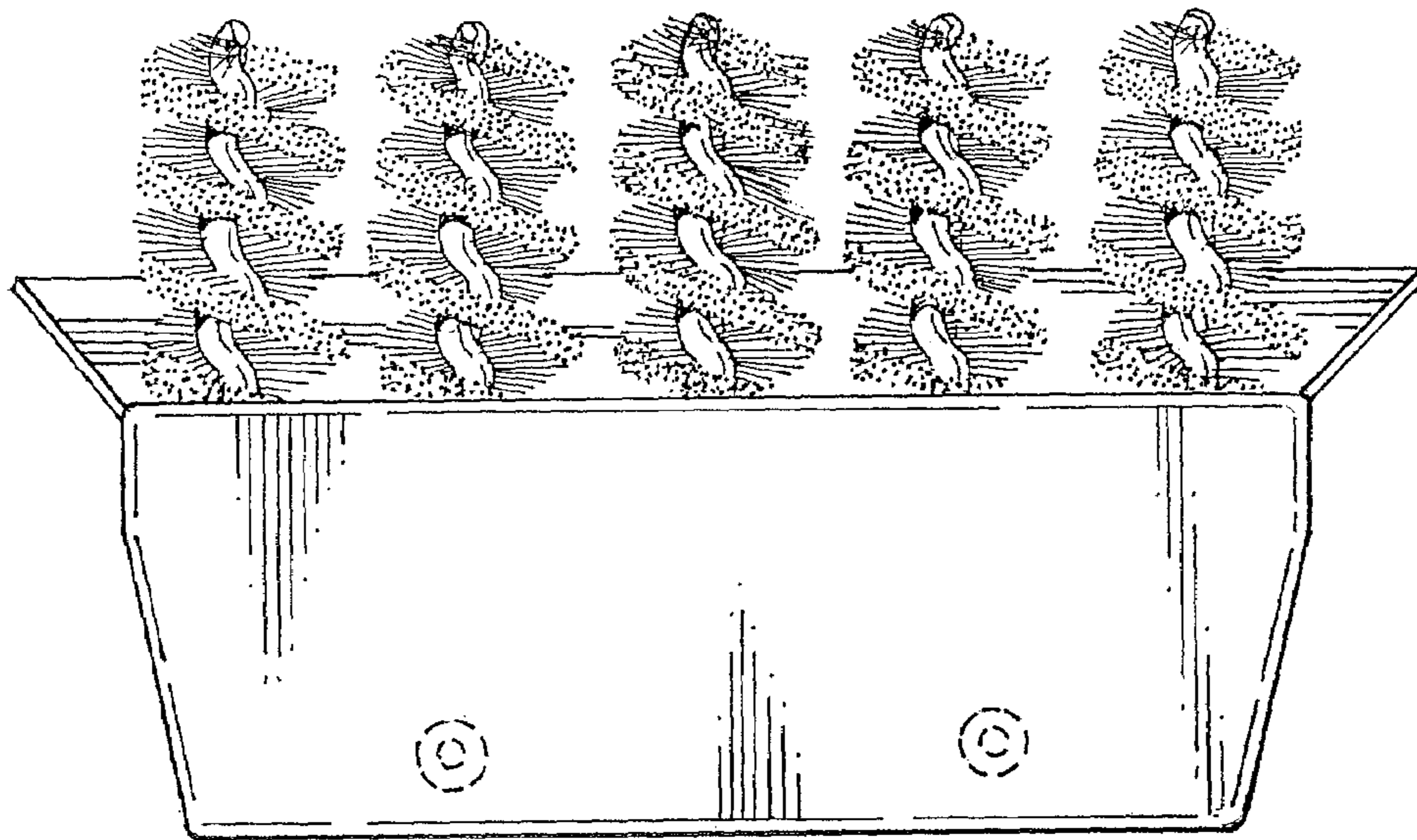

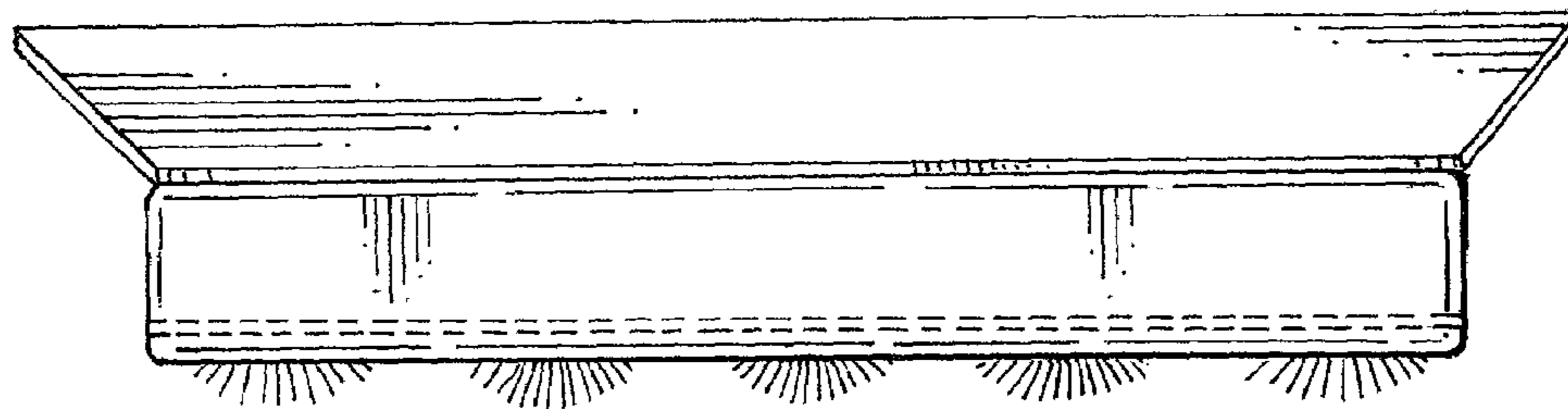
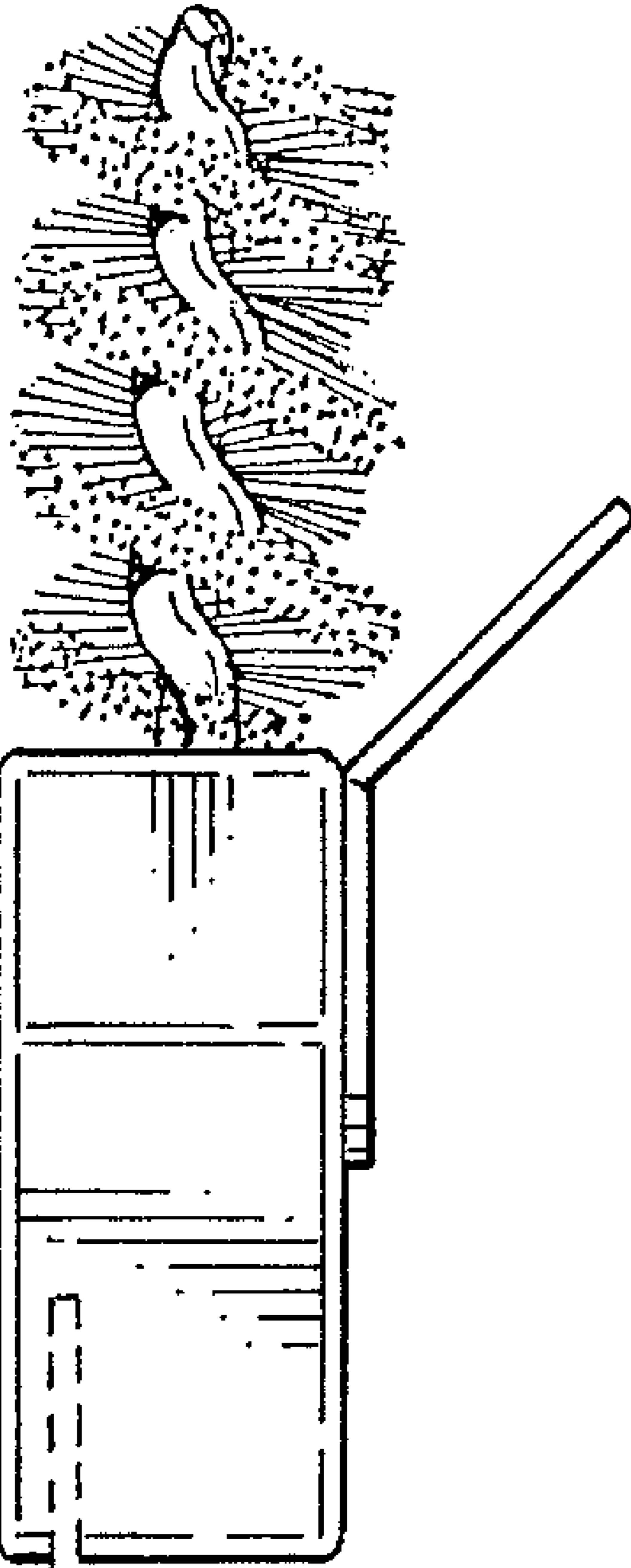
