DESCRIPTION

FIG. 1 is an enlarged perspective view of a first embodiment of my new design.

FIG. 13 is a cross-sectional view along line 13—13 of FIG. 11.

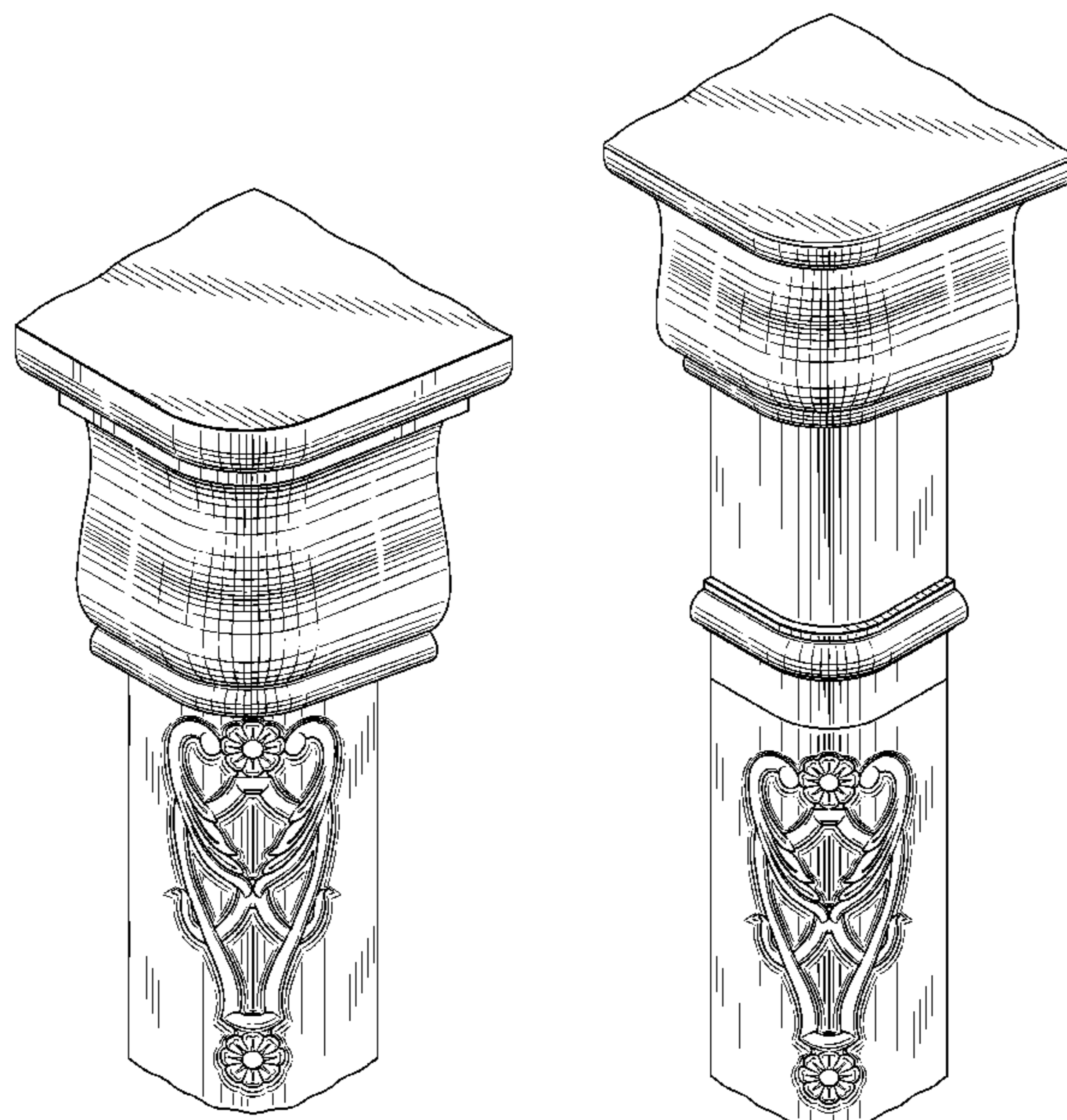
FIG. 14. Is a cross-sectional view along line 14—14 of FIG. 11.

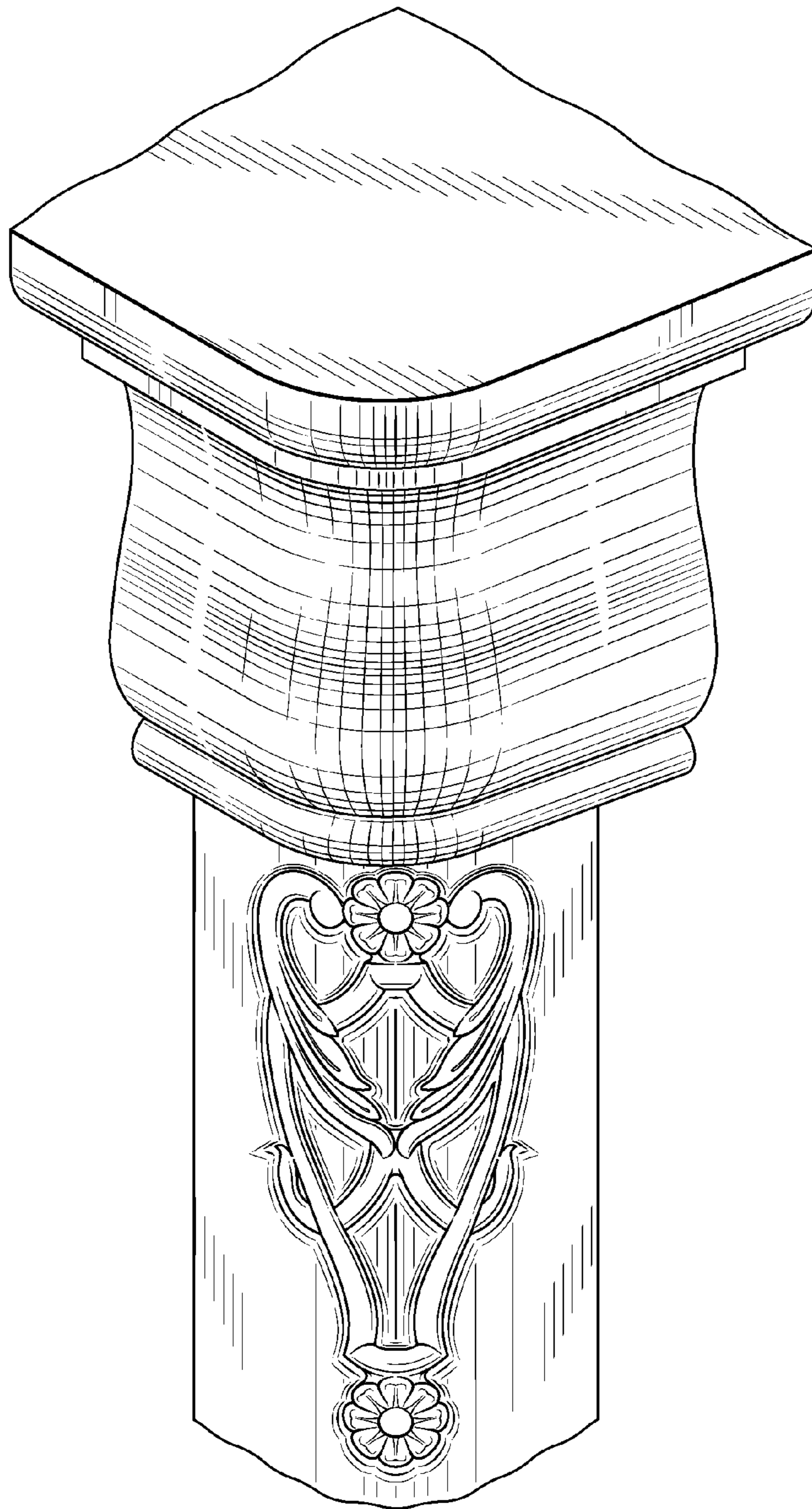

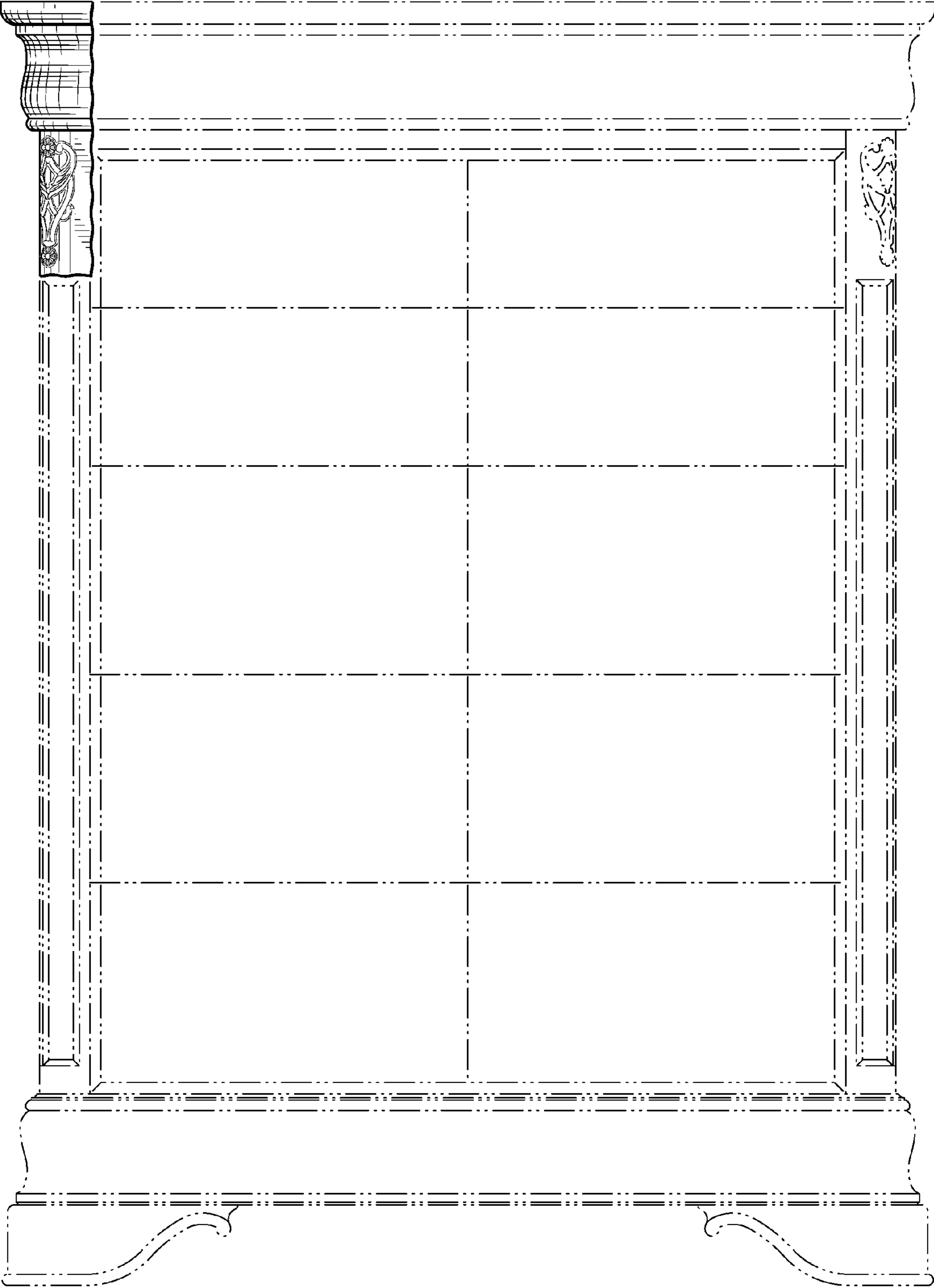

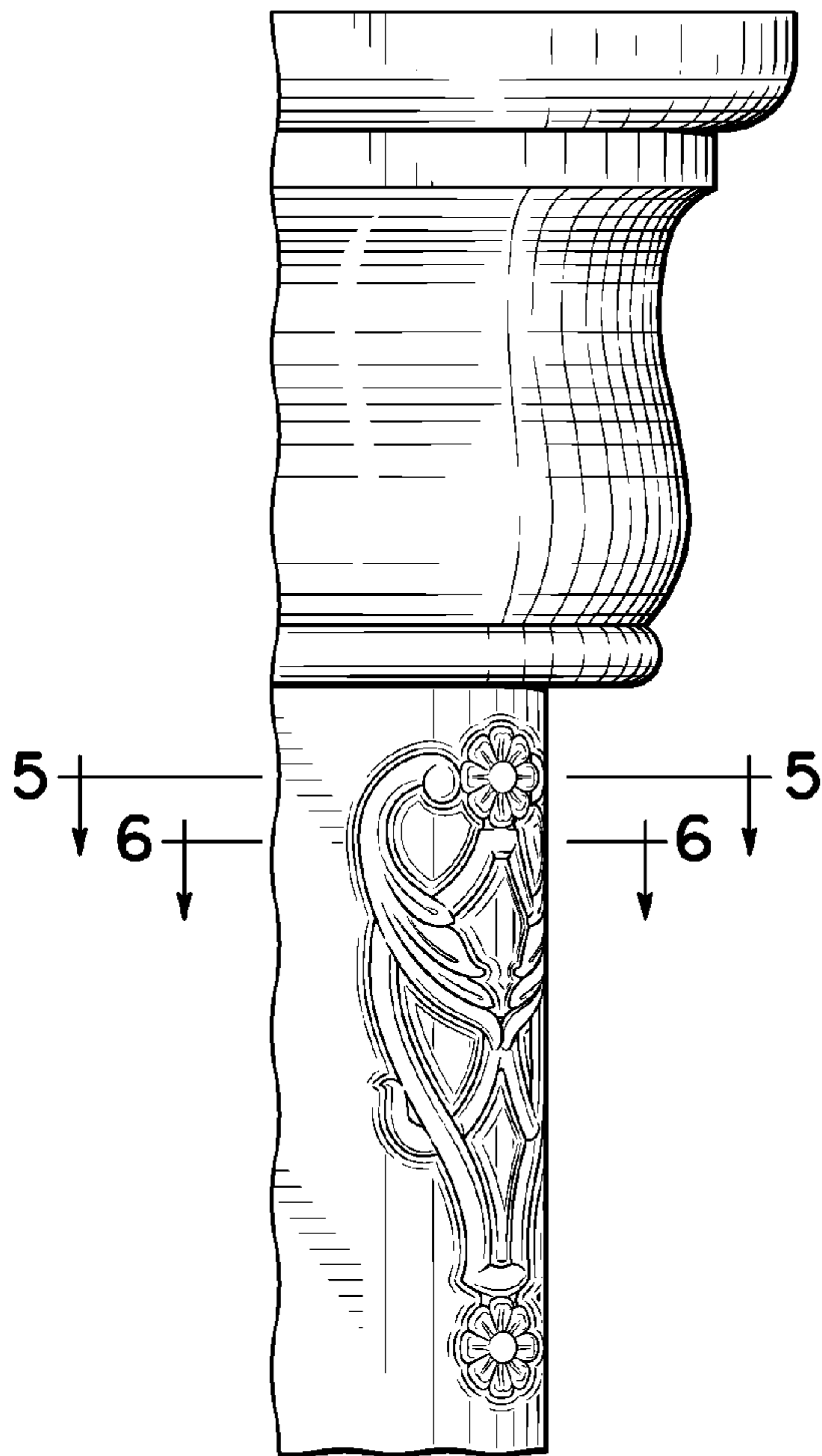

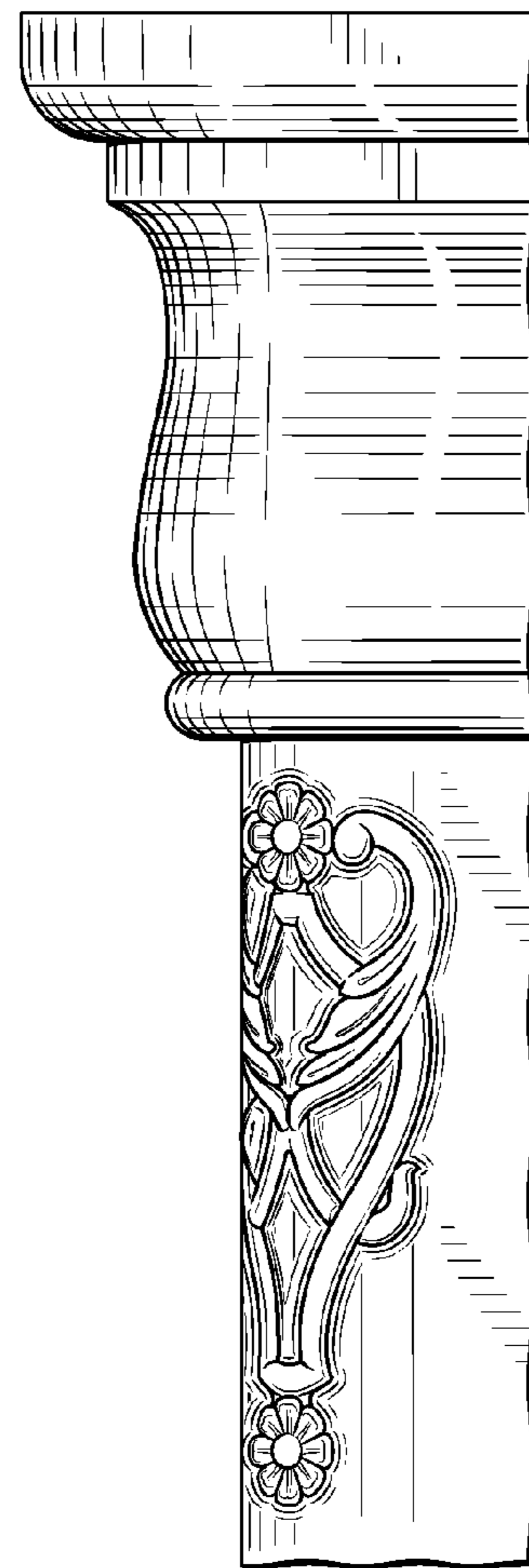

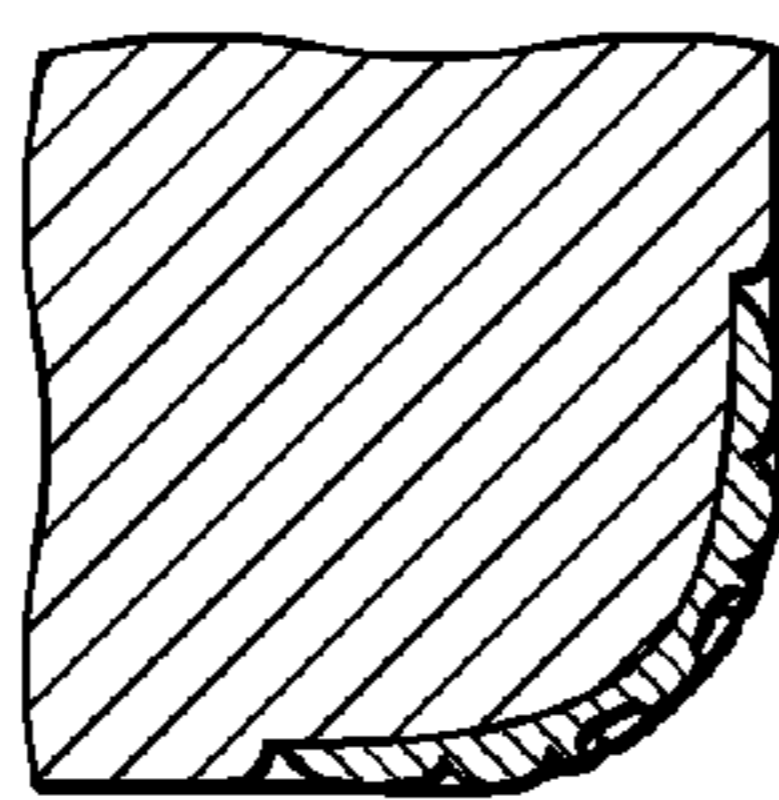

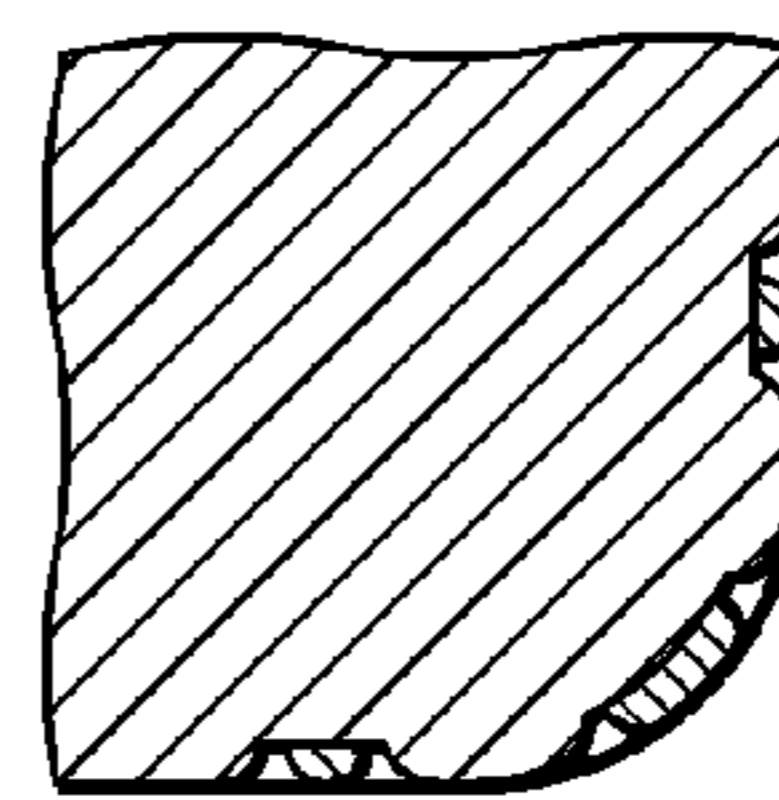

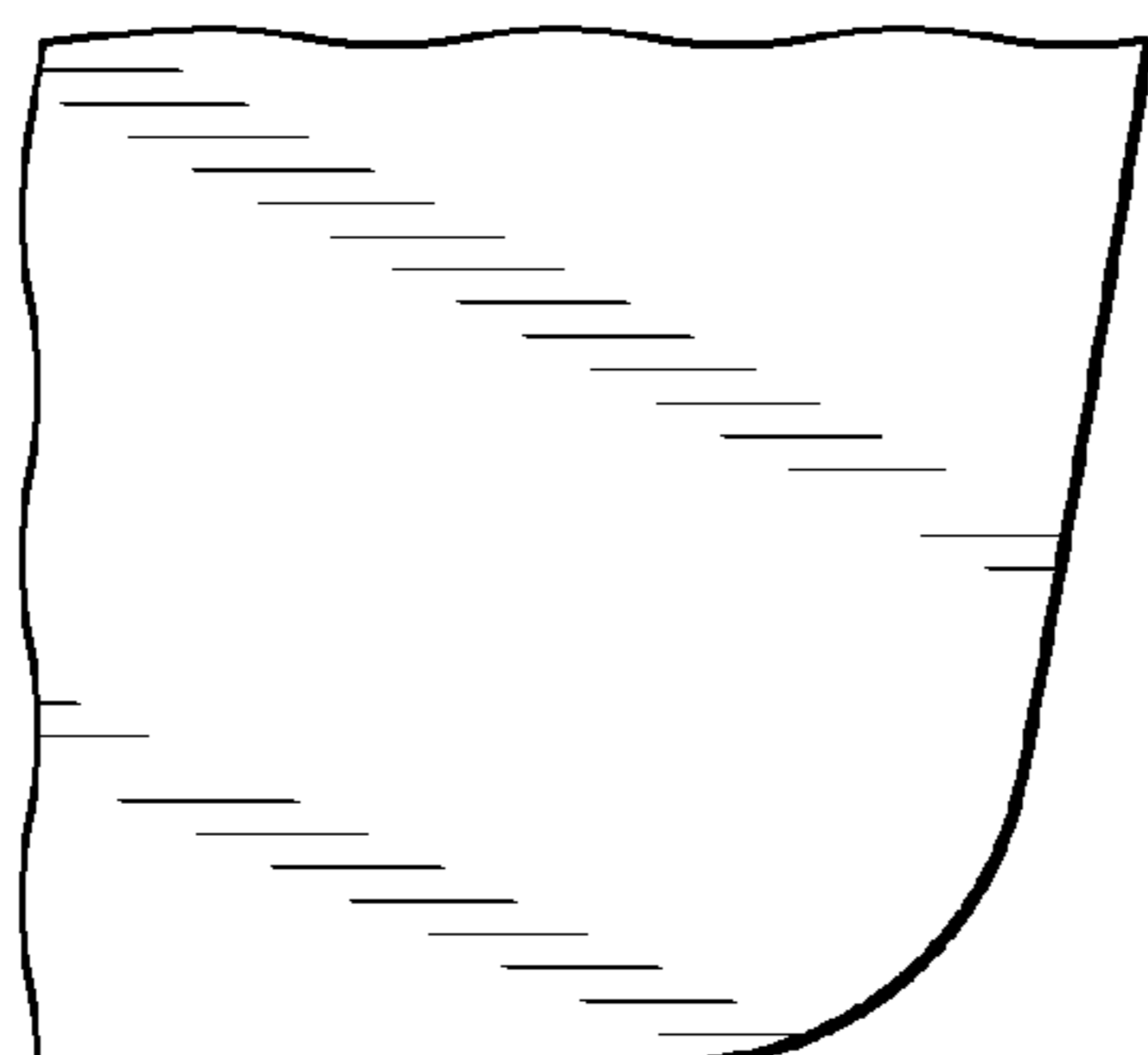

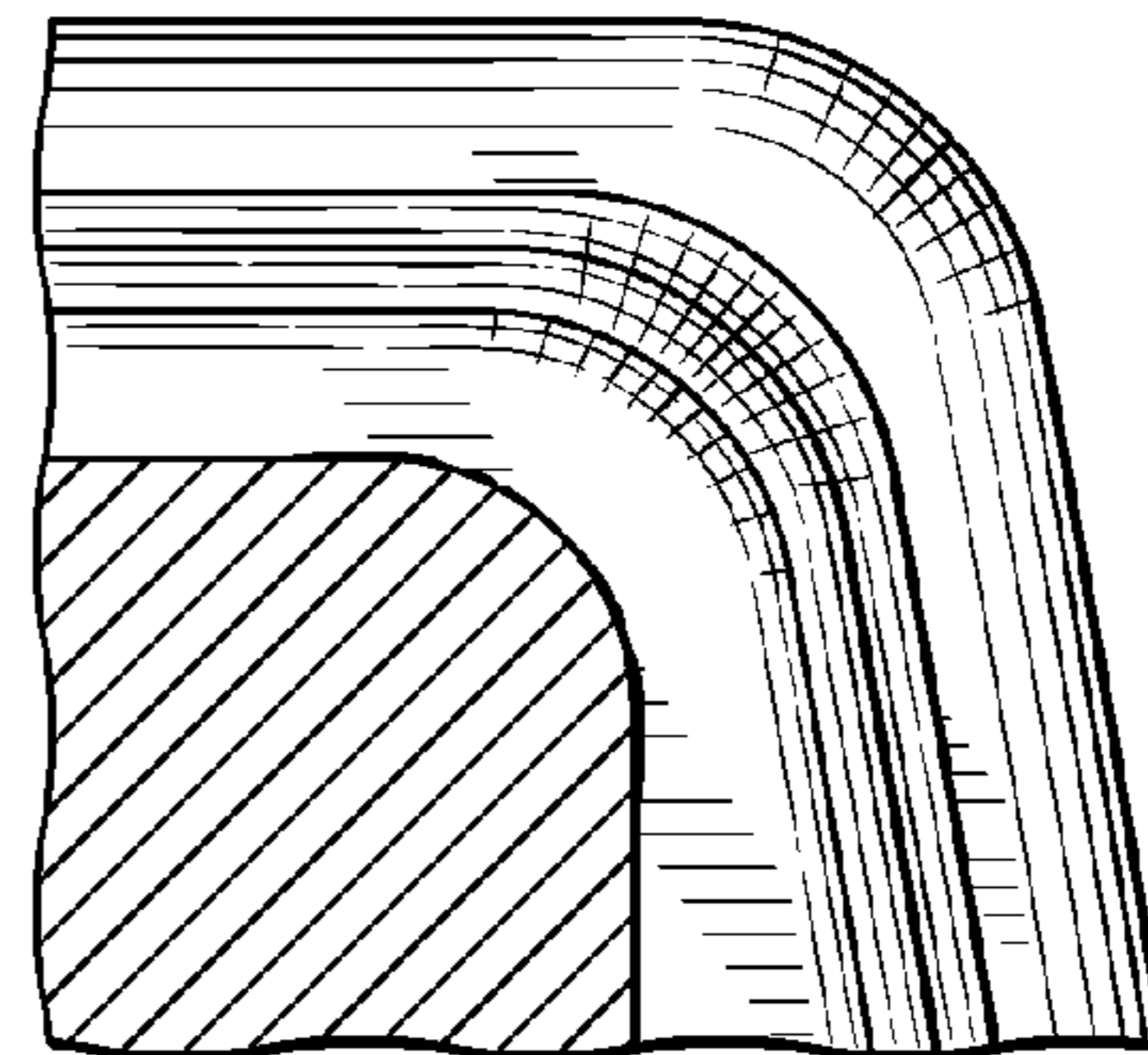

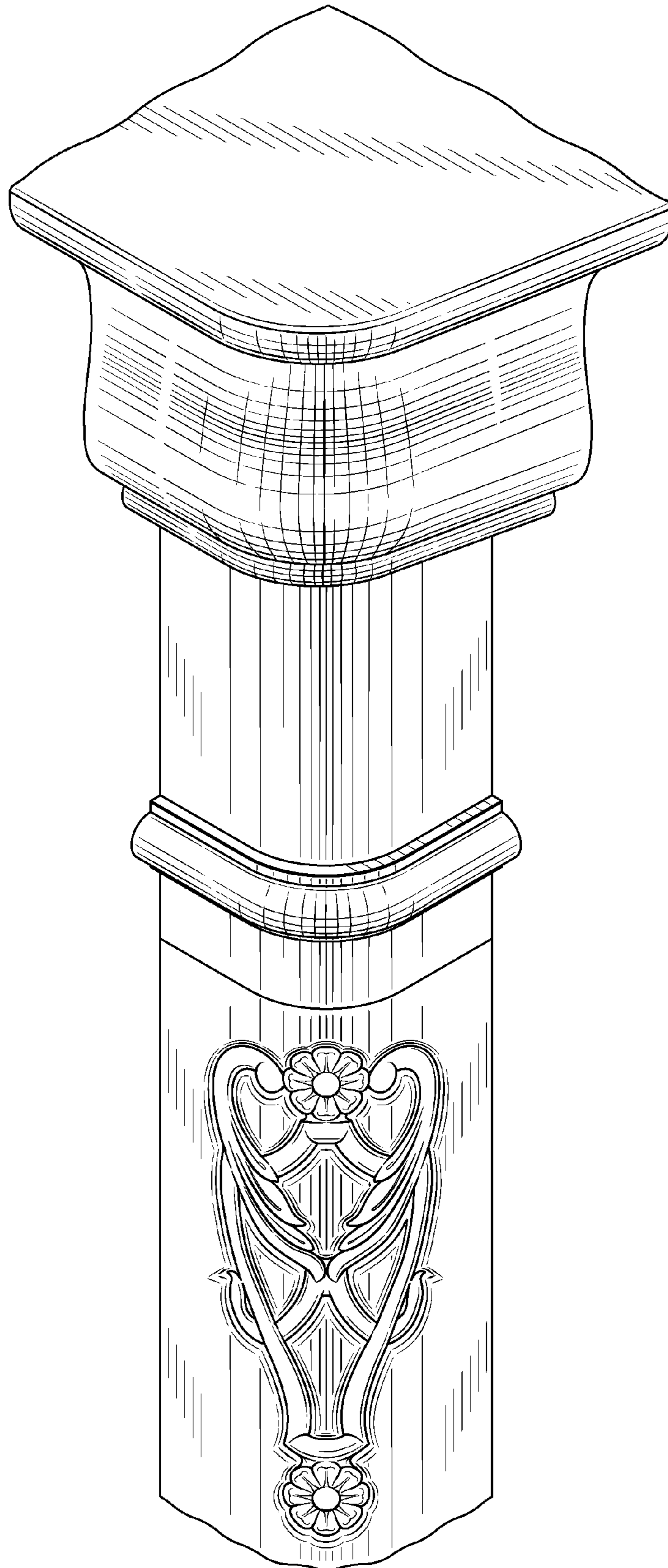

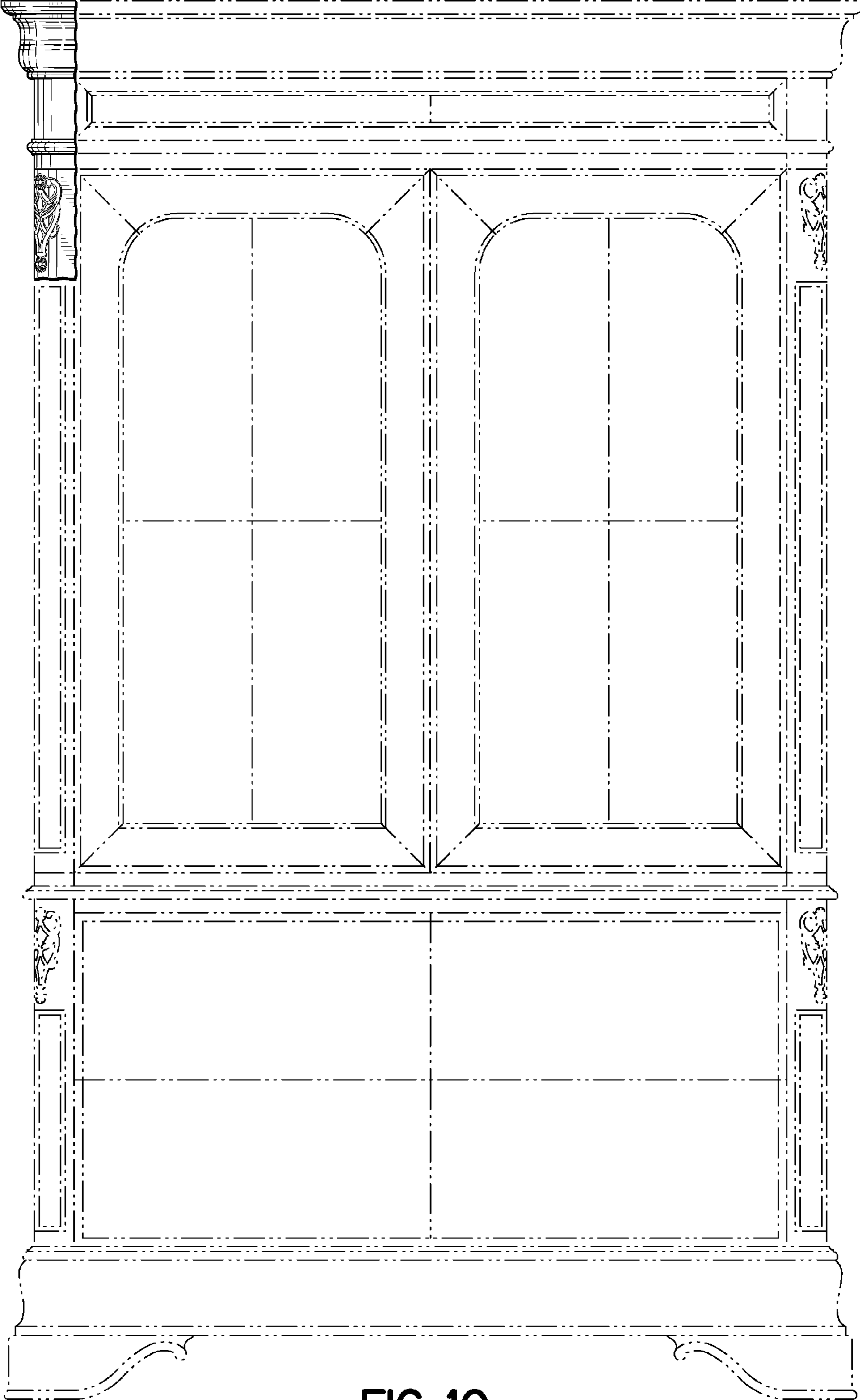

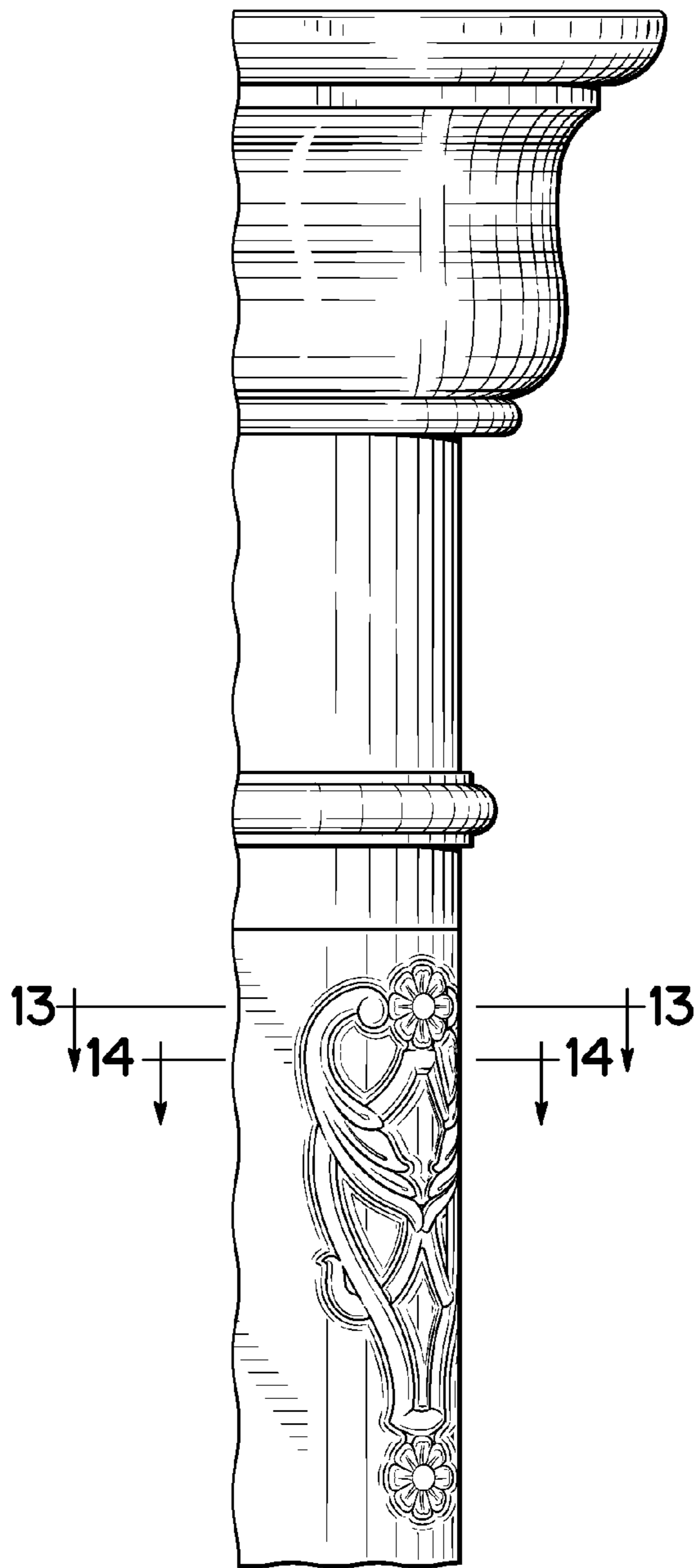

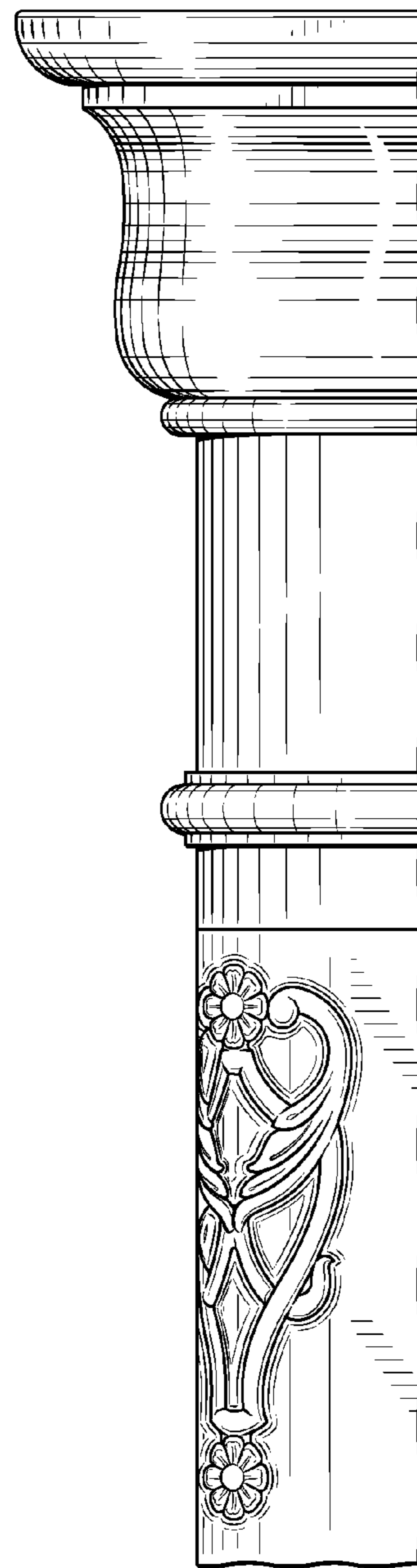

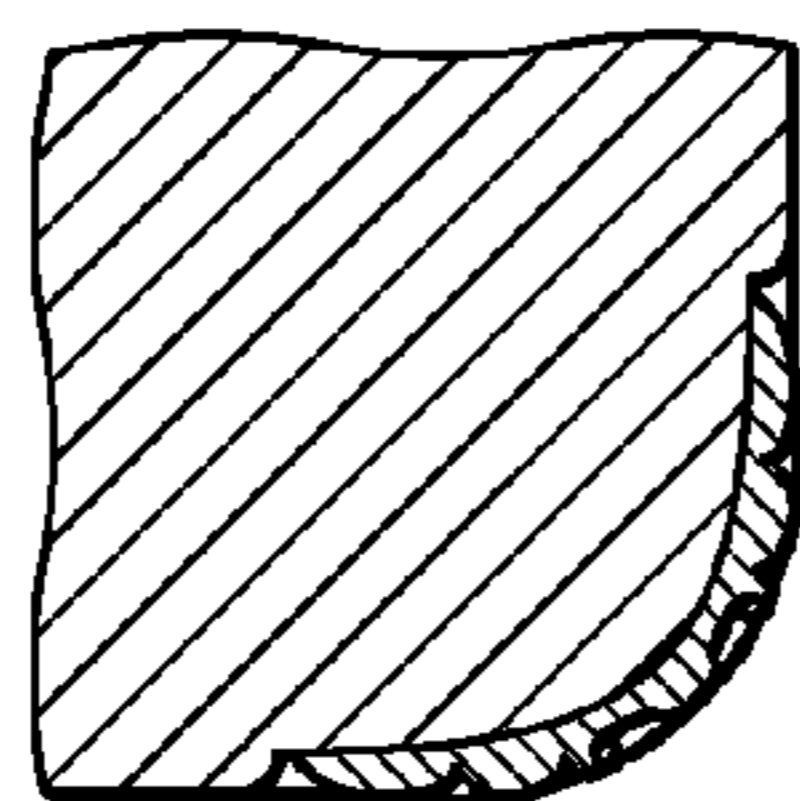

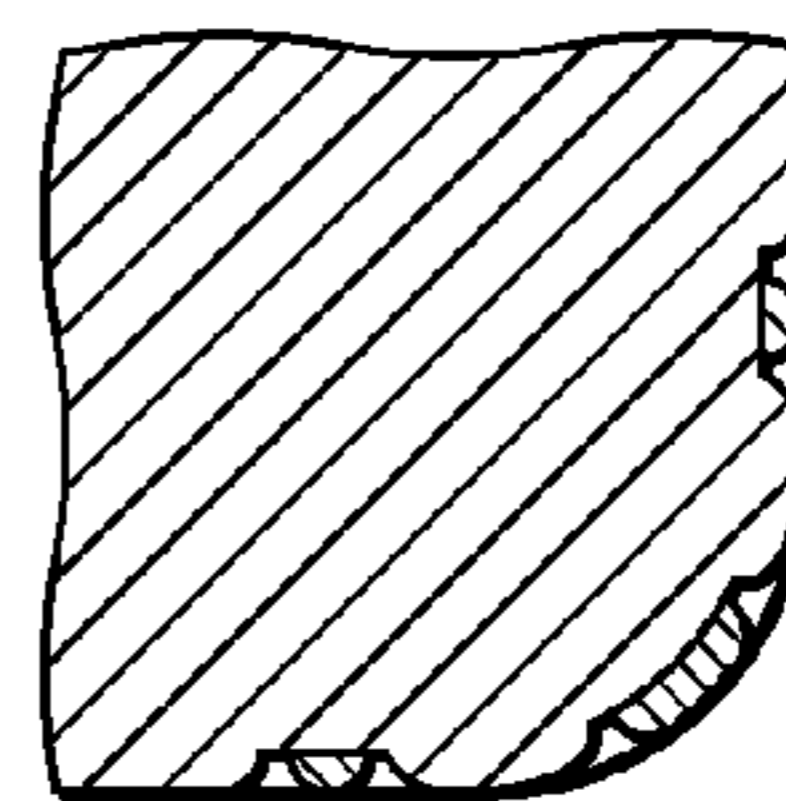

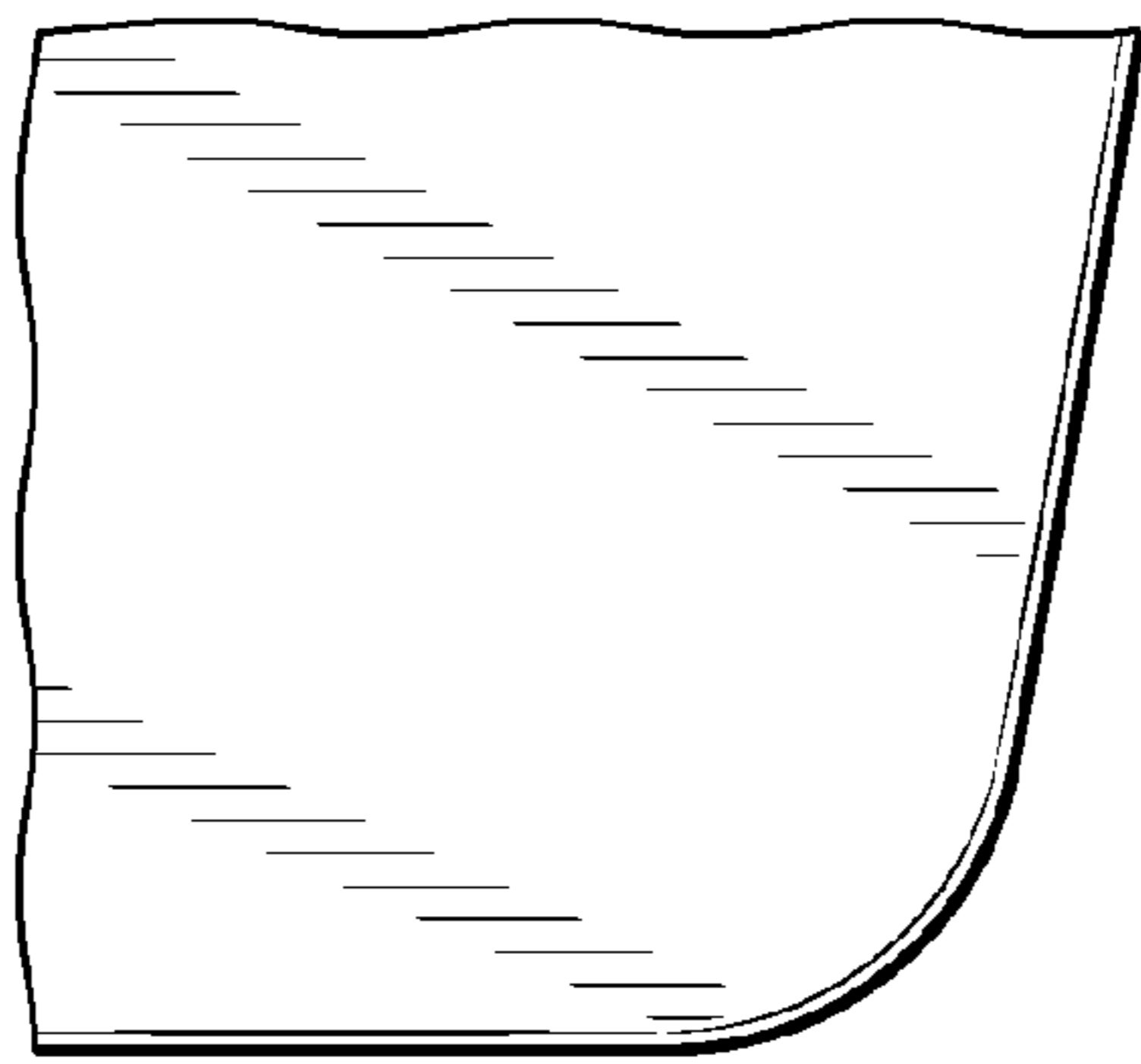

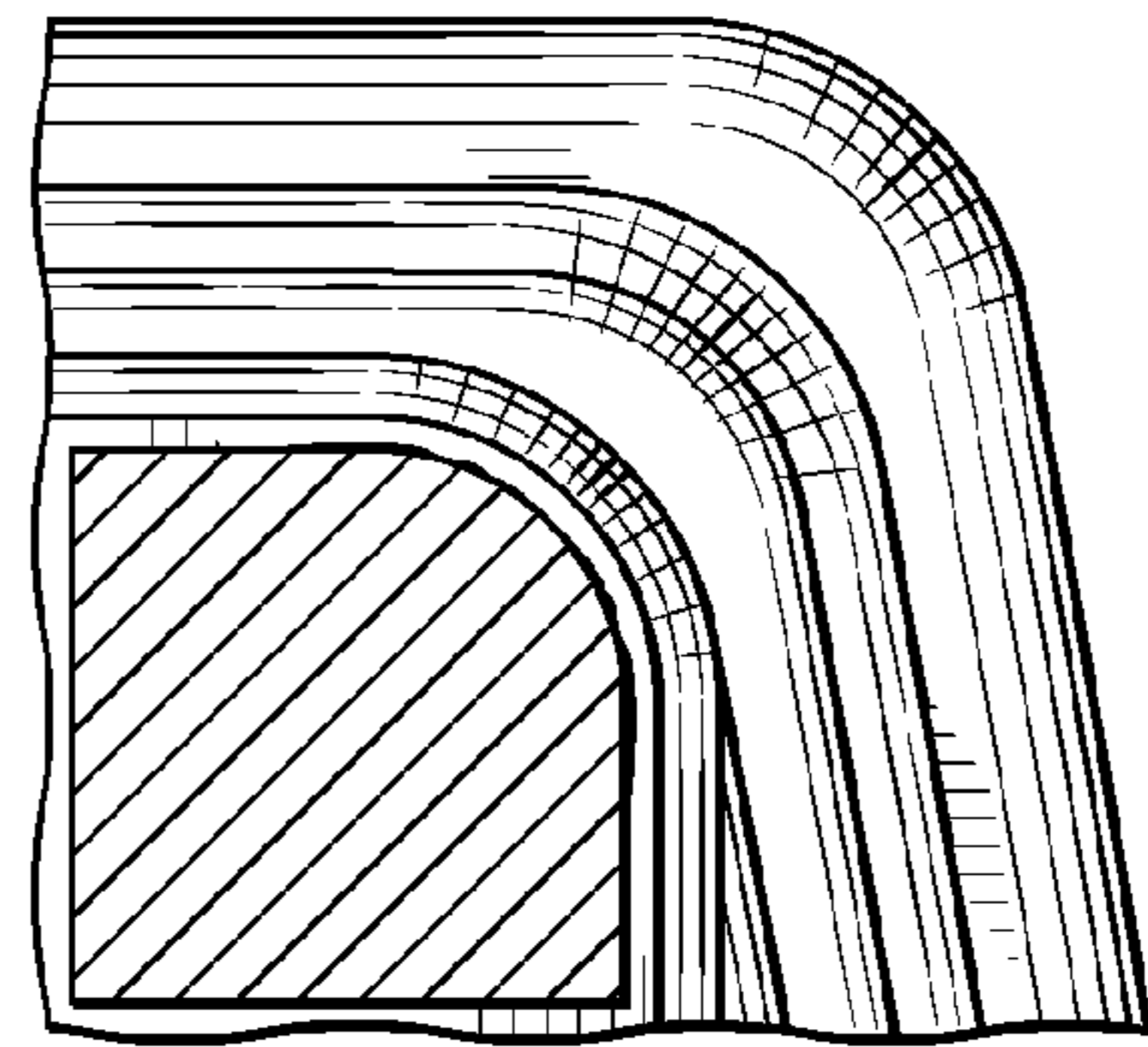
