FIG. 2 is a perspective view, from below, of the container base.

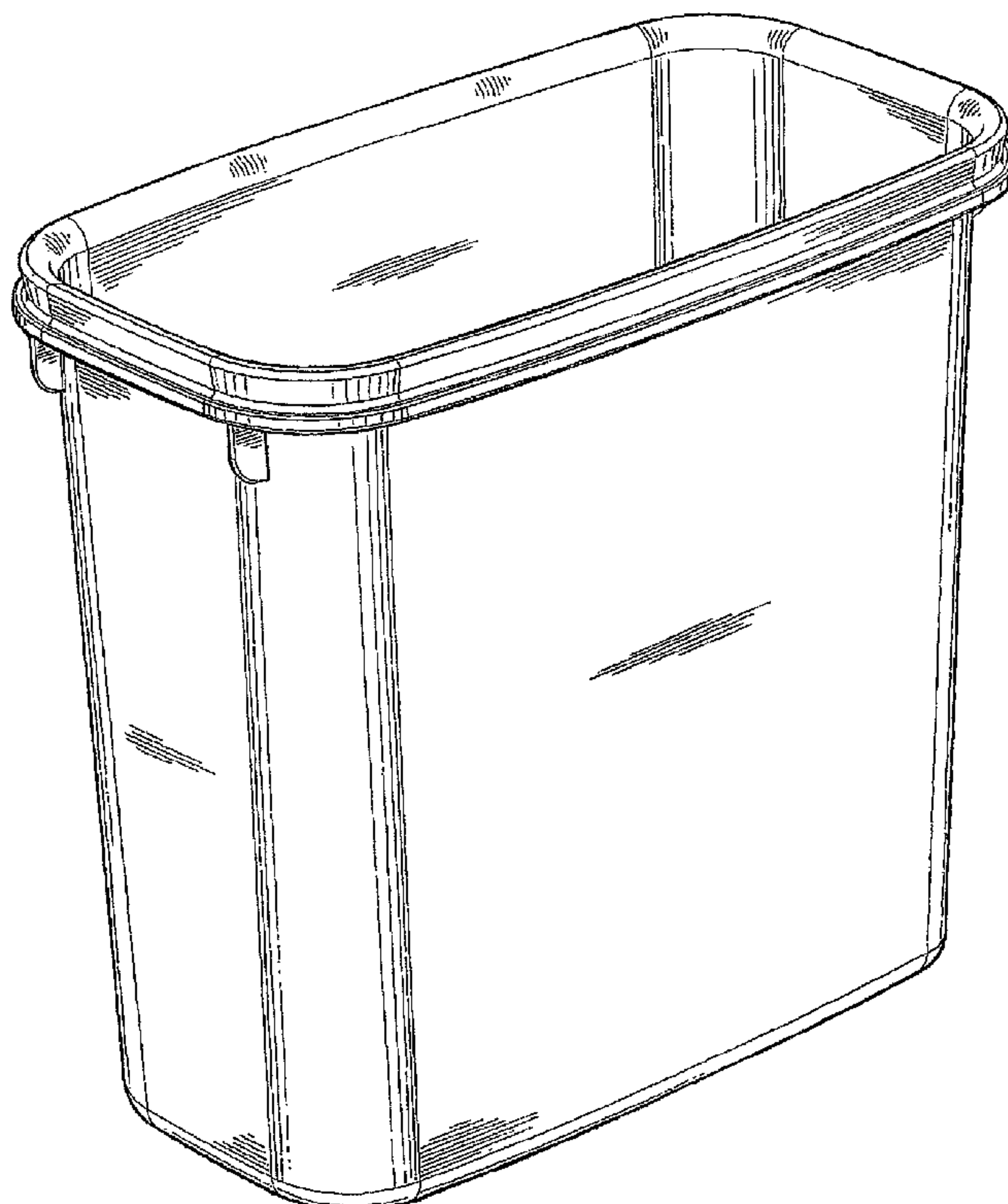
FIG. 3 is a front view of the container base. The back view of the container base is the same as the front view.

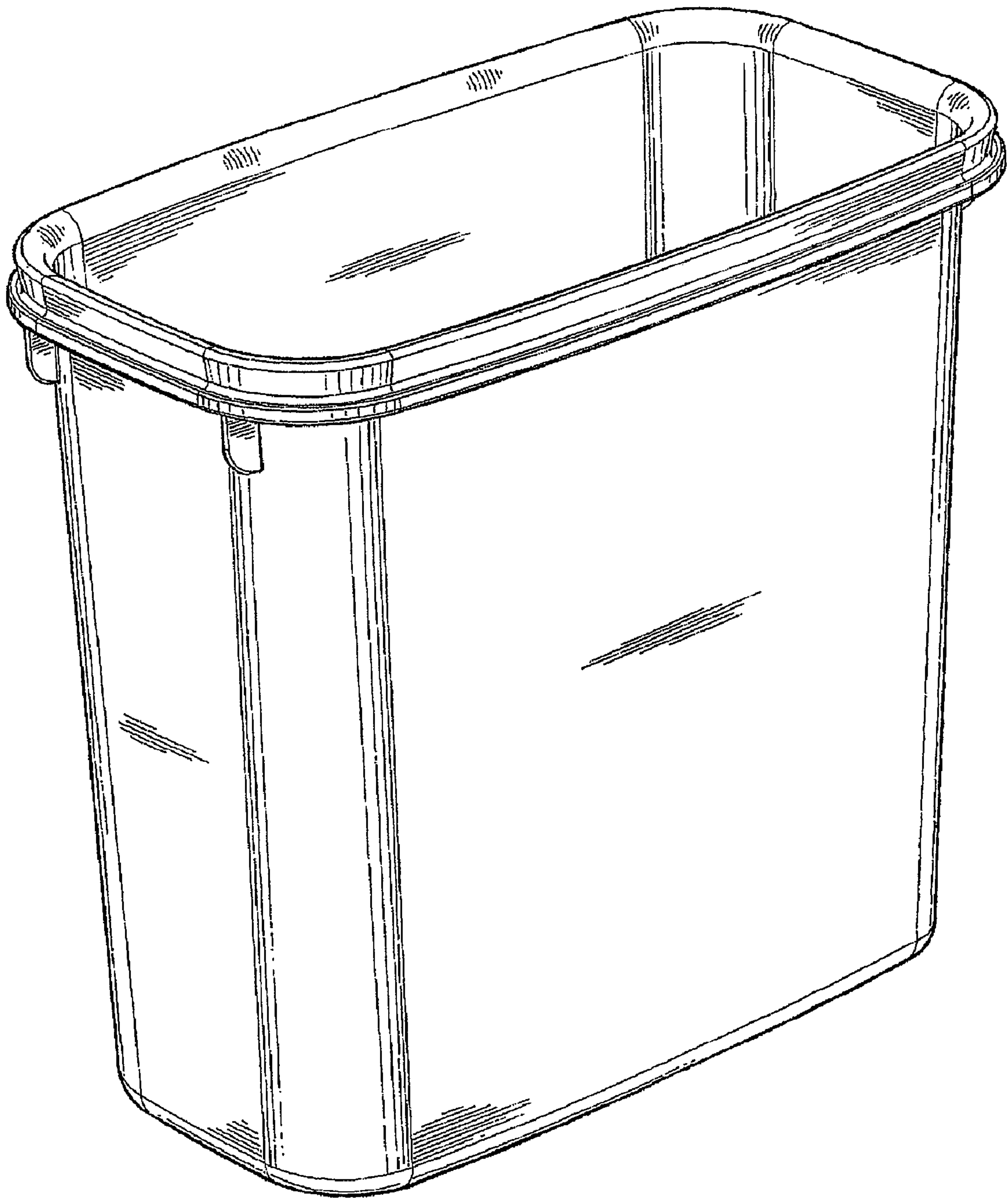

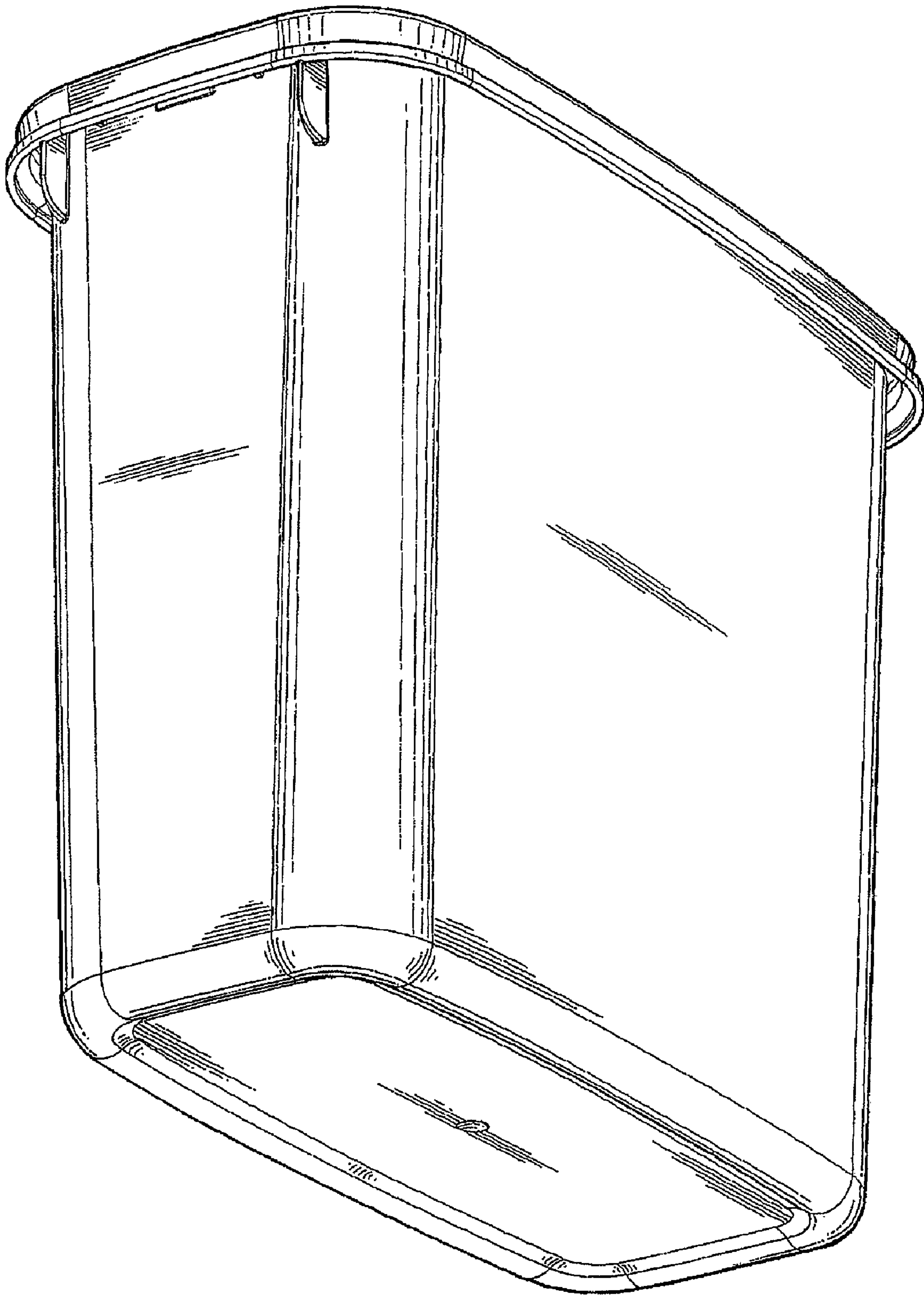

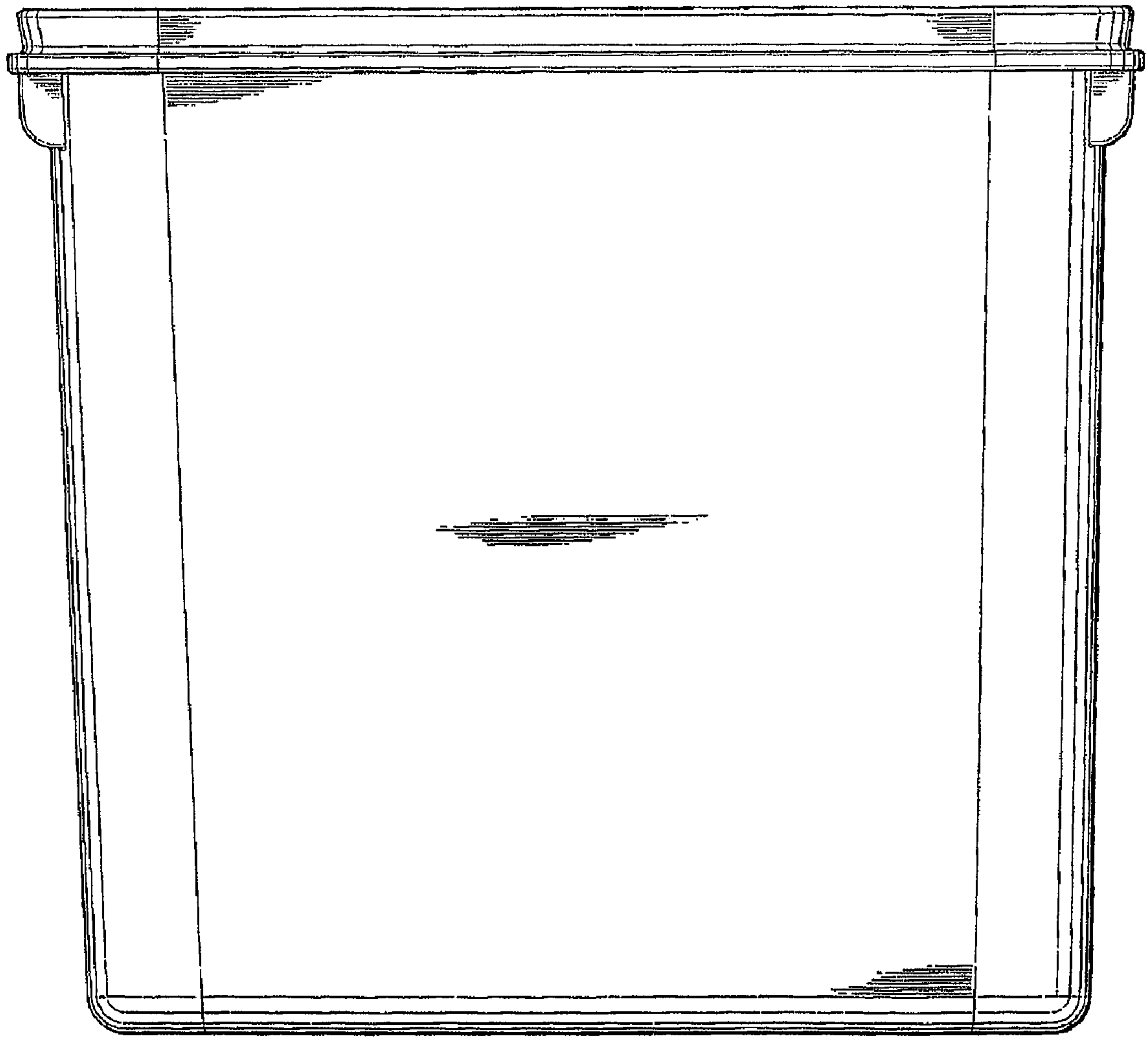

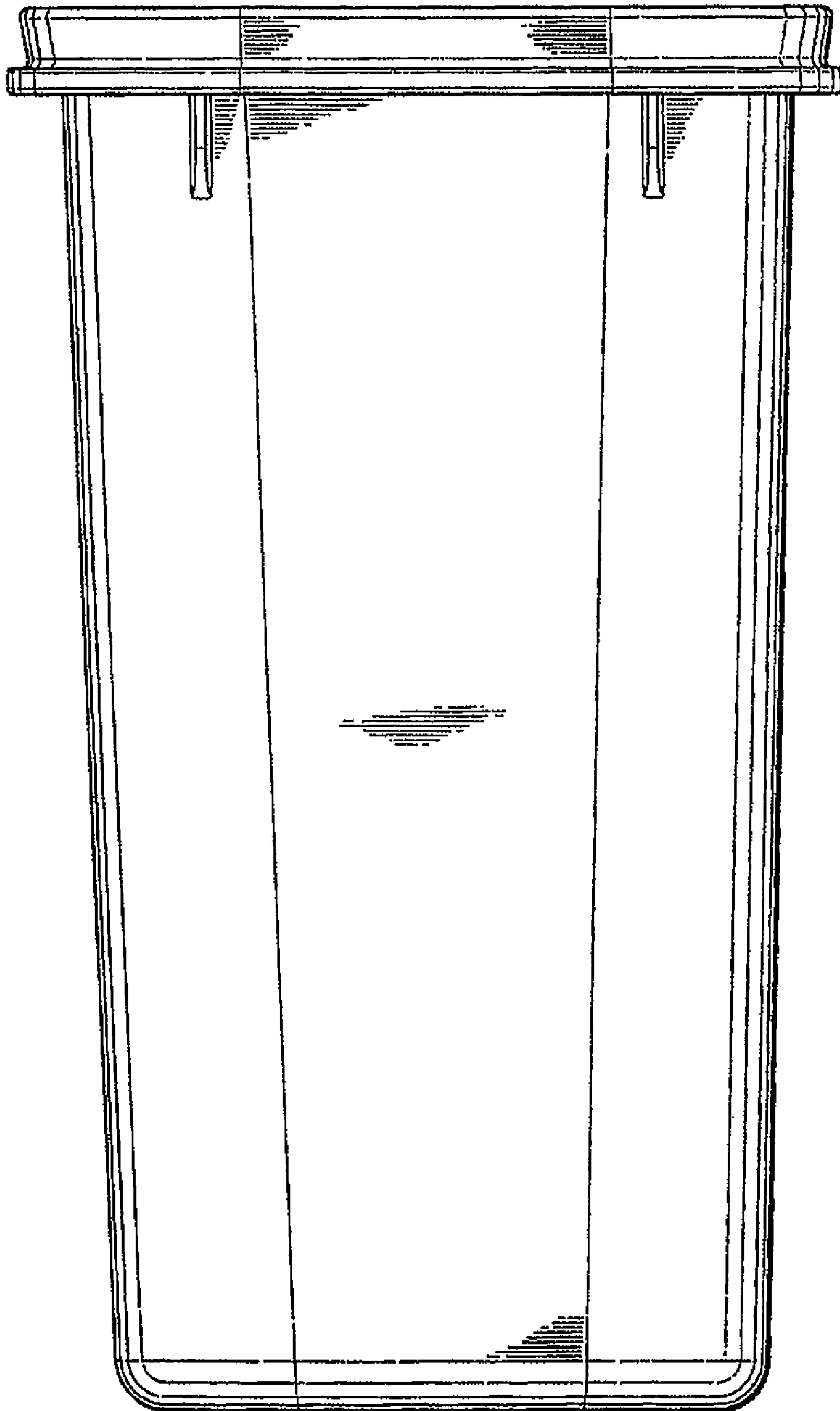

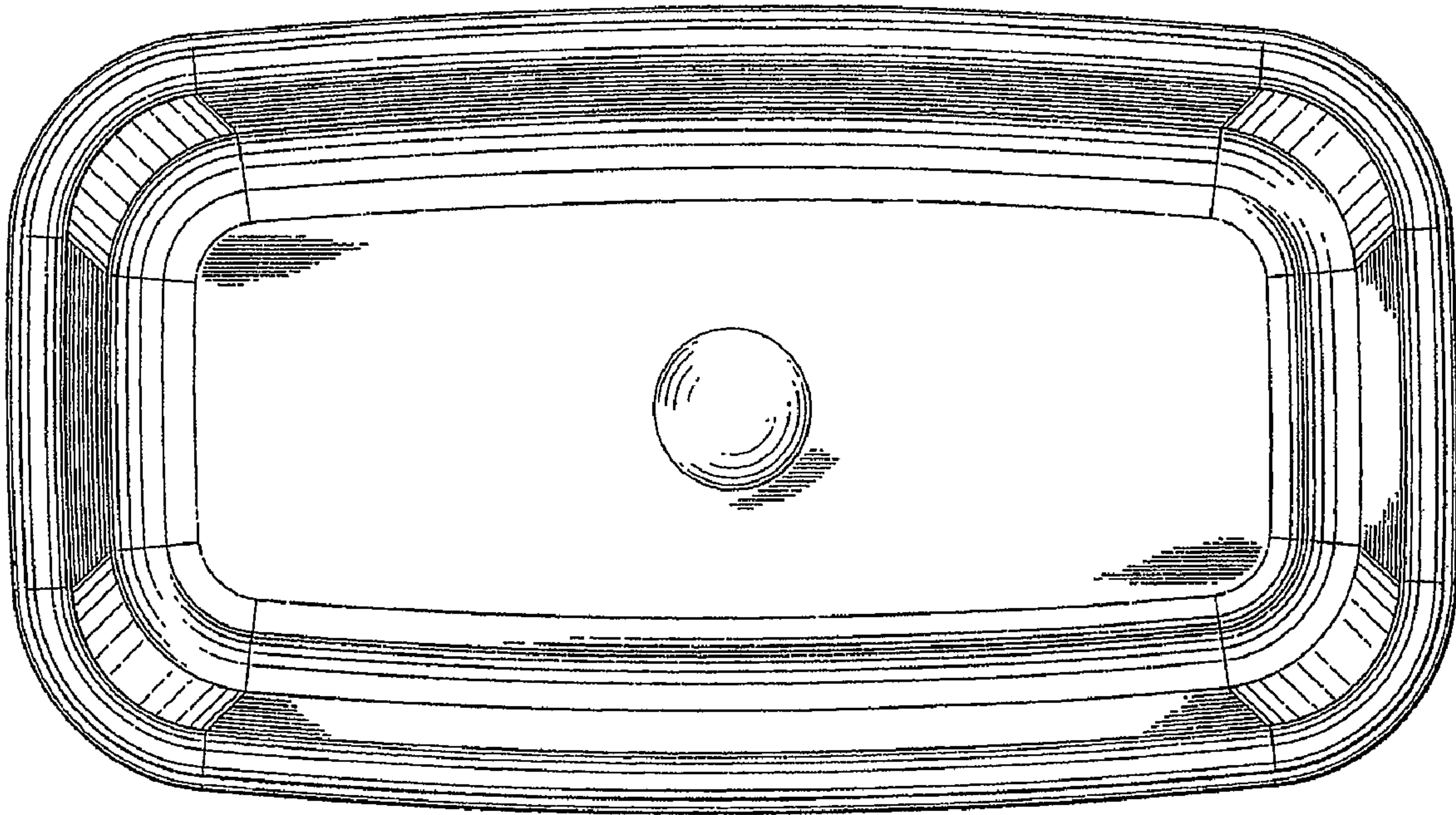

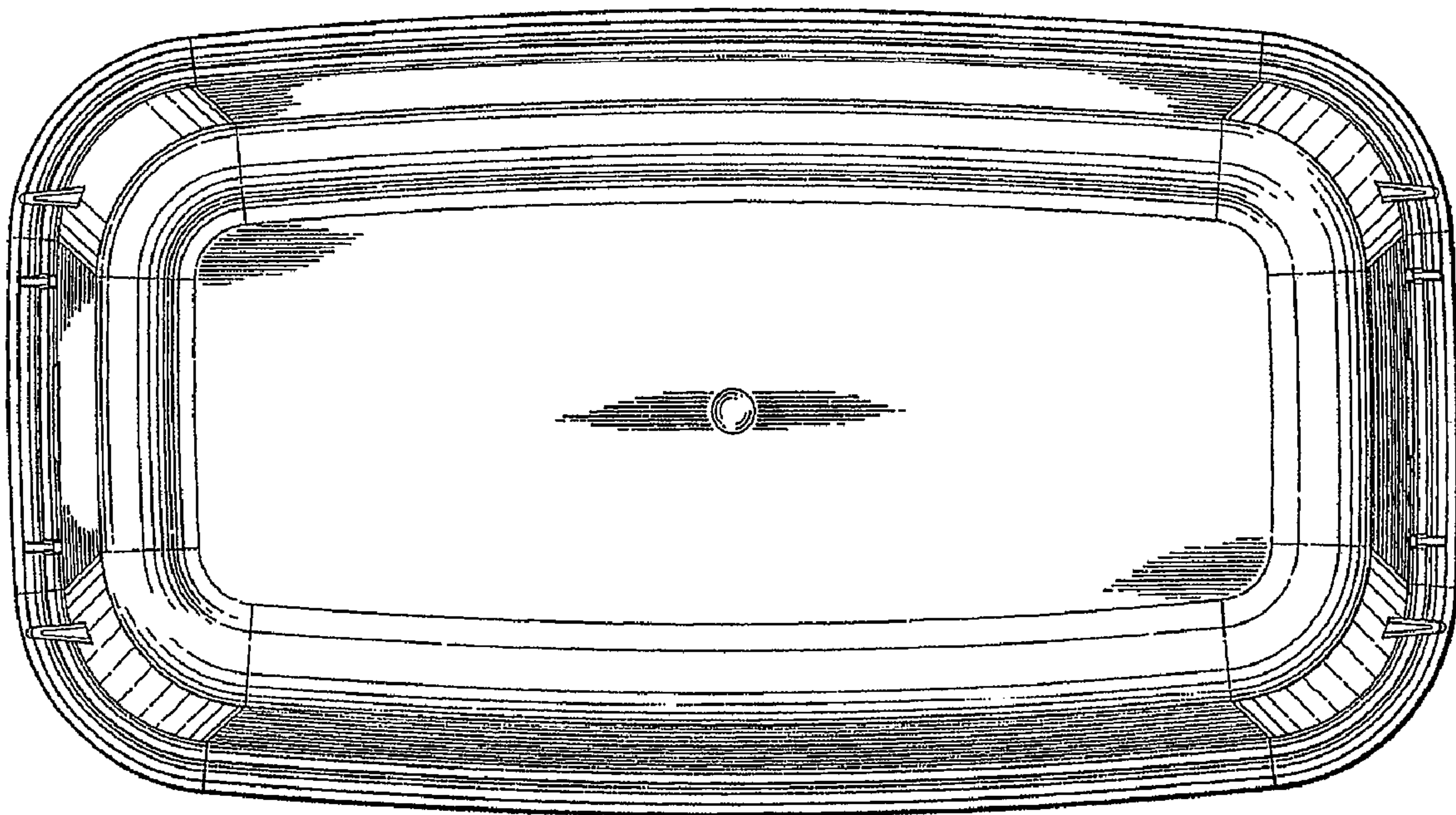
