FIG. 4 is a first side view thereof;

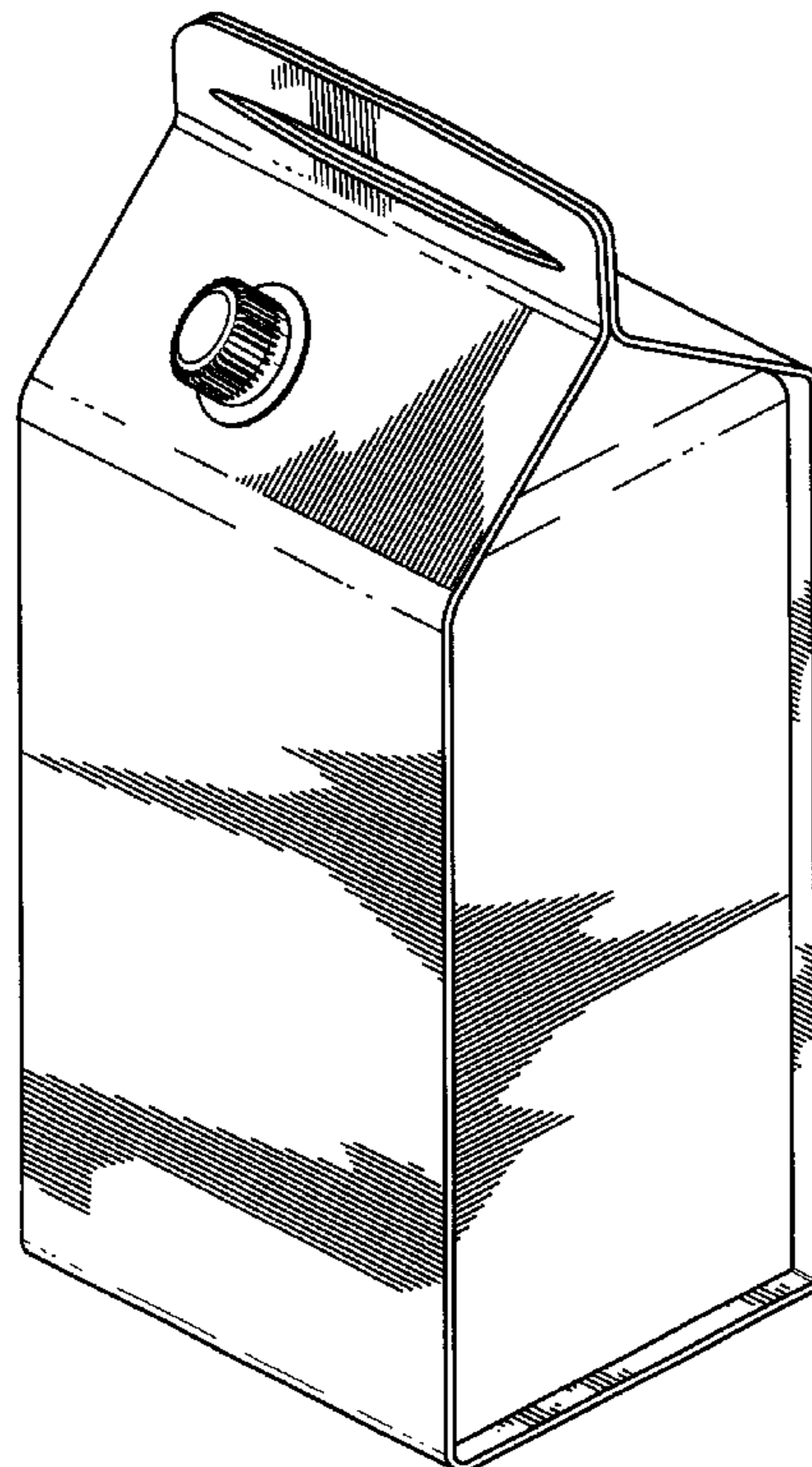
FIG. 5 is a second side view thereof;

FIG. 6 is a top view thereof;

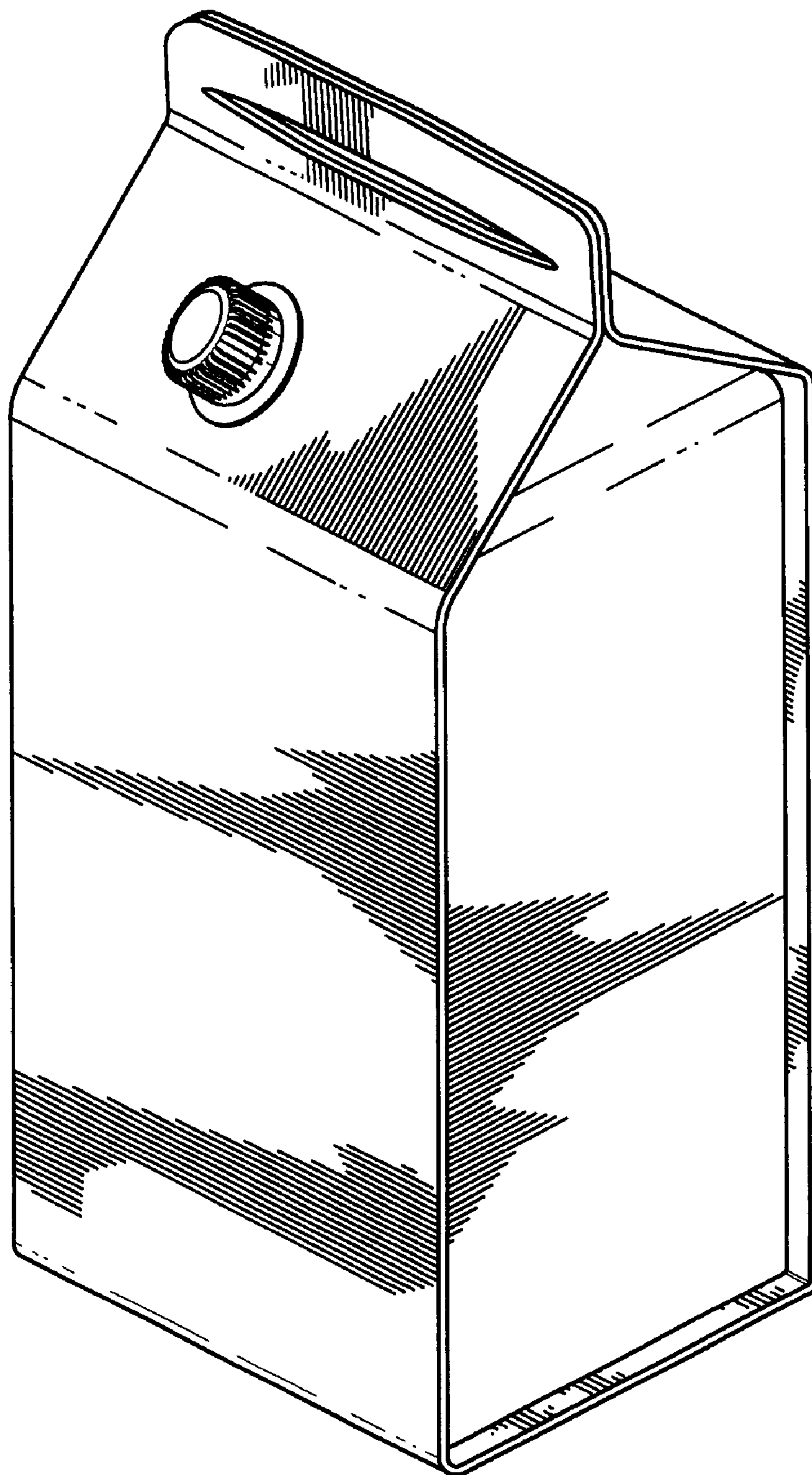
FIG. 7 is bottom view thereof; and,

FIG. 8 is an elevated perspective view of the gable container with slotted handle in use.

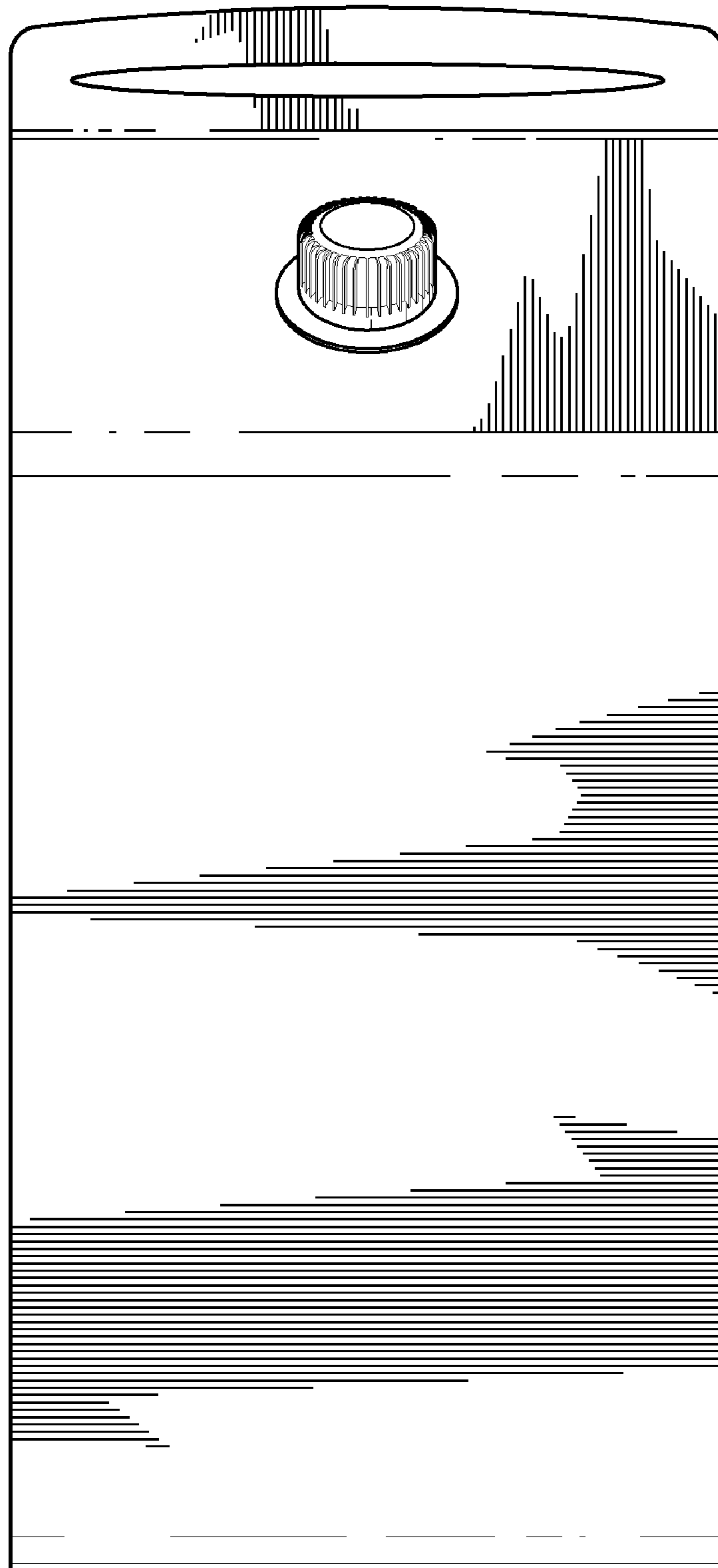

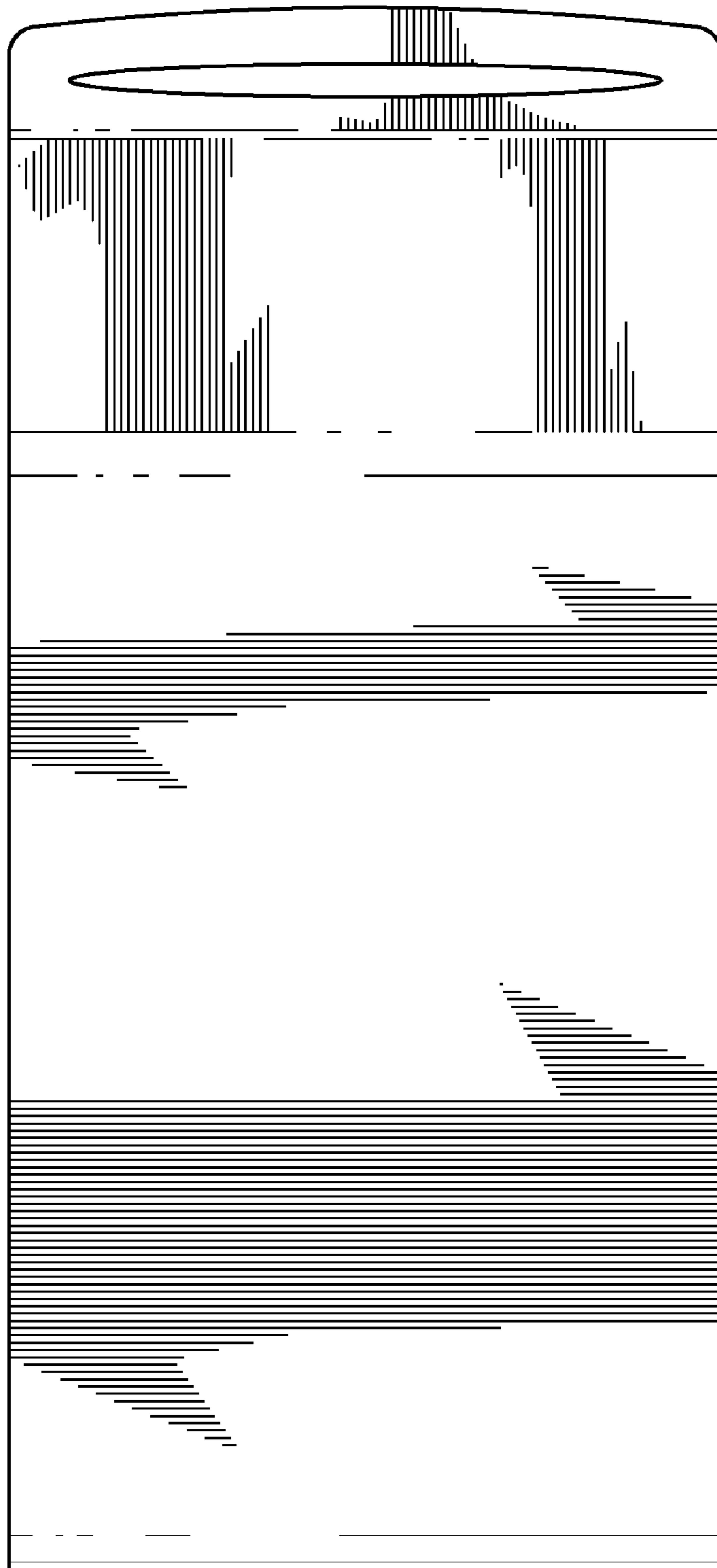

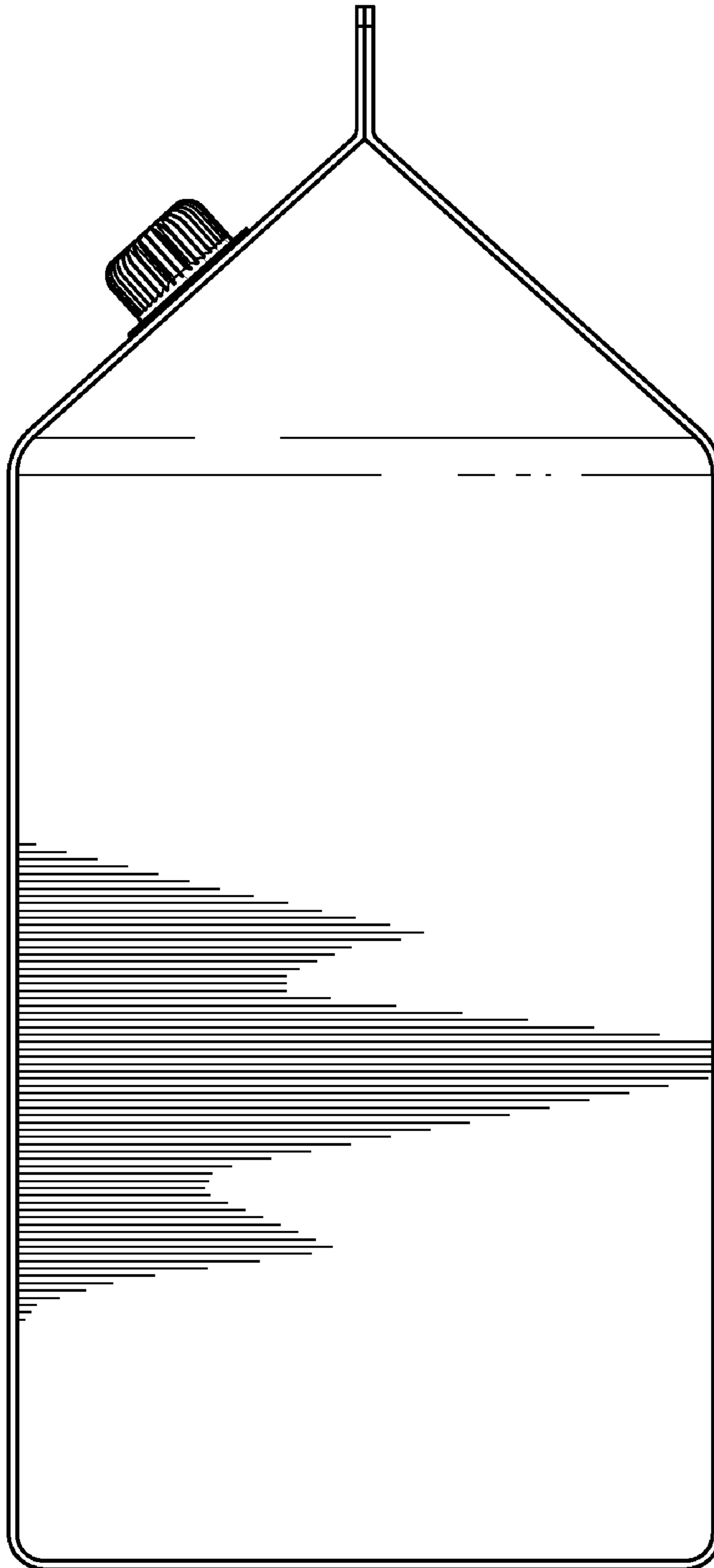

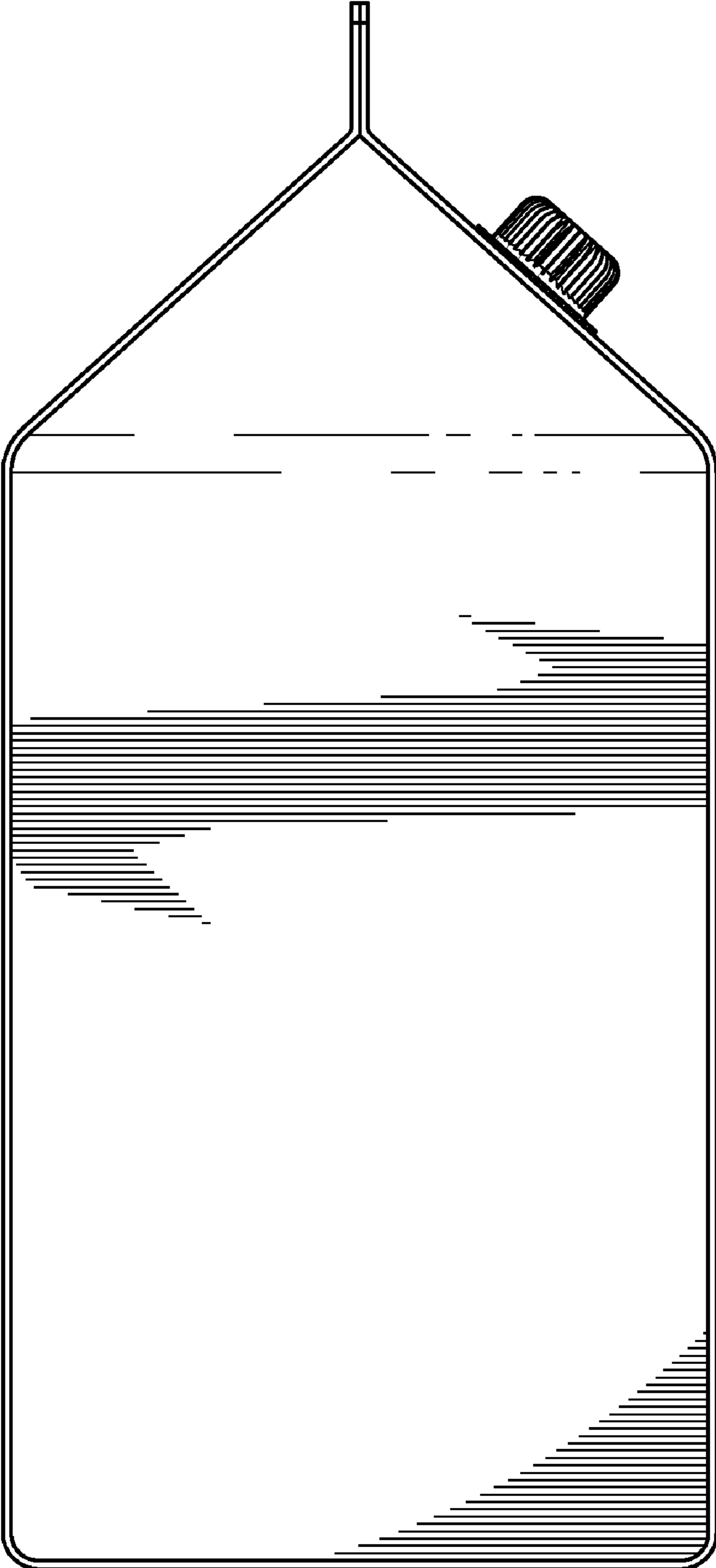

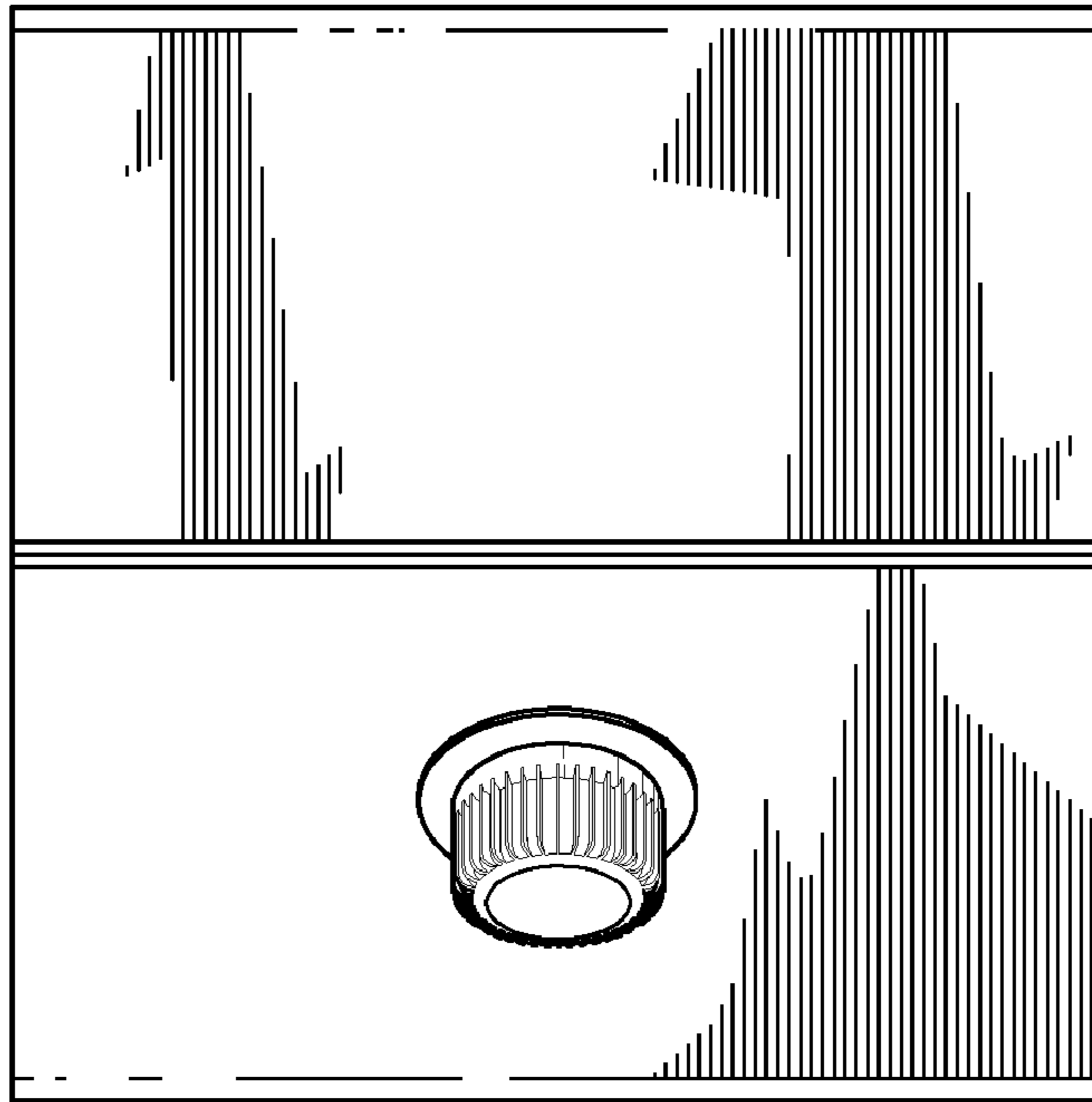

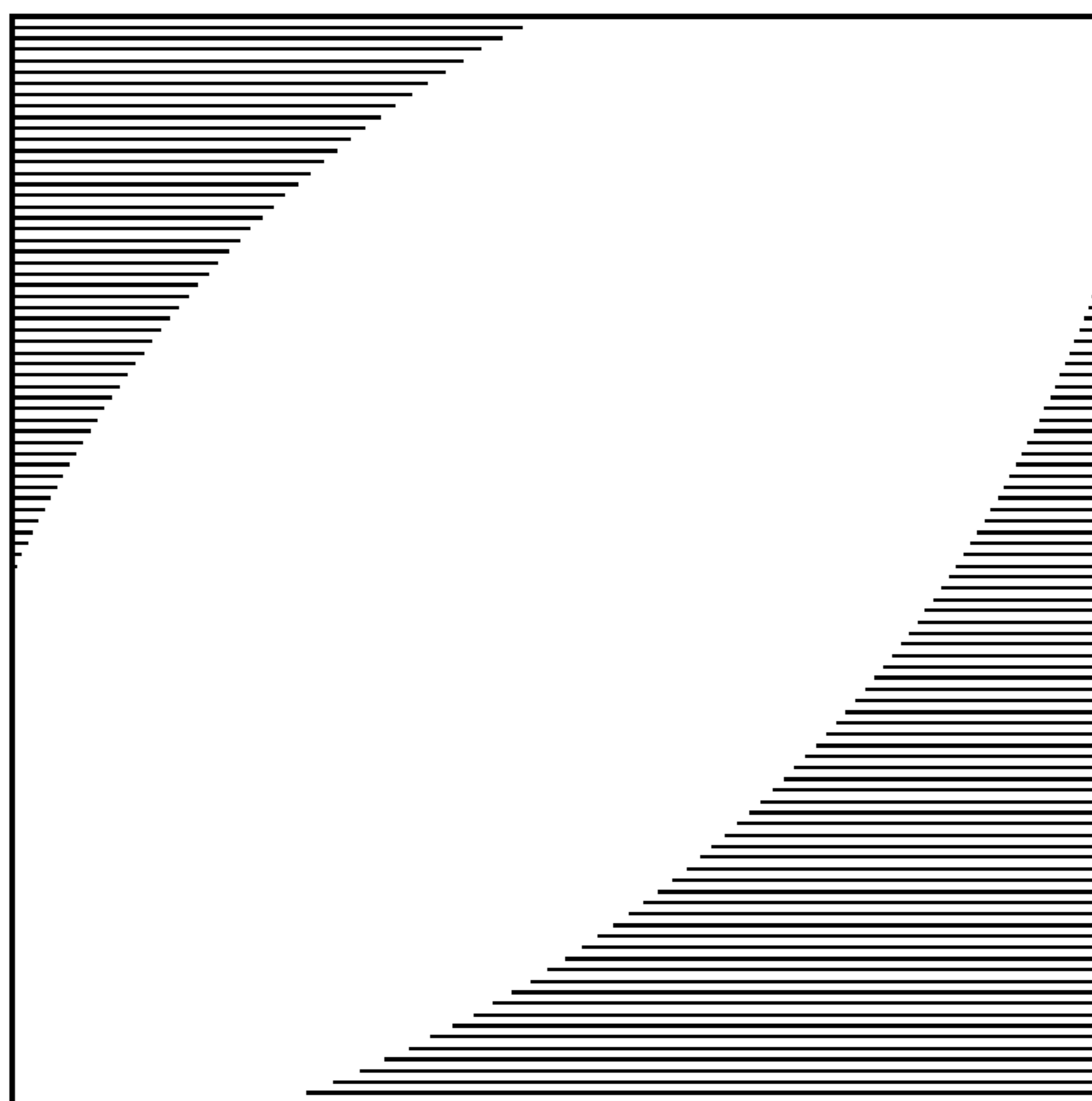
