(57) **CLAIM**

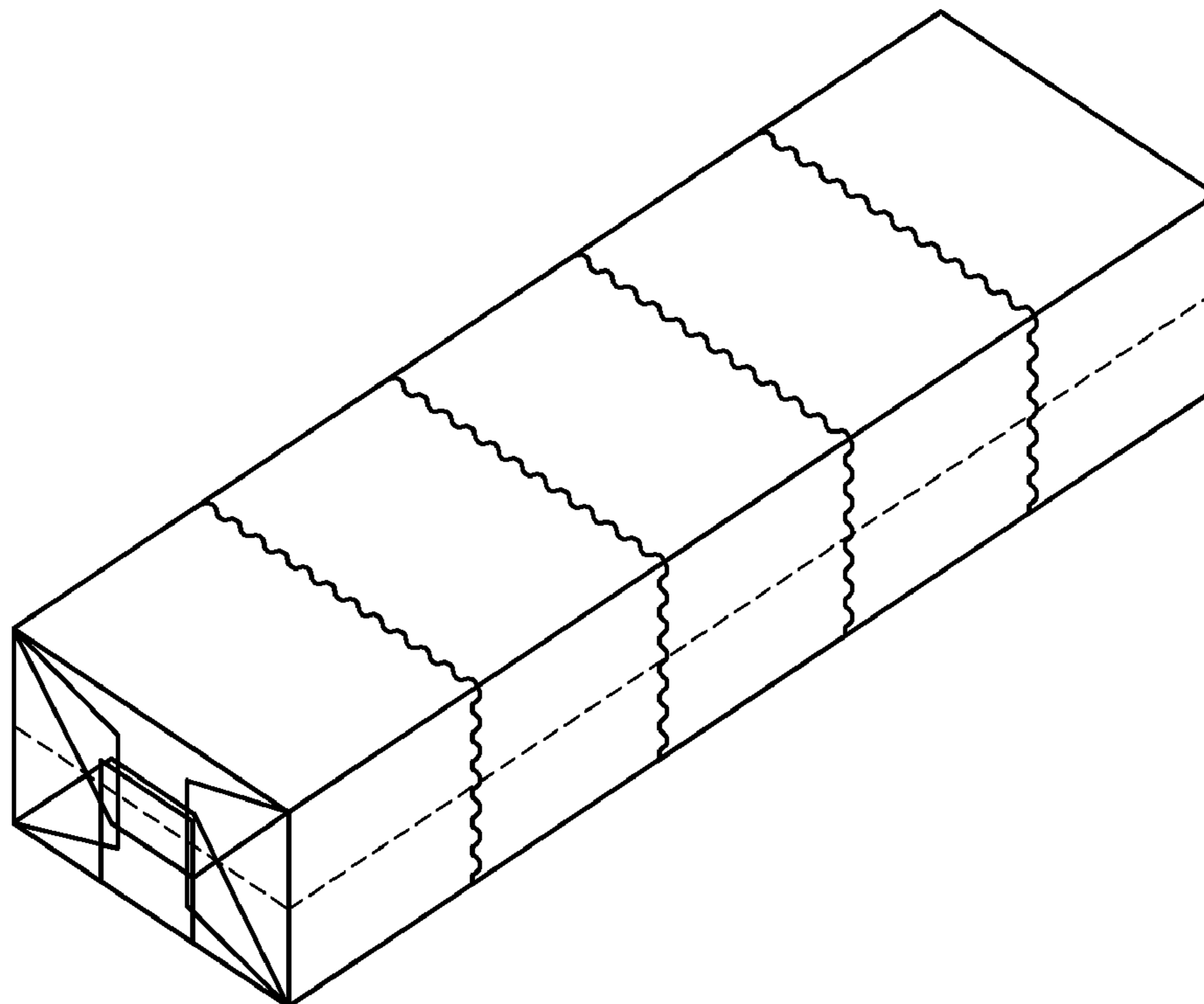
The ornamental design for a cigarette packet, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view showing the new design;
FIG. 2 is a bottom view;
FIG. 3 is a left side view;
FIG. 4 is a top view;
FIG. 5 is a right side view;
FIG. 6 is a left end view; and,
FIG. 7 is a right end view.

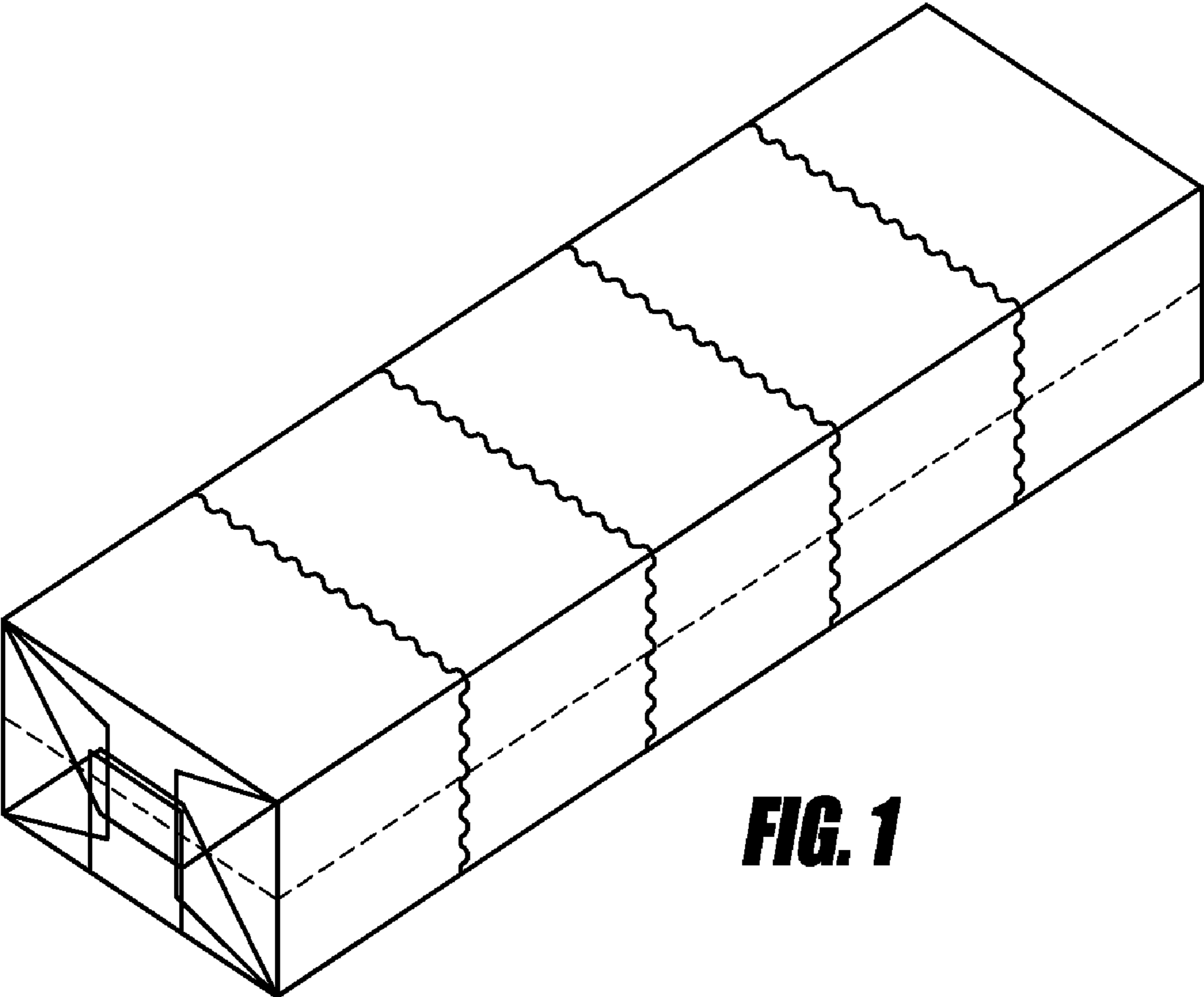

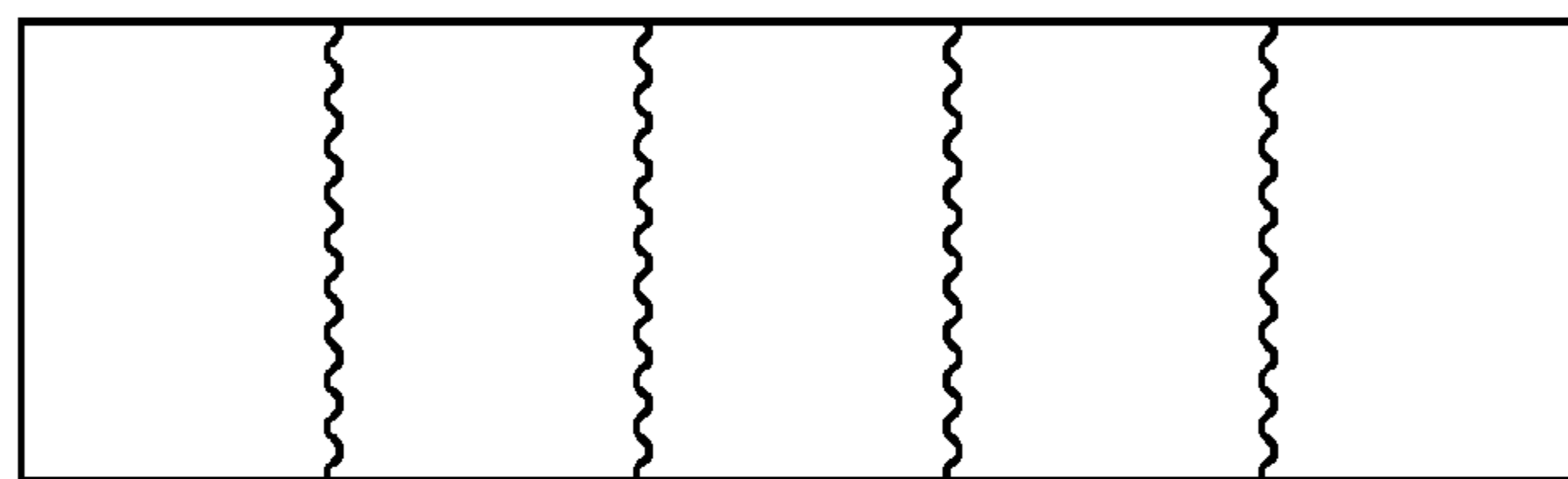

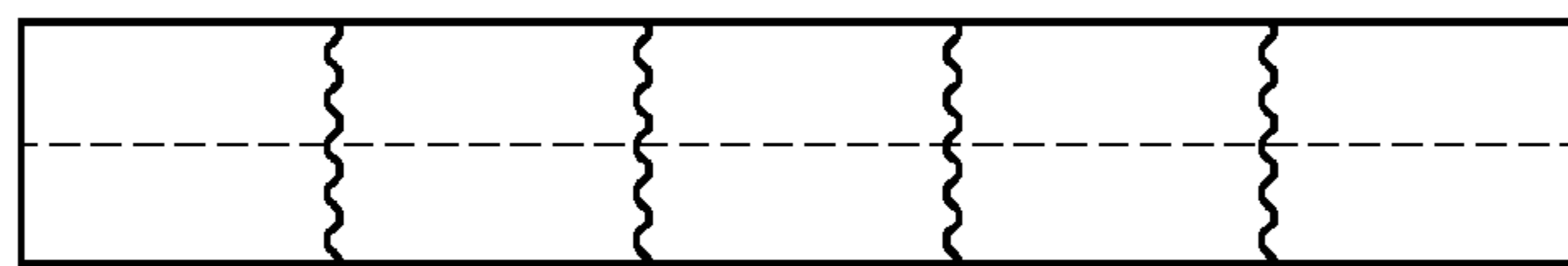

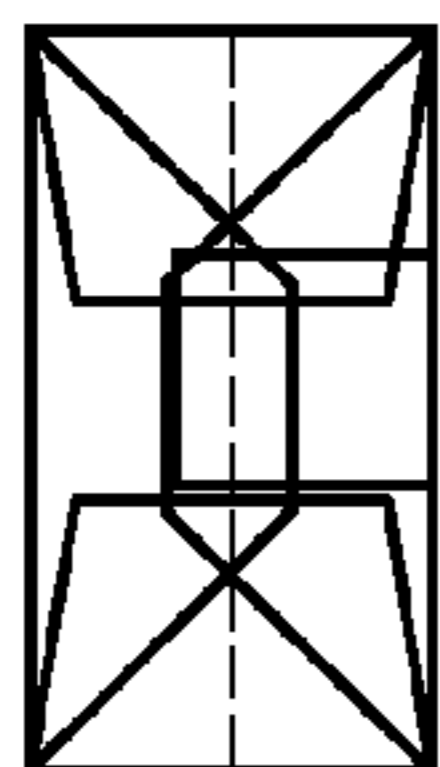

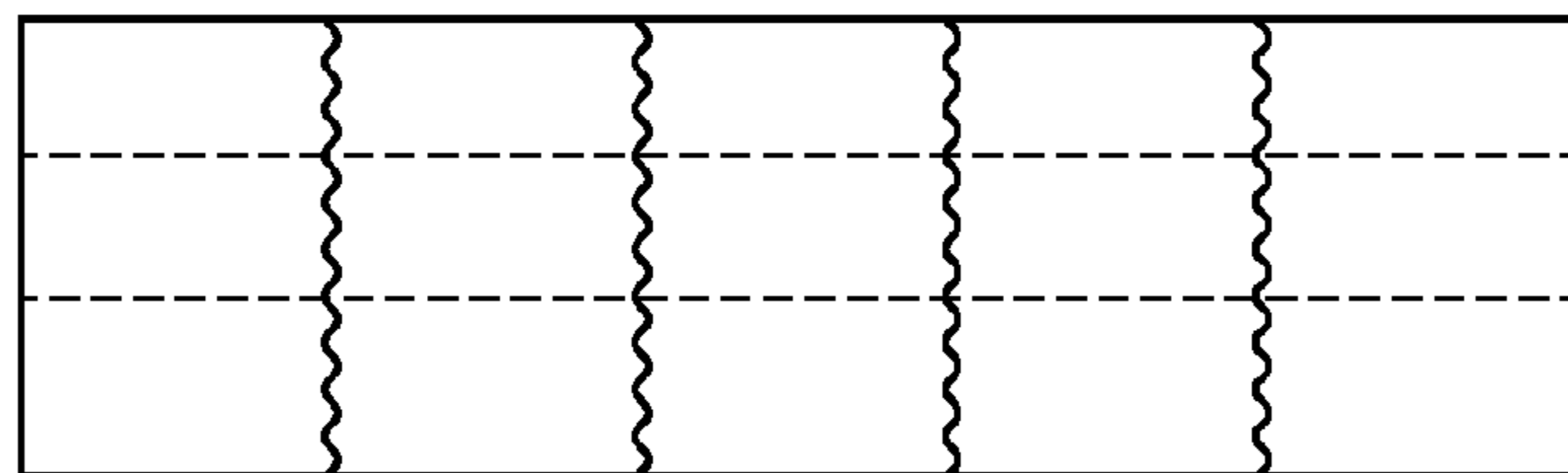

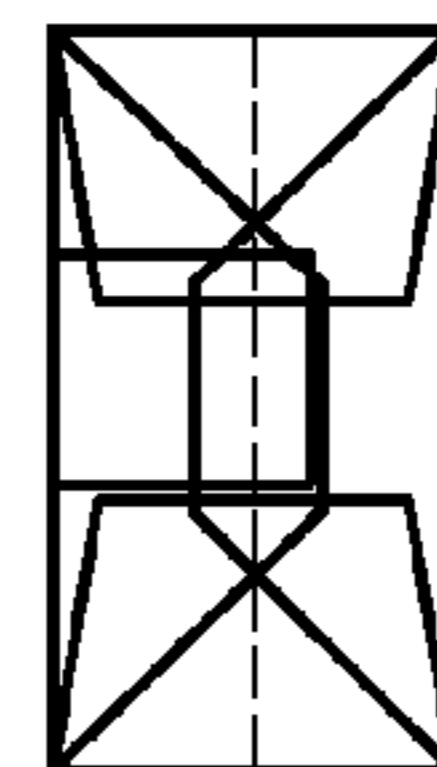

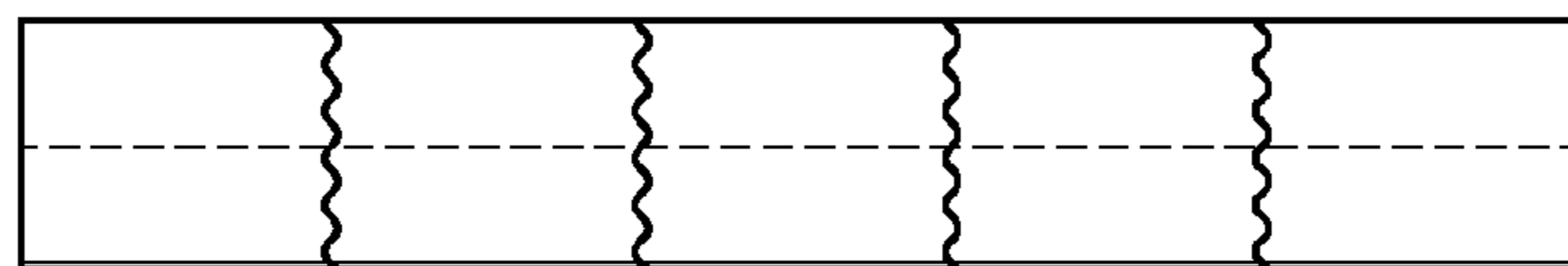
