FIG. 4 is a left side view of a smoke alarm;

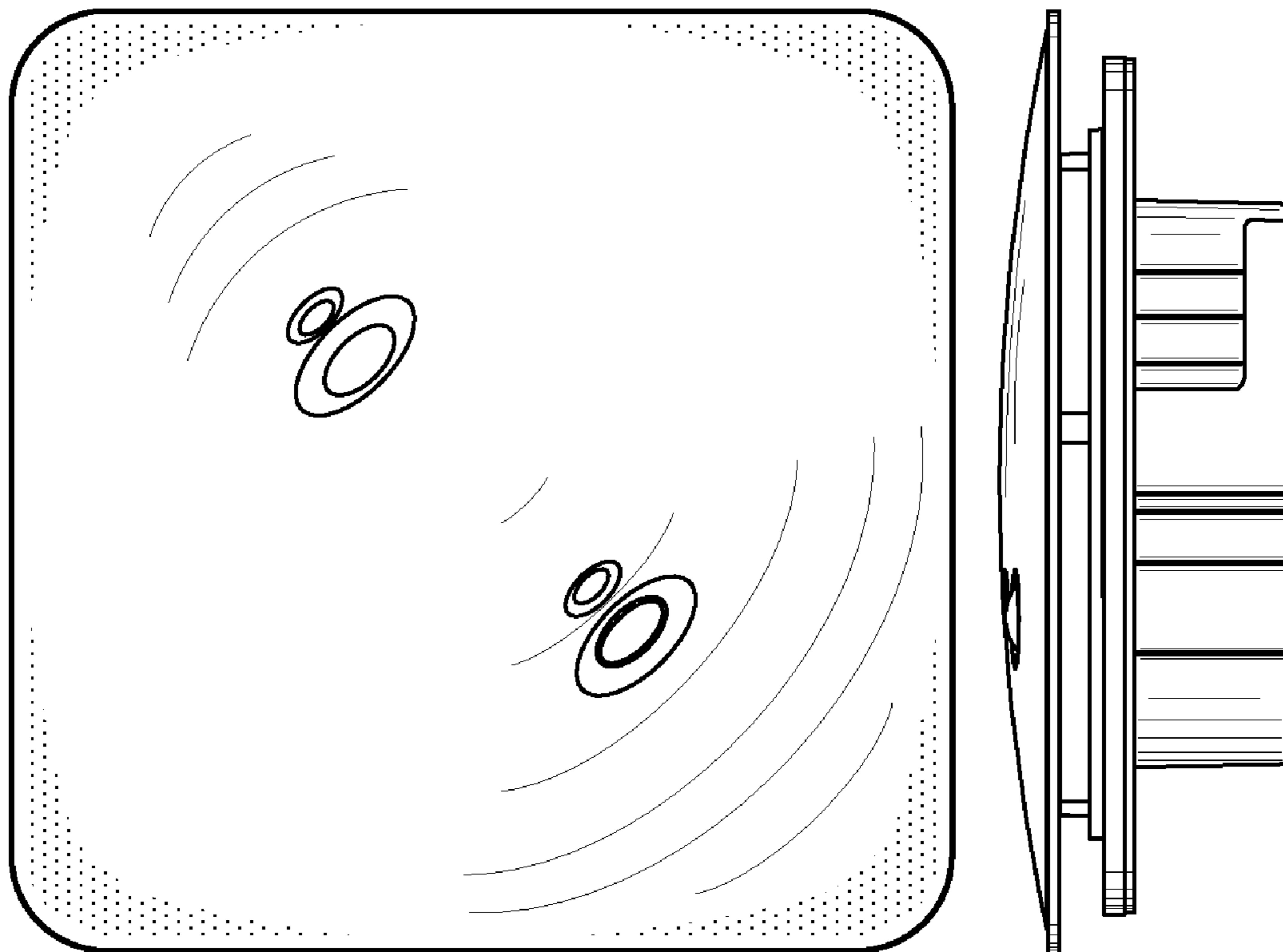
FIG. 5 is a top view of a smoke alarm;

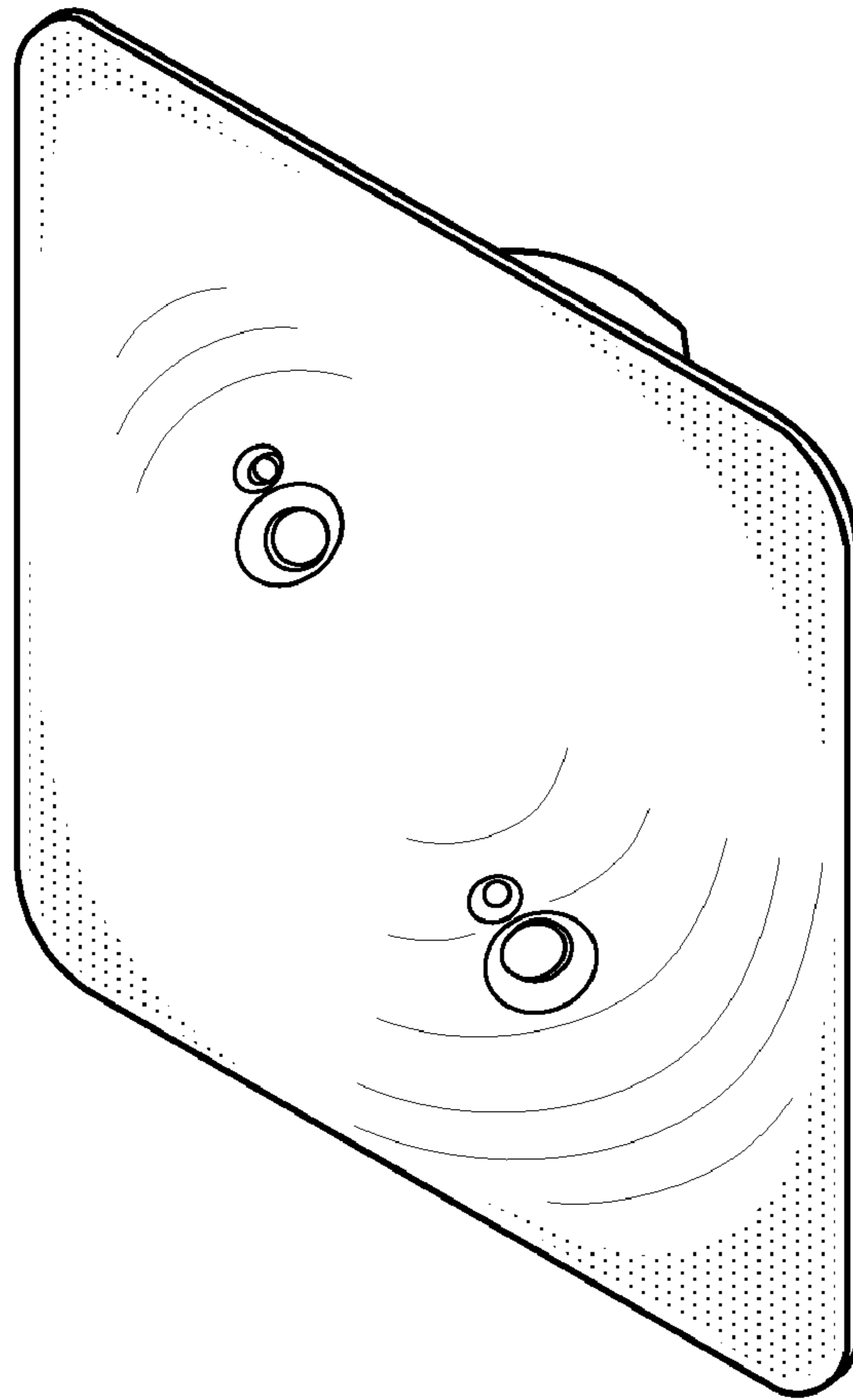

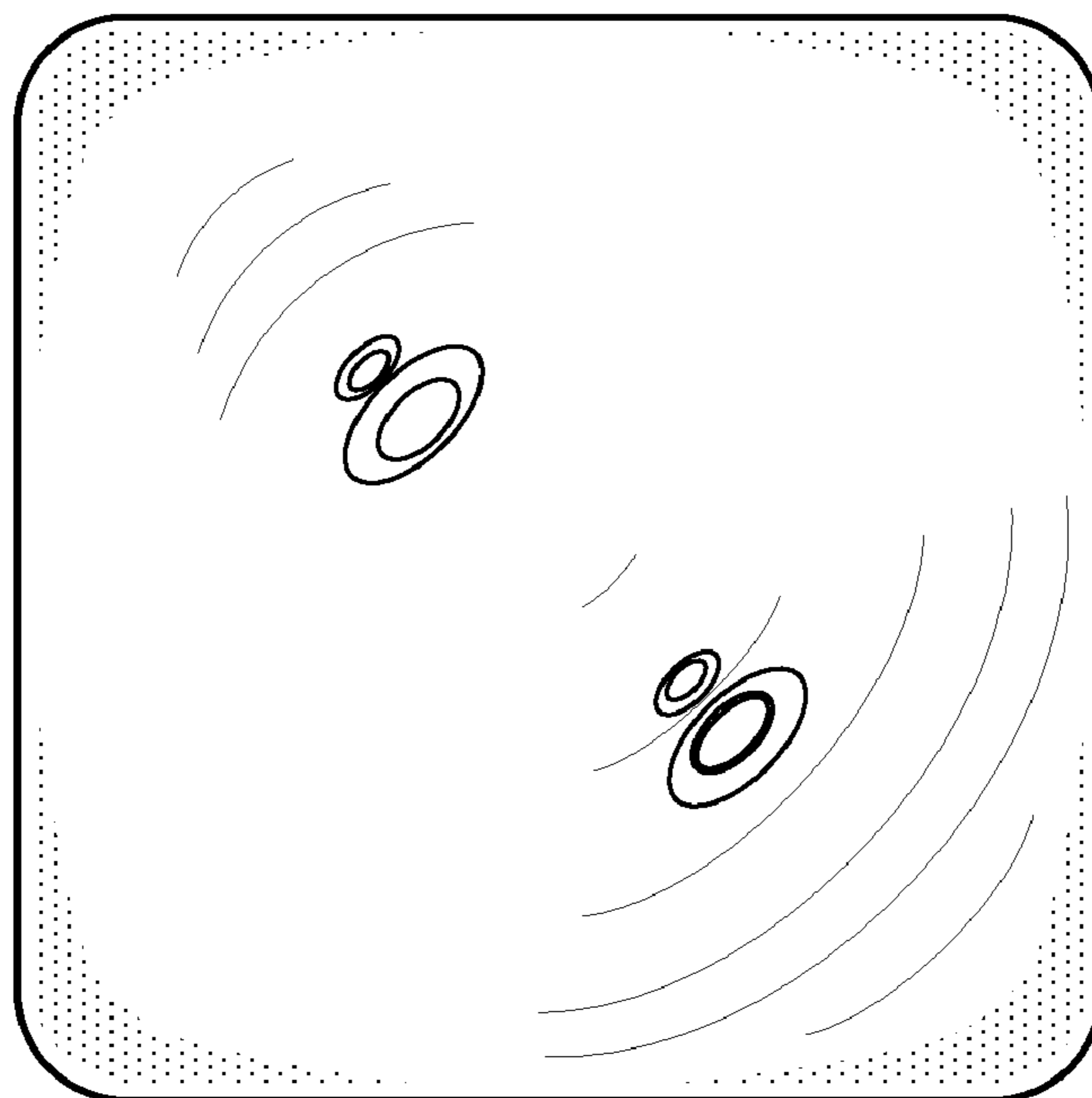

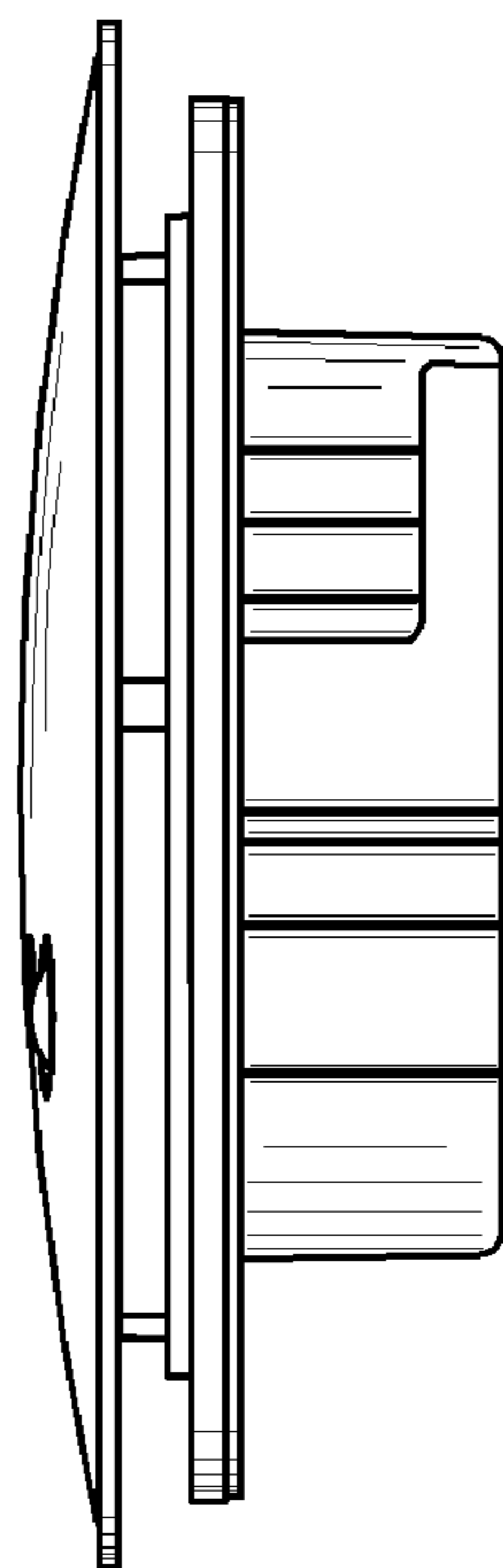

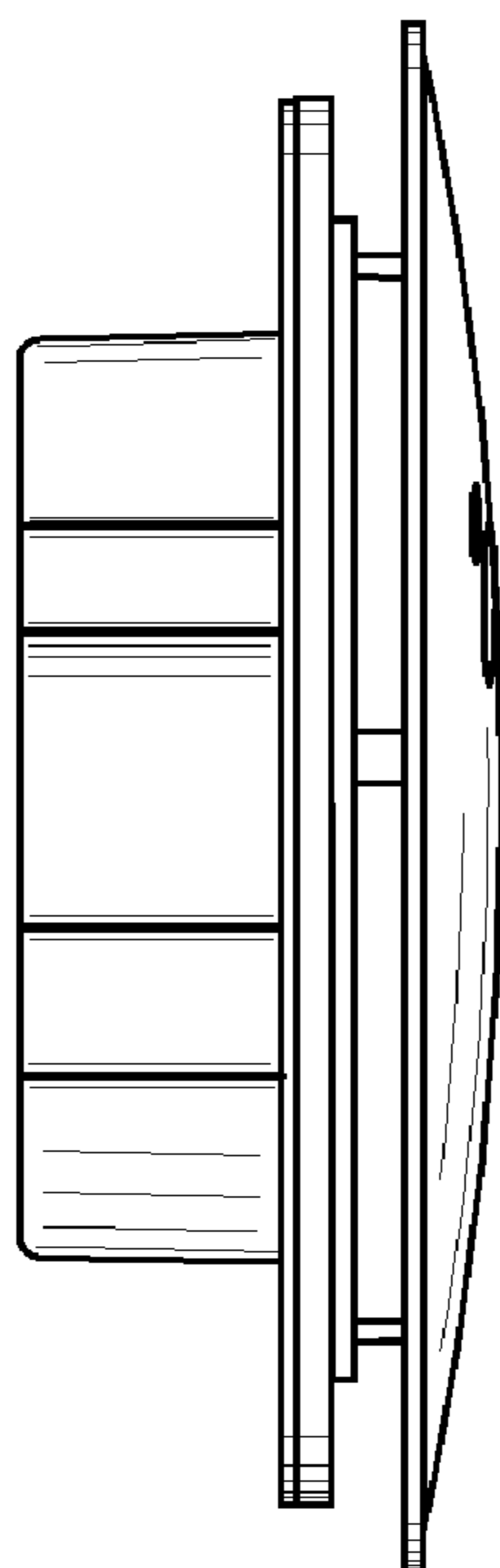

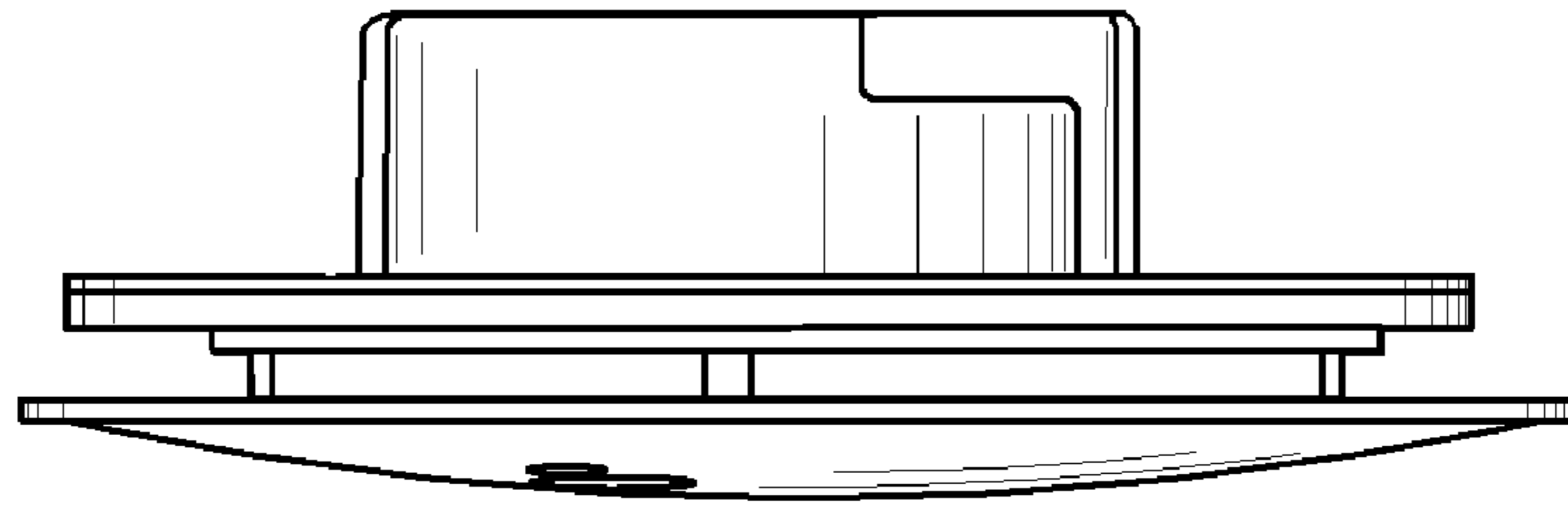

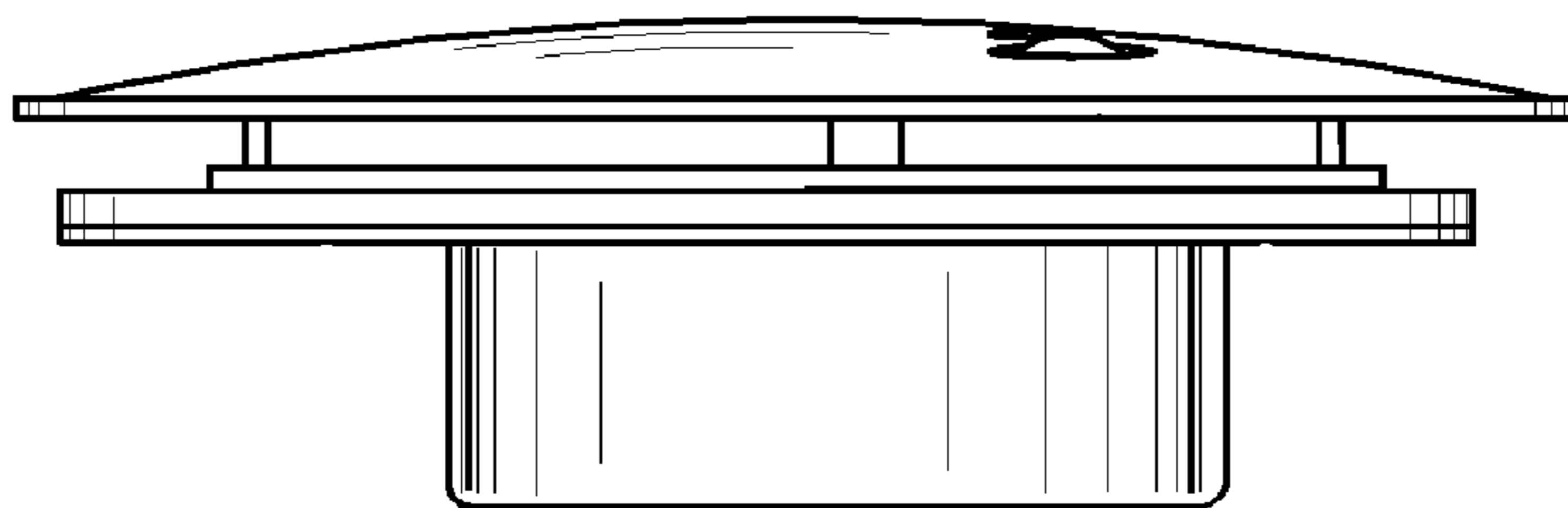

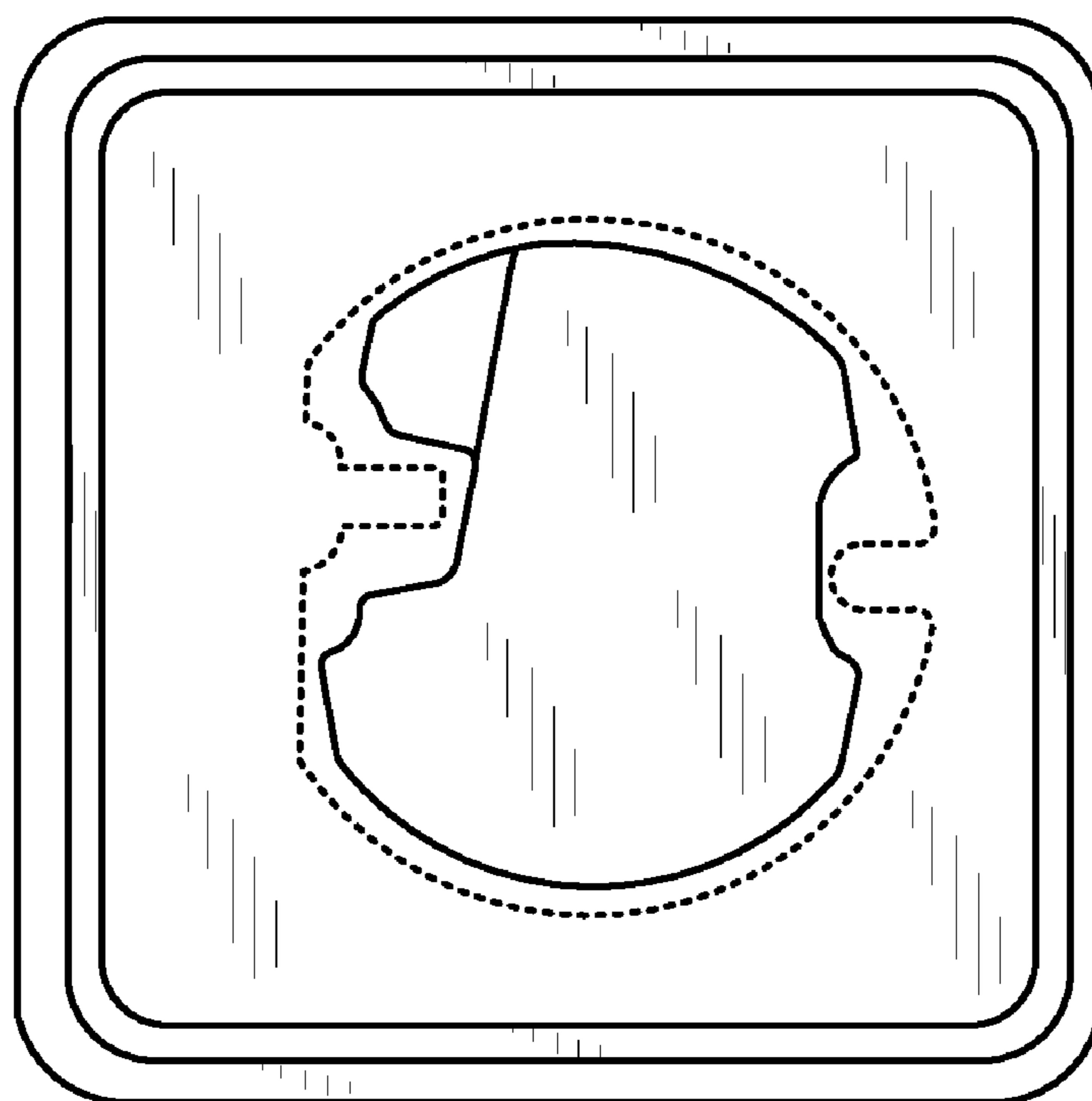
