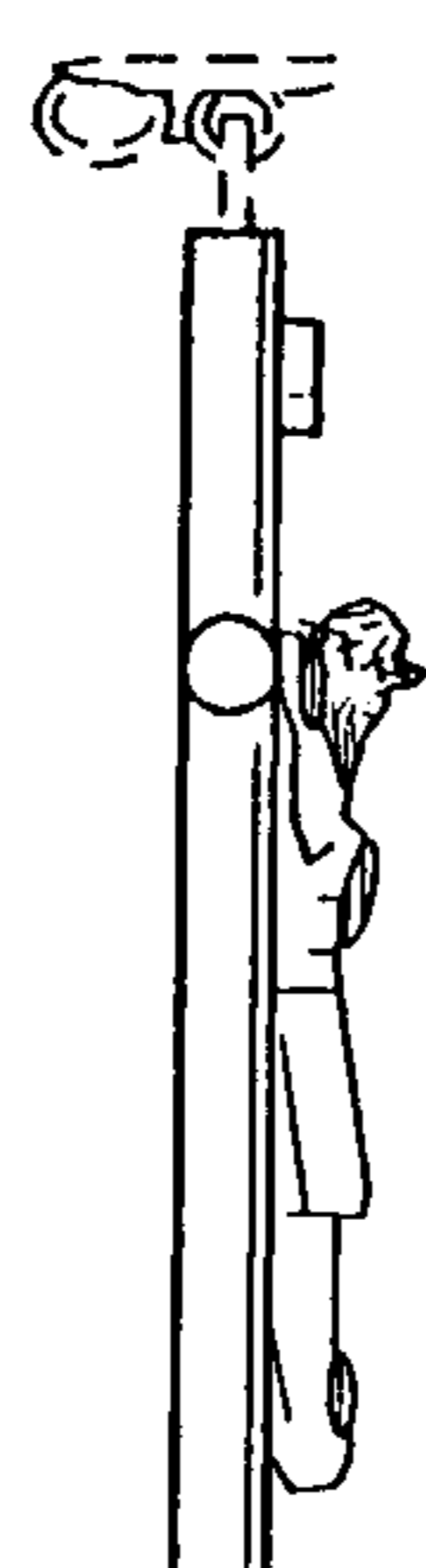
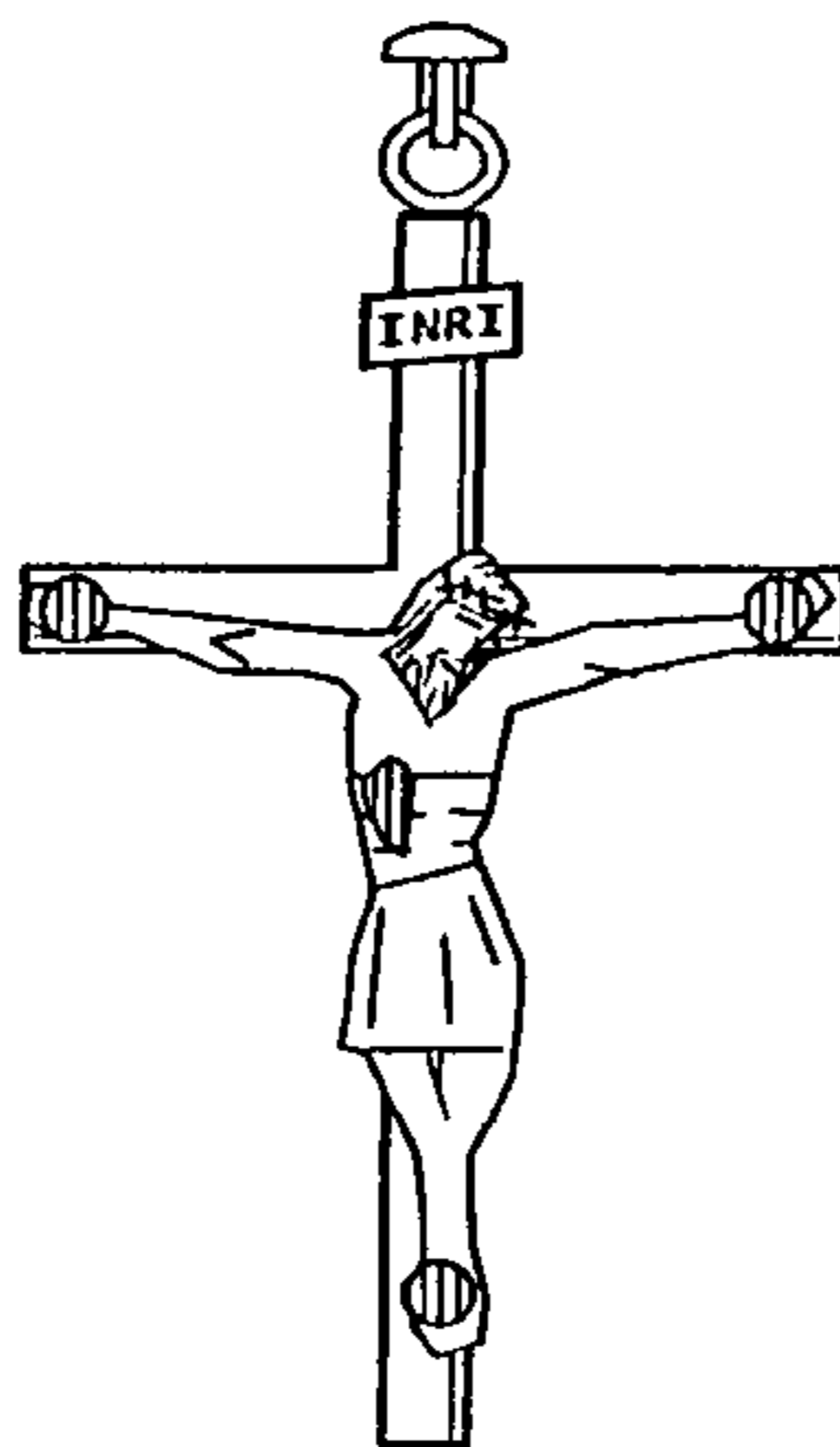

(57) **CLAIM**

The ornamental design for a crucifix with jewels for precious wounds of Jesus Christ, as shown and described.



DESCRIPTION

The broken lines depicted in FIGS. 7-78 illustrate environmental features, and are not part of our design.

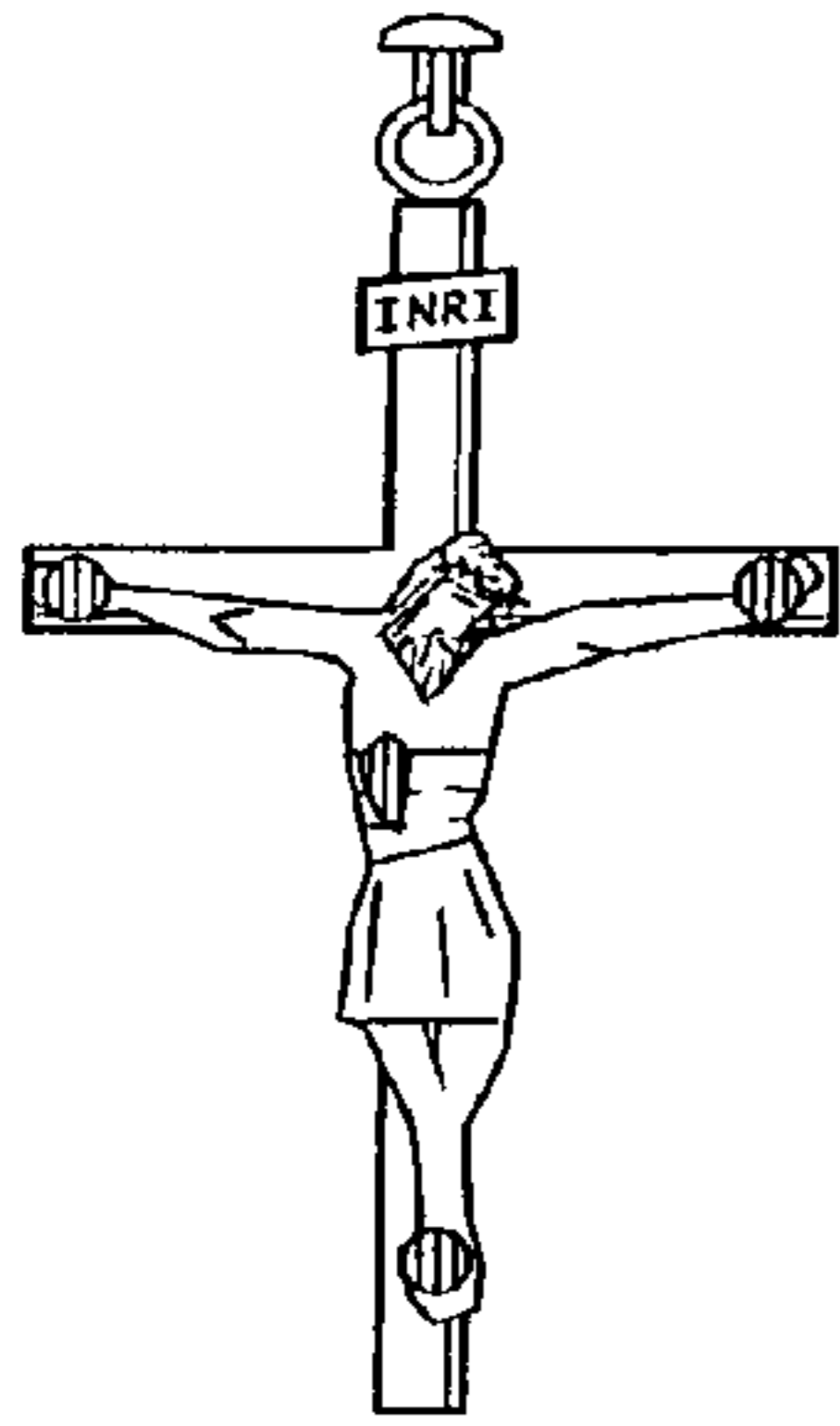

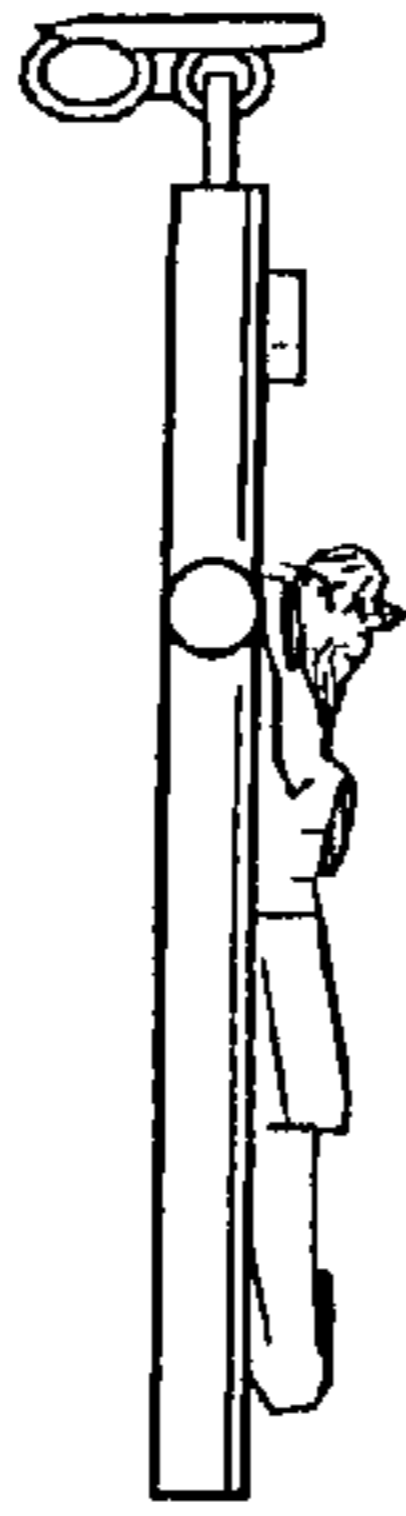

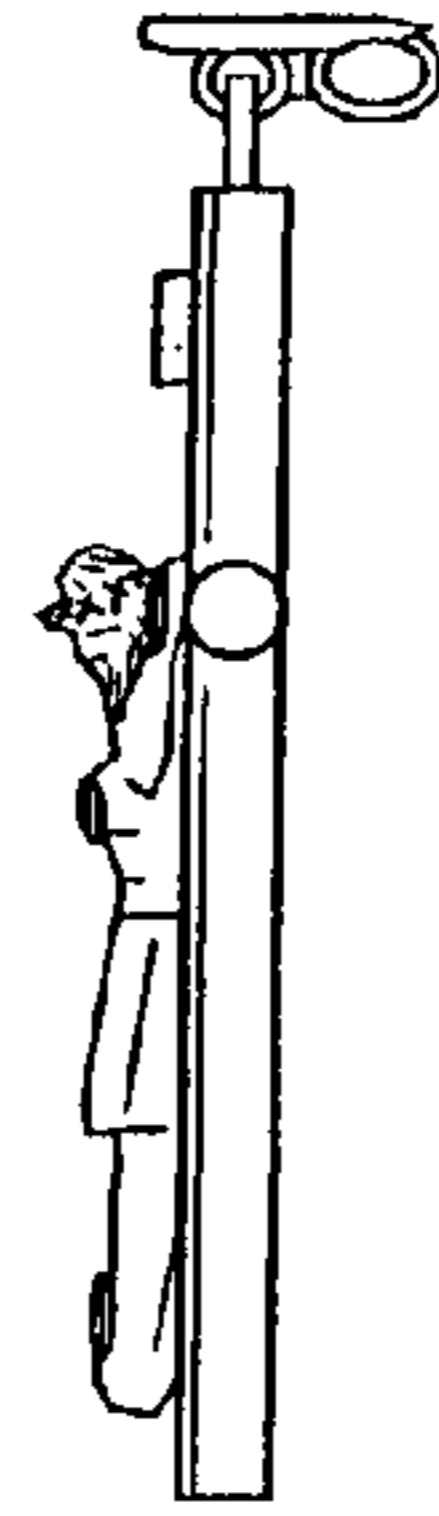

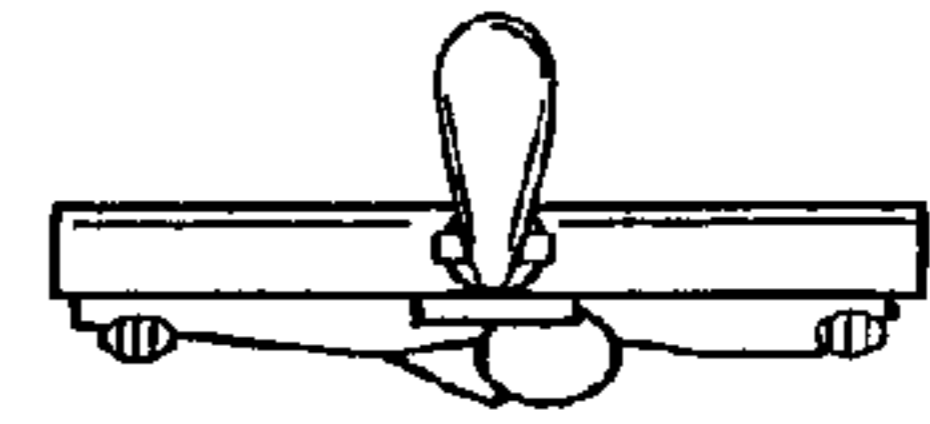

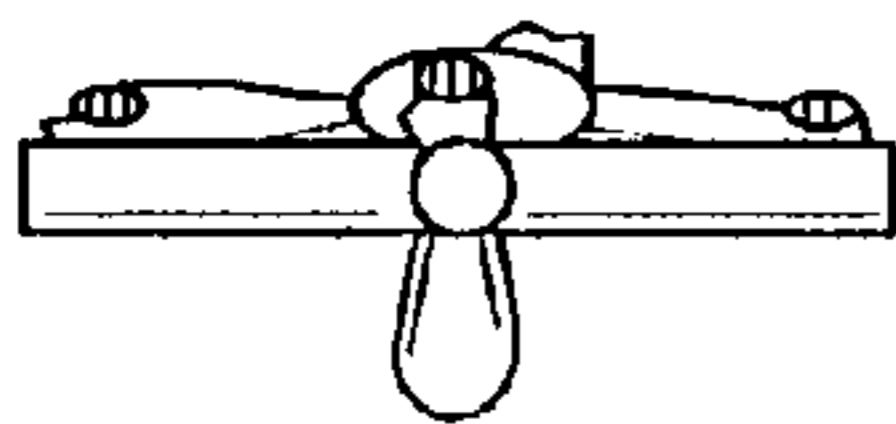

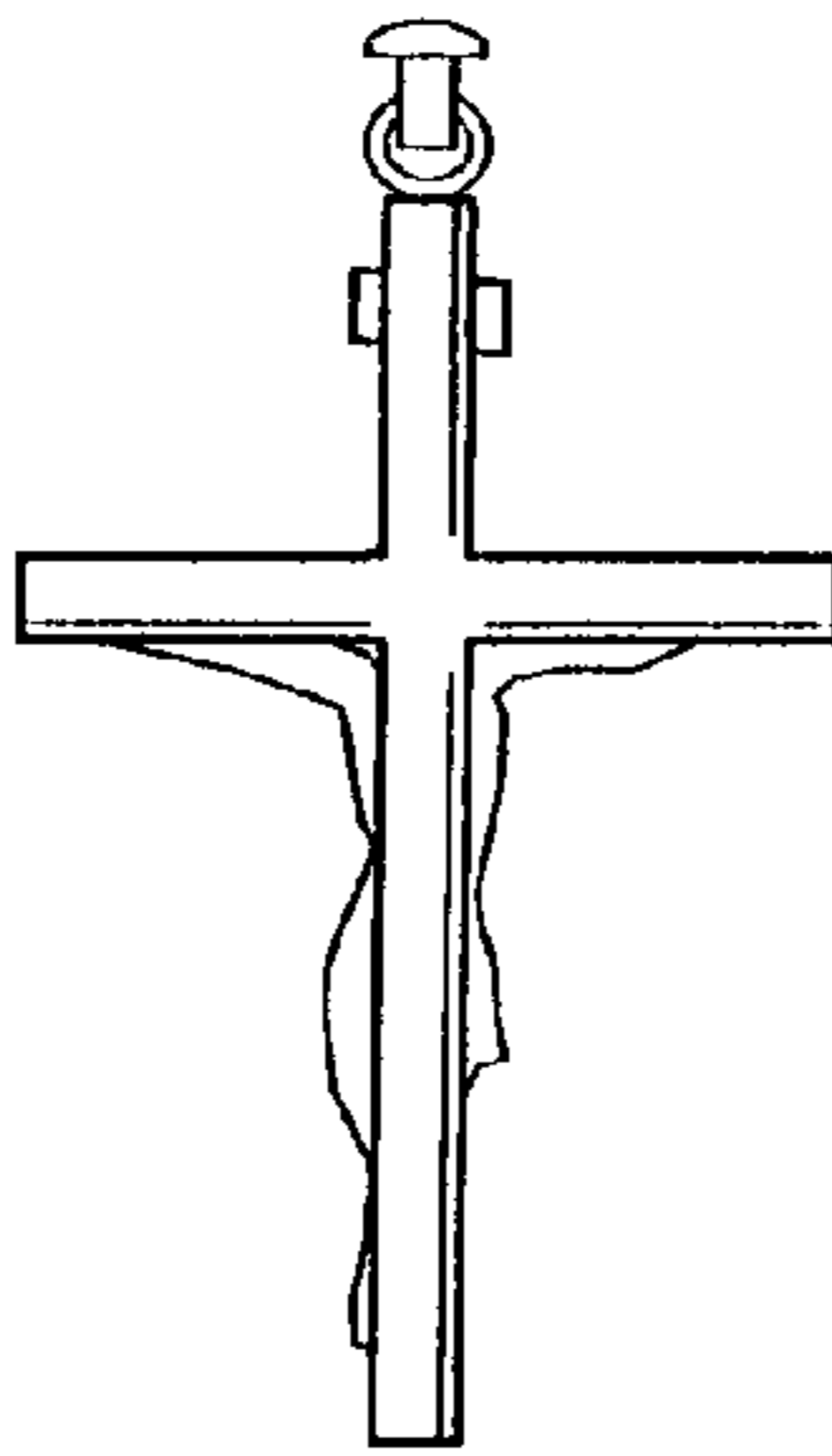

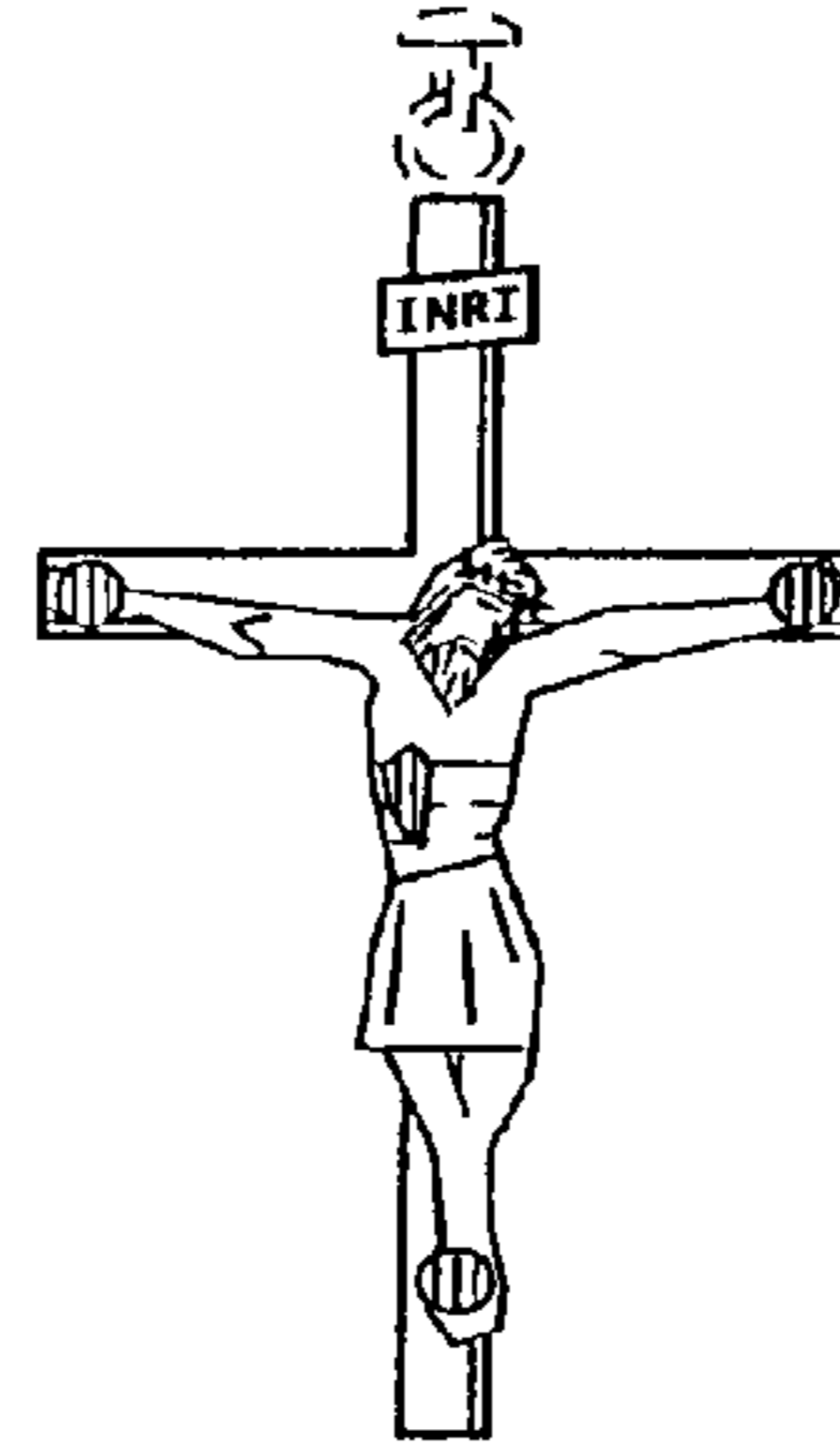

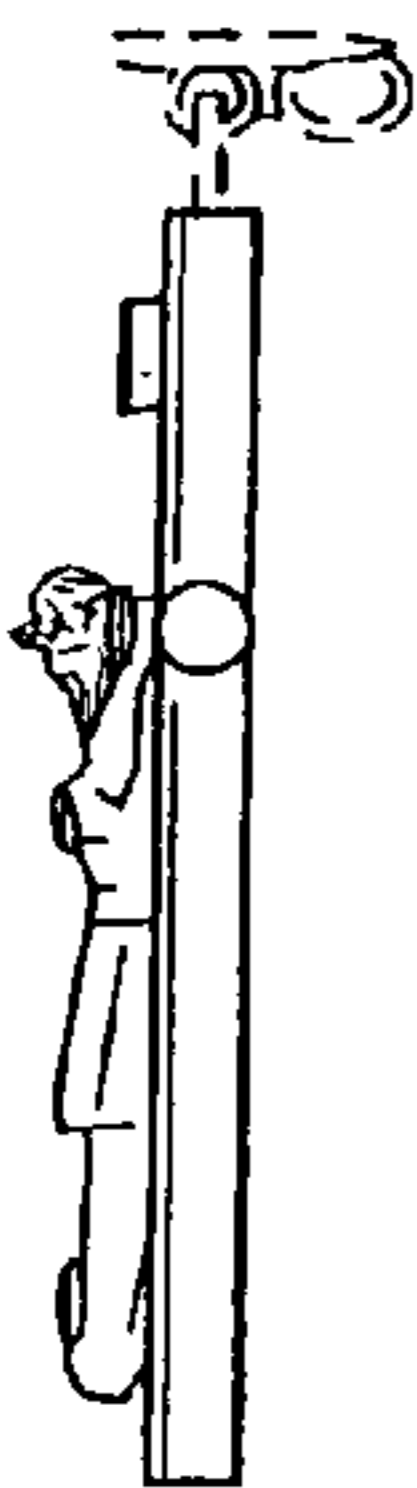

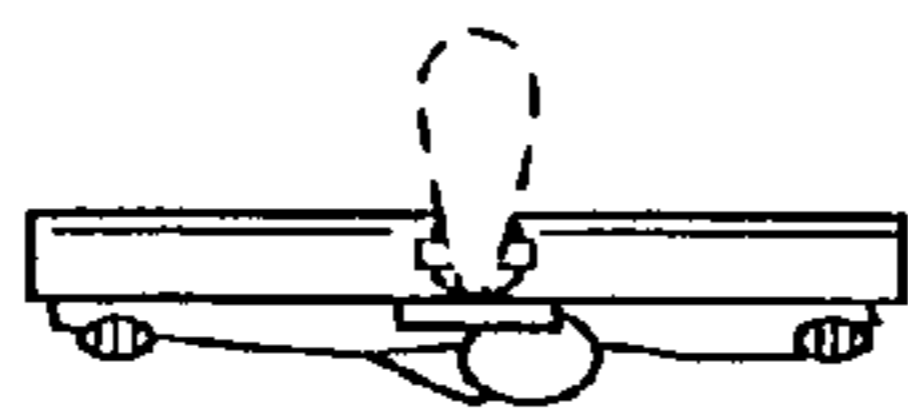

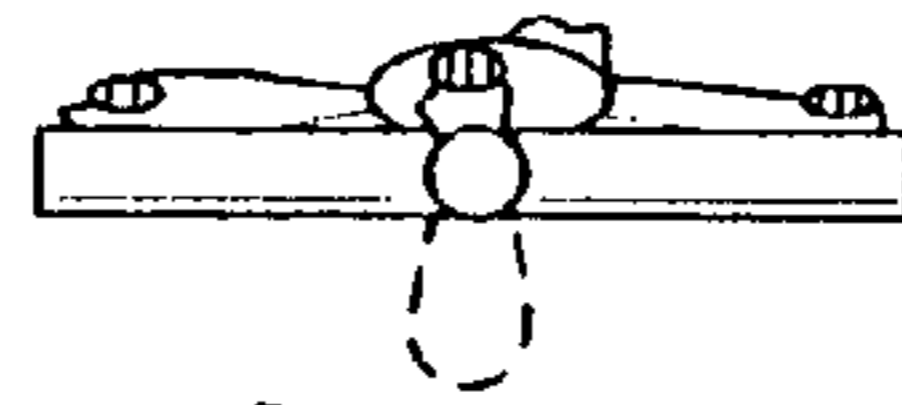

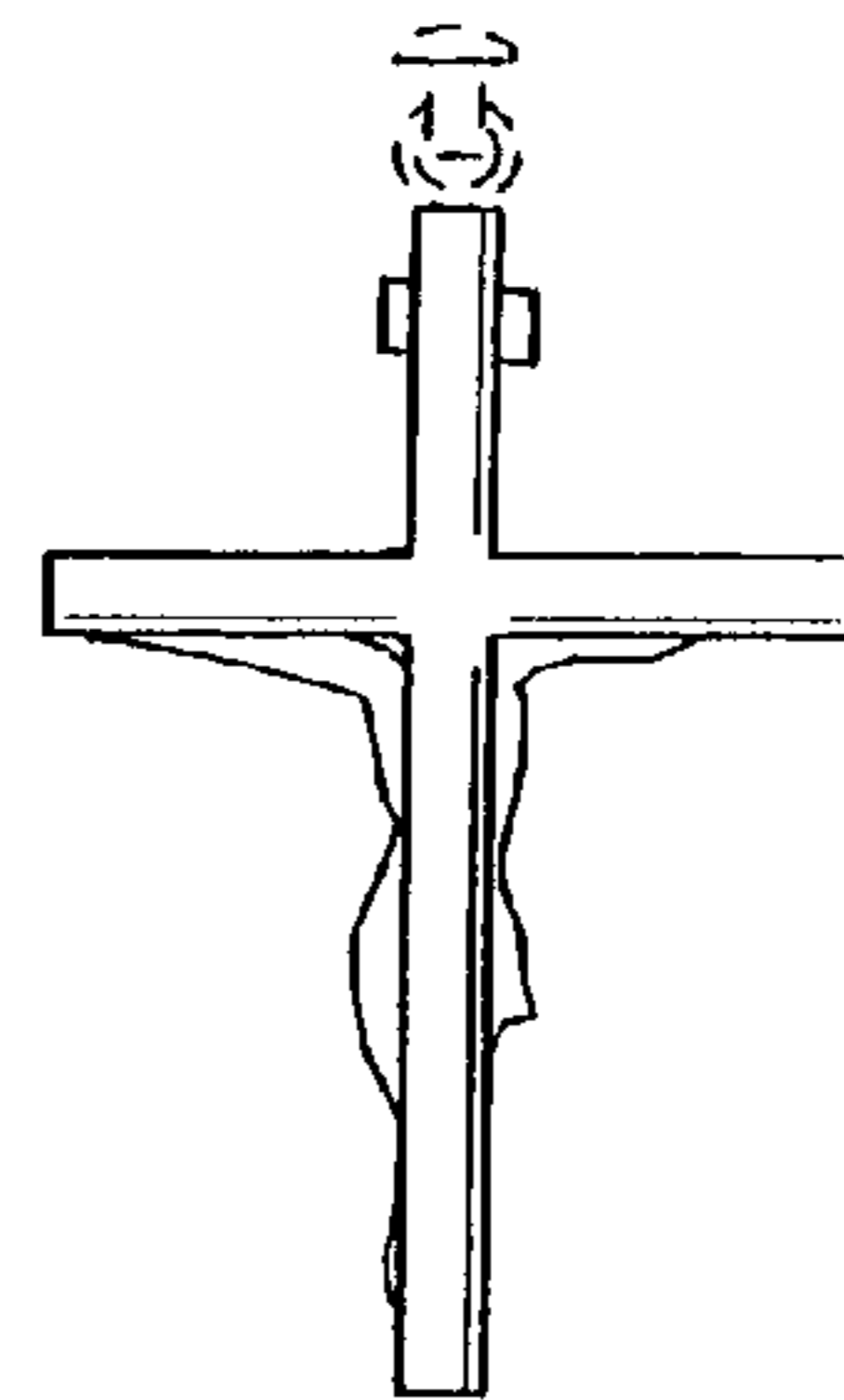

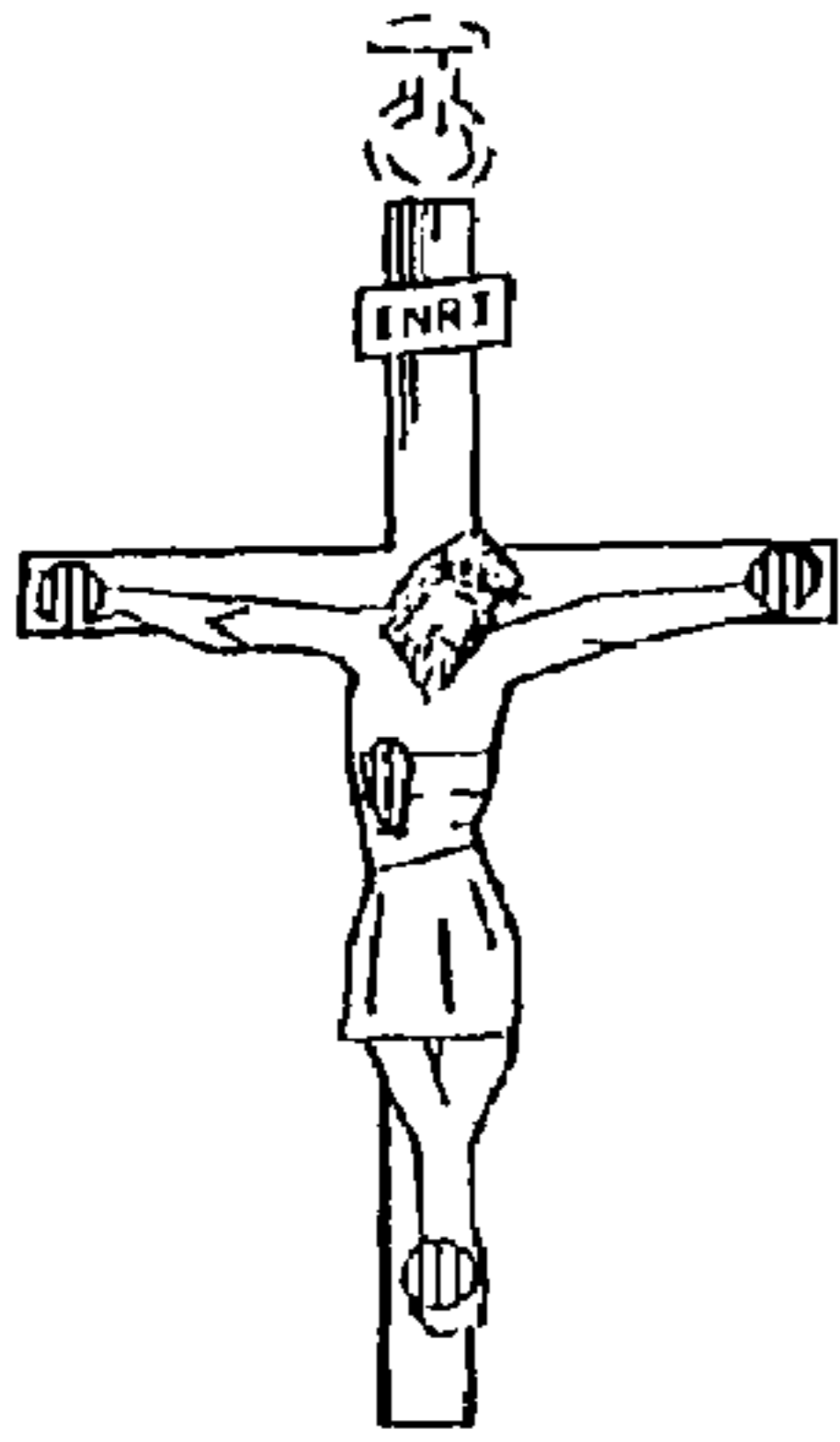

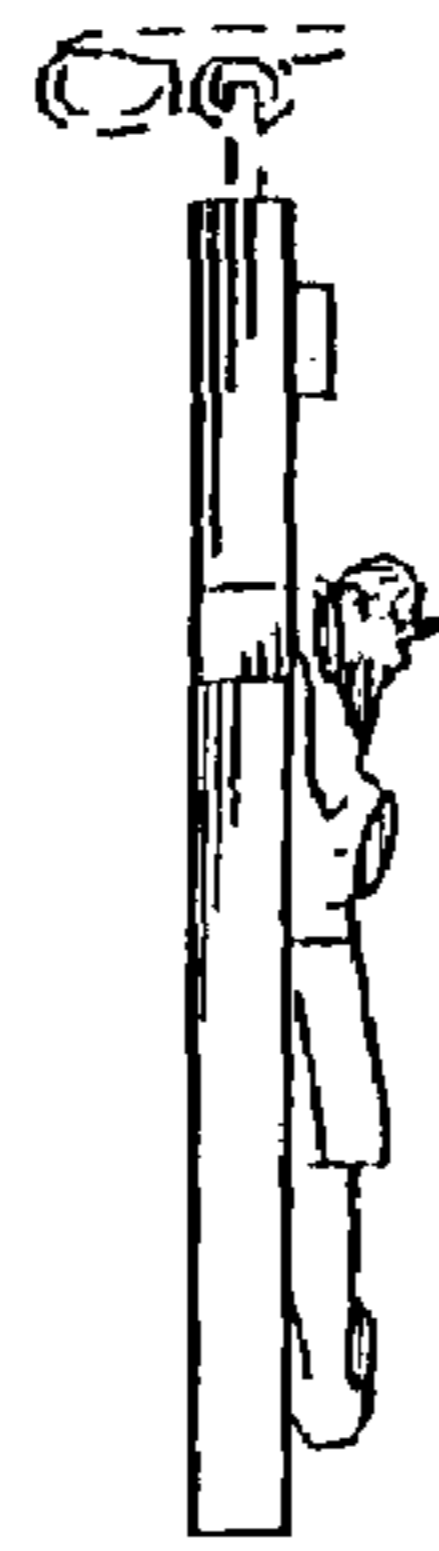

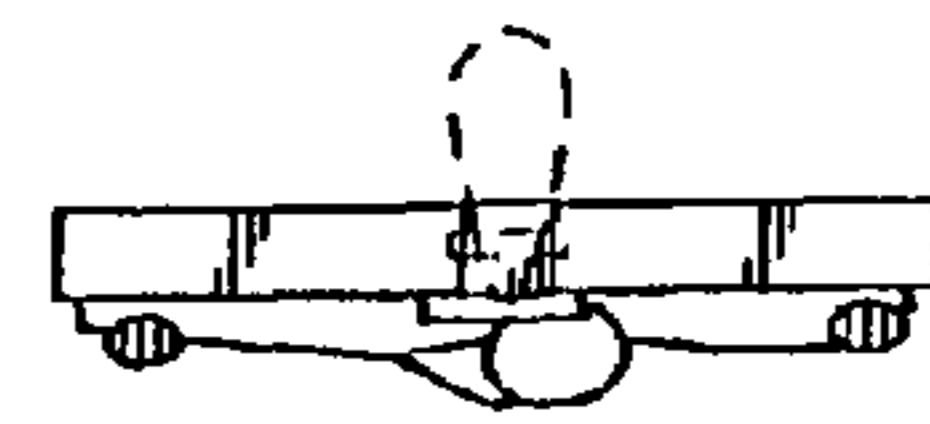

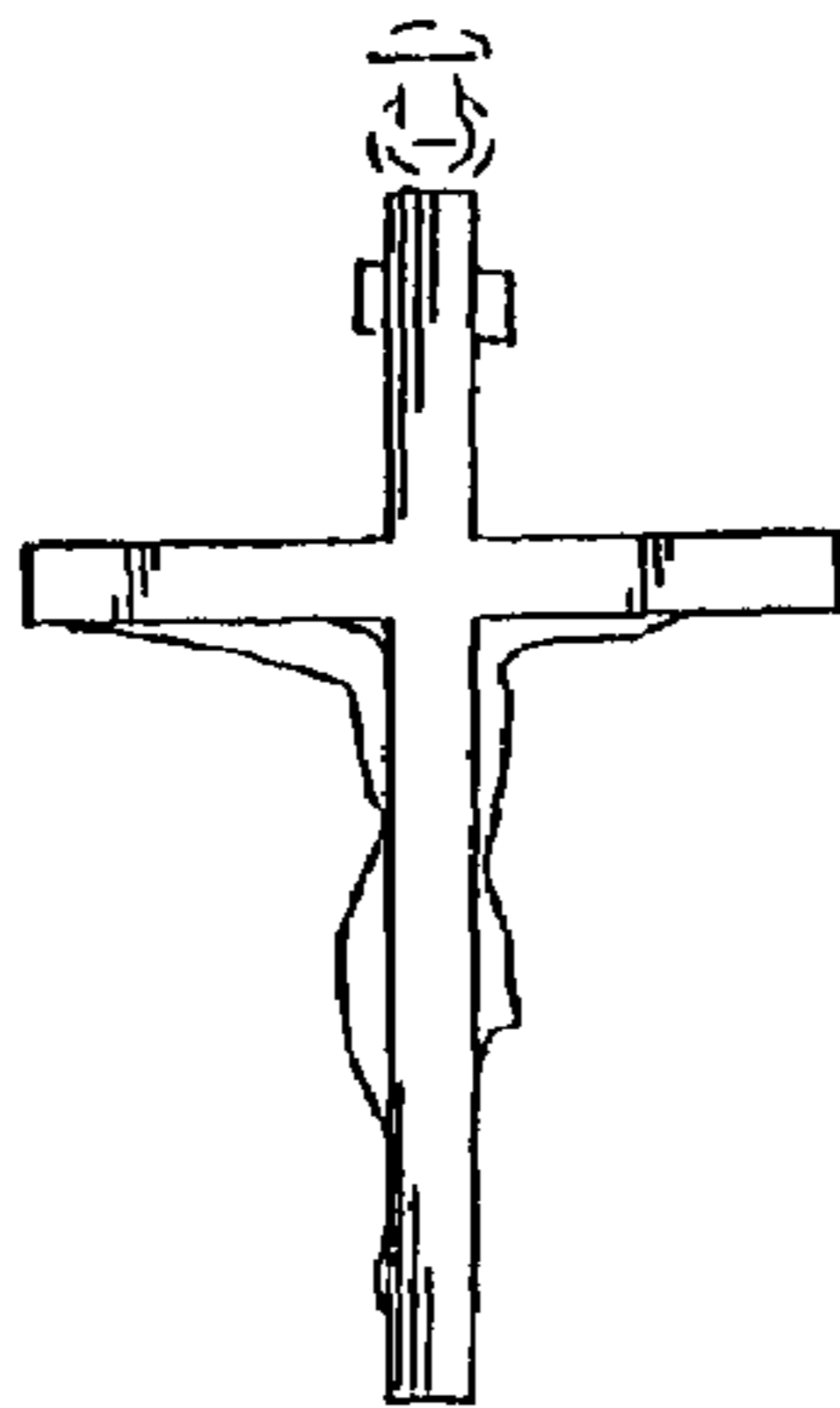

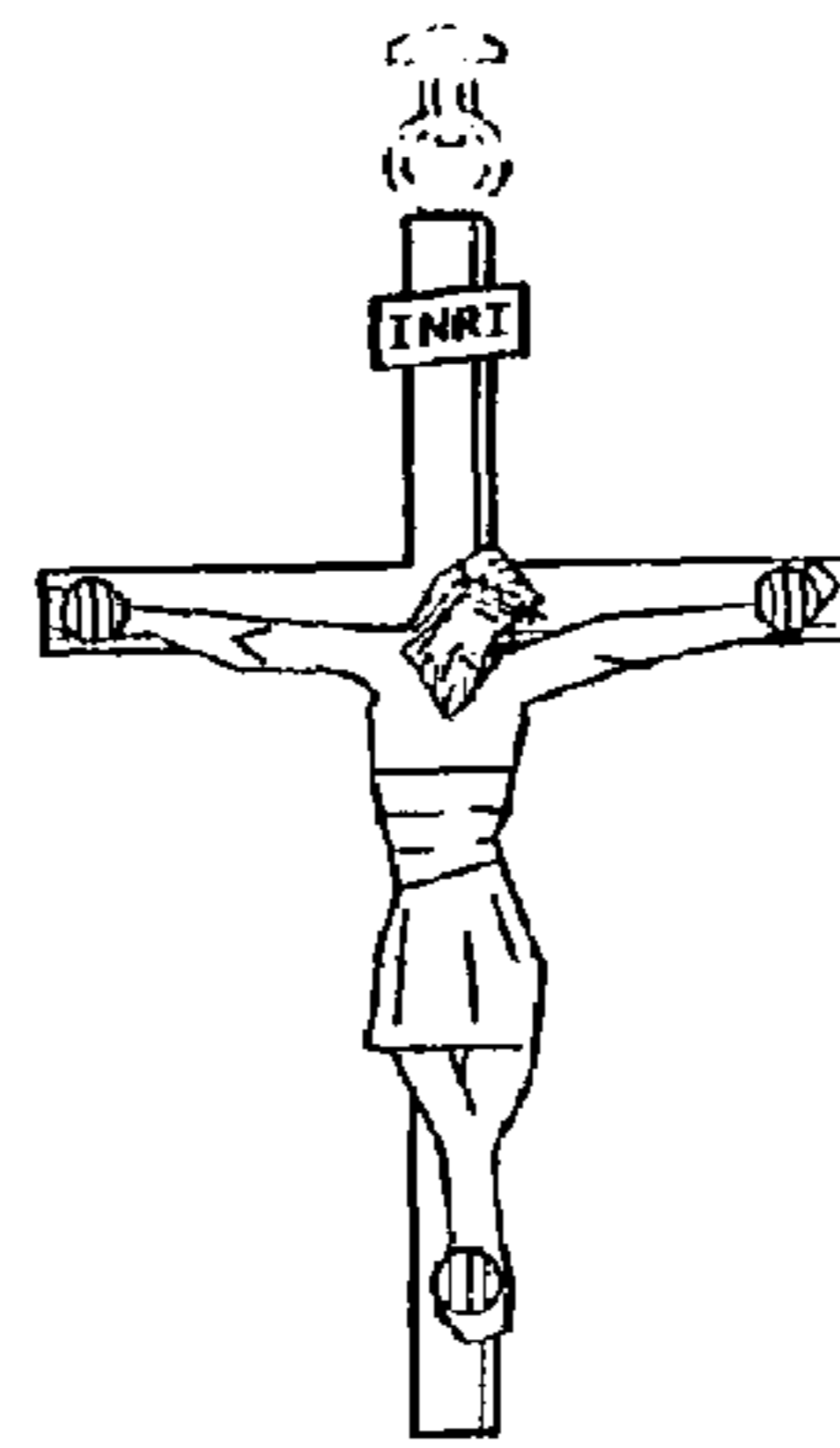

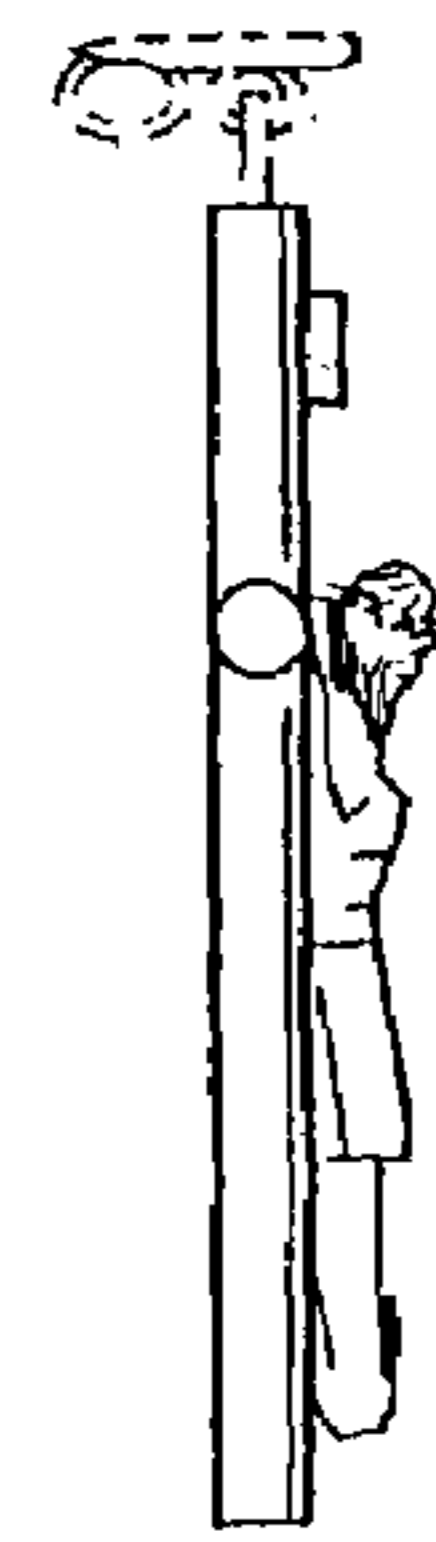

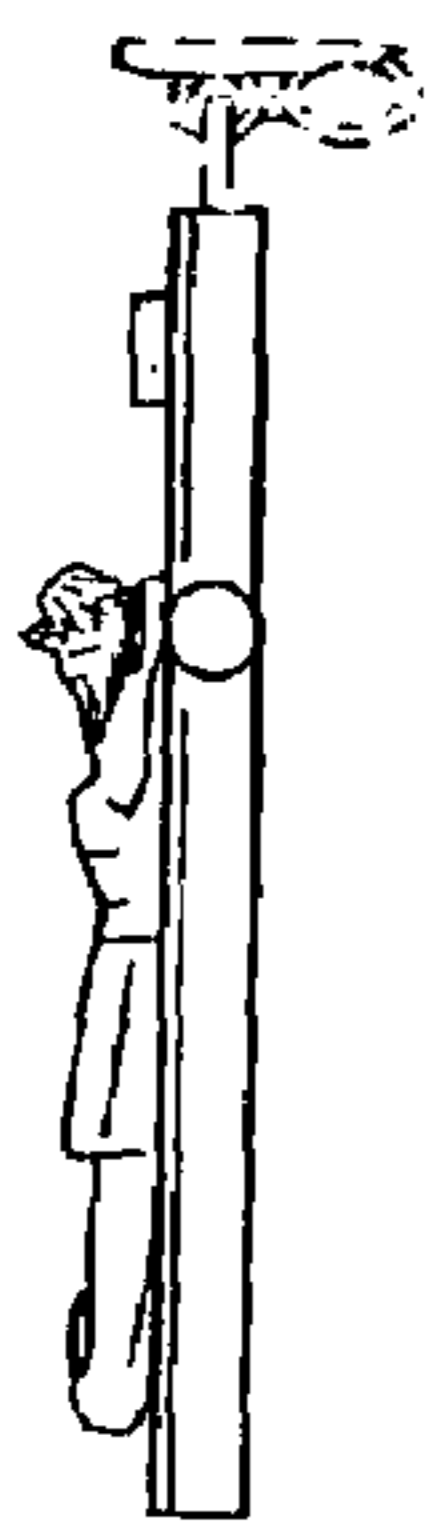

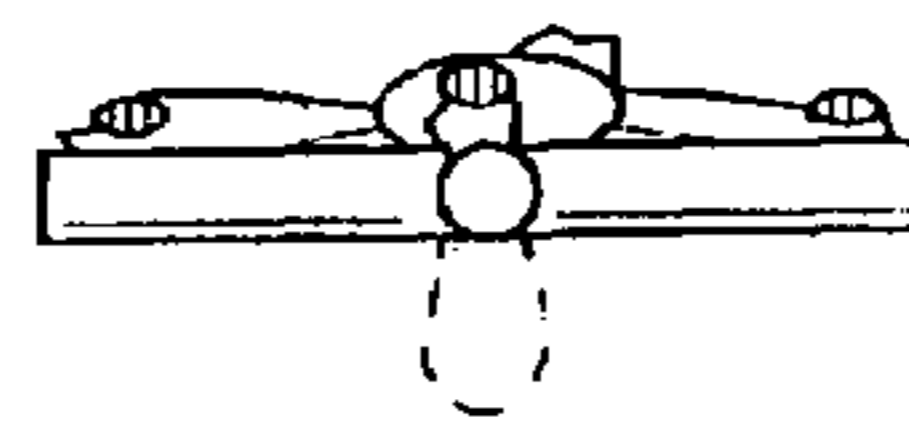

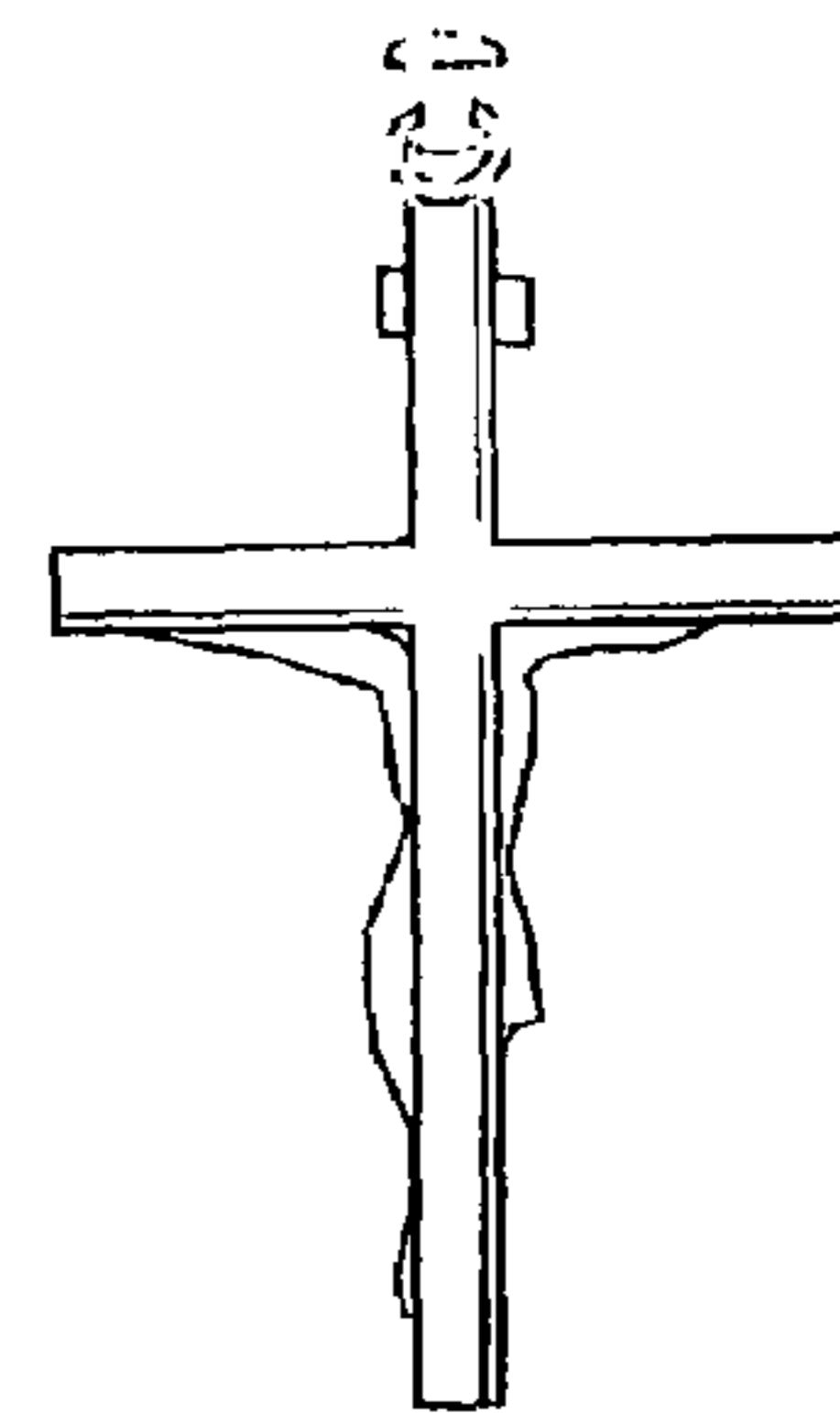

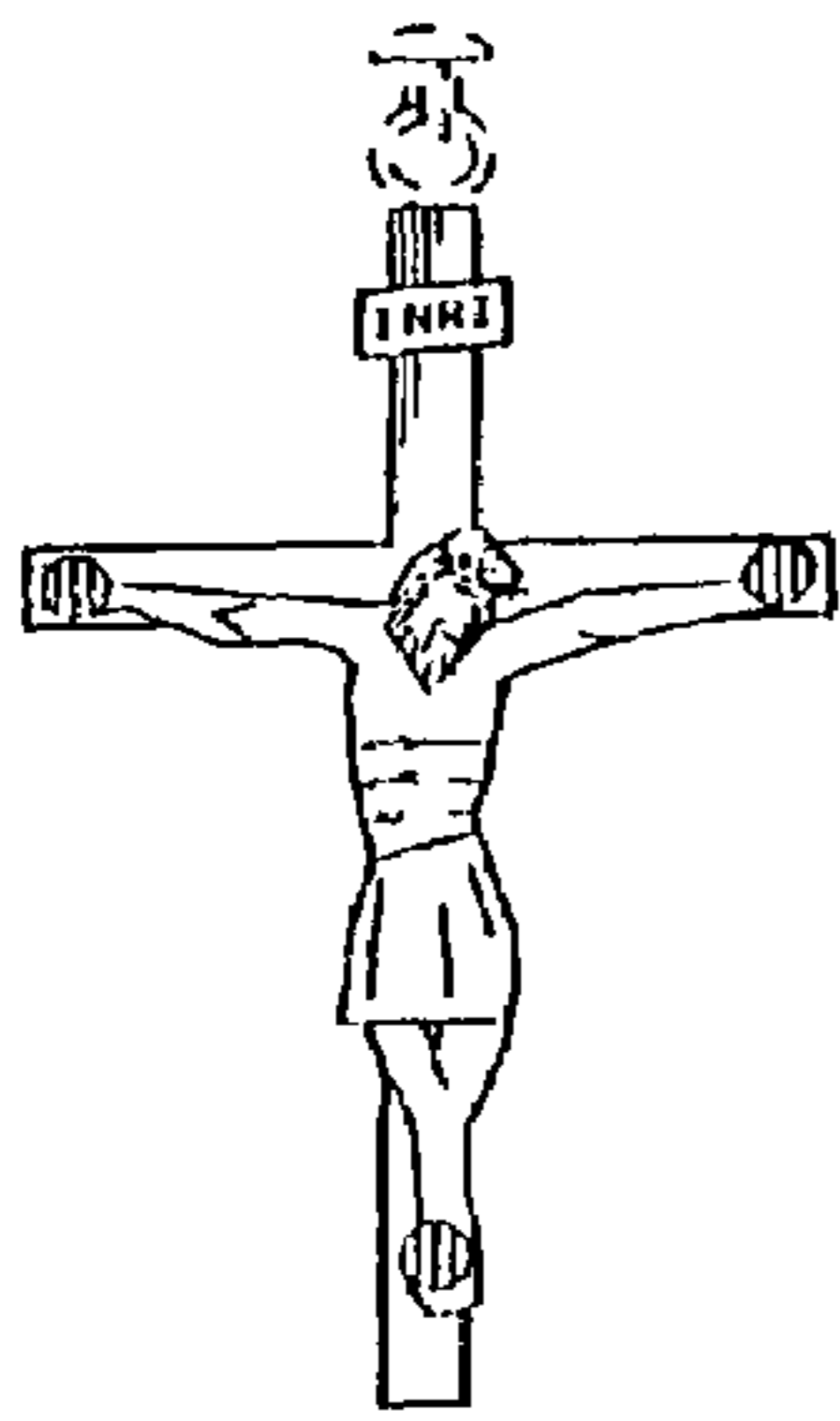

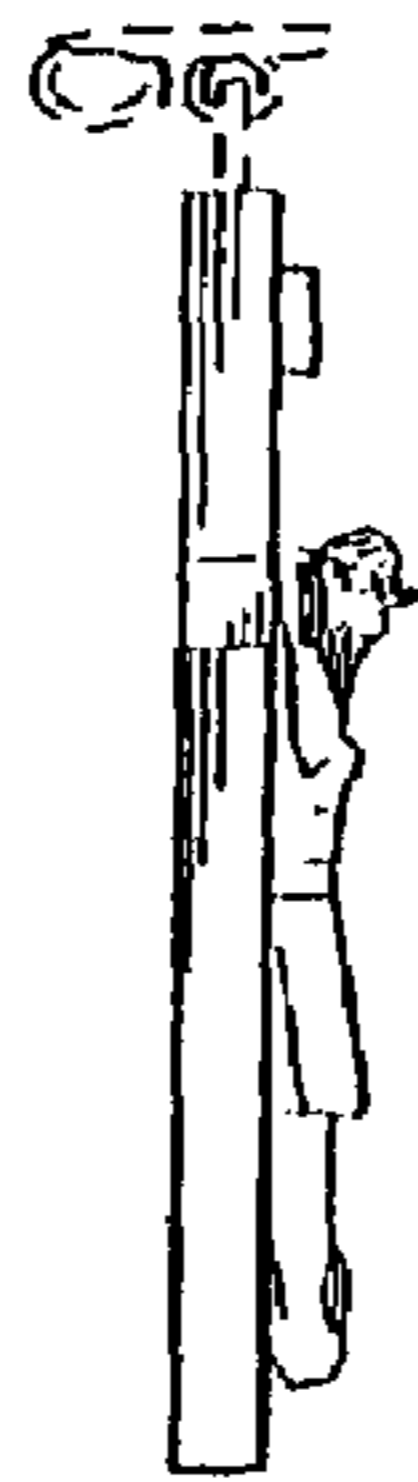

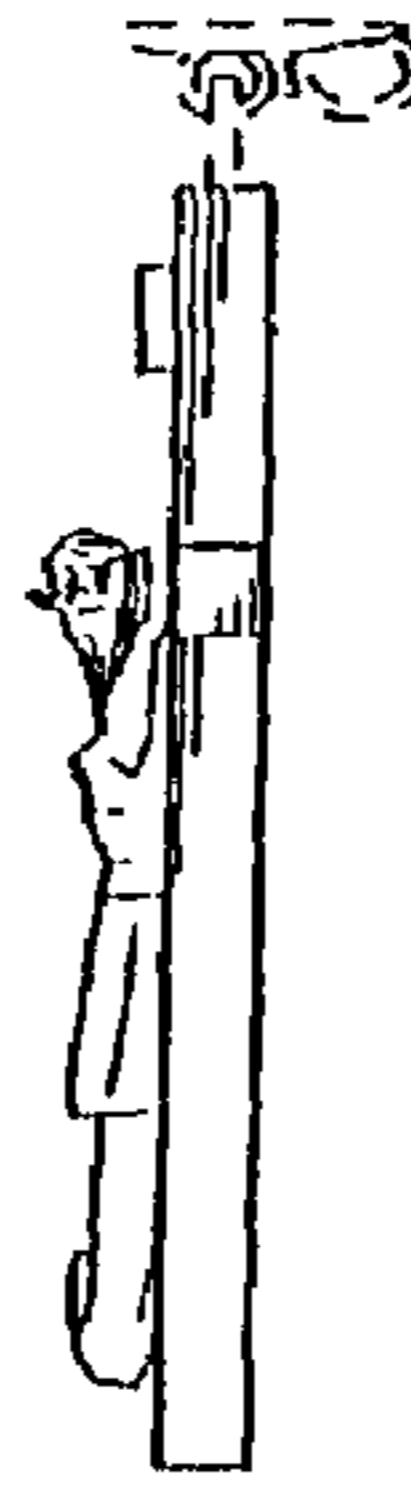

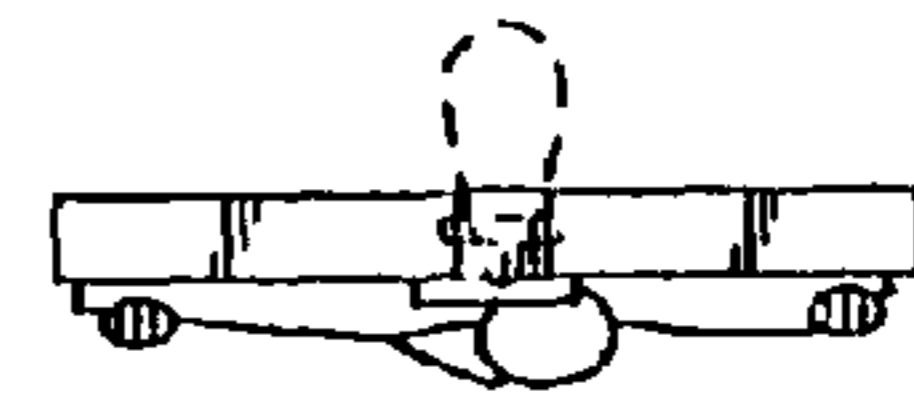

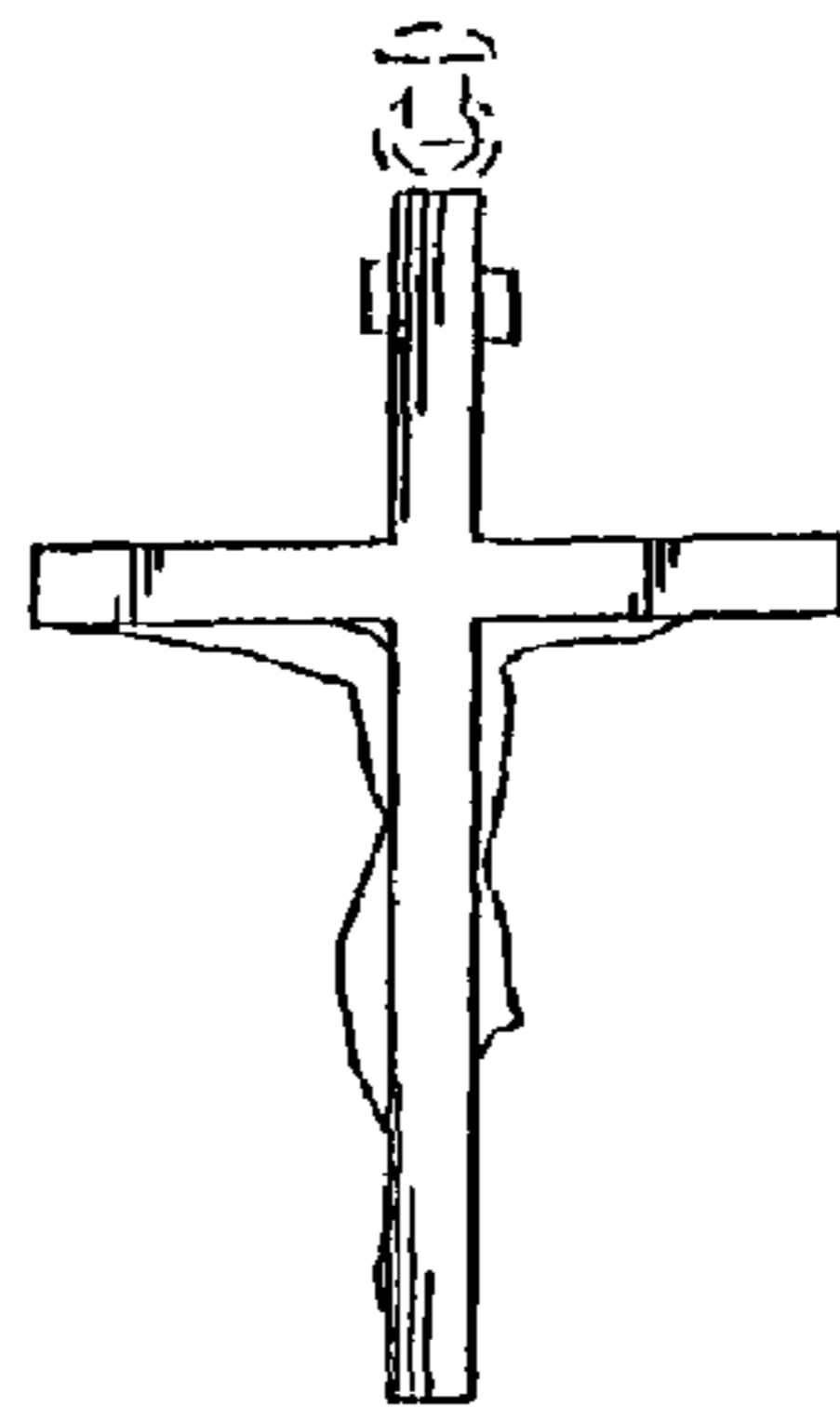

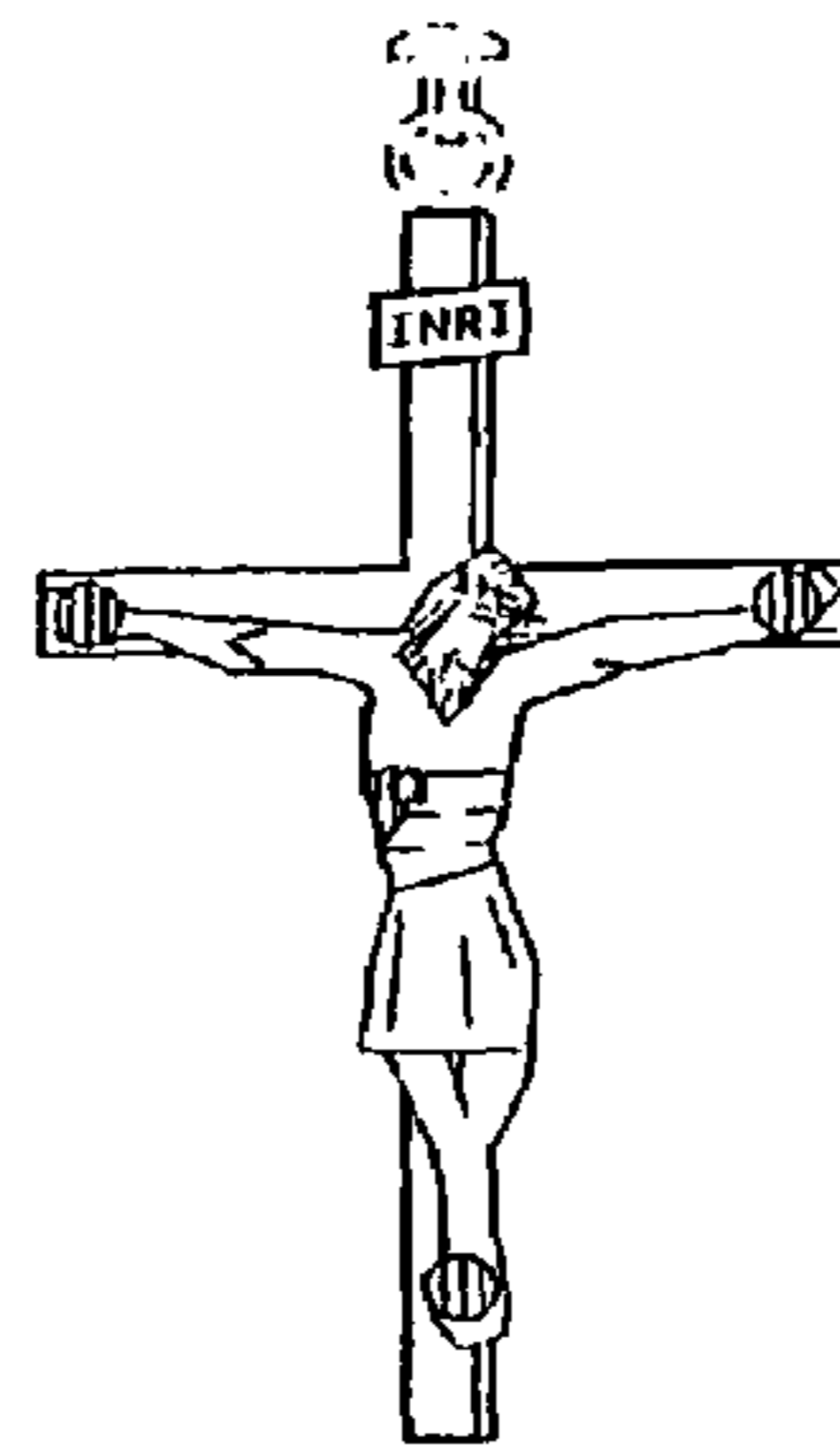

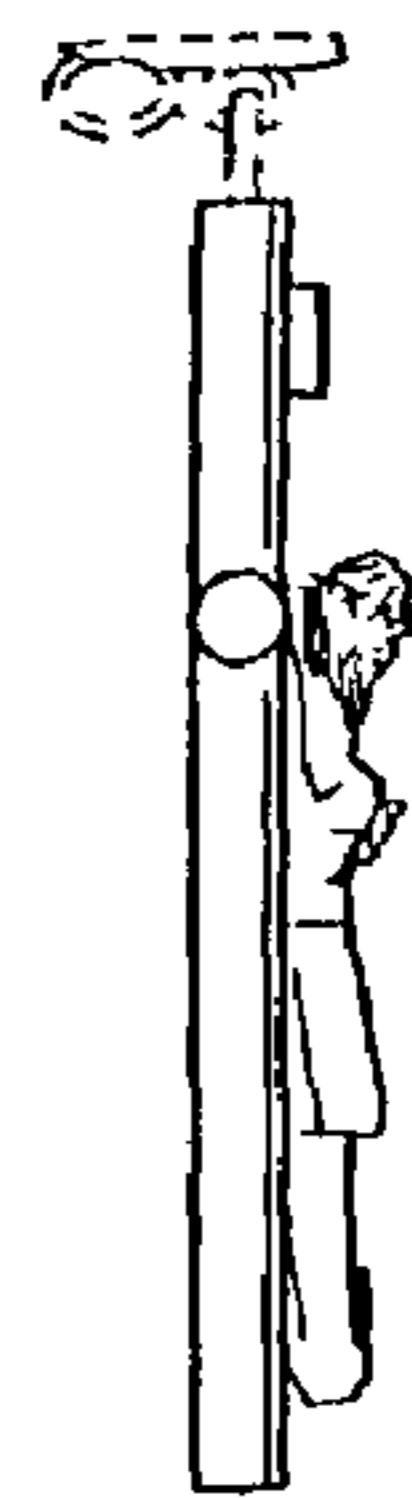

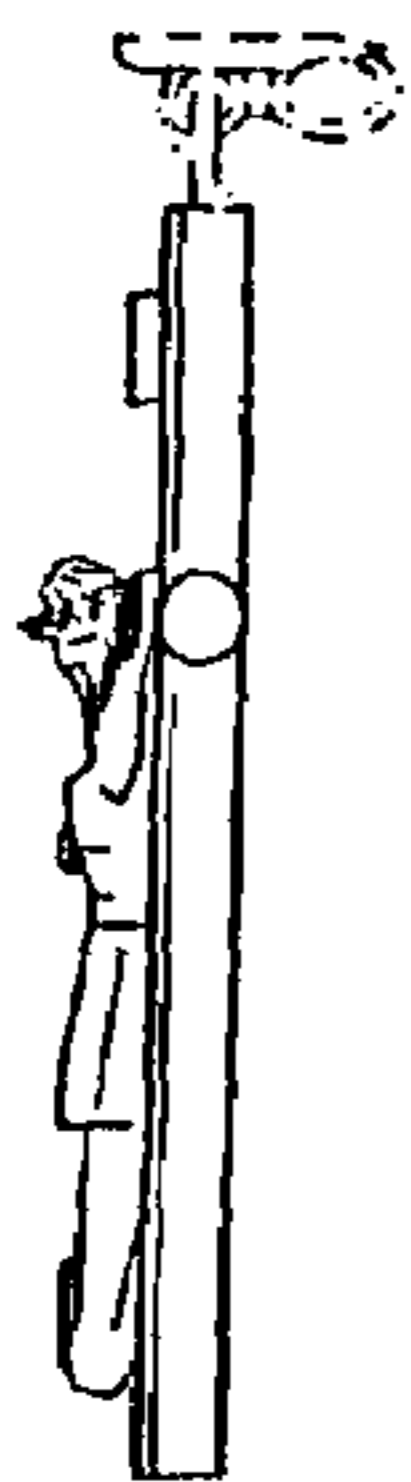

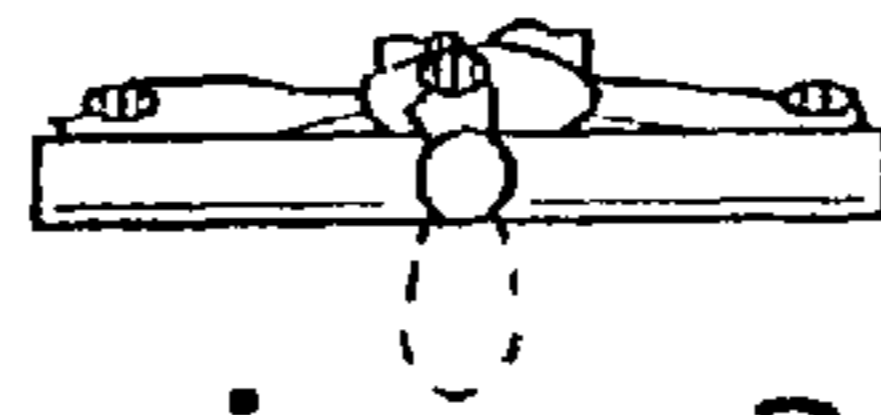

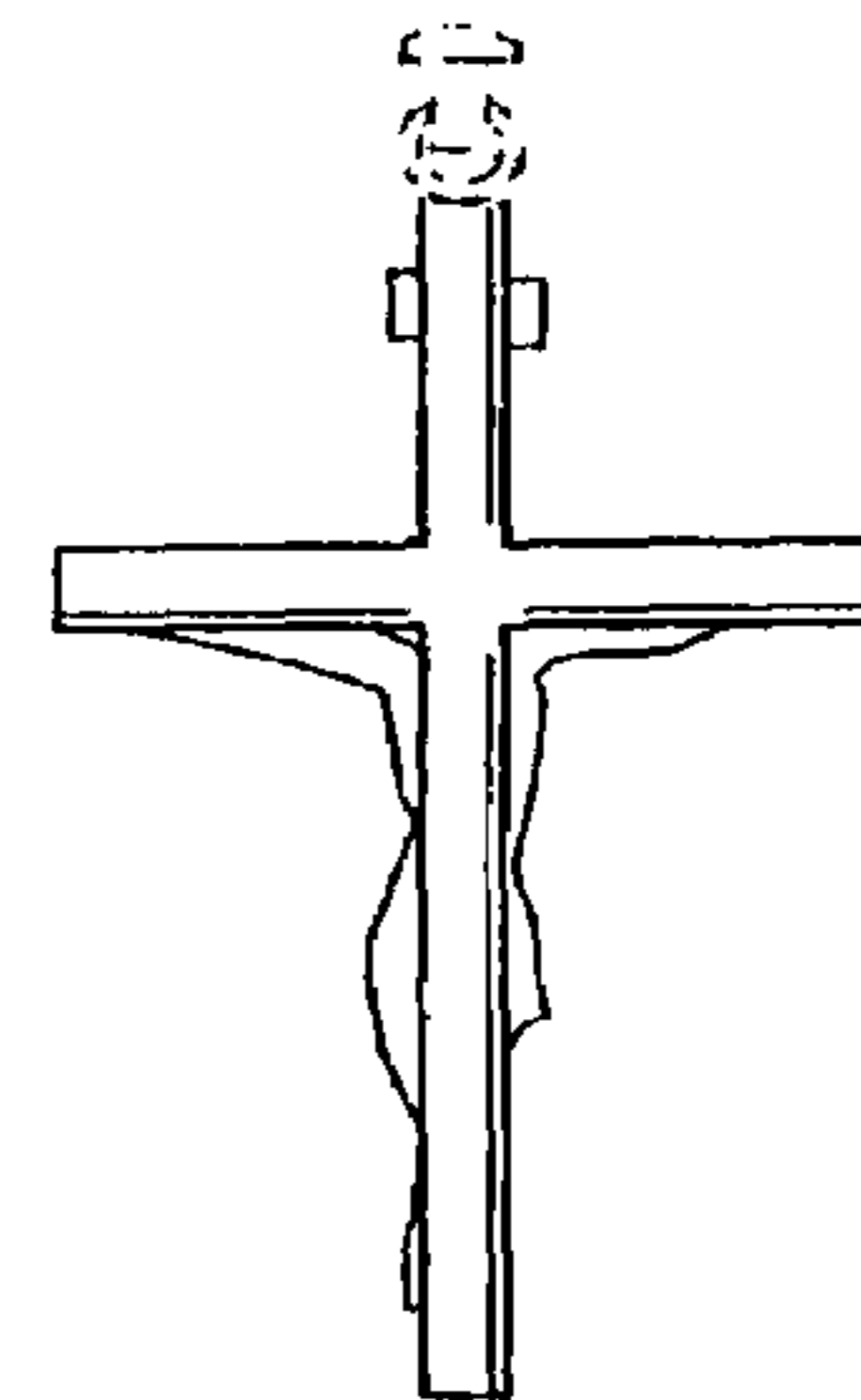

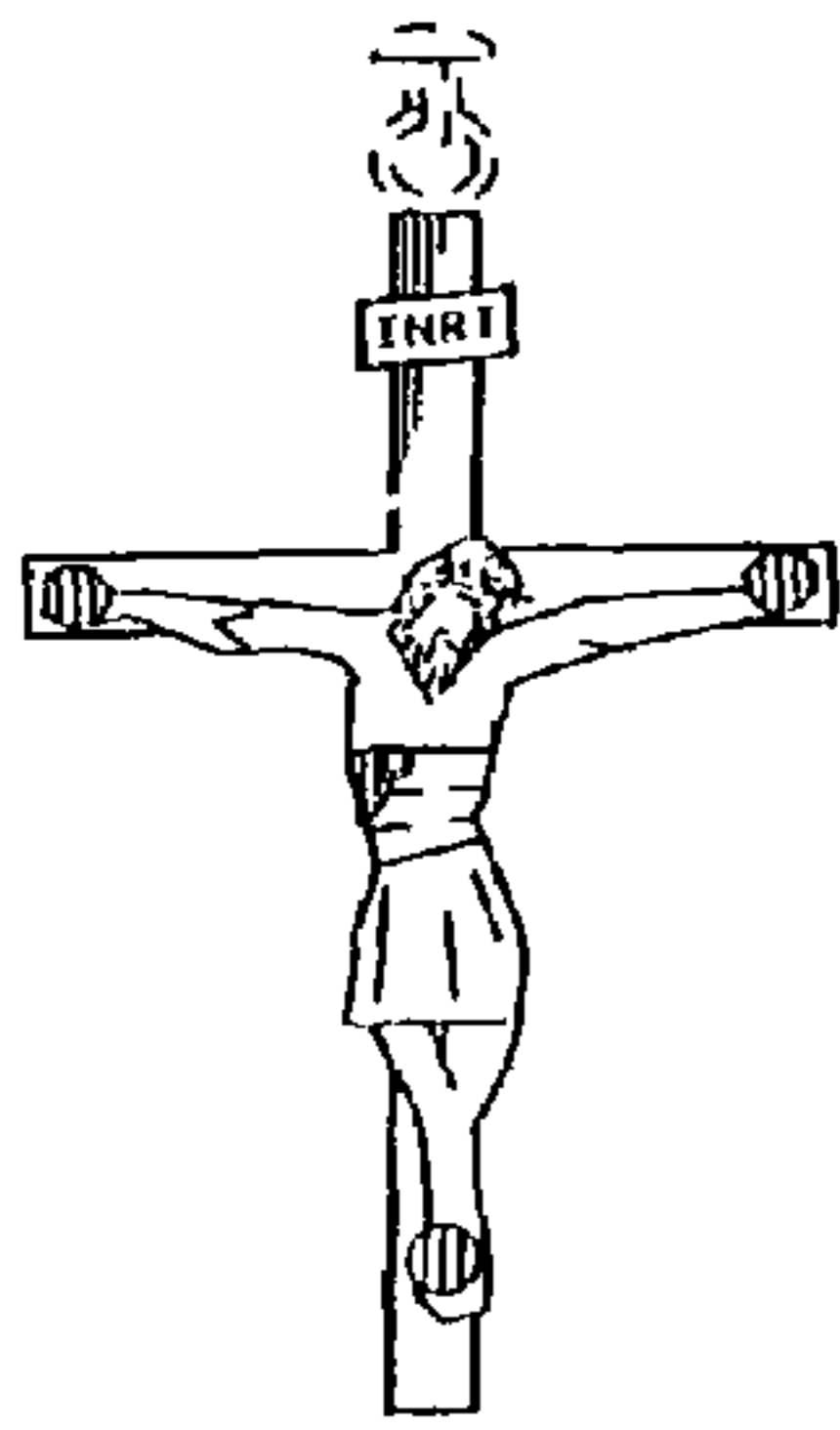

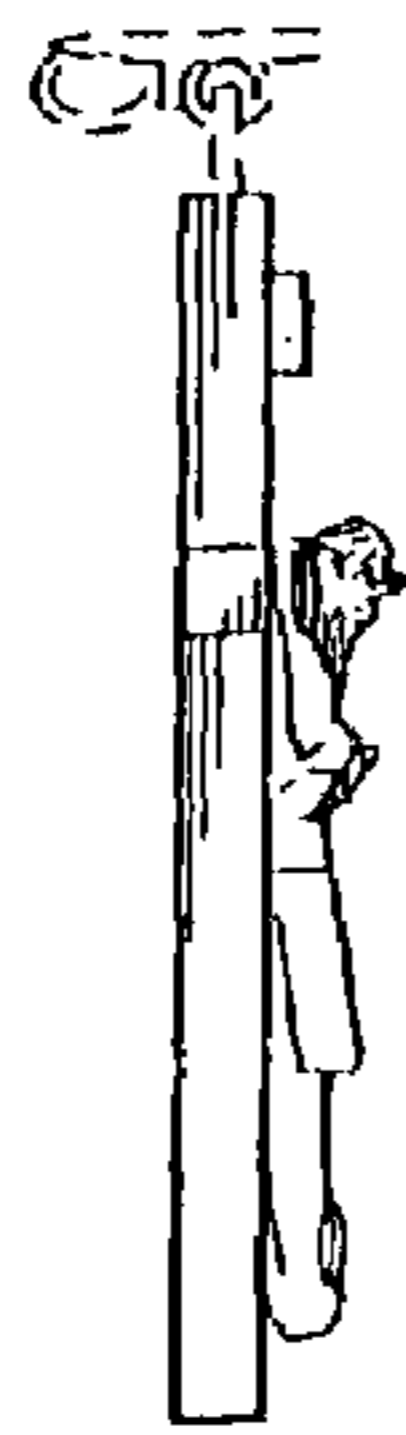

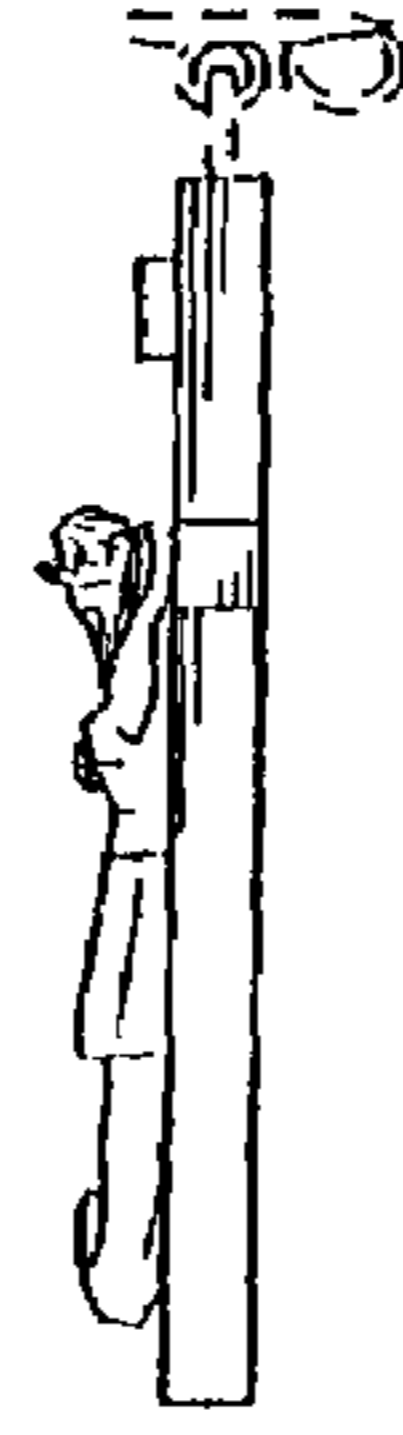

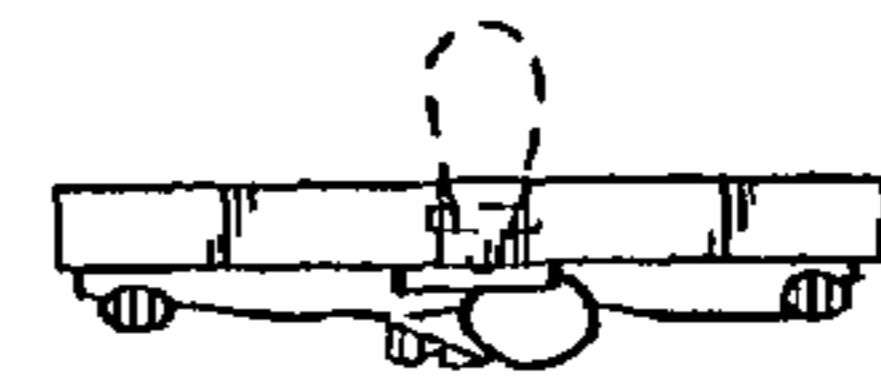

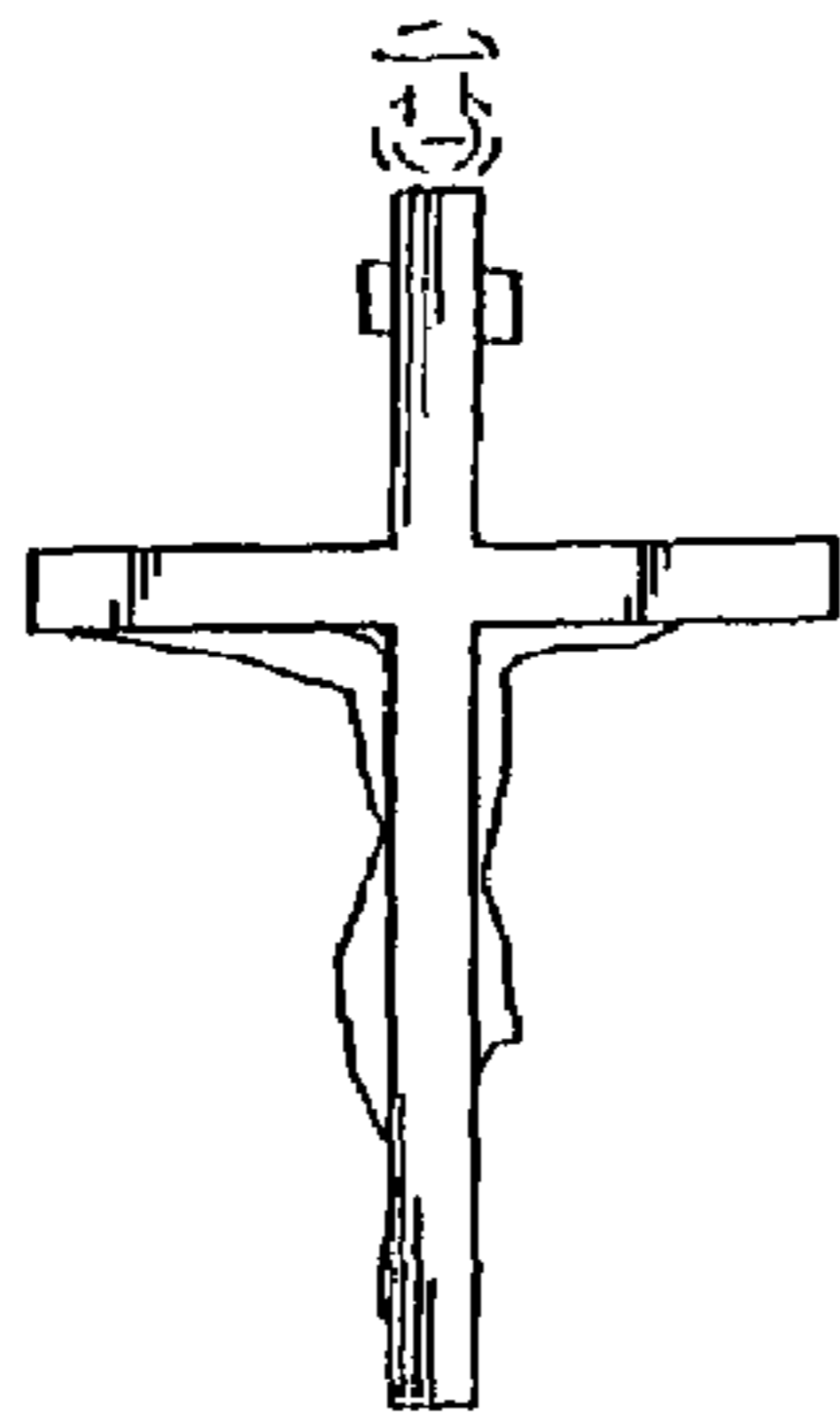

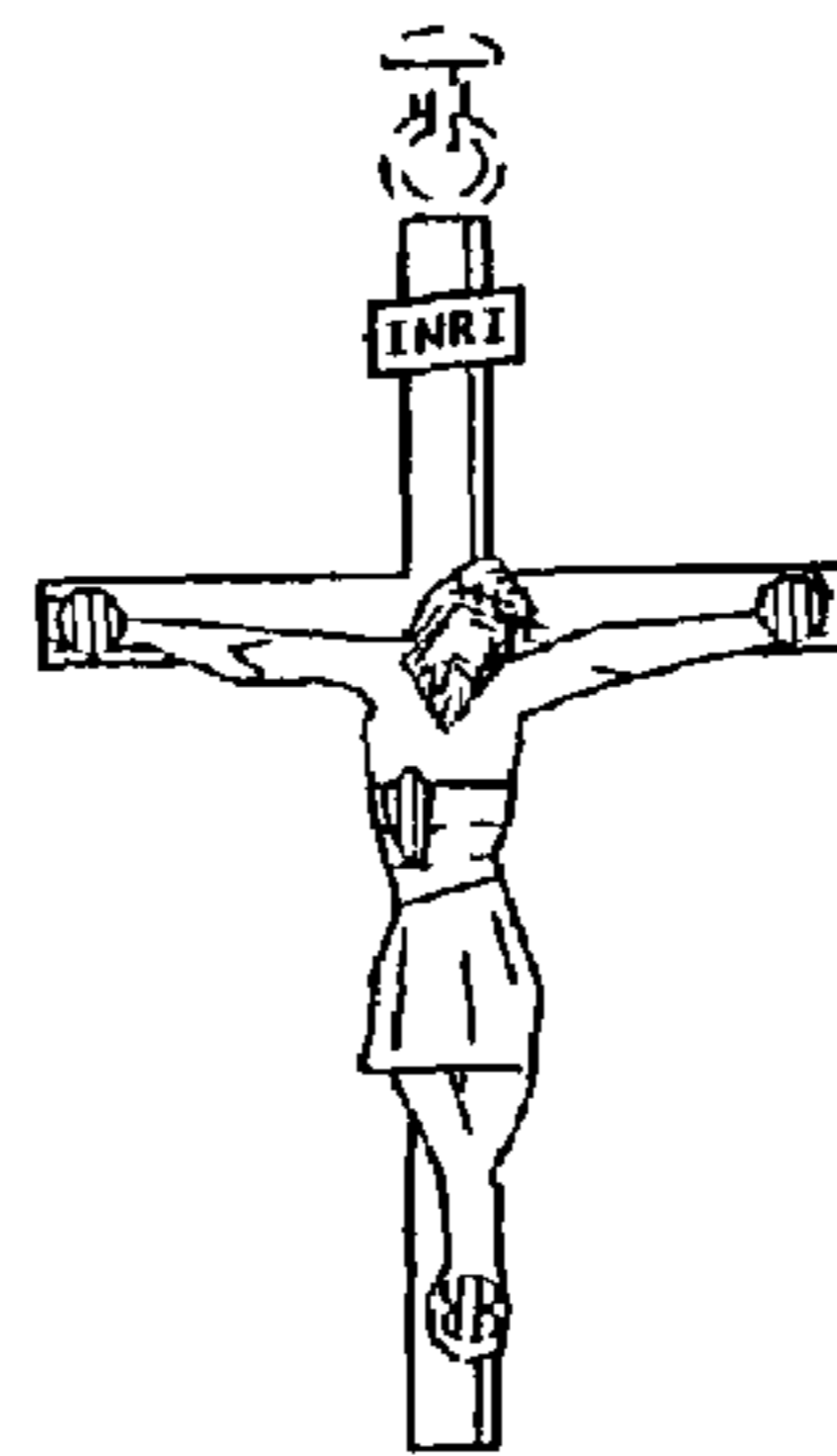

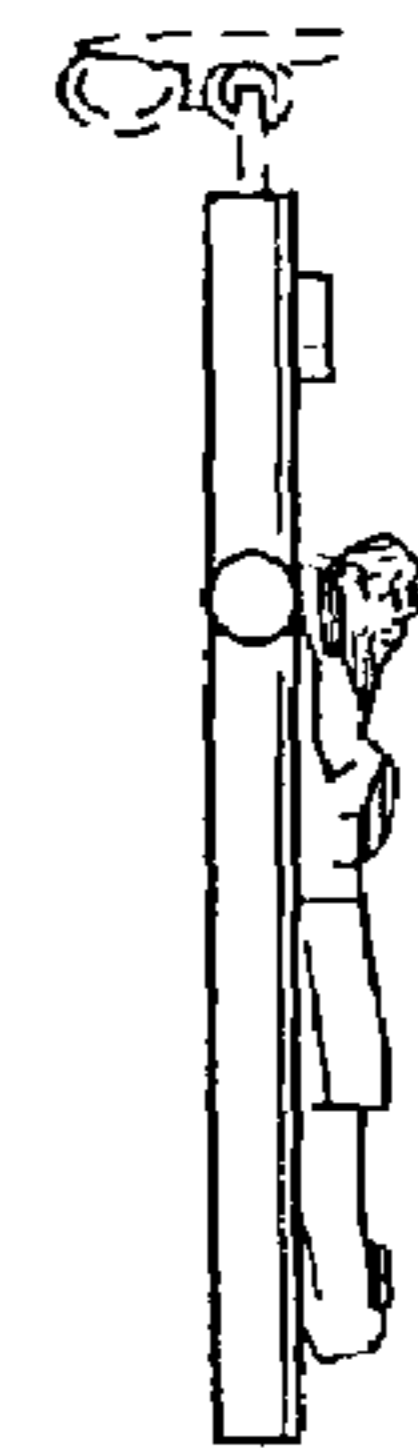

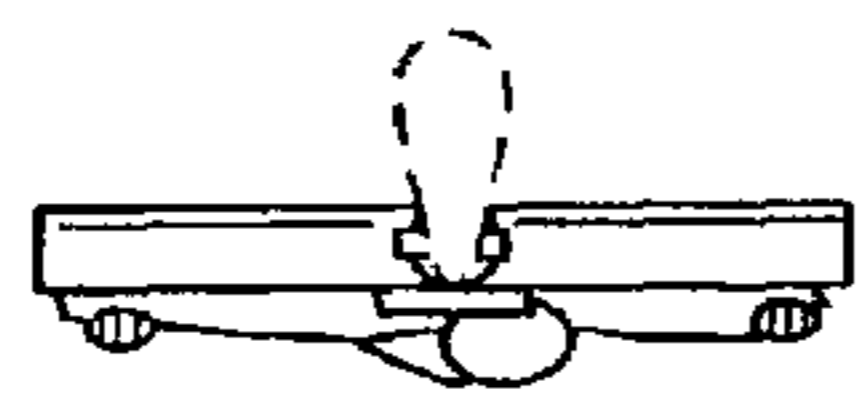

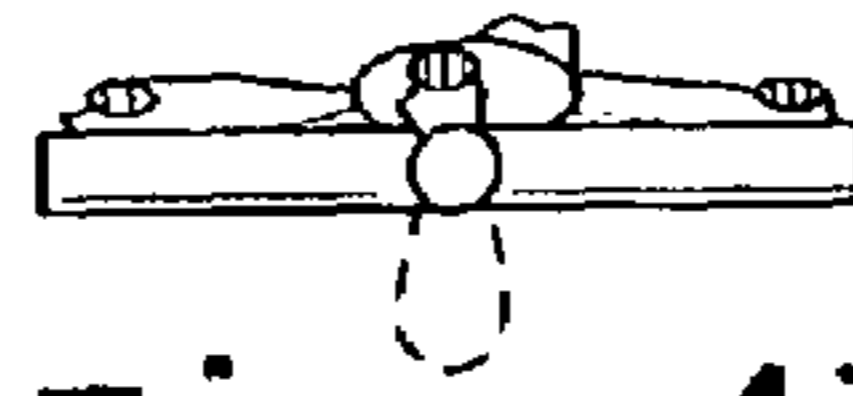

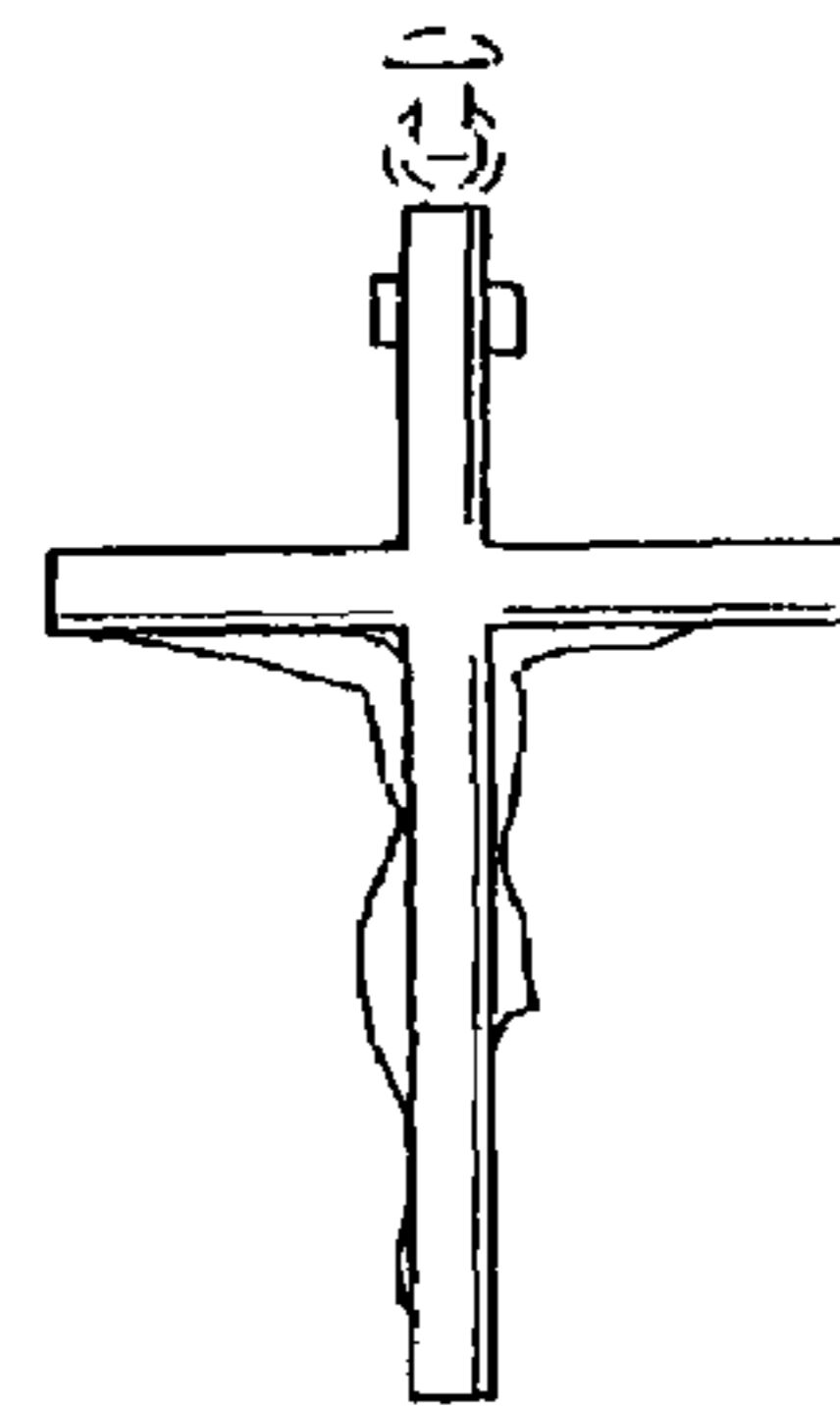

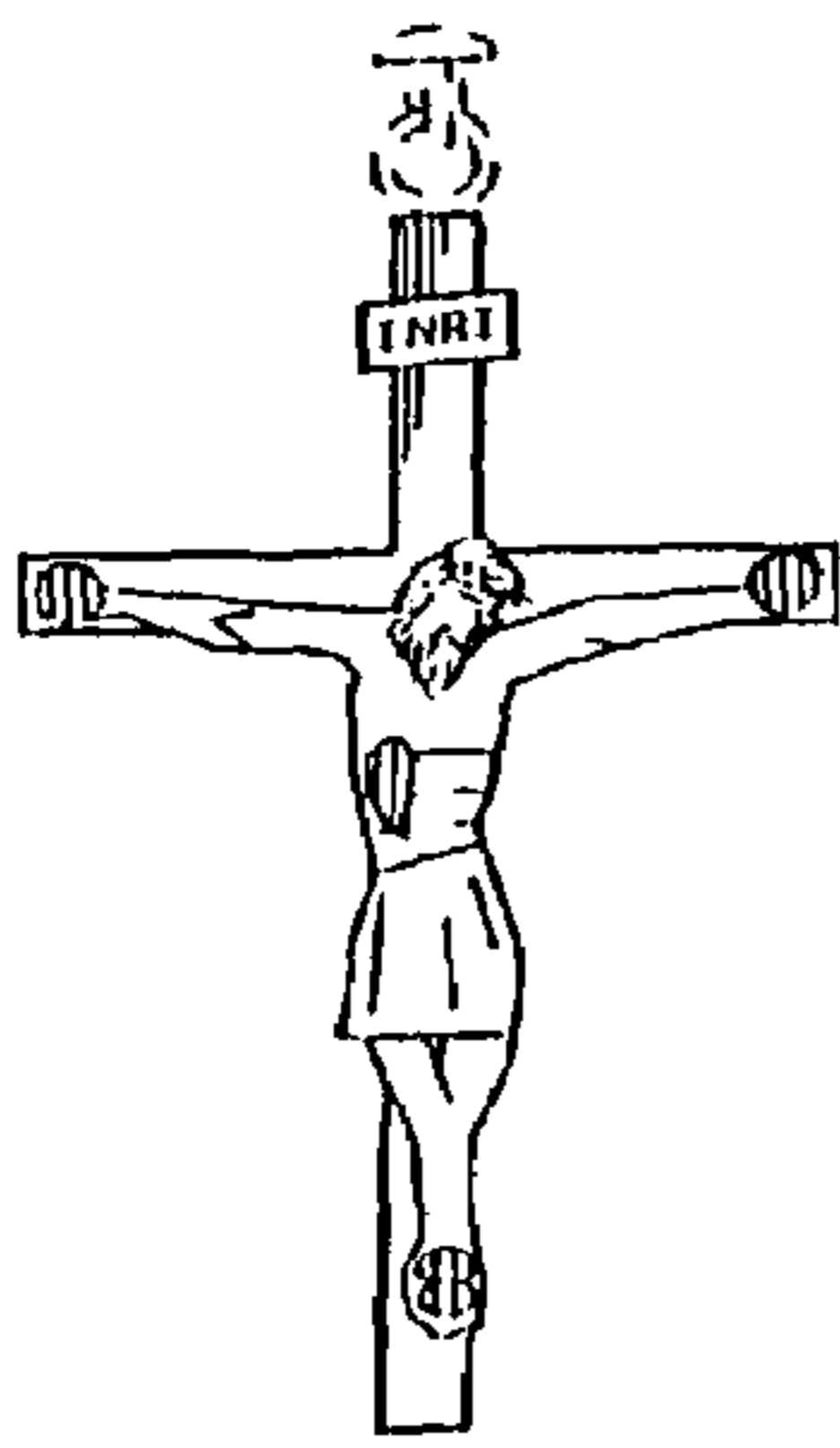

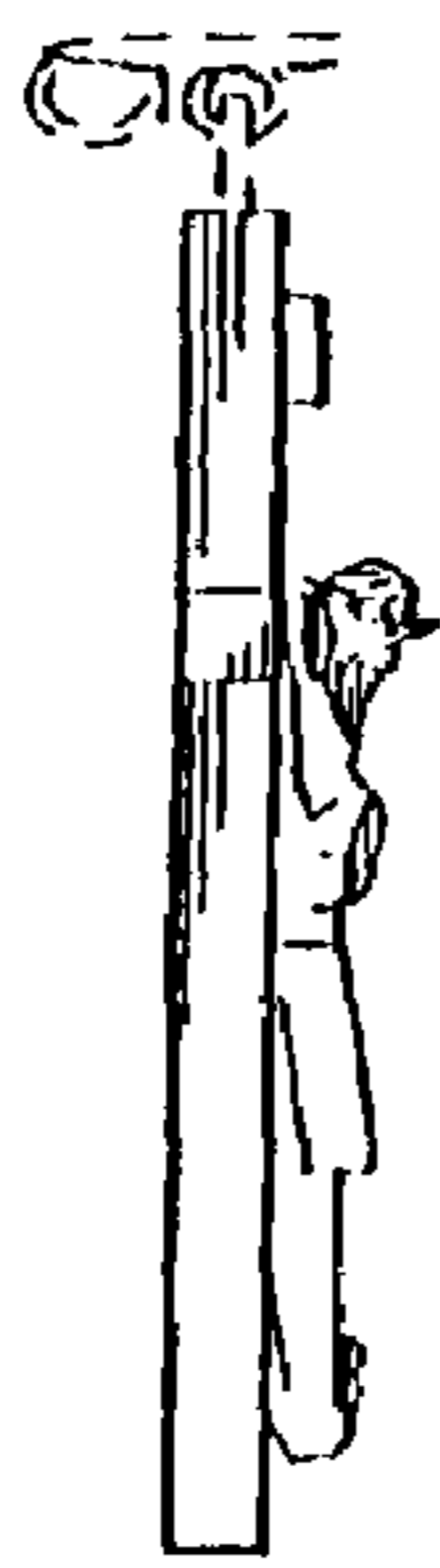

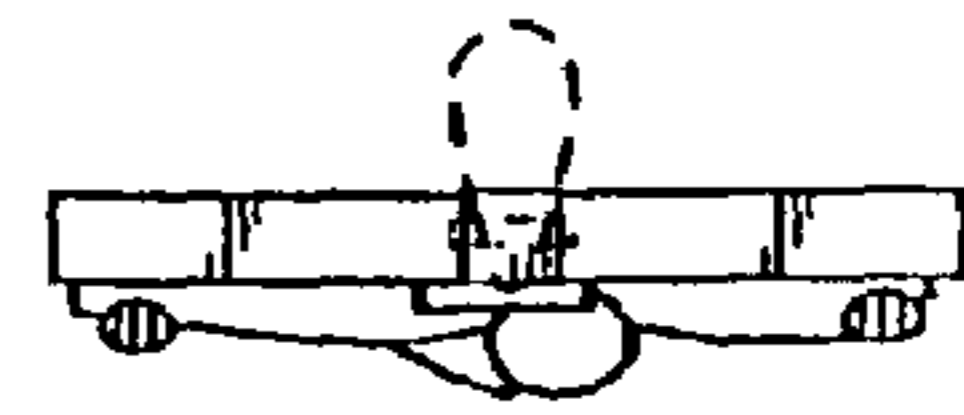

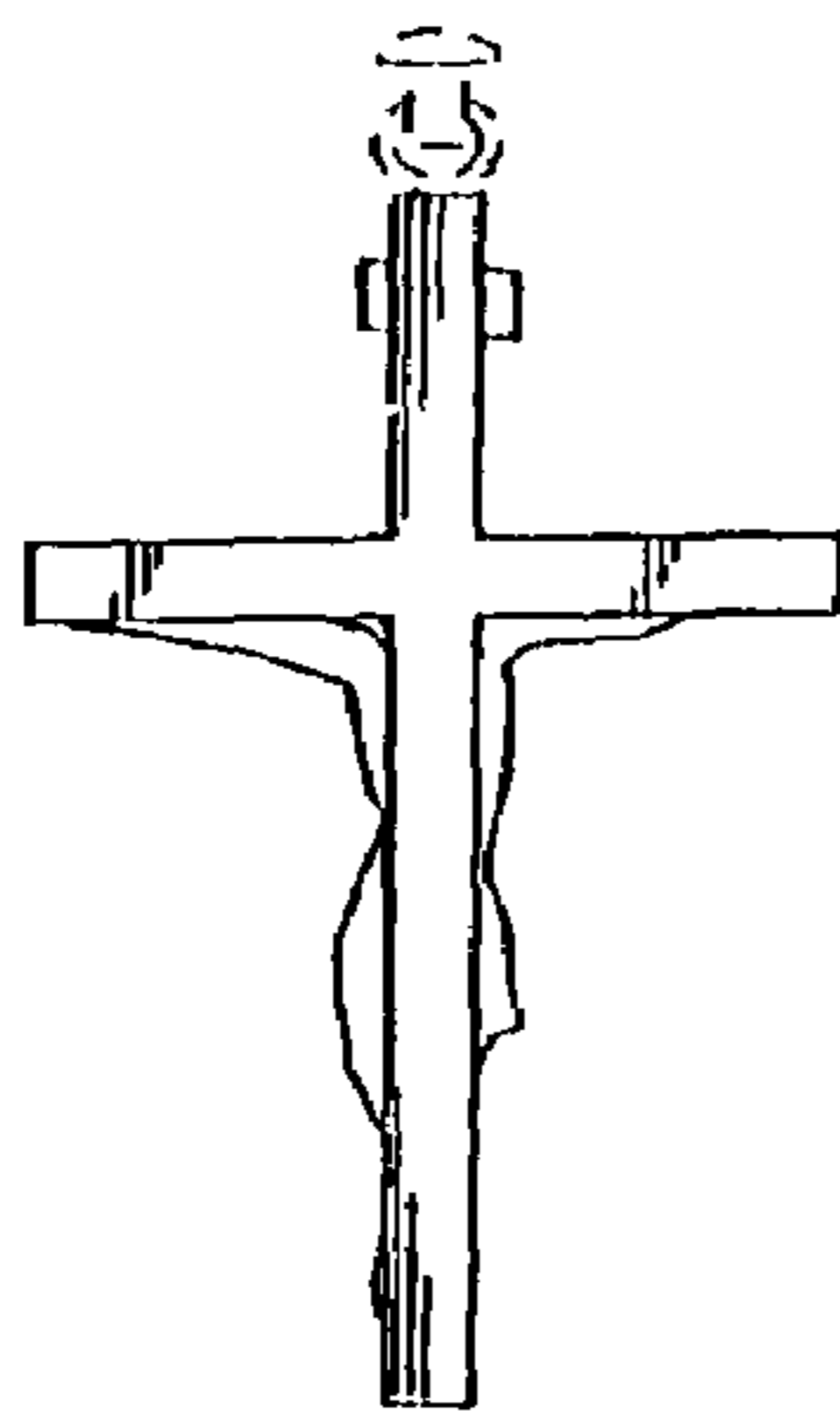

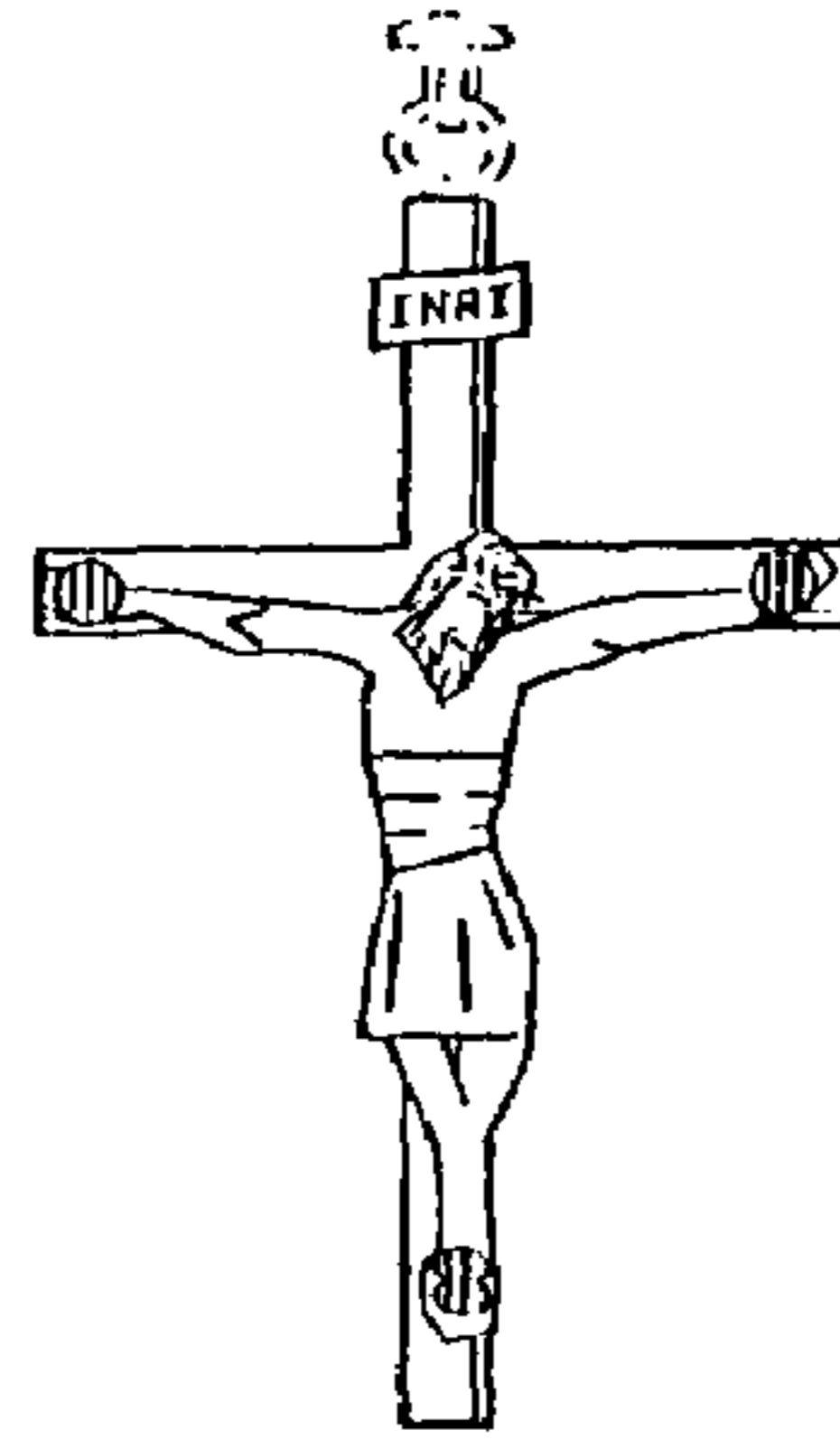

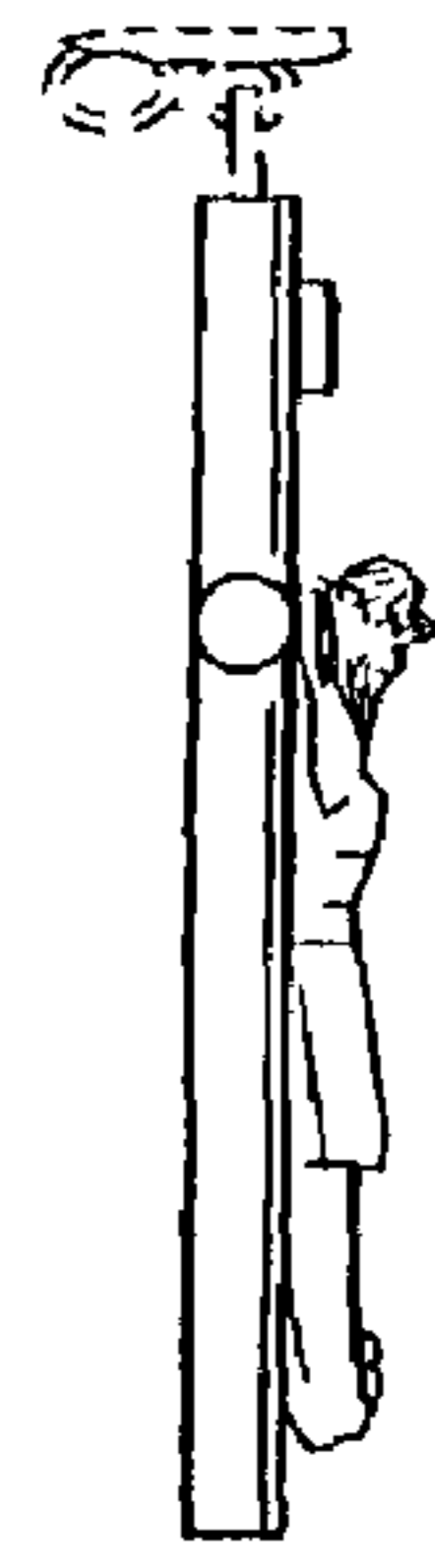

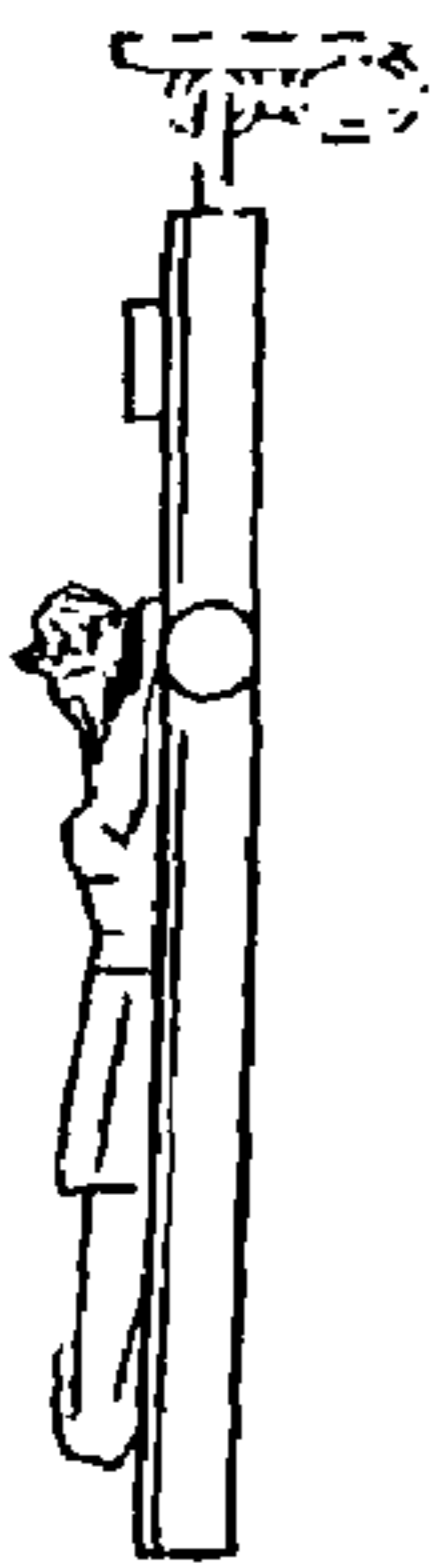

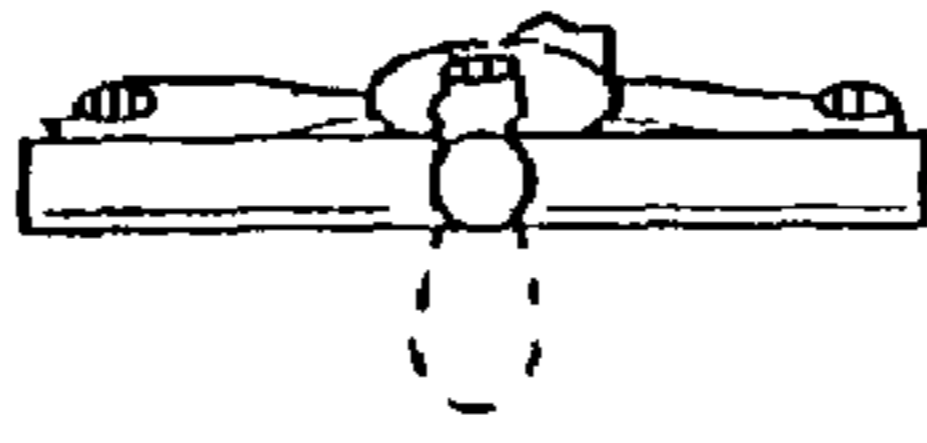

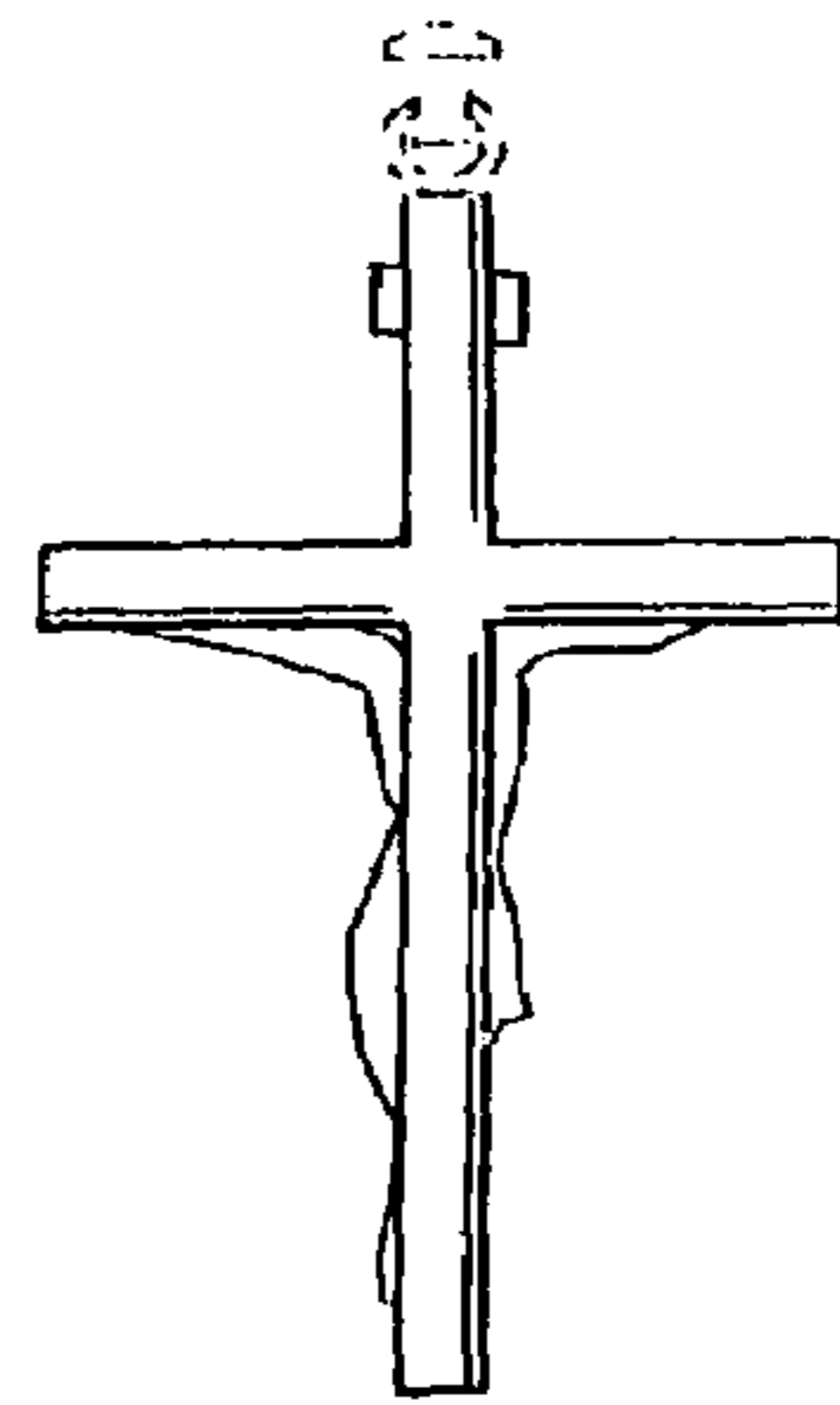

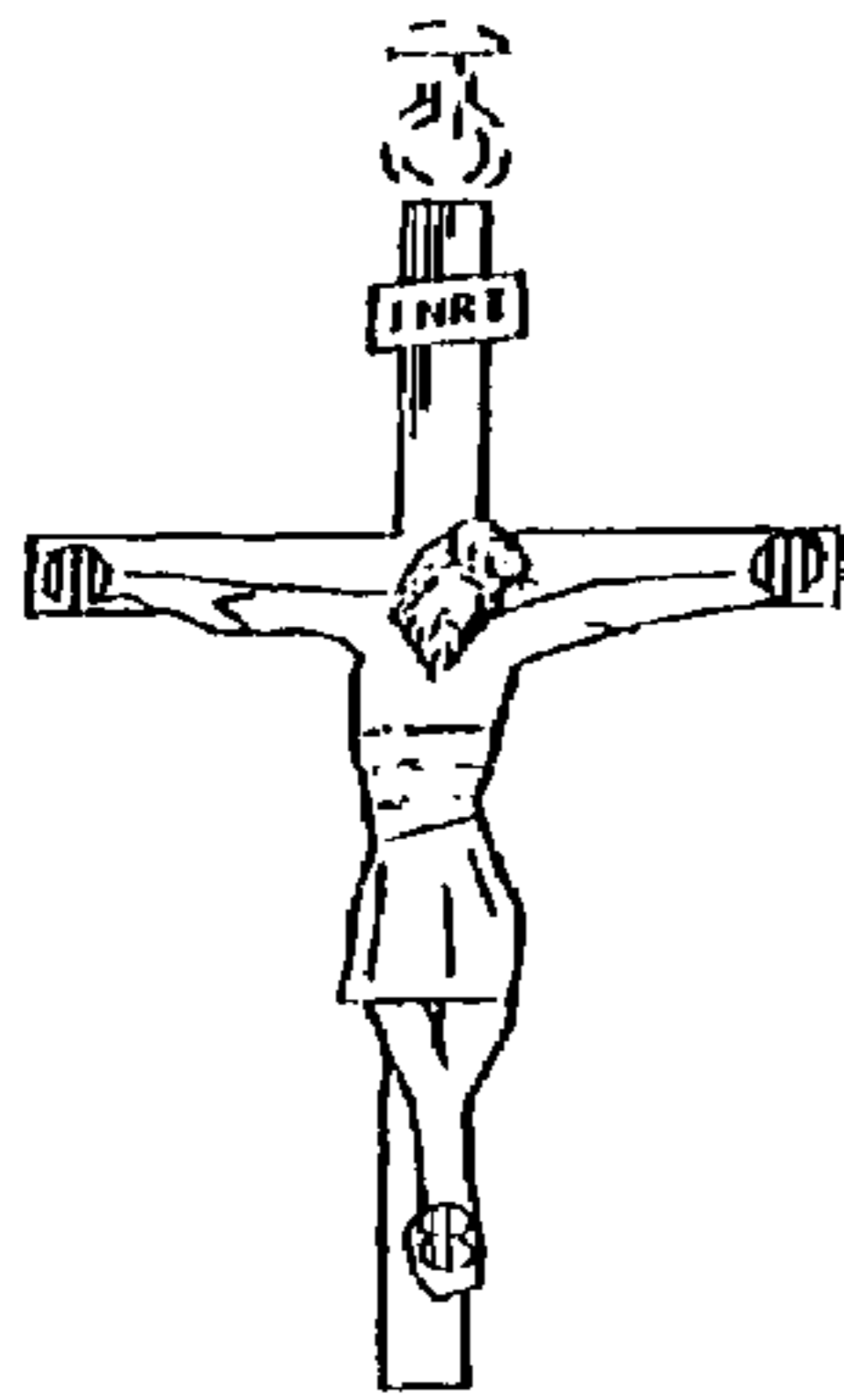

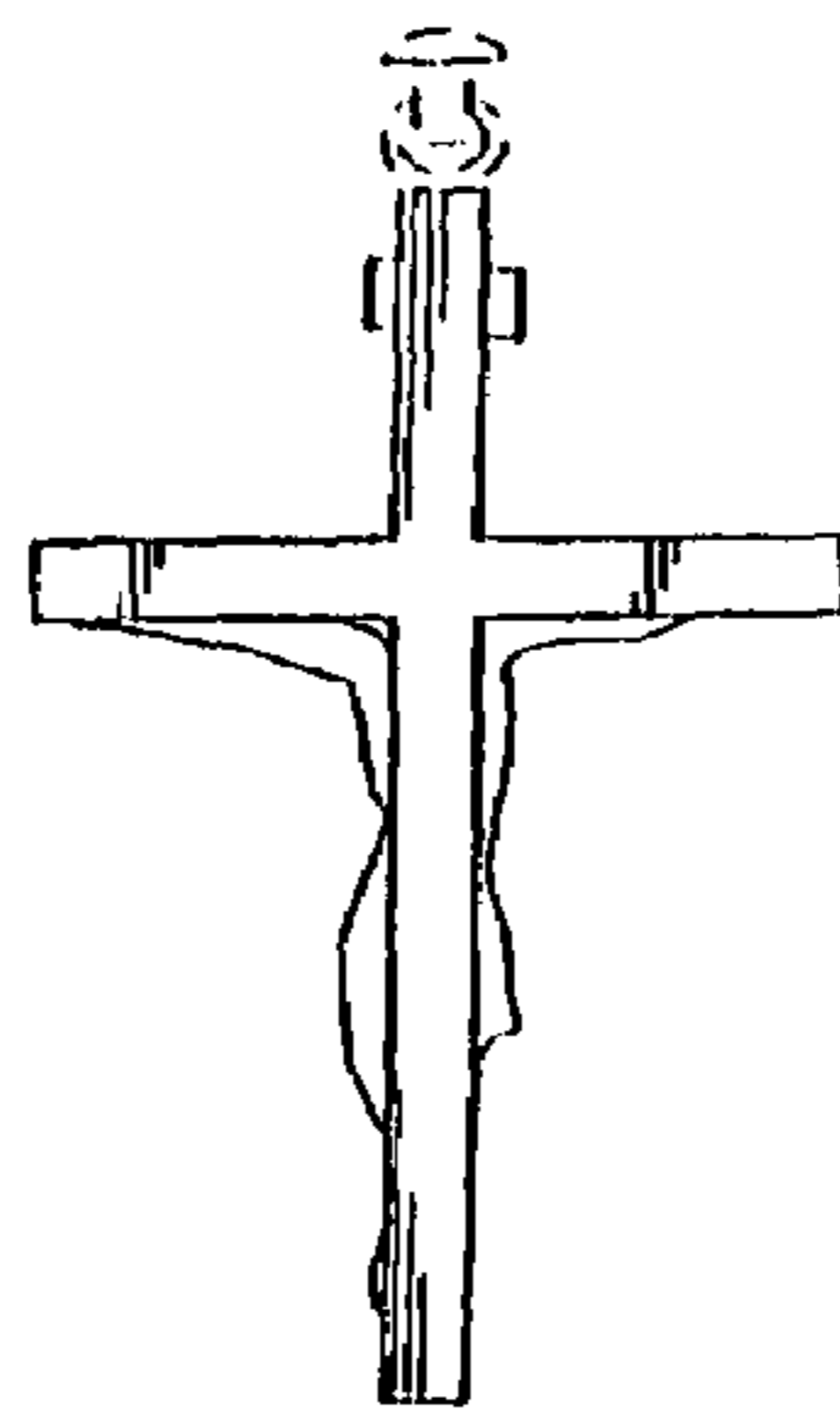

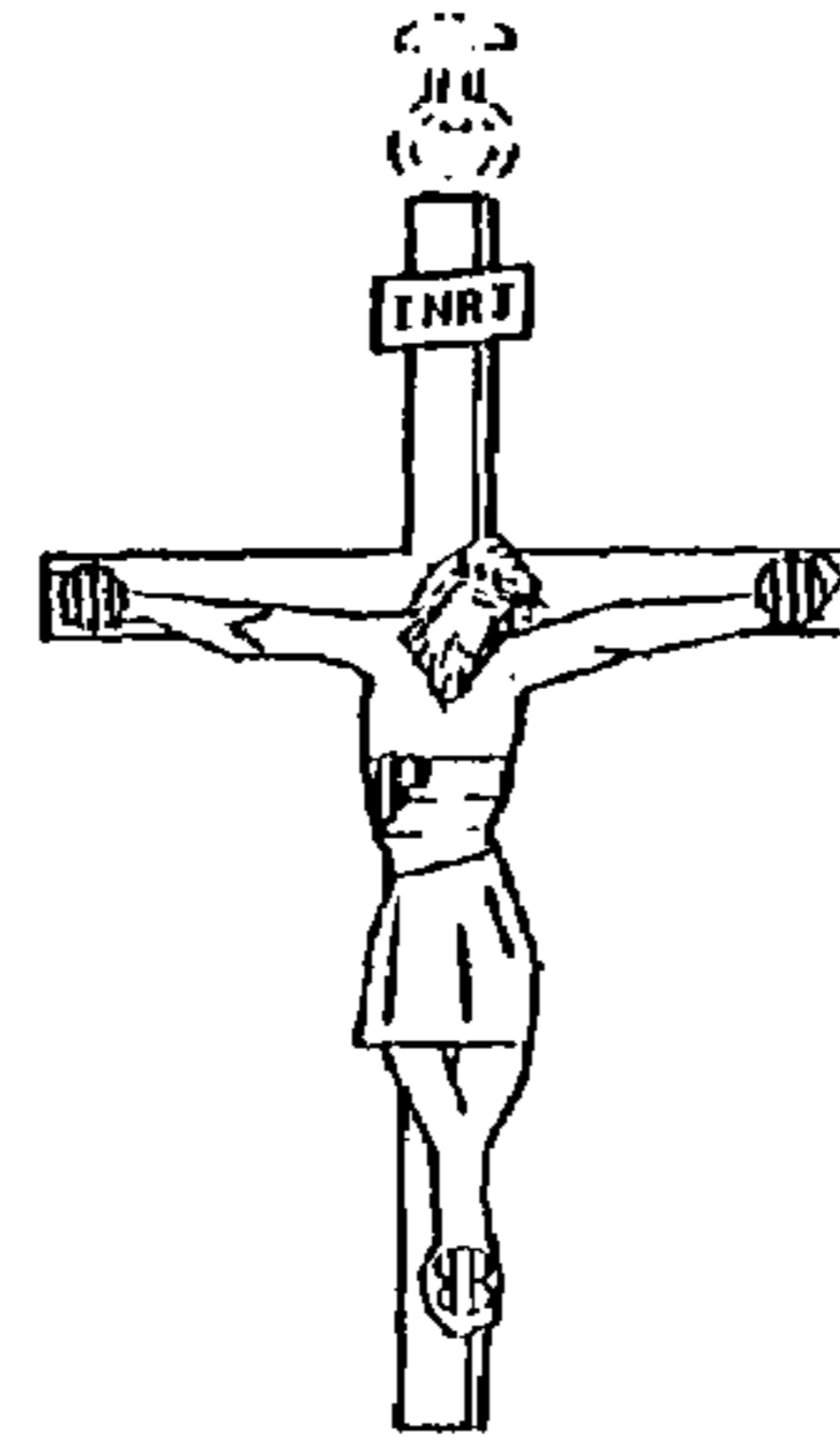

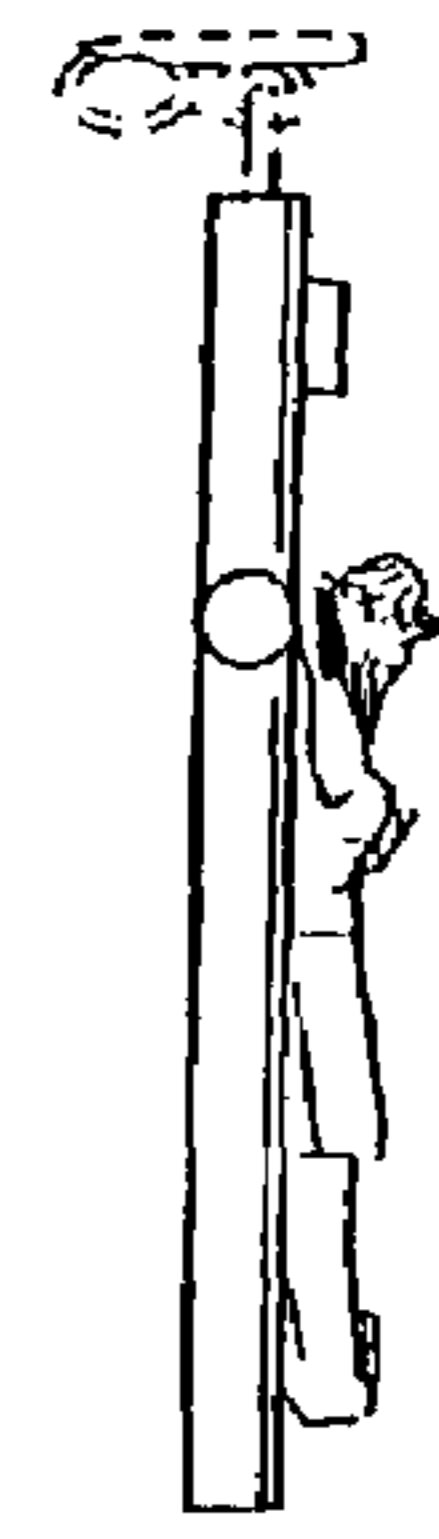

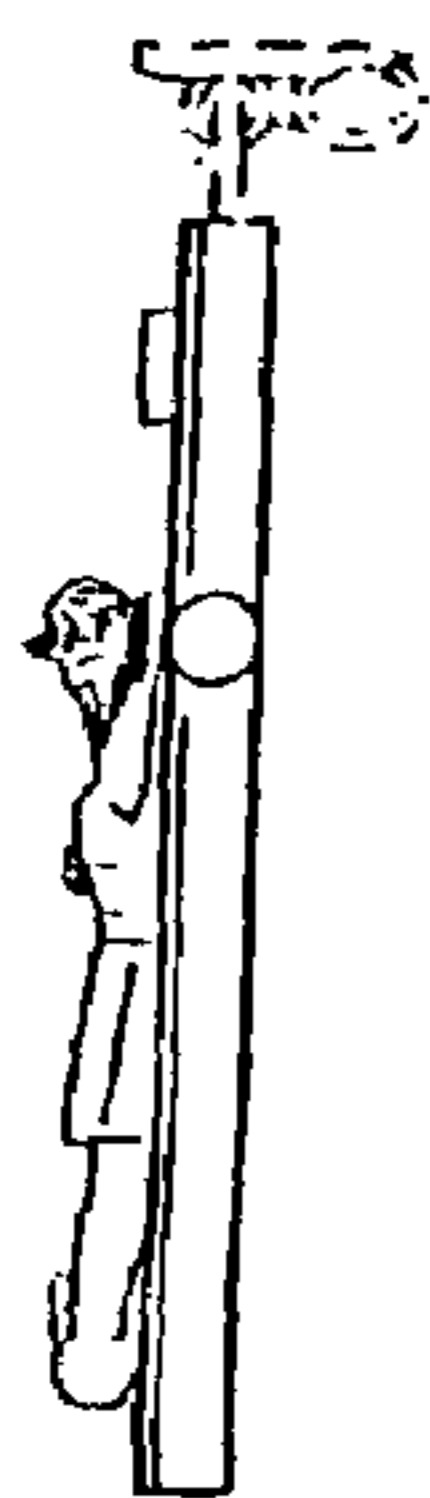

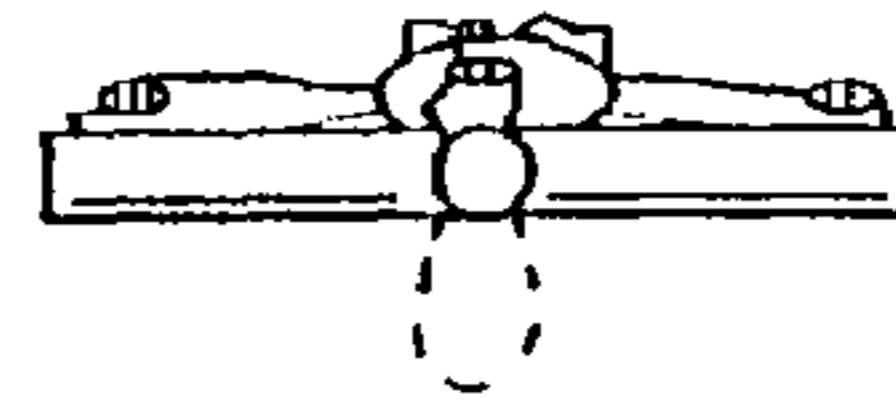

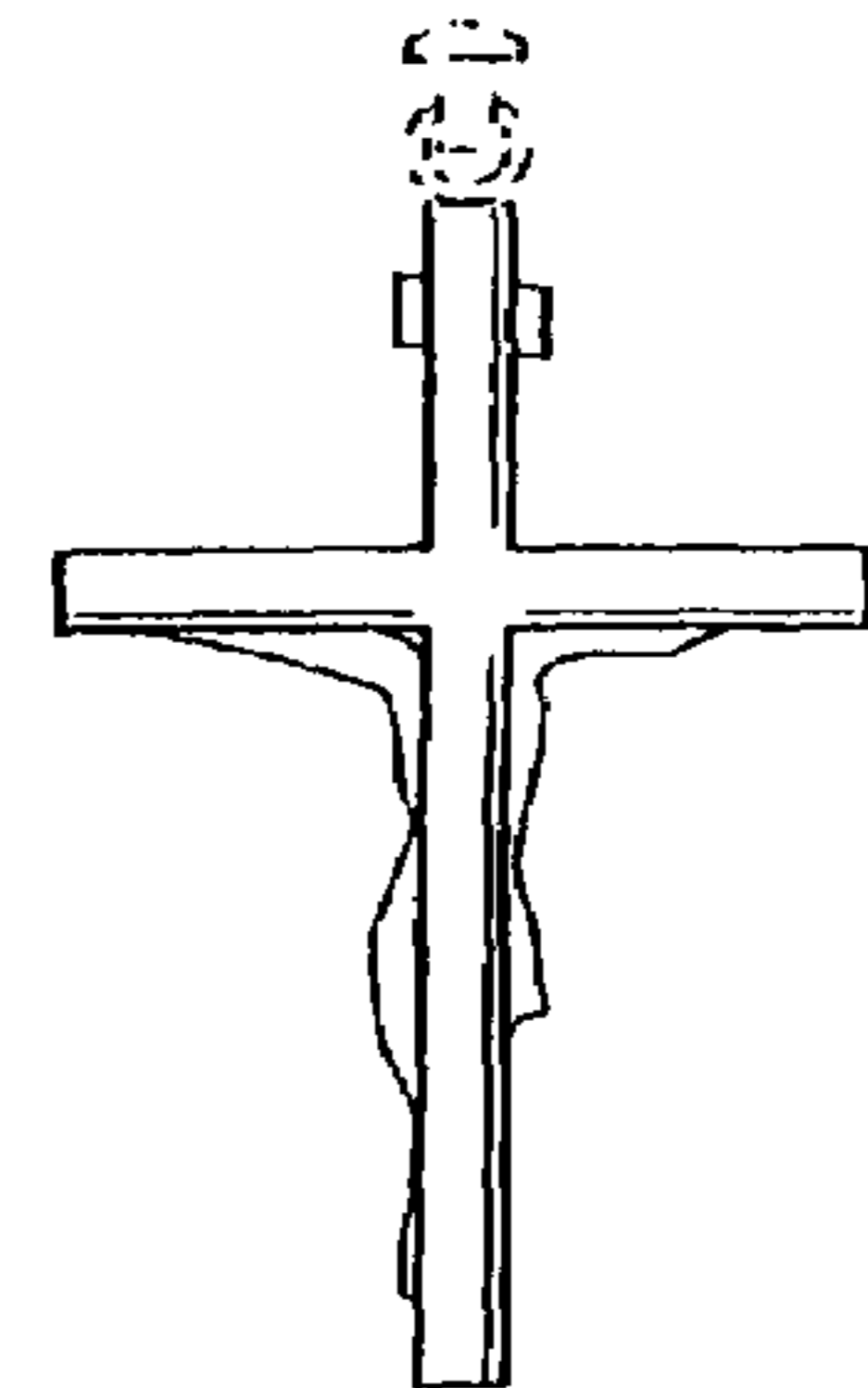

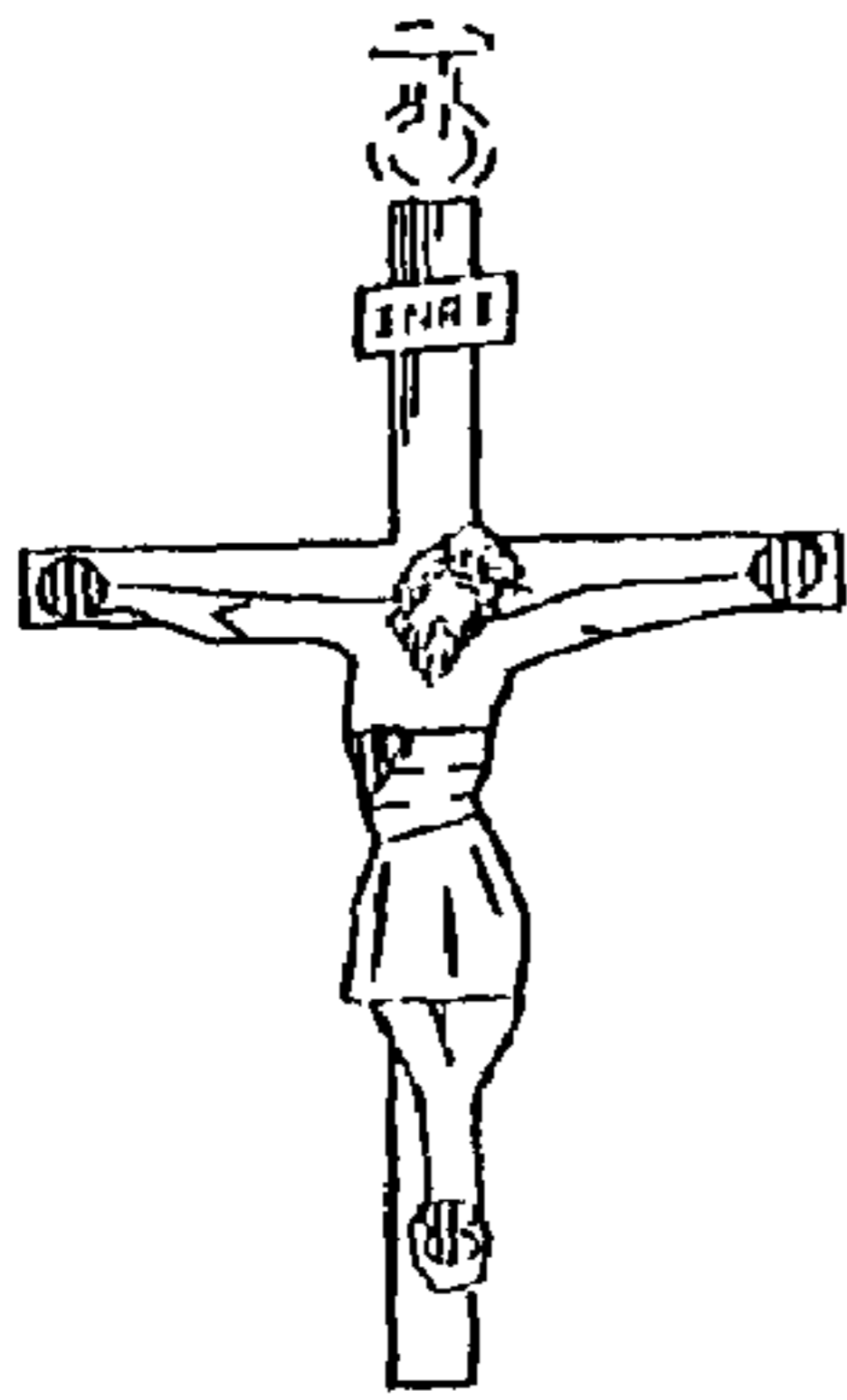

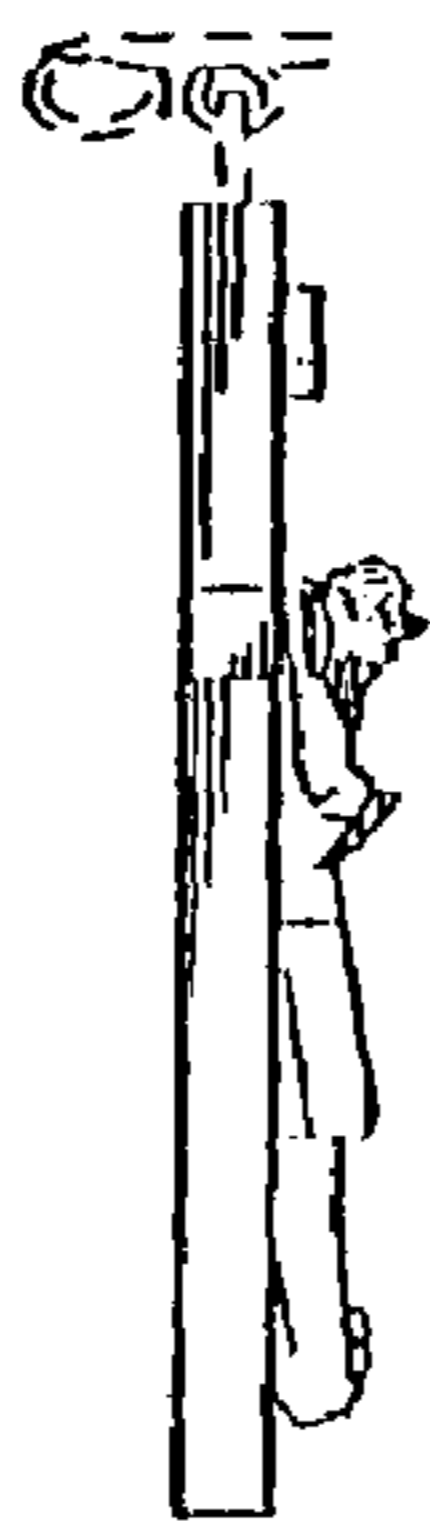

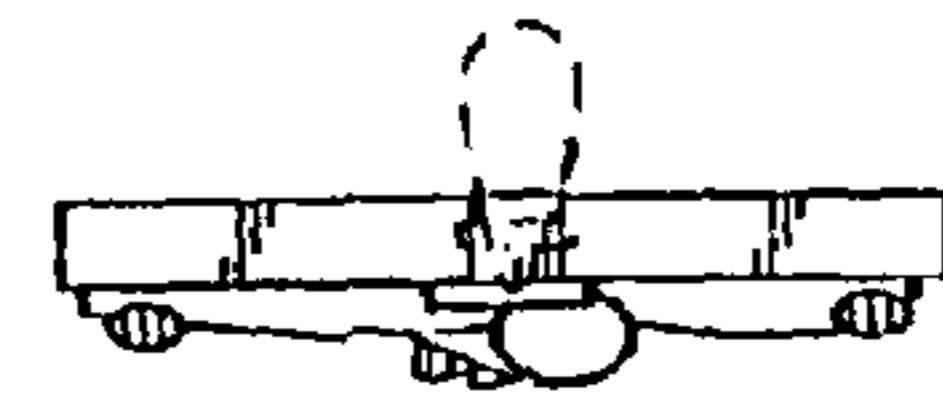

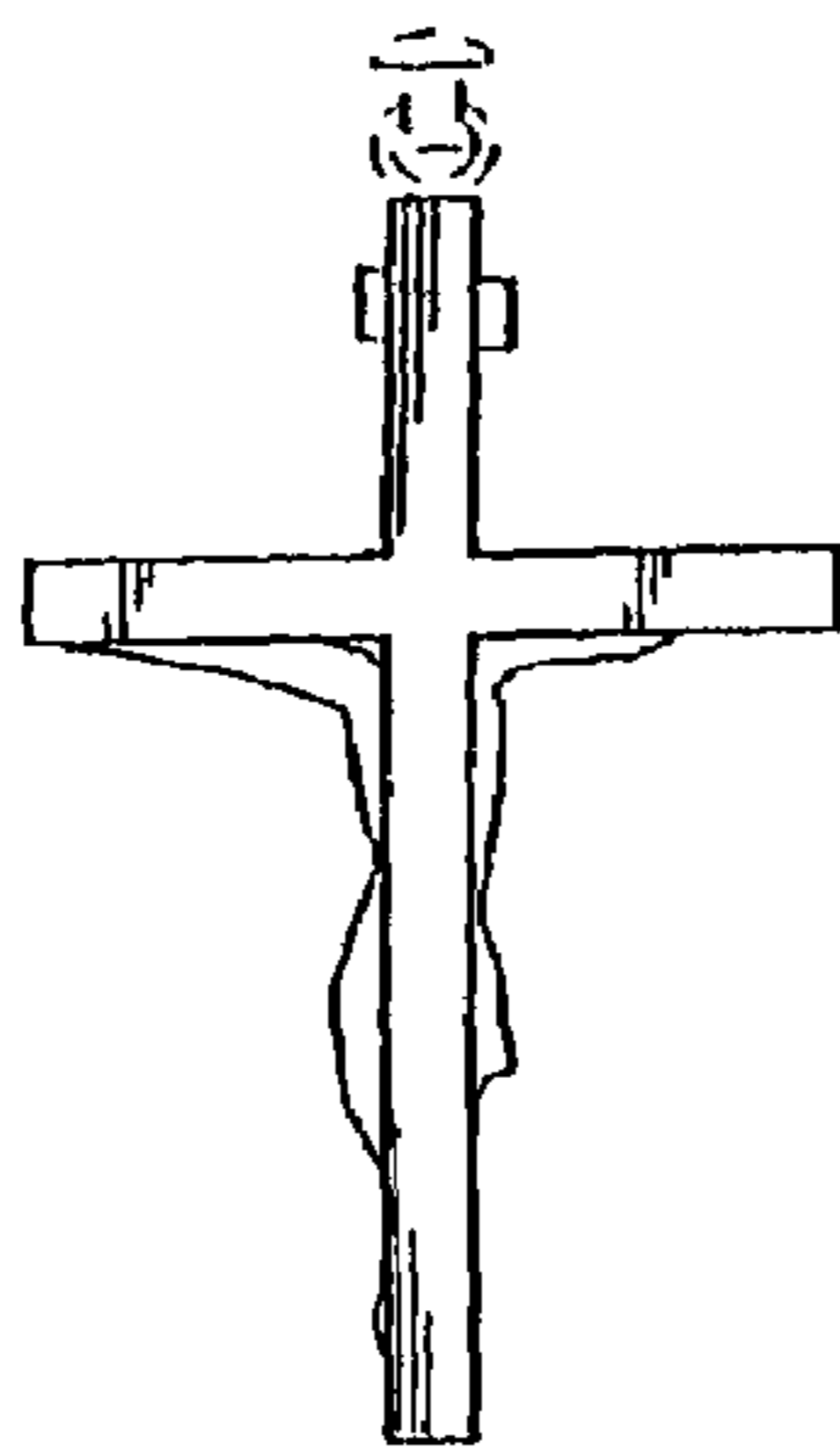
