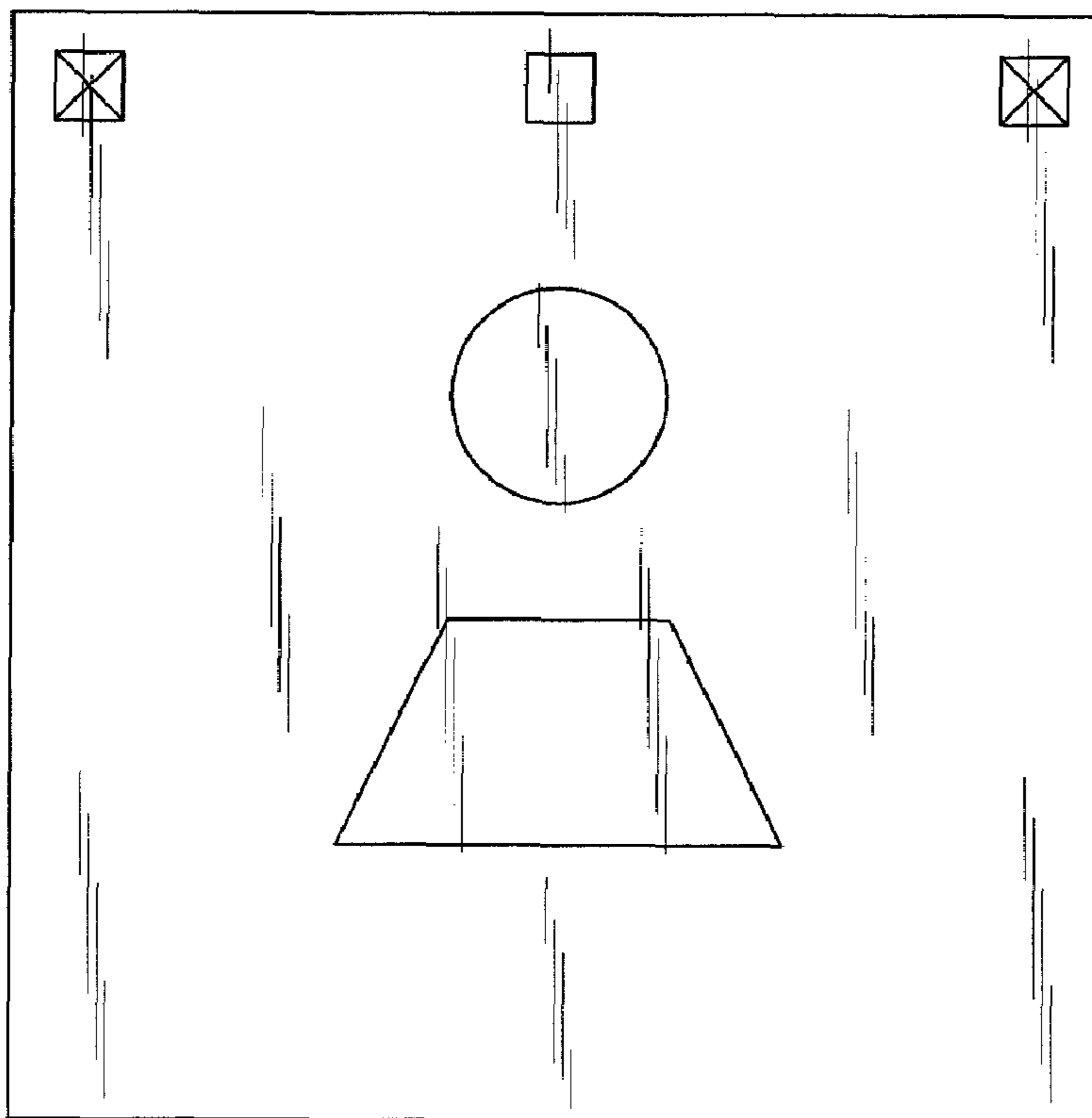

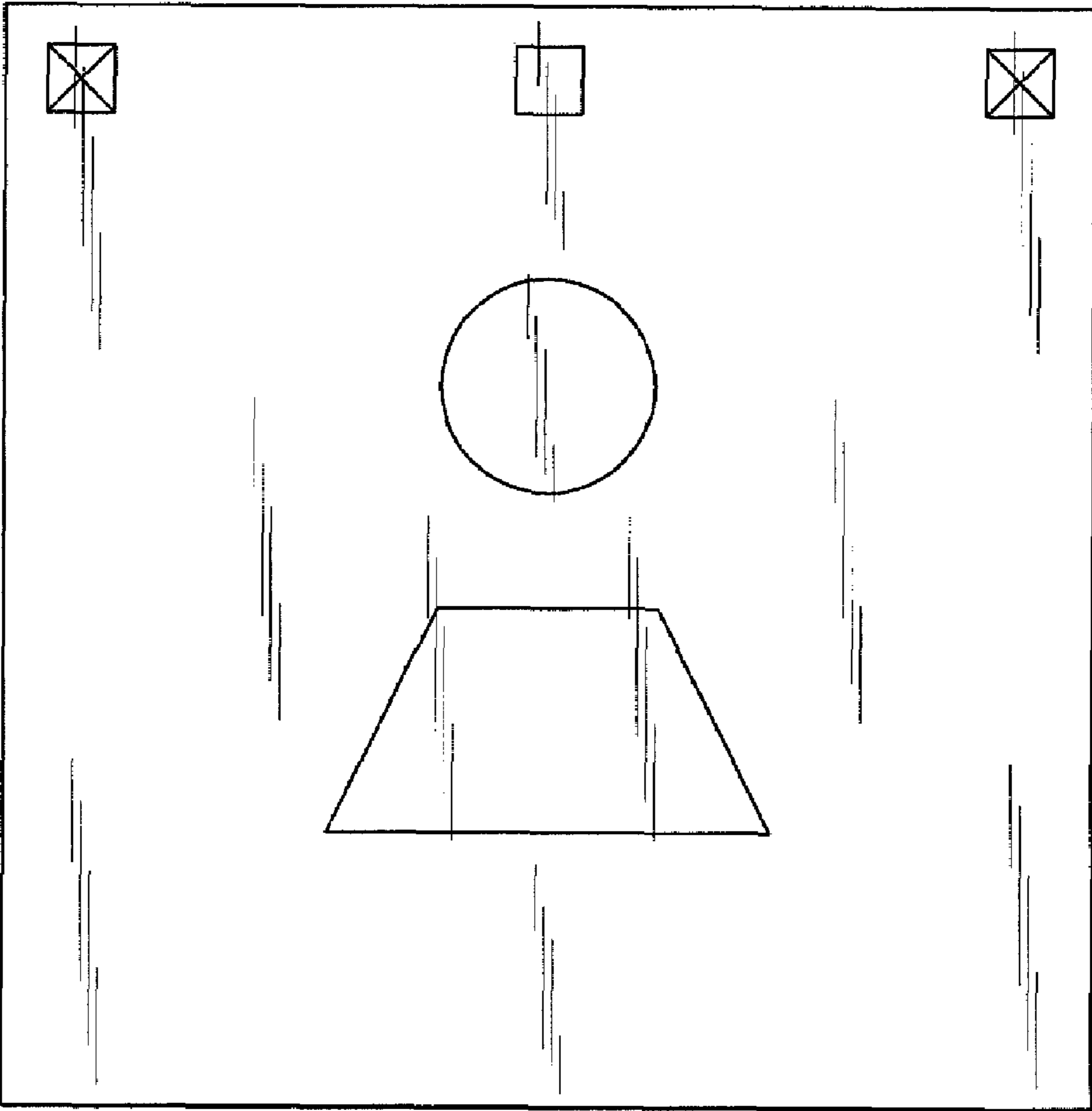
The ornamental design for a medal, as shown and described.

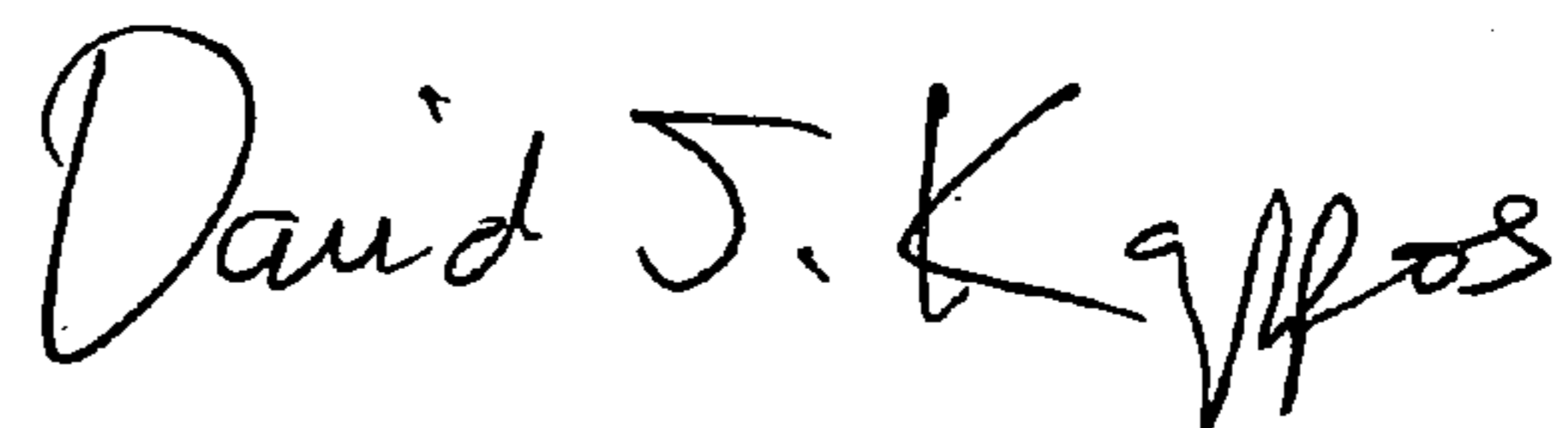
