The ornamental design for a jump starter, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a jump starter according to the present invention;

FIG. 2 is a front view of the jump starter of FIG. 1 according to the present invention;

FIG. 3 is a rear view of the jump starter of FIG. 1 according to the present invention;

FIG. 4 is a left side view of the jump starter of FIG. 1 according to the present invention;

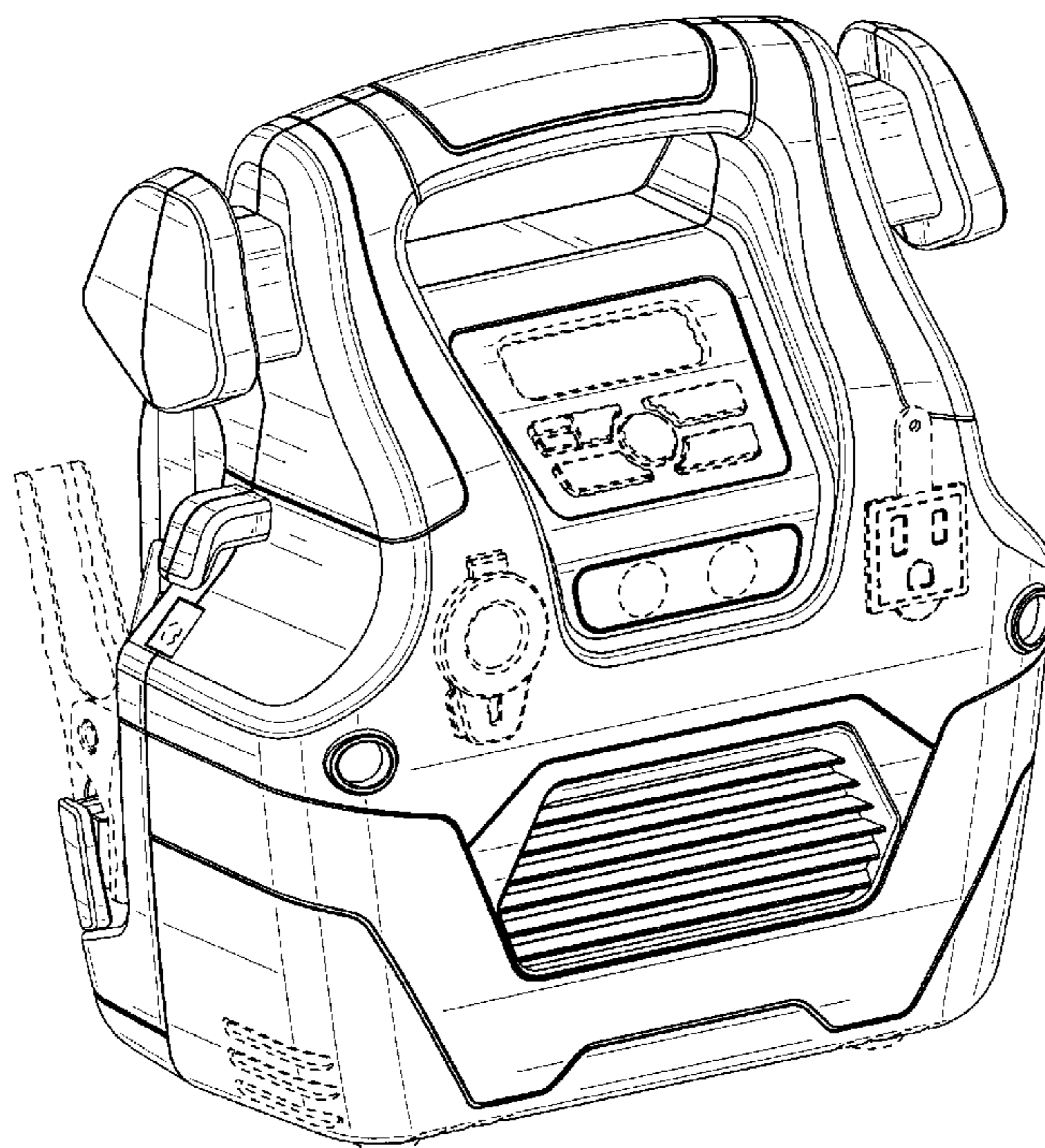
FIG. 5 is a right side view of the jump starter of FIG. 1 according to the present invention;

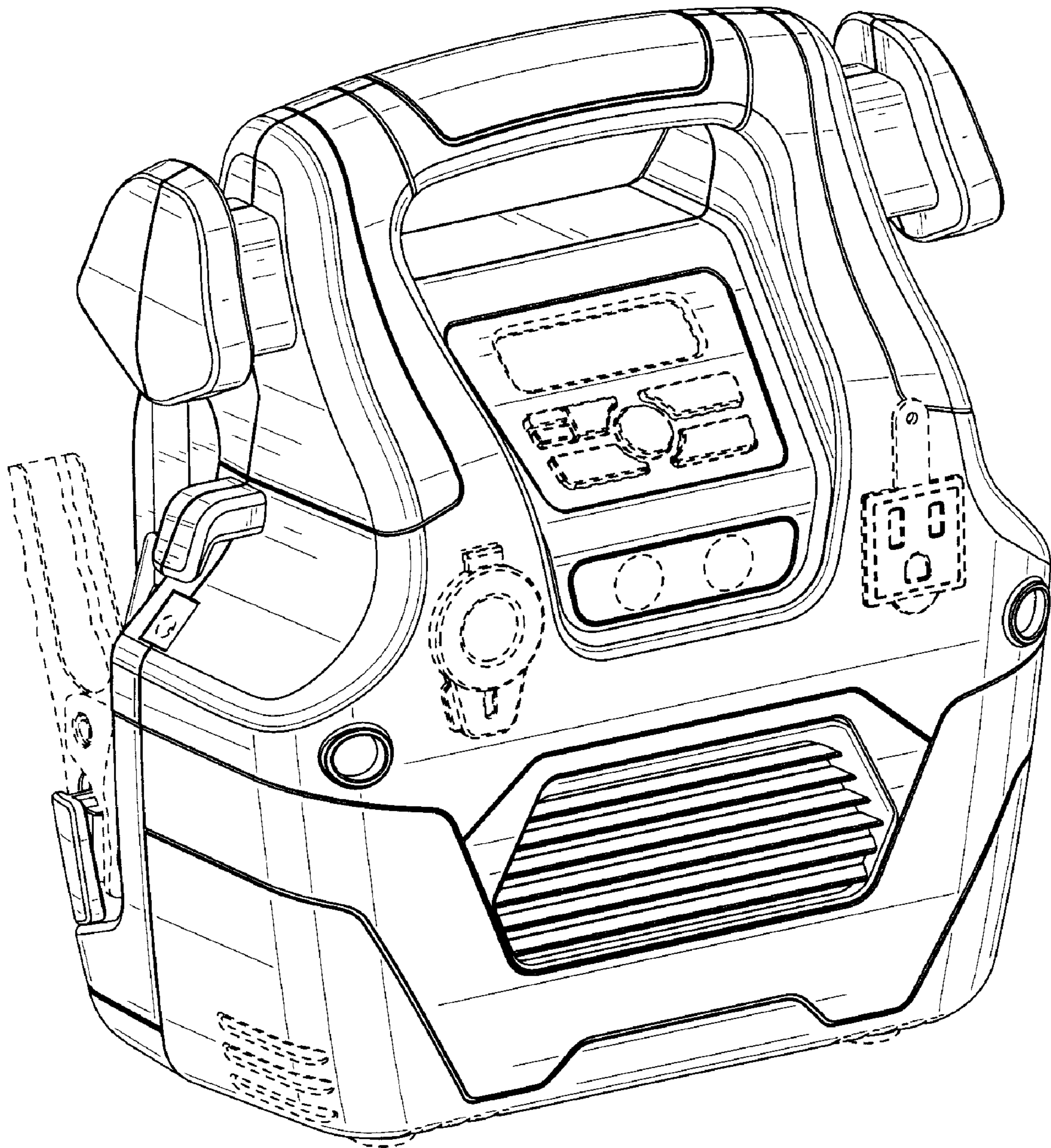

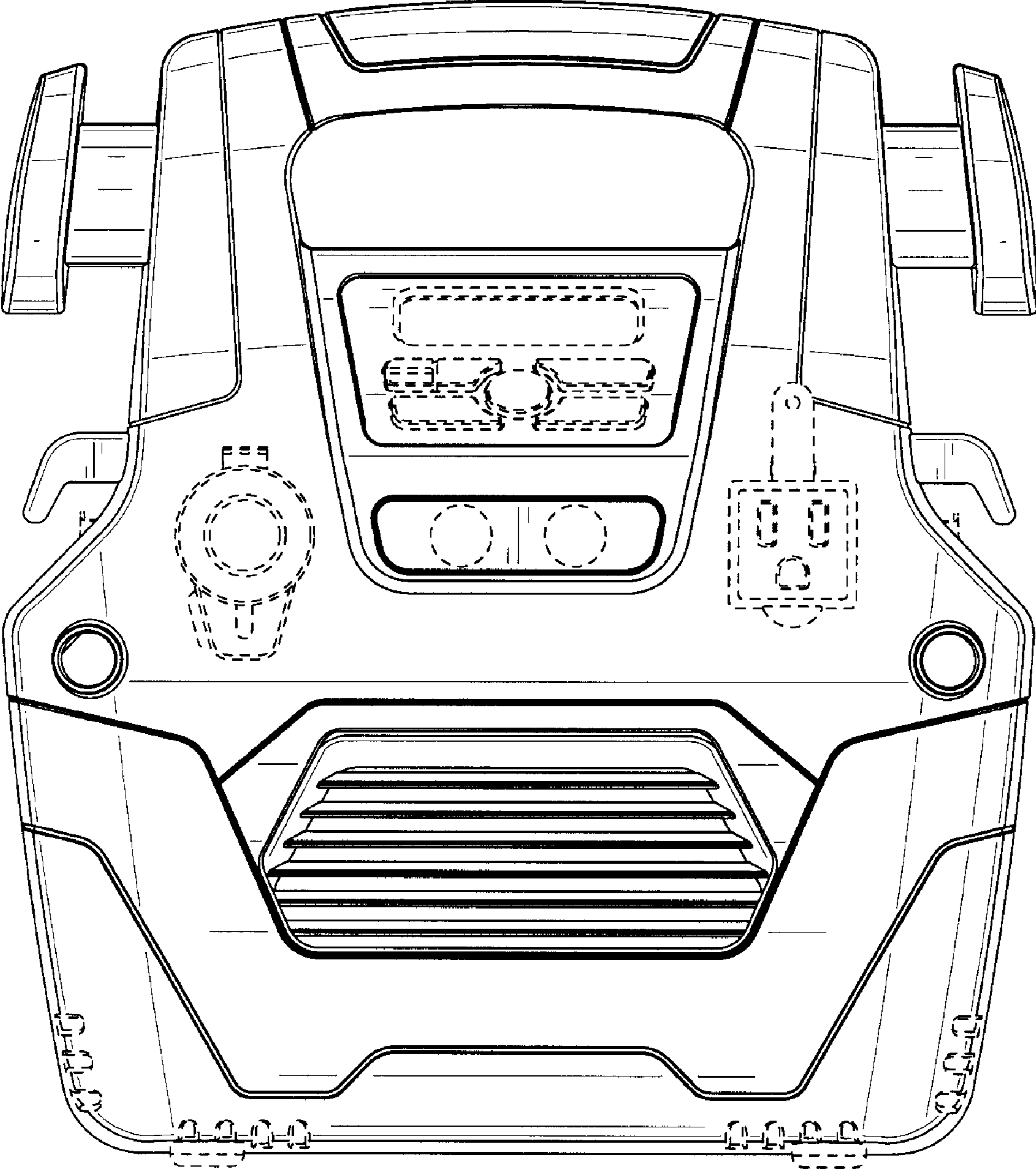

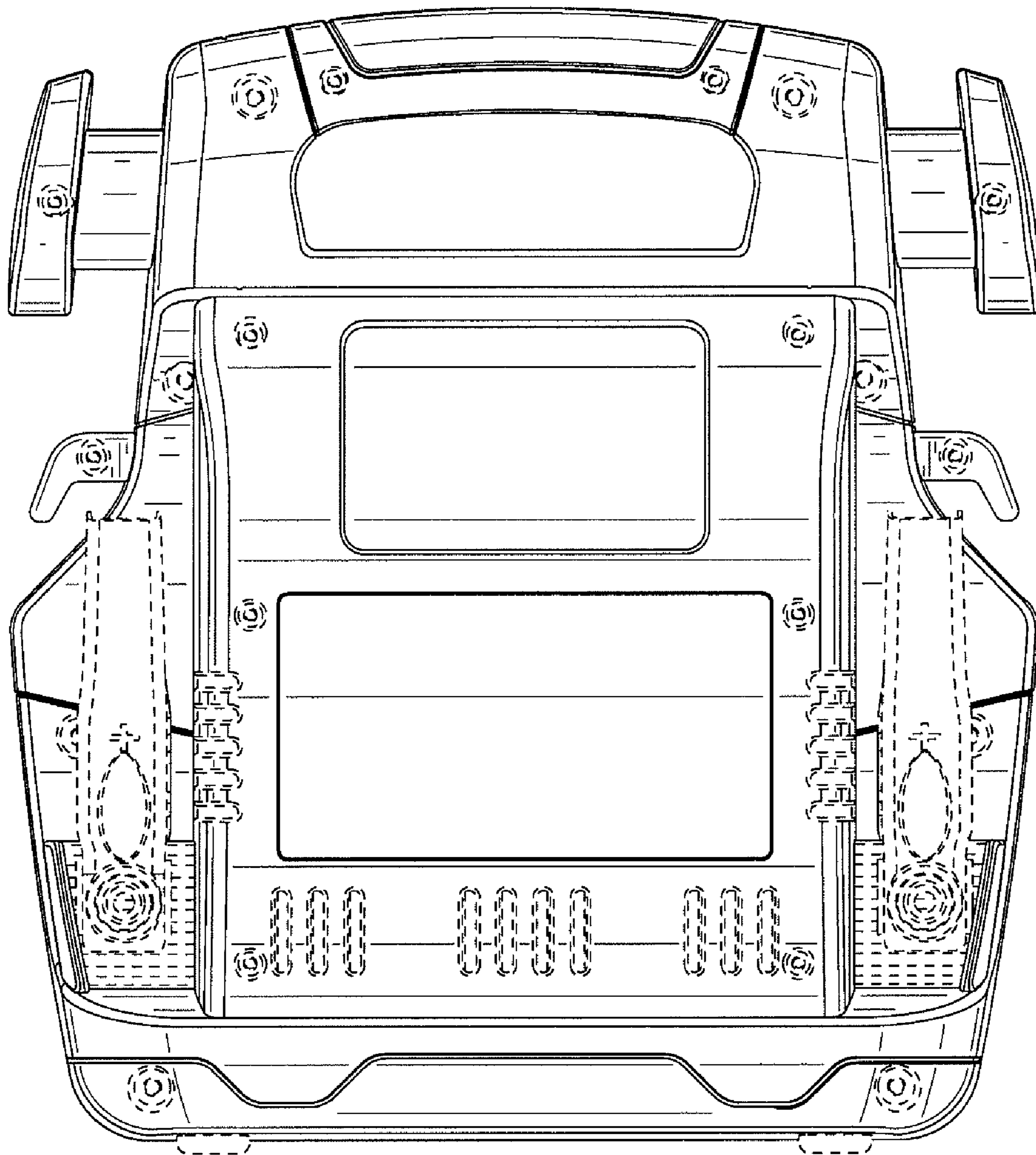

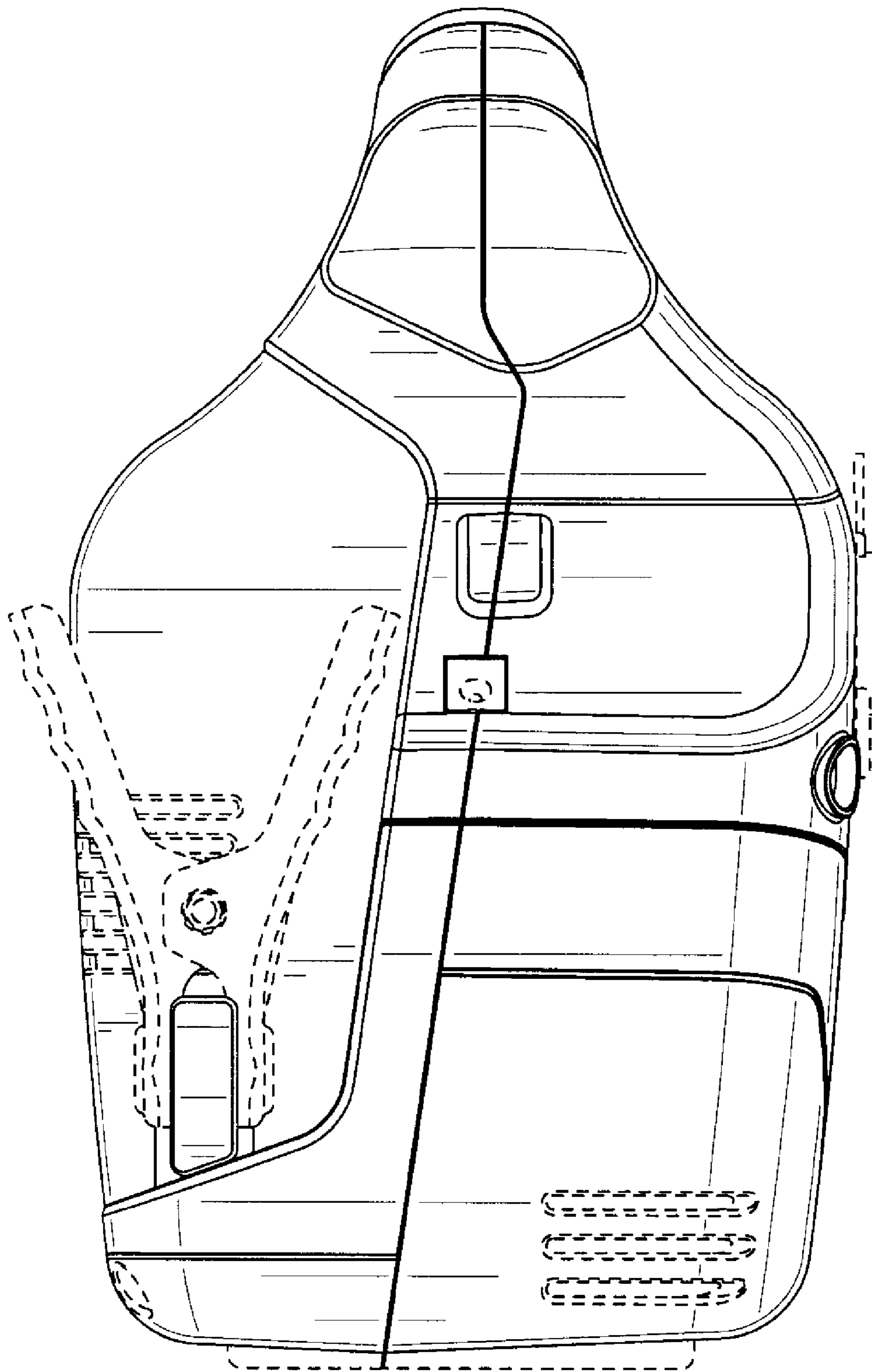

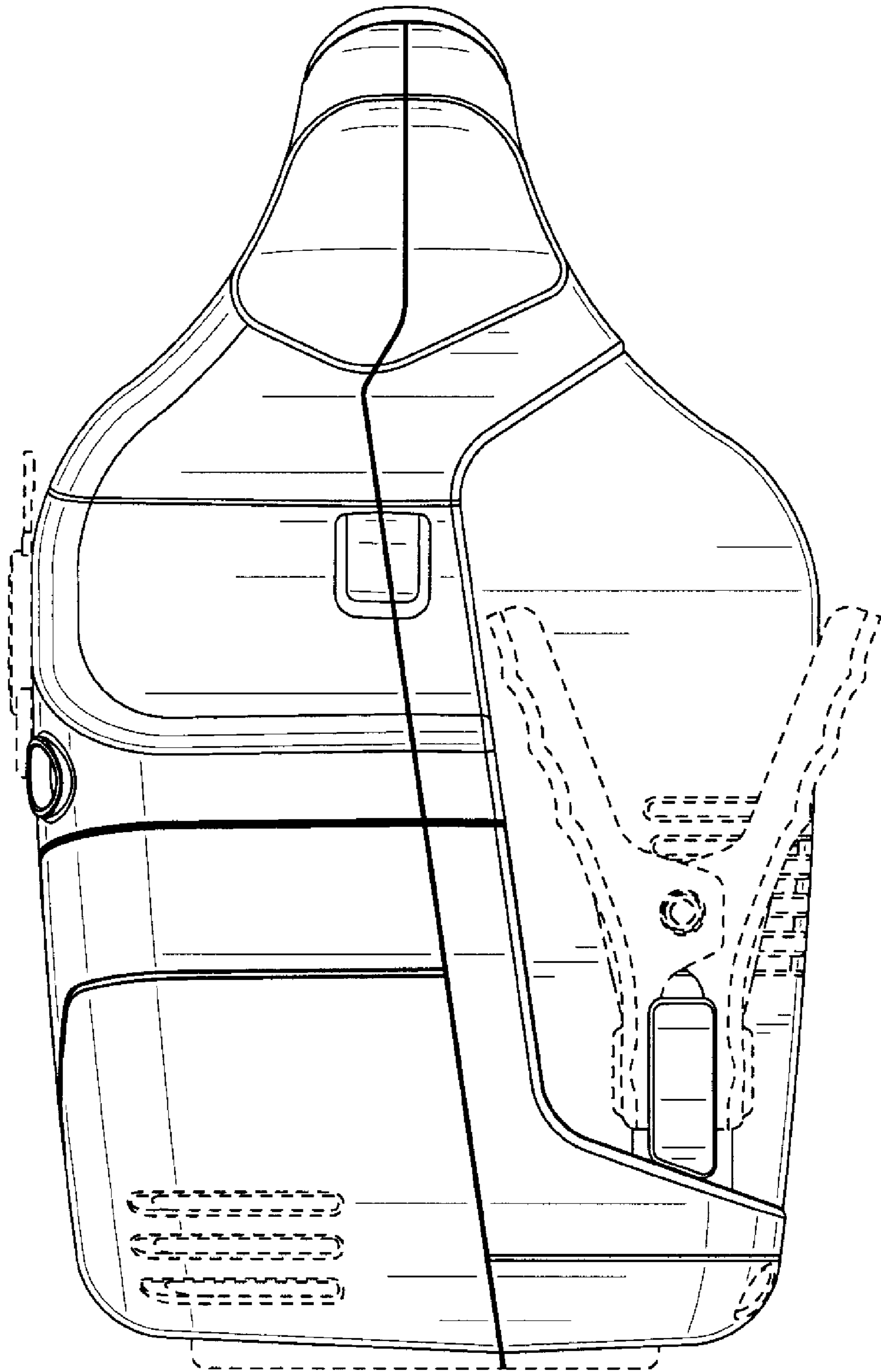

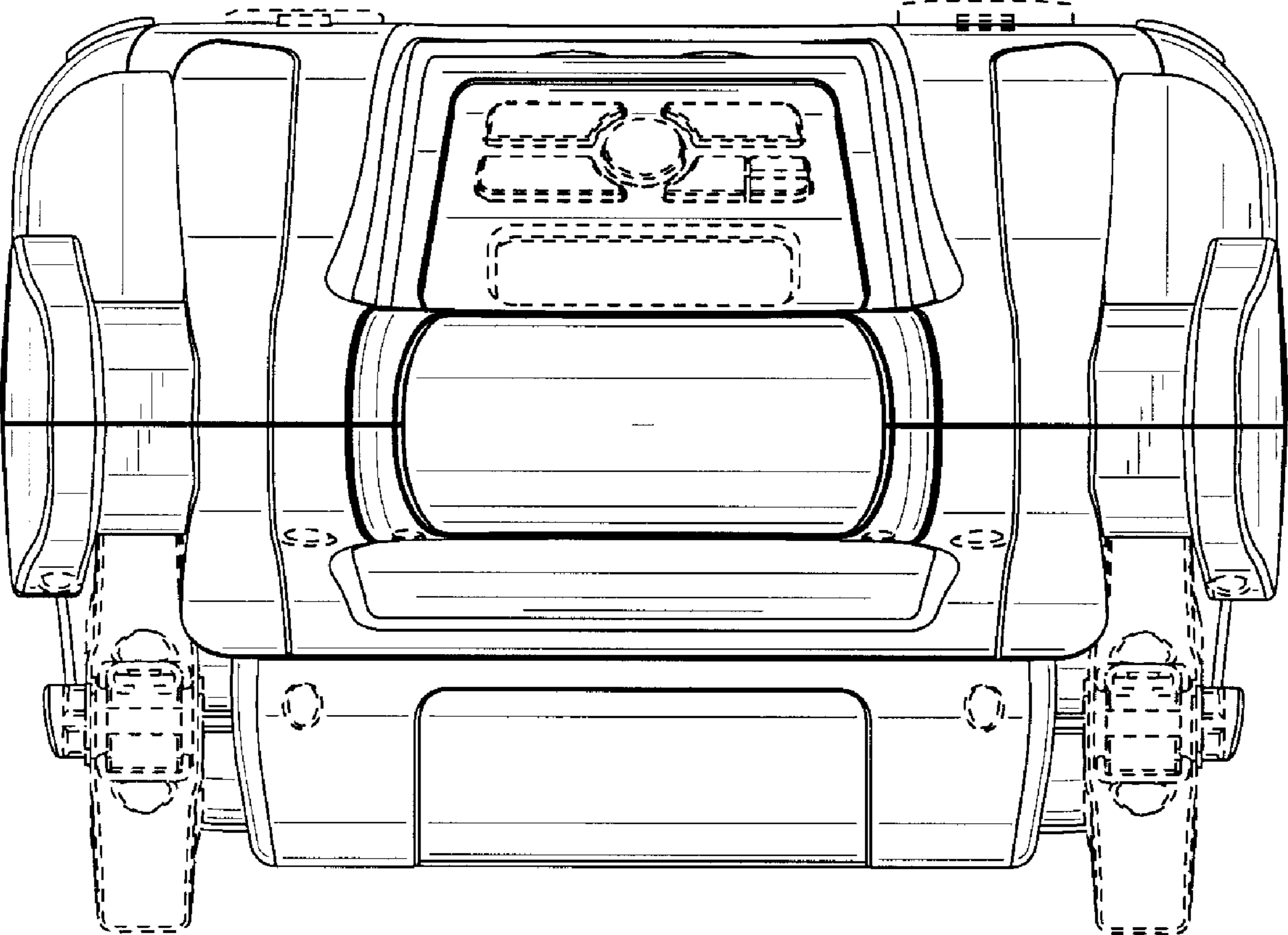

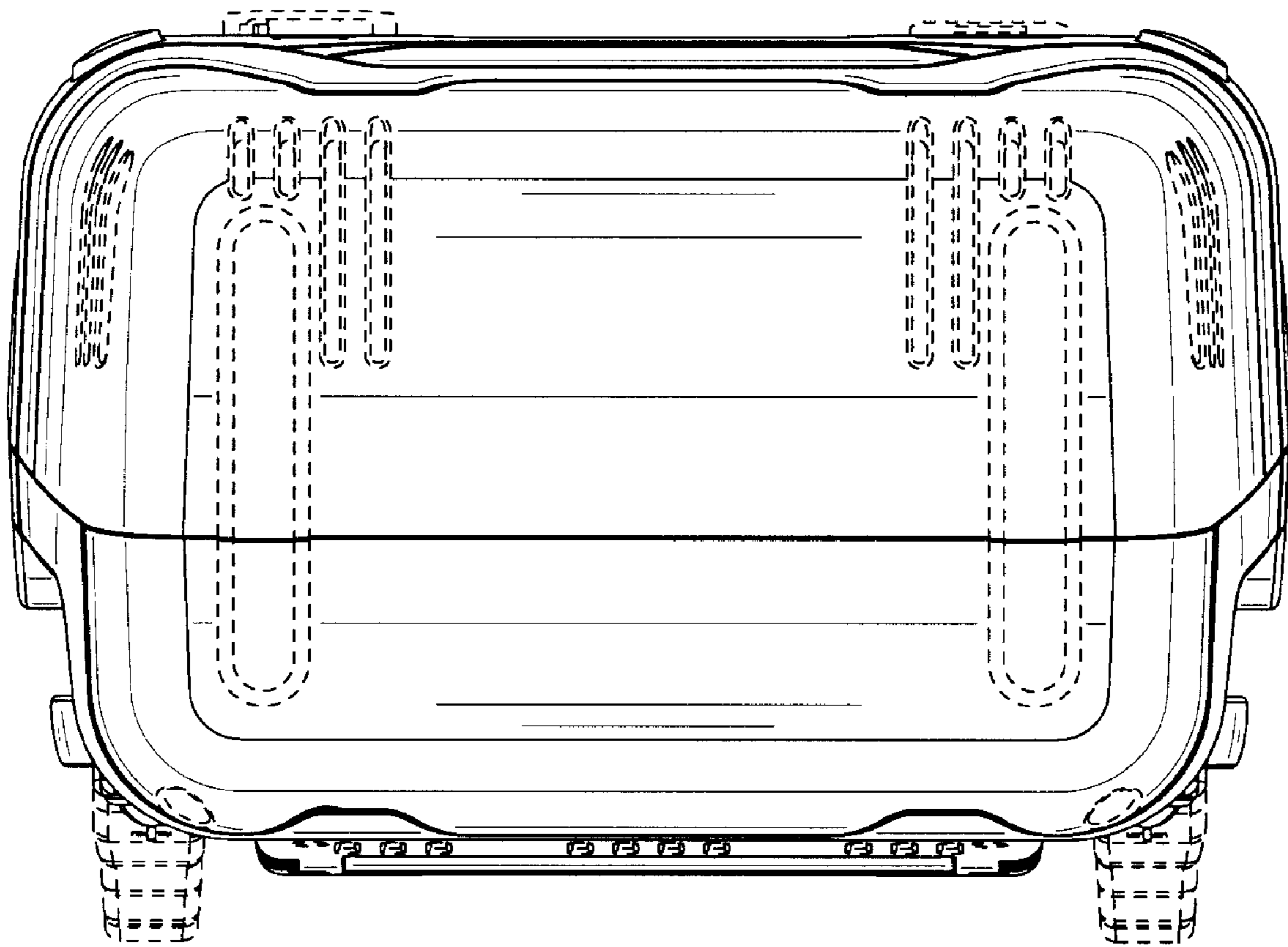
