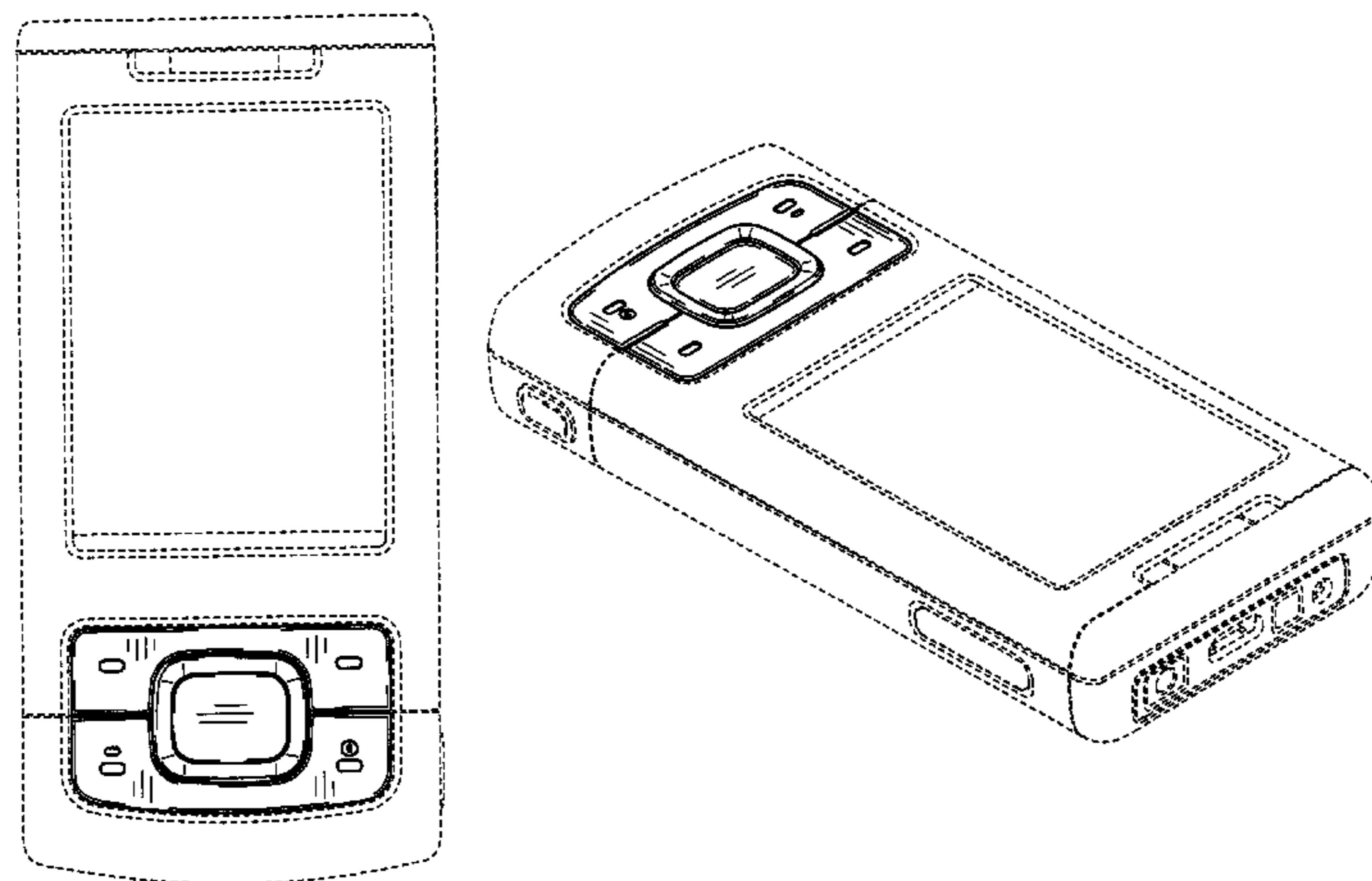
The ornamental design for a set of keys for a handset, as shown and described.

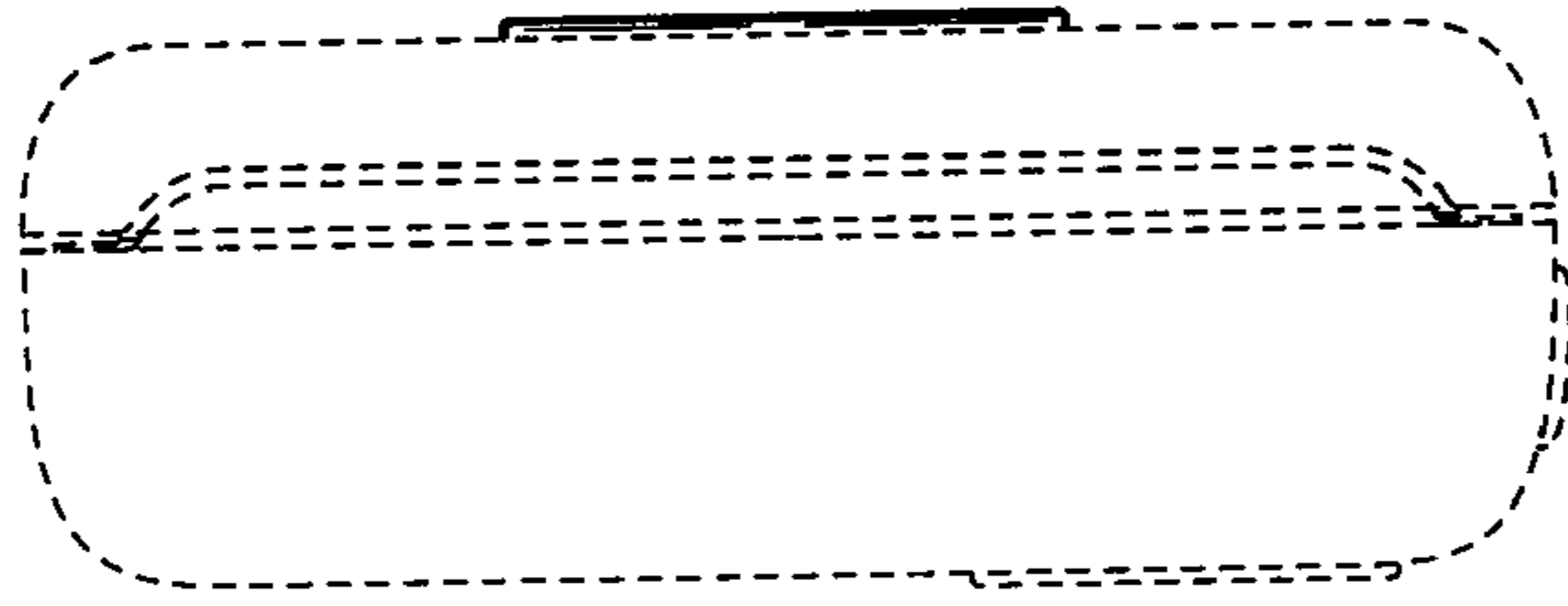

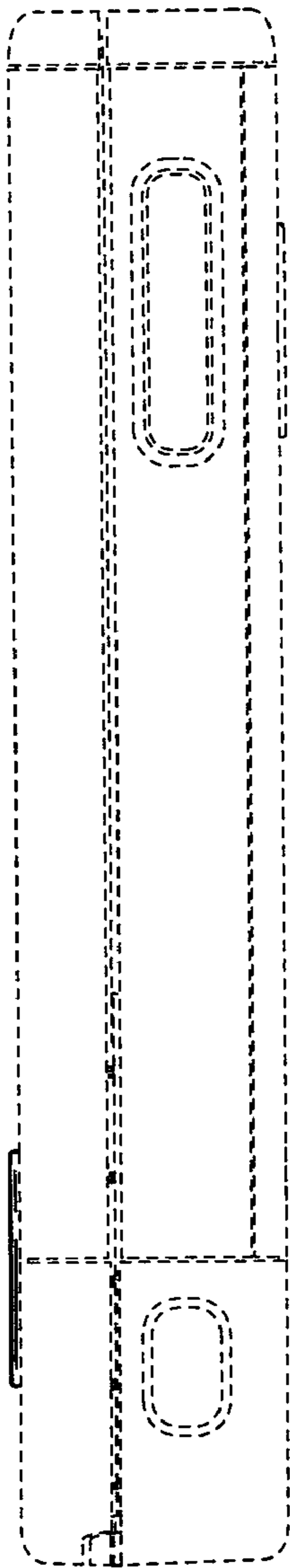

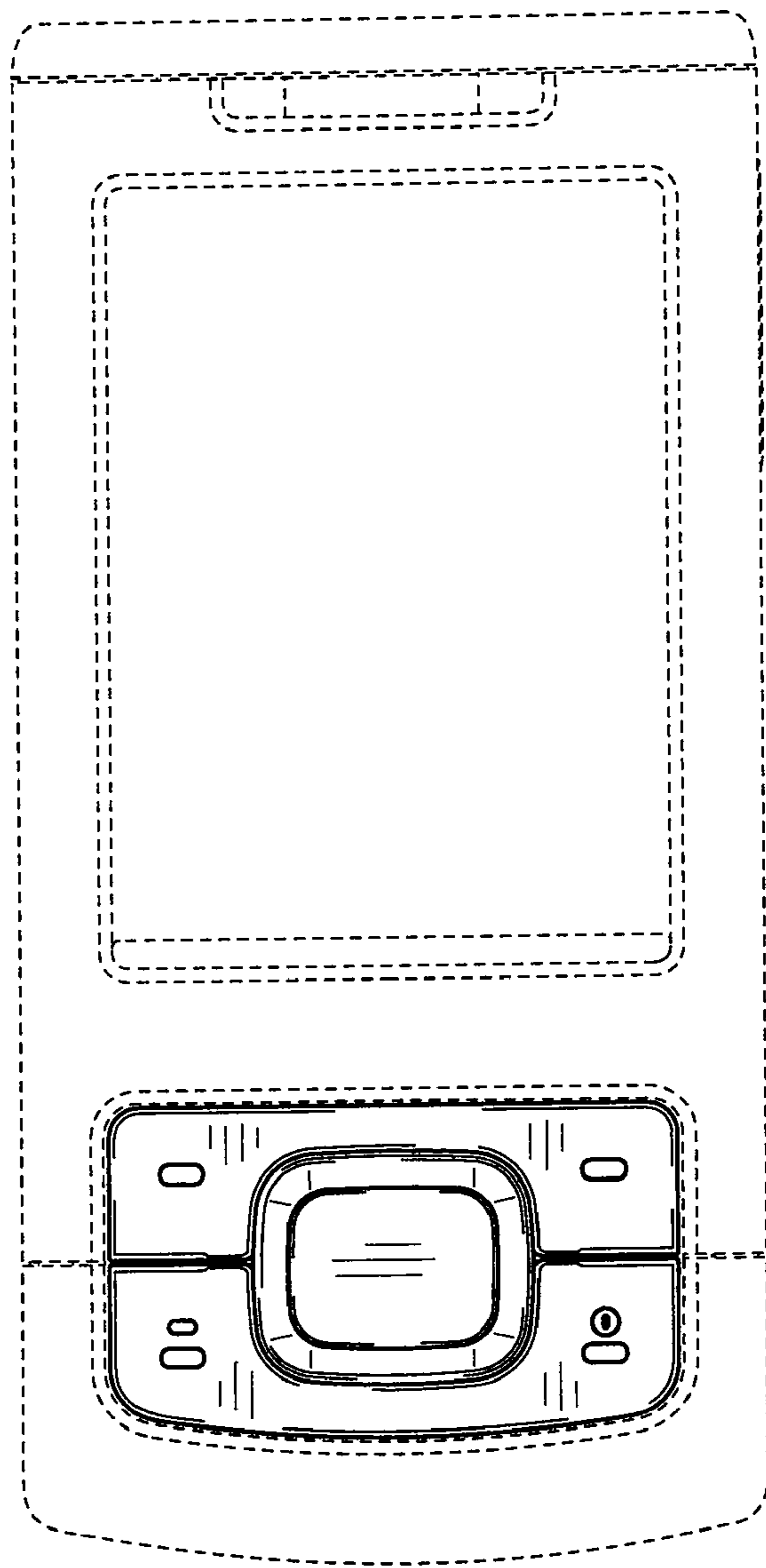

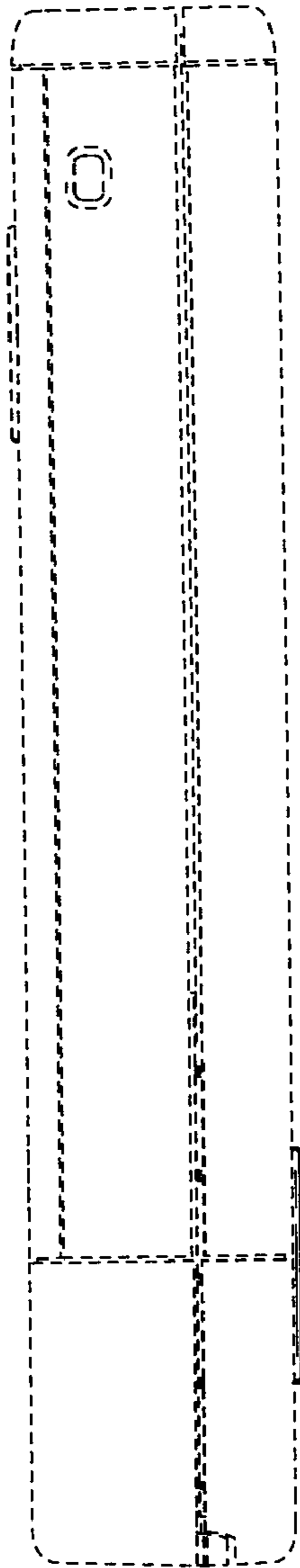

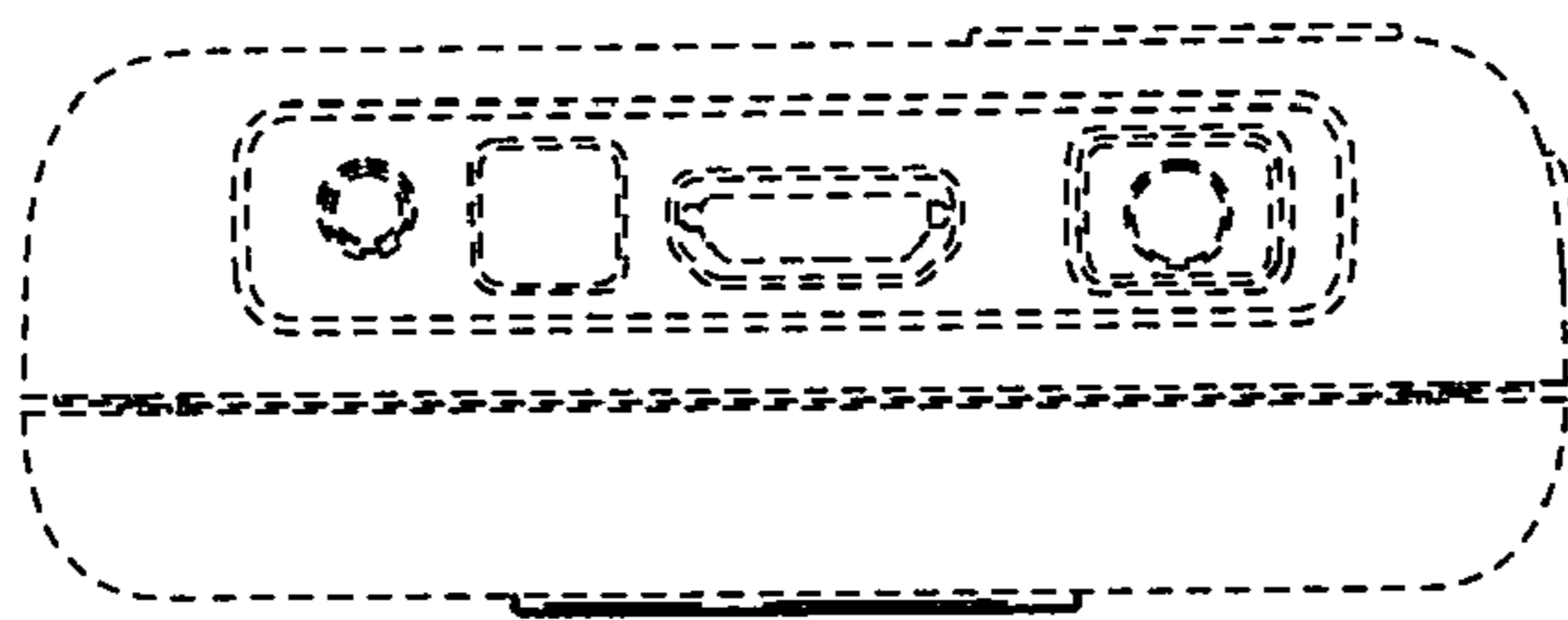

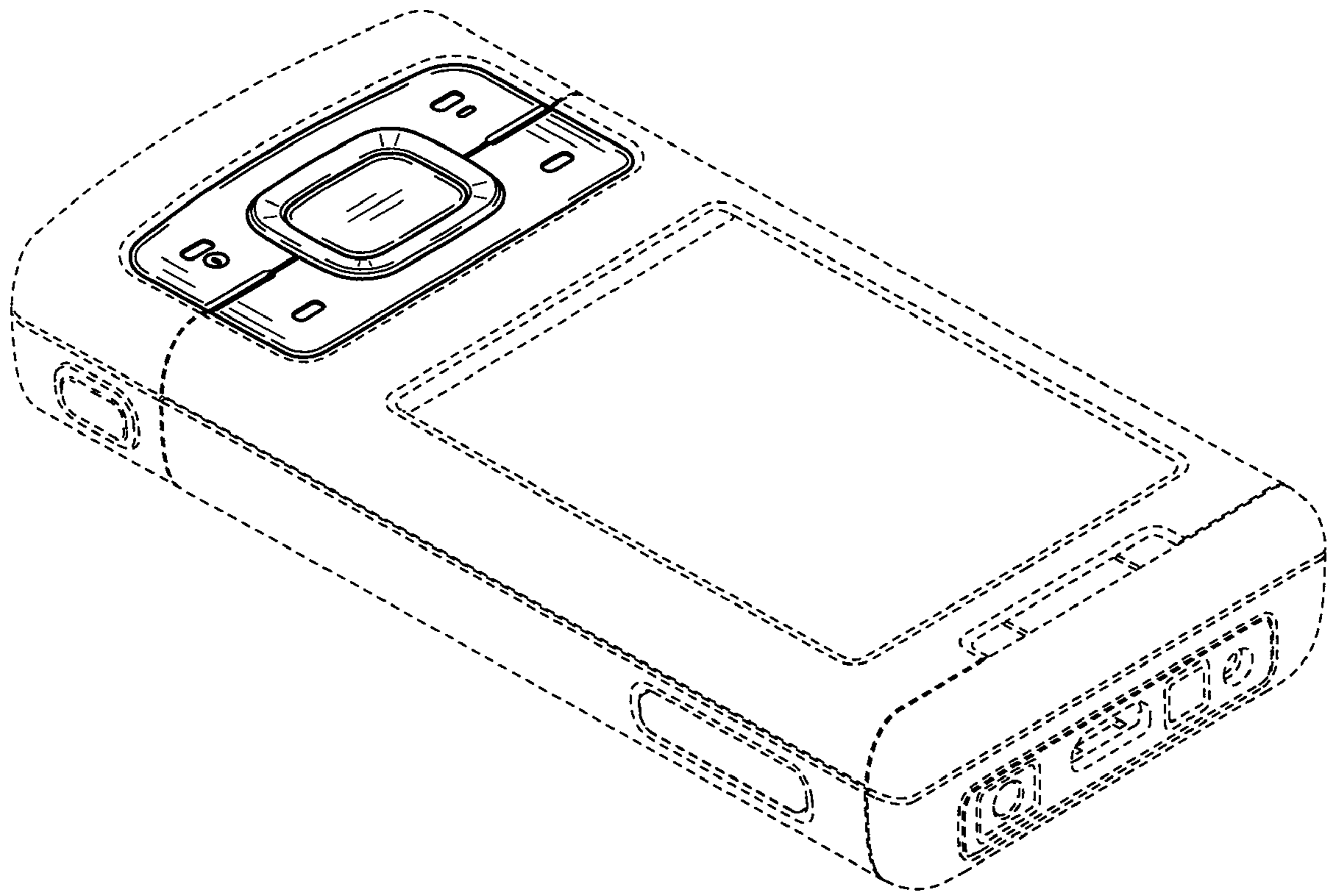
