(57) **CLAIM**

The ornamental design for a display screen with an animated color image, as shown and described.

DESCRIPTION

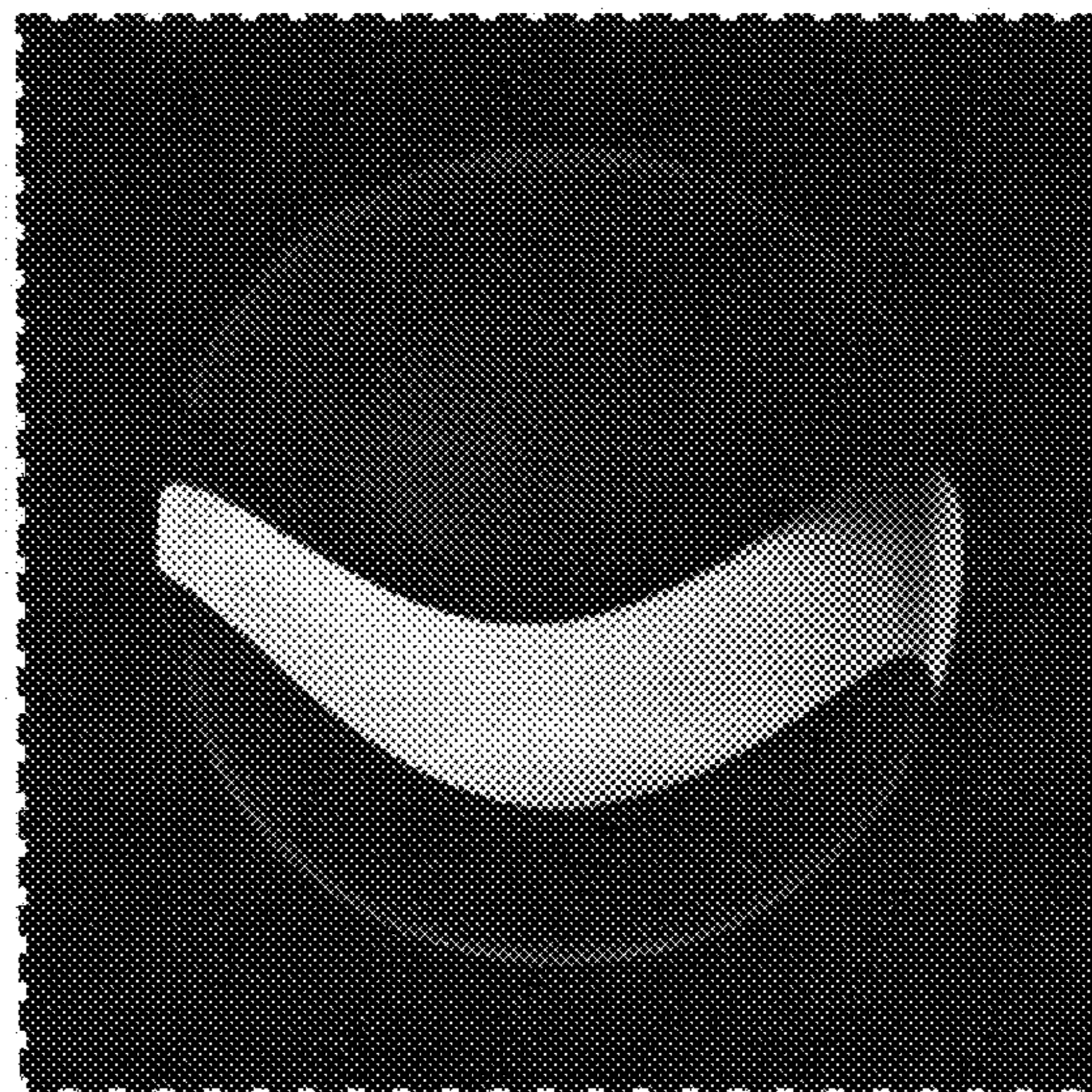

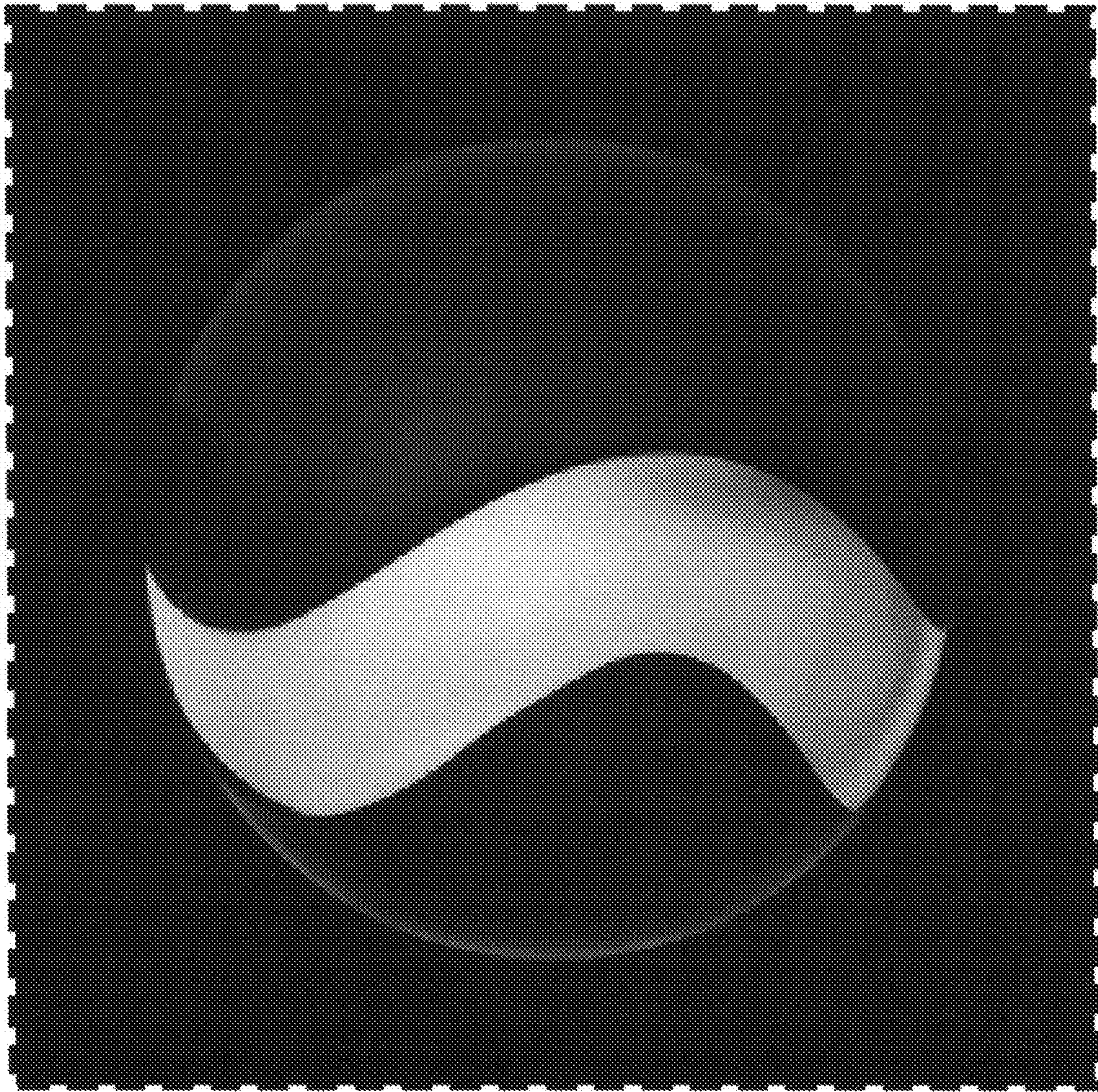

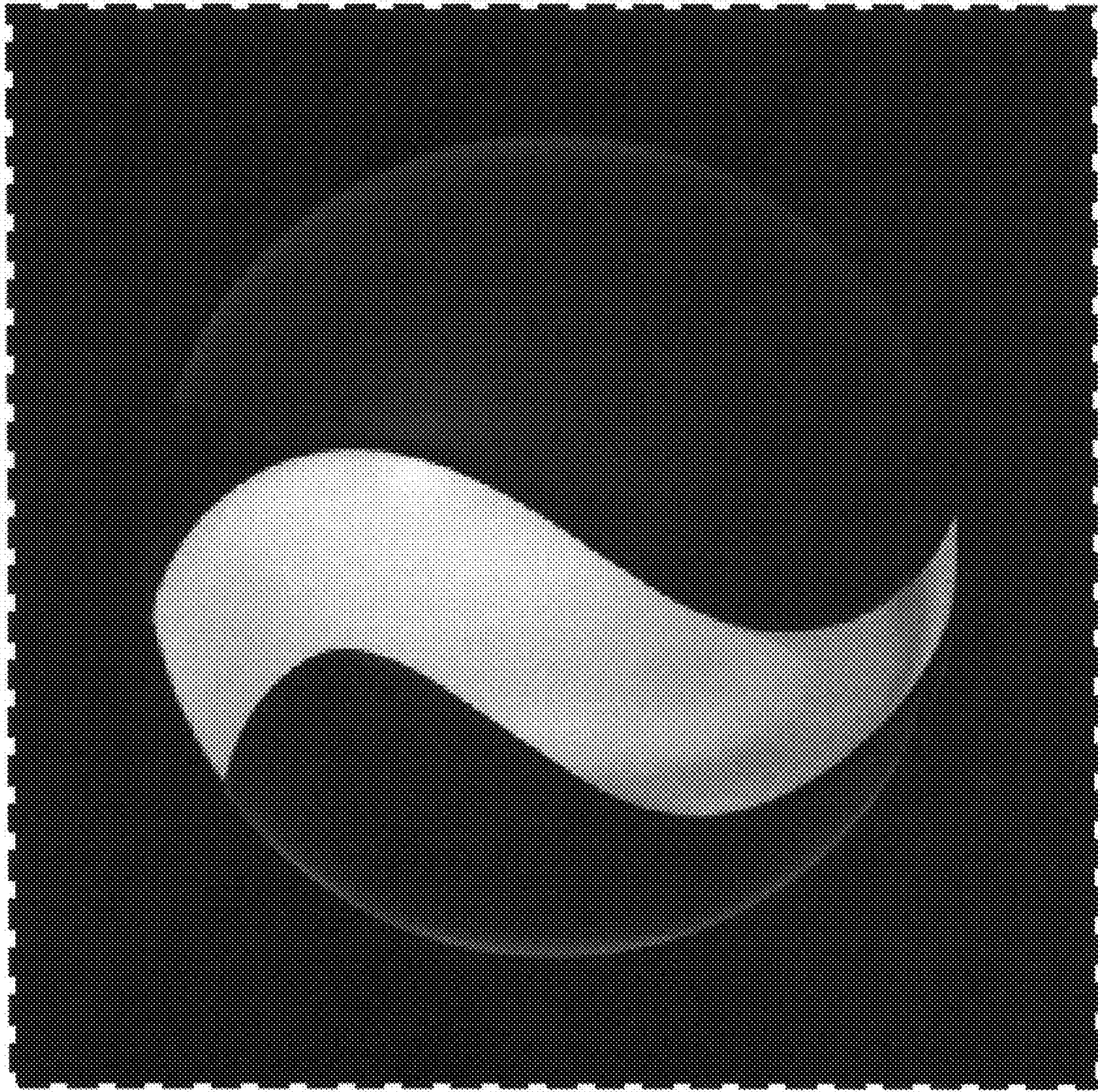

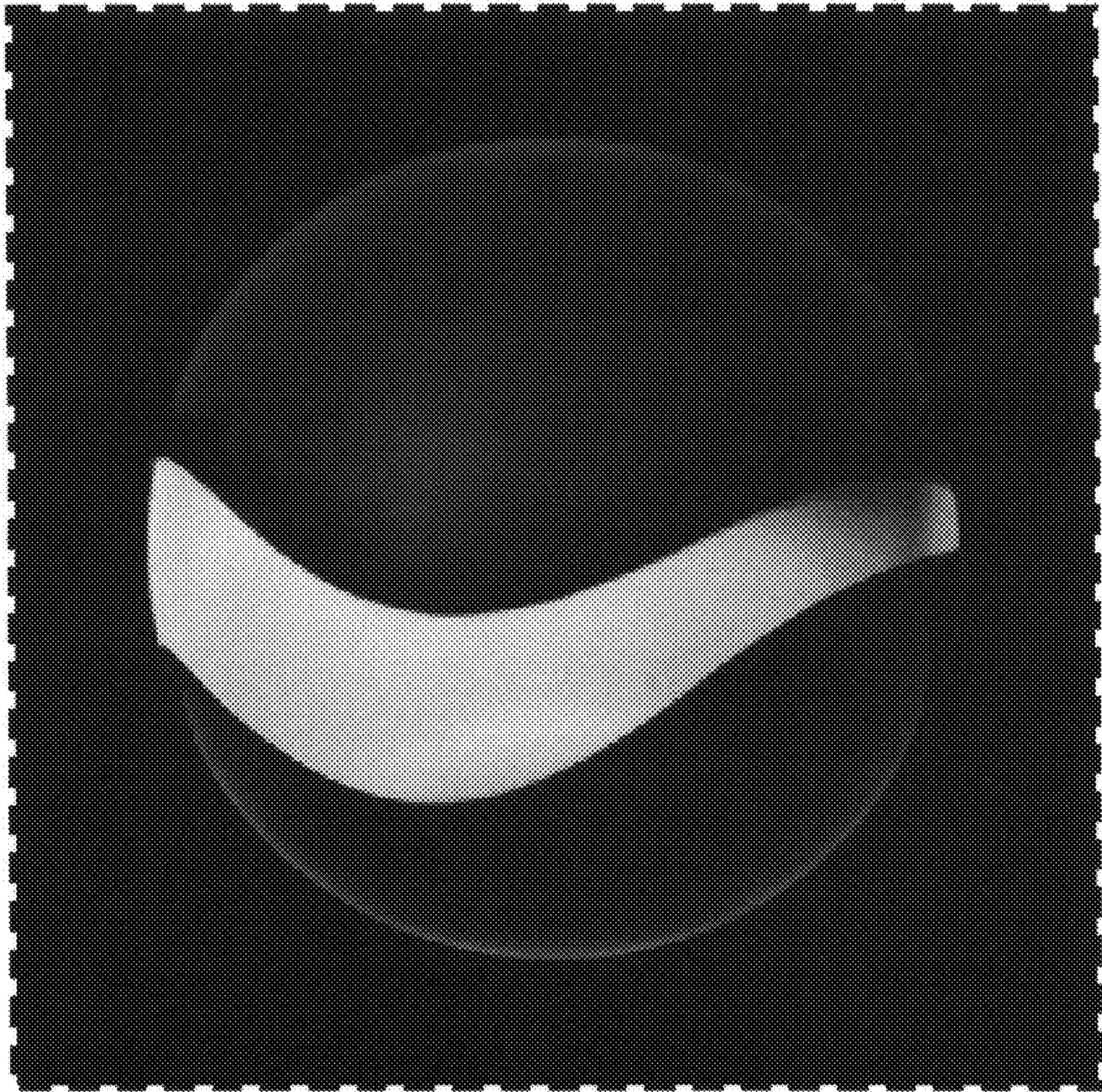

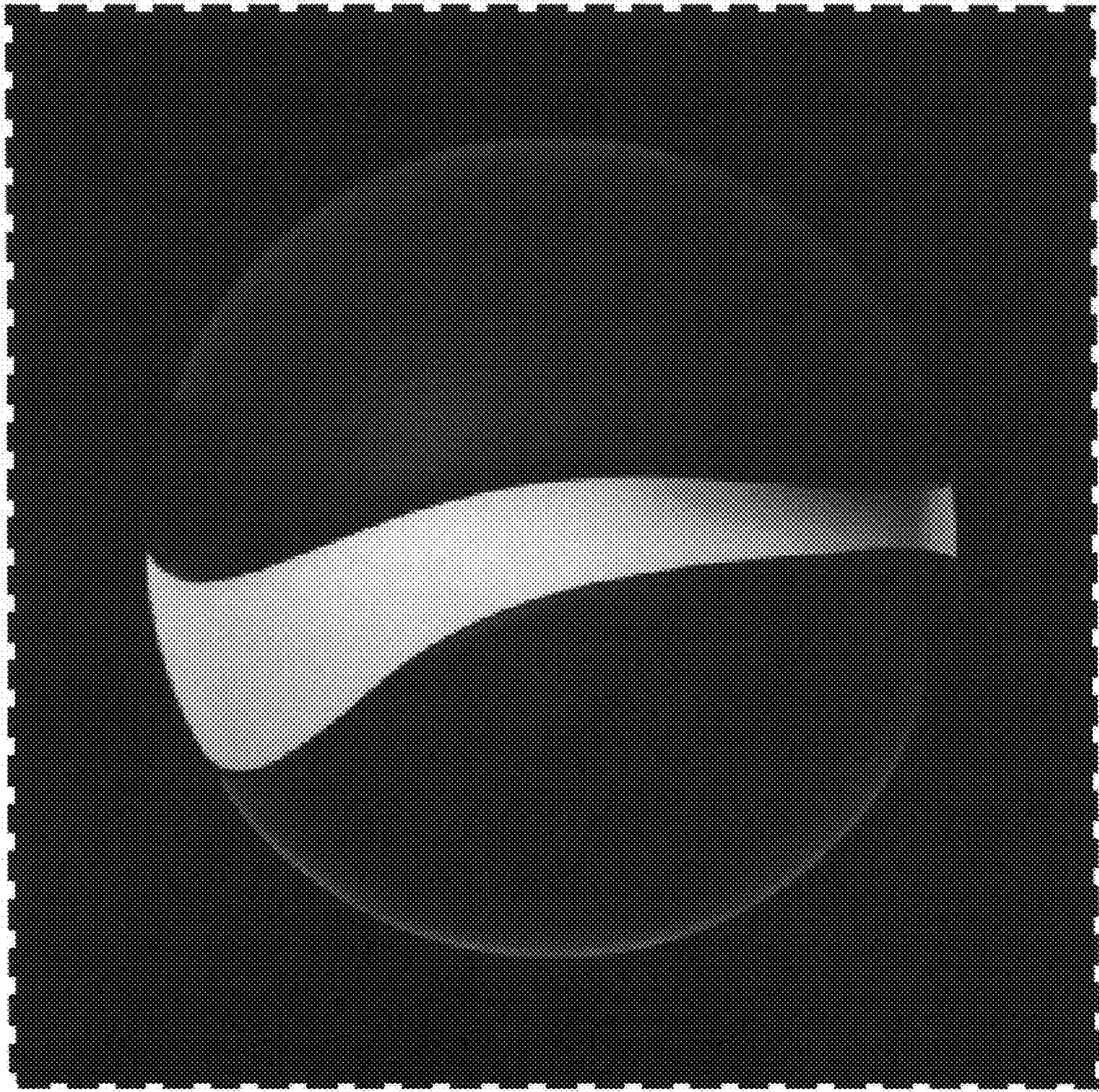

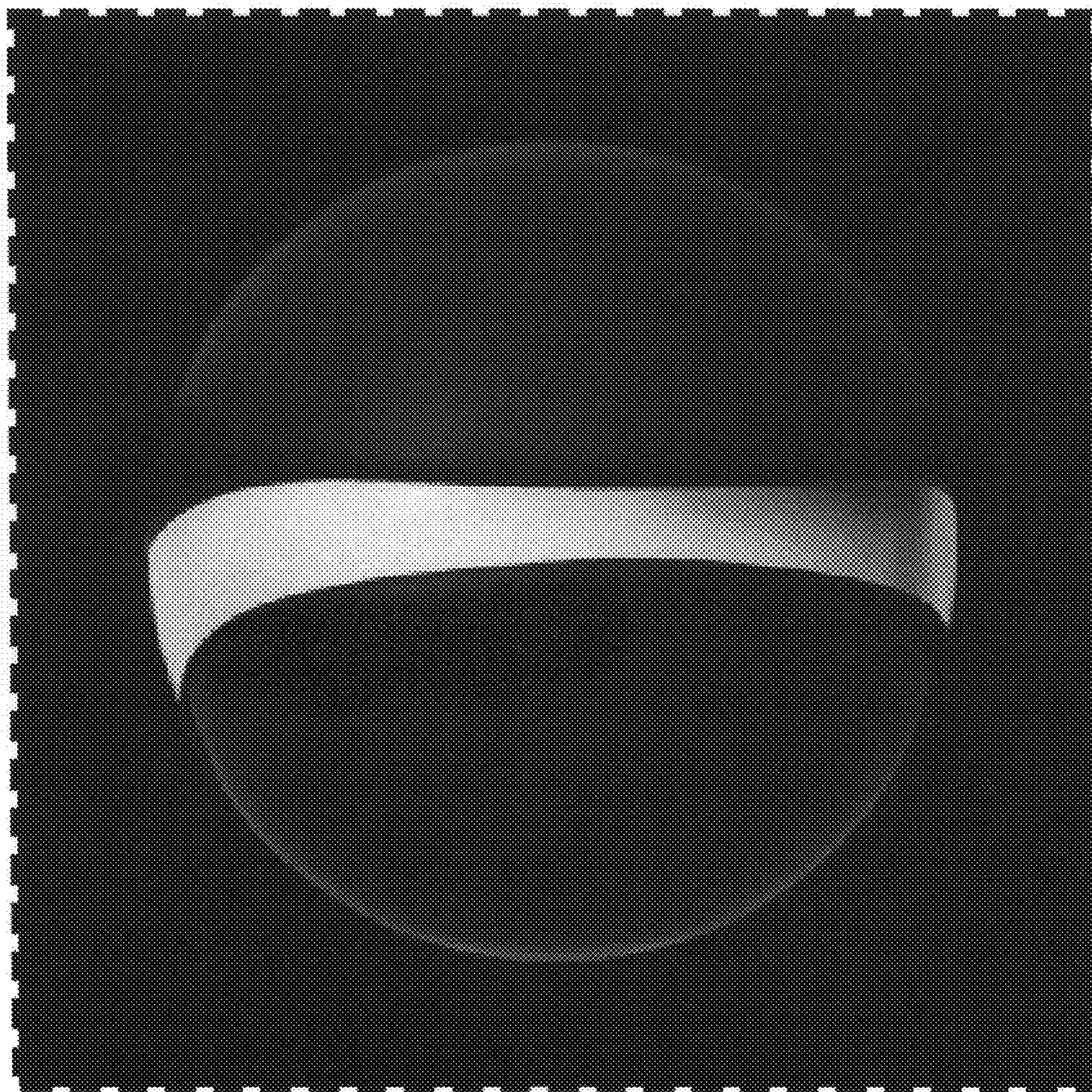

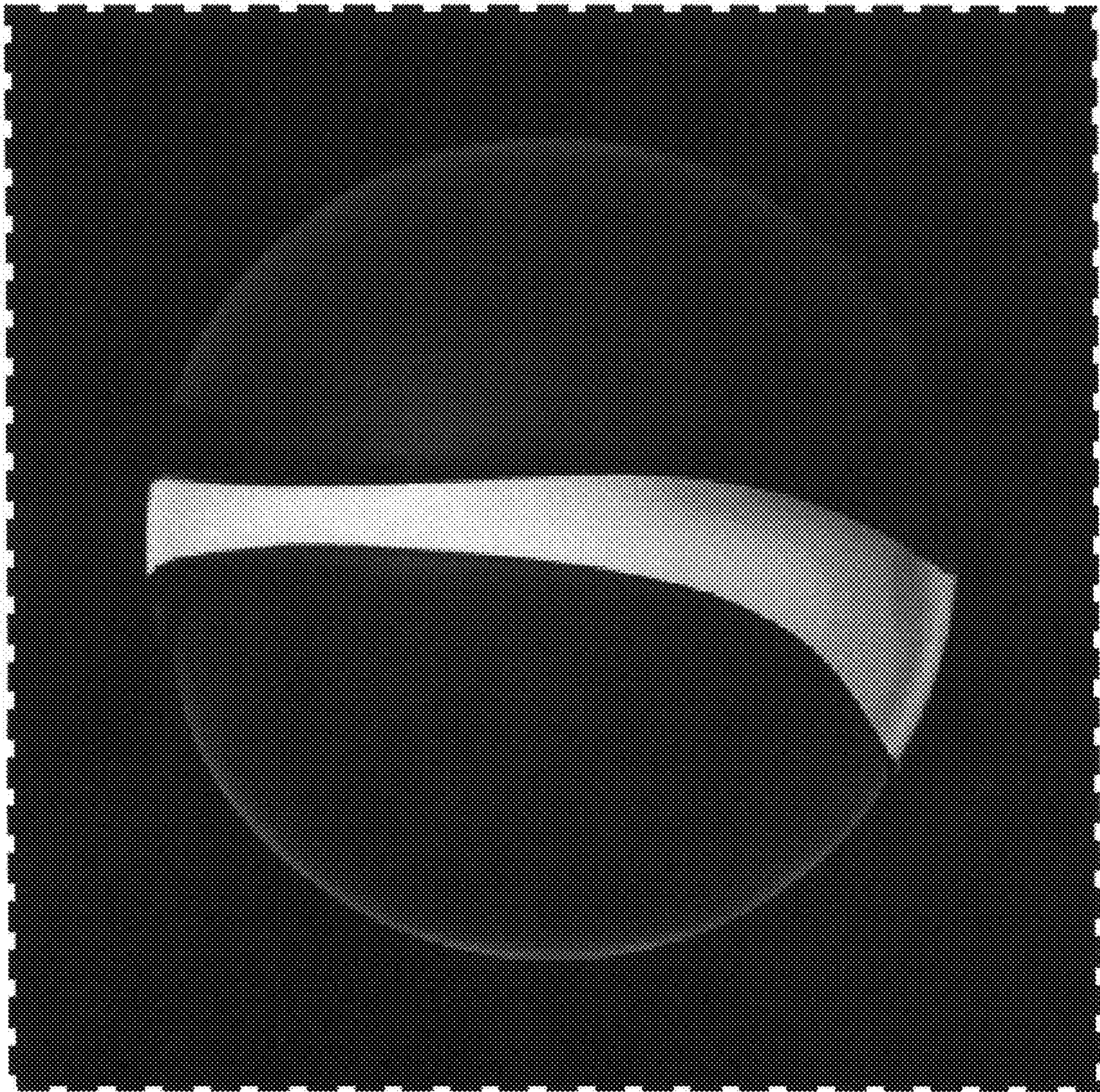

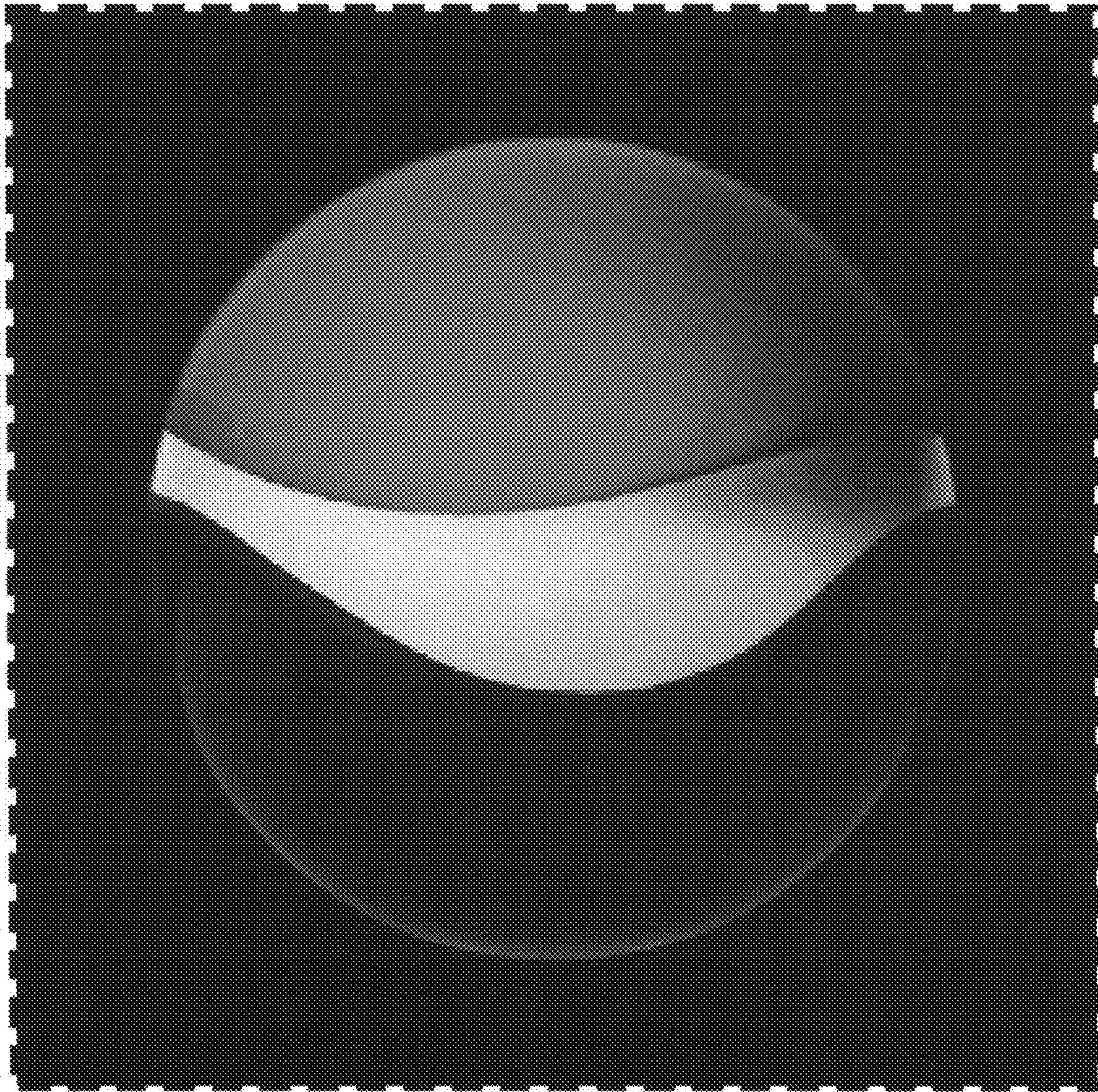
