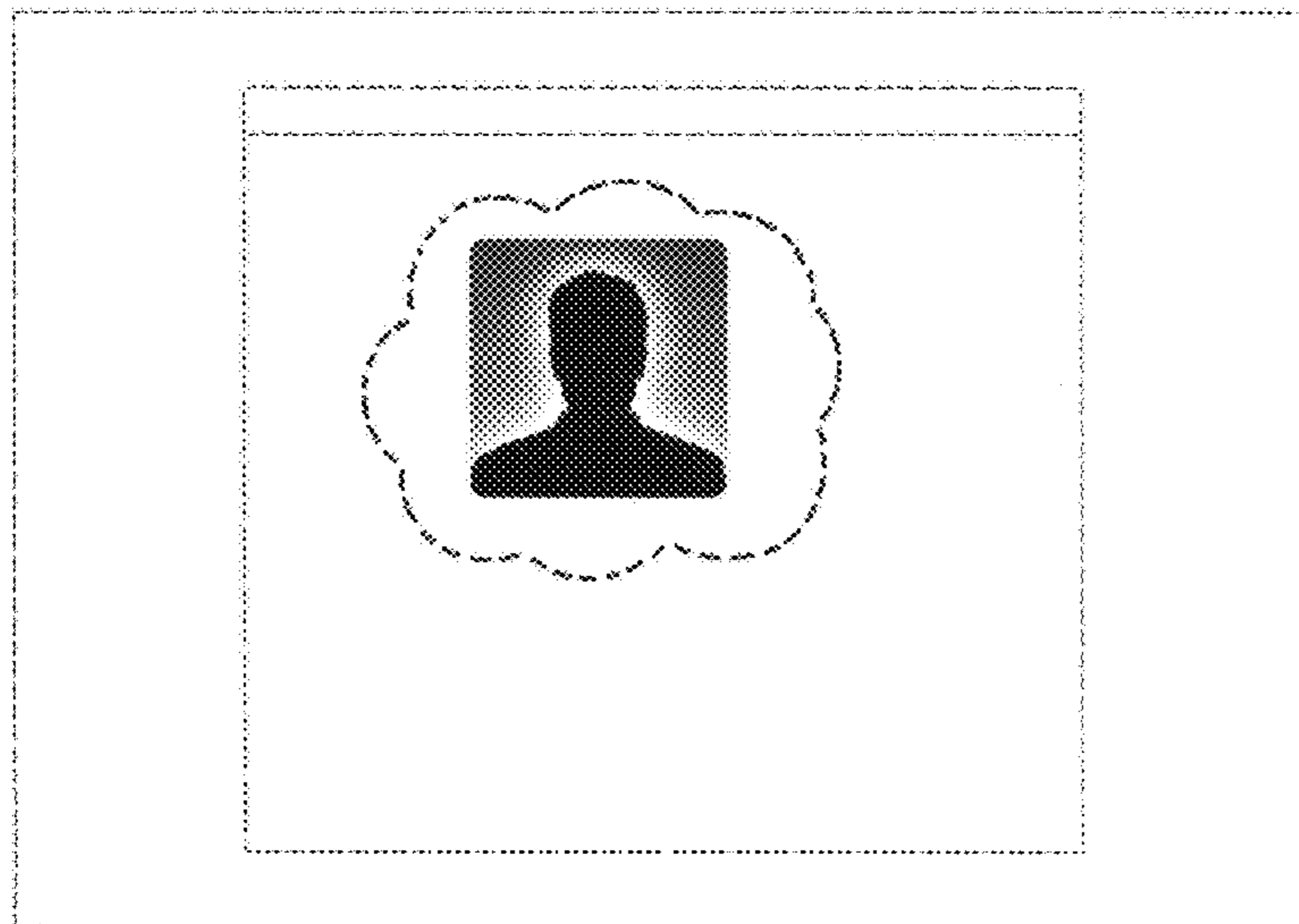
The sole FIGURE is a front view of a user interface for a computer display showing our new design.
