(57) **CLAIM**

I claim the ornamental design for a driveshaft tunnel with a line shield, as shown and described.

DESCRIPTION

FIG. 1 is a perspective side view of a driveshaft tunnel with a line shield shaped according to an embodiment of the design;

FIG. 2 is an end view of the design;

FIG. 3 is a side view of the design;

FIG. 4 is a top view of the design;

FIG. 5 is an opposite side view of the design;

FIG. 6 is a bottom view of the design.

FIG. 7 is a perspective side view of a driveshaft tunnel with a line shield shaped according to another embodiment of the design;

FIG. 8 is an end view of the embodiment of the design shown in FIG. 7;

FIG. 9 is a side view of the embodiment of the design shown in FIG. 7;

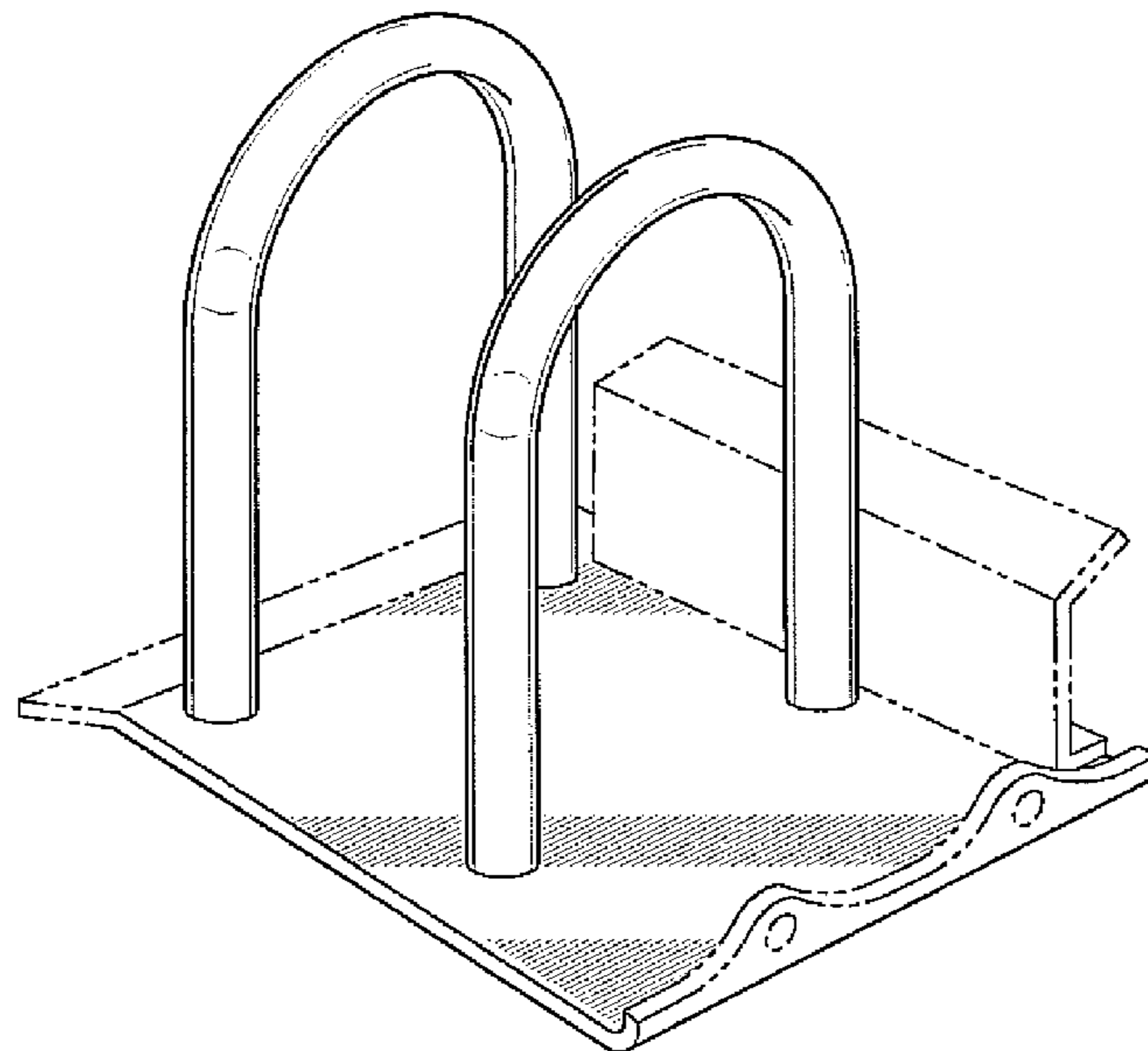
FIG. 10 is a top view of the embodiment of the design shown in FIG. 7;

FIG. 11 is an opposite side of the embodiment of the design shown in FIG. 7; and,

FIG. 12 is a bottom view of the embodiment of the design shown in FIG. 7.

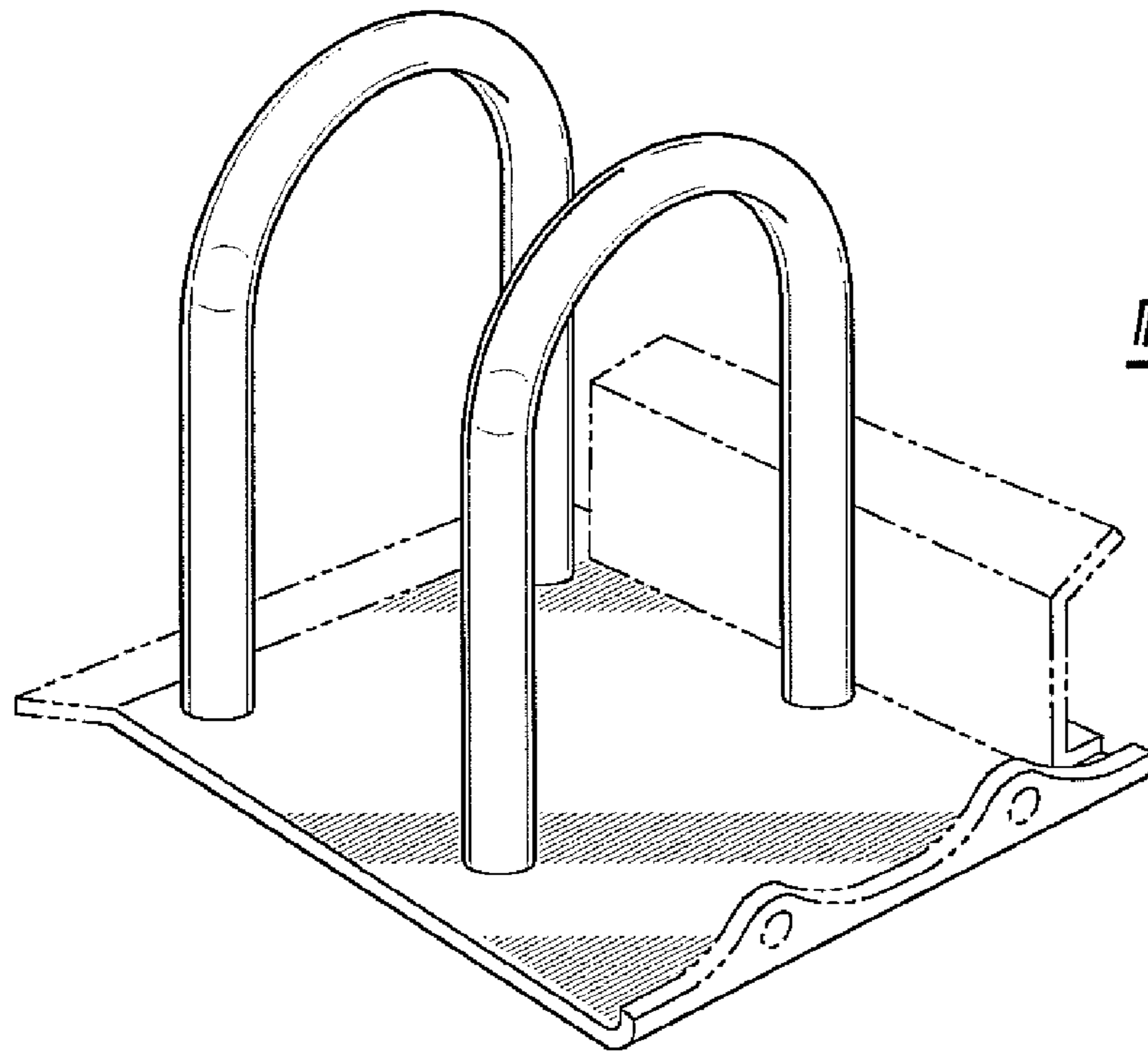

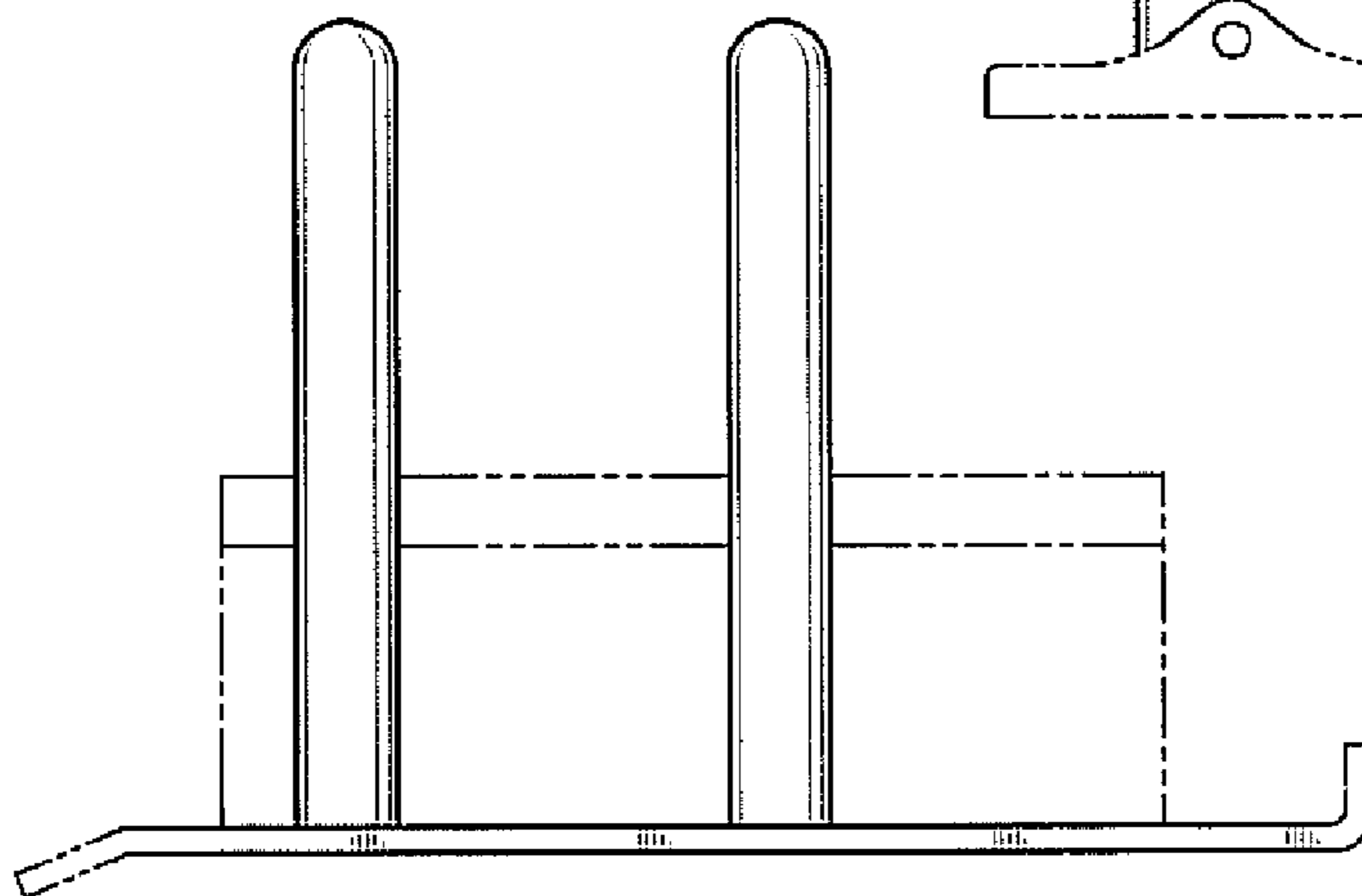
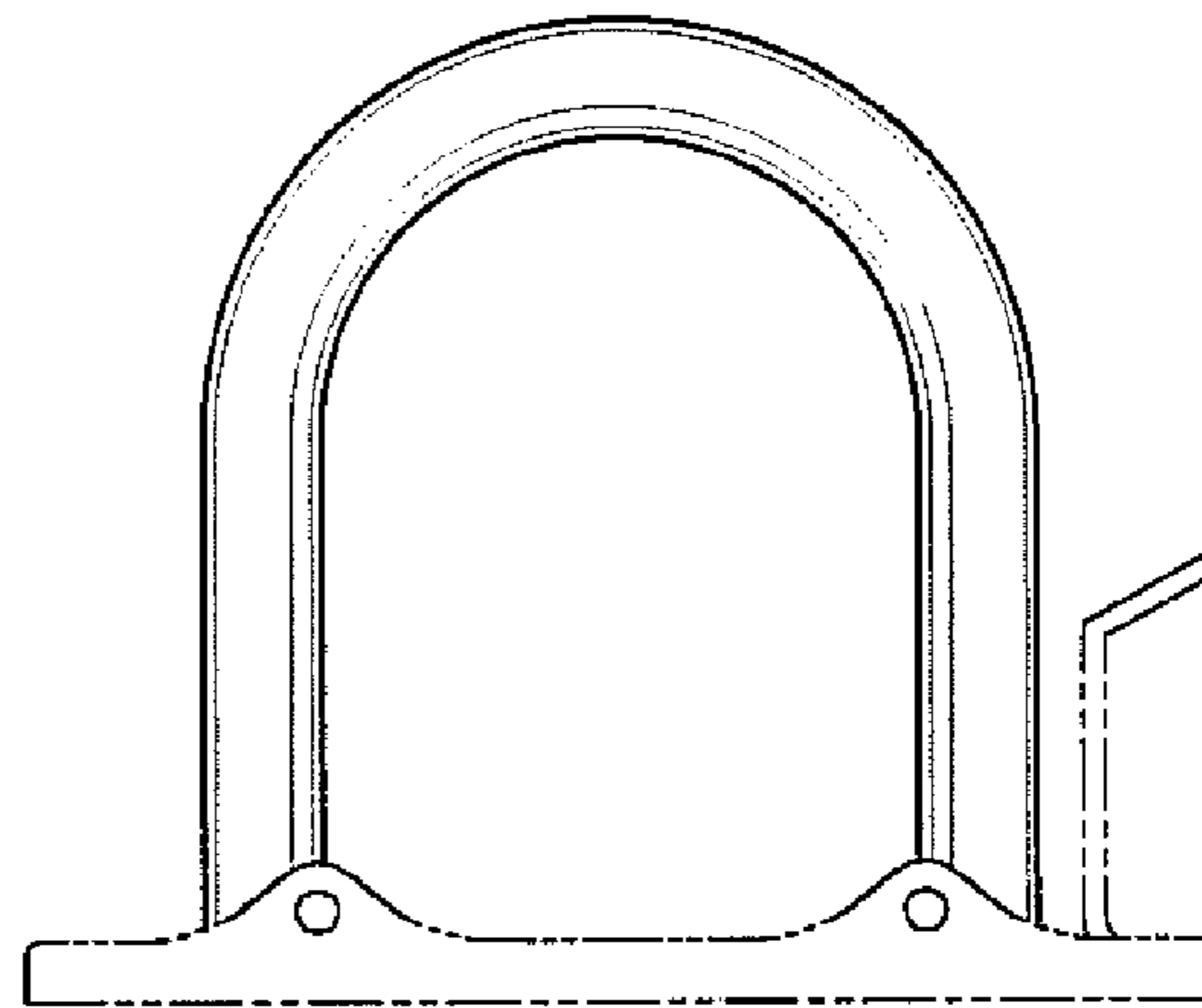

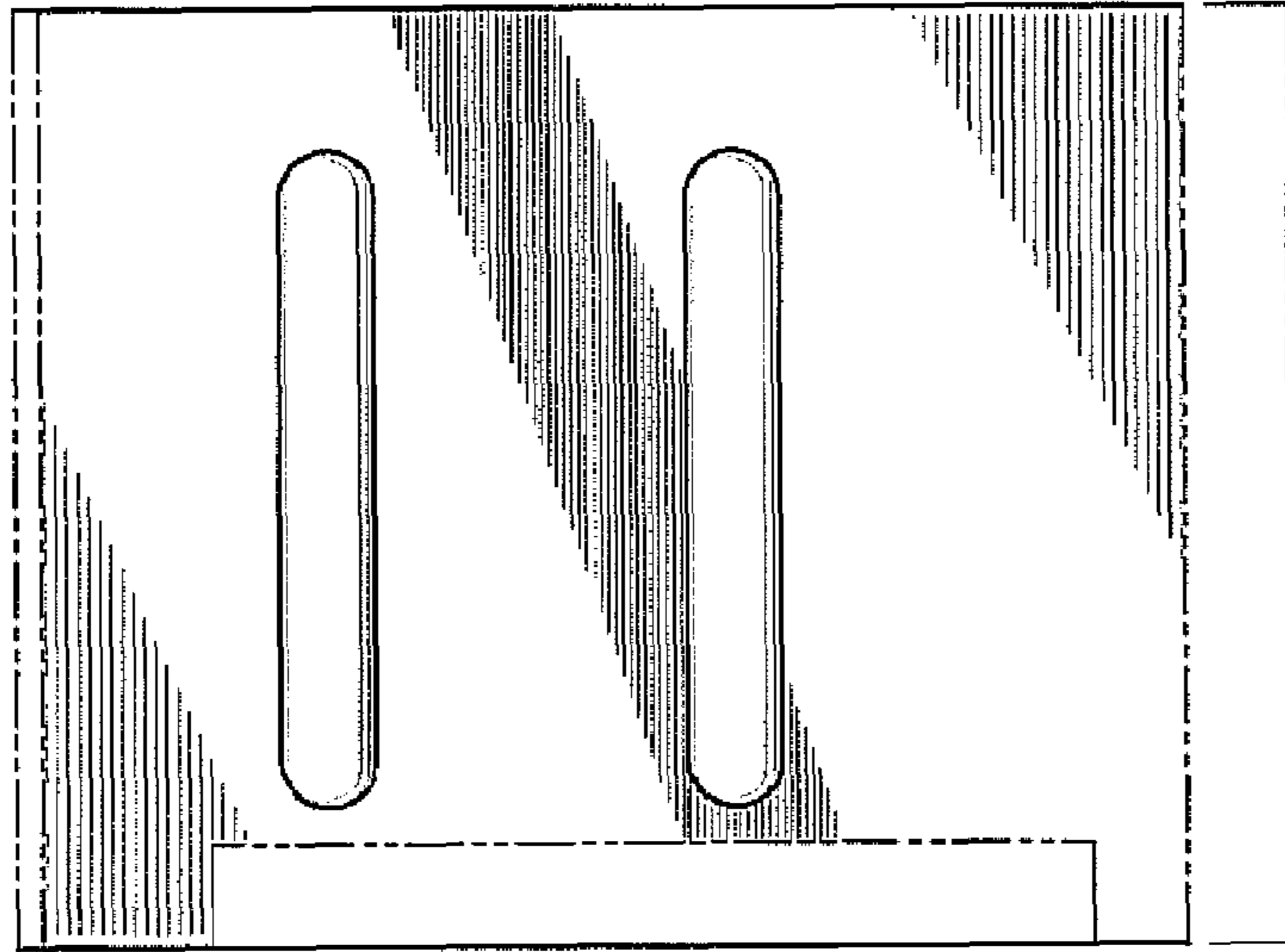

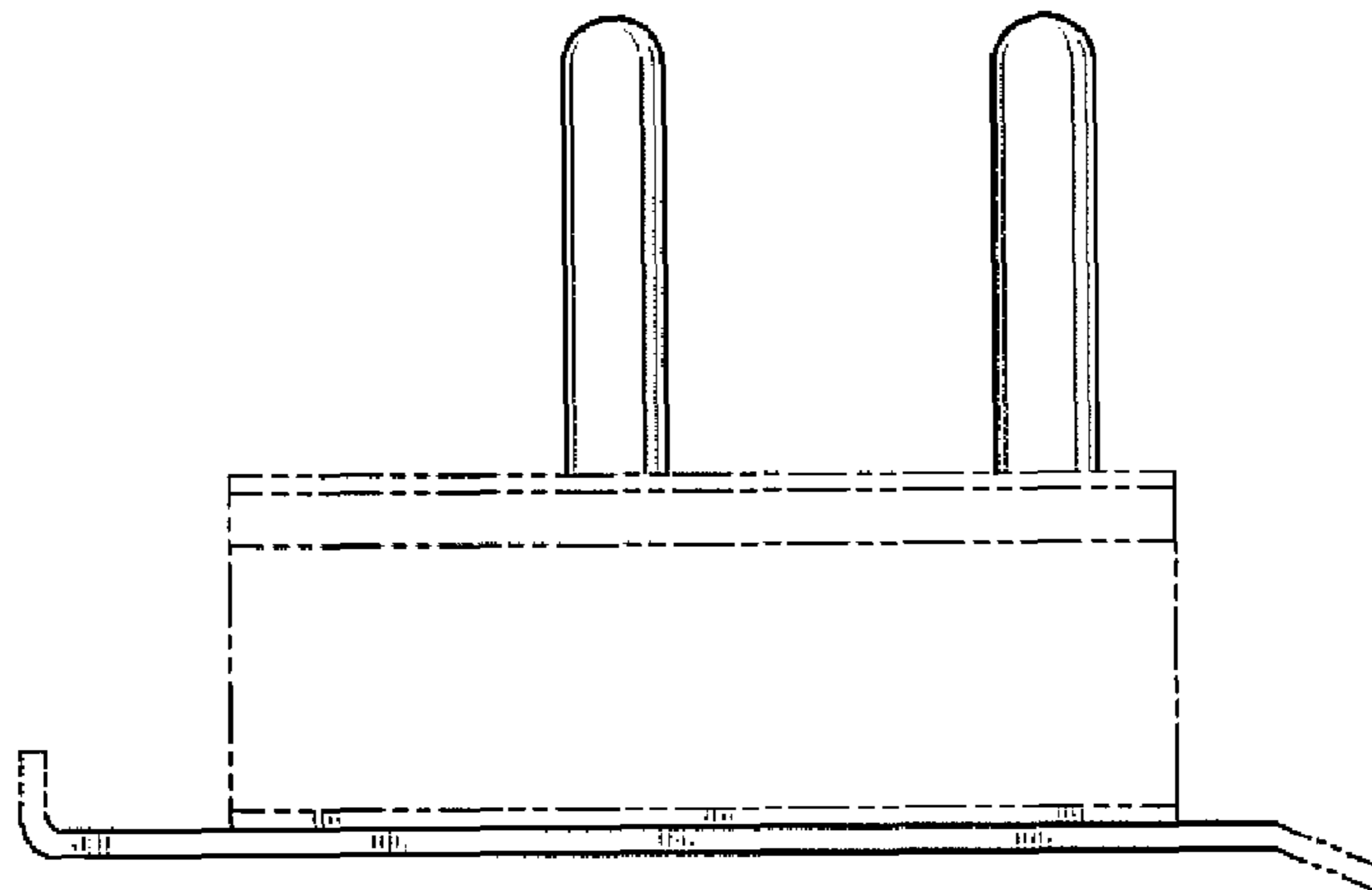

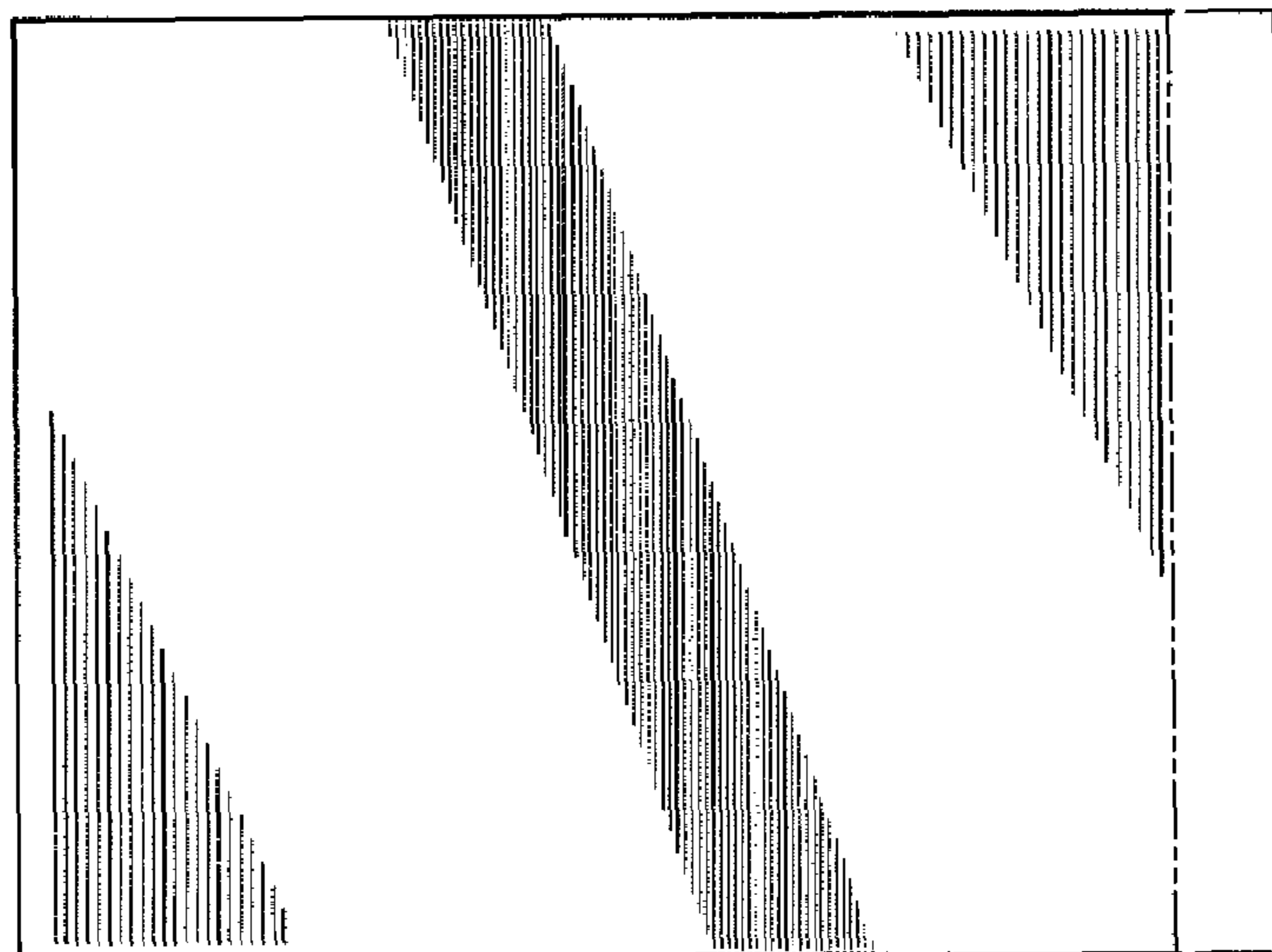

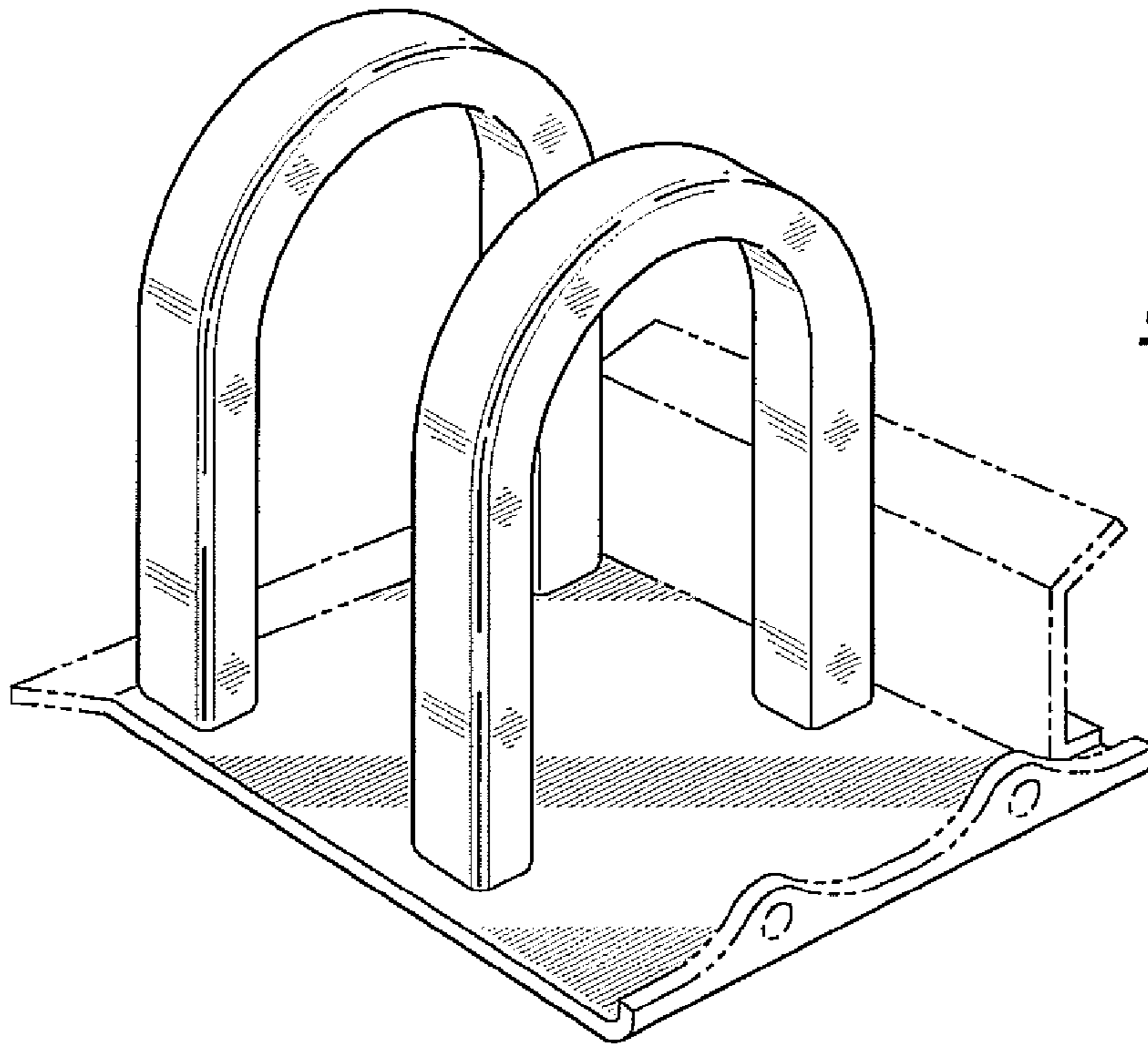

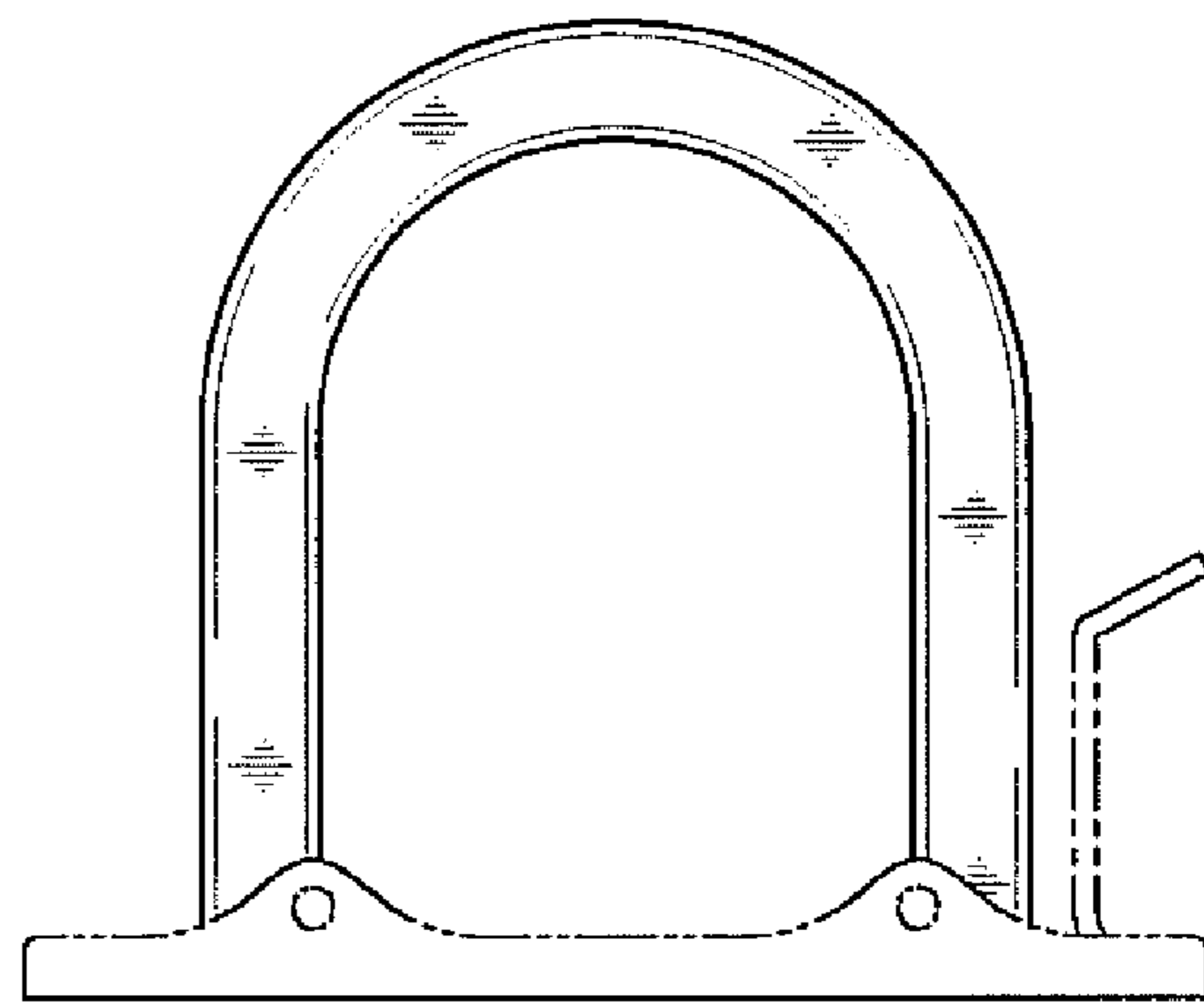

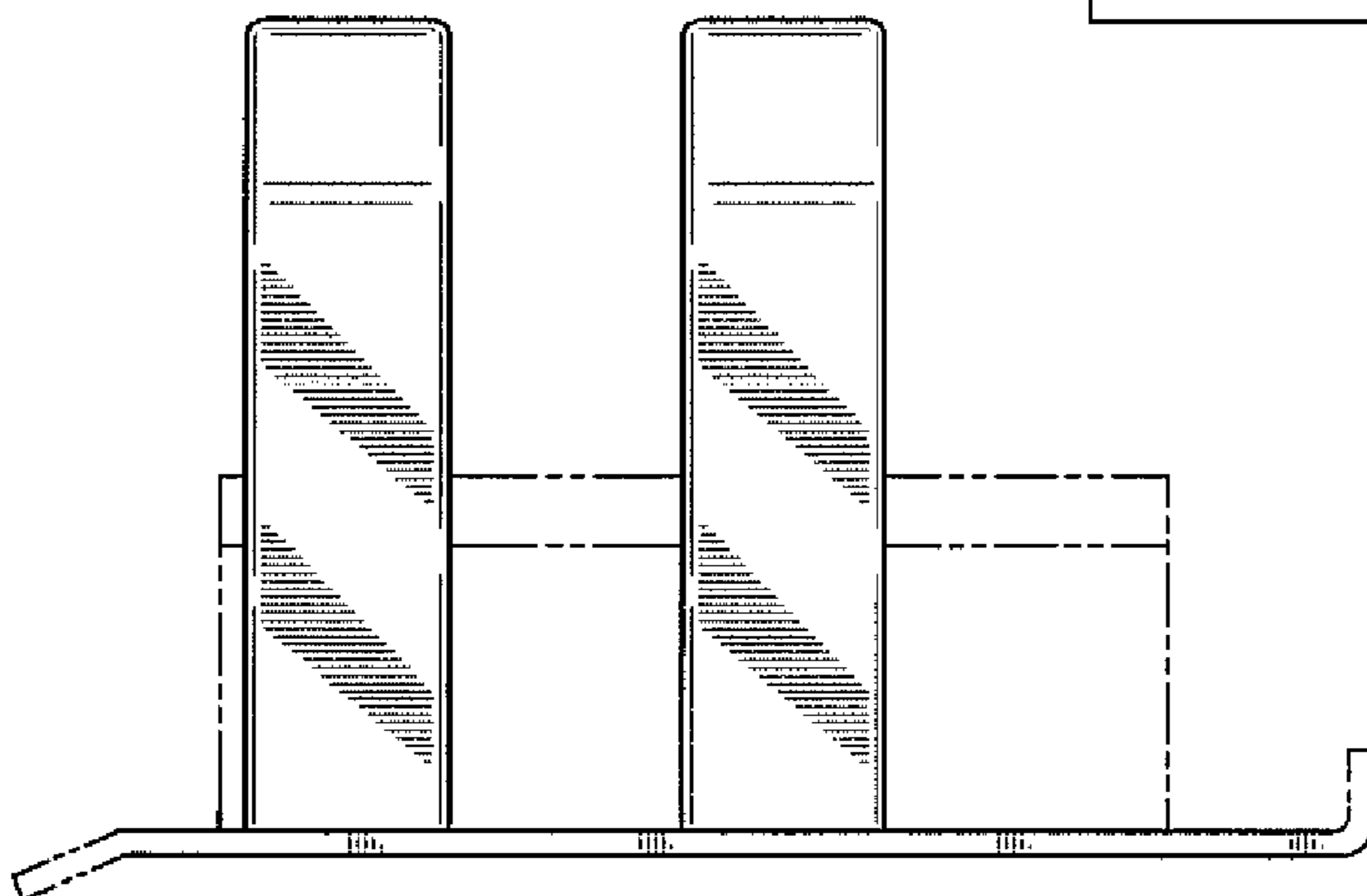

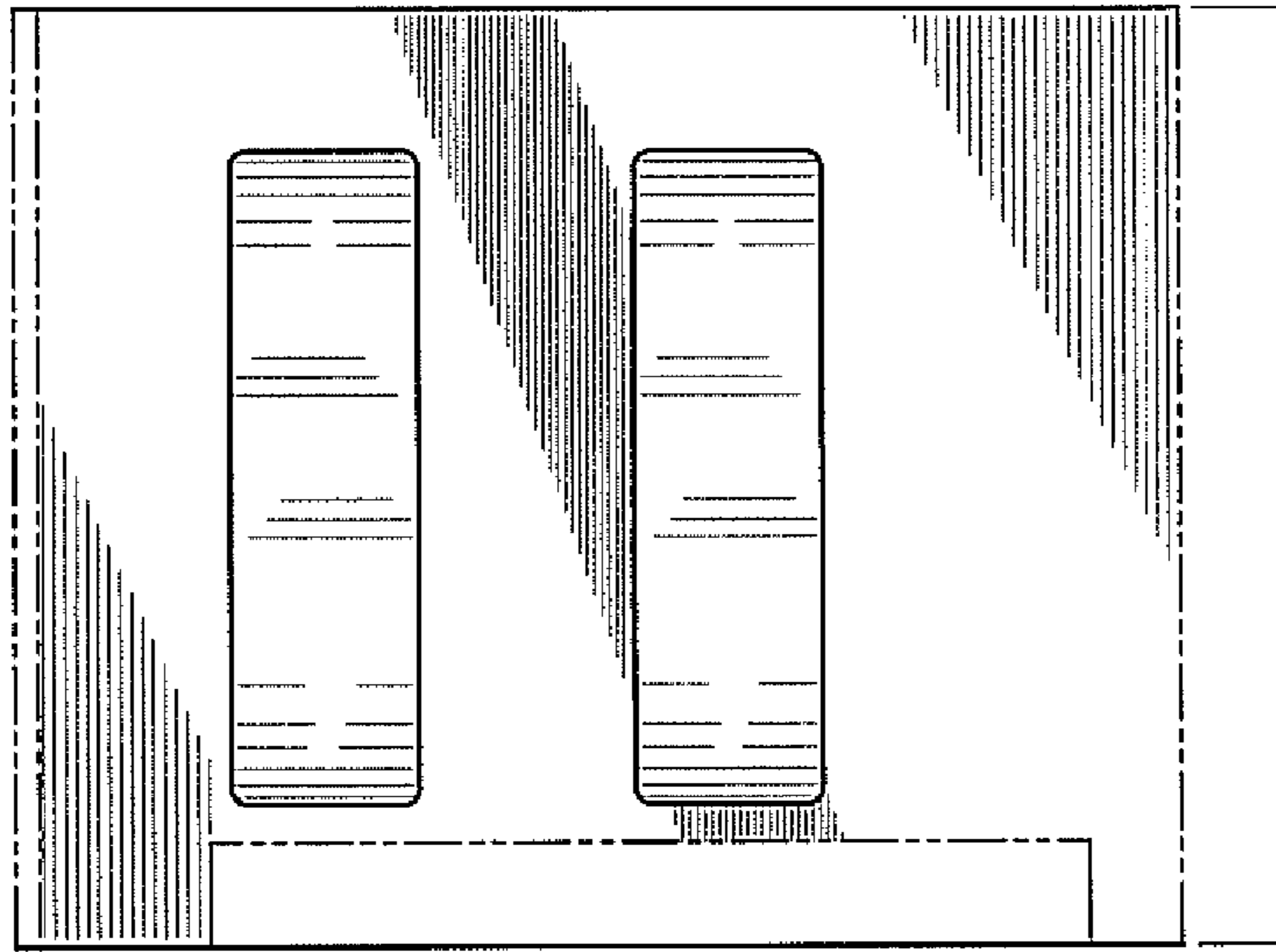

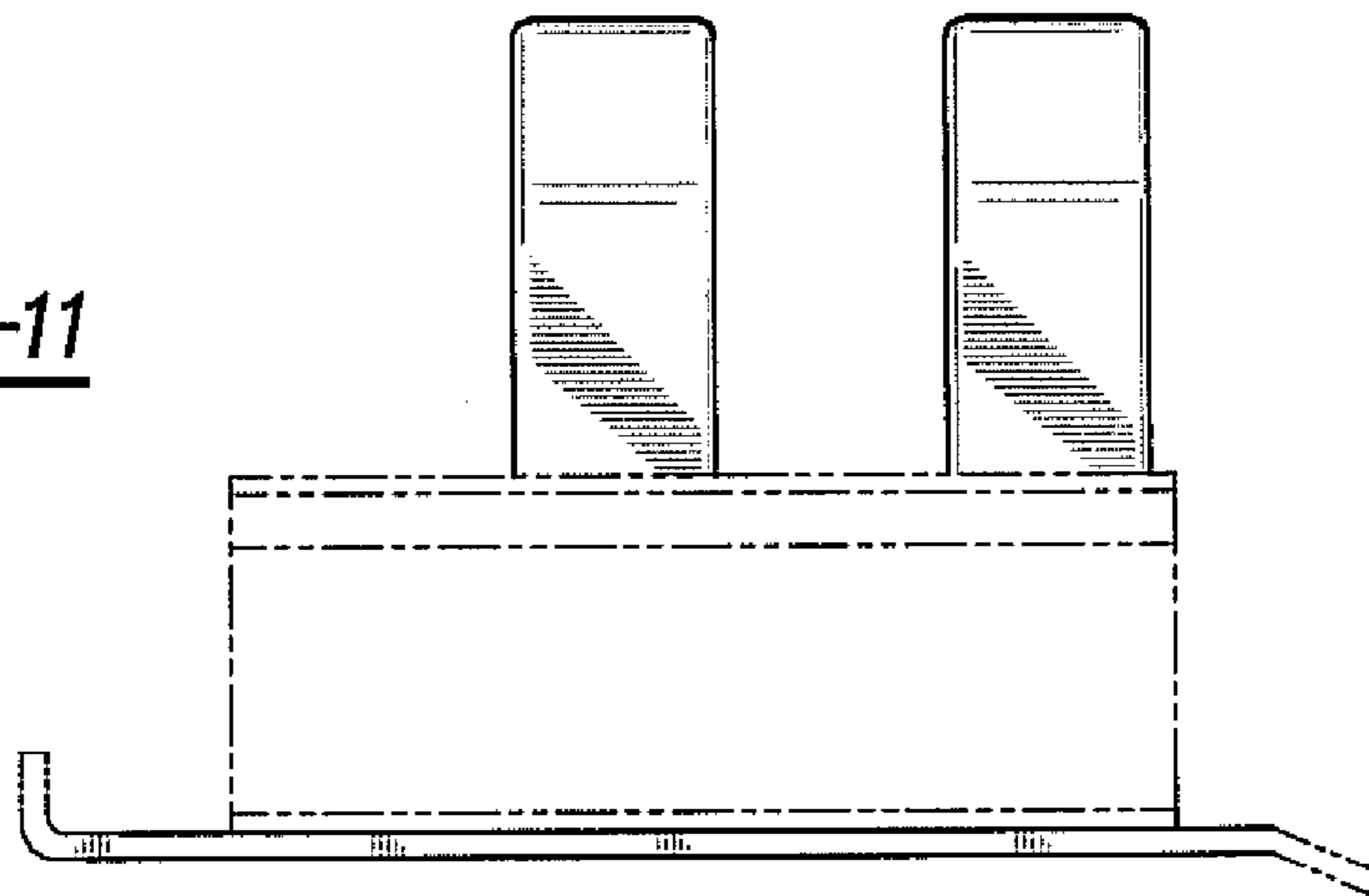
