The ornamental design for a signage, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the signage showing my design thereof;

FIG. 2 is a front view thereof, the front view being the same as the back view;

FIG. 3 is a side view thereof;

FIG. 4 is a perspective view of a second embodiment of the signage showing my design thereof;

FIG. 5 is a front view thereof, the front view being the same as the back view;

FIG. 6 is a side view thereof;

FIG. 7 is a perspective view of a third embodiment of the signage showing my design thereof;

FIG. 8 is a front view thereof, the front view being the same as the back view;

FIG. 9 is a side view thereof;

FIG. 10 is a perspective view of a fourth embodiment of the signage showing my design thereof;

FIG. 11 is a front view thereof, the front view being the same as the back view;

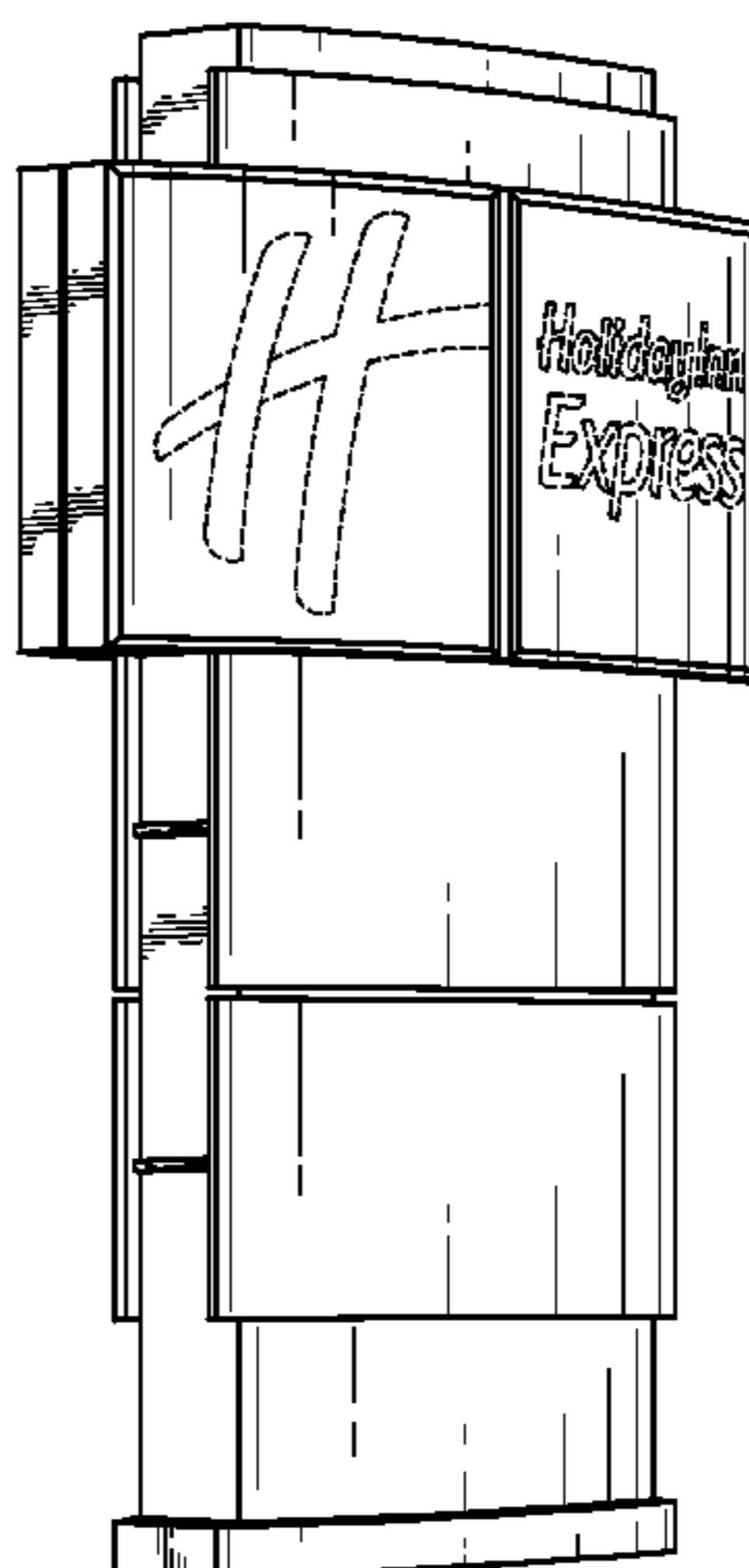
FIG. 12 is a side view thereof;

FIG. 13 is a top view of the signage of the first, second, third and fourth embodiments; and,

FIGS. 7-12 are shown broken away to indicate no particular height is claimed. The panels on the front and side of FIGS. 7-9 repeat uniformly throughout the height of the sign.

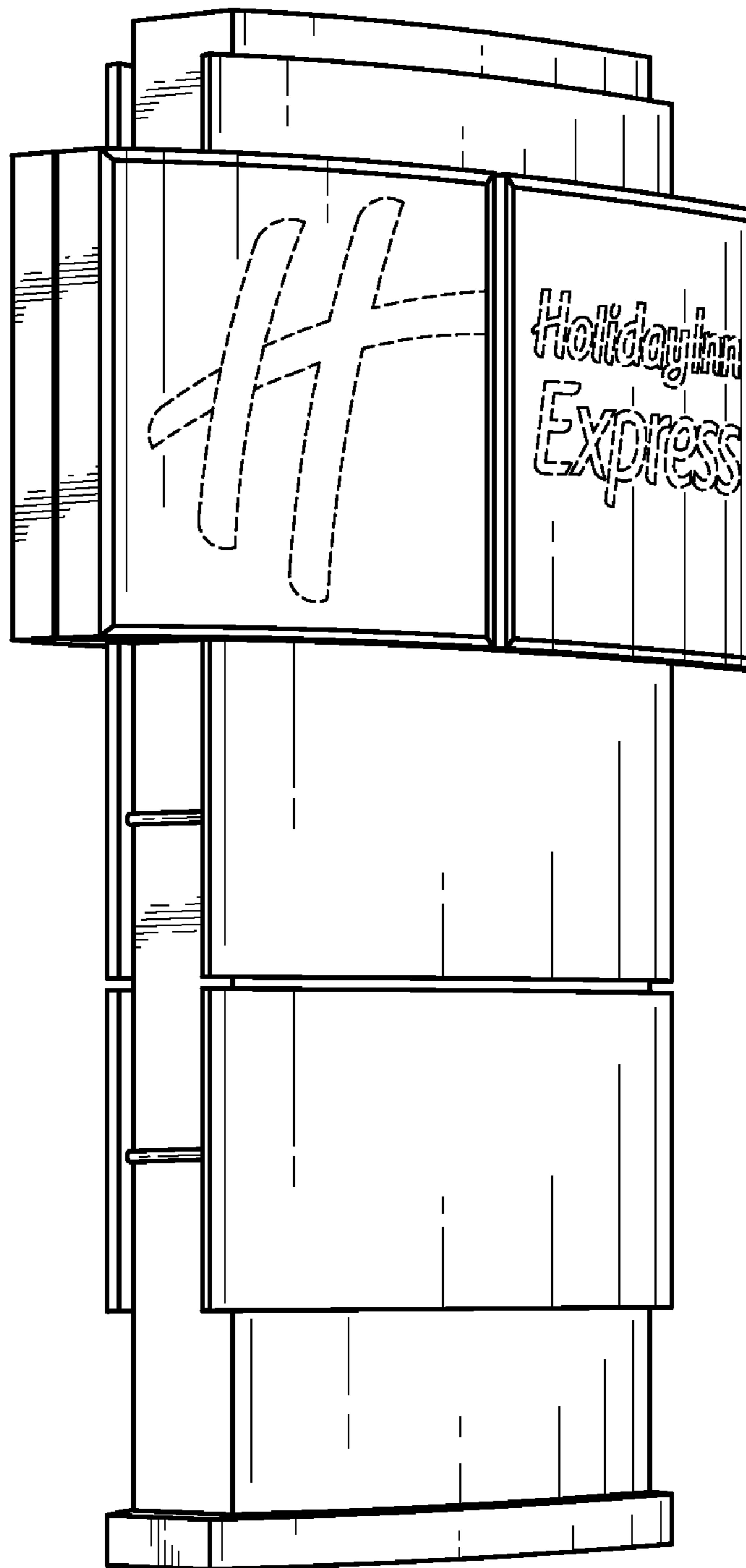

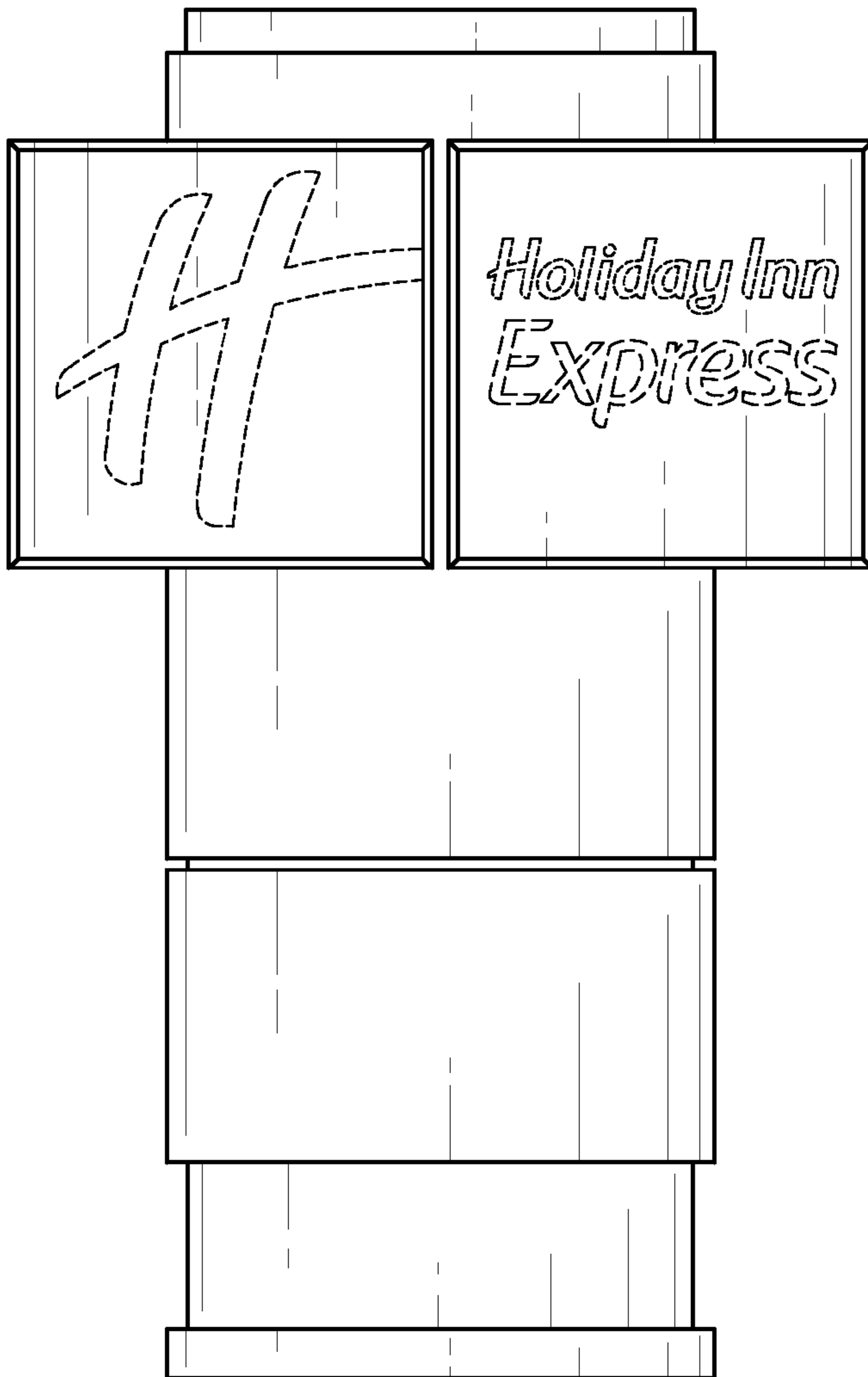

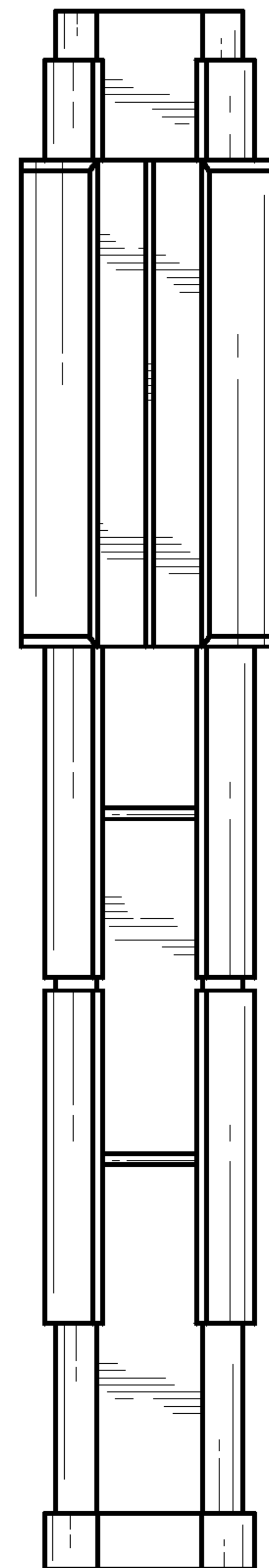

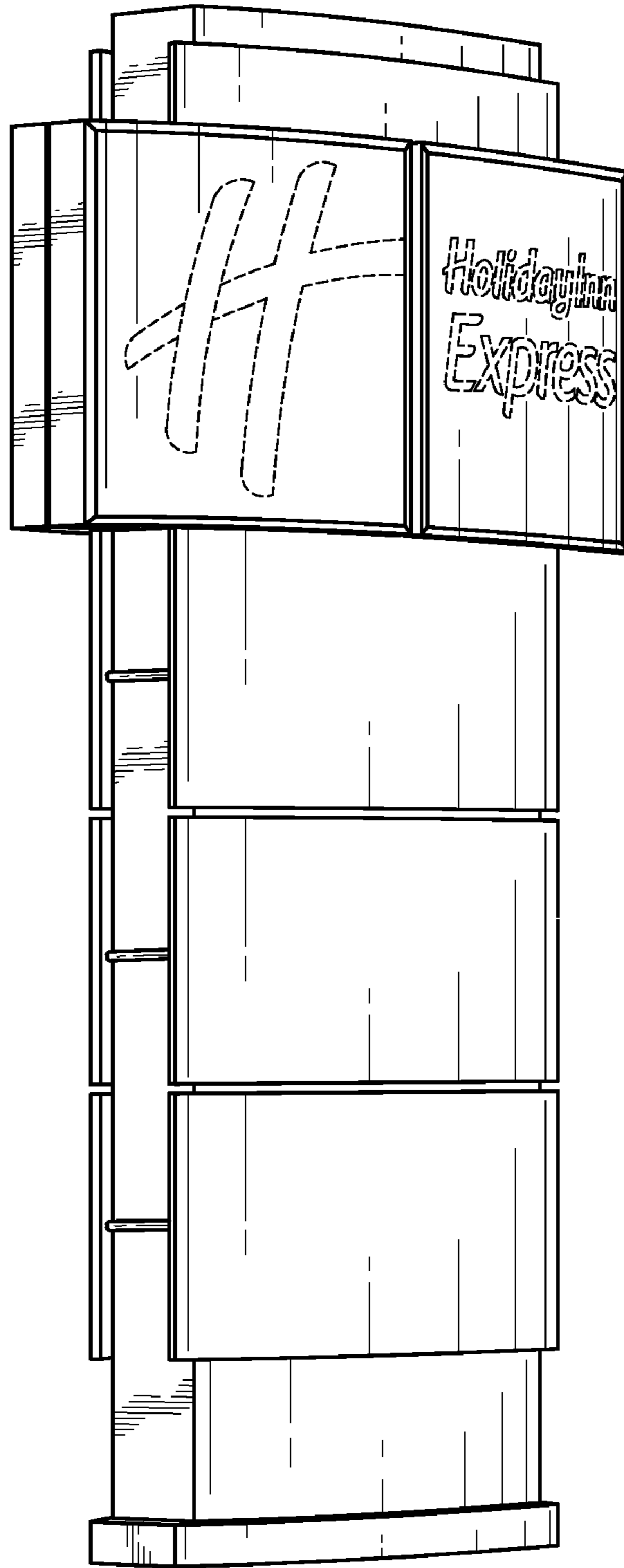

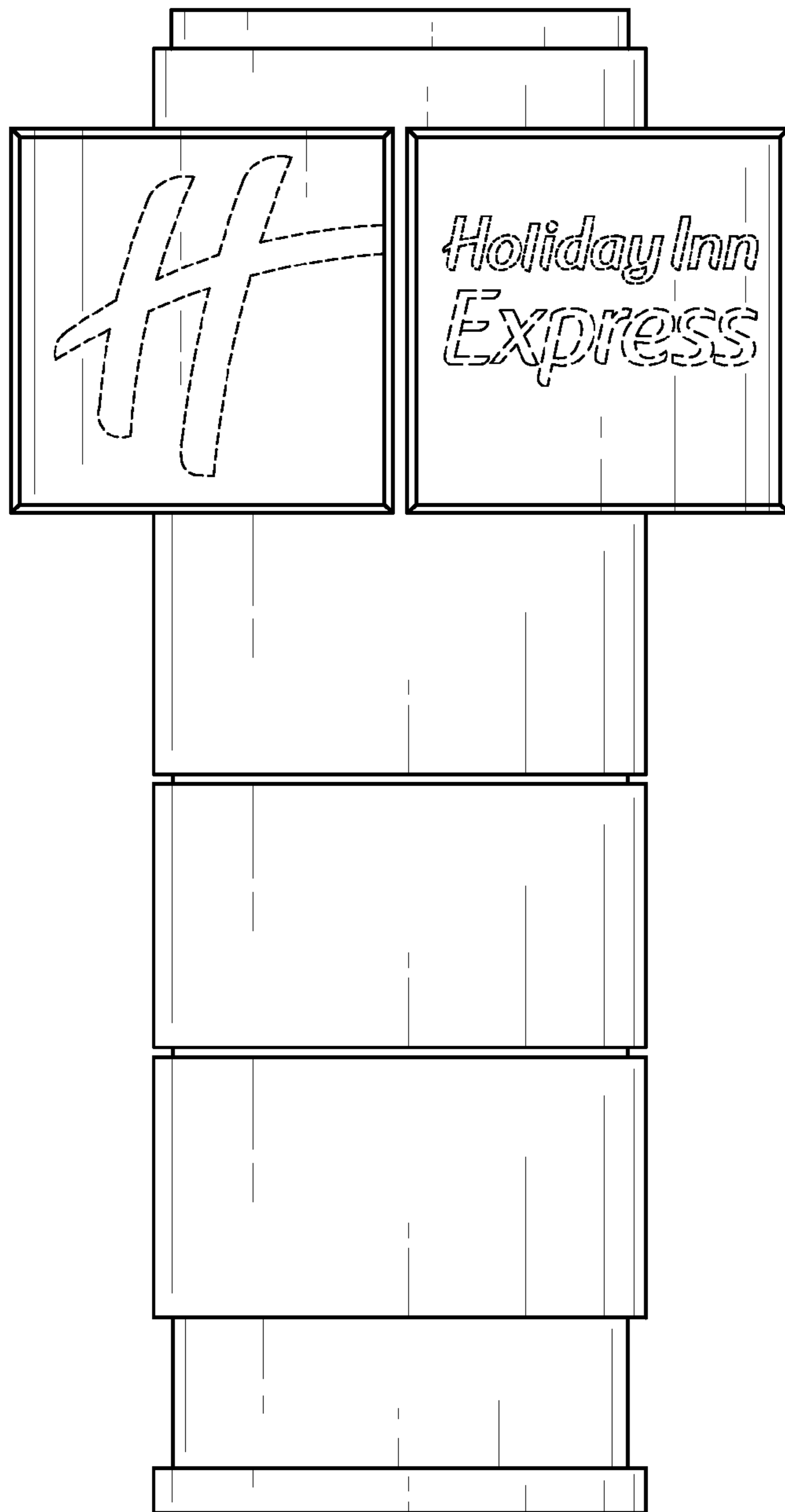

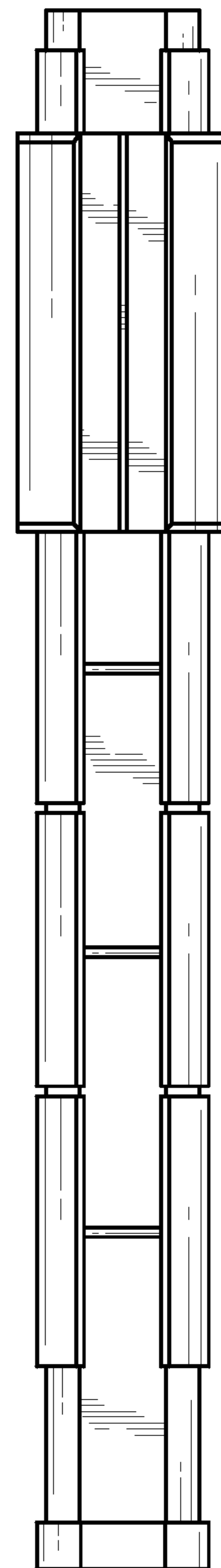

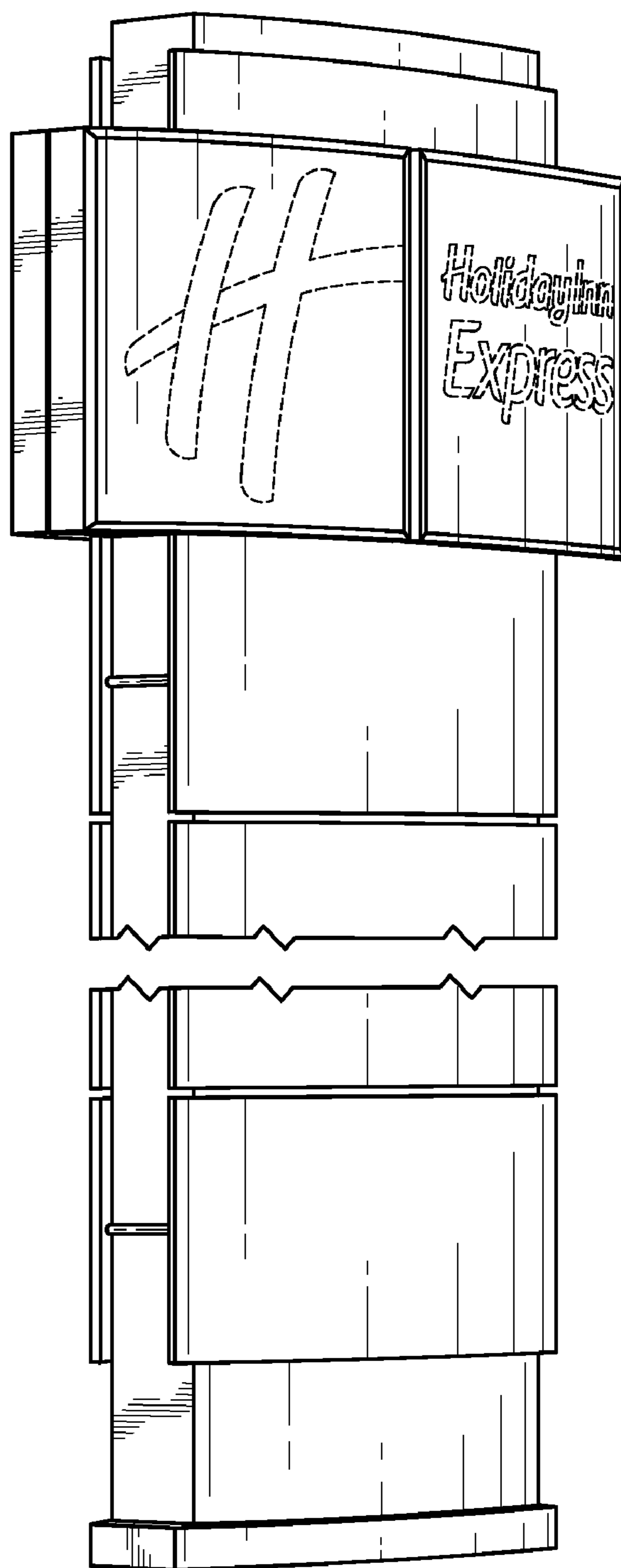

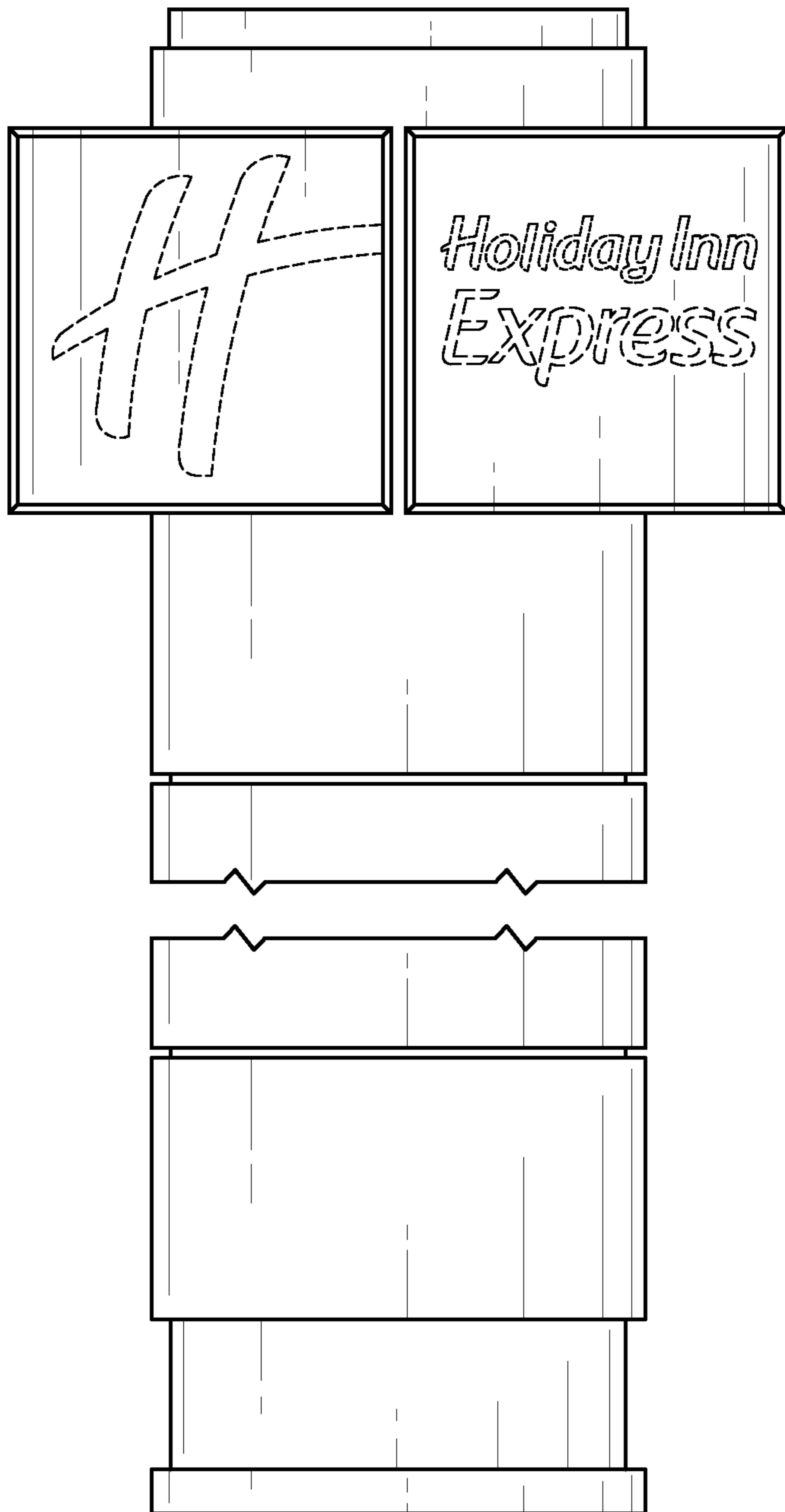

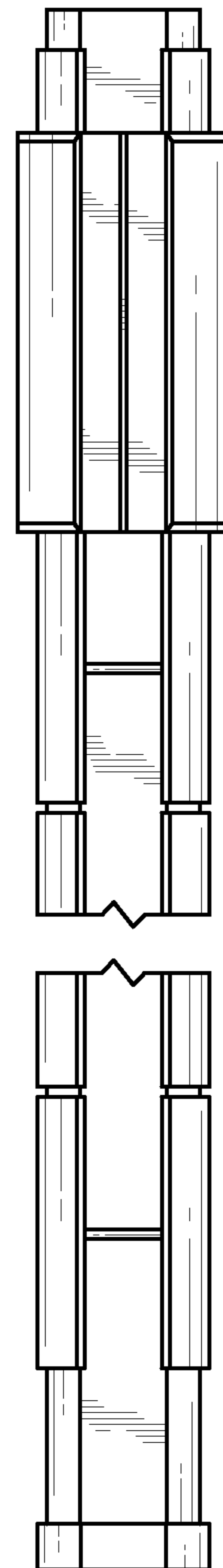

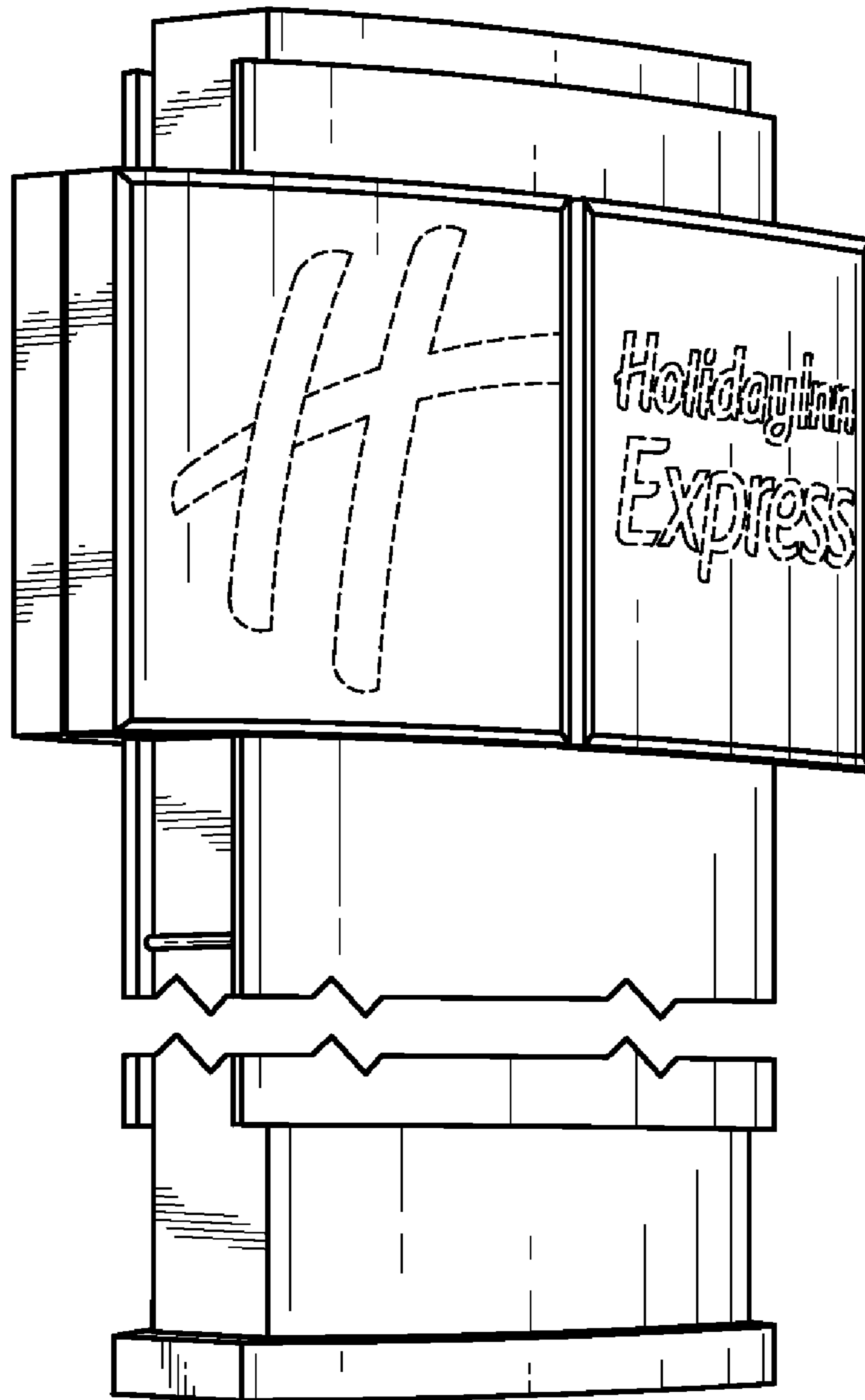

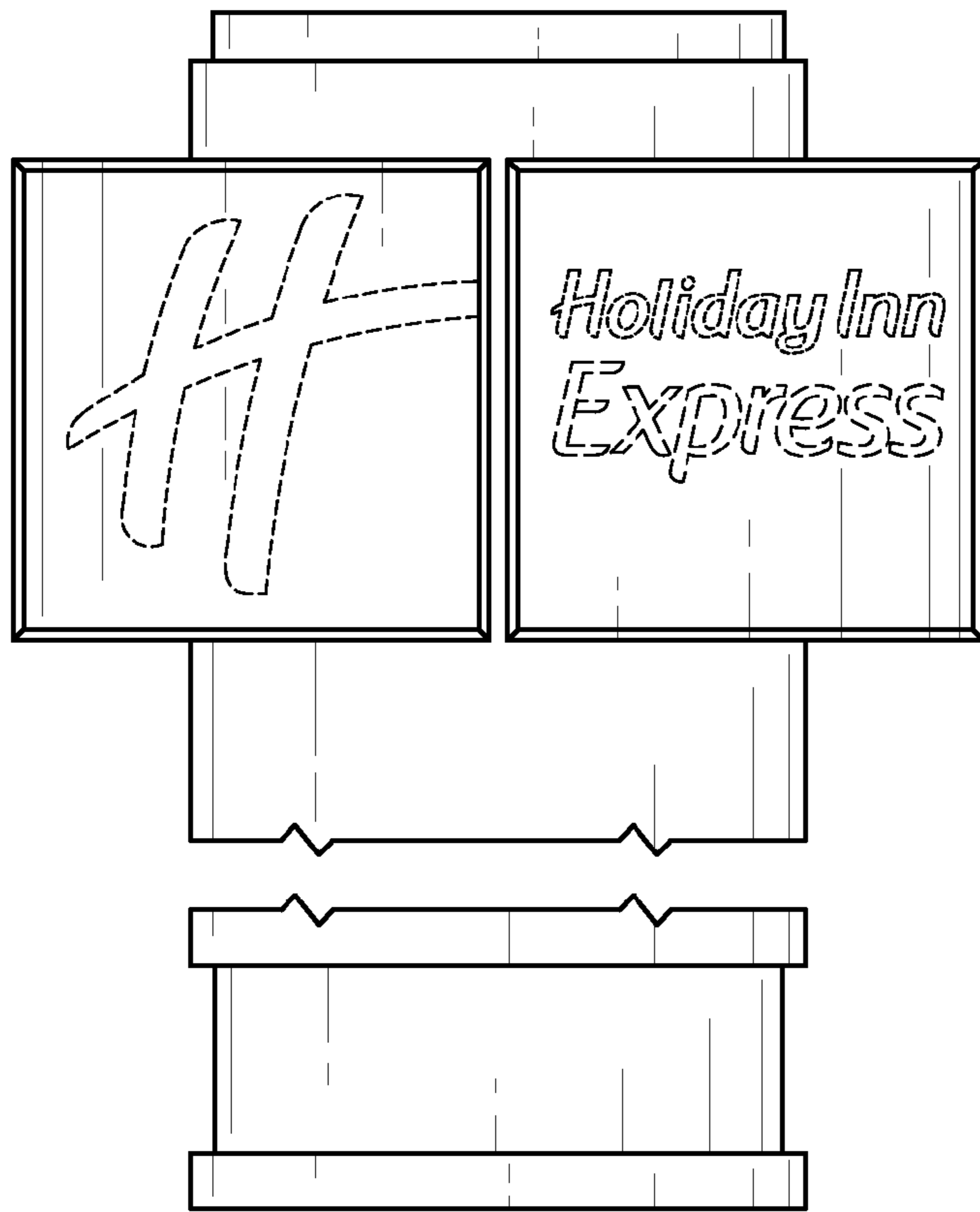

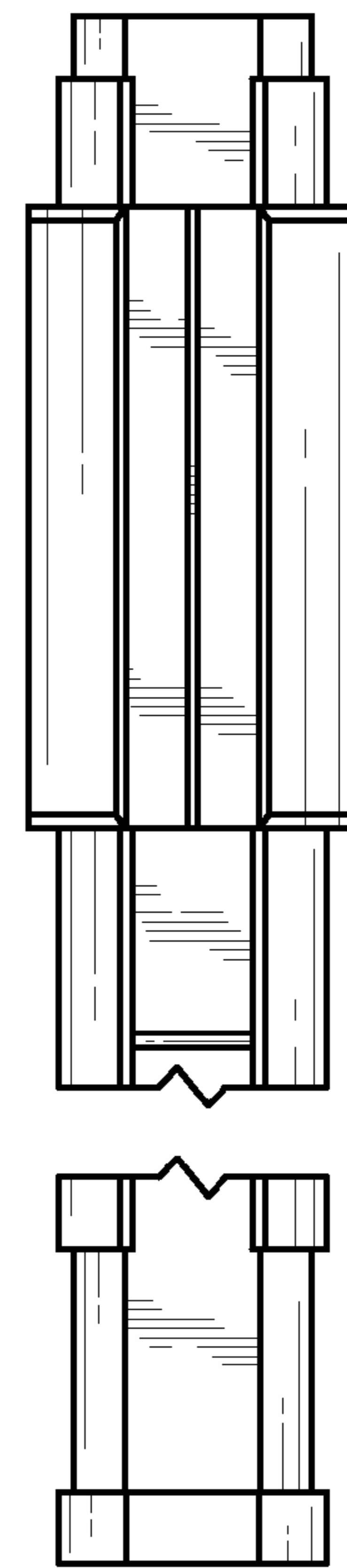

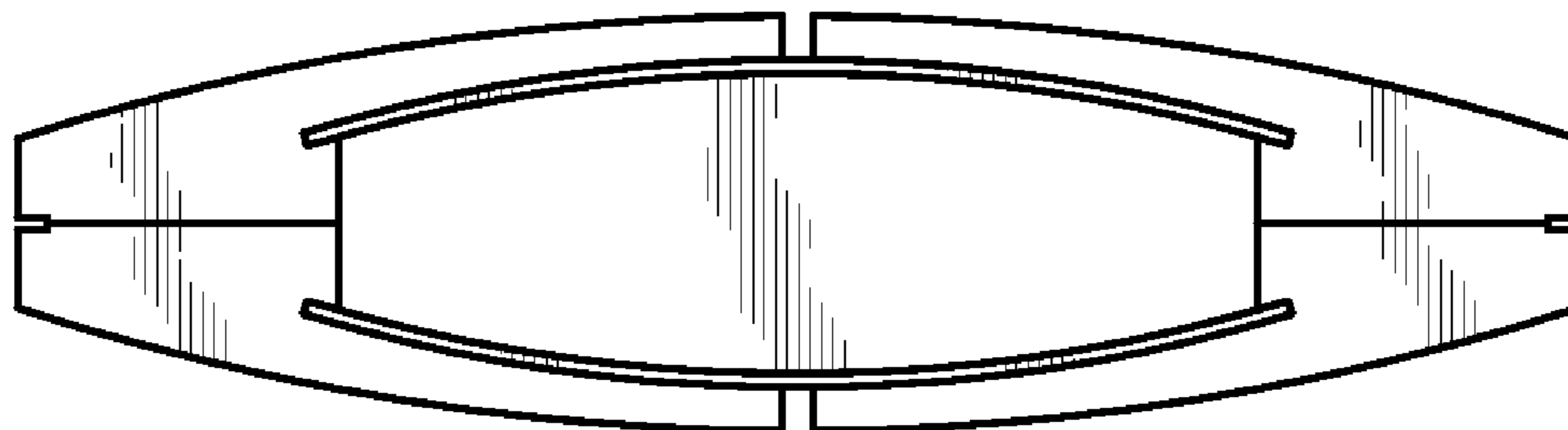

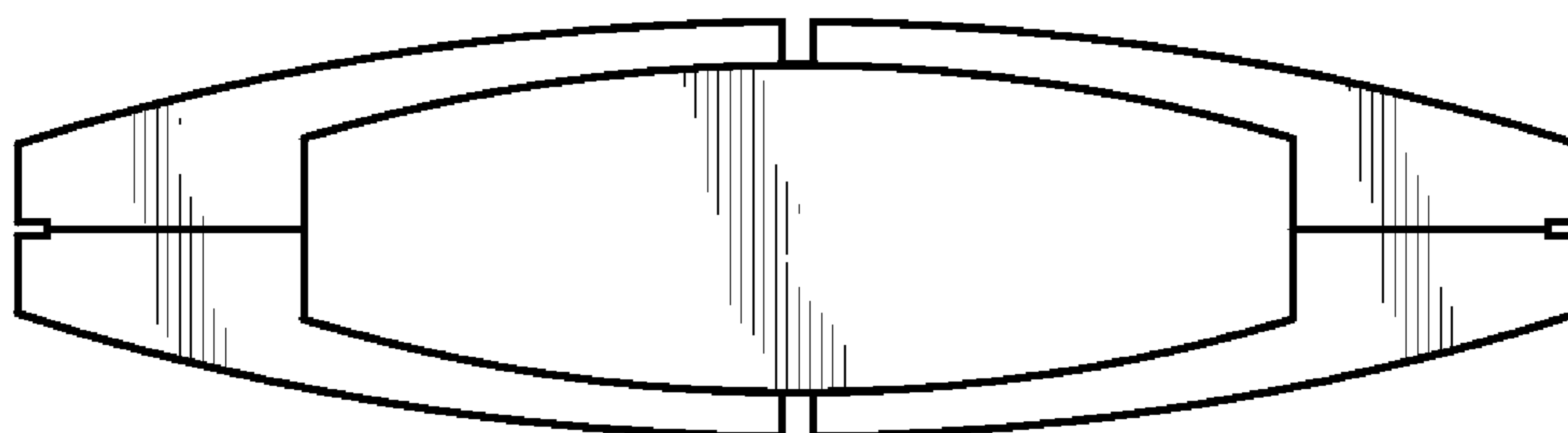
