The ornamental design for a handpiece for a dermatological optical delivery system, as shown and described.

**DESCRIPTION**

FIG. 4 is a rear view thereof;

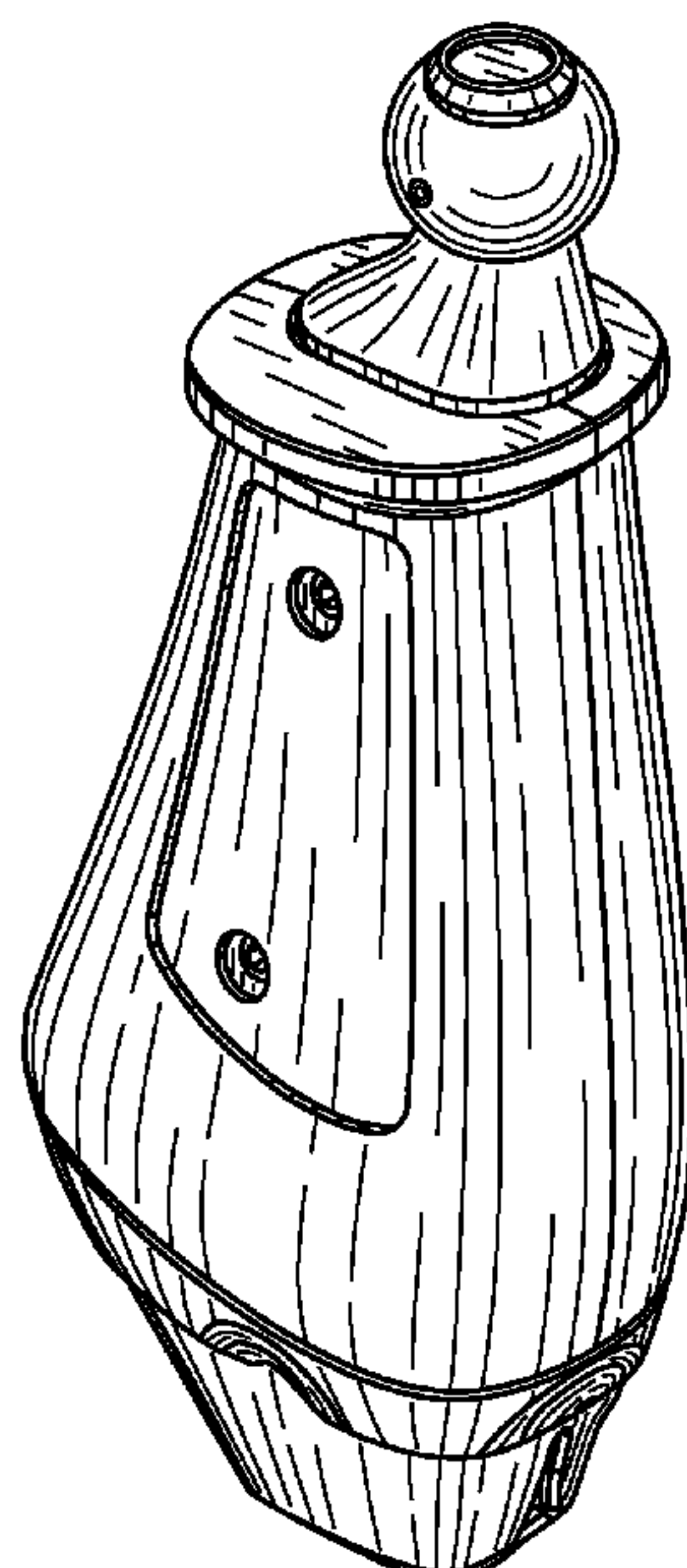
FIG. 5 is a right side view thereof;

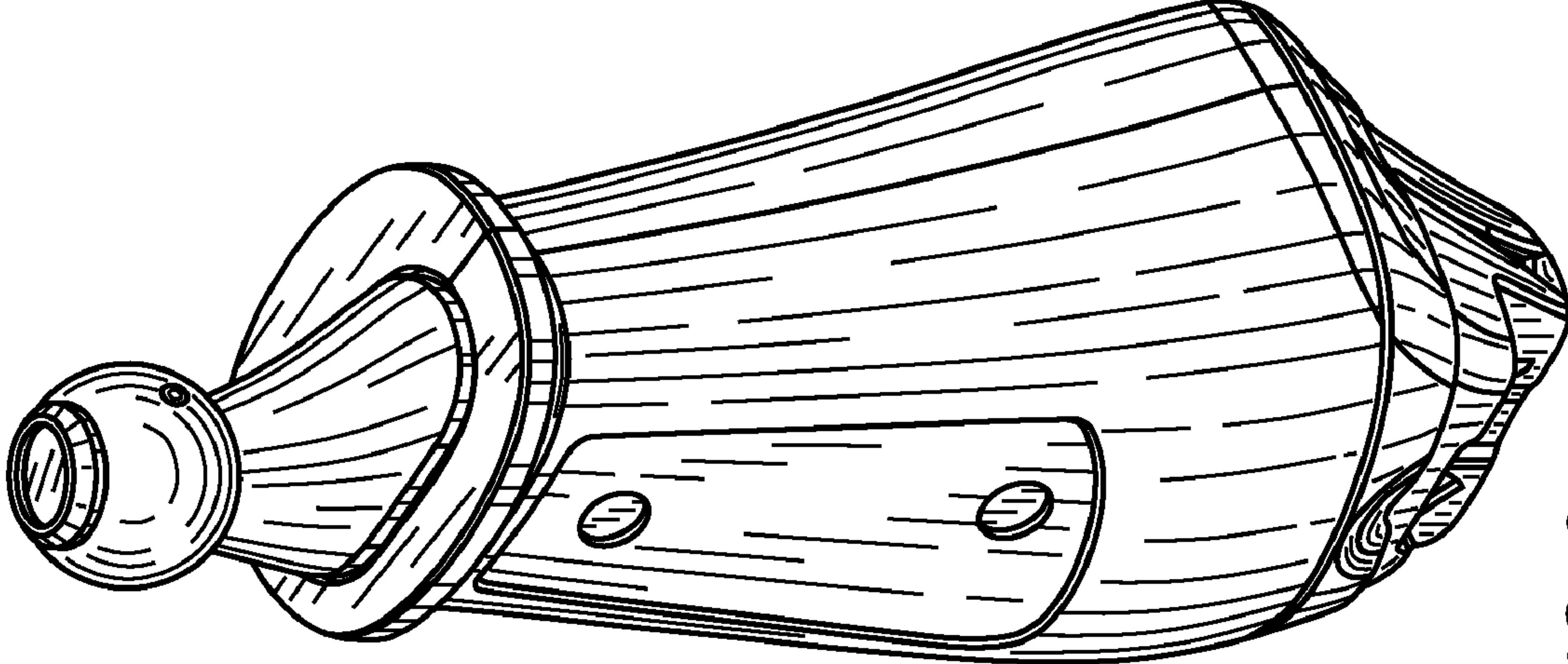

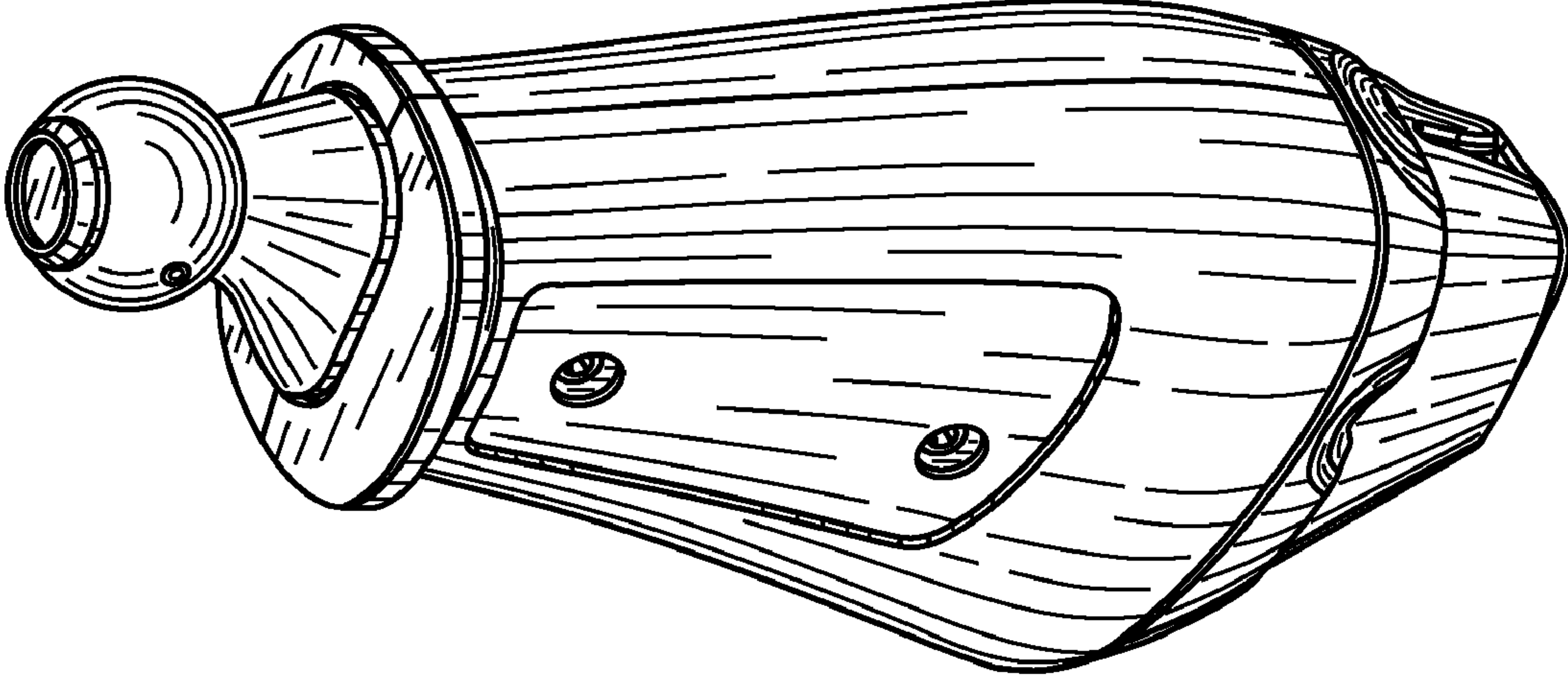

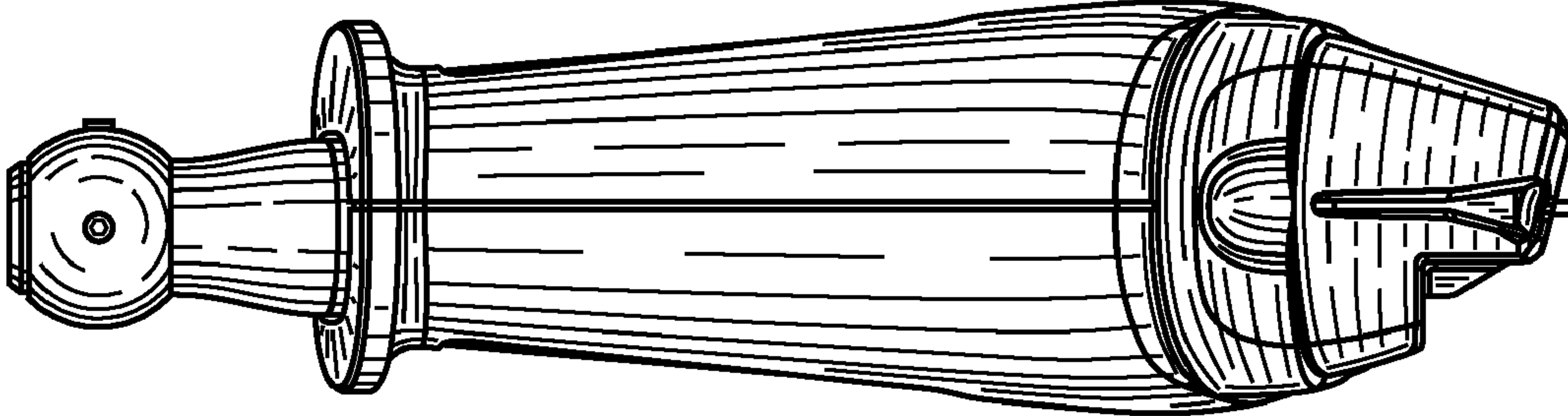

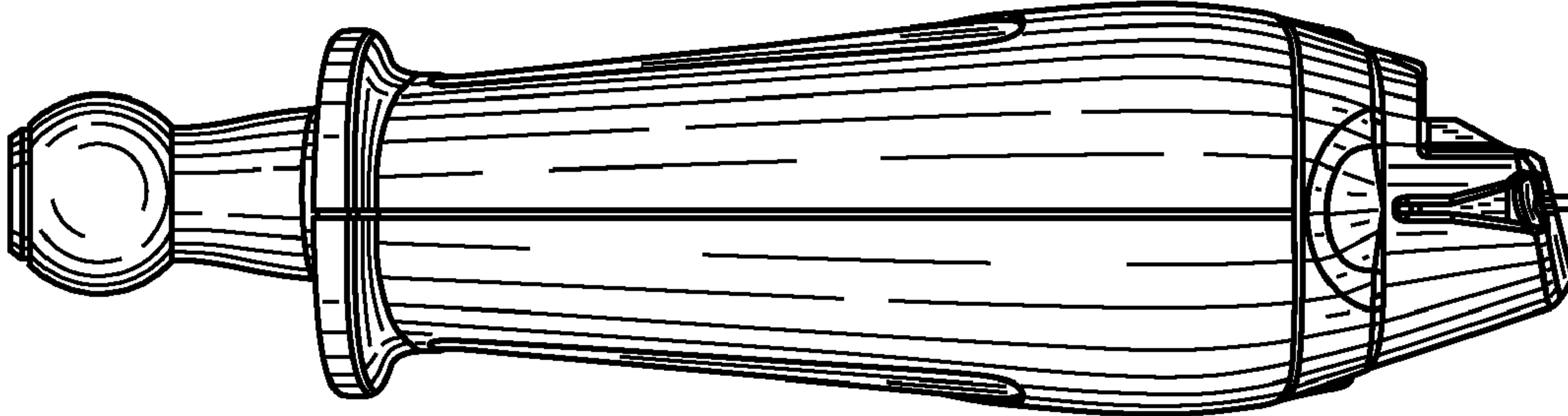

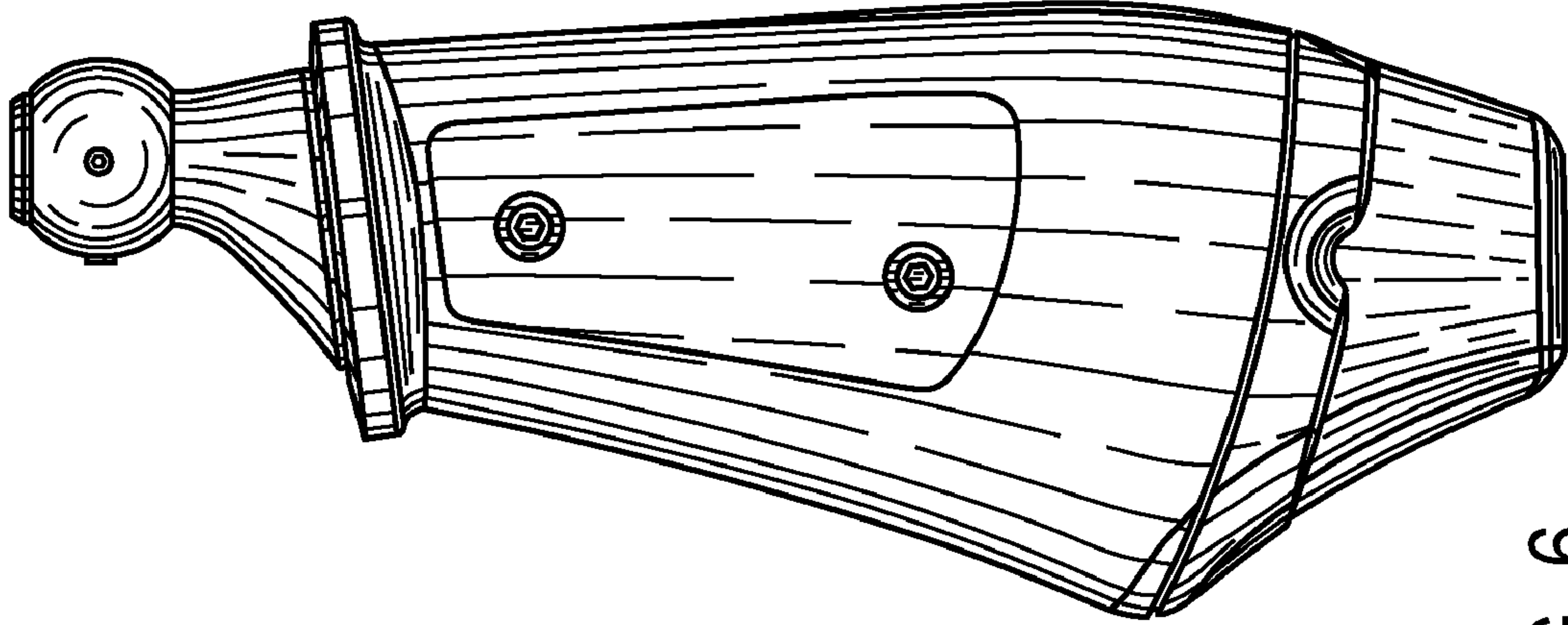

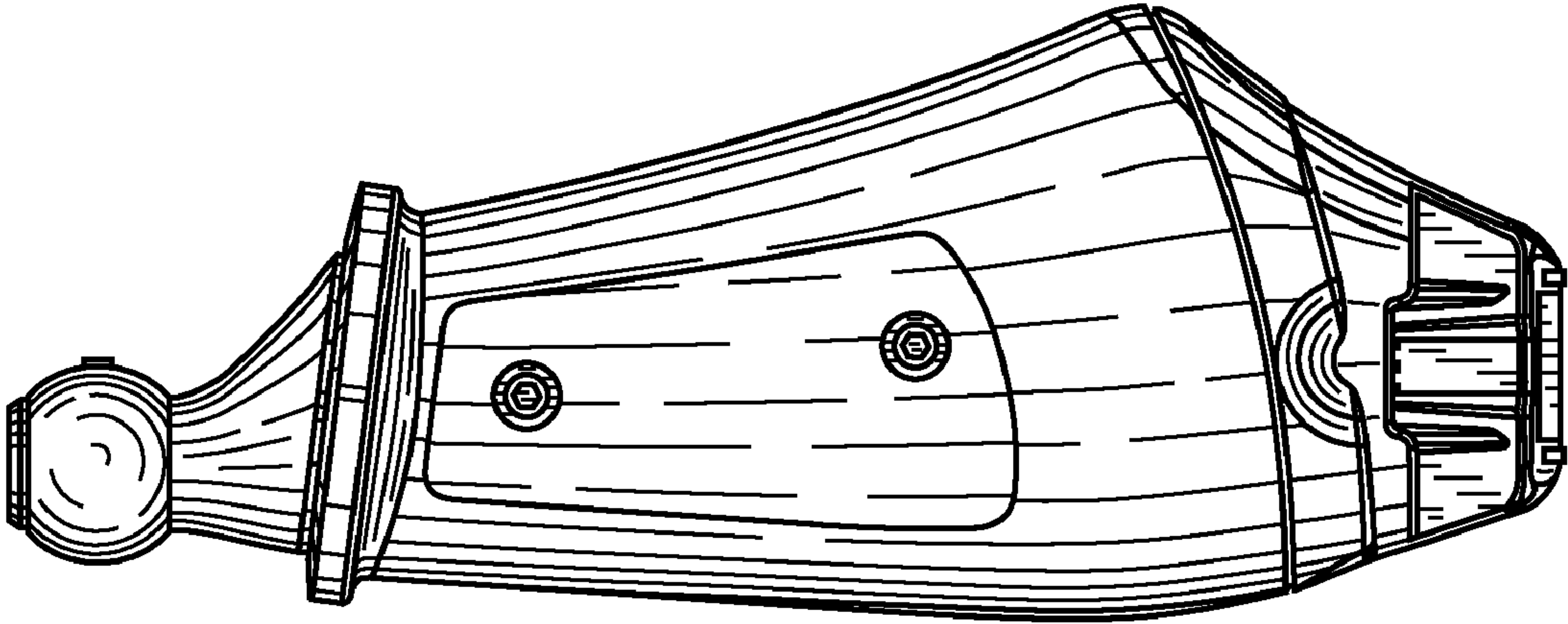

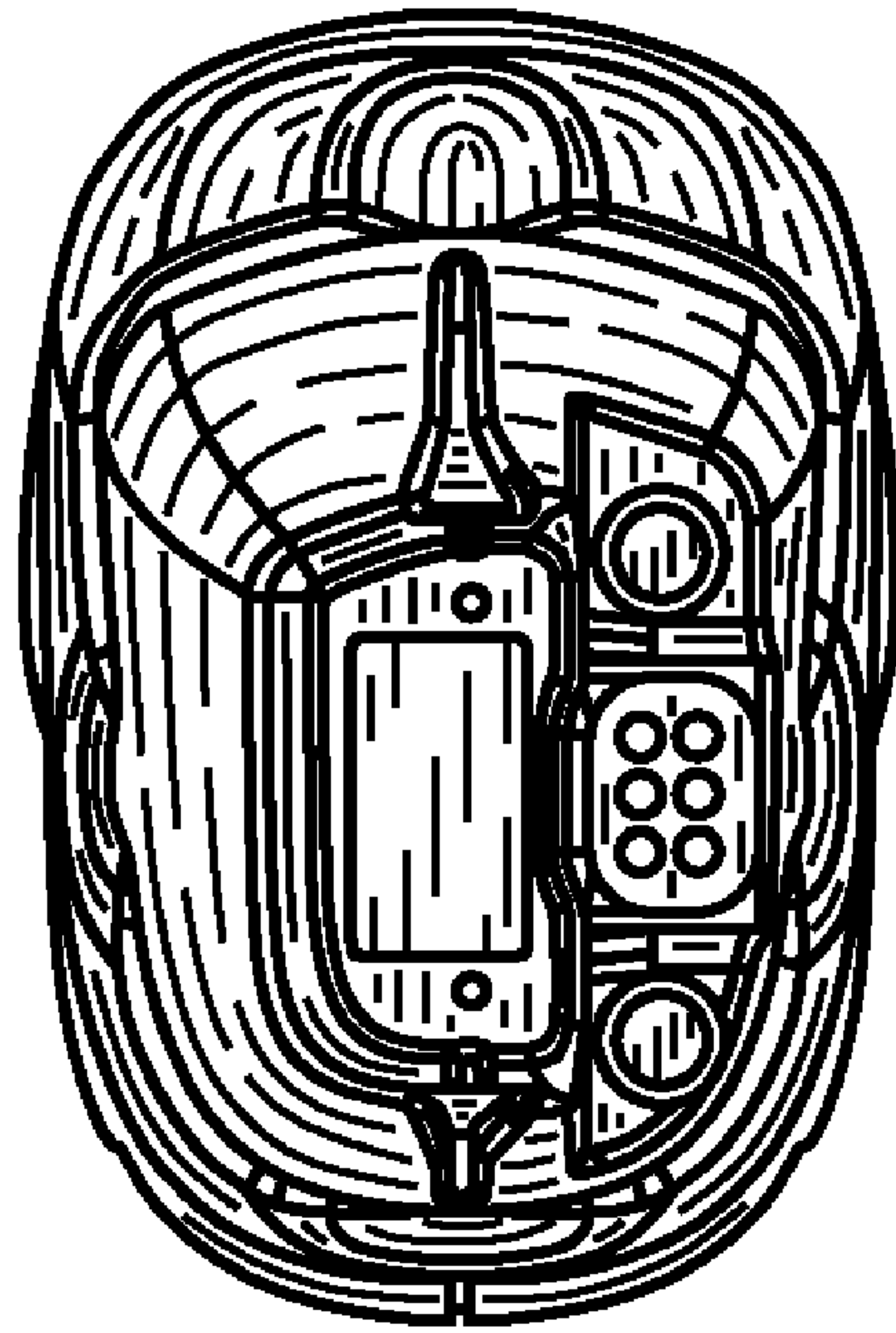

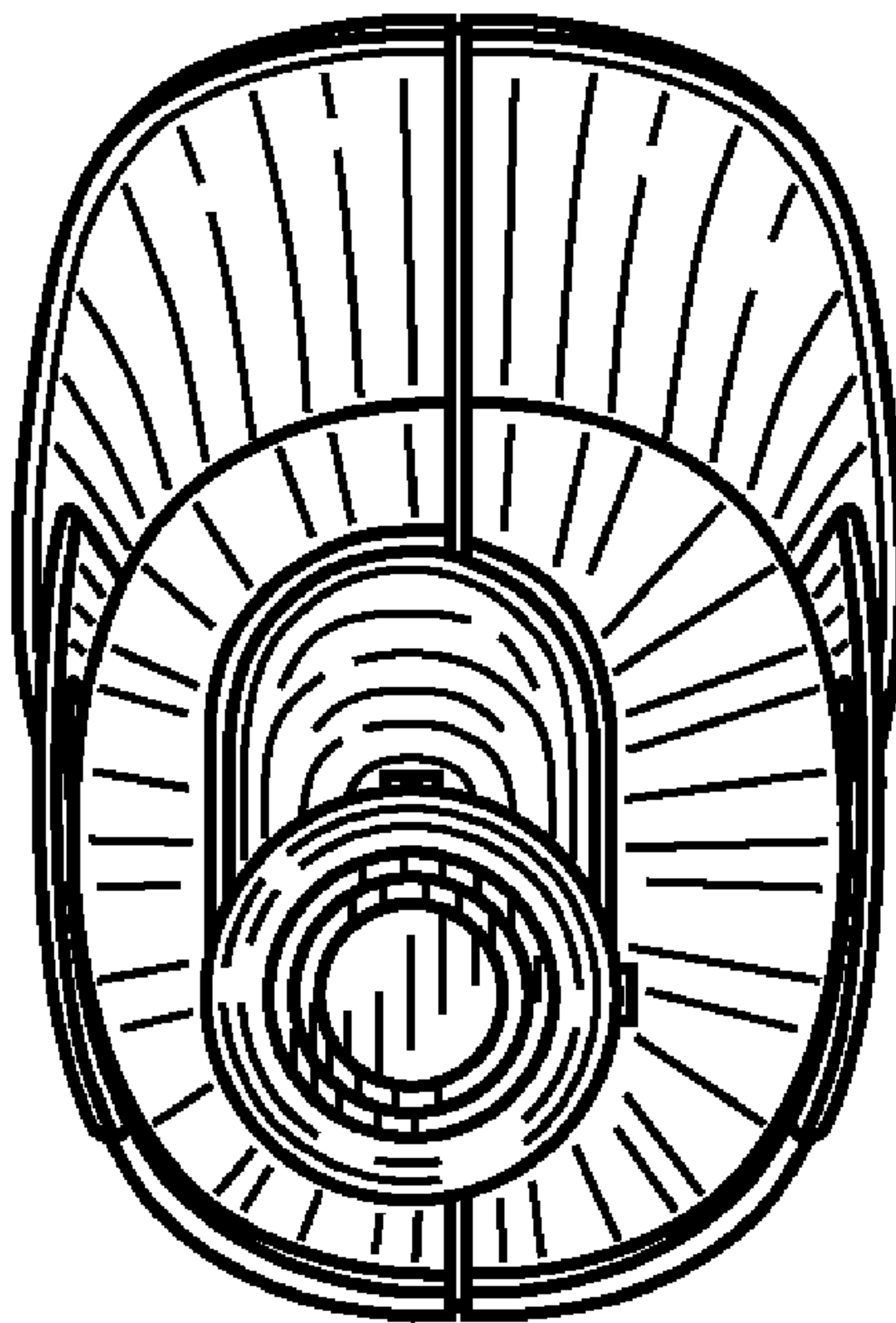
