FIG. 3 is a rotated side view of the dental implant of FIG. 1;

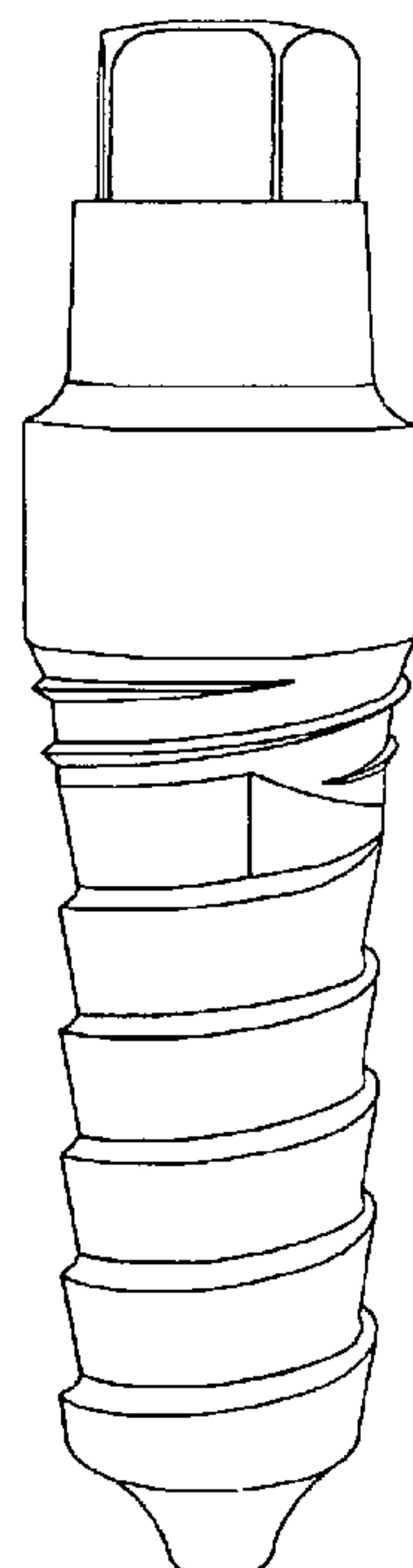
FIG. 4 is a rotated side view of the dental implant of FIG. 1;

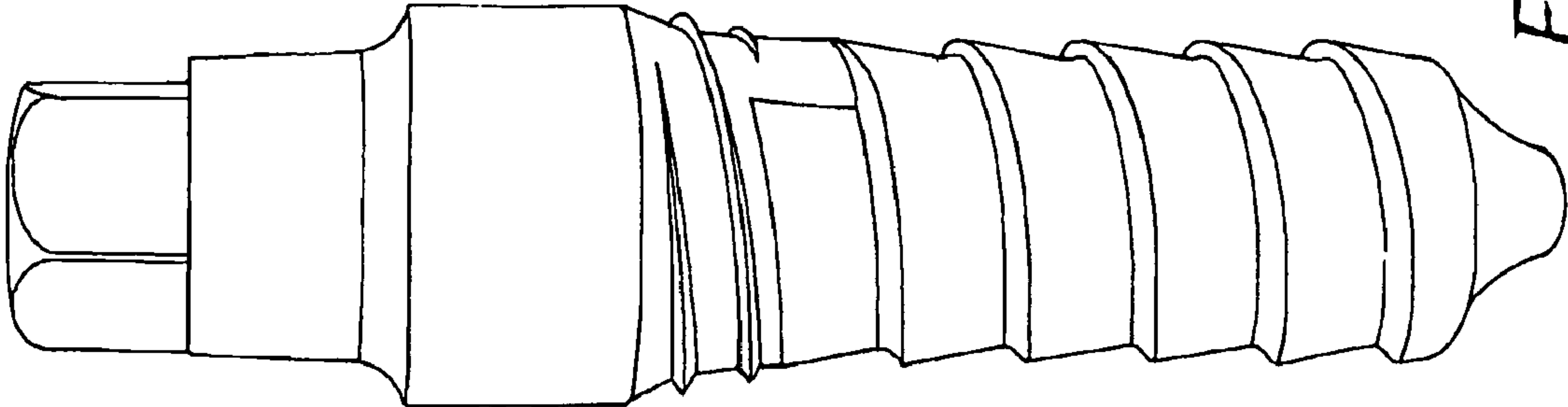

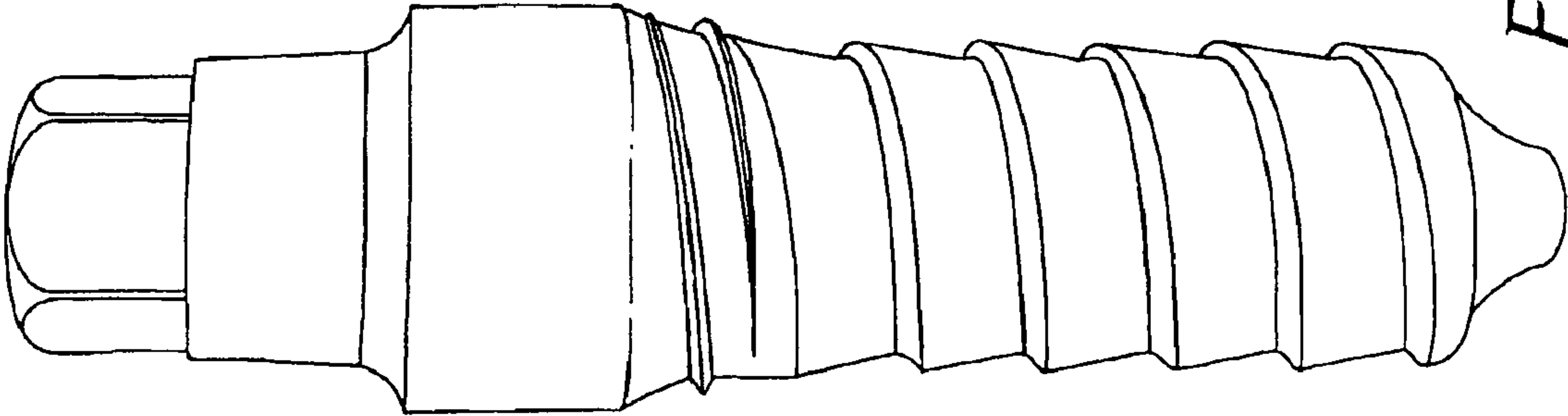

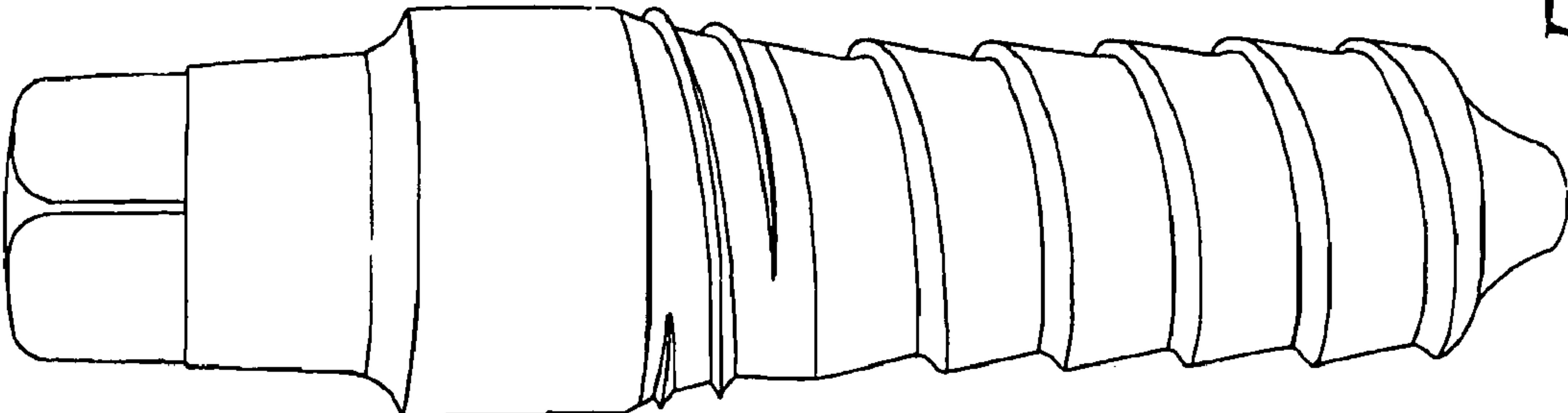

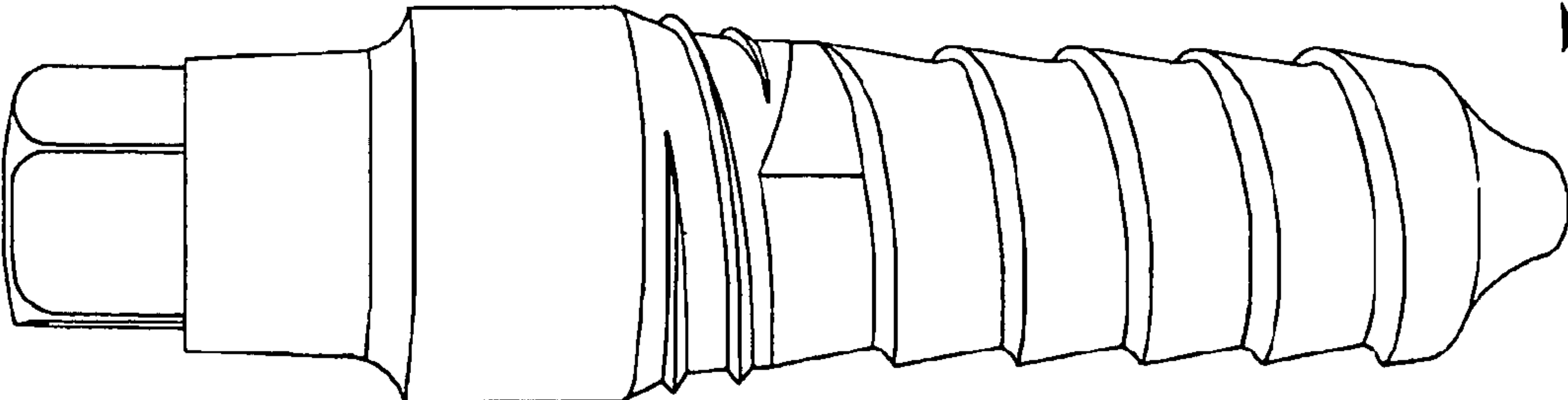

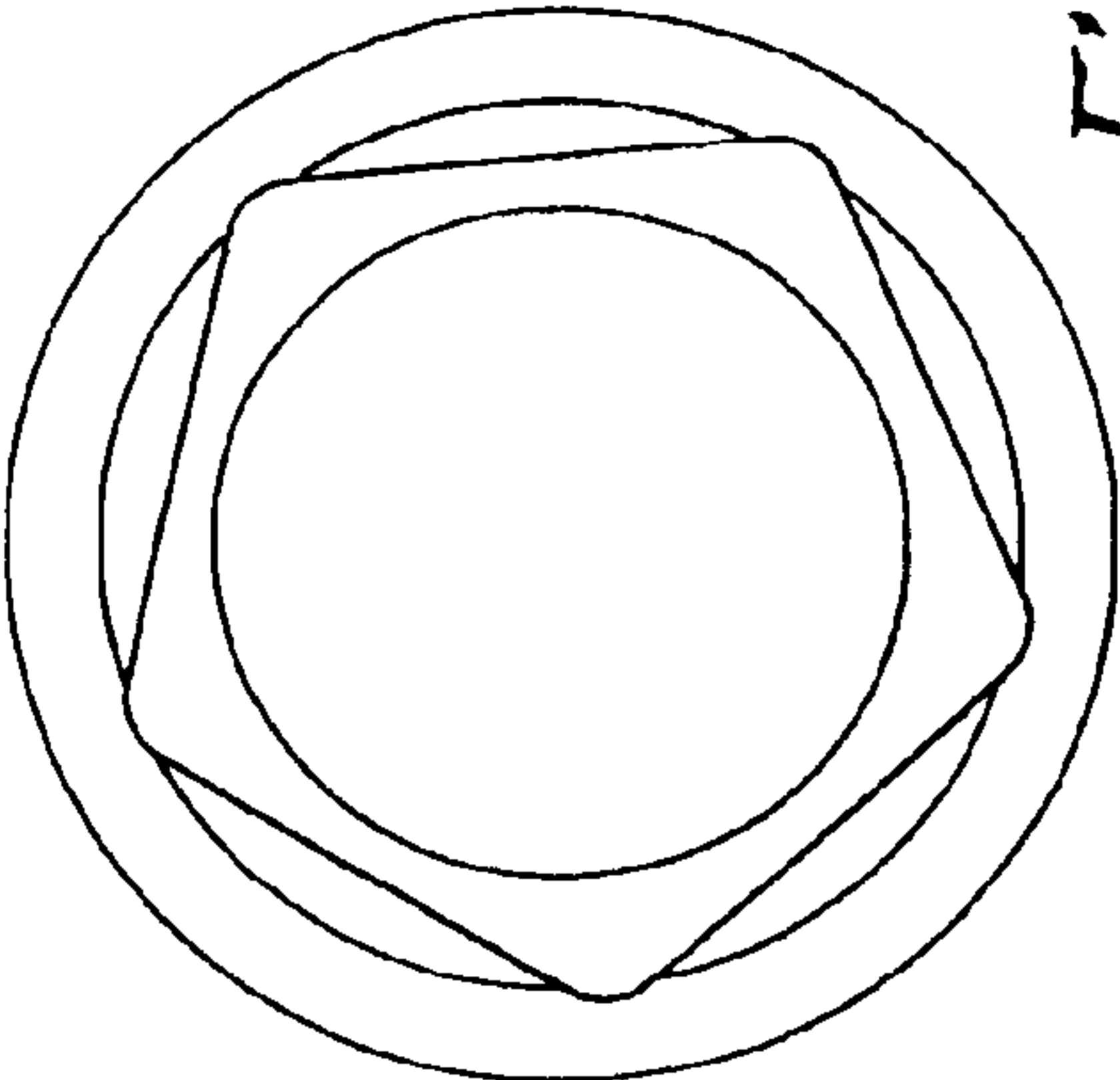

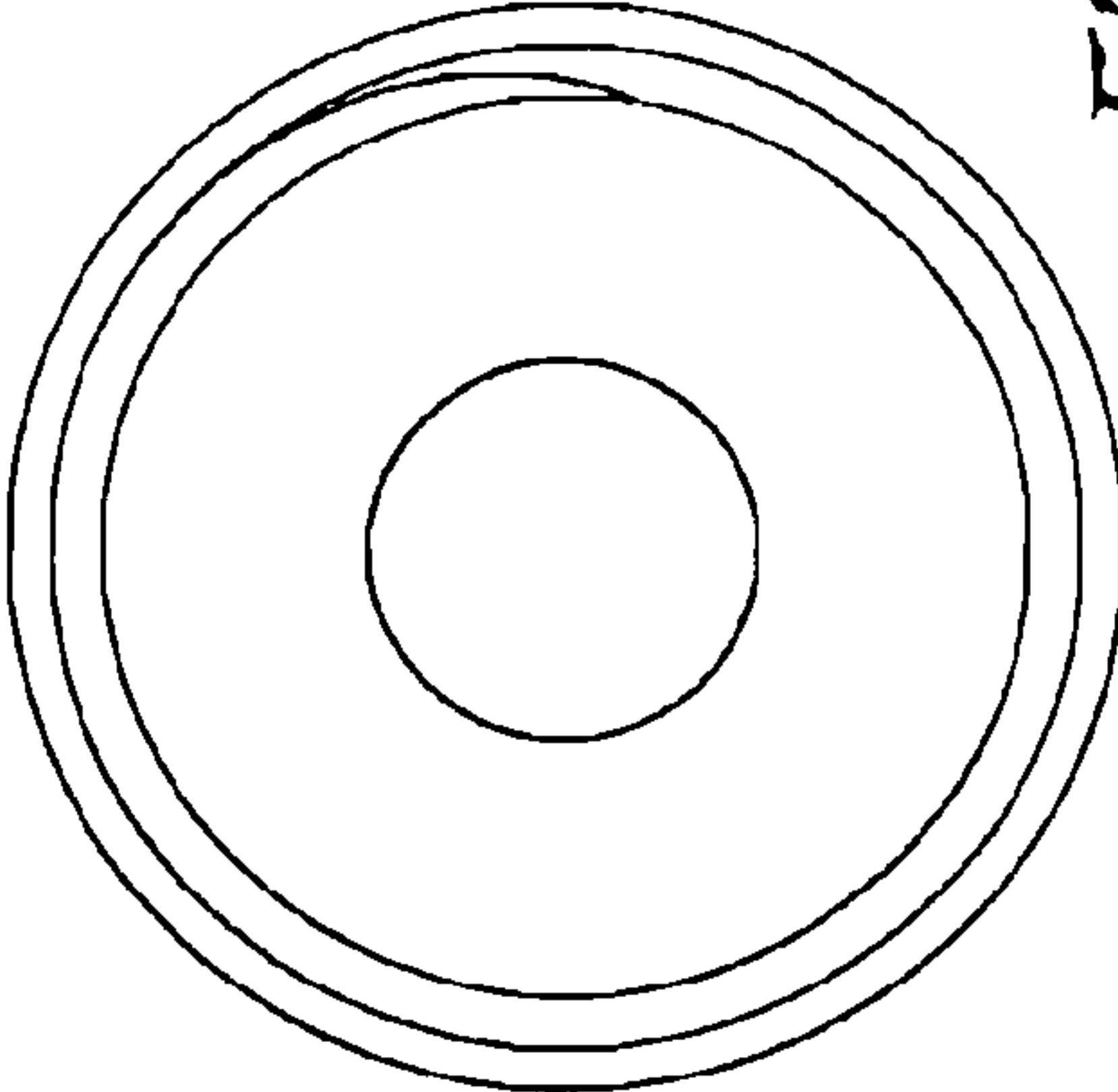

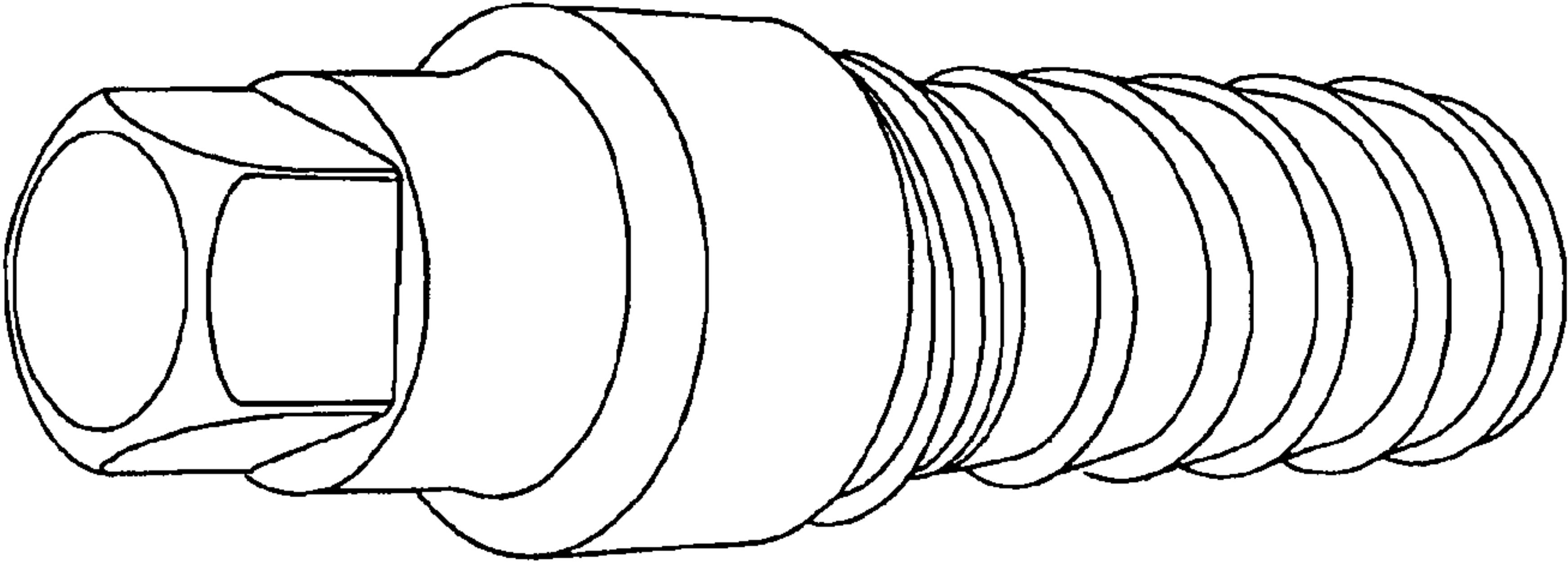
