The ornamental design for a curved bottom bandage, as shown and described.

FIG. 4 is a rear elevational view of FIG. 3;

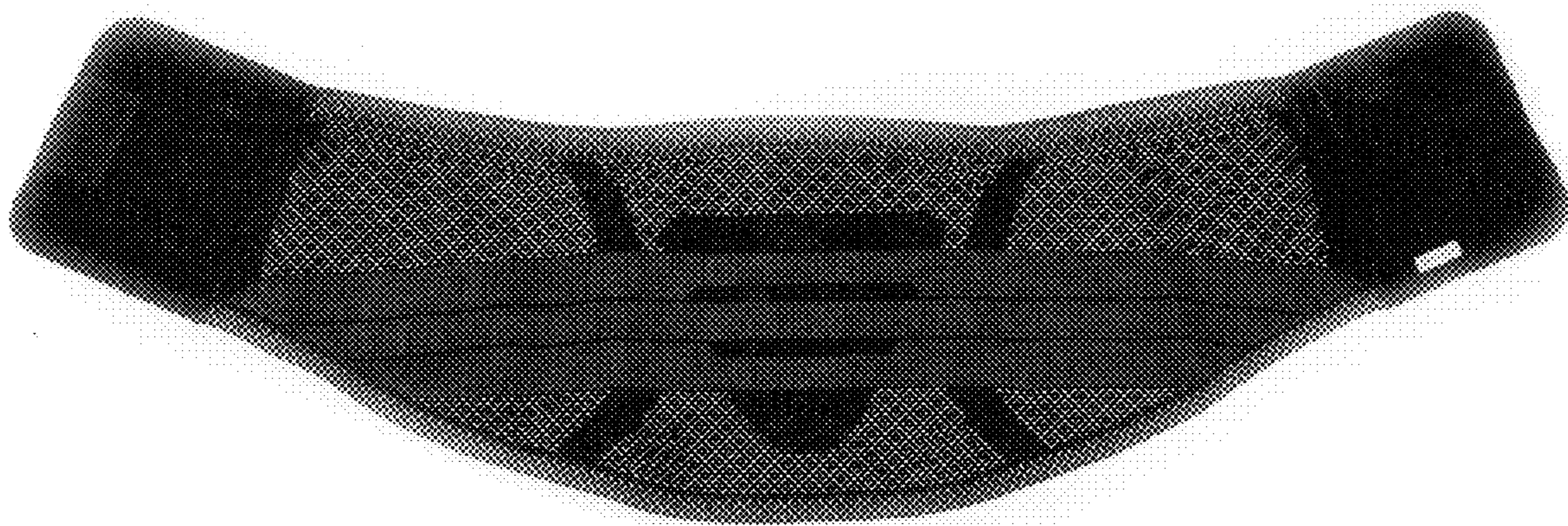
FIG. 5 is a front elevational view of a second embodiment of a curved bottom bandage showing my new design, wherein the curved bottom bandage is laid flat;

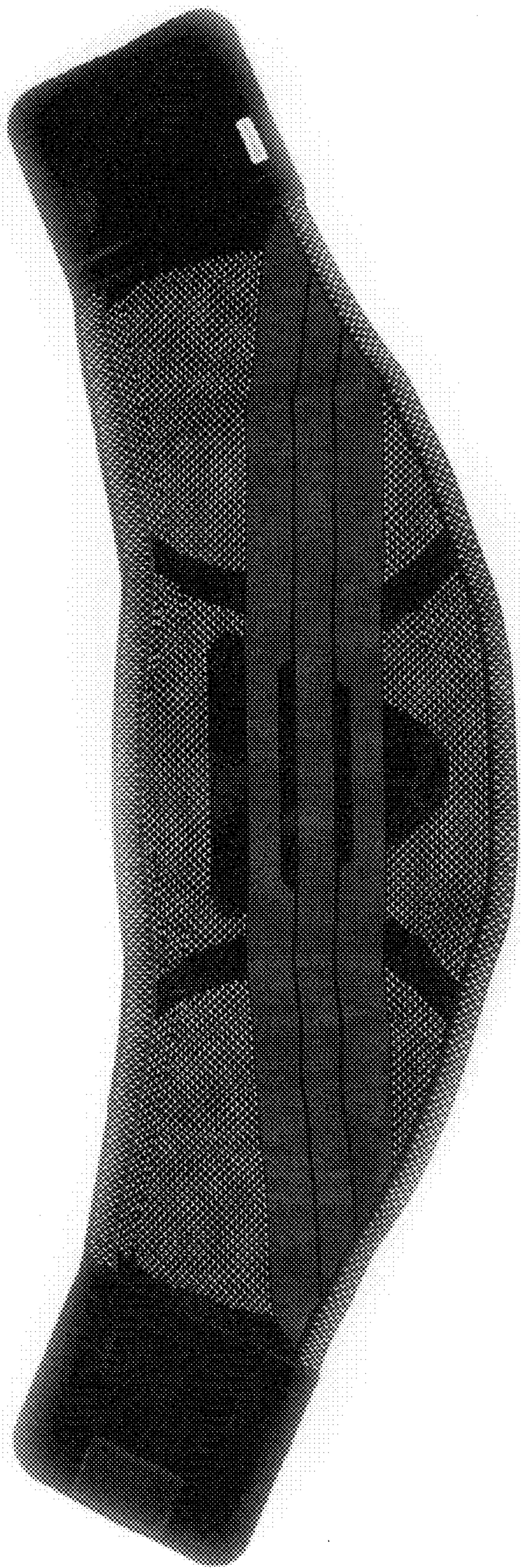

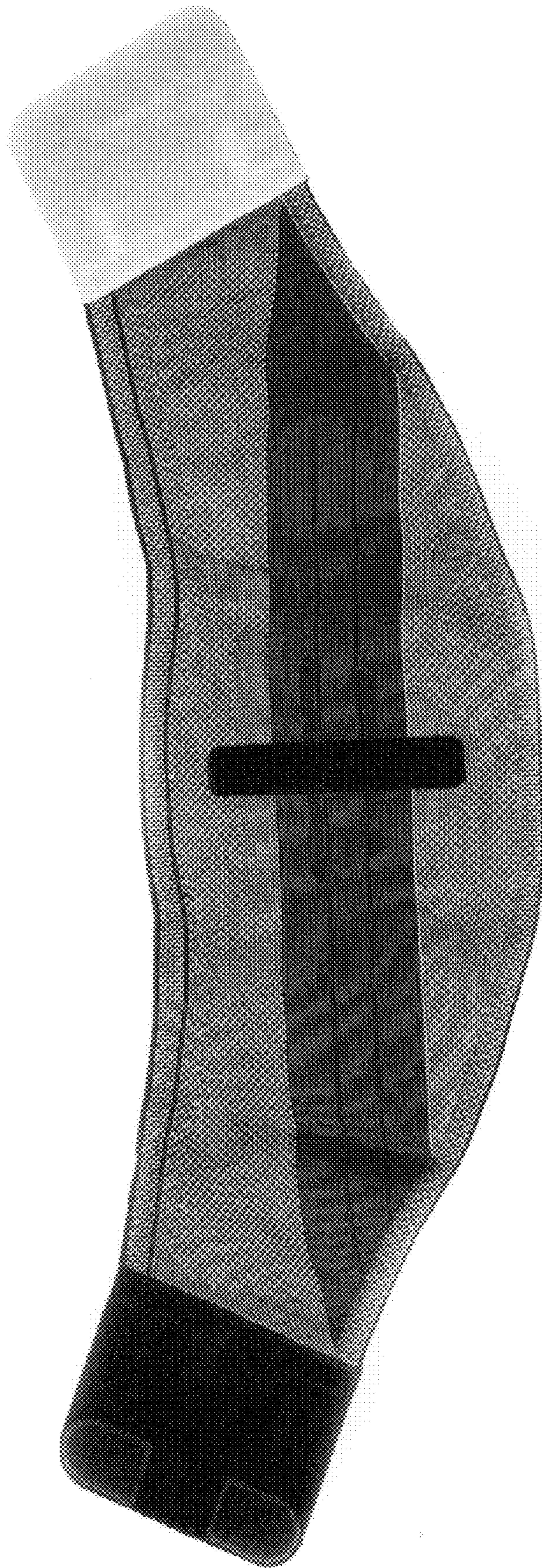

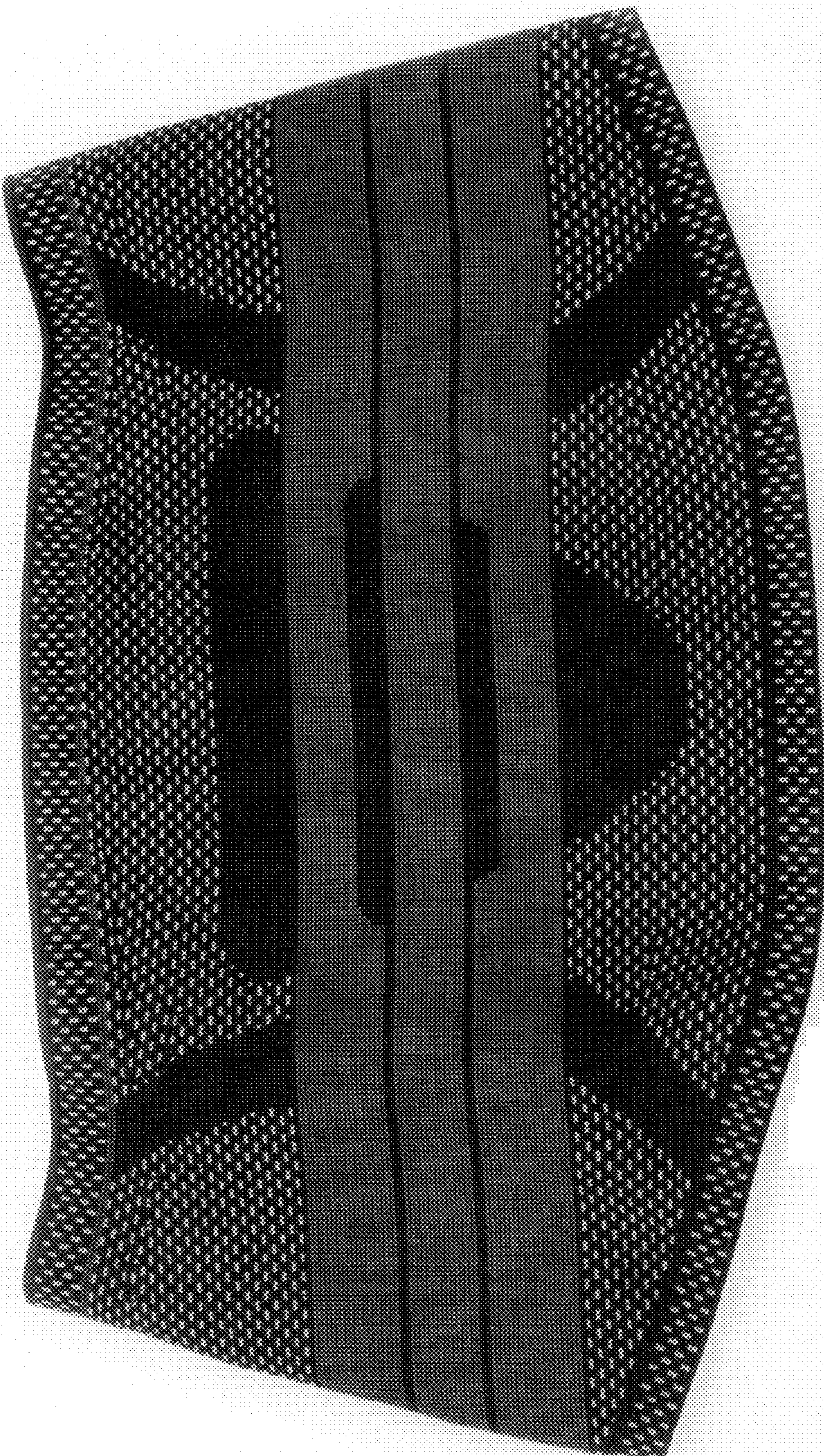

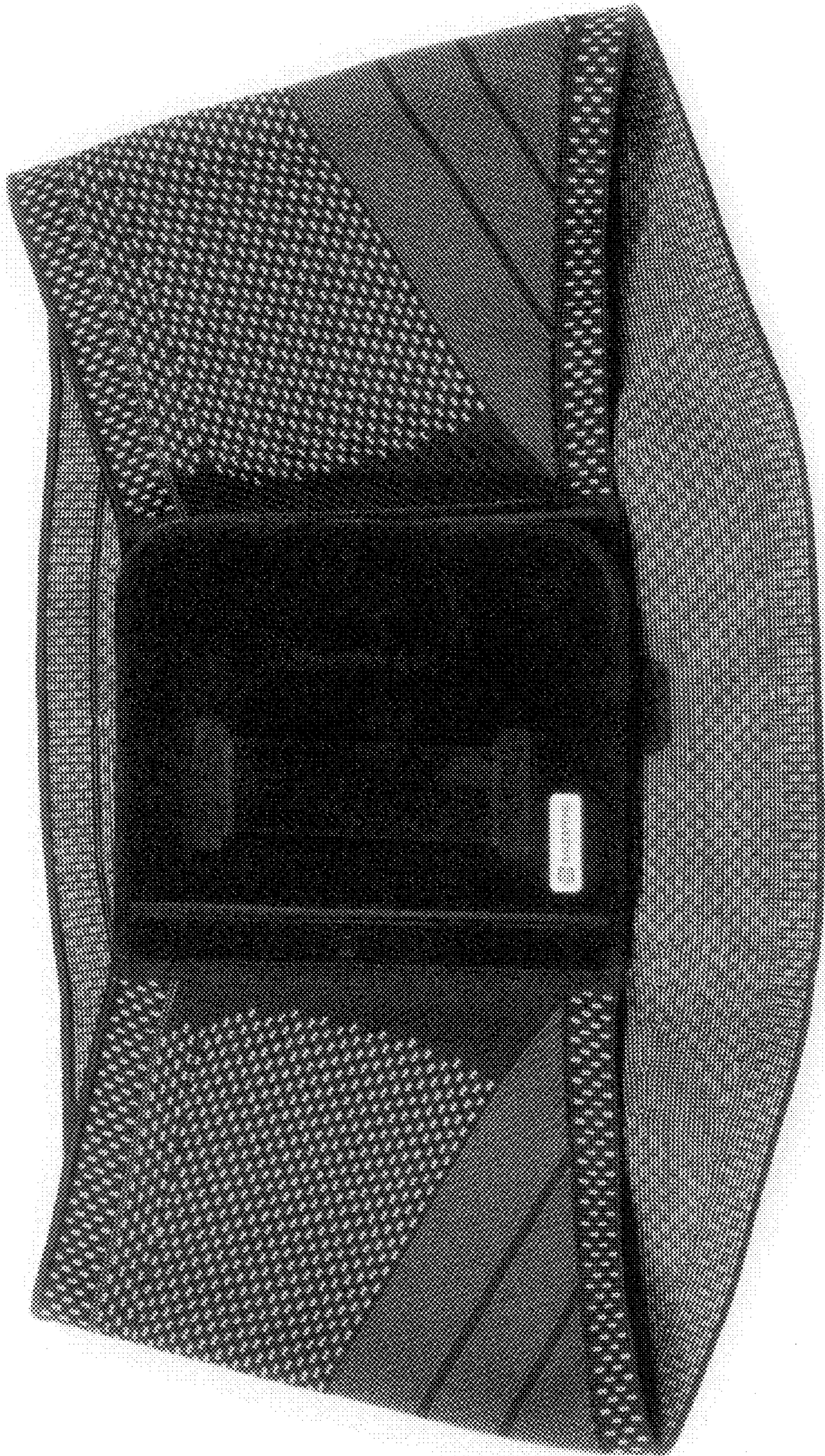

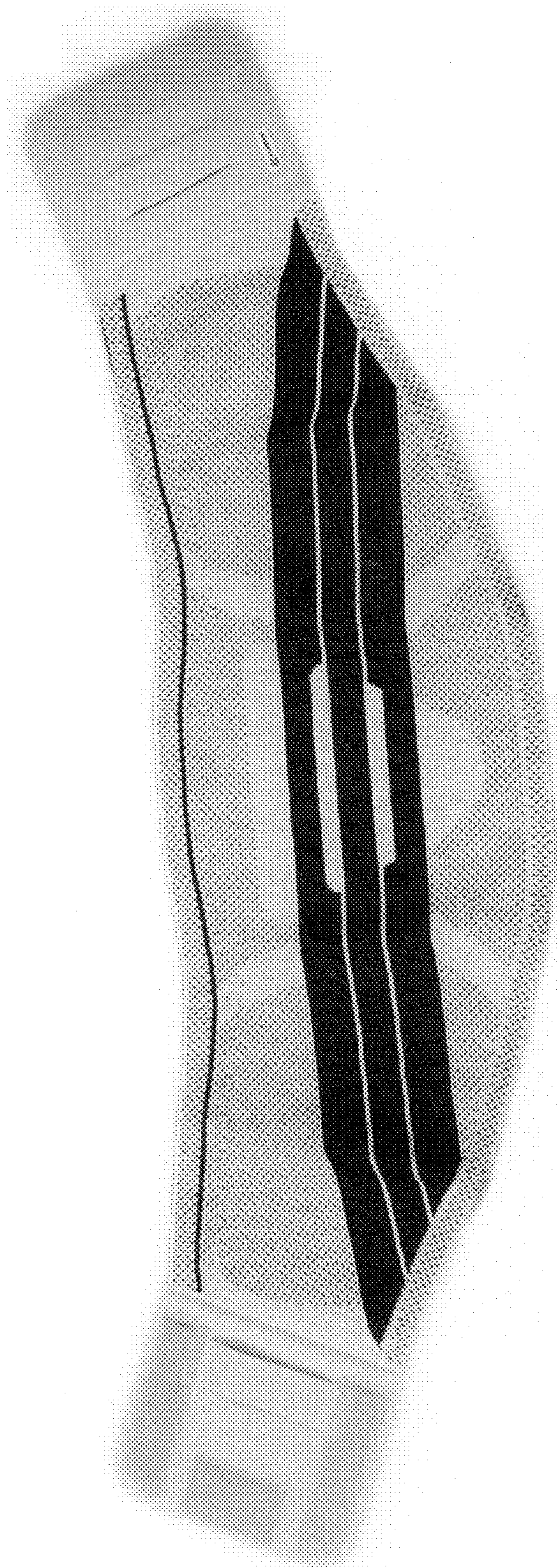

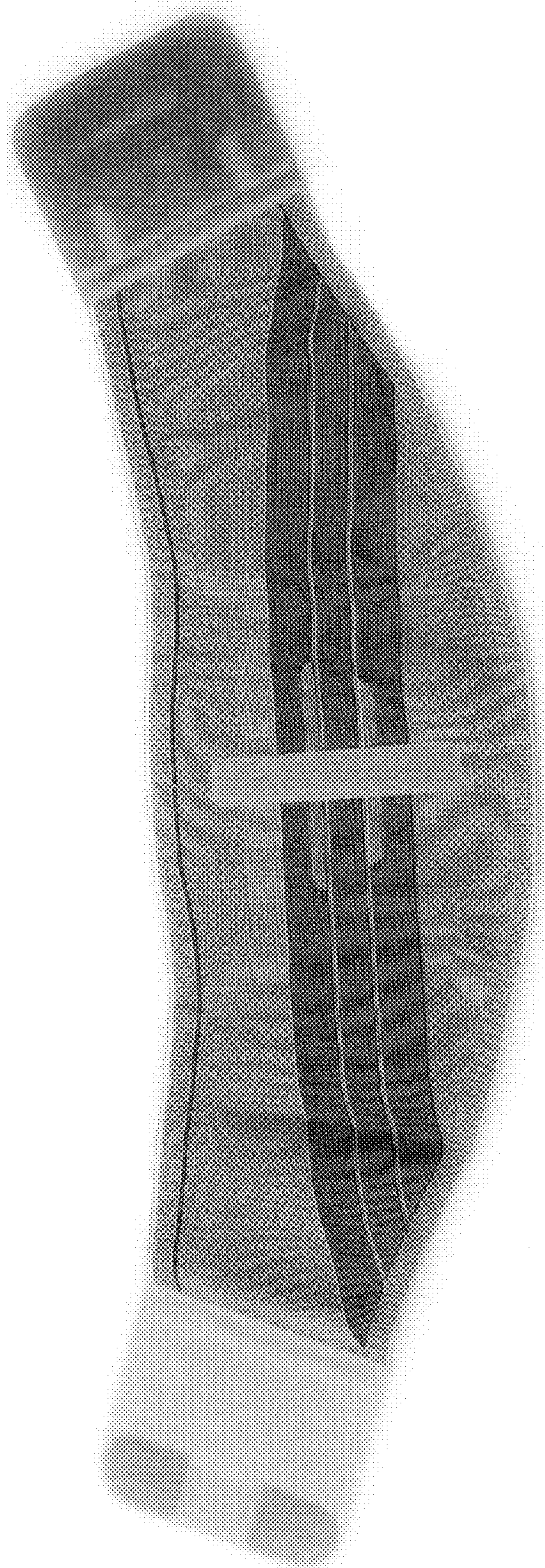

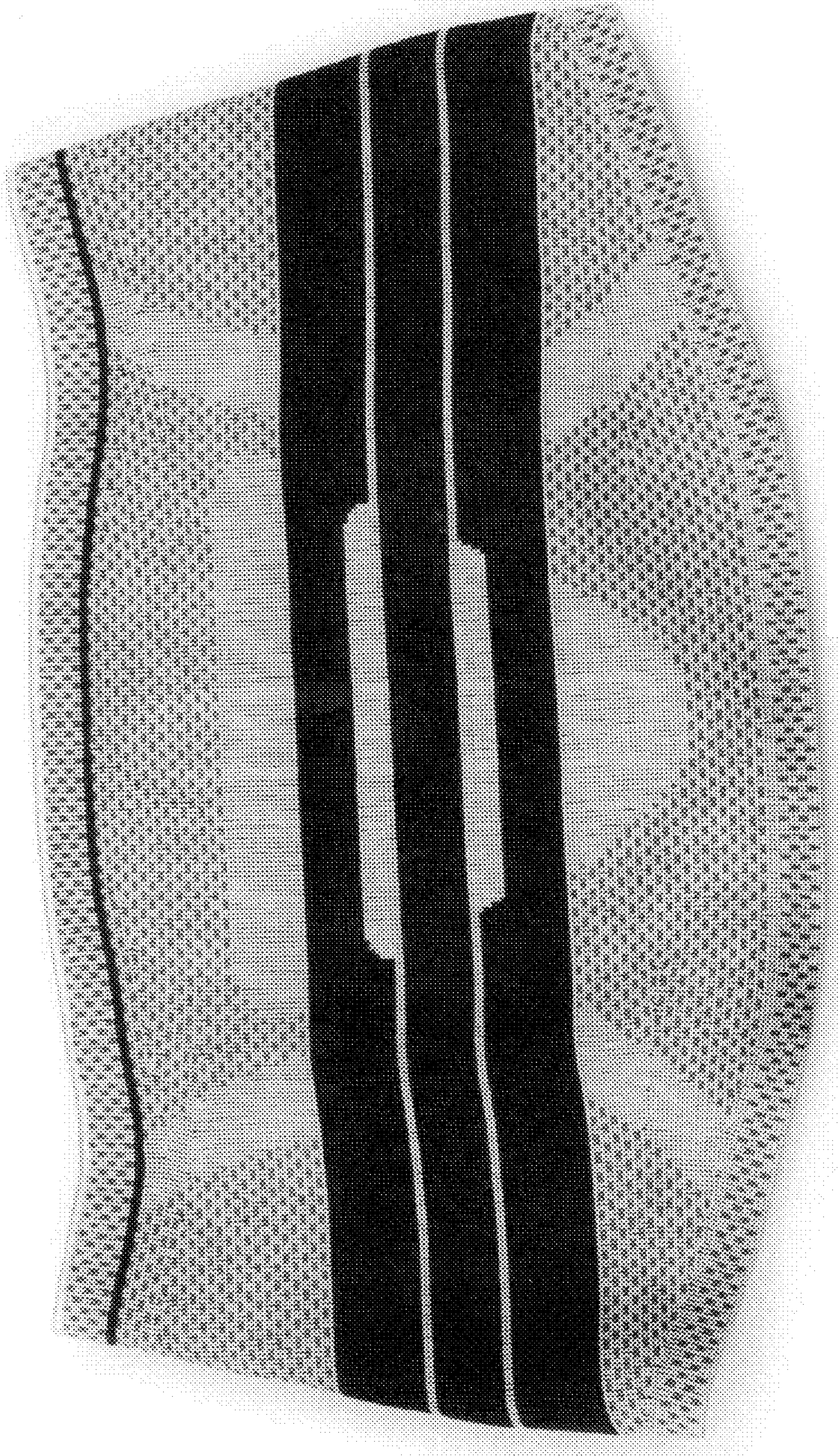

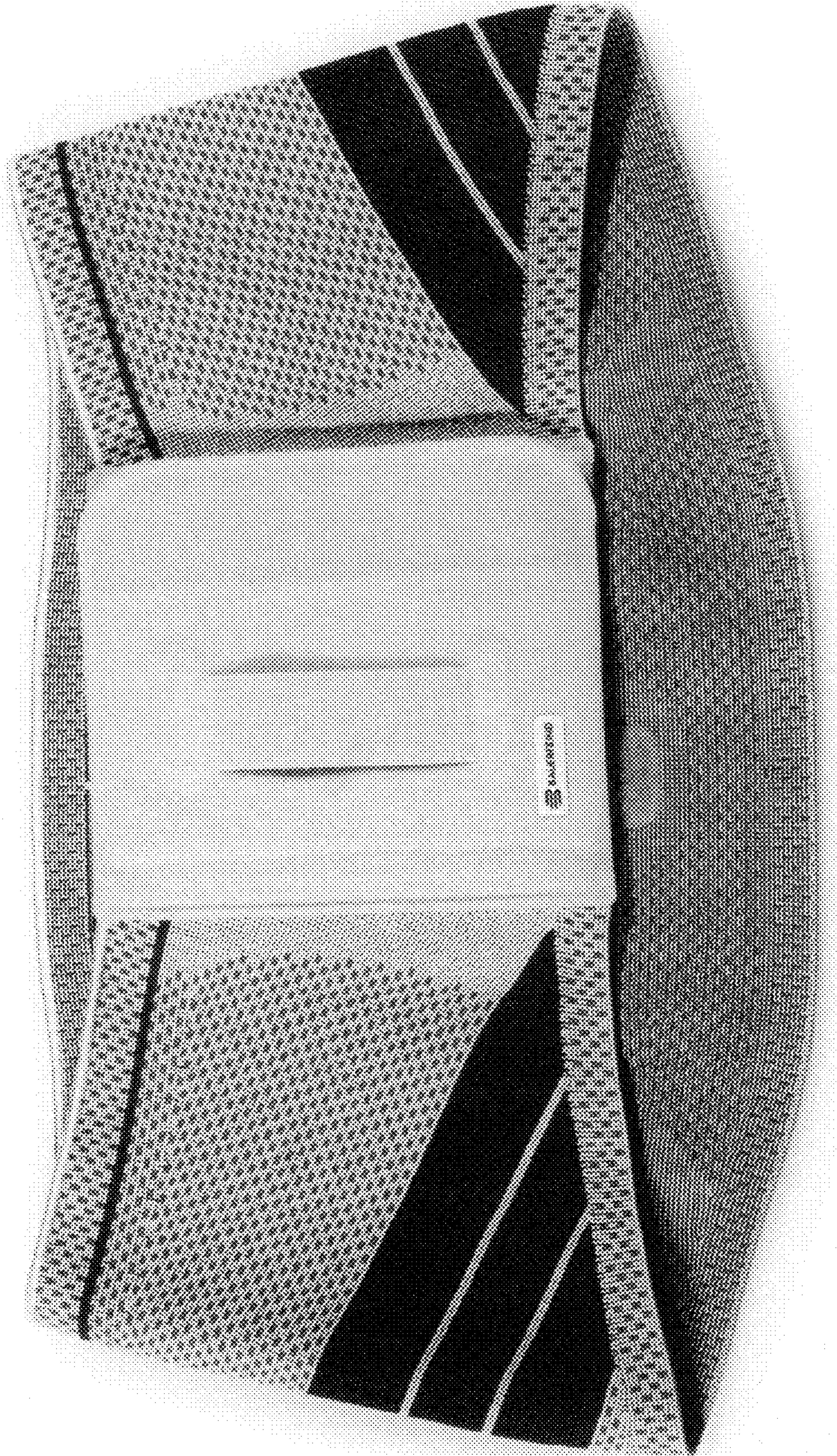
