FIG. 7 is a perspective back view of the embodiment of the invention;

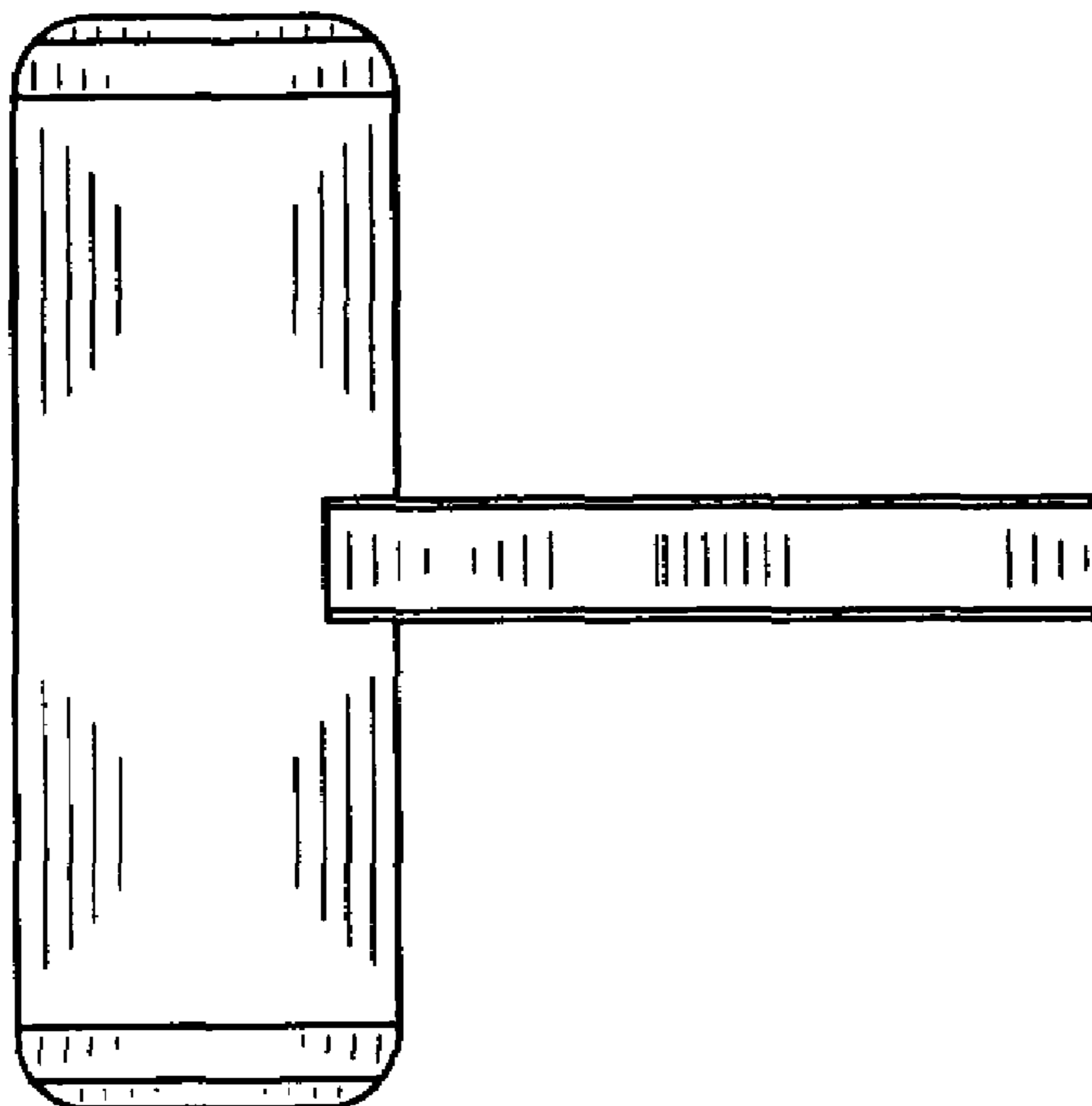
FIG. 8 is a perspective view of the embodiment of the invention;

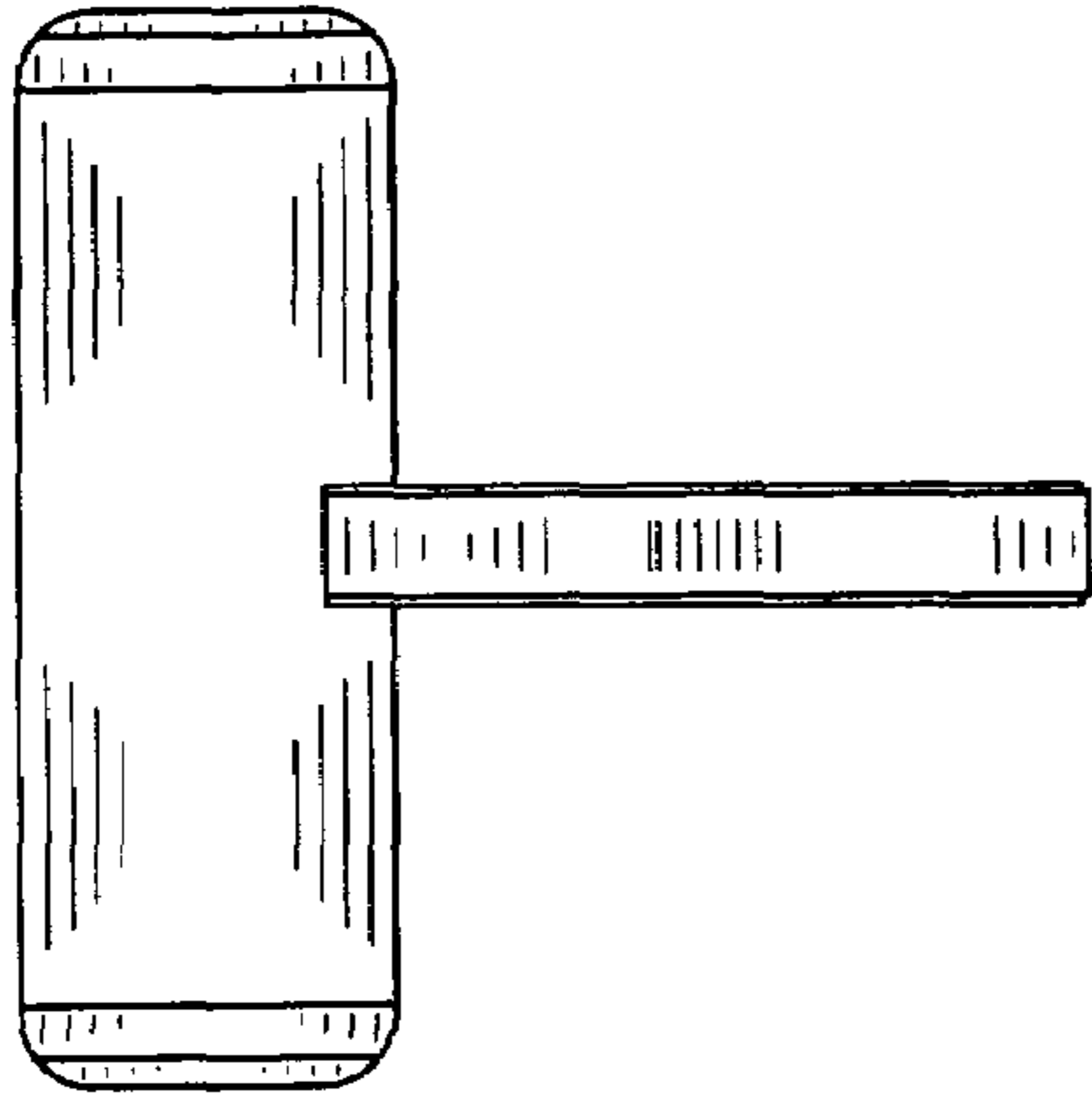

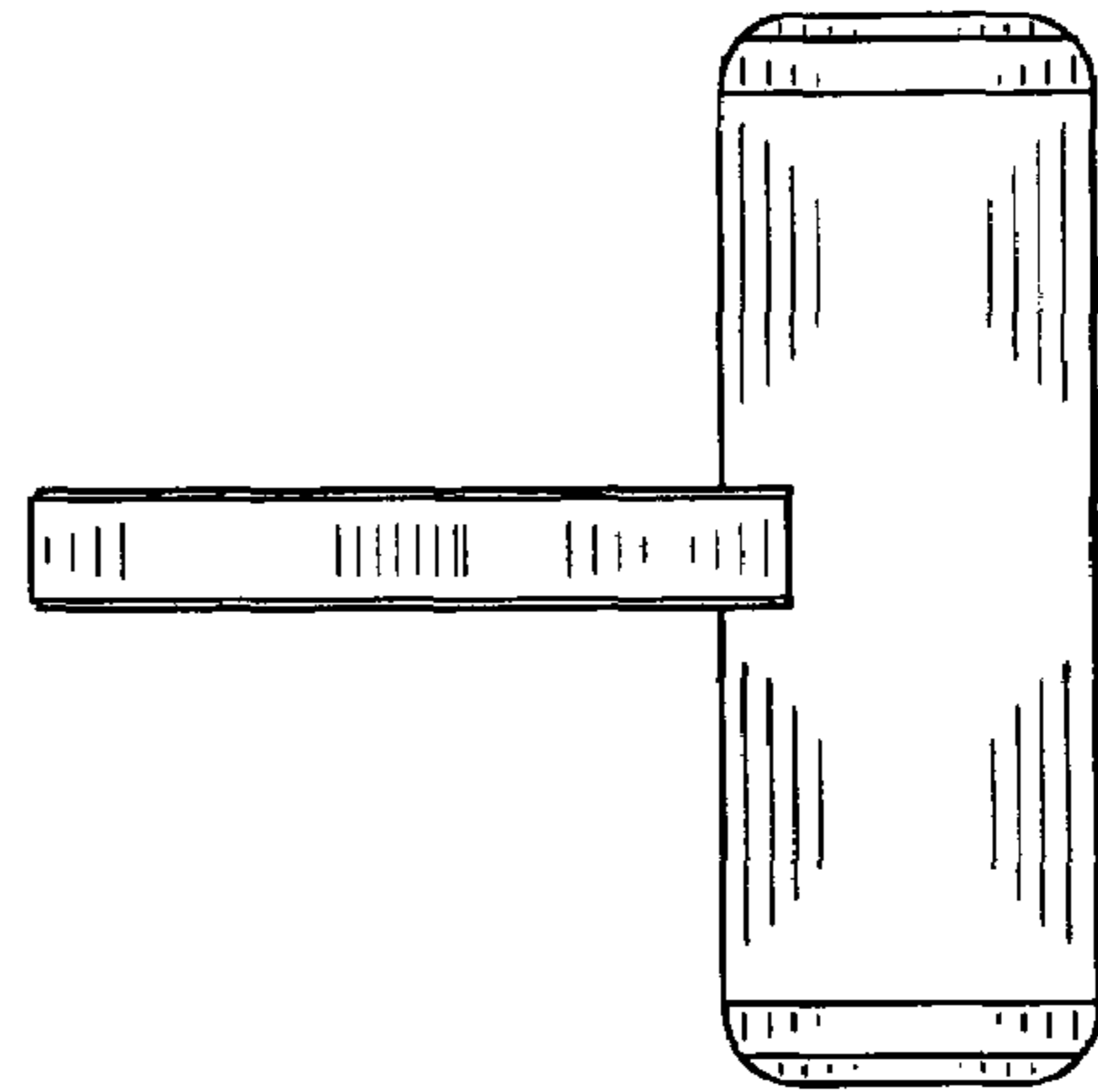

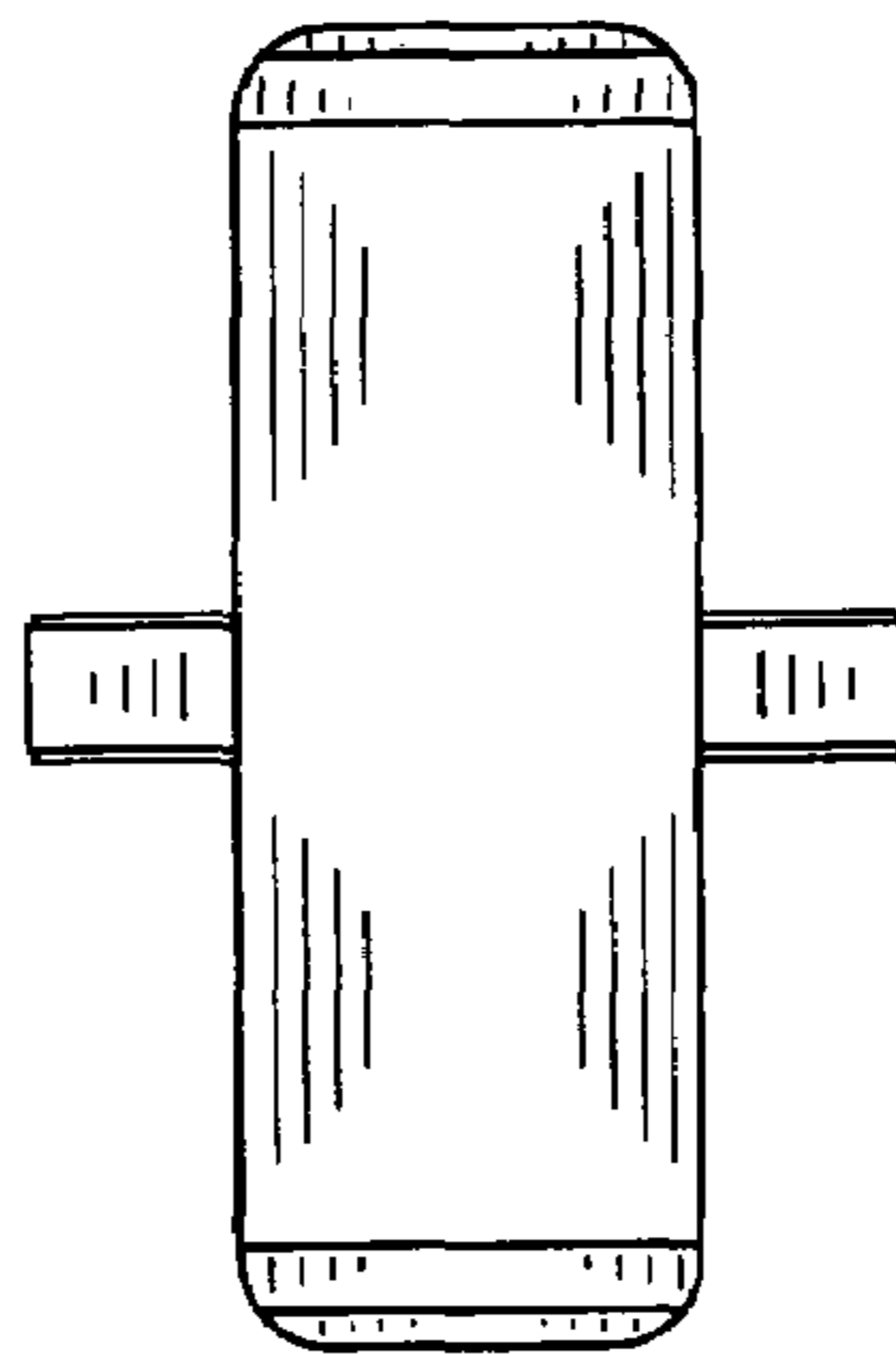

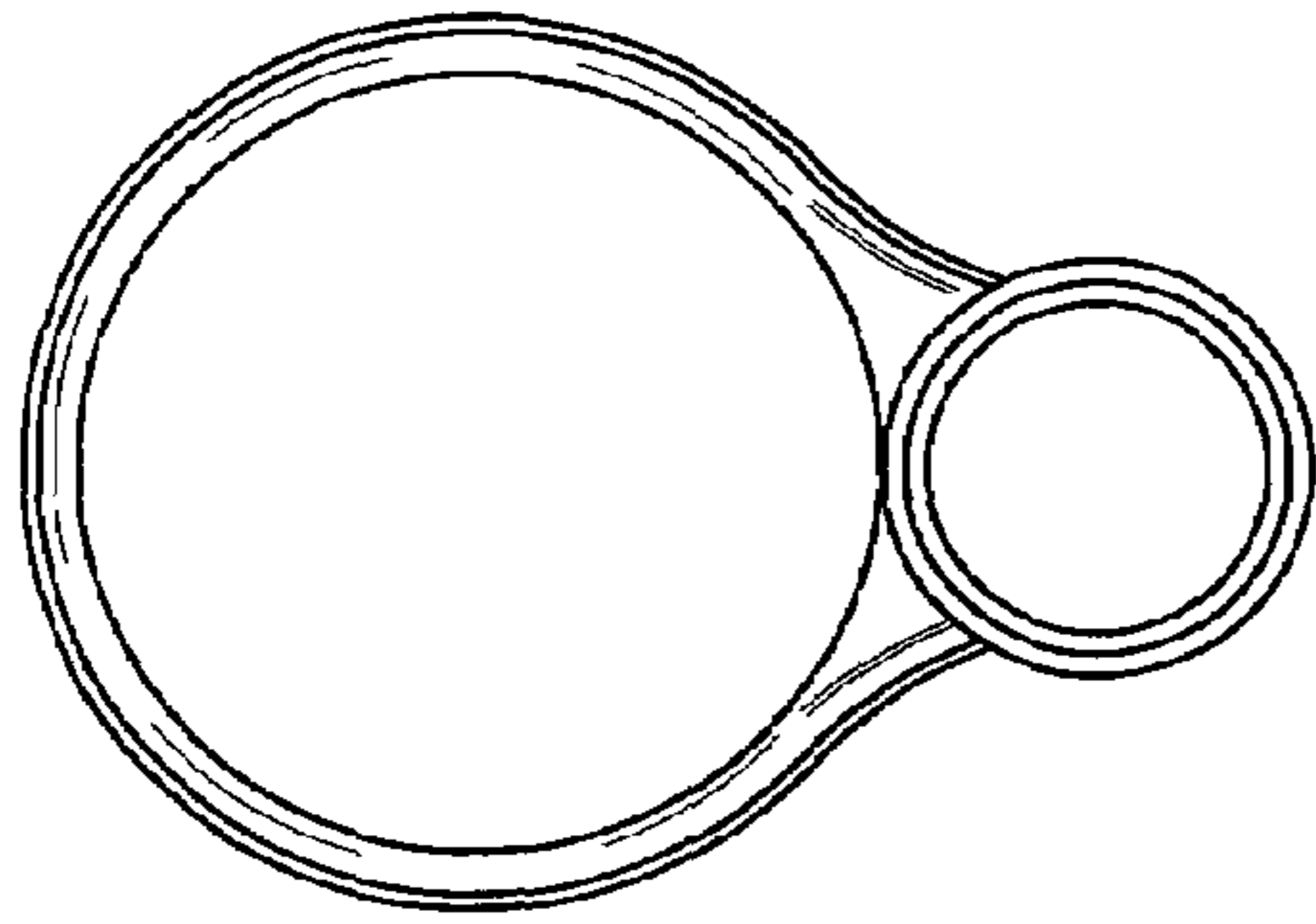

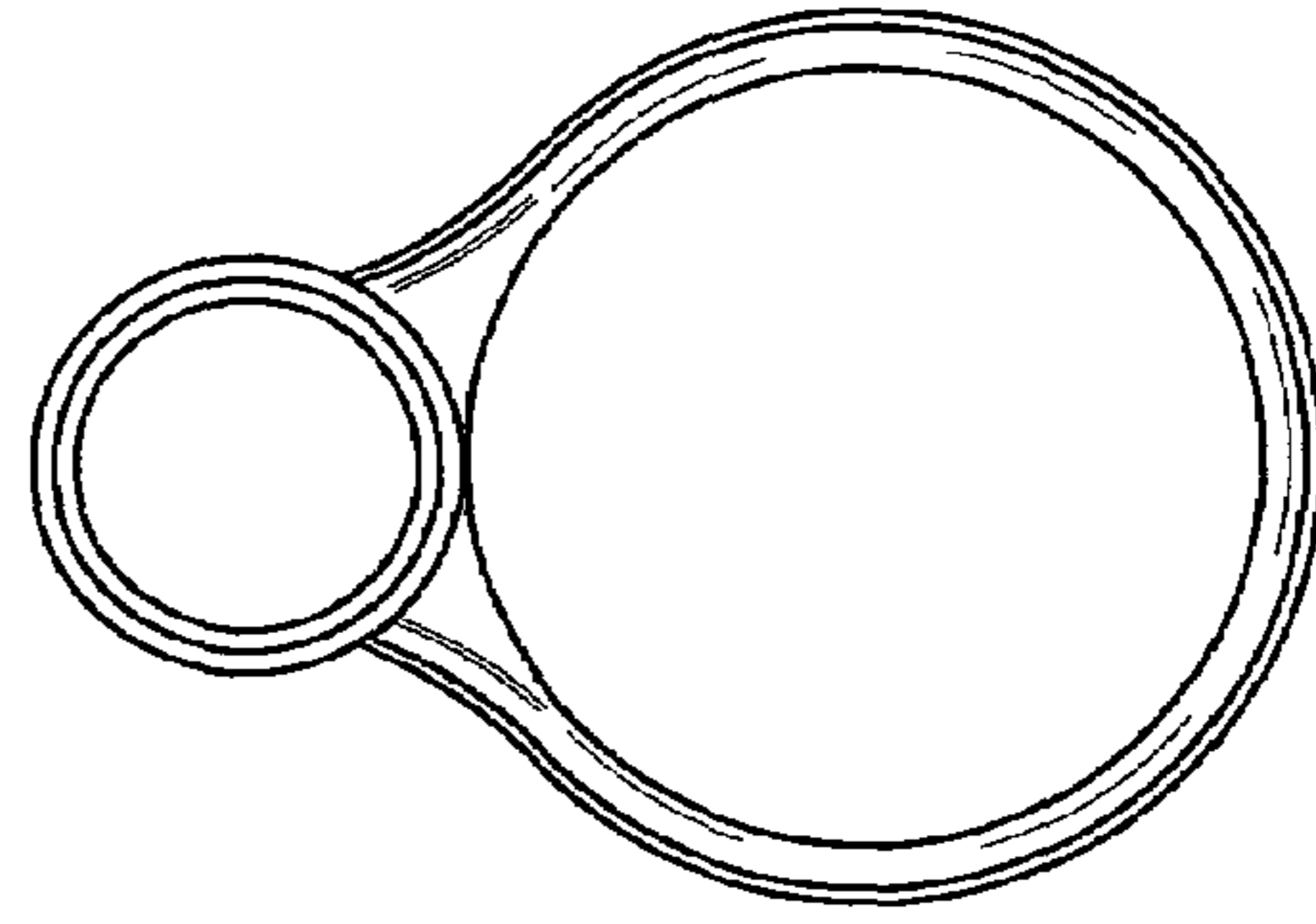

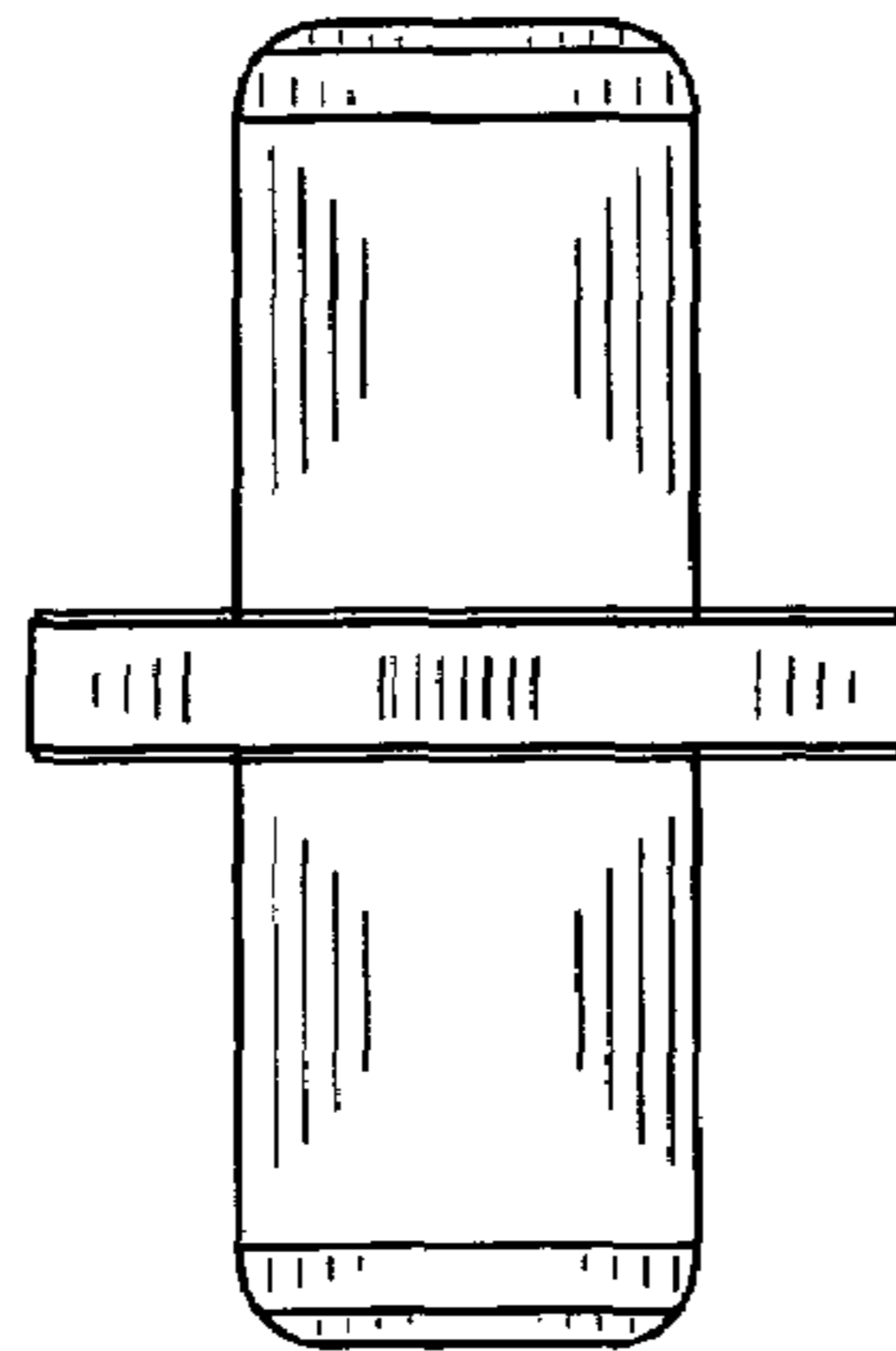

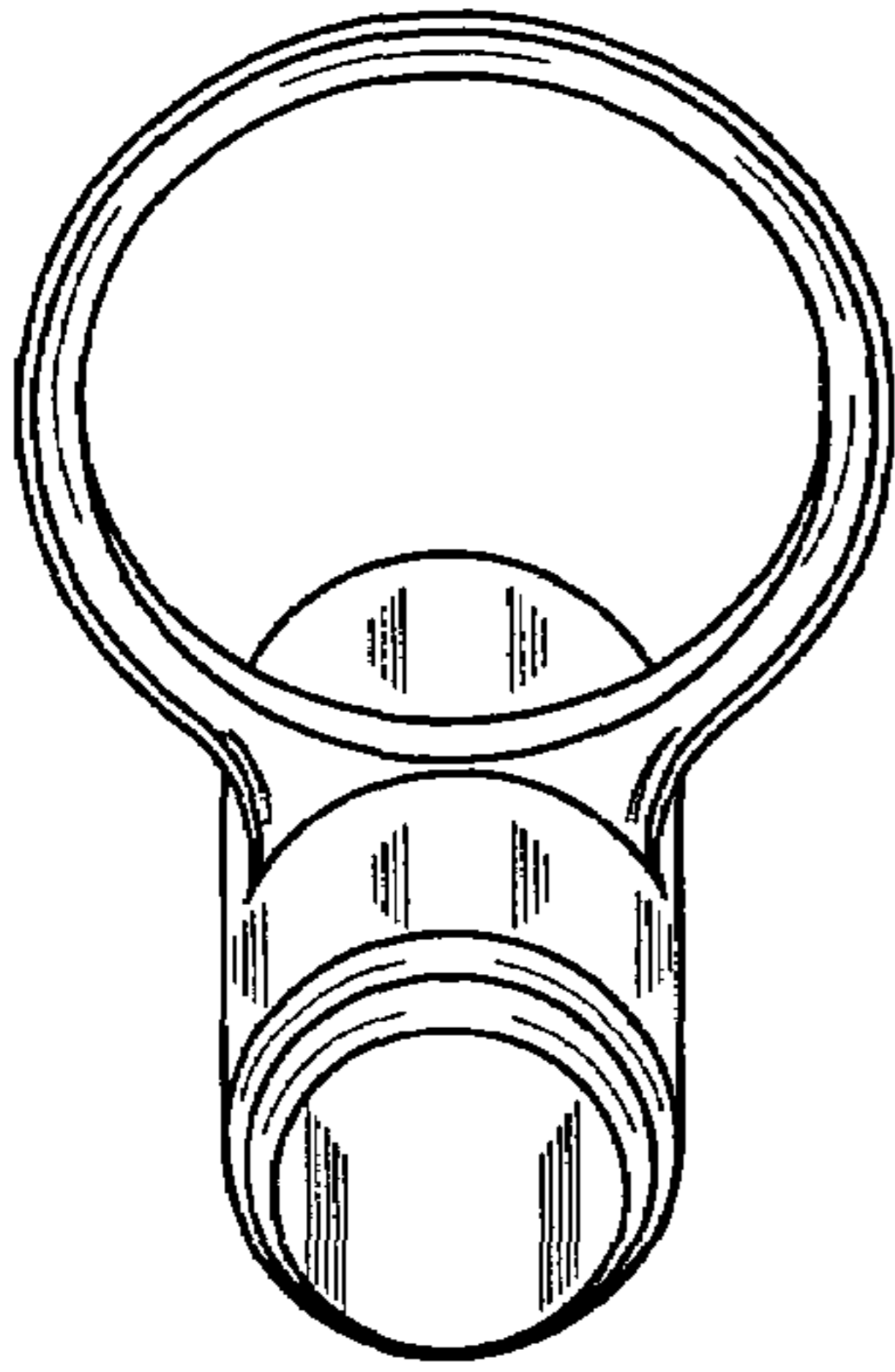

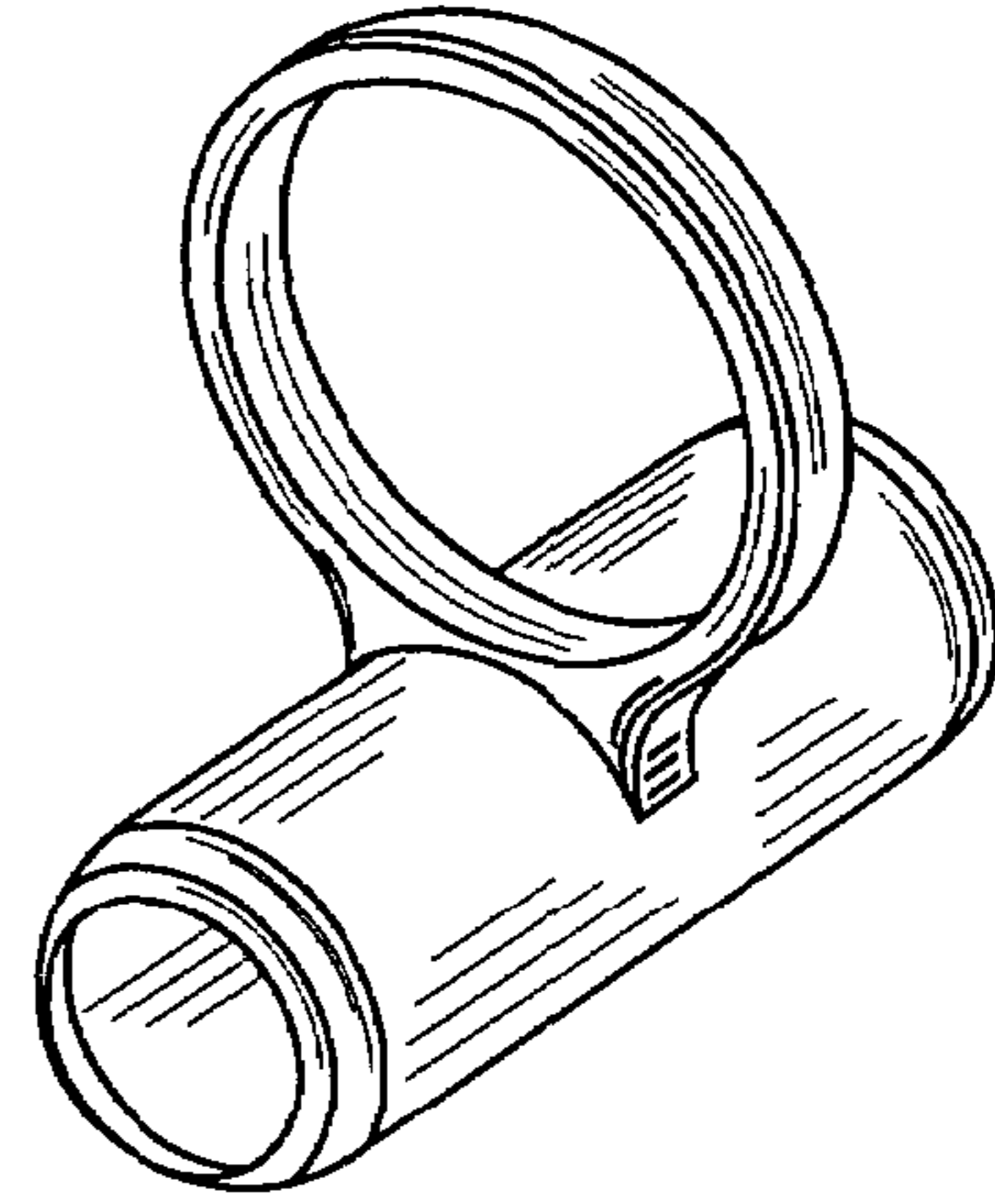

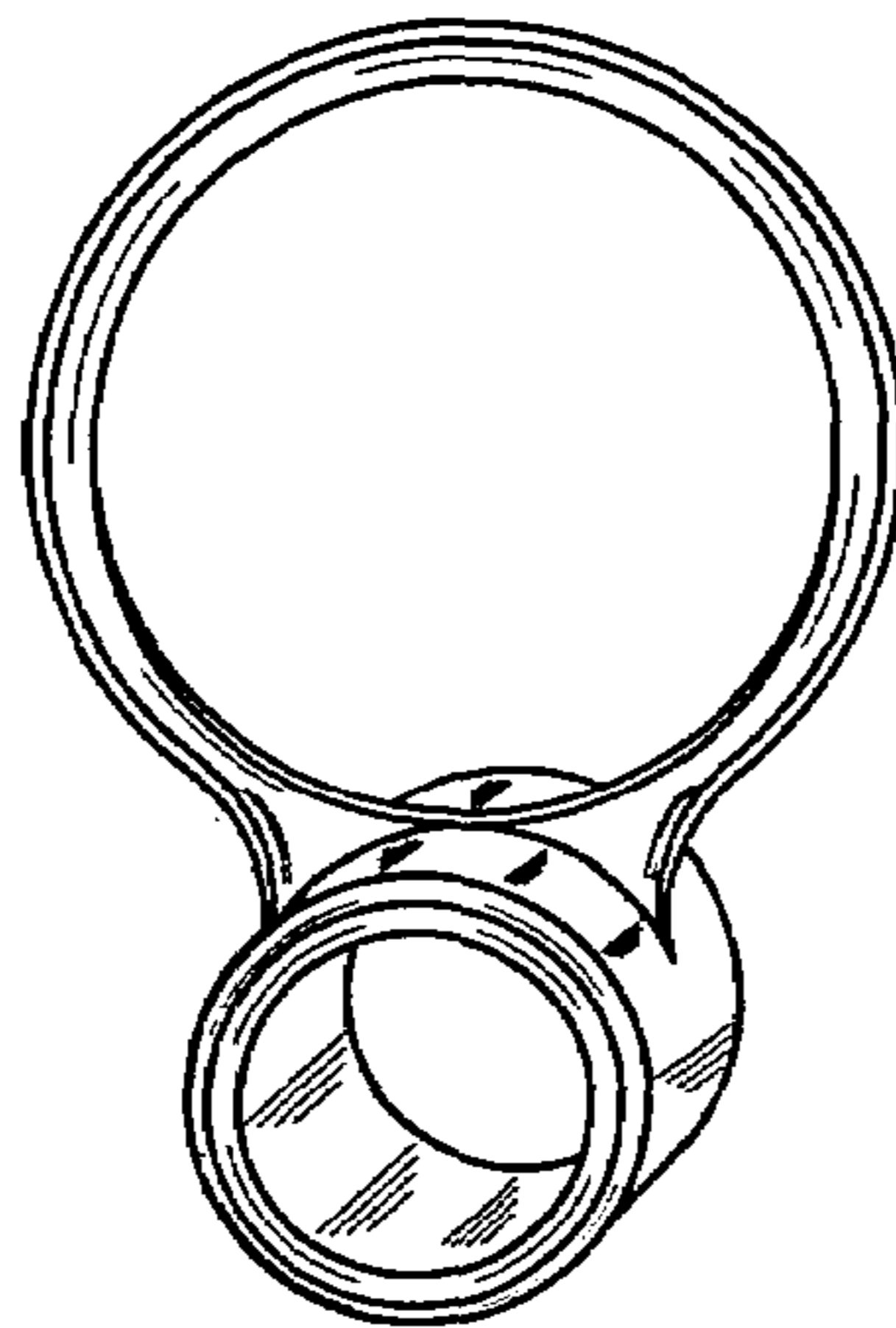

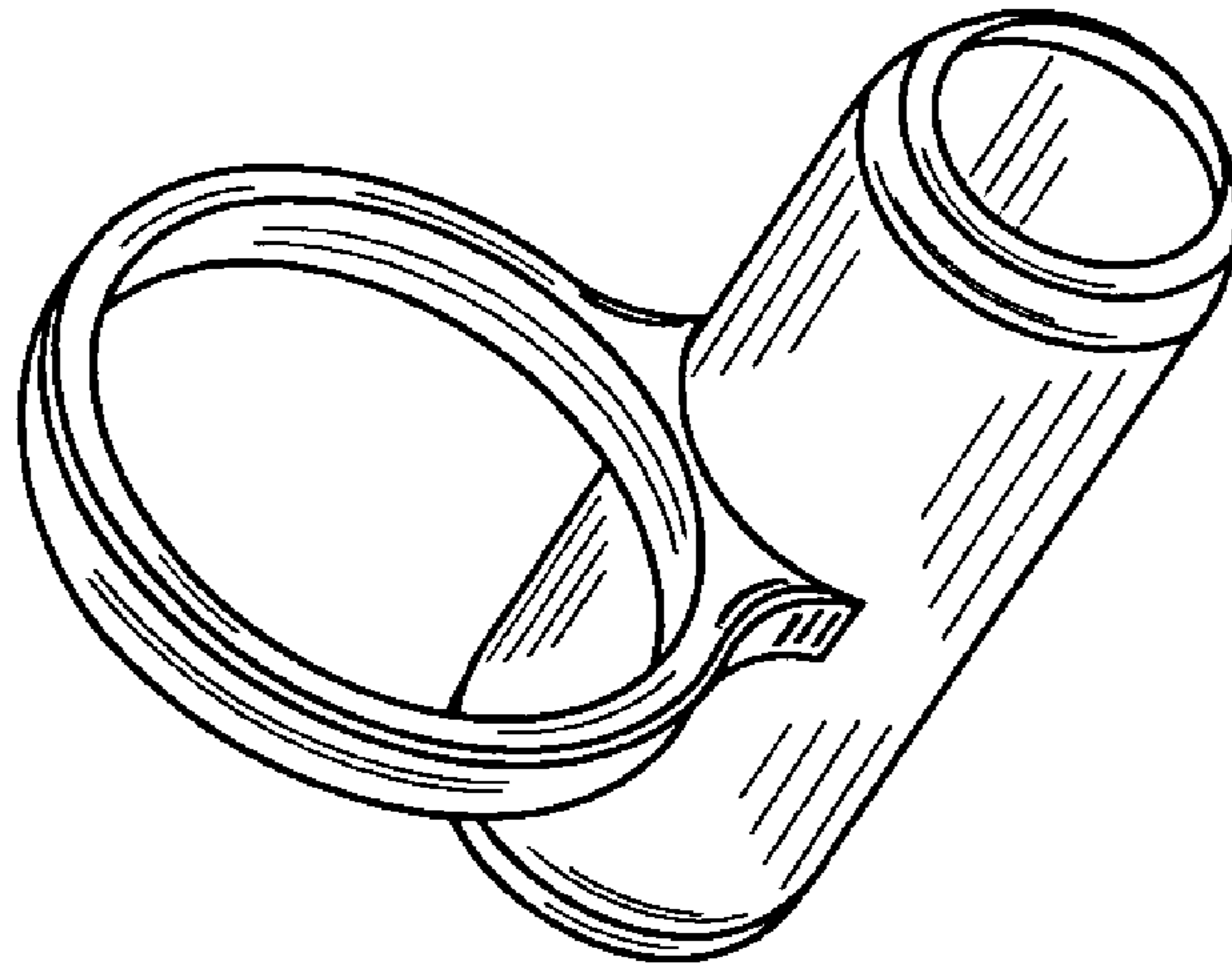

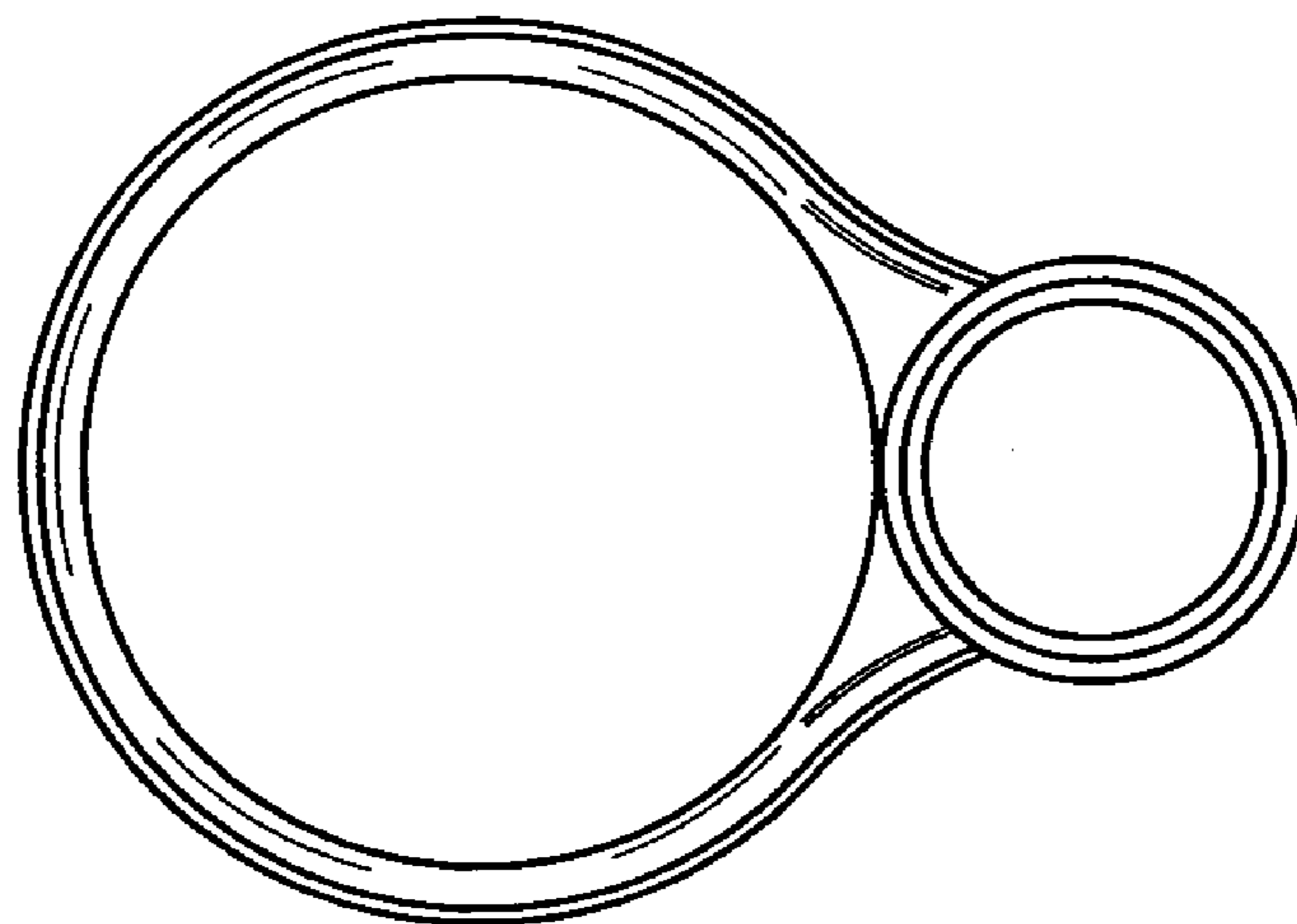
